MESMERIZED

In an article appearing in a newspaper dated 1977, comes the following headline: **10 Million Americans Are Walking Around In A Trance—** "More than 10 million Americans are so easily hypnotized that they're actually walking around in a kind of trance, which exposes them to serious emotional problems, warn two top psychiatrists.

"The psychiatrists describe these Americans as the kind of people who:

- * Get hungry at the mere sight of someone eating.

- * Feel itchy when someone scratches.

- * Reach for a cigarette when someone nearby lights up.

- * Buy impulse items habitually from fast-talking salesmen.

"At least 5 percent of the U.S. population (more than 10 million Americans) are extraordinarily hypnotizable," declared Dr. Tobias H. Brocher, psychiatrist and director of the Menninger Foundation's Center for Applied Behavioral Sciences in Topeka, Kansas.

"About 5 percent of the population cannot be hypnotized at all. And from 80 to 90 percent can be hypnotized to varying degrees," he said.

"At the far extreme, however, is a sizable segment who are so easily hypnotizable that they are in a constant state of exaggerated suggestibility, even when awake and going about their normal daily routine."

"They are at the total mercy of all forms of influences," explained Dr. Brocher, "and can easily be persuaded to do things and afterward have no idea why they did them."

"About 5 percent of the general population go around in a kind of day-long trance without even knowing it," Dr. Voth [senior psychiatrist at Menninger] said."

NUCLEAR CLOUDS OVER NEW MEXICO

In an article taken from the December 16 edition of the *ALBUQUERQUE JOURNAL*, written by John Fleck, "Los Alamos scientists intentionally sent radioactive clouds aloft over northern New Mexico at least four times in 1950 as part of an experiment in tracking nuclear fallout, congressional investigators revealed Wednesday."

WHOOPI GOLDBERG

In the December 2 edition of the *ROCKY MOUNTAIN NEWS*, "Actress Whoopi Goldberg was accused of ethnic stereotyping in a joke recipe she contributed to a Connecticut fundraising cookbook.

"Her *Jewish American Princess Fried Chicken* appears in *Cooking in Litchfield Hills*, a cookbook sold to benefit the environmentalist Pratt Center.

"Among the recipe's directions: 'Send a chauffeur to your favorite butcher shop for the chicken,

watch your nails' and 'have cook prepare rest of meal while you touch up your makeup.'

"I don't think it's funny,' Abraham Foxman, national director of the Anti-Defamation League commented. 'It's totally insensitive because it raises all the ugly anti-Semitic stereotypes.'

"Goldberg's publicist, Brad Cararelli, said: 'Maybe (the critics) are not aware that Whoopi is Jewish, so she is certainly not anti-Semitic.'"

PA STATE SUPREME COURT

In a recent AP story in an unknown newspaper, "The state Supreme Court ruled against one of its own, denying Justice Rolf Larsen a transcript of his testimony before a grand jury investigating his allegations of wrongdoing by fellow justices.

"The high court ruled Friday that while state law allowed witnesses in grand jury proceedings to discuss their testimony with others, the privilege did not extend to their transcripts.

"Upholding a ruling by the grand jury's presiding judge, Justice Nicholas P. Papadakos said Larsen needs to seek legislative changes to obtain the transcripts.

"Redress lies with that body and not with the courts,' said Papadakos."

JOURNALISTS

In another recent AP article, again from an unknown newspaper, "The British public trusts journalists as little as government officials to tell the truth, according to a survey published by the *TIMES* newspaper in London on Monday.

"The *TIMES* said the biggest change had been in the public's view of journalists. The number trusting their veracity has virtually halved since 1983 and stands at 10%.

"Journalists were at the bottom of the list of 15 professions, along with government officials."

GERMANY & NUCLEAR POLICY

In the December 16 edition of the *FINANCIAL TIMES*, in an article written by Quentin Peel, "Germany yesterday unveiled a 10-point plan to strengthen the policing and control of the spread of nuclear, chemical and biological weapons.

"Mr. Klaus Kinkel, German foreign minister, called for tougher international export controls and closer cooperation between potential suppliers of technology for weapons of mass destruction.

"The 10-point plan says the UN has agreed in principle that nuclear proliferation is a threat to international peace and security. But it states that any use of military measures to prevent the spread of nuclear arms should be seen as specifically legitimized by the U.N. Security Council."

JEW'S' THIRD TEMPLE

In an article from the December 5 edition of the *ROCKY MOUNTAIN NEWS*, written by Dick Foster, "An old gold mine near Victor [Colorado] has

been purchased by a group of Christians and Jews who hope to build the prophetic *Third Temple* they believe will herald the coming of the Messiah.

"The Joe Dandy Mining Corporation, which owned the 27-acre Climax gold mine, sold the property to the New Temple Builders Association of Tel Aviv, Israel, for \$9 million in no-interest bonds payable Jan. 1, 2001."

HOLOCAUST AD

In an article from the December 12 edition of *THE NEW YORK TIMES NATIONAL*, "The campus newspaper at the predominantly Jewish Brandeis University has created an uproar by accepting an advertisement questioning whether the Holocaust occurred.

"The editors of the weekly newspaper, *THE JUSTICE*, said they ran the advertisement so readers would know that such thinking existed.

"After the advertisement appeared on Tuesday, several thousand copies of that issue of the paper were apparently stolen. When more copies of the newspapers were distributed under police guard on Thursday, about 250 students rallied in protest.

"I thought this was a more liberal and open community that would have a little more empathy for why we made our decision,' said David Turner, editor-in-chief of *THE JUSTICE*. "We wanted our community to be aware that reprehensible views like these exist in the world, and we did not want to put our collective heads in the sand on this issue."

"But at the rally on Thursday, Prof. Anthony Polonsky, a Holocaust historian, told demonstrators: 'Holocaust denial is not a serious scholarly debate. This is a new form of hate propaganda. This is not a First Amendment issue.'"

Say what?

LIVING IN CITIES

In a *news-brief* appearing in the December 13 edition of the *FINANCIAL TIMES*, "Half the world's population will be living in cities by the end of this decade, leading to critical shortages of clean water, housing and health care, according to Population Concern, the United Kingdom-based family planning charity.

"The world's population is growing by 96 million people a year, with more than 80 per cent of the growth in towns, it says. The U.N. has forecast that the world's population could double to more than 10 billion people by the middle of the next century."

AIDS VACCINE

In an article from the December 4 edition of the *SAN FRANCISCO CHRONICLE*, "An experimental vaccine that uses a genetically engineered mouse virus to help the human body fight the AIDS virus was approved for testing yesterday by an advisory committee to the National Institutes of Health.

"Developed by Dr. Richard Haubrich of the University of California at San Diego, the vaccine is designed to mobilize killer cells within the immune system of patients already infected with the AIDS virus so they can fight off the disease.

"The Recombinant DNA Advisory Committee, a group of experts who evaluate experimen-

tal human therapy proposals based on manipulated genes, approved a proposal by Haubrich to test the vaccine on 20 patients. Before the experiment can begin, it also must be approved by the director of the NIH and the Food and Drug Administration, but Haubrich said that approval is expected quickly.

"Haubrich's vaccine is designed to kill off cells in the body that are infected..."

"The experimental vaccine is actually a modified mouse virus. It is first modified so that it cannot reproduce. Then two harmless genes from HIV are inserted into the mouse virus, along with a bacterial marker gene used to trace the spread of the mouse virus.

"In effect, the mouse virus is used as a vehicle to carry the HIV genes into the body."

AIDS MORTALITY

In the November 19 edition of *MMWR (MORBIDITY AND MORTALITY WEEKLY REPORT)* from the Centers for Disease Control, "In 1992, HIV infection became the number one cause of death among men aged 25-44 years."

MILITARY CUTS

In an article appearing in the December 11 edition of the *MODESTO BEE*, written by Robert Burns, "The Army National Guard and Reserve will lose about 127,000 jobs during the next six years and some units will be disbanded as the nation's backup combat and disaster relief forces reorganize, the Pentagon announced Friday.

"Aspin said that although the Guard and Reserve will get smaller they will be more tightly focused on specific wartime and peacetime missions and will benefit from what Army leaders called a new partnership with active-duty forces.

"The Bush administration had suggested cutting the Army Guard and Reserve to 563,000 by 1999 but met resistance from Montgomery and other supporters of the reserves in Congress.

"The Clinton plan is to reduce the Guard to 367,000 and the Reserve to 208,000 for a total of 575,000 by 1999. The Guard force now stands at 422,7000 and the Reserve at 279,600. The administration plans to cut the active-duty force to 1.4 million from 1.7 million."

SUPREME COURT RULING

"In an article from the December 14 edition of *FINANCIAL TIMES*, written by George Graham, "U.S. life insurance companies are bracing themselves for an administrative upheaval affecting \$570 billion of assets, after the Supreme Court ruled yesterday that these funds must be managed in line with pension protection laws.

"Some insurance executives feared the ruling could oblige companies to set up segregated accounts for their group pension clients, which would create great difficulties in dividing the assets now pooled in their general accounts."

TOBACCO SMUGGLING

In an article appearing in the December 12 edition of *THE GAZETTE (Montreal)*, "A new Revenue Canada policy that was quietly implemented at the beginning of December allows police officers to seize vehicles if they find even a small amount of smuggled tobacco inside."

DEER VIRUS

In an article from the December 7 edition of the *LOS ANGELES TIMES*, written by Maria Cone, Sonora: "When the first deer dropped dead in Jill Ballas' yard, she didn't give it much thought. But six weeks later, when a fawn keeled over in her flower bed, Ballas knew something was wrong.

"In just three weeks, 20 deer had died mysteriously within a two-mile radius in this little Mother Lode town on the western slope of the Sierra Nevada.

"By mid-August, California's deer die-off had become one of the biggest *who-dun-its* in the animal kingdom, baffling everyone, until a sharp-eyed pathologist dissected the fawn that died in Ballas' yard and noticed an odd mark in the center of a cell.

"The culprit turned out to be a virus—a nasty, DNA-mutating strain never encountered before.

"The death toll remains unknown, but it is believed to be in the thousands. Since July, the carcasses of at least 500 deer—mostly fawns—have been found in 17 counties, from the redwood forests of Yreka to Yosemite National Park to the coast of Marin County. The body count has slowed to 20 or 30 a week, but officials suspect the corpses found represent a fraction that are dying in the wild.

"Bob Nordhausen, who operates the lab's high-powered electron microscope, prepared the tissue for closer examination. Bathed in the green phosphorous light of his microscope, he magnified the cell 80,000 times.

"Nordhausen then uttered one word that touched off a flurry of interest: Adenovirus. He was 99 percent certain.

"Adenoviruses—a broad category of infectious viruses that alter DNA and cause respiratory disease—are ubiquitous, even in humans."

AIDS IN AFRICA

In an article from the December 13 edition of the *ALBUQUERQUE JOURNAL*, written by Terril Jones, "About 2 million more people were infected with the AIDS virus in the last year, mostly in Africa where teenagers and young adults are being infected at an alarming rate, the World Health Organization said Sunday.

"Nearly 70 percent of the world's 15 million people infected with the human immunodeficiency virus are in Africa, said Michael Merson, director-general of WHO's Global Program on AIDS.

"Most alarming is the spread of AIDS among African youths and young adults. Merson said a new WHO study of the African epidemic shows that 60 percent of new infections are among people ages 15-24."

SCHOOL VIOLENCE

In an AP story appearing in the December 17 edition of *THE SPOKESMAN-REVIEW* (Spokane, Washington)—"More than one in 10 teachers and nearly one in four of their students have been victims of violence in or near their public schools, according to a survey that suggests schools have become a place where children 'learn to cope with the daily fear of being harmed.'"

FREEDOMS DECLINE

In another article from the December 17

edition of *THE SPOKESMAN-REVIEW*, "The post-Cold War era suffered its worst setbacks in 1993, as the number of the democracies plummeted to the lowest level worldwide since 1976, according to a survey released Thursday by a leading human rights monitoring group.

"The number of people living in repressive societies increased by more than half a billion, according to the survey by Freedom House. Of the world's 190 countries, the total judged to be *not free* jumped from 38 to 55, the largest increase in the history of the annual survey, which dates back more than two decades.

"Freedom House is a non-partisan human rights monitoring group founded by Eleanor Roosevelt and Wendell Wilkie in 1941.

"Several new entries to the *not free* list are close U.S. allies, including Egypt, Bahrain, Oman, Ivory Coast, Tunisia and the United Arab Emirates.

"The 20 worst-rated countries in the *not free* category are: Afghanistan, Angola, Bhutan, Burma, Burundi, China, Cuba, Equatorial Guinea, Haiti, Iraq, Libya, North Korea, Saudi Arabia, Somalia, Sudan, Syria, Tajikistan, Turkmenistan, Uzbekistan and Vietnam."

RADIOACTIVITY

In an article from the December 9 edition of the *ST. PETERSBURG TIMES*, "Millions of pounds of highly radioactive reactor fuel have been sitting in Energy Department storage pools for so long that they are breaking down and spreading radioactivity, the Energy Department said Tuesday.

"The problem promises to add substantially to the cost of cleaning up after 50 years of nuclear weapons production, already expected to run into the tens of billions of dollars.

"The fuel was put through nuclear reactors as a step in making plutonium and tritium for bombs. It was intended to sit in the storage pools for only 18 months or so, to cool until the plutonium and other valuable material could be extracted from it. But when safety problems suddenly shut the processing plants in the 1980s, the fuel was marooned.

"The Energy Department has 29 pools or clusters of pools, at the Savannah River Site, near Aiken, SC; the Hanford Site, near Richland, WA; and the Idaho National Engineering Laboratory, near Idaho Springs.

"All three are large government reservations in rural areas, limiting the danger that the public will be exposed. But deterioration has already exposed dozens of workers to sharply higher radiation levels. And any radioactive material that escapes could spread for years."

POSTAL CRIME WATCH

In the December 16 edition of the *ST. PETERSBURG TIMES*, in an article by Tim Roche, "After two months of meetings and planning, Bill Pick [postal carrier] and associates created a crime-watch program believed to be the first of its kind in the nation, a network of letter carriers serving as the eyes and ears of a police department.

"If we can keep it so carriers are not seen as somebody peeking over fences, it'll be a success," Pick said.

"Under the Postal Crime Watch, St. Petersburg police since September have provided car-

riers with descriptions of people and vehicles wanted in crimes throughout the city. Some 600 carriers read morning updates on bulletin boards at nine postal branches."

HUMAN RIGHTS

In the December 21 edition of *THE SPOKESMAN-REVIEW* (Spokane, WA), "The General Assembly created the watchdog job of U.N. High Commissioner for Human Rights on Monday to promote basic rights and freedoms worldwide, but deliberately left its powers broad and vague.

"The move, hailed as a victory by the West, was the result of a compromise by the United States, Western nations and human rights groups and developing nations.

"The Clinton Administration had made creation of the post one of its U.N. priorities this year."

WHOOPIING COUGH DOWN-UNDER

In an article from the December 16 edition of the *MESSENGER STANDARD*, an Australian newspaper, "The State is suffering a whooping cough epidemic with more than 875 cases reported this year, including 500 last month.

"Dr. Kerry Kirke said the disease could start with cold like symptoms and develop into coughing spasms between which affected people gasped for breath, causing the whooping sound."

WHOOPIING COUGH STATE-SIDE

In an article from the December 17 edition of *THE MODESTO BEE* (CA), "U.S. children are coming down with whooping cough in huge numbers this year because too many are failing to receive vaccinations on time, federal officials said Thursday.

"The Centers for Disease Control and Prevention reported 5,457 cases of whooping cough through Dec. 4, the highest number of cases since 1967. Outbreaks have occurred in Chicago and Cincinnati."

CHICKEN POX

In an article appearing in the November 27 edition of the *ST. PETERSBURG TIMES* (FL), "Dr. Jo White sent her son to play with a friend who had chicken pox, testing whether an experimental vaccine would protect him. It did.

"By next spring, all U.S. children may be so lucky [lucky?], as government gets set to approve the nation's first vaccine against a disease considered more a nuisance than a killer even though it kills more than 90 people a year."

COMET COLLISION

In an article appearing in the December 10 edition of the *ST. PETERSBURG TIMES*, "A comet will strike Jupiter with the force of 1-million atomic bombs.

"Two spacecraft are expected to photograph the momentous collision in July 1994—the space probes *Galileo* and *Voyager 2*, which has been in space for 17 years.

"Just over a year ago, the comet had a close encounter with Jupiter and was torn into 20 pieces by the planet's gravitational pull and scattered across 102,000 miles.

"The badly mauled comet was sighted in

March 1993. It was named Shoemaker-Levy 9 after the astronomers who discovered it.

"The Galileo probe is likely to have the best view of the projected collision.

"Some astronomers think parts of the comet could penetrate deep into the surface of Jupiter.

"...the debris is expected to tear holes the size of a country like Spain in the planet's cloud belts and to glow brightly when it disintegrates in the planet's atmosphere."

CHINA'S BANNING

In an article in the December 22 edition of *THE SPOKESMAN-REVIEW*, originally from the *WASHINGTON POST*, "China will use abortions, sterilization and marriage bans to 'avoid new births of inferior quality and heighten the standards of the whole population,' the official New China News Agency said Monday.

MILITARY DEATHS

From the December 20 edition of the *ALBUQUERQUE JOURNAL* comes an AP story which reads: "Military investigators concluded that the deaths of 40 soldiers at bases around the world were suicides despite evidence suggesting some of them were killed, *THE PHILADELPHIA INQUIRER* reported Sunday.

"The investigators misquoted witnesses, failed to perform routine forensic tests and lost or destroyed other evidence in reaching their conclusions, the *INQUIRER* said.

"The military frequently uses suicide rulings to clear the record quickly, said Ronald F. Decker, a former Air Force criminal investigator.

"They want these cases closed,' Decker said. 'An unsolved homicide is a terrible thing to have on the books. So they close them out as suicide. Who's going to complain about an extra suicide or two—except maybe the families."

TB BATTLE

In an article written by Luran Neergaard, appearing in the December 24 edition of the *ALBUQUERQUE JOURNAL*, "The United States won't help pay for the global fight against tuberculosis, despite dire warnings that TB resurgence here is fueled by the world epidemic, an official said Thursday.

"The World Health Organization asked the U.S. government to fund a third of its \$9 million program to fight the deadly lung disease in developing countries and to thwart its mutation into incurable strains.

"About one-third of the world's population is infected with the TB germ and 8 million get sick every year."

DEMJANJUK

In an article from *THE NEW YORK TIMES*, appearing in the December 31 edition of the *DAILY NEWS*, "The Justice Department abandoned on Thursday its long-held contention that John Demjanjuk was one of the most barbaric Nazi figures of the Holocaust. But it nonetheless accused him of being a lesser war criminal and of lying on his immigration papers, and it moved to have him stripped of his U.S. citizenship and removed from the United States."

YELTSIN'S SECURITY MOVE

In an article from the December 22 edition of the *FINANCIAL TIMES*, written by John Lloyd, "President Boris Yeltsin last night announced the abolition of Russia's Ministry of Security—formerly the KGB—in a move which brings the country's security and intelligence services under his direct control.

"A new Federal Counter-Intelligence Service has been created, with its director explicitly under Mr. Yeltsin's command."

MIRANDA CLARIFIED?

In an article from the November 2 edition of the *ST. PETERSBURG TIMES*, "The Supreme Court agreed Monday to set new boundaries for its landmark Miranda ruling on the rights of criminal suspects by deciding just who qualifies as a suspect and how police must respond to vague requests for a lawyer's help.

"The justices will use murder cases from California and South Carolina to clarify what still is an often-disputed part of law enforcement—the legal protections accorded people being questioned by police.

"The court's 1966 ruling in *Miranda vs. Arizona* requires police to warn suspects before questioning them that they have a right to remain silent or get a lawyer's help, and that anything they say may be used against them.

"Later high-court rulings require all police questioning to stop when criminal suspects invoke their right to have a lawyer's help, and bar police from initiating any subsequent interrogation.

"Decisions in both cases are expected in July."

SOCIAL SECURITY

In the December 20 edition of the *ST. PETERSBURG TIMES*, "The Clinton administration should consider accelerating the timetable for raising the age at which elderly Americans begin receiving Social Security benefits, Treasury Secretary Lloyd Bentsen says.

"I think that's one of the things that we should look at as people live longer and longer and are more productive."

"An analysis last year by Robert Shapiro, vice president of the Progressive Policy Institute, a think tank with ties to Clinton, calculated that raising the retirement age to 67 by 2008 could save \$60-billion over the next two decades."

NAVAJOS SMELL A RAT

In an article from the December 19 edition of the *ALBUQUERQUE JOURNAL*, written by Leslie Linthicum, "In the six months since scientists found a name and a cause for the Four corners *mystery illness*, federal, state and tribal officials have mounted a massive health education campaign to warn people away from the identified carrier of the deadly disease—the deer mouse.

"But here in Littlewater, where the illness struck most ferociously, and in other communities scattered across the Navajo reservation, the campaign has been met with distrust, disbelief and sometimes anger. The reason is simple: Many people don't believe the scientists' basic premise that people died from an infectious

disease carried by mice. And mice, they say, are creatures to be respected from a distance, not killed in baited traps.

"They're not calling it a disease," says Louise Nez, an employee of the Navajo tribal government who works with elders in the community. They say it's not true that the mouse is the cause of it. It's the mouse, then everybody would get sick."

"We live with the mouse," Kee Tapaha says. "We don't bother them and they don't bother us."

"Disbelief, and the reluctance of many residents to talk about what was a traumatic episode for Navajos, has left health educators stymied."

STARVATION FACES MANY

In a December 22 article from an unknown newspaper, "Millions of people in 20 countries stricken by war or civil turmoil are faced with starvation and malnutrition in 1994, according to the U.N. Food and Agriculture Organization.

"Edouard Saouma, the organization's director-general, issued a statement with Tuesday's release of the organization's report. The report said 'grave regional food shortages persist.'

"Most of the threatened populations are in Africa. In Angola, Burundi, Eritrea, Ethiopia, Kenya, Liberia, Mozambique, Niger, Rwanda, Sierra Leone, Somalia, and Sudan political strife or civil war disrupt growing and distribution. Adverse weather conditions affected harvests in some countries."

CANADA'S COD INDUSTRY

In an article by Bernard Simon appearing in the December 21 edition of the *FINANCIAL TIMES*, "Canada's once-thriving east coast cod fishery will be almost entirely shut down in 1994 as part of efforts to rebuild severely depleted stocks, fisheries minister Mr. Brian Tobin said yesterday.

"Mr. Tobin also announced that quotas for other ground-fish species will be severely cut, bringing next year's total allowable catch down to 250,000 tons, about a quarter of its level five years ago.

"The cuts are expected to cost 35,000 fisherman and processing plant workers their jobs."

BOVINE TB

In an AP story from the December 19 edition of the *ALBUQUERQUE JOURNAL*, "The Agriculture Department has proposed new branding and identification requirements aimed at halting the spread of tuberculosis by cattle imported from Mexico.

"The dramatic rise in tuberculosis-infected cattle found at U.S. slaughter-houses that have been traced back to Mexico makes our ability to identify the source of these animals increasingly important," said Billy G. Johnson, deputy administrator of the Animal and Plant Health Inspection Service."

COPYRIGHTS & CLASS NOTES

In an article from the November 25 edition of the *ST. PETERSBURG TIMES*, written by Edie Gross, "A company that hires University of Florida students to take notes in class and then sells those notes for a profit is not violating professors' copyrights, a federal jury has decided."

RADIO-TELESCOPES

In an article by Rex Graham in the December 23 edition of the *ALBUQUERQUE JOURNAL*, "A radio-telescope observatory west of Socorro is using \$1 million to install new equipment that might help astronomers catch stars in the act of giving birth to planets.

"The money is coming from the Mexican government and is the first foreign investment in the observatory.

"It is another step in the scientific hunt for very distant planets—and for possible extraterrestrials living on them.

"The system should be ready by March or April to begin the hunt for young, planet-spawning stars."

EUROPE'S UNEMPLOYED

In an article appearing in the August 15, 1993 edition of *PARADE MAGAZINE*, "Think America is the only country with a sluggish economy? The worst recession in six decades has hit the 12 nations of the European Community.

"Unemployment grew from 14.6 million at the start of the year to 22 million in July. As many as 80 million citizens in the EC are living in poverty, and about 2.7 million are homeless.

"Germany has by far the most homeless people—1.3 million, according to the European Federation of National Associations."

GLACIER ON THE MOVE

In an article from the December 10 edition of the *ST. PETERSBURG TIMES*, "Alaska's immense Bering Glacier is on a rampage, speeding up in recent months rather than slowing as expected, scientists said.

"The surge, which began in May and measures up to 300 feet per day, affords scientists a rare look at how the giant ice wall behaves as it pushes forward."

TB IN AFRICA

In an article from the *SUNDAY TIMES* (South Africa), "...a new TB superbug, resistant to the usual drugs, is cutting swathes through entire families in South Africa."

From the December issue of the *ROCA REPORT*, "AIDS and TB are terrible twins," Professor Eric Glatthaar, chairman of the TB Advisory Group said on Dec. 4. In AIDS patients, TB progresses 10 times faster than normal while AIDS is also more virulent and progresses more rapidly. TB often takes a different form in AIDS patients, attacking organs and bones rather than affecting the lungs. About 10 million South Africans are infected with the TB organism but do not fall ill unless something else—like poor nutrition or the HIV virus—triggers it. There are 80,000 new TB cases every year. Almost one-third of the patients in some TB hospitals are HIV-positive."

SOUTH AFRICA UPDATE

The following is taken from the December issue of the *ROCA REPORT*: "With the inauguration of the Transitional Executive Council (TEC) on December 7, South Africa moved into a dangerously unstable situation. Effective political power passed from the elected Parliament to

the self-appointed council controlled by the South African Communist Party (SACP) and its front organization, the African National Congress (ANC). Up to that date, opponents of the transitional process have been restrained because they acknowledged the lawful authority of Parliament. However, they see the TEC as an illegal usurper whose authority they reject. They therefore feel free, indeed obliged, to defy its authority.

"How the SACP/ANC, through the TEC, exercises that power in their attempt to impose their will on the country and how groups that reject the TEC's authority react to their efforts, will determine events in South Africa in the months before the planned April 27 elections. Violence could be sparked either by TEC attempts to reincorporate the homelands against their will or by efforts to set up an independent Afrikaner homeland (volkstaat).

"The Afrikaner Volksfront (AVF) and its mouthpiece Radio Pretoria are in a similar position. With the installation of the TEC, the radio's temporary licence expired. In any case, it has been broadcasting news and political material in defiance of its licence conditions. The TEC must now decide whether to provoke a confrontation by attempting to close the station or just to ignore it. However, as was pointed out in *ROCA REPORT* no. 59, the station is fanning Afrikaner nationalism and rallying Afrikaners to the anti-Communist cause. It is therefore too important for the TEC to ignore. On Dec. 9, the committee which had been running Radio Pretoria since it began broadcasting in September, officially handed the station over to the AVF. This is a clear indication that the station intends to defy the TEC and continue broadcasting. Again, it must be stressed, it has no option. Following the advice of the AVF, many small towns have held pools among their rate-payers who have overwhelmingly rejected the TEC. Similar unofficial polls in Pretoria have produced the same results. These areas will form the volkstaat.

"By refusing to submit to the authority of the TEC, the FA [Freedom Alliance] will provoke confrontation and conflict. It must however be stressed that if the FA refuses to challenge and fades away, this does not mean peace and prosperity will descend on South Africa. The potential for resistance in South Africa from those (Afrikaners, Zulus, Tswanas, etc.) who will not accept Marxist/Khosa/anti-Christian rule, is so great that conflict is inevitable. But it is likely to be sporadic, uncoordinated and therefore far less likely to succeed than if it were a united stand taken by the FA."

Estate Planning Today! (PART 2)

(This article is a continuation from page 5 of the 12/21/93 issue of CONTACT.)

Gifting: Transferring the ownership and control of a corporation to your heirs should be started before you get into an estate tax problem. The simplest way to start doing this is to begin a gifting program to your heirs. You can gift to each heir corporate stock worth \$10,000, and if there are 2 people who own a corporation, they can both give \$10,000 each to every heir. This can be done every year.

Long term corporate planning is not just estate planning. Estate planning by itself is done in contemplation of death. Such planning has tax implications and interpretations by the IRS that simply don't apply here. If you have done your long term corporate planning, then you have successfully accomplished a dynamic feat. Why is this a dynamic feat? Because with your long term corporate planning, little exists for a lawyer to do. Your estate isn't consumed by legal expenses or taxes. This is why some lawyers are not going to tell you how to take advantage of long term corporate planning. It is bad for their business. What is the magic? **Corporations are immortal unless terminated by statute or by their corporate articles.** Corporations do not cease to exist because one of their key people dies.

Here is an example of long term corporate planning. This type of strategy is referred to as advanced corporation strategy. The sequence is important, so follow closely: First you establish a corporation called a shelf corporation. It has no assets, no liabilities, the stock is worthless at this point. Because the corporation has no assets yet, stock from the corporation can be sold to your investors or heirs at 1 cent per share, and apportioned by the prorated amounts you choose, depending on how you want to give it to your heirs. Since the stock has been sold to them, it is not a gift. One object of all stock is to increase in value over a period of time. If the stock increases in value, nothing wrong, illegal, unethical or strange has occurred. Take a proxy from your shareholders, or your heirs in this case, that allows you to hold the stock even though you don't own it. The proxy may be irrevocable so that your right to vote is guaranteed. In Nevada, a proxy must be renewed every 7 years. To insure its renewal, the shareholders should give you an option to buy the shares back at the initial price of 1 cent per share. The option can be worded in such a way as to expire upon your death so the shares wouldn't go through probate. Then put your assets into the corporation.

Here is another way to proceed. Place your assets into the corporation as a capital contribution for the benefit of the shareholders (heirs). This would be a gift to the shareholders, but if you are within the tax exclusion limits, that is no problem. So again, that has to be held within a yearly \$10,000 per indi-

vidual. Put your assets into the corporation for a lifetime management contract where you agree to provide certain services for the corporation and the corporation agrees to provide you with a house, all living expenses, plus medical care. This can be an attractive option. You would want to have a lawyer draw that up properly because the IRS could come in and scrutinize that heavily.

Another idea is to put assets into the corporation in exchange for a promissory note with interest payments of interest only for, say, 10 years, and larger installments on principal and interest after 10 years. The note could also be a demand note that expires upon your demise. So, again, you can put your assets in, get some return on them, and at your death (or before), the note expires and everything ends up with your heirs. You can control all of your assets but your heirs own them before your demise, no probate, no estate taxes, and no hassles. When you put your assets into the corporation, the value of its stock increases but there are no taxes until such time as dividends are paid by the corporation or the stock is sold. In both cases this is a matter over which you have complete control and you can adequately plan in advance to legally avoid taxes.

Voting vs. Non-Voting Stock: Another way of transferring ownership is to move your assets into the corporation. Let's say you have a corporation and your estate is basically in there, you can then gift the shares of stock to your heirs, retaining your rights to vote those shares, by proxy. Another idea is to sell them non-voting common stock of the corporation and you would control all the voting shares. They have their stock in nonvoting shares and upon your death, whatever percentage that you have left, would then be passed to them and they would have the voting shares broken down between them.

Limited Partnerships: Limited Partnerships are also commonly used for estate strategies. A limited partnership is made up of the general partners who manage a limited partnership, and the limited partners, who are the owners of the partnership. The limited partners are the ones that get the income derived from the partnership. In some situations you'll see where a limited partnership will purchase the stock or be given the stock of a corporation.

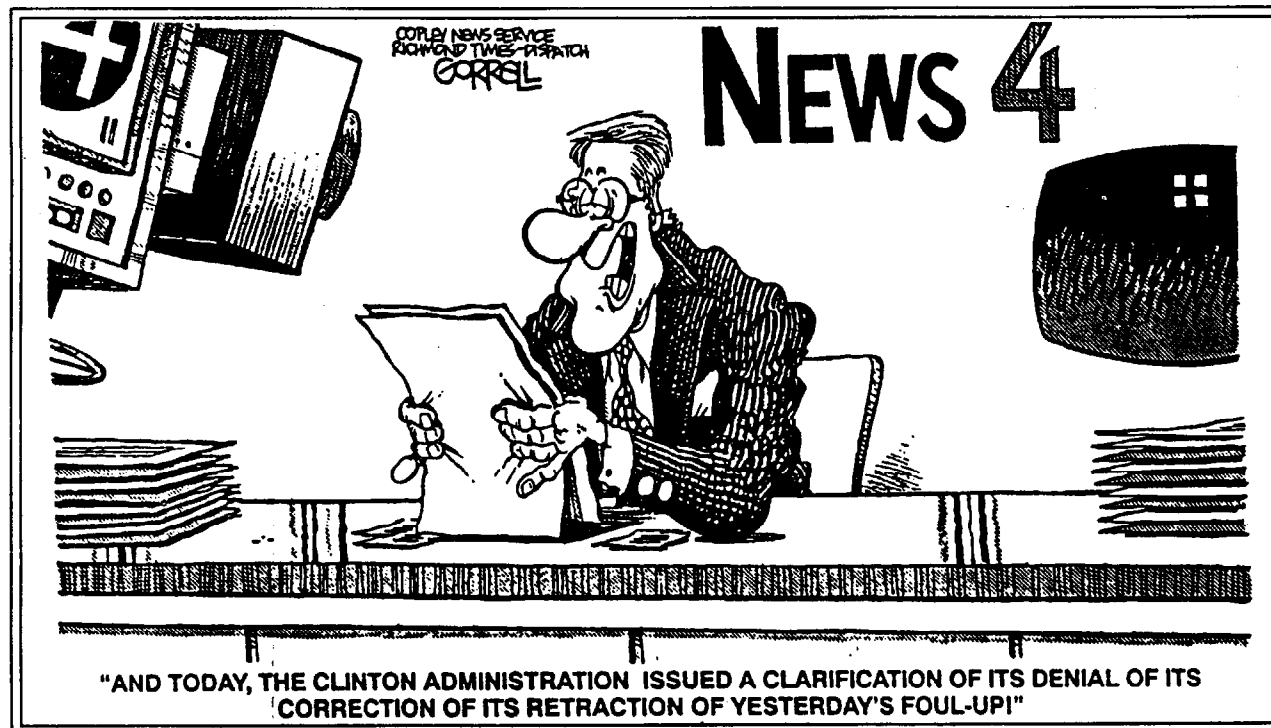

SUMMARY OF ALLEGATIONS

1. This Court has only limited ministerial jurisdiction of this controversy because of the invocation of the Ninth and Tenth Amendments, U.S. Constitution, and of the Social Compacts under-girding the Constitution, including, but not limited to, the Magna Charta, i.e., pursuant to such invocation this Court has no power to enforce any provisions litigated herein unless and until specifically granted by Plaintiffs.

2. Plaintiffs have a right to file this action in federal courts without fear of waiving their right to an impartial tribunal, which they cannot obtain in this District from any judge corruptly supervised by the "judges" of the U.S. Court of Appeals for the Seventh Circuit ("7th Circuit"), or of the 7th Circuit.

3. The Defendants have engaged in an enormous conspiracy to commit treason against the People, including, but not limited to, the Plaintiffs and all others similarly situated; thus, this action is a class action, modeled after Rule 23, F.R.C.P.

4. The United States was founded upon a Compact, the leading principle of which is that individuals can never be trusted with governmental power without tight restraints upon the exercise of that power, i.e., that power corrupts individuals wielding such power and every presumption must be against the innocence of the individual wielding delegated governmental power; the Constitution is evidence only of the provision for governmental service with appropriate restraints, and does not represent the entire Compact, nor all the instruments of restraint.

5. The Bible and the ancient nation of Israel were used as a model for English royalty, as well as a basis for English common law; the Compact is Christian in nature and has, as its documentary foundation, the Magna Charta and the Bible.

6. The Sovereignty of the People is both explicit and implicit in the Compact.

7. The required oath of office from all governmental servants, federal, State and local, is a pledge of allegiance binding all such servants to a contractual relationship wherein they must serve and protect the People and their rights, individually and collectively, under the Compact, and, as such is a waiver of basic citizenship rights in favor of such service to each of the Sovereign People; anyone who does not so waive his/her citizen rights cannot serve the People.

8. The assertion of immunity by any governmental servant is an attempt to assert a Title of NOBILITY, a grievous and treasonous violation of the oath given to the People.

8. (sic) The People, as Sovereign, are not required to take an oath or give a pledge of allegiance to the servants, to the Constitution or to the Compact and, thus, retain all their rights, privileges and immunities without reservation.

9. The Compact is binding on the parties, both the People and their governmental servants, unless abrogated by the servants, at which point the People may invoke supra-Constitutional powers to restore the Compact.

10. ONLY the People may invoke supra-Constitutional rights which were intended to ensure that the People retain and reserve all powers not specifically delegated and those rights may not be denied by the servants, otherwise the servants are guilty of treason by criminal usurpation of powers.

11. The perversion of "The king can do no wrong" maxim led to the modern legal theory of sovereign and judicial immunity. *[Editor's note: Viewed correctly, the maxim might have been more clearly stated: "the king may do no wrong", meaning the king's inviolate duty should be to his subjects, the people; rather than, as commonly misunderstood, the monarch is above criticism or reproach due to his position.]*

12. The main instrument which is currently being used by the Defendants and each of them, individually, severally, jointly and in concert, to commit the grievous and massive treason against the People, is the Federal Emergency Management Agency ("FEMA").

13. Defendant FEMA and all of its officers, employees, agents, representatives, contractors, attorneys, operatives, affiliates, confederates and co-conspirators have committed treason and genocide against Plaintiffs and all others similarly situated by usurpation of powers not granted or delegated.

14. In complete and total violation of the Compact, Defendant FEMA and its secret team of clandestine operatives and co-conspirators, under sham and pretense of federal authority and various unlawfully and treasonously declared "national emergency type situations" but without actual authority, treasonously have been planning to impose, and have imposed, martial law, or "martial rule", upon this Nation and its People and have staged a seditious, silent coup on behalf of enemies of the People of the United States.

15. The IRS, under the control of the FRS and FEMA, has evolved into an organization which has only three major functions, namely:

- to insure the collection of interest, disguised as tax collection, on the national debt of the United States;
- to act as the overseer of the Federal Reserve money laundry;
- to act as a provocateur agency, entrapping all FEMA "undesirables" into violations of secret IRS "laws".

16. the Defendants, individually, jointly, severally and in concert with each other and with other confederates, have knowingly and intentionally violated the Compact to the detriment and damage of the named Plaintiffs and all others similarly situated, thereby committing treason against the named Plaintiffs and all others similarly situated.

17. Intelligence-gathering federal agencies engage in illegal and treasonous counterintelligence activities; under sham and pretense of authority but without actual authority, such counter-intelligence activities, as they pertain to certain of the named Plaintiffs, have been implemented against Plaintiffs and all others similarly situated.

18. The IRS, through its various divisions, such as IRS Intelligence, has become the primary federal intelligence agency.

19. The ultimate use to which IRS Intelligence puts its information-gathering apparatus

against individuals and groups is the implementation of FEMA program testing, i.e., the enforcement of alleged "tax laws" in this country is "criminal" and treasonous.

20. The Plaintiffs, and all others similarly situated, have been damaged by a joint IRS-Intelligence/Mossad covert operation, treasonously perpetrated in concert with other federal, State and local officials.

HIGHLIGHTS FROM **CASE No. 91C 314**

1/1/94 NORA BOYLES

(This is a summary, with excerpts, from a case filed in Illinois in 1991, which is being copied verbatim by Dharma for Hatonn for inclusion in an upcoming JOURNAL.)

Count I

Plaintiffs Sato, Harrigan, Nowak, and Thibodeaux, complaining against the Defendants (listed previously), demand cessation of acts and doings described below and declare them to be both treasonous and unconstitutional.

1. The matter in controversy exceeds the jurisdictional minimum.

2. The Court (as hereinafter always distinguished from the FEMA operatives disguised as judge of the Court) has limited ministerial jurisdiction of this controversy under:

- The Ninth Amendment, U.S. Constitution;
- The Tenth Amendment, U.S. Constitution;
- The "Social Compact" evidenced by the Declaration of Independence, the Constitutions of the Colonial States, the U.S. Constitution, especially the Bill of Rights, and other documents including the Magna Charta.

3. The Ninth Amendment prohibits any judge from having any discretionary power in this case.

4. The Plaintiffs invoke and reserve all rights under the Tenth Amendment, and declare their intent not to waive any such rights by filing the Complaint.

5. The Court has limited (according to preceding sections 2-4) jurisdiction of this controversy. Listed below are the types of Constitutional Laws being invoked (See the JOURNAL for complete details):

- Prohibition against granting Titles of Nobility
- Article pertaining to Treason
- Prohibition against infringement of freedom of religion, freedom of speech and press, or the rights to peaceable assembly and redress of grievance.
- Prohibition against unreasonable searches and seizures and requirement of the issuance of warrants only upon probable cause.
- Prohibition against forced self-accusation, deprivation of life, liberty or property without due process of law. (The Fifth Amendment to the

Constitution.)

f. Prohibition against excessive fines, or cruel and unusual punishment.

g. Prohibition against involuntary servitude.

h. Right to due process and equal protection of the laws.

There are additional laws listed which limit the jurisdiction of this Court including sections of the Racketeering Influenced and Corrupt Organizations Act (RICO), Internal Revenue Code, etc.

Within Section "B. Venue" of the case the Plaintiffs set forth their right to file this case in the U.S. District Court for the Northern District of Illinois ("ND"), and their intent that the case not be heard in this court due to the alleged corruption of all the judges involved—including judges of the 7th Circuit Court of Appeals. The list of allegations includes: taking of bribes; taking of bribes in off-shore accounts; corrupting influence of the mafia; corruption of clerks' offices—concealment and/or alteration of records and/or documents; blackmail, etc.

As a result the Plaintiffs believe they have a right to consider the "Defendants who claim official status to be absolutely stripped of any claim of immunity." They list several Laws and Codes which state that no man may be a judge in his own case! "Plaintiffs intend to either name as defendants or unnamed co-conspirators, or to call as witnesses or demand documents from each and every individual claiming to have been masquerading as, a judge, past (living) or present, of the ND or of the 7th Circuit Courts..." Plaintiffs further declare that "This Complaint is not submitted for hearing either in secret, ex parte, or in camera, by any corrupt individual posing as a judge and presiding over the proceedings", etc. They invoke the Social Compacts (already listed) which prohibit such hearings, and which are in "the nature of Star Chamber proceedings".

In Segment #2 the Plaintiffs are described as "residents and citizens of the State of Illinois, a State of the United States, or of other States." They allege that the Defendants consider Plaintiffs to be "United States citizens" and subject to Defendants "jurisdiction", which contention Plaintiffs vigorously deny. Plaintiffs further contend that, due to the nature of the case, it is "appropriate to be designated as Multi-District Litigation or MDL".

The Defendants are alleged by and through Defendant CIR (Commissioner of Internal Revenue) to "have supervised, directed, controlled or substantially influenced all the other defendants who are, or have been agents, officers, representatives, attorneys, employers, operatives, assets, contractors and servants of the IRS, including the Intelligence Division agents, contractors, etc., all over the country who act in concert with them.

Through Defendant DD (District Director IRS), and FEMA and their agents, and agents of the IRS District within the jurisdiction of the Court it is alleged that the defendants have been working in concert for the purpose of "fraudulent and treasonous takeover of the federal administration apparatus, widely called the 'federal government'."

The reasons for the need for, and proper designation of, the case as a class action case are listed. In addition, the Plaintiffs Mark Sato and Thibodeaux are described as "self-educated in

law" who "can adequately represent the class" and are "better qualified than members of the bar for the purpose of the complaint because of the Ninth Amendment claims made under the Magna Charta and because they cannot be threatened with loss of license as would be a certainty...."

The "class" of persons seeking relief in this law suit have been designated by IRS as "illegal tax protestors" or ITP (a designation which Plaintiffs deny) but are so labelled by the IRS. Plaintiffs claim they have been summarily and arbitrarily labelled, without hearing or due process. [Editor's note: This suit is brought not only as an action by the named Plaintiffs, but is "on behalf of all others similarly situated" so as to become an actual "class action" suit of we-the-people.]

In the "Summary Background Necessary to Understand the Jurisdictional Foundation, the Nature and Significance of the Complaint" there are many excellent items listed which elucidate the case. For example, Item 2: "The United States was founded upon a Compact which has as its basis the principle that individuals can never be trusted with governmental power without tight restraints upon the exercise of that power: i.e., that power corrupts individuals wielding such power and every presumption must be against the innocence of the individual wielding delegated governmental power."

In Items 5 and 6 of the above named Summary, the basis of the "Compact" which was derived from the Bible, English Common Law and the Magna Charta are set forth, including some English proceedings against the crown, wherein the governmental administrator or judges fail "in any circumstance" to protect the rights of "any person", or violate those rights. Under some of these proceedings, "Oliver Cromwell caused King Charles to be beheaded and the Star Chamber judges routed."

Item 6 asserts that "the founding of the 'Compact' in this country is Christian in nature and has, as its basis, the Magna Charta and the Bible." I will list those items in the Complaint which clearly show that the "Sovereignty of the People is explicit in the Compact."

1. Declaration of Independence, Par. I—"It is the right of the people...to institute new government...."

2. Preamble to the U.S. Constitution—"We the People of the United States...do ordain and establish this Constitution for the United States of America."

3. President Abraham Lincoln's Gettysburg Address—"Government of the People, by the People and for the People."

4. Christian people are "Kings and priest unto God" (Revelation 1:5-6), who shall "reign on earth" (Revelation 5:10).

5. As governmental officials are servants, the People are unavoidably Masters, Sovereign in relation to said servants.

Further note is made of the laws pertaining to the impeachment process; the level of behavior for which federal judges may be allowed to hold office, i.e., "good behavior"; the impeachment duties of the Senate (the servants of the people), and the reverting of these duties back to the people in case the Senate fails to act.

There are some very interesting comments on Chapter 61 of the Magna Charta, which purports to show that government servants are not en-

titled to Constitutional rights. This is because "Article VI of the Constitution requires an oath of office from all government servants who hold office in this county, and the oath is a pledge of allegiance binding all governmental servants giving such an oath to a contractual relationship wherein they must serve and protect the People, and their rights individually and collectively under the Compact." This amounts to a "basic waiver of citizenship rights in favor of service to each of the Sovereign People". (What does this interpretation do to those governmental officials who have all too easily and often invoked the 5th amendment in order to avoid answering possibly incriminating question? Think about it!)

At this point Hatonn made a very important comment in the writing regarding the significance of the tradition of the Talmudist Zionist "Jews" who now sit on all the benches in the legal chambers and who totally control the Judicial System, yet have the Kol Nidre Vow to "cover" any vows required. In other words, the Kol Nidre Vow voids any vows these ones make, according to their "religion"! In my opinion you cannot have a greater conflict of interest than this in the Judicial System or any other governmental post. When the Talmudist "Jew" takes office he/she promises to serve the people. Within a year, and each year thereafter, this same "Judge" or office holder, takes another vow, the Kol Nidre, to deliberately void all vows or pledges made!

Getting back to the Complaint, having laid forth the above the Plaintiffs review the circumstance of Judges and public servants claiming immunity under the law due to their particular status. The Plaintiffs allege this is "a violation of the Constitution which prohibits the grant of a Title of Nobility", since it represents a grievous and treasonist violation of the oath given to the people. i.e.:

1. Such "immunity" is greater than any protection actually granted by the Sovereign People to themselves.

2. Governmental servants cannot assert a greater shield than that granted by the People.

3. To claim sovereign or judicial immunity is an attempt to vault a governmental servant over the People, a treasonous usurpation of power.

4. Judges, as well as other officials, only hold their delegated trusts pursuant to the Compact and cannot annul the authority delegating it.

However, "where the governmental servants faithfully, honestly, diligently and strictly carry out their duties under the Compact, taking great care not to abuse the delegated power, nor to usurp powers not delegated, per their oath, the People are bound to acquiesce in that exercise."

There are additional comments on the subject of "immunity" for governmental servants as well as references to English cases involving the Magna Charta, etc. It asserts that where the "judiciary is corrupted, Magna Charta principles cannot and will not be asserted by judges, but must be asserted by the People acting on their own behalf under First Amendment principles," as in this case.

We now get into a review of the "higher law"... "written by the finger of God in the heart of man, [specifically] the people of God."

It is shown via a certain case as well as biblical scriptures (I Samuel 8:18, II Samuel 7:14), that "the sole redress against widespread

tyranny...is reliance upon divine vengeance, which operates, in this age, through human agency, e.g., the People."

Further, "the independence of the individual was an outgrowth of Martin Luther's doctrines of the priesthood of the individual, e.g., an individual who is a believer may rightly assert the dominion of God, based on *Revelation 1:5-6* and *5:10*: [Jesus] "hath made us kings and priests unto God and His Father". See also *Matthew 24:14*, which asserts the dominion of God and the Gospel of the Kingdom of God: "and this gospel of the kingdom shall be preached in all the world for a witness unto all nations; and then shall the end come." [*Hatorn suggests here that we, everyone, take a good, long and hard look at this statement!*]

The Complaint further states that "the assertion of the Gospel of the Kingdom necessitates an assertion within political realms, i.e., "in all the world" refers to the worldly political realms in which the Gospel of the Kingdom must be asserted "for a witness unto all nations", that is, as testimony to every political entity of the complete, utter failure of each to conform to the Kingdom standards.

The Complaint asserts that the main instrument which is being used by the Defendants to usurp political power, and which is in grievous and massive treason against the People, is the Federal Emergency Management Agency (FEMA). The creation of FEMA was absolutely forbidden in the Compact and the restraints built into the Compact. Plaintiffs declare that Defendant FEMA et al. have committed treason and genocide against them and all others similarly situated by usurpation of powers not granted or delegated.

There are several assertions which are supported by Appendices to the case. I will briefly list them for your information. That FEMA et al.:

1. Have committed genocide against the People of this nation and other nations, e.g., by knowingly setting in motion disasters which kill thousands and threaten millions.
2. They deal in the "allocation, distribution and...the replenishment of Government stockpiles of narcotic drugs" for their own benefits and in conspiracy with enemies of the People of the United States.
3. Steals billions of dollars of property from the People.
4. Carries out a silent coup against the People via threats to use violence intended to shock or intimidate a large group or coerce a government.
5. Cooperates with and/or employs international terrorists, organized criminals, drug dealers and gun runners.

I quote number 2 under part G. of the Complaint: "In complete and total violation of the Compact Defendant FEMA and its secret team of clandestine operatives and co-conspirators, under sham and pretense of federal authority and various unlawfully and treasonously declared "national emergency-type situations", but without actual authority, treasonously have been planning to impose, and have imposed, martial law, or "martial rule", upon this nation and its People and have staged a seditious, silent coup on behalf of defendant FRB (Federal Reserve Bank) and its foreign owners and controllers.

"a. FEMA is the successor to the various cover agencies for bogus 'national emergency' activity perpetrated since 1933, e.g., the Office of Emergency Preparedness, the Office of Defense Mobilization, the

Office of Emergency Planning, the Economic Stabilization Agency, and the Civil Defense Administration"...FEMA's major functions were, unconstitutionally and in violation of the Compact, delegated under sham and pretense of a series of so-called Executive Orders, but without actual authority."

There follows a list of some of those Executive Orders, which are planned to go into effect at the time of "any national emergency type situation that

might conceivably confront the nation", i.e., "national emergency type situation" is not only NOT defined, "it can't be defined by virtue of its vagueness." The list shows how all the government functions are to be brought under the CONTROL of ONE MAN, the Director of FEMA! [*A Dictatorship.*] Julius W. Becton, Jr. is the Director listed in the complaint.

America In Peril

The tape is of a man lecturing to an empty, secured room and is identified only as "Mark from Michigan". This lecture took place sometime in 1993. It will serve as excellent confirmation to our regular readers, and may even seem old-hat to some. Mark speaks of martial law, the use of concentration camps, rallying patriots, the use of gang members in cooperation with police departments for house-to-house searches with booty thrown in for their efforts, and many other alarming New World Order tactics. Sit back now, lock the doors, and prepare to get mad. Our only information about this tape is what is marked on the video cassette itself: Red World Productions, 7092 Highland Road, #174, Waterford, MI 48327 for \$29.95 + \$3 s/h.

Mark from Michigan:

We will be covering everything we can concerning the New World Order operations inside the United States. We will be discussing the MJTF (Multi-Jurisdictional Task Force) Police, FINCEN United Nations combat forces inside the United States, and the conversion of the United States as an asset for the United Nations.

To begin with I originally worked as an Intelligence Analyst in 1975 through 1981 first with USEC Company D of USEC Fort Huachuca, Arizona. From there I moved on to 5th US Army Intelligence Center where I worked both as an Intelligence Analyst and as a Counter Intelligence Coordinator. Later through the 80's up until present time I command two, both second and third, outdoor brigades which are special warfare units that train US military forces in foreign warfare and tactics.

We are going to start with the MJTF Police and where it came from, what its original mission was, and what its mission is now. Through a series of political actions that started around approximately March of 1989, the Federal Government extorted resources from most of the states, sometimes all 50 states simultaneously over a two week period, passing laws in every state authorizing the use of Federal Funding to convert local and state forces into national police forces. The MJTF Task Force is

in virtually every state of the union of the United States at this time. Its primary mission is house-to-house search and seizure, separation and categorization of men, women, and children in large numbers to transfer to detention facilities and the use of those facilities for interrogation purposes. The MJTF are regular National Guard, local law enforcement, and street gangs converted to National Police Services. Remember this was originally organized under George Herbert Walker Bush. We all know, of course, that President Clinton has purposed a National Police Force. This is simply another name, in fact an over-name for the MJTF Police. Now the model for the MJTF Police is that they are the velvet glove on the iron fist. Anybody who is familiar with some of the speeches that have taken place, ex-President Reagan spoke in England by phone approximately two months ago and commented that the United Nations Forces would be the velvet glove on the steel fist. This is a very popular phrase. It has been used extensively by these people who are within the New World Order operation. I don't know how you feel about this but anytime I've been hit with an iron fist, I usually don't feel too good and a velvet glove doesn't make much difference. It should be noted that most of the resources are being drawn from again, Federal Funding to our regional governments.

The State of Michigan converted part of their forces over on February 11 of 1989 when Senator Carl Levin, the State Adjutant Generals of the states of Michigan, Ohio, and Indiana met in Lansing and at 6:35 in the evening an agreement was struck in which elements of the Michigan National Guard would be deployed in Indiana and Ohio in the event of—in fact it was stated that when firearms are confiscated in the Midwest, that these forces would be deployed both in Indiana and Ohio. Indiana and Ohio would then provide 50% of their Guard forces to police the Michigan area, under the MJTF guidelines. Approximately 3 months after the arrangement was made through the Department of Defense (DOD) in conjunction with other agencies, some of them unknown at this time, the State of Indiana backed out of the agreement. When this took place the Federal Government through a series of funding coordinations withdrew resources from the State of Indiana. They had to restructure part of their Guard mechanism and in the process were able to maintain a good portion of their original integrity concerning their preparedness strength for Guard forces. Three battalions had to be restructured at that time.

Now the MJTF Police are supplied and supported through strategic reserve aircraft that have been transferred to their resource. They will convert almost all of the existing local police agencies to National Police forces after they have riffed personnel they do not consider trustworthy and they will also incorporate street gangs.

Now if anybody has seen the guidelines, and we have copies of both, the original stated that house-to-house search and seizures would be performed by military, law enforcement, and civilian personnel. Now we all know who the military are. That is anybody in a green uniform or a blue uniform with the Army, Navy, Air Force, Marines, Coast Guard. We understand that those will be people in the National Guard Reserve and our active military forces. We know who law enforcement is. These are the constables, individuals that you have at your local level all the way up to and including our secret police in the United States such as the FBI, Central Intelligence Agency, and other agencies that might be at their disposal—Defense Intelligence Agency, etc. Who are the civilians that are going to come into your home? I don't recall there being any guidelines for that in the *Constitution*. If anybody has listened to National Public Radio you will note that on several different occasions, specifically the 10th month of 1992 it was announced, in fact, it was a one hour special program, on National Public Radio about converting the street gangs to law enforcement agencies. We have been talking about this for years prior to its action. We knew that there were preparatory activities taking place, but through these activities a truce was signed by most of the large gangs in the city of Los Angeles. At the time there were negotiations in process in Chicago and this was also taking place in New York. Since the initial action, a full agreement has been signed in Los Angeles and both the Crips and the Bloods are now being trained, equipped, and uniformed with Federal Funding through California. Chicago has finalized this agreement last week. New York is in the process of doing so sometime in the next few weeks and we can assume that they will do this very quickly. These forces will be the cannon fodder. Their mission is to be the forefront for the master forces to come through the door. Remember that the average Federal Agent makes anywhere from \$47,000 to \$57,000 a year. He is more or less looking at his pension. He is not concerned with risking his life, especially if he can find someone to throw in front of him as a sandbag. That is the mission of these group forces that are being organized.

Since last I spoke, probably the best example I'm sure that everybody listening here has heard about is Waco, Texas. These forces that were on the ground, to give you the best example, were not effective fighting forces. When you retreat and leave wounded and dead lying on the ground, that is called a rout. That's not a retreat and this is symptomatic of professional forces that are there for the money. On the other hand, if you use the old medieval pillage principle and you have a profit mechanism set up in which you are allowed to confiscate properties, cars, jewelry, furniture, the neighbor's wife, whatever, then you are

highly motivated to go through that door, and especially if you have been doing it illegally for an extensive period of time and all of a sudden you are given the opportunity to be legitimized. Remember, why let the street gang situation foster or flourish the way it did? We had more than the capability to restrict the street gangs at the time when they came about and most assuredly we had the capacity to restrict them in any way that we wished to. However, by allowing the street gangs to flourish, you create regimentation. Then, the strong come to the top. These are your NCOs and leaders and when you are finished, you simply put them in uniform and you have an organized military force at your disposal. They are thugs but they are expendable thugs! Remember that.

Now, MJTF police operations are, there are several actions that have taken place within the last two years starting in 1991, they participated or were part of operation "Achilles", which was a sweep from the southern Ohio Valley up through to Michigan of ATF (Bureau of Alcohol, Tobacco and Firearms) and MJTF forces to harass and eliminate FFL holders who were manufacturers and producers of components and arms. Their primary concern was not to confiscate or to charge somebody with illegal arms but rather to acquire records and resources that were available and in the hands of the people who held the FFL. In every case where they went into these businesses the only thing that they took were the records of who purchased products and where they lived. Very important to understand. There are a series of other activities that took place after this. MJTF was deployed in Los Angeles during the LA riots, though there was only a slight mention of it, that's the authority they were under along with FINCEN. All of these agencies are overlapping and under the general authority of the United Nations. Remember, we are now an International Organization, not the United States. We are a small corporate part of a big company, a larger company.

In 1992 through early 1993 reorganization was taking place to try to give the MJTF greater credibility. However, it was understood that the mercenary forces probably will not function as originally anticipated so the Guard has been restructured. That, for many people who are familiar with the way the Guard operates, will be able to understand why the Guard is being riffed of experienced personnel. Desert Dust, or in other words what we call Desert Storm, its primary mission (it was threefold), but its primary mission was to see whether or not the American people would eat the New World Order... U.S. soldiers were sent overseas, American flags were taken off their uniforms, flags were taken down by officers in the field, the flag was not to be flown. Most every other nationality was allowed to fly their flag and other than for publicity purposes for public consumption, the general position was that the flag was to be trodden at every opportunity. However, if any of you were watching the news you will notice a lot of Marines were jumping up and showing their patch, which they just pulled out of their pocket, and laying it on their arm and going "see this, this is what I'm fighting for". These people have to be done away with. You can't have these people in the military and so, they decided they would have

to riff these people out, transfer them to Guard. If they are already in Guard units, restructure, reestablish guidelines that would allow them to extract these people from the mechanism. They are trying to go to the next generation of educated idiots. They are looking for people who are going to be more pliable, as Mr. Rockefeller said many years ago, clay that could be molded more efficiently. And since the first or latest crop didn't work, we are now going to restructure the entire mechanism and see what we can get from the next batch. This is where we are going with this.

Now it should be noted that before they can perform any of the actions that are pending, they are going to have to take the weapons that we have inside the United States. I will say again that the meeting that took place in 1989, the Federal Government and the representatives that were there stated unconditionally WHEN we take the weapons, not IF we take the weapons but WHEN! Under that premise everything else was constructed.

Now, there is one that I like here and I'm going to have it put up on the board as we are speaking. A little poster everyone should remember. All those in favor of gun control raise your right hand. There is an interesting piece that just came out that I was most fascinated with in regards to firearms laws. It is a book concerning the gun control act of 1968, in which it has been demonstrated that the gun control act of 1968 was simply an American creation. It was taken from Nazi Germany's gun control laws of 1938, word for word. Now that's very important when you consider this. We are not talking a few paragraphs here and there. The entire document is taken from Nazi Germany's gun control laws of 1938. If they are already at that level in 1968, then where are you going to go with our gun laws now. If you have listened to the people who are talking about this they say that the Brady Bill, for instance, (I'm hoping that everybody understands what that is. That is one of the pending firearms legislations, that's at the Senate and House level right now). It is a good first step. Follow through on this. I don't think anybody likes that idea. If that's a first step then where are we headed?

It should be understood that the MJTF Police is not trusted by the Federal agencies and eventually will be done away with. Again, the MJTF are useful cannon fodder that eventually will be swept to the side.

Moving on beyond the MJTF Police. We are going to back up into them a little bit—there are FINCEN Forces. FINCEN are Financial Crimes Enforcement Network personnel. FINCEN has as much to do with finances as the SAS had to do with airplanes. The SAS (Special Air Service) was a cover name for an entity which existed in England and was the equivalent to the OSS of World War II 1941 through 1945. FINCEN Forces: their mission is house-to-house search and seizure, separation and categorization of men, women, and children, transfer to detention facilities, securing properties acquired, but not the maintaining of detention camps. That will be the mission of the MJTF Police.

I should mention very quickly the detention camps themselves. Originally under FEMA, 23 detention camps were authorized. These

detention camps were spread out across the United States. In addition to that, there are 20 supplemental camps that were authorized with 1990-1991 Military Fiscal Budget. Carl Levin's DOD Budget Amendment 656 authorized the implementation of these 20 camps to supplement the 23 that were already authorized. There are now 43 total camps that are pre-deployed inside the continental United States. In addition to that there are supplemental camps or auxiliary camps through each state and each region, an example of this would be the Nike-Hercules site located near Monroe, Michigan. That is a pre-designated detention facility. The 3 sites that are located in Michigan: (1) Located due north of Pickney, Michigan, due west of Brighton. (2) Earmarked near Lansing, Michigan to be north-northeast. (3) Fort Custer Military Reservation which has been upgraded from a D facility to a B facility. This is very important because a D facility is State authorized and State controlled. A B facility, on the other hand, has been upgraded to Federal status and is comparable to any of our prime military facilities such as Ft. Benning, Georgia, Wright Patterson AFB, any facility that we are presently using for active military forces. However, if you get a chance to tour the highways and byways and back roads of Fort Custer you will find that there is a new urban warfare center there. The new urban warfare center doesn't look like Bad Hersfeld [base], Germany. It looks like downtown Monroe. It looks like downtown Saline. It has 3 bedroom ranch style houses, crackerbox farm houses, small living areas inside downtown areas. At this particular site MJTF Police forces were training from the first week of January of 1989 on. They were training every second and third week of the month from Monday through Thursday. They were paying with non-DOD funds, in other words, these were GSA funds other than regular military budget allocations. It is important to understand how they pay because that's how you can find out who it is that's playing.

These forces operated secretly for a number of months and we identified them as they were training and they changed facilities. We understand after approximately 1 1/2 year cooling time they are using Custer and they are using Grayling again, extensively bringing forces together from other parts of the state, training them on site and sending them back out to be prepared for whatever is going to happen in the future.

We'll get back to FINCEN now. FINCEN was organized utilizing four military forces as secret police forces here in the United States. They are drawn from military and secret police forces overseas. They are predominantly European. We have Belgian, Dutch, German. We are looking at French. We also have a variety of Asian military personnel. It is known at this time, for instance, that FINCEN has an element in Montana that is made up of Gurkhas (warlike Hindus from Nepal). The 197th Mechanized as of one week ago has deployed for a training operation that may last as long as two months in northern Montana through to the Canadian frontier. It is the 197th Mechanized Infantry combined with 2 brigades of British Mechanized Infantry, the First Canadian Armored Division, Gurkha Mercenary Forces, 1

Belgian brigade, 1 EEC Mixed Security brigade and an undetermined number of other forces all foreign. They originally were scheduled to work for approximately 3 weeks in the area but if this is similar to the last mobilization that took place, you will find that they will be there for up to 2 1/2 to 3 months. During the LA crisis that took place there were a series of actions that took place both in Montana and we also saw activities in California, and there were activities in northern Texas in the panhandle. FINCEN forces are ruthless. For example, the Gurkhas are professional mercenary forces from Nepal. They rotate these forces for a period of time out of Nepal and were originally hired by the British military force for a number of years. Now that they are under UN authority of course, they have to find a use for them and they have. Remember the Gurkhas were being paid by the British and probably still are to be used against us. Kind of like the Hessians of 1775, isn't it? I think you will find a lot of other forces with similar perspective there.

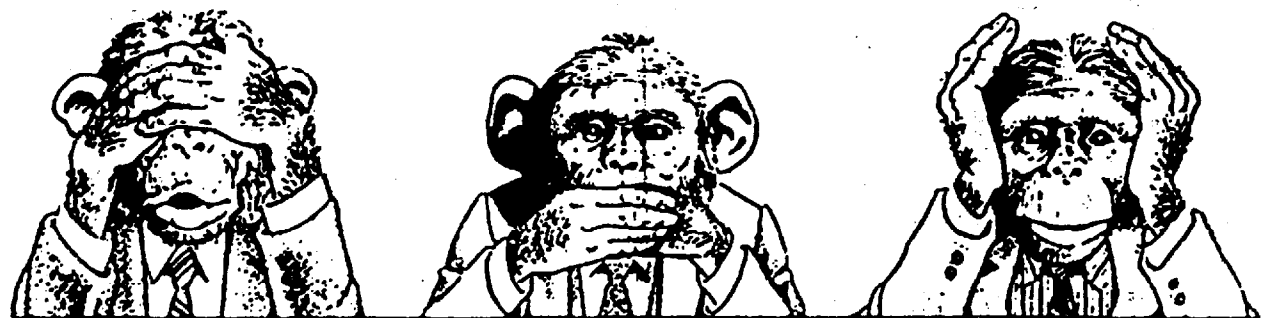
There are, and I will use the regional map here, there are a number of forces spread throughout the 10 regions. For those of you who are not familiar with regionalism: Regionalism is a form of government that we are about to experience if the New World Order people have their way. Under regionalism, Michigan becomes not Michigan but area 5. As area 5 our capitol will be in Chicago. Under the New States Constitution this particular type of government comes into power and we are going to find that all of a sudden we are going to be part of this warm fuzzy New World Order real quick. Unfortunately, we never vote for a Governor again. The Governor will be directly assigned by the President, kind of like in Star Wars. If you remember, that was rather entertaining, Grandma Tarking goes, "The Emperor has just done away with the Senate". And, of course, one of the Admirals goes, "How will he manage without the bureaucracy"? And the Grandma turns and goes, and decides to go, "Well, our Regional Governor shall deal with the problem. Terror shall reign". And most assuredly, terror shall reign! The Regional Governor will not have the same authority over his military forces but he most assuredly will have full authority over his security forces. Unlike the Governors of old he will not have a pocket army, he will simply have police. The centralized military force will be completely under the authority of the United Nations.

Now, how did we get here? Well, that's an interesting story when you think about it because there are a lot of problems that are involved. It's an ongoing escalation of resources pitted against the American people and the Republic. We are a Constitutional

Republic, by the way. We are not a democracy. I think that everybody had better remember that right now. This is a problem you run into even with Republican Presidents. How many times did you hear George Bush say "this democracy". This is a man who calls himself a Republican. I'm not necessarily a Democrat or a Republican. I'm one of those independent American kind of guys.

Here's an example of FINCEN and some of the effects that overlap into United Nations operations. This was on the cover of *Airman* magazine which is the US Air Force publication, July 1992. It should be very evident that the forces that are displayed here on the cover are very impressive. Unfortunately, of the 5 aircraft on the cover only one of them is American. The rest are all Soviet bombers or Soviet heavy-lift aircraft. It should be noted that these types of assets have been reported on by a lot of people in the military who people didn't want to listen to or believe. These are documents that more than verify the validity of comments that were made in the past. The forces involved that we are going to see in FINCEN will be very well educated. They are professional military forces. They are for all practical purposes mercenaries of course. You are going to find that they normally serve an 8-year tour unlike the old American mechanism which was a 6-year tour mixed time of active and reserve component with IRR, (independent ready reserve) options. Instead we have now gone to an 8-year mechanism, the same as all foreign professional forces overseas, very characteristic of the same mechanism that the British used against us in 1775. Conscription through pressing was normally done with an 8-year tour.

There are a variety of different mechanisms. This one was done by a friend of ours which I'd like to also include. I think it is very interesting, it's a whirlpool, actually a black hole. And most assuredly we are spinning into a black hole if we allow this to exist. It should be noted that these people are chipping on despite the types of pitfalls we've thrown in front of them. We will slow them down but we probably will not stop them completely and this will become an armed confrontation. I cannot believe that the American people are going to continue to participate in something like this, not without realizing that somebody is selling the cookie jar. They aren't just grabbing the cookies. Otherwise, what we are looking at right now is an action which is quite sophisticated and has taken probably 50 years to develop, and the enemy has almost reached that point where he can touch the golden ring. Imagine, if you will, going around on a merry-go-round and almost having your hand on it. All of their different schemes, plotting and



conniving have come to a nexus, a point in time in which they have the opportunity to grab everything. To do this they must act quickly. They have windows of opportunity. They are very dangerous at this particular point because there is an old story, "the swift stroke oft misses". That's the problem with this. If we are lucky we can get them to move quickly. If they move too quickly they will show too much, and the American people are not complete dummies and there are enough of us, there are enough patriots out there that are interested in seeing the *Constitution* and the *Bill of Rights* survive that they will participate in the defense of the nation.

There are a lot of military forces that are being sent overseas. Does anybody wonder why in this time of peace we are sending more and more of our military strength to Bosnia-Herzegovina, Somalia, Thailand? And has anybody heard about our forces in Peru? I imagine not. Well, I'll give you a good example. We have 20,000 to 21,000 personnel right now sitting off Yugoslavia's coast or in Yugoslavia at this time. We have approximately 20,000 mixed personnel functioning in Somalia. That's 40,000 combat personnel. In addition to that we have 22,000 to 23,000 in Cambodia. Now we've got 60,000 people overseas and most of them are combat troops. Lets go one step further back during Desert Dust, one of those little actions that was missed by everybody is that during the executive orders that were signed, 18,000 US military personnel were sent to Peru for policing operations there under UN authority. Now this is documented. We've got people who are down there right now. There are families and there are Mothers who are highly concerned about the people that are in place. They have lost people there. People have been killed. This receives no publicity and yet it is going on. It is a prime example of "Watch my right hand". "Hey, you didn't see what was going on over here, did you?" That's what we have to worry about.

These people control the media completely. What I do a lot of times, and I recommend you do the same thing, is video tape what is going on television but ignore what they say. Pay attention to the photographs. If they are really concerned with something they won't feed you much, but in many cases they feel the general population is not observant and there is more in a picture than in all the gobblygoopen words that they have fabricated. You have to ask yourself when you look at pieces of equipment and activities, why is this taking place? Where is this taking place? Is this actually what is going on? If you look at the expressions of the individuals, the activities, the attitudes, you know that something doesn't taste right. A lot of military people coming back are tickled pink to leave Somalia as fast as they can throw their feet on a 747 or 737 air bus. There is a reason for that. It is an untenable situation but it is typical of the type that the United Nations has put us into. Of course, by the way, we are paying the bill too. This is not good.

It should be noted that a lot of personnel who are overseas, and we have personal contacts that are experiencing this right now, are having difficulties bringing family members back or sending family members back from Europe to the United States. We have three

families in particular that are experiencing this right now. They are attempting to send their wives and children out of Europe back into the continental United States and the military will not do it, will not send them. They have not released the dependents, let alone their own husband. This is interesting considering we are not at war and we have no threat of war on the horizon that anybody could pick out short of a few policing actions that are supposed to be fairly minor. I will inject this though, it used to be we called it the Balkans not Yugoslavia and there were a handful of wars there over a period of 50 years and many of your antecedents left Europe because of that. After having three or four of them in a row and losing probably one half or a third of the family, most of the Europeans decided it was time to what we call "un-ask" the AO, excuse me. That was the objective. Now we are calling it Yugoslavia. Right next door are the Moslems. The Moslems are not exactly friendly people to deal with. Given the opportunity and good weapons, they are darn good fighters. Anybody that was in the Korean war knows about the Turks. Those are the people to the east. If they align with the other Moslems, we may have a very interesting experience on our hands. Who will we side with? Well, we'll side with the UN and they'll side with whoever it is that is against the United States. Very simple.

One of the things that I like to incorporate: Good old Fred Rexer, a man to remember and a man to admire: "Be prepared, its later than you think. If you don't think so take a look around you". The amount of force facing the American people right now is approximately the equivalent to several heavy infantry divisions with a couple of mixed mechanized divisions combined. We are looking at a little over 300,000 personnel that we can verify or that we can at least identify in different parts of the country. These forces include FINCEN elements through Montana, northern California, southern California, central Texas, the northern part of North Carolina, Ft. Drum, the Eastern Seaboard including elements that are now stationed around the capitol of the United States, Washington D.C.. There are 5 FINCEN companies deployed there.

I will mention this, we have put a great deal of heat on these people since we have begun to identify them. And I will ask you something, how many people have seen a newsclip every night when they watch the media. Somebody takes one of those nice ski masks and puts it over their head and busts into somebody's home. *Sixty Minutes* did a little piece on this just the other night but it is what we've been talking about for a long time. Who is under the ski mask? If you are wearing a ski mask how do you know who these people are? How do you even know that they are law enforcement agents? Anybody can wear a ski mask and a ski mask hides the identity especially when nobody says anything, and even if they do, how would most people be sure? A ski mask does for a person at 3:00 in the afternoon what the KGB did at 12:00 midnight and 3:00 in the morning, with a knock on the door. It is called terror! And the fact that we would allow that to happen in the United States is a disgrace to our country and a disgrace to our *Constitution*. I'll tell you right now when I was in the military

we were trained to shoot people with ski masks on, if you'll recall. We called them terrorists, bankrobbers, you know, criminals, only in this case I guess now they are hired by the government. It is very important to understand this because we cannot be lackadaisical in understanding the threat. They have progressively, through gradualism, got everybody in this mindset that this is an acceptable situation. It is not. It cannot be allowed, and certainly not be allowed to continue.

If these people are on the up-and-up why not bring them into the light? If these people are doing something that is for the good of the nation why not bring them into the light. Why conceal their activities? Why shroud them in darkness?

Why shroud them in chaos? On the other hand, maybe we want a little chaos. Remember crisis management? Mr. Kissinger brought this up first. Crisis management is a good thing. You are hearing it in the news constantly, aren't we? Crisis management, crisis in Russia, crisis overseas, crisis in New York, we had a bombing, oh my goodness. With something like this, of course, thesis, anti-thesis, synthesis, you create the problem. You demonstrate and answer and you execute the solution. But you have created all three. We are looking at the same thing right now here.

Now UN combat forces. I am going to interject these people right here because all these people interlock and overlap. United Nations combat forces include those that are cooperating with FINCEN at this time in Montana, the elements that are in California. There were 25,000 of them identified south of Los Angeles and are probably deployed north-northeast of Los Angeles in the Sacramento Basin. The elements that were located in Texas have shifted by all indications and are probably spread out through a series of garrisons. The Ohio Valley starting in the Cincinnati area and moving north-northwest have forces deployed there. We know that these elements are also located at Ft. Huachuca, Arizona; there are some at Ft. Benning, Georgia. We know that an element was also located at Ft. Drum, New York.

By the way, our processing center for detainees in the western half of the United States is Oklahoma City. We do not know what the location is for the Eastern Seaboard at this time, however, by all indications Ft. Drum will be the control point for processing individuals to detention facilities on the eastern half of the United States, east of the Mississippi. If there are any problems, what I would recommend for a lot of people that are concerned about this is that we observe the air, not the ground.

What I would like to get into next are the activities and future proposed actions inside the United States by a variety of organizations including the MJTF police, FINCEN, and UN battle groups that will be deployed against the American people. First of all we'll go back to early 1989 when originally in smoke filled rooms, behind closed doors, some committee of political monkeys decided that it was time to go after the weapons inside the United States. In doing so, what they did is decide to come up with a program called guns/drugs drugs/guns. If you have a gun you must be a drug dealer. This is everybody, private arms own-

ers, skeet shooters, whoever. Our response as law abiding American citizens was supposed to be, "Oh, take my guns, I'm not a drug dealer, oh please". Unfortunately, what happened as far as the government is concerned is that the American people started to rearm themselves very quickly.

We surveyed a lot of different shows throughout the United States, Midwest, specifically, in fact in some cases we covered three different cities and two different states within a 10 hour period. What we saw weren't people trying to get rid of their weapons, in fact, that wasn't the case at all. You'd notice that people weren't selling anything and were buying more. It was shoulder to shoulder, elbow to elbow, rear end to front, and heel to toe and everybody was bringing everybody's uncle in to buy weapons, munitions equipment and we saw this from Kentucky and Tennessee to Pennsylvania, to New Jersey to Michigan, Indiana, Illinois. The effect that their guns/drugs guns program had is that the patriots out there started to talk to people and said, "see this is what we told you was going to happen". And after surveying a few shows, I'm sure that the intelligence information coming back to the Alcohol, Tobacco and Firearms people and also from other agencies that were monitoring the gun shows was that the result was not exactly what they wanted either.

More ammunition and weapons passed through the FFL dealers and through firearms sellers at gun shows in the three months of 1990 than within the last fifteen years prior to that at all sales combined. In some cases, over a million rounds of ammunition were sold off of ammunition dealers' tables, thousands of conventional firearms, virtually hundreds of thousands if not millions of dollars worth of equipment such as field gear, boots, uniforms, medical support items. These were all going out and disappearing.

Now it used to be when Fred Shmidlap and Jim and myself would go over to a gun show, we'd go in and, "well lets go buy something". We'd go buy it and take it home and fire it up a little bit. We thought it was neat but it was that vogue toy for the month. We got done with it, we might take it back in and sell it and go buy something else. It was a used firearms market. Today there is no used firearms market. There is a reason for that. Everything that is in the hands of the people is being absorbed. This is happening right now again. It is as if somebody cut an artery and the weapons are just gushing out. In fact, the people cannot keep up with demand enough. Now because of this they are getting a tad concerned again. The effect of the guns/drugs drugs/guns campaign should have been for people to just hand things over to try to dispose of the weapons because they were fearful of being prosecuted by the government.

When in 1990 it was realized that they weren't exactly accomplishing their original mission they had to change their time table a little, we think. By the third month it was realized that the militia forces civilian arms were burgeoning at a massive proportion. The structured forces inside that were deployed included operation "Achilles", which we mentioned before. They began to reduce their actions because of notoriety and the fact that

they were seeing more aggressive stances on the part of the civilian population that they were attacking. Unfortunately, like cockroaches, you can spray and they keep coming back. So by late 1992 the latest guns/drugs drugs/guns campaign escalated with a variety of other actions overlapping. It's a threat to your children. (Well, not if you train your children properly.) It's a threat to society. Well, this society isn't monarchical England, it isn't Pharaonic Egypt, and we most certainly aren't the Union of Soviet Socialist Republics. Because of that we trust our people with firearms; in fact, we are the government, therefore we are the ones who decide who should have firearms. I think everybody forgets that we, the people have an obligation and responsibility.

Now during this time from late 1992 to the early part of 1993 we have seen a series of other actions take place in which firearms confiscations house-to-house, door-to-door have taken place. Operation "Clean-Sweep" in Chicago, Operation "Achilles 2" in Cleveland, and a series of actions that took place after the Los Angeles riots, not against the street gangs but against the citizens who defended their homes and their businesses. Remember the Koreans who were on top of their roofs. Strangely enough the government used the video tapes that were made to track down these home owners and they are now being prosecuted for using their weapons to defend themselves. And this is an ongoing program. You are not seeing this in the general media because it wouldn't exactly hold well with the rest of us. Because of this it is realized that they are going to have to intensify, in fact, have intensified their campaign.

During the earlier phases, for instance in Chicago, the black helicopter missions that we were talking about in the earlier hours were taking place extensively. We have individuals who were in high-rises who were actually above helicopters flying between the high-rises in Chicago, in the windy city. These operations culminated in a final activity which lasted approximately one week in which they cordoned off neighborhoods, went building to building and house to house, entered forcibly if necessary, and prosecuted the owners of any firearms, ammunition, or gun parts found. This was operation "Clean Sweep".

In Cleveland an activity which was covered only by National Public Radio involved elements of the MJTF police and probable FINCEN forces. The Ohio Guard was mobilized from several different areas of the state, transferred to an area outside the Cleveland airport where a moulting area, an urban warfare training area was set up with three neighborhoods. The units that were brought in were trained in house to house search and seizure and securing a neighborhood. They then went into the first training neighborhood, went house to house, secured the neighborhood and then attacked the second neighborhood. Once they had secured the second neighborhood they had to hold the first two and went to get a third neighborhood. After these elements were trained and passed through this mechanism, they were transferred to different parts of Cleveland where they were actually deployed against the population.

This happened about the same time that the Weaver incident took place in Idaho. It was almost simultaneously. In fact a series of actions both in Cleveland and one here in Michigan took place either during or shortly after the Weaver incident. Now in Cleveland this received media coverage. In some part of Ohio this received media coverage but it received no national media attention except for one place, National Public Radio, who thought that this was the next best thing to sliced white bread, that they had violated people's homes, that they had gone into different parts of the city and that they had done this. Now interestingly enough we were challenged on this but in the last three weeks, when the Alcohol, Tobacco and Firearms forces came into Detroit to search house-to-house in specific neighborhoods, it should be noted that National Public Radio on the 11th of March broadcasted another one hour program in which they specifically mentioned that if we can do it in Cleveland, why can't we do it in Michigan. Now I had to ask people when they heard this broadcast what were they talking about, what happened in Cleveland? We knew but nobody else did. The enemy only refers to their victories very quietly after they know that they have secured the action and they have been successful, otherwise, no comment made.

The Waco situation which is typical of a lot of what we are going to be seeing in the future, although, I think you are going to see more ham-handedness, involved a 100 to 130-man assault company of the Alcohol, Tobacco and Firearms, probably under MJTF authority again. It should be understood that as of March 1989, the ATF, Alcohol, Tobacco and Firearms forces were divided up into these assault companies. Each platoon consists of 40 men armored with the M16-A2 rifle, the AR15-9 millimeter conversion, or the M79 grenade launcher. It is now known that these forces also include the M60 machine gun, which is an infantry battle weapon now being deployed with policing agencies, you know, like they have in Russia. It was interesting to note that this assault company in Texas was identical to the type of forces that were used during Operation "Achilles" in the Ohio Valley coming up into Michigan. The forces are in all black BDU uniform. They wear the black pasgan armor with the black pasgan helmet which looks quite a bit like the German colscuttle. They are armed, equipped and maintained through DOD resources. So, many of the weapons that they are provided with are actually provided by our military. In many cases, Alcohol, Tobacco and Firearms, the FBI, DEA are now receiving training by Quantico Marines and many of them have gone through the US Army Ranger School. That is rather exotic training for people who are supposed to be police officers in the United States. On the other hand if you again need thugs, you've got to send them some place where they can learn to be fairly efficient thugs. Many of the people that we've had that went through Ranger School in the last one year said that up to 50% of their company were made up of Federal Bureau of Investigation people and individuals who were involved with Alcohol, Tobacco and Firearms or Drug Enforcement Agency. Now, DEA, by the way, has what we call CLET units. CLET

units are directly under the control of the Treasury and/or can be accessed by the MJTF police or FINCEN. CLET units are armed identically to the ATF combat elements and are deployed throughout the United States and can be used overseas. DEA is now using extensive resources from outside the United States in terms of manpower but they will not identify what the name of the organization is that's being used. Now remember, we know what FINCEN is but nobody else is supposed to, so it can be assumed that FINCEN is the element that is involved.

How are they deploying equipment here? Well, its kind of strange. A lot of people say, where are they? Well, they are in all parts of the United States but we've had at least one face to face confrontation with some of their people right here in Michigan.

In fact, though I can't mention names, on a given date one of our people was attempting to use a space-available flight through US Army Tactical Lift Command. Upon arriving at the site they gave him his military ID card. Somebody punched in his name, looked at him very briefly and went and punched it in again. In a minute and a half there were two MPs behind him. Now this site is Selfridge Air National Guard. The individual was then taken and put in a car, driven around to the southwest quadrant of the Post. When he arrived there, the MPs took him out of the vehicle and as he entered the structure the first person at the table, at the entrance desk was in all-black uniform with no identifiable insignia or markings at all. He was then taken to an interrogation room. Now at first he's going, "oh my goodness, what did I do?"

"My ID card must be messed up or something." Upon seeing the black uniforms he understood exactly who he was dealing with. He was sat down. The first thing he was asked was how many cars do you own? How much food do you have? How many weapons do you own? What are the names of your children? What does 762 x 39 millimeter mean? He really didn't know. Well, he really did but he thinks in inch not in metric. Then there was a little conference and they left the room. Well, they left the room and they left a file sitting on the table. Anybody that is involved with military knows that you don't do that. Your career rests on security but it should be understood that in this file—he dragged it across the table, opens it up very quickly and there is a big rap sheet about 2 1/2 ft. by 1 1/2 ft. tall. On this sheet was a spiderweb of names of people to be arrested. My name was at the top for the State of Michigan; so I can be proud I'm #1 in trying, I don't have to try harder. Number 2 was another individual that was with us. Number 7 was the individual who was being questioned. All of the other lists had virtually dozens and dozens of names. It should be understood that it was meant for him to see this and it was a direct threat to anybody else who is prying into the affairs of these little goosesteppers. The gentleman made a little rattling noise at the door and came back in, sat down, and basically told him, we have nothing to hold you on. We are going to let you go. Walking back out two MPs appeared, picked him up, walked him back over to the vehicle, drove him around to his vehicle and he left the Post.

Now anybody that understands military documentation will understand that if you have a classified records jacket, you take a classified record sheet and put it on top, first of all. (That's if you just have it laying around on your desk.) The next thing you don't do is take a classified document and leave it where somebody you really don't want to see it can see it. This was meant as a direct threat. This was just before we were involved with other

meetings that we've participated in that we were illuminating people to this subject. If I keep this up, they are going to do something to me. Well, I'll tell you what, I'm not stupid. If I'm already on the list as many other people are, look at it this way, you are never going to come off that list. Ok. Your butt's in the fire and you might as well fight and go for broke cause you ain't got no place left to run. It's that simple. [To be continued.]

RUSSIANS FEELING THEIR OATS

A new political superstar has taken front stage in Russia with an appeal to populism and nationalism. His win in the recent elections has the internationalists reeling. [H: Gosh, and I bet you thought the troubles of Clinton revolved around his cast-off underwear!]

NEW YORK—The surprise victory of Russian nationalist Vladimir Zhirinovskiy—the first populist candidate to sweep the national elections of a major power since World War II—has sent the White House into a "tailspin" and the Establishment media into a "deluge of misinformation", Russian delegates at the UN headquarters here assured the *Spotlight's* diplomatic correspondent.

Zhirinovskiy, whose one-man campaign rolled over President Boris Yeltsin's well-oiled political machine when voters went to the polls across Russia's 11 time zones on December 12, is neither an "extremist" nor a "warmonger", said the delegates. [H: You see, they are not as "advanced" as are you nice computer-driven people. The polls reflected the election because of lack of "fixed" equipment. You could do this too, Americans, if you demanded back your paper vote and kicked out the tinkers and computers which have the election results fixed long, long before election day.]

"Most of what Americans are told about this historic event is wrong or intentionally misleading," asserted Yevgeni Torogin, a veteran political reporter from Moscow who now covers the world forum. "Zhirinovskiy is not a demagogue. You can call him a 'radical' only in the sense that he makes us confront the root causes of our troubles."

The nationalist candidate's willingness to address the reality of the lives led by ordinary Russians—beset by poverty, social disintegration, run-away inflation, rampant corruption and systemic gangsterism aided and abetted by ruthless exploitation by Western banks—has won him at least 25 percent of the popular vote, well ahead of the Yeltsin bloc, according to early ballot counts still in progress as this

issue of the *Spotlight* went to press. Interestingly, the army units that backed Yeltsin during the recent parliamentary crisis voted overwhelmingly for Zhirinovskiy.

The U.S. media's denunciations of Zhirinovskiy as "anti-democratic" or "neo-fascist" sound laughable to most Russians, Torogin said.

"We already live under a president [Yeltsin] who has sent tanks into the streets, burned parliament, censored the press and seized dictatorial powers—and did it all with U.S. support," he explained. "I don't see how you can be more anti-democratic than that."

Zhirinovskiy was reportedly ignored or dismissed as a maverick by the Western megabankers, corporate lobbyists and currency speculators who provided lavish campaign financing for Yeltsin's supporters.

Their favorite newsmagazine, the weekly *Economist*, did not even mention Zhirinovskiy among the 10 leading candidates in its pre-election issue.

Zhirinovskiy is a critic of Israel, and he favors imposing "limitations" on the growing power of the ministate's lobbyists and promoters in Russia. "That was enough to make him a 'non-person' in the U.S. media," says British newsman Andrew Rowe, an old Moscow hand.
