Dole starts off his letter by saying to you, "My Fellow American". Well, right here and now is the time to make Dole's terrible lies and deception clear—lies that in his arrogance he does not even hesitate to put in writing.

have that happen.

Jeff: This is one to two years prior to Operation Desert Storm?

Peter: That is correct. Now, what is very important and how this ties together with, again, the headquarters for IBI (Ishan Barbouti International) was in Houston, Texas at the Gold Building, as it was called for many reasons—for the flow of money—but at 777 Post Oak Bldg., downtown Houston. I hear the building is abandoned at this time. It's a large office building. However, the Barboutis had holdings throughout the United States and, as you spoke with Joyce Riley, you know of the other biologicals that were developed in the Texas area and tested on the Huntsville prison inmates.

In Florida the specific strain, as there were several of them, of the hydrogen cyanide was called Prussian Blue, and it's very key in that Prussian Blue was being tested on gas mask filters about a year-and-a-half prior to the Persian Gulf War. So, that's very, very critical.

Jeff: I see. What happened next?

Peter: As things were going, how I got to know what I know and the evidence that I acquired is, I took the initial concerns to the CIA, the FBI, and U.S. Customs and actually operated for the United States Government under a code-name. I was told that IBI—that these people were international terrorists and that the government was going to prosecute them. So, I was misled actually because, as I began to acquire my evidence—and I don't think anyone thought I would take it to an extreme as to bugging phones and doing other types of things like that, especially recording conversations of federal agents which I acquired—conversations with CIA, FBI, counter-intelligence, Customs agents, attorneys, members of Congress, people all the way up to the White House—calls from the United States to London and Baghdad. I amassed a lot

of evidence which, in putting it together, found that in fact, this was not happening covertly in the United States but with the knowledge, consent, and assistance, and actually, what you would call a joint-venture with U.S. Intelligence and the United States Government.

Jeff: Do you remember the time when that realization really hit you?

Peter: Well, yes.

Jeff: And wondering how you felt at that time? Betrayed, duped, deceived?

Peter: Yes, very much so, betrayed. And as a result, I lost my wife through that and I lost a lot of other things, but very much betrayed in that I went to the people, I thought, who were to protect America, to protect what was happening. And, in fact, what I was doing was going to the enemy. I

was turning over information to people who knew what was going on and were involved in it and basically, I guess they wanted to know how much of a leak there would be, what I would do and what evidence I would acquire. As a result, two weeks prior to the war with Iraq, on July 16, 1990, I refused to believe that the entire U.S. Government was involved in this conspiracy. I sent a Federal Express package to the National Security Agency to code-name M323CF and I issued a warning that Iraqi intelligence was operating in the United States and in close proximity to a classified military project and I asked two very deadly questions in writing:

(1) Is our military in a joint-venture with IBI to develop chemical and biological weapons for the U.S.? And,

(2) Does the President know?

As most people should be aware, Mr. Bush has claimed to have been left out of the loop on prior occasions when he was accused of criminal wrong doing...

Jeff: Don't they all?

Peter: Yes, sir, but he is the master of this act. Of course, I already knew the answers. I wanted something from them. What I got from them was a visit by eight Nazi-Gestapo federal agents with automatic weapons

and tape recordings from my place of business and I was threatened not to discuss this with the media.

Jeff: Or?

Peter: Or else, ok? Let me say that, at this time, I have a suit against federal agents and agents of FinCEN and U.S. attorneys and although I can speak very candidly about most things, there are some things that I will dance around only because it is evidence yet to prosecute people. As a result, what they did with the evidence, however—this was in early 1990—they sealed it and made it "national security" and to this day, actually, it is still national security. No one has been indicted or prosecuted and no evidence was ever presented to a Grand Jury to prosecute anyone, although I was subpoenaed to at least three Grand Juries, supposedly inquiring into the criminal activities of IBI and was the star witness for the U.S. Government.

No one thought that I would live for five years or the last four years, and I did, just barely. I've been hospitalized and attempts made on my life including attempting to blow up my vehicle. My wife suffered. I suffered a loss of my wife as a result of that. After four years I have been able to unseal that affidavit. I do not have the evidence; it is still considered national security. What the unsealing has done, it has basically been discovered to be a signed confession by federal agents and the U.S. Government in that they made a very, very strong case to the Magistrate in 1990 before anyone was harmed in Operation Desert Storm. And in the document, they actually are confessing now. What they are stating is they knew what was going to take place in the Persian Gulf. They knew about these weapons. They knew about gas mask penetration. They know all of these things that we've just been talking about and how the biologicals were developed and delivered on our troops with the mask penetration agent, Prussian Blue. If you remember when CNN aired some of the goings on about the Gulf War, there were some question brought up to President Bush as to why he did not wish to change the gas masks of the American forces to the same type of quick-change gas mask filters that the coalition forces had. And, of course, the public did not understand why. It really didn't matter whether you had a ten-second filter that you could change or a thirty-minute filter—it didn't have anything to do with it. You were going to get your dose either way. So, there were many things that took place during the war that, again, we just did not know, as far as the public.

Jeff: Peter, two things, and I hope it's not too personal. You mentioned twice that you lost your wife; what exactly happened?

Peter: It is a warfare agent that was used against her and that is evidence in my suit to prosecute these people. However, after she died I received a phone call from an agent delivering a message to me. Several threats were made on my life, including that the Pentagon issued a warning to me which came by the way of a Mr. Dave McMichaels at 2001 5th St., NW, Suite 740, Washington, D.C. phone number 202-483-9222. Part of the message goes like this: "Tell Peter Kawaja to chew on it. If he comes forward, we will deny. If he has evidence, credible witnesses will come forward and testify against him." That's the non-death part of the threat. This was after they had relieved me of documents and they were doing the "what if they didn't get it all?" As Joyce Riley told you, when she tried to call for a Congressional investigation with my documents, the only thing the National Security Agency wanted to know was, did they get all the copies of Peter Kawaja's evidence? And that was the only thing they were concerned about.

Part of the reason I am still alive today is that I am more dangerous dead than I am alive. I'm sure they're aware of that, although it doesn't mean they didn't attempt nor would like to still see me dead.

Jeff: They killed your wife. They've threatened you. You have somehow managed to protect yourself by making yourself so dangerous they would rather have you alive. This has been an ordeal that few men or

women could go through. I wanted to ask the other question. Do you feel that, at some level, somewhere, American troops were sent over there with the full knowledge they would be used as guinea pigs to see how this stuff played out in large laboratory settings?

Peter: Oh, definitely, definitely. It's not a matter of question, and by the way for the listeners, I mentioned I have a suit.

There are two cases going on right now. When I speak, I speak from authority.

First, as being someone directly involved and doing work for the government in amassing the evidence. Of course, they never thought I would amass what I did, and/or dare to bug certain

buildings or phone lines or acquire intercepted transmissions for the CCC-BNL from Switzerland, so my story is very lengthy. It couldn't be covered in one show. The evidence that I have proves what was to take place in the Gulf War and that, in fact, the Persian Gulf War was orchestrated several years in advance and you run down the players who are put into place and these people who are moved around to include John Deutch, who is now the CIA Director, who used to be involved—he's a professor of chemistry at MIT and chaired the Defense Science Board. Brent Scowcroft who was a

consultant to the BNI. Scowcroft and Lawrence Eagleburger and James Baker, who were on the payroll of Henry Kissinger/Kissinger & Associates. Scowcroft and Kissinger, actually, wanted to go to war immediately with George Bush when Iraq went into Kuwait. Dan Mica, former member of Congress, also a Kissinger Associate—we recorded many conversations of politicians who came

into town and I also bugged the corporate apartment, which was the guest suite for these officials, in meetings in very expensive, lavish surroundings and restaurants. H a i d a r Barbouti, the doctor's son, is

discussing with members of Congress about the cyanide and dumping it into the water supplies in the United States and they refer to it as "Cyonara". So, there were several agendas that were taking place and, in fact, the unsealing of the affidavit now proves that warfare-grade, free cyanide was dumped into the city of Boca Raton's water supply. There may be other places that I cannot discuss and other things that were dumped down. I have since found that the city of Boca Raton has gone into the plant, poured cement down the drains, and has been going there periodically to take water

sample tests in the area. What people need to know is that the plant, when it was shut down in 1990, after I broke the initial story publicly—what happened is that the RTC took it over. Then, mysteriously, Century Arms International appears on the scene to have occupied the building. You need to check out their background and ties to CIA and British MI-6. They were flying the British flag over that building until I released a document and made it public about what was taking place there and I have personally videotaped and taken pictures since, because I live in Boca Raton, of missiles that are being stored in a residential community—in the same place where a warfare plant was—in the heart of the Jewish community for South Florida. So, the public does not know any of this. [see box]

Jeff: Well, Peter, they're going to know a little bit more of it after tonight. [Break]

We're talking about some horrifying things. Peter, you just told me a moment or two ago that you actually have tape recorded Congressmen and a relative of the Barbouti family talking about cyanide in drinking water in Boca Raton's water system.

Peter: Yes.

Jeff: Why?

Peter: Well, it's not just cyanide alone, by the way, and it is warfare grade, what's called free cyanide. That is also the same ingredient that is common in what happened in Switzerland, Waco, Japan...

Jeff: In the subways, you mean?

Peter: Yes, all of these—also the World Trade Center bombing...

Jeff: There was cyanide in that?

Peter: Yes, sir. What happened, why it did not kill as many people, if you go back to the early reports—I could fax you a copy of the document—but the judge prosecuting the case stated that the bomb—the terrorists made a little boo-boo—that the bomb was so powerful that the tanks of sodium cyanide did not vaporize. They were exploded and blown away. So, there was a two-fold purpose of the bomb. If in fact the cyanide had vaporized, everybody in the north tower would have died, so it would have been a worse disaster than the Murrah [Oklahoma City] Building.

And, by the way, of course we're jumping ahead but there is no way to tell this in a sequential form...

Jeff: There's too much information.

Peter: At the Murrah Building [bombed], the V.A. hardfiles that were being kept on the returning Desert Storm veterans of their illnesses, the critical ones, were transferred to the Murrah Building and, gee, wouldn't you know? They got destroyed in that building.

Jeff: So the Gulf War Syndrome files are gone?

Peter: Yes, sir. Along with, of course, the NBC logs which are the nuclear, biological and chemical logs; the government is now claiming that some of them got accidentally burned.

I would like for the government and Janet Reno and Louis Freeh to know, of course—this message is for them—they know they have come already with an illegal warrant. So, nothing is at my home. I have miscellaneous copies but somehow, someone sent me more than 10 pages, I won't say how many hundred pages of the NBC [Nuclear/Biological/Chemical] logs before they were destroyed—proved several things: that GF [a nerve agent] was found by the Israeli military police, although the United States continues to deny the existence of GF in Iraq's arsenal after the Persian Gulf War, and that the MSDS on GF originates at the U.S. Army Chemical and Biological Defense Command at Edgewood Army Engineering Center, Aberdeen Proving Grounds, Maryland. It's very, very critical.

What people need to know also is that the PB pill, the Pyridostigmine Bromide pill was not to counteract Soman, as stated by the DOD, but was to counteract GF. That's why that is very critical.

Jeff: Which was given to hundreds of thousands of troops.

Peter: That's correct. So, again, proving what was going to take place in the Persian Gulf War. In other words, if you know what is going to be deployed on troops and you prepare or supply them with, supposedly, the antidote, that was part of the test and only one.

Jeff: You're talking about a big laboratory experiment here.

Peter: Very big. You don't need 700,000 troops to take out a tiny little country like Iraq and, in fact, it proved itself out that we waged an air campaign rather than a ground war. That was planned, of course; there was a build-up over a long period of time.

Getting back to—prior to—the crimes. I would like to name some more criminals for the American public. As they were trying to take my evidence from me, one of the tricks I was referring to, a Trevor Armbruster, who is the senior editor of *READER'S DIGEST* as CIA, who arranged with James Baker III to fly me, and these were the words almost verbatim, "James Baker is waiting. We're going to fly you and land you and deliver you right on the steps of the White House." Of course, you understand the only aircraft that could land on White House grounds would be the Presidential choppers. And, James Baker was waiting for me; however, there was one stipulation—I had to bring all of my originals.

Jeff: Oh yeah.

Peter: I did not accept the offer. Howard Hebert at Defense Imaging and DBA Systems, a Defense contractor in Melbourne, was a very close friend of Brent Scowcroft. So, Mr. Scowcroft and Mr. Bush are not going to be able to state that he was left out of the loop. They were relayed information from me. There is just so much evidence as to what took place and, in keeping in line with the players, Janet Reno, of course, was moved to become Attorney General. Those of you who are familiar with her activities in Miami, Florida—she is from Miami, Florida as a prosecutor and person that covered-up VOTESCAM. Are you familiar with that?

Jeff: Yes, yes. She's got, allegedly, an incredibly sordid, immoral past.

Peter: Very disgusting, immoral past and I, of course, being the upstanding American I am, I would not lower myself to talk about the terrible things they talked about when they were doing this Clarence Henry Thomas thing because if I were, I would mention things that Attorney General Janet Reno was found in awkward positions with young females—of course, I won't say that. Certain Miami police approached me with pictures and things like that, but I won't talk about Janet Reno in that manner. She hired, knowingly as Attorney General, John Hogan to investigate and write the BNL Task Force Report and I don't know if you've seen that report. However, John Hogan was also, gee, a Miami attorney. And, also, happened to be a Miami attorney that represented none other than IDI, the Barboutis. So, naturally, the BNL Task Force Report on Iraqgate, the only section in the BNL Task Force Report that is considered national security is on, guess who, IDI. So, the Attorney General of the United States—as far as I'm concerned and I would like to charge her with felonies, multiple felonies—has lied to the American people. Not only is she the butch-er of Waco, but she has perpetrated many crimes against Americans in knowingly hiring an attorney who the government—and, by the way, I have secret, government documents, U.S. intelligence documents, Dept. of Defense documents that prove the United States Government itself state and prove—not me—I would not dare call Haidar Barbouti and Dr. Barbouti terrorists, even though they are. The United States Government has proved that, and yet, the Attorney General hires a Miami lawyer who worked for the same terrorists to write a report in such a manner that nothing took place in

Desert Storm.

So, that will give you an idea of what's going on. Of course, James McAdams, the U.S. attorney who handled the cover-up of the BCCNL [CCC-BNL?], was also moved to Miami to also hide and cover up the Noriega scandal, which was drugs; and then, was moved to West Palm Beach, to, when I opened my lawsuit against federal agents, to cover-up Iraqgate and Gulf War Illness. When the process server went to serve the U.S. Attorney Tom O'Mally there and other agents, we found that Mr. McAdams was conveniently recalled to Washington on a special one-year assignment. His secretary is still there. His office is still in West Palm Beach but he is conveniently not available.

So, that will give you just an idea of a few players and I name them from the CIA all the way down. I am involved in the criminal aspects of it now. Let me say that I received in 1995, March 29, 1995, in addition to my suit that I have filed against federal agents, from the Inspector General, Dept. of Defense, a letter to me

regarding some evidence that I sent to President Clinton. They make mention of that and I have the document that I could send to you. President Clinton, apparently, turned over the evidence to the Dept. of Defense, and they issued a case number to me—95-L59724 and opened up a case under my name regarding the Persian Gulf War. I was told that is highly unusual, however, I am not sure what the trick is here. I have called at the Pentagon, the same Pentagon that threatened me several years ago and they have until 9/20/95 before they will release any information. However, that will give you an idea that I think I have a few people worried as to what is going to happen with my evidence. [see box]

Now, what has happened with my suit is that the United States Government has appointed powerful U.S. attorneys to defend these criminal agents. They responded by putting in a Motion to Dismiss my complaint. They did not deny my charges. What they are stating is that even if the defendants committed misconduct—treason and war crimes—that's a new word, buzzword is "misconduct", they should

still have immunity. Now, what happened with this response, I was given one day to respond. The judge—they pulled a trick—there are many illegalities they've done against me. I am fighting these powerful people—but it proves that they cannot fight me or fight the truth. When they responded with this, the judge then sent a separate order, ordering me and giving me one day to respond to their Motion to Dismiss. I fooled them and walked into the federal building and filed a two-and-a-half-inch-thick document with evidence, within the one day. Two days later I received a telephone call from the judge's secretary. They canceled the hearing that was to take place in another two days; this was in March of 1995. I filed a Motion for Continuance and they are in Default and have not continued. What they are doing is stalling either to kill me or hope that this will go away, or in fact, when they did that Notice it was done in March. And, conveniently, the Dept. of Defense issues me on March 29, a case number all of a sudden. So, what they are saying is that there is an ongoing investigation on criminals and on terrorists and that is the way they can keep my evidence as national security. Because as long as they claim there is an on-going investigation they cannot unseal any documents.

Jeff: It sounds almost like, Peter, they could also volleyball you around until the cows come home, if they really wanted to. It's got to be very frustrating for you. You're an extremely courageous man, brave; I don't know what word to even give you. But, you are obviously a man of great resolve and integrity and I think they know that.

Peter: Yes, they tried to buy me. I was offered, through another deal, a hundred-million dollars. I was offered untold sums of money. I was even recently offered a contract with the V.A., of all people, which I turned down. That was something that came through the President's office, I won't go into greater detail. But, this was an attempt to buy me off with a lucrative contract if I were to help Desert Stormers, of course, and compile the evidence for the government to help them to save these Gulf War veterans. Well, I don't need to do that because I am helping Gulf War veterans and I am not going to collect the evidence for the same government that is trying to kill Americans.

Jeff: Peter, we're going to have to pause for our next break. We're talking with Peter Kawaja on the Gulf War Syndrome, which comes from Operation Desert Storm where troops, maybe 200,000 people now infected with organisms that were generated by the Iraqis as warfare measures, which in turn and prior to that were manufactured, apparently, here in the United States and sold to the Iraqis prior to 1990. Peter, how many different biological warfare agents have you come across that you feel were involved in the war?

Peter: That would be a piece of evidence I couldn't say, however, it wasn't a matter of just—let me clarify something. There are two types of tests, actually more than two, but it wasn't just what was sold to Saddam Hussein. It was a matter of things that we developed ourselves that we tested on our own troops and, in fact, some of the vaccines—I'm not sure, are you familiar with Abe and First Flight?

Jeff: No.

Peter: Those were two horses that were originally pastured in Minnesota by the Joint Chiefs of Staff who became, all of a sudden, they became, I guess, ranchers. But these horses were being shot-up with anti-botulism, gradually increasing where they could take a hot toxin shot when one dose would kill a thousand horses. That's where they got the plasma. Eventually, they were moved to Ft. Detrick, Maryland and under the Joint Chiefs of Staff supervision that had at least a hundred horses or more that I can document from where they got the plasma for the vaccine.

Jeff: These horses could take botulism and survive it, you're saying?

Peter: Yes, sir.

Jeff: Unbelievable.

Peter: It is, sir. But, you know, we would get into another area of an anaerobic cell and what they are looking—you know, some of these babies that are deformed—babies that are born. That is a specific—that is one of the tests, by the way, being able to have someone either grow limbs, like a lizard if you cut the tail off and the tail regrows—it's sort of genetic engineering or manufacturing human bodies where you can have people with or without specific limbs and that is what Joyce Riley is talking about. It is not just an accident. There were many tests that were conducted in the Persian Gulf War. There are certain drugs that are now available, one of them for the treatment of Alzheimer's. The problem that the DOD is going to have with me and the FDA is that, where are the years of human trials? What happened is, in the Persian Gulf War, some of it was for military purposes and control of world population and things like that. Another part of it was for money and to test certain types of weapons and/or drugs that they would need—it would be illegal, in other words, to do that in a civilized society.

Jeff: Yes.

Peter: You wouldn't be able to do that. But they were saying, well, we have this war. It's a crisis. We don't have time to check out whether it is safe to administer this or not, so that's where we come in with this "informed consent" waiver that they were asked to sign. Basically, what the military did to all of our Desert Storm veterans is say, "Hey, we're not telling you what we're really doing but why don't you sign this little piece of paper because what we want to do is make you a rat and we're going to experiment with you in this war." It's just a crisis, you know, although the war was planned, you see?

Jeff: Yes.

Peter: Much of this is evidence that I have and it is just very, very sad for me to know what I know and to have gone through that. It is just unbelievable and my heart goes out to Gulf War veterans, but it is more than that. At this stage, what America needs to do is understand that I am talking about crimes perpetrated, war crimes, greater than any other crime in the history of the United States of America. Crimes against Americans, perpetrated specifically against Americans by supposedly the people who are suppose to protect us. You cannot leave this end here. You cannot just say the civilian population always wants to think it will not effect them. This is not only about military. This is a communicable disease. It is a slow form of Ebola Zaire. It transforms itself into all forms of cancer, and ultimately, death. Where it will go is death. It is not something which is just Chronic Fatigue that a lot of people think it is. So, it is a warfare agent by design and it is going to kill an immense amount of people and there are hundreds of thousands of people around the world now that are sick and dying. There is just a uniform black-out by the normal media about this; it's just terrible. They're not carrying the information. And if you heard about these individual staph, strep and TB outbreaks, these mini-outbreaks that you are hearing—that is part of the Gulf War Illness. So, I don't know if you've had any of that in your area but I am hearing it all over and the streptococcus...

Jeff: Sure, Group A strep, yes.

Peter: Yes, sir, and the flesh-eating. All of that has to do with the Gulf War Illness. As a result, if you would check, there have been so many outbreaks since the Persian Gulf War. Now, what the government is preparing everyone for is—I saw a TV program about two weeks ago and they are admitting or preparing America that it is not IF but WHEN will there be a world-wide outbreak. And they are trying to say that it is because of this international air travel that somebody is going to bring back the Ebola. In fact, all of these are warfare agents that were tested on people and in foreign countries. And it is not such, as Christians try to

believe, that this God is punishing, like with AIDS, people of sin. It is, these are man-made weapons of war, including the HIV, and of course you know there are thousands of different strains of HIV.

Jeff: There are 2003 at last count that have been identified by the Pasteur Institute, not all of which are fatal but certainly each one of those organisms mutates quickly.

Peter: There you go. All of this is part of a plan by design and, of course, it leads into what we call the New World Order Plan. Sort of a cleansing, an ethnic cleansing. It is also a way to kill off or—most of the military is so sick. It is not just a matter of a few. And, of course, there are 300,000 foreign troops or U.N. troops in the United States almost making it a one-to-one where, on every military base if you've got a real American, you've got also some sort of foreigner there sitting side-by-side which is very disturbing to me. Very disturbing to me.

Jeff: At the very least. Time for our last break. Peter, many many people, maybe millions, have CFS (Chronic Fatigue Syndrome). Certainly not all of that came from the Gulf War, or do you think most of it did?

Peter: Well, again, I would be foolish to try to be the expert to say that but yes, as far as I'm concerned unless it was prior to 1990, the Chronic Fatigue Syndrome as it is out there today is as the result of the Persian Gulf War. And that's sad because it will not end with just that. That is the beginning of the symptoms.

I'd like to get something about Congress and John Scheibel. In 1991, when I tried to do an exposé with ABC NIGHTLINE and THE FINANCIAL TIMES joint-venture, THE FINANCIAL TIMES OF LONDON—I don't know if you remember seeing me on NIGHTLINE but I appeared there with Ted Koppel.

Jeff: No, I missed that.

Peter: It was brief and they did a partial exposé about this. When I questioned them about why they really didn't do a hard-hitting show they responded to me that, "We did not want to topple the entire U.S. Government."

Jeff: (Laughter.)

Peter: That's kind of like what ABC did, but I think they were on a fishing trip to find out what I know. They did some sort of exposé and for that I'm thankful. But, as a result of that I got a call from John Scheibel and he is on the sub-committee of International Economic Policy and Trade investigating the army of Iraq, and he asked me one question. "Who are you more afraid of..."—by the way, Mr. Scheibel, I tape recorded that call. "...Who are you more afraid of, George Bush or Saddam Hussein?" I replied, "George Bush." Scheibel immediately said, "Do not try him in the media," and hung-up. Within three months my wife died, amongst other people. I would like to also ask the question: is the public aware that Ron Brown is the U.S. Arms vice-president of marketing? Are you aware of that and does the American public know that U.S. Arms operates out of the Pentagon? What is the agenda of the U.S. Government or U.S. Arms? I'd like to read you an open letter, very short, a couple sentences, from President Clinton. And every president, as they get elected, miraculously become the C.E.O. of U.S. Arms. So, here is the statement. [Quoting:]

To Our Shareholders:

Strong growth in lean years is the hallmark of competitiveness and U.S. Arms has had a very competitive year. Some shareholders were worried by my campaign promise to press for strong international limits on the dangerous and wasteful flow of weapons to troubled regions. But I can assure you that I have held fast to the course set by former C.E.O.s Ronald Reagan and George Bush. The end of the Cold War has caused a drop in both domestic and global arms demand. U.S. Arms has responded by spending shareholder money to develop export markets in Asia and the Middle East. As a result, our share of global conventional arms agreements rose from 17 percent in 1988,

(two years prior to the Gulf War), to 70 percent in 1993. And, thanks to the efforts of our marketing team, the majority of our 1993 sales were to a promising new market, the developing world. In order to insure stability, unelected governments and developing countries feel the need to acquire more arms. (Oh, God.) We are reaching out to them vigorously; where we once catered to Cold War political allegiances, we now aggressively respond to supply and demand. With Russia, our major competitor, still severely crippled, we can look forward to several years of spectacular growth. [End quoting.]

Jeff: An astonishing letter. It's amazing.

Peter: Amazing, isn't it.

Jeff: Yes, you know you mentioned a lot of names earlier in this program. Names that have been around for many years. They continue to play musical chairs with this cast of characters—I don't want to call them ghouls, but—they certainly are involved in some pretty ghoulish business, according to you.

Peter: These are not allegations. Again, documents back this up and personal experience backs it up. That's exactly what you have. It's lateral shifting. People get put into positions. You know, if you are in the private sector in a business, you become general manager or president because you work your way up and you've done good. It seems that in the government, if you are moved into a position, it is because you've done bad or you've got skeletons so that the powers that be can control you. That's kind of how Janet Reno got shifted. The CIA Director gets shifted, John Deutch, involved in biological weapons. All of these people are players in these great crimes. It is just so very sad. I have very little to hold onto. I hold onto this only through my faith and only because I am avenging the death of my wife and the death of all Gulf War veterans and Americans and the atrocities. I know that one day I will die. It is a matter of time that they will kill me. I want the public to know that, no matter, if they have evidence and a video recording of Sister Mary Theresa standing over my dead body and a signed confession from her, I want the American people to know that I will die at the hands of my own government or, supposedly, the government of America. And I am wondering who the good guys are any more. So, I'd just like to make that statement. I live every day knowing that today could be my last. And it almost has been several times. And I've been in exile as a political prisoner in this country that is supposedly a free nation. That's basically where it's at. I am not going to quit. I can't quit because too many people are dying and it is a nation-wide outbreak at this stage and America needs to wake up and it is not a matter of getting mad. I am not a member of a militia group, although I support them. I am not suggesting that people take up arms. I am saying, "You better get ready because this is going to be something devastating, along with what's coming down with the New World Order." For those who do not understand what it is or why, you need to read the *Constitution*. You need to start finding out what's going on in this country. It is just too lengthy to cover here. That's basically my statement.

Jeff: Peter Kawaja, incredible. Breathtaking, heartrending story you've just told us. You're not selling anything. You're not out to profit. You've been offered huge amounts of money to shut up. You've lost your wife. How do you suggest the average America try to better inform him or herself?

Peter: They can contact the American Gulf War Veterans Association at 713-587-5437. They can also call me at 407-241-8407. We'd like to inform America of how they can help and I do need assistance in prosecuting the crime, but I have no product to sell. I sell no tapes and I am not writing a book.

Jeff: Thank you and we will remember this program for a long time. Would you come back and talk with us again?

Peter: Surely, I'd appreciate it.

Jeff: Thank you and the best of luck to you.

The following is a fax received by CONTACT from Peter Kawaja on 8/22/95:

The Saddest Chapter Of America's History Is Now Being Written

The people of America have yet to learn that indeed germ warfare was used on our servicemen/women during the Gulf War, and the greatest tragedy—it was a joint venture with the United States Government.

This information will shock, surprise, and sadden you. But yes, the worst is yet to come if Americans do not wake up and change our government. The evidence exists, and is overwhelming. Here are only a few atrocities committed against all of us:

* *Chemical & Biological* (germ) warfare weapons of mass destruction were made in Boca Raton, FL, and Houston, TX—by "international terrorists" working with U.S. intelligence.

* One of the special strains of HYDROGEN CYANIDE called *Prussian Blue* was being tested on Gas Mask Filters at the Florida Product Ingredient Technology (P-I-T) plant, for "gas mask penetration"—over a year prior to the Gulf War.

* The PIT plant was financed/engineered by the same Dr. Barbouti/IBI (Ishan Barbouti International), builder of the *Pharma-150* chemical/biological complex, at Rabta, LIBYA.

* Former President George Bush, James Baker III, John Deutch (now CIA Director), had financial interests in some of the companies which developed/sold/transferred these weapons to IRAQ. Yes—whilst being Commander-in-Chief, President Bush was arming Saddam Hussein with these weapons of mass destruction, and two years later, "knowing" that (but the American Public did not)—placed American Forces in harms way.

* President Bush, Brent Scowcroft (NSC), and U.S. intelligence were behind the testing/use of Prussian Blue which rendered our Troops defenseless against the biological agents that were to be tested in the upcoming Gulf War, a war which was planned for this purpose, at least two years in advance.

* In addition, certain vaccines were "grown", several years again "in-advance", with prior specific knowledge of the type of weapon that the vaccine was designed to protect against. * The NBC Logs also prove that Schwarzkopf was given the authority to use our own chemical & biological weapons. There are Gulf veterans who were involved in shipping out our own supplies of these

weapons, most are now sick, others have died. They will testify at the proper time if we act now, whilst they are still alive and willing to come forward.

* Peter Kawaja, a security specialist, was awarded a million-dollar security contract to provide a computer-based system for PIT, and was prime security contractor to IBI, providing bodyguards and other physical services. Kawaja was then asked (after being contracted) to install a *hydrogen cyanide detection system*.

* Kawaja became suspicious and took his concerns to the CIA/FBI/CUSTOMS, and operated for the government under a code name because he was told that these people (IBI) were "international terrorists", and the government was going to prosecute them. This was in 1989, prior to any war, or anyone losing their life. Kawaja soon found however, that U.S. intelligence and the U.S. Government were acting in a joint venture with these same terrorists. Kawaja obtained video and audio recordings of these terrorists, federal agents and politicians (calls to/from the U.S., London, Baghdad), along with paper documents, and intercepted fax transmissions (originating from Switzerland) regarding the Commodity Credit Corp.-*Banca Nazionale del Lavoro* (CCC-BNL). * Federal agents provided their evidence of "gas mask penetration" at the PIT plant.

* Federal agents provided their evidence, *that Ishan Barbouti was supplying MILITARY items to IRAQ!*

* All of this and more was sworn to by federal agents in 1990, yet all of it, and ALL evidence taken from Peter

Iraq admits to larger germ warfare arsenal

UNITED NATIONS — Iraq has told the head of a U.N. inspection team that its germ warfare program was larger and more advanced than it had previously admitted, including bombs and scud missiles armed with lethal biological agents, officials of the team said Tuesday.

In weekend meetings with the U.N. official, Rolf Ekeus, the Iraqis provided new details of stockpiles of germ weapons that included substantial quantities of anthrax, botulin and other agents.

The government of President Saddam Hussein also admitted that, contrary to earlier assertions, the biological agents and weapons were not destroyed before the start of the Persian Gulf War in 1991, according to Charles Duelfer, Ekeus' deputy.

Iraqi officials, who in July said their biological agents had been destroyed in the fall of 1990, now say that they eliminated the stockpiles after the conflict, Duelfer said in an interview here

Tuesday.

But some diplomats and officials say they are concerned that Iraq may still have biological weapons stored at secret sites.

Although Iraq had previously confessed to having both toxic agents and warheads, the inspectors said the fact that the warheads had been armed indicated the weapons were much closer to being used than previously known.

"Now they admit that these types of agents have been put on ammunition, including missile warheads, on bombs, and this is, of course, a major admission," Ekeus told reporters after his visit to Iraq. "That means also that the Iraqi weapons program was very much advanced."

Duelfer described the Iraqi biological weapons program as "very significant, advanced and mature" and a threat to the region.

Officials say they do not have enough information to be certain why Iraq did not use its biological arms during the war, but suspect that the Hussein government feared a huge retaliatory response by the United States and its allies. During the war Iraq hit Israel with missiles armed with conventional explosives.

In recent days Baghdad has also provided substantial new information on its nuclear weapons

program, a spokesman for the International Atomic Energy Agency said in Vienna Tuesday. The agency has its own inspector, Maurizio Zifferero, working on Iraq. He has been in Baghdad with Ekeus.

A Western diplomat said the new information includes confirmation that Iraq was continuing research into the nuclear fuel cycle, apparently trying to enrich uranium for weapons.

The new admissions by the Iraq government were apparently prompted by the defection to Jordan earlier this month of a son-in-law of the president, Lt. Gen. Hussein Kamel Hassan, who had been responsible for developing Iraq's weapons of mass destruction. Officials say that the Iraqis appeared to want to pre-empt Kamel, whom Ekeus met Tuesday in Amman, where he was given asylum on Aug. 8.

By revealing information that Kamel was likely to provide anyway, Iraq may hope to win favor for being forthcoming, and thus advance Saddam's campaign to end international sanctions against his country.

Ekeus, whose judgment of Iraq's candor would be influential, said the disclosures were a step toward lifting the sanctions. "We see a new language in Baghdad during our visit," he said. "How deep it is and how sustainable that policy will be, that is still, of course, open for judgment

confirm or negate the offering.

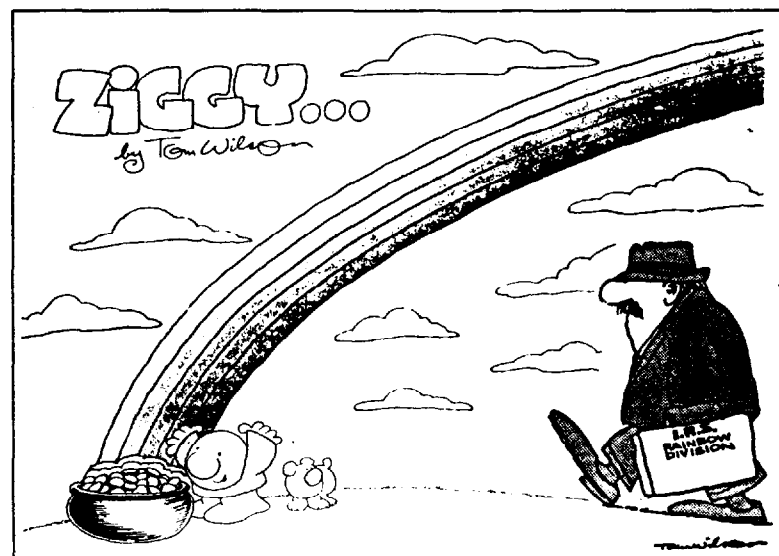
So, what do "I" know about this man in point? What difference does THAT MAKE? Is it not what YOU know that manages "your" living?

ANIMAL MUTILATIONS: VICTIMS OF TOXIC TECHNOLOGY?

Supreme Court Justice Anthony Kennedy moonlights for part of the summer as a law professor. Each July, Justice Kennedy and his wife, Mary, spend three weeks in Salzburg, with all major expenses and a \$20,000 stipend paid by a Sacramento, Calif., law school called McGeorge, which runs a summer session here. The high court finished on June 29, and on July 1 Chief Justice Rehnquist was in England to see Andre Agassi and Boris Becker [play tennis at Wimbledon]. Then he headed off to Cambridge, where he lectured on the history of the court, toured cathedrals and war memorials, and was feted by British lords and ladies. [A bit of a royalist, eh?] Tulane Law School in New Orleans and Valparaiso Law School in Valparaiso, Ind., sponsors of summer sessions at Cambridge, split the chief justice's travel and accommodations costs.

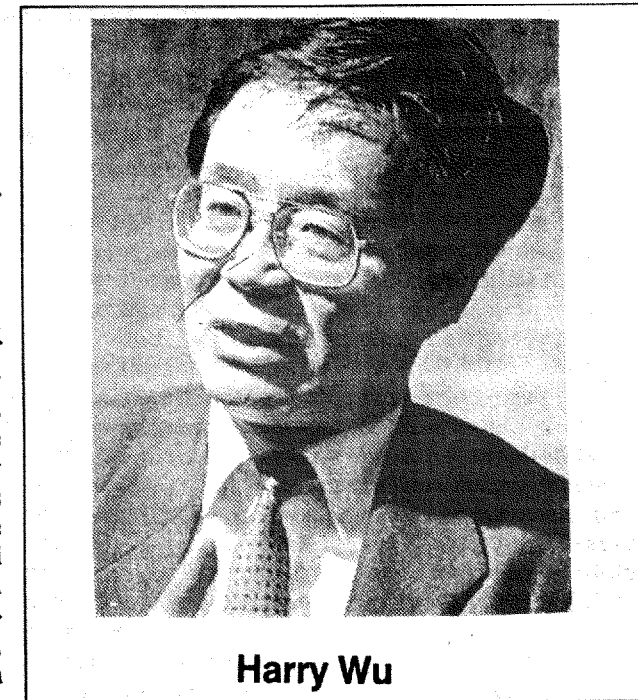

The crimes of spying and leaking state secrets are punishable by death. Wu, a U.S. citizen, was dedicated to exposing China's extensive penal colonies. He emigrated in 1985 after serving 19 years in labor camps for criticizing the Communist Party. He returned to China several times, posing variously as a businessman, a worker from Shanghai visiting camp guard friends or a Chinese policeman, to document forced prison labor and the use of organs from executed prisoners in transplants. Wu was well-known in Washing-

From August 30 to Sept. 15, 1995, delegates from more than 170 sovereign nations will attend the United Nations Fourth World Conference on Women in Beijing, China. Immigration and Naturalization Service authorities acknowledged they took no action until state officials received a similar tip six weeks ago. A woman who escaped through the air-conditioning duct of the El Monte apartment complex informed state authorities about the conditions at the sweatshop. Some of the Thai-born laborers told of 17-hour days inside the garment factory, circled by barbed wire. "I was told I could come here and make a lot of money sewing in the United States," Vuttiphong Vutthiboompronsak said through an interpreter. "There are some who tried to escape, but they were caught and sent back to Thailand."

The workers sewed women's ready-to-wear garments, some of which ended up in East Coast department stores.... Retailers may have legitimately purchased the garments from manufacturers, who in turn had subcontracted with shops that subcontracted with the El Monte operation.

Speaking of corruption, this article from a recent issue of the *FEDERAL TIMES* tells of sex, drugs, and bribery in the Customs Service, [quoting:]

A former Customs Service employee who has waited years for grand jury investigation into the agency's San Diego district has finally gotten his way. A grand jury in San Diego is hearing testimony on allegations that eight Customs officials here accepted bribes or sexual favors in return for helping Mexican cartels smuggle cocaine into the United States. The investigation is the culmination of numerous government inquiries that

tro], the Treasury Department inspector general and a congressional committee [in other words, probably bigger crooks than the alleged crooks!], said Bobbie Cassidy, a Customs spokeswoman in San Diego. No charges came out of the investigations. [Reminiscent of the "official" investigations of government involvement in "Waco" and "Oklahoma City" and Gulf War Syndrome.]

The focus of the investigation is reportedly a program known as "line release" that allows companies believed to be of little risk to ship goods into the United States with little or no inspection. The allegations say at least one employee cooperated with drug traffickers in return for sexual liaisons with boys in Mexican border towns and that others accepted money to cover up smuggling. Customs employees also are accused of allowing Mexican customs officers caught with drugs, undeclared U.S. currency and a stolen vehicle to go free.

NEVER A DULL MOMENT IN THE MIDDLE EAST

Disinformation and continual chaos seem to be the goals for the Middle East. Marjorie Miller reports in the August 22 issue of *THE LOS ANGELES TIMES*, [quoting:]

JERUSALEM—Israeli Prime Minister Yitzhak Rabin [British Intelligence Zionist] vowed Monday to continue peace talks with the Palestinians as the Islamic extremist group Hamas [creation of British Intelligence] claimed responsibility for a morning rush-hour bus bombing that left five people dead and 108 injured...part of a violent campaign to end peace negotiations between Rabin and Palestinian leader Yasser

WORLD BANK WARNS OF WATER CRISIS

What does the World Bank have to do with water? This article comes from the *HARRISON (Arkansas) DAILY TIMES*, [quoting:]

WASHINGTON (AP)—Unless current trends are reversed, the Earth will have a worsening water crisis, the World Bank warns. We are warning the world that there is a huge problem looming out there," Ismail Serageldin, a bank vice president, said as the bank released a report on the world's water Sunday. "The water problem in most countries stems not from a shortage of water but rather from its inefficient and unsustainable use," Serageldin said. "We need to change our attitudes toward water and stop wasting it the way we do." Global demand for water, which has historically increased at a rate of 2.3 percent a year, doubling every 21 years, must be slowed, the paper said. It recommended that the problem be addressed by establishing associations of river and lake users to manage water, and by selling water at prices high enough to encourage conservation. [More control! And water is a survival commodity. It's amazing how the words "global" and "world" show up with ever greater frequency in the media—have you noticed?]

The Los Angeles City Council on Wednesday ordered the DWP to study fluoridating the city's water supply to help prevent tooth decay. Decades ago, a group of anti-fluoride protesters argued the plan was a Communist-inspired conspiracy to destroy Americans' health. Mounting a well-organized campaign that involved picketing throughout the city, the group in 1966 was key in convincing the council to reject the idea.

Since then, the National Research Council has released a report concluding fluoridation is safe. [As if that made it so!] The research council further estimated last year that about 55 percent of Americans have used fluoridated water without any ill effects [How would they recognize an ill effect as being fluoride-related?] and that it has helped prevent tooth decay.

One version of the rumor, consistently denied by Microsoft, had it that the Registration Wizard sent the serial numbers of the programs it finds so that Microsoft could crack down on pirated copies of its software. Even if demonstrably false, the rumors about the snooping software have been a PR headache for Microsoft. Some companies, for example, have balked initially at installing Windows 95 for fear that competitive information would end up in Microsoft's hands. And earlier this week, there were reports that the Australian Navy was investigating the program, believing it might lead to security violations.

Setting The Record Straight On Ruby Ridge

CONTACT reader (and loyal and supportive letter writer to our incarcerated friends) Laurie Anteau wrote this excellent letter-to-the-editor to her hometown paper, the *Santa Barbara News-Press* for 8/19/95. We excerpt parts to share [quoting:]

The Aug. 12 article on the Justice Department investigation of the Ruby Ridge siege in Idaho contained a very inaccurate paragraph: "The FBI siege ended when a bureau sharpshooter accidentally shot and killed Weaver's unarmed wife, Vicki, as she walked out the door of their remote cabin. The marksman said he had been aiming at an armed man nearby."

It galls me that such inaccuracy can be spread over the news wires. It is important the American people know the truth about Ruby Ridge and what atrocities our government forces committed against their own citizenry.

The siege ended *nine* days after Vicki was shot. IT was an 11-day siege beginning Aug. 21, 1992, when Sammy Weaver, 14, was killed by a team of U.S. marshals, who were illegally and covertly on their land with no warrant and dressed in camouflage. Prior history to this siege was an attempt by authorities to get Randy Weaver to infiltrate, spy and inform on local skinheads; Randy refused. He was arrested on charges of selling illegal arms (guns with barrels one-eighth-of-an-inch short of the legal minimum). He was released pending trial. He received a notice to appear in court *after* the court date had passed.

Psychological profiles on the Weaver family were done prior to the Aug. 21 assault. Vicki was shot the second day, purposely and with "extreme prejudice" intent by a sharpshooter. The sniper testified in court that he could "hit a quarter-inch target at 200 meters", which is over 600 feet. Vicki was "armed" only with her baby, Elisheba, as she held the cabin door open, not while "she walked out the door." Her skull exploded.

During the siege, Vicki's decomposing body lay under the kitchen table, in sight and smell of her children and husband. Randy, his three surviving daughters and Kevin Harris, huddled in the dark cabin with their *Bible* as our government forces engaged in psychological warfare, naming their camp "Camp Vicki" and taunting the family.

The FBI used a robot to deliver a telephone to the cabin. Attached, undetectable, was a shotgun. Randy

was suspicious and refused to go near it. A neighbor with a video camera taped a 20-gallon blue plastic drum being filled by a diesel truck with the same fuel used by the generators and then being placed aboard an FBI helicopter. The helicopter took off and flew toward the cabin. The man with the video camera made sure the pilot of the helicopter saw he was being taped. The pilot circled and landed. This film evidence has survived. The diesel fuel was to have been poured on the cabin where a charge of explosives had been planted on Aug. 23 to set off a fire bomb that would have certainly killed all the occupants of the cabin.

You will remember that there were two young girls (Sara, 16, and Rachel, 10) and a 10-month-old baby inside that cabin, as well as two wounded men. Randy and his family have been marked by different labels, somehow making it acceptable to have had this siege happen. When is it OK to kill? When someone's beliefs are different? Was it OK to murder his son and wife because he is labeled a white separatist? This is a biblical belief by some the races should live separately, not a judgement in value of the races. Is a little hand slapping, letters of reprimand or demotions comparable to murder charges? OR is the promotion to No. 2 official in the FBI of Larry Potts—the man in charge of the Ruby Ridge siege and the Waco siege—justice?

Government witnesses admitted they presented falsified evidence, removed evidence and rearranged evidence from the crime scene for photographs presented as genuine.

Why have no warrant charges for the murders of Sam and Vicki been issued? Why were there unprecedented orders to shoot to kill, in direct violation of Idaho law?

After the siege, I spent many hours in conversation with Randy over the phone and exchanged letters with Sara and Kevin Harris. I know this family. They are an American family, like you and me. They believe in God and country. They are of flesh and blood. They had, and have, dreams and rights, just as you or I. I want you to feel for this family as you have felt for the victims of the Oklahoma City bombing or any family that has experienced an unwarranted tragedy. If this happened to your family, to someone you know, or if you had been given the facts of this outrage, wouldn't you cry for truth and for justice?

This is no trifling tale of science fiction. Its aim is to instruct, and it is written with subtle artistry. Start it and you will fall under its spell. If you are young in heart and the sense of wonder still stirs within you, you will read without pause till the end is regretfully reached. Yet you will not guess when the tale was written nor by what manner of man.

In these days space-time and the fourth dimension are household words. But *Flatland*, with its vivid picture of one and two and three and more dimensions, was not conceived in the era of relativity. It was written some seventy years ago, when Einstein was a mere child and the idea of space-time lay almost a quarter of a century in the future.

In those far off days, to be sure, the professional mathematicians were imagining spaces of any number of dimensions. The physicists too, in their theorizing, were working with hypothetical graph-spaces of arbitrary dimensionality. But these were matters of abstract theory. There was no public clamor for their elucidation; the public hardly knew that they existed.

One would think, therefore, that, in order to write *Flatland*, Edwin A. Abbott must have been a mathematician or physicist. But he was neither of these. True, he was a schoolmaster—a headmaster, no less, and a most distinguished one. But his field was classics, and his primary interests literature and theology, on which he wrote several books. Does this sound like the sort of man who would write an absorbing mathematical adventure? Perhaps Abbott himself thought it did not, for he published *FLATLAND* pseudonymously, as if afraid that it might besmirch the dignity of his more formal writings of which he betrayed no reluctance to acknowledge his authorship.

Much has happened to our ideas of space and time since *FLATLAND CAME INTO BEING*. But despite all the talk of a fourth dimension, the fundamentals of dimensionality have not changed. Long before the advent of the theory of relativity, scientists thought of time as an extra dimension. In those days they regarded it as a solitary, isolated dimension that kept aloof from the three dimensions of space. In relativity time became inextricably intermingled with space to form a truly four-dimensional world; and this four-dimensional world turned out to be a curved one.

These modern developments have less significance than one might imagine for the story of Flatland. We do indeed have four dimensions. But even in relativity, they are not all of the same sort. Only three are spatial. The fourth is temporal; and we are unable to move freely in time. We can not return to days gone by, nor avoid the coming of tomorrow. We can neither hasten nor retard our journey into the future. We are like hapless passengers on a crowded escalator, carried relentlessly forward till our particular floor arrives and we step off into a place where there is no time, while the material composing our bodies continues its journey on the inexorable escalator—perhaps forever.

Time, the tyrant, holds sway in Flatland as in our own world. Relativity or no relativity, we still have only one dimension more than the creatures of Abbott's imagination; we still have only three spatial dimensions to their two. [H: And you don't really use those!] The inhabitants of Flatland are sentient beings, troubled by our troubles and moved by our emotions. Flat they may be physically, but their characters are well rounded. They are our kin, our own flesh and blood. We romp with them in Flatland. And romping, we suddenly find ourselves looking anew at our own humdrum world with the wide-eyed wonder of youth.

In Flatland we could escape from a two-dimensional prison by stepping momentarily into the third dimension and coming back on the other side of the prison wall. But that is because this third dimension is spatial. Our fourth dimension, time, true dimension though it be, does not permit us to escape from a three-dimensional prison. [H: Pay attention, readers, for I am trying to show you HOW to get beyond the limitations of this very prison!] It does enable us to get out, for if we wait patiently for time to pass, our sentence will be served and we shall be set free. That is hardly an escape, however. To escape we must travel through time to some moment when the prison is wide open, or in ruins, or not yet built; and then, having stepped outside, we must reverse the direction of our time travel to return to the present. Neither we nor the inhabitants of Flatland can travel thus through time.

Though the crowded years go by, this nigh on seventy-year-old tale shows no sign of age. It remains as spry as ever, a timeless classic of perennial fascination that seems to have been written for today. Like all great art, it defies the tyrant Time. Banesh Hoffman.

Flannery reached for the book. He ran his hand through the pages and stopped at page sixty-four.

Flannery was stubborn.

"Pigs is pigs," he declared firmly. "Guinea-pigs, or dago pigs or Irish pigs is all the same to the Interurban Express Company an' to Mike Flannery. Th' national-



ity of the pig creates no differentiality in the rate, Misther Morehouse! 'Twould be the same was they Dutch pigs or Rooshun pigs. Mike Flannery," he added, "is here to tind to the expriss business and not to hould conversation wid dago pigs in siventeen languages fer to discover be they Chinese or Tipperary by birth an' nativity."

Mr. Morehouse hesitated. He bit his lip and then flung out his arms wildly.

"Very well!" he shouted, "you shall hear of this! Your president shall hear of this! It is an outrage! I have offered you fifty cents. You refuse it! Keep the pigs until you are ready to take the fifty cents, but, by George, sir, if one hair of those pigs' heads is harmed I will have the law on you!"

He turned and stalked out, slamming the door. Flannery carefully lifted the soap box from the counter and placed it in a corner. He was not worried. He felt the peace that comes to a faithful servant who has done his duty and done it well.

Mr. Morehouse went home raging. His boy, who had been awaiting the guinea-pigs, knew better than to ask him for them. He was a normal boy and therefore always had a guilty conscience when his father was angry. So the boy slipped quietly around the house. There is nothing so soothing to a guilty conscience as to be out of the path of the avenger.

Mr. Morehouse stormed into the house. "Where's the ink?" he shouted at his wife as soon as his foot was across the doorsill.

Mrs. Morehouse jumped, guiltily. She never used ink. She had not seen the ink, nor moved the ink, nor thought of the ink, but her husband's tone convicted her of the guilt of having borne and reared a boy, and she knew that whenever her husband wanted anything in a loud voice the boy had been at it.

"I'll find Sammy," she said meekly.

When the ink was found Mr. Morehouse wrote rapidly, and he read the completed letter and smiled a triumphant smile.

"That will settle that crazy Irishman!" he exclaimed. "When they get that letter he will hunt another job, all right!"

A week later Mr. Morehouse received a long official envelope with the card of the Interurban Express Company in the upper left corner. He tore it open eagerly and drew out a sheet of paper. At the top it bore the number A6754. The letter was short. "Subject—Rate on guinea-pigs," it said, "Dr. Sir—We are in receipt of your letter regarding rate on guinea-pigs between Franklin and Westcote, addressed to the president of this company. All claims for overcharge should be addressed to the Claims Department."

Mr. Morehouse wrote to the Claims Department. He wrote six pages of choice sarcasm, vituperation and argument, and sent them to the Claims Department.

Mebby thim clerks wants me to call in the pig doctor and have their pulses took. Wan thing I do know, howiver, which is they've glorious appytites for pigs of their soize. Ate? They'd ate the brass padlocks off of a barn door! If the paddy pig, by the same token, ate as hearty as these dago pigs do, there'd be a famine in Ireland."

To assure himself that his report would be up to date, Flannery went to the rear of the office and looked into the cage. The pigs had been transferred to a larger box—a dry goods box.

"Wan,—two,—t'ree,—four,—foive,—six,—sivin,—eight!" he counted. "Sivin spotted an' wan all black. All well an' hearty an' all eatin' loike ragin' hippypottymusses." He went back to his desk and wrote.

"Mr. Morgan, Head of Tariff Department," he wrote. "Why do I say dago pigs is pigs because they is pigs and will be til you say they ain't which is what the rule book says stop your jollying me you know it as well as I do. As to health they are all well and hoping you are the same. P.S. There are eight now the family increased all good eaters. P.S. I paid out so far two dollars for cabbage which they like shill I put in bill for same what?"

Morgan, head of the Tariff Department, when he received this letter, laughed. He read it again and became serious.

"By George!" he said, "Flannery is right, 'pigs is pigs.' I'll have to get authority on this thing. Meanwhile, Miss Kane, take this letter: Agent, Westcote, N.J. Regarding shipment guinea-pigs, File No. A6754. Rule 83, General Instruction to Agents, clearly states that agents shall collect from consignee all costs of provender, etc., etc., required for live stock while in tansit or storage. You will proceed to collect same from consignee."

Flannery received this letter next morning, and when he read it he grinned.

"Proceed to collect," he said softly. "How thim clerks do loike to be talkin'! Me proceed to collect two dollars and twinty-foive cints off Misther Morehouse! I wonder do thim clerks know Misther Morehouse? I'll get it! Oh, yes! 'Misther Morehouse, two an' a quarter, plaze.' 'Cert'nly, me dear frind F'annery, Delighted! Not!'"

Flannery drove the express wagon to Mr. Morehouse's door. Mr. Morehouse answered the bell.

"Ah, hal!" he cried as soon as he saw it was Flannery. "So you've come to your senses at last, have you? I thought you would! Bring the box in."

"I hev no box," said Flannery coldly. "I hev a bill agin Misther John C. Morehouse for two dollars and twinty-foive cints for kebbages aten by his dago pigs. Wud you wish to pay ut?"

"Pay— Cabbages—!" gasped Mr. Morehouse. "Do you mean to say that two

little guinea-pigs—"

"Eight!" said Flannery. "Papa an' mamma an' the six childern. Eight!"

For answer Mr. Morehouse slammed the door in Flannery's face. Flannery looked at the door reproachfully.

"I take ut the con-sign-y don't want to pay for thim kebbages," he said. "If I know signs of refusal, the con-sign-y refuses to pay for wan dang kebbage leaf an' be hanged to me!"

Mr. Morgan, the head of the Tariff Department, consulted the president of the Interurban Express Company regarding guinea-pigs, as to whether they were pigs or not pigs. The president was inclined to treat the matter lightly.

"What is the rate on pigs and on pets?" he asked. "Pigs thirty cents, pets twenty-five," said Morgan.

Morgan reached for the telegraph blank and wrote: "Agent, Westcote. Don't sell pigs."

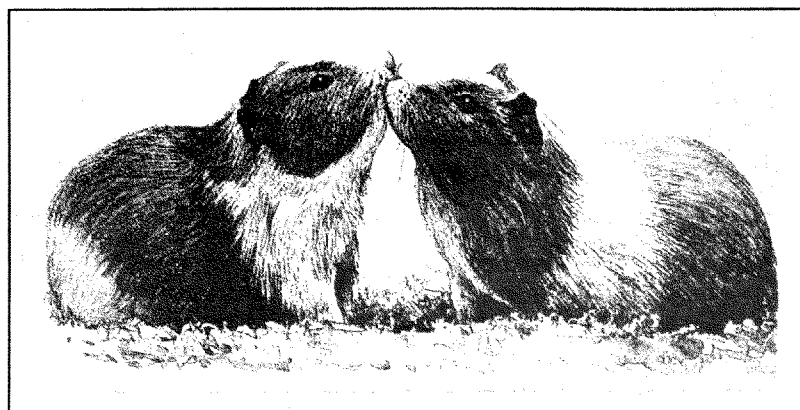

Flannery read the telegram and cheered up. He wrote out a bill as rapidly as his pencil could travel over paper and ran all the way to the Morehouse home. At the gate he stopped suddenly. The house stared at him with vacant eyes. The windows were bare of curtains and he could see into the empty rooms. A sign on the porch said, "To Let". Mr. Morehouse had moved! "Can't collect fifty cents for two dago pigs consignee has left town address unknown what shall I do? Flannery."

The telegram was handed to one of the clerks in the Audit Department, and as he read it he laughed.

"Flannery must be crazy. He ought to know that the thing to do is to return the consignment here," said the clerk. He telegraphed Flannery to send the pigs to the main office of the company at Franklin.

When Flannery received the telegram he set to work. The six boys he had engaged to help him also set to work. They worked with the haste of desperate men, making cages out of soap boxes, cracker boxes, and all kinds of boxes, and as fast as the cages were completed they filled them with guinea-pigs and expressed them to Franklin. On the next train up from Franklin came one of the company's inspectors. He had instructions to stop the stream of guinea-pigs at all hazards. As his train drew up at Westcote station he saw a cattle-car standing on the express company's siding. When he reached the express office he saw the express wagon backed up to the door. Six boys were carrying bushel baskets full of guinea-pigs from the office and dumping them into the wagon. Inside the room Flannery, with his coat and vest off, was shoveling guinea-pigs into bushel baskets with a coal scoop. He was winding up the guinea-pig episode.

He looked up at the inspector with a snort of anger.

"Wan wagonload more an' I'll be quit of thim, an' niver will ye catch Flannery wid no more foreign pigs on his hands. No, sur! They near was the death o' me. Nixt toime I'll know that pigs of whatever nationality is domestic pets—an' go at the lowest rate."

He began shoveling again rapidly, speaking quickly between breaths.

"Rules may be rules, but you can't fool Mike Flannery twice wid the same trick—whin ut comes to live stock, dang the rules. So long as Flannery runs this expriss office—pigs is pets—an' cows is pets—an' horses is pets—an' lions an' tigers an' Rocky Mountain goats is pets—an' the rate on thim is twinty-foive cints."

He paused long enough to let one of the boys put an empty basket in the place of the one he had just filled. There were only a few guinea-pig: left. As he noted their limited number his natural habit of looking on the bright side returned.

"Well, annyhow," he said cheerfully, "'tis not so bad as ut might be. What if thim dago pigs had been elephants!"

When it seems that nothing is happening and things are stalled in delays and interference, let us be glad and let us give thanks that OTHER THINGS ARE HAPPENING somewhere else and are simply not in our focus of attention nor ability to see. Faith is that which we offer God when our own way seems quite bogged or desperate.

Life can only be understood by looking back and weighing that which has already been experienced and therefore it would be quite reasonable to suggest that life can only be understood backwards and yet must be lived forward. Sometimes that seems to be "fast forward". I also realize that, as we WAIT patiently or impatiently for something expected, it appears to be in sub-slow-motion. You have to MAKE THINGS HAPPEN, Readers. You have to plan the happenings lest life be that which piles upon you while you make other plans for the results and forget to finish the job of the obtaining. Think about this as you complain and focus negative thoughts upon ones from whom you await help. In other words, where that awaited is worldly in goods—MAKE IT HAPPEN. YOU HAVE THE POWER TO ACCOMPLISH ANYTHING YOU WISH IF YOU ACT PROPERLY ON THOSE WISHES. Most often that which you demand, according to your own desires, would lead you directly into the viper's den of chaos and demise. If we pull the cart instead of push it by strings, we shall succeed, for foundations have to be laid soundly before the house can be built.

Let us turn to our subject of Biological Transmutations, please.

We are grateful to Robert James for sharing this work with you readers. We use it for teaching and information because we find the volume containing cellular transmutations no longer is published and this information is apparently no longer reprinted in publication. Again we have to give gratitude and recognition to translators for English was not Kervran's language. It seems the last printing which we can find referenced is in the early 1970s by Swan House Publishing Co. in Brooklyn, N.Y. We could not find such a place but I am confident that if you can do so you will find priceless volumes of information.

Louis Kervran was an active member of the New York Academy of Science but again we have to turn to France for his work to be revealed. It isn't that the theories did not present themselves, it is simply that Kervran is owed the debt of being able to offer explanation in fact of biological transmutation. The information was offered in interest for physicists, chemists, biologists and geologists so you can see what a consideration is offered here for our own understanding.

The information may well NOW seem old—but again, retrospection is the easy way AFTER someone points out something to you. Please remember that things are deliberately HIDDEN from you and certainly the great and honored names at the time of introduction of new revelation do not like their own theories de-

stroyed by the presentation of truth. What happens is that the presenter gets bashed, his work buried and the truth is taken by the adversaries and ultimately used to the advantage of destroyers and lost to the creators.

For you who would wish me to go directly to the "good part" and the lectures, I have this to say: We owe a great honor to Michel Abehsera who has presented this work in English and compiled many of Kervran's presentations into one volume. To allow use of this information we have to either offer ALL so that no context is lost in any instance or fail to give more than an outline. I choose to cause you to sit through ALL.

You are going to find revelation in so many things that you are taking for granted that you will be shocked. For instance, readers, if you need Iron in the body, you will have to take organic manganese. If you need Calcium you have to take organic Silica. The movement of life proceeds from the constant changing of one element into another. This is also called "alchemy".

Right up front here, because so many of you suffer from bone loss and calcium needs, I am ASKING NEW GAIA TO GET AND OFFER SILICA. I do not like to offer information and suggest things be gotten or consumed unless you have resource for products from our own availability. We have had a resource outside our location so that product could be "controlled" and regulated. This will offer pre-transmuted minerals which will absorb instantaneously within body cells and will immediately adapt to individual DNA/RNA Programming. We will later integrate the Mitochondria (AquaGaia) but that means changing cholesterol transmutation to prevent or clear out buildup of plaque on blood vessel walls and we need several changes to facilitate an easier transmutation process. When we work with living cells only recently brought back to you after eons of absence, we have to gently bring them up to full-form working capability. We don't need further on this right now but we will be bringing you information within the next couple of weeks about the new product which can simply be integrated with what you have and both will become upgraded. Just remember that when you "feed" drias they eat up everything IN SIGHT and change characteristics of EVERYTHING in their presence—THAT is called transmutation so it is nice to tinker with these precious living cells but often is not too wise, for you find qualities desired for one purpose are negated in the transmutation processing. If you just don't "jump the gun" we will soon be off and running in a race you can better understand. BIOLOGICAL TRANSMUTATIONS by Louis C. Kervran

FORWARD

This English edition of the works of Louis Kervran is intended for everyone: scholar, layman, or college student. It could have been directed toward a scholar's mind exclusively, presenting itself to him in cold scientific terms, but this would have slowed down progress. If, in Mr. Kervran's words, scientists "have made of science another job", it would not be ethical to present it to them alone. The problems of ecology, medicine and nutrition, and the alarming rise of radioactivity are too acute to be dealt with solely through academic channels. It is within everyone's ability to comprehend the biological transmutations as long as there is a desire for true knowledge. To understand the biological transmutations requires nothing more than to cast aside all rigid thought while studying them. Transmutation is no more and no less than a reality which teaches us about change. In change we find life, and by change we create life. Our only constant is our goal of becoming Man.

The principles of the biological transmutations affect every phase of our existence. They are already being applied without patent or license by industrial, dietetic and pharmaceutical products based on Kervran's research. Transmutations are now recognized in medicine. They have opened the door to new treatments and therapeutics for reputedly "incurable" diseases. There are solutions already projected for curing arteriosclerosis, rheumatism, excessive arterial tensions, decalcification, kidney stones, hormonal deficiencies, etc., in a natural way, without danger to the patient. Agronomists are already practicing Kervran's findings on a large scale. Dietitians are the biggest beneficiaries, because dietetics is too close to man's body and soul to remain an academic and isolated science. In accordance with this law of the change of elements which Louis Kervran uncovered, there is now a movement by hundreds of thousands of people to eat in a natural way.

The U.S.A. is ecologically in bad shape. Only through the understanding and practice of biological transmutations can this alarming problem be solved. The land is not only polluted but is in some parts barren. Heavy chemicals have killed it. No ecological problem can be solved on the surface; it can only be remedied as its name indicates: ecologically. This means that it can be done only through natural law. Ecology starts with man, mind and body. If his body is clean, his environment will be clean, naturally. If our tastes are sensorial, if our measure of happiness and health is comfort, then ecology is relegated to a mere science with man as a hopelessly retarded child who must be dealt with by caresses and long walks for a year or two or three, until the end of his invalid life. Ecology is often synonymous with attractive environment. Cans

of beer are removed from beaches; hands are cleaned; everyone returns home satisfied. That is merely a good cleaning job.

What about man? What about his body and mind? If the food being consumed does not change, the problem of ecology will worsen. If scientists do not change their minds about nutrition, man, a biological part of this earth, will soon be extinct. Intestines must be healed, since they are as polluted as our streams. The populace must be educated to choose food that does not come canned, bagged in plastic, or chemically treated. From the need of the consumer, from this need only, can the ecological problems be considered—and solved. From a good earth one regenerates one's health. Our blood is but the product of an agent, the earth. The biological creates the physiological. Has this become a secret, or has man become so mechanical, so enslaved to fast relief in any possible way, that he has become accustomed to the "miracle pill"? His pain is relieved in seconds. This is proof enough for him to believe in the "scientific way". But that is not true science.

In a letter to the author of this English version, Louis Kervran wrote: "I hold the same conception as you do: if one desires to bring about a deep change in science, it is not to the high scientific spheres that he should address himself, but to the masses. Not being narrow-minded like the specialist, they can see the synthesis of things and not just their details. This is how I have been progressing this world during the last ten years. But one should not be so absolute in judgment as to say that all scientists are narrow-minded. I have found great support among known personalities, but they are a minority. They are lost in the crowd and cannot vanquish the obstacles and inertia created by the too many. Science has become a petty job. Fifty years ago there were a few thousand men of science; now it is by the hundreds of thousands that one counts them, so that the average level of quality has greatly diminished."

What Mr. Kervran means is that man has become mechanical in his thinking and doing. The physiological, which is what we "are", and the biological, from which our daily nourishment comes, are but a shadow of what man used to be when he was free. What is freedom if it is not to be free in every way, from our most minute cell to our most expansive dreams? He is free who can afford to let the interactions between cell and spirit take place in the most harmonious way. There is no freedom in intellect. "Freedom" of that sort lasts for the duration of a thought, of an act. To be truly free is to be able to establish peace between all opposites within us. That is at the least the beginning of freedom.

Mr. Kervran, with his discovery of biological transmutation, has given this chaotic and scientific world the Alladin's Lamp by which we can save ourselves and our diseased earth. From mechanical men we will raise ourselves to physiological and spiritual beings. That which is mechanical does not believe in change nor in beauty, nor even in man. The mechanical mind lives within the hour. If it projects an idea for the future, it is but a steel-like construction erected out of stress, a protection from the "invaders". The mechanical man is afraid. He thinks the enemy is outside of him, so he protects himself a bit more every day until he loses the natural immunity he inherited from this just world.

With biological transmutations we are taught a lesson about freedom. We learn that an element is free to become another when it meets its opposite. It travels from one state to another, procreating newborn atoms. It is the hope of Mr. Louis Kervran and this author that biological transmutations will be applied to the fullest

extent in the U.S.A. and in the whole world.

In 1799 the French chemist Vauquelin was so intrigued by the quantity of lime excreted every day by hens that he decided to put a hen in a cage and feed it oats exclusively. Having measured the quantity of lime that was present in a pound of oats, he gave the oats to the hen. When the grains had been eaten, he analyzed the quantity of lime excreted through the eggs and fecal matter. The hen was found to have excreted five times more lime than it had taken in the food. Vauquelin concluded that lime had been created, but he could not determine the cause.

In 1822 Prout, an Englishman, was the first to clearly define the problems of the transmutation of elements. He systematically studied the increase of limestone (a compound consisting chiefly of calcium carbonate) inside an incubating chicken egg, proving that limestone is not contributed by the shell.

In 1831 the Frenchman Choubard let watercress seeds germinate in an insoluble dish (sand, glass, etc., washed with acids, rinsed with water, heated). He verified that the young plants contained minerals which had not existed in the seeds.

Others followed. In 1844 Vogel experimented with watercress seeds placed under a large bell jar. Keeping the air "analyzed", he added a nutritive solution containing no sulfur whatsoever. After their germination he analyzed the young plants, finding that they contained more sulfur than the seeds from which they stemmed. This phenomenon remained obscure to Vogel, who concluded that either sulfur is not a simple body or there was an unknown source of sulfur.

A few years later Lauwes and Gilbert considered the weight variations of ashes during vegetation. They observed, in analyzing the ashes, an inexplicable variation in the amount of magnesium. In 1875 von Herzele went a step further by verifying a weight increase in the ashes of young plants stemmed from germinating seeds. He made a culture without soil in a well-studied medium. Later on he carried out experiments related to Vogel's earlier study of weight variations of magne-

sium, already considered by Lauwes and Gilbert. Von Herzele then concluded that there was a transmutation of elements.

He seems to have been the first to research the origin and destination of an element. His remarkable work remained without echo in the scientific world. In 1950 Hauschka took it out of the dark to publish von Herzele's findings in one of his books.

Branfield, Lakhovsky, Spindler and Freundler, among others, followed. None of them arrived at clear conclusions.

Baranger, chief of the laboratory of organic chemistry at the Ecole Polytechnique in Paris, became acquainted with von Herzele's work. In 1960 he published the first results, handed to him by A. Spindler, of the variations of phosphorus and calcium in germinated seeds. Baranger concluded that a transmutation of elements had occurred, but his research, like that of his predecessors, failed to show the mechanism by which the discrepancy was produced.

It was in 1959 that Louis Kervran started publishing his discoveries. At about that time the coincidental works of the above scientists became known to him. In the summer of that same year, Mr. Kervran came to a conclusion concerning his many years of systematic research. He did his best to prove his conviction to the scientific world, a conviction that none before him had been able to put down in clear formulas. Having waited for years, witnessing thousands of convergent analyses, he succeeded in demonstrating that not only molecules but atoms themselves can be transformed. He verified that there is transmutation of matter from one simple body to another, from one atom to another.

All the proof was presented, yet Kervran encountered violent opposition from skeptical people who were reluctant to accept something new. On the other hand, warmest congratulations and encouragement poured in from very great personalities of science, who now saw light in what had always been obscure to them. Already in 1959 Kervran had found solid help among those having true scientific spirit.

In July 1960 a French scientific review published an article on Louis Kervran. That was enough for the public to know what many scholars had refused to see. Magazines, radio and television gave millions the chance to be informed about the "transmutations". It was not until 1962 that *Biological Transmutations* was published by Librairie Maloine. In a matter of a few months, the first edition was sold out and reprinted. A third one was to follow two years later. Successively came *Transmutations Naturelles*, *Transmutations a' Faible Energie*, *Preuves Relatives a' l'Existence en Agronomie*.

In the preface of *Transmutations Naturelles* Jean Lombard, a geologist of worldwide reputation, wrote these words: "The true workers of science, who are always ready to welcome new suggestions, sometimes ask themselves if the greatest obstacle to the progress of science is not bad memory on the part of the scholars; they wish to remind the latter that some of their predecessors were burnt because they proposed 'interpretations' which have now become foremost truths. If pioneers of science were still being burnt, I would not give much for Louis Kervran's skin."

In January 1963 a group of scientists listened to Louis Kervran. After that meeting a report was written by Fishoff, saying: "We are convinced that there is here a series of observations and phenomena of the highest importance for the progress of our knowledge in physics, biology, geology, cosmology, etc. The great merit of Louis Kervran is to have felt strongly that there was something strange in the facts he brings to us and that there was a need for something 'new' to explain it. He obstinately followed an idea and patiently, for many long years, accumulated facts, observations, and results—having no apparent link—at last assembling all these converging facts and ideas to form a daring hypothesis, solid and thrilling. Daring, for it appears to be opposed to the classical conception of nuclear physics and biology. Solid, for the invoked and observed facts are very many, sustained by an infallible reasoning argument. Thrilling, for it opens new perspectives and horizons in biology, medicine, energetics, physics, cosmogony, etc."

Twelve years have passed since *Biological Transmutations* became public. The debate of the times continues. France is now divided into two camps, those for Kervran and those against him. English scientists have invited Louis Kervran to give a series of lectures and demonstrations. Scientists from Switzerland, Italy and Belgium have already heard him and are starting to put transmutations into practice. Russia contacted Kervran. All books about transmutations have been translated into Russian, but not yet on a commercial scale. They can be consulted now in the Moscow Library. Russian scientists are now organizing a congress exclusively dedicated to transmutations, to be held in 1973. The Chinese Embassy officially and insistently invited Kervran many times to go to Peking for three months to give Chinese scholars a chance to learn about his work. Nine years ago the Dow Chemical Company invited Kervran to come to the U.S.A. Mr. Kervran, however, could not honor the

invitation at that time.

After I had finished the present book and had written the major part of this Foreword, I went to see Mr. Louis Kervran in Europe to make corrections. What I had done was to put all his books into one. It was not an easy task. Choosing the most essential parts was the first difficulty, for everything seemed essential. Another difficulty kept arising at almost every sentence. Kervran's statements were directed at French scientists, who do not ask for as much precision as their American colleagues do. My problem, then, was to

well enough to decipher Kervran's texts. I reasoned and convinced myself thus: this is a new way of looking at science; it is up to the reader—whoever he may be, scientist or layman—to go ahead and grow with it. My role will be limited to that of a catalyst. [H: Glory be that he would not tamper to his own pre-determined opinions and ruin another goodly work. In so many cases the original receiver and offerer of information is correct but those who come along afterwards manage to destroy the value and validity of the original product. This can either be by total misperception or deliberate tampering or through a desire to actually remove the information from public understanding and availability. Most often this is accomplished through the "religious" aspect of focus in some manner or another.]

This I may have done well, but I humbly declare myself incapable of doing what really ought to have been done. Being busy with studying and teaching, I could afford to spend only six months on the book (twelve hours daily). Truly it needed another six months. In short, this book needed a man richer than I in all respects, one who would have spent a year or two at his desk thinking and working only on the transmutations.

This book is not a textbook or something to use in the laboratory. Its sole purpose is to stir the minds of those who are still truly concerned about this earth ecologically. I would never finish if I were to cite all the possible applications of the biological transmutations. Of special importance is the place they will occupy between the scientist and the metaphysician. So far there has never been a direct dialogue between the two, because of the differences in language. Now I believe their meeting is possible, for the biological transmutations teach us about the movement of life. From this movement the scientist will see that science can no longer limit itself to the study of the physical alone, for movement also implies elevation toward the metaphysical, not entropy. From this same movement, animating the invisible elements, the metaphysician will learn that life is worth studying in its most singular aspects. He will discover in the minute that which he always knew, that life is a continual renewal of self and cell.

I would like to end this foreword by presenting, in a few words, Mr. Kervran. I had expected to meet a scientist with whom I would discuss—as men usually do when they meet—philosophy. But things did not happen as I anticipated, for he showed himself such a dragon in science that nothing but science was discussed. Mr. Kervran knew his subject well; he seemed to have read all the scientific books and articles published all over the world, to know the work of every living scientist. And when I told him that he had given to

science a new direction and hope, he answered, his face growing red, "I simply pointed out what has always existed."

The chapters of this book have been placed in the best possible order for the reader who is unfamiliar with the biological transmutations to become acquainted with them.

The reader will perhaps meet some difficulties which I myself met upon first reading Mr. Kervran's books. For this reason I advise him to read this book more than once, or, if he wishes, to go directly to the

INTRODUCTION

It is premature to reduce the vital process to the quite insufficiently developed conceptions of 19th and even 20th century physics and chemistry. L. de Broglie.

Lavoisier was a great scholar of the 18th century. He is considered the father of modern chemistry. The general principle with which he worked and from which he derived his new science is that nothing is lost, nothing is created, everything is transformed. The atom being considered the smallest particle of matter and a constant in nature, it was assumed that no element could be created. The atom could not disappear. If it should separate from a molecule of two or more atoms, it could be found unchanged in another molecule.

This principle could in no way be refuted or even debated. It was the basis of the official science of the 19th century. Those who studied it gave it a general extension and applied it to every science close in spirit and form to chemistry. There were enough experiments to support it. It was not until the 20th century that this principle, left undiscussed for more than one hundred years, saw its first officially recognized contradiction. This was the discovery of natural radioactivity, showing that some bodies can be transmuted into different bodies, a principle for which the alchemists of the Middle Ages were so exaggeratedly ridiculed in the

18th and 19th centuries. An atom of radium was finally transformed into a non-radioactive and stable atom of lead, as one can read in books concerning the discovery of radium by Marie Curie.

“Specialists in biochemistry fail to tell us why a chemically pure reaction, such as the one in which an atom of nitrogen and an atom of oxygen are combined, can be realized only *in vitro* at the electric arc temperature (or at a very high temperature and pressure). Living organisms do the same at room temperature! Many similar cases can be cited showing that the living organism is capable of reactions which can be reproduced in the laboratory only by a great deal of energy. Proteins are hydrolyzed in the stomach at 37°C in a slightly acid medium, but this same reaction requires a 120°C temperature and a highly concentrated acid medium to be realized *in vitro*.”

In chemistry the label “element” is given to what in common language is termed a “body”. “Element” is the actual scientific term, which is why we label oxygen, sulfur, calcium, copper, etc., elements. Atoms have a number of protons (heavy particles charged with positive electricity, constituting, along with the neutrons, the atom’s nucleus) equal to the number of electrons (light [-weight] particles charged with negative electricity, moving in orbits around the nucleus). An atom is electrically neutral because it has an equal number of electrons and protons.

Elements were long ago called “simple bodies” because they represent the simplest possible unit of matter. They had existed since the creation of our planet, and could be neither created nor broken down by man. They could only be “moved” from one molecule (or composed body) to another. It is on these simple bodies that Lavoisier’s law is based.

It was established that there are 92 elements in nature, this being deduced and assembled from analogous cases concerning properties of matter by Mendeleev who, in the middle of the 19th century, classified the known elements in a table. The table was charted with empty boxes which were to be filled with new elements corresponding to the characteristics foreseen in a specific box.

Some boxes remained empty, not only because some elements were yet to be isolated, but also because some of the elements no longer existed on earth, being radioactive elements which had long ago been transmuted into other elements. This theory remained precarious until the 20th century when it became possible to produce these lost elements artificially, with nuclear physics. These elements might never have existed in natural form, but may be created under artificial conditions in a laboratory. This breach with Lavoisier’s law, however, concerned only radioactive bodies studied in nuclear physics. In chemistry the teaching continued as before that nothing is lost, that it is impossible to create something by chemical reaction. This is conceded in “chemistry”.

CHEMISTRY AND ITS LIMITS

The serious error of scientists consists in their saying that reactions occurring in living matter are solely chemical reactions, that chemistry can and must explain life. That is why in science we find such terms as “Biochemistry”. It is certain that a great number of manifestations of life are produced by chemical reactions. But the belief that there is only chemical reactions and that every observation must be explained in terms of a chemical reaction, is false. One of the purposes of this book is to show that matter has a

property heretofore unseen, a property which is neither chemistry nor nuclear physics in its present state. In other words, the laws of chemistry are not on trial here. The error of numerous chemists and biochemists lies in

their desire to apply the laws of chemistry at any cost, with unverified assertions, in a field where chemistry is not always applicable. In the final phase the result might be “chemistry”, but only as a consequence of the unperceived phenomenon of transmutation.

This severe error has led the scientific world to believe that one should find at the other end of an organism exactly what was originally given it. In other words, scientists expect to obtain a null balance sheet, counting that which has been retained by the organism or that which the organism has used up from its reserve. But balance sheets are never null. Today’s scientists avoid the problem by saying that something escaped them during the experiment—unfortunately, a confession of incompetence.

Specialists in biochemistry fail to tell us why a chemically pure reaction, such as the

one in which an atom of nitrogen and an atom of oxygen are combined, can be realized only *in vitro* at the electric arc temperature (or at a very high temperature and pressure). Living organisms do the same at room temperature! Many similar cases can be cited showing that the living organism is capable of reactions which can be reproduced in the laboratory only by a great deal of energy. Proteins are hydrolyzed in the stomach at 37°C in a slightly acid medium, but this same reaction requires a 120°C temperature and a highly concentrated acid medium to be realized *in vitro*.

Enzymes, which are a kind of biological catalyst, are no doubt responsible for making this *in vivo* reaction possible at low temperature. But the exact mechanism is not known; (it differs, however, from the catalysis with which we are familiar in chemistry).

Again, Lavoisier’s law is not being rejected here, nor is any law of chemistry. What is rejected is the attitude of too many chemists who apply chemistry in every domain. This phenomenon studied in the next pages is not chemistry. Einstein wrote, “The essential is to get rid of deeply rooted prejudices, which we often repeat without examining them.” [H: I guess this is about the only thing Einstein ever wrote with which I absolutely and whole-heartedly AGREE.]

The aim of this book is not to give a very detailed explanation of the mechanisms of biological transmutation, but only to show that they exist and, better, that they are being applied. They will be explained, perhaps, in the future at a time when science is ready.

We are probably on the eve of a great change in physics. Too many physicists have thoroughly committed themselves to paths which but lead to quicksand. But we are departing from our subject. My intention was only to remind the reader that great men of science, such as Einstein, de Broglie, etc., are teaching us to remain modest, to recognize that our knowledge is far from absolute, that teachings are not always true, and that there are transient hypotheses, even in physics which is labeled an “exact science”. This is even more true in biology, where the complexity is enormous and where we must be most cautious in our explanations. We observe results, but to describe the detailed mechanism leading to these results is always more or less subjective. It is hoped that this book may be objective so that it might assure the reader of the existence of a phenomenon other than chemistry—a deeper kind of phenomenon, not a mere exchange of electrons in the peripheral shell of the atom.

The limitations of chemistry can be revealed by a few typical examples in which researchers have failed to give any substantial explanation of certain phenomena. Other examples will demonstrate that there is a biological transmutation of elements. If the reader

finds his faith in Lavoisier's law somewhat shaken, he will be further surprised to find that many other explanations given him in the past are unfounded or tenuous, existing only to satisfy the dogma of "the invariability of elements".

For example, it is said that when a plant is enriched in an element different from those it previously contained, it has "obviously" taken that element from the soil or from the jar in which the experiment was conducted. Terms such as these are used: "Concentrated", "preferentially fixed", etc.; and the question is dismissed. Those who employ such terms have never measured the total content of the element in question—neither in the experimental jar nor in the soil—before and after cultivation. The latter should have been done if only to determine whether what was added to the plant was still in the jar. There is much talk about a possible source "by migration", but coming from where? And why? By what process—through impermeable soil? [H: I do not want to change subject in mid-cycle but I would consider "impermeable" as to not be absolute as the term would imply. You cannot contain [or block] such as cosmic

waves, or for that matter, any type of high frequency sound or light waves. However, as in a growing medium with fertilizers, etc., for soil and plant growth medium you do need, in Gaianria for instance, the PARTICULATE of these elements which give whole life to the Dria cells. It is elevation in frequency that we try to achieve for the "healing" characteristics in repelling damaging microbes of one sort or another—BUT THE WHOLE LIFE CELL MUST HAVE THE ELEMENTAL PARTICULATE TO REACH FULL MATURITY WHICH IS THEN CATALYZED BY COSMIC ENERGY WAVES. THE FREQUENCY IS SIMPLY NOT ENOUGH WHEN THE SUBSTANCE IS FOR INTRODUCTION INTO THE BODY FOR IMMUNE SYSTEM PERFECTING. There is no concern "here" but as we get further along and more tampering and tinkering is going to be taking place by those who THINK they have DRIAS, there will be incomplete substance making its way to you-the-public. PARTICULATE of the elements MUST BE PRESENT TO PERFECT ABILITY OF TRANSMUTATION IN THE GAIANDRIANA GROWING AND CONVERSION MEDIUM.]

Thus we must change our way of thinking entirely and be more cautious about what teachings we accept. Let us cite F. Dagnon who, in *Atoms*, revolts against the simplistic teachings of many of his colleagues. To use just one of his examples, he writes about respiration: "The CO₂ is exhaled before the oxygen enters; more exactly, the formation of the pyruvic acid or the 'acetyl-coenzyme A' takes place without its help, or at least without its direct influence. We are miles away from Lavoisier and the first biochemists who believed that respiration is combustion."

Brillouin, a great physicist, readily admitted that not all laws of physio-chemistry deduced from experiments performed on dead matter are necessarily true with regard to living matter. He cites the case of one of the laws of thermodynamics, that of the degradation of matter. It is the force opposite that of entropy ("negative entropy") which maintains life. Explanations given by physicists—where they try to show that

this law of Carnot is an absolute law, always true, applicable to the "living"—are of baffling naiveté. They do not dispute the fact, proven by experiments, that energy is provided by the living, but they declare that the living being receives that energy from its environment. Why then bring out the 2nd law of Carnot-Clausius, which has value only in a closed medium with no exchange whatsoever with the outside? This has nothing to do with entropy, positive or "negative". These are empty words. J. Rueff declared that Clausius, by setting forth his principle, "committed an audacious, if not hazardous, generalization, for it has value only in isolated systems formed of elements

independent of one another."

It is not difficult to see that life itself is in complete opposition with the law of entropy. Why? What is the secret? It is not known. What we can see, nonetheless, is that there are inexplicable phenomena which it is our role to decipher, be it with chemistry, physics, or biological transmutations.

PHYSICS

All laws of classical physics have been deduced from experiments made on dead matter. The principle of divergence—of elastic waves, acoustic, luminous, or material: all the physical waves of the inert—is not applicable to biology. Physicists such as Watan, Adams, MacLennan, Penrose, and Percival have shown the link between a progressing entropy (a degradation of energy or, more exactly, an increasing degree of molecular disorder) and the retardation of the waves. With Costa de Beauregard we can speak of a unity in physics, whose laws about dead and living matter would be as front and back, inseparable and complementary. We recognize here the concept central to Far Eastern philosophy, that of Yin and Yang, a unique principle with two faces.

Physicists were not surprised at the news: the biological transmutations made sense to them. In a way, they had been waiting for them. It was in the order of things. That is why the physicists were the first to give their support. To reject the biological transmutations *a priori* in the name of nuclear physics—a science based on observations of dead matter—is to evince an ignorance of this duality (yin and yang) which exists in all aspects of physics.

The greatest men of science now recognize that neither the chemistry nor the physics of inert matter is integrally applicable to living matter. Szent-Gyorgyi, who was awarded the Nobel Prize, expressed this point quite well in his disagreement with the physicists of yesteryear: "This makes the relationship between the physicist and the biologist rather delicate... If I had always accepted the physicist's verdict, I would have abandoned this way of research. I am glad that I did not

do it." He arrived at the conclusion that molecular biochemistry is not enough to make us understand what happens in living matter, that one should take a step down in the structure and study the atom, because it is at the sub-atomic level that the unknown is being produced. Otherwise "physics is the science of probabilities... biology the science of the improbable." (Szent-Gyorgyi, *Introduction to a Submolecular Biology*, Acad, Press [London, 1960.]) The improbable surely happens, because quantum mechanics proceeds only on the basis of statistics. But in biology things are different. An electron makes a sure jump and one only; it never misses the target. (This explains the small amount of energy necessary.) Why? This fact brought Szent-Gyorgyi to write: "Even quantum mechanics should be improved in order to be applicable in the analysis of most problems in biology." We are hanging in the air!

Let us recognize, however, that Szent-Gyorgyi and the others who follow the same path have but glided over the atom. They saw only what happens in the outer layer. They then remained in the field of physio-chemistry as it is now conceived—that is to say, the physical study of the movements of electrons in the peripheral layers. (The electrons, becoming "excited", jump to place themselves in levels other than those of their normal orbit.)

It will be widely demonstrated that there are other biological phenomena unexplainable by the movements of the electrons—that is, by chemistry or physico-chemistry—because of a frequent incompatibility between biology and these sciences.

L. de Broglie recognizes this incompatibility in *Matter and Light*. [H: Readers, you who can't wait for our dissertation on the subject of Light relative to "matter" which we presented in the now-banned series of volumes—you may wish to seek out this man's work. It is excellent and completely covers more understandable aspects of the "science" and spiritual realms of LIGHT secrets. Otherwise just stay with us a bit longer and we will help you make sense of the relationship and with that of "soul" energy.] He wonders if "the new conceptions of physics would help us understand why the classical methods of objective science have difficulty in adapting themselves to the vital order." Modern physics, as it was developed in the second half of the 20th century, has its roots in quantum mechanics. It took shape with Bohr and Planck and found precision with L. de Broglie in the beginning of this century, blossoming in 1960 with Gabor and Brillouin. Then came Jordan, Augier, Davilliers, etc., who touched on the different observations which had led them to believe that the microscopic physics of the inert is not always valid in living matter, where the parts are interdependent. These parts are all coordinated and have obvious interaction; otherwise there is no life. All this brings us far from Einstein, Heisenberg, Schrodinger, and Dirac. [H: And here you find the greatest few giants of misinformation toward building of a misinformed society in order to relate to and gain a New World Order. The only ones who would be left to know truth would be the ones with the ulterior motivation of the Zionist Khazarian rulership of your globe. Such obvious truth-bringers would be burned out and the work disallowed publicity and such daring ones who would come forth would be ridiculed and stripped of their "Rockefeller" credentials toward a healthy and strong civilization. You, through these methods, became totally an unadulterated PEOPLE OF THE LIE. There is no way that Einstein's theory of relativity can be correct—no way—and worse, he knew it. He was busy, if you recall, helping to build atomic BOMBS.] It is now widely admitted that a molecular reaction in living matter is controlled by a modification of the position of the electrons in their orbit (thus by their energy); that it is at the subatomic level that the chemical reaction is first prepared. But one must probe even more deeply in the study of the

atom, not only because it is unknown why and how these electrons "get started", but because other phenomena intervene in the heart of the atom.

Today physicists are obliged to recognize that at the subatomic level laws such as the conservation of mass or energy are not always observed, even in the physics of the inert. Bohr long ago recognized that we cannot say *a priori* that the law of conservation is valid at the level of the atom. J. Debiessé, director of the Centre d'Etudes Nucléaires of Saclay, remarked that the emission of π -mesons occurs with the sudden increase of the system's mass and energy. (Thus the energy does not increase due to a loss of mass; there is also an increase of mass.) Debiessé writes, "It remains to be seen whether at the speed of exchange 10^{23} seconds the law of conversion of mass and the law of energy are still valid." Such things brought R. Furon to say, "The rapid advance of our scientific knowledge excludes any orthodoxy and conformism." (In the magazine *Revue Générale des Sciences*, Paris).

Let us accept these lessons of modesty from our most eminent scholars. We shall then be ready, with no preconceived purpose, to become acquainted with the following study. Einstein's law of $E = Mc^2$ will not, then, be accepted as absolute in advance. Even Einstein himself indicated the limits of this law of "special relativity", special because it is applicable ONLY to non-accelerated and non-circulatory movements. (Einstein's first postulate admits that his law is valid only in a uniform and rectilinear movement.) Another restriction, pointed out by Einstein, is that this law is valid only if one accepts as the second postulate a constant velocity "c" for light. He then declares that that same postulate is cancelled out by his law of General Relativity; otherwise it would be impossible to explain the curvature of light under an intense gravimetric effect. (A constant speed is represented by a straight line. If positive energy is given to the mobile, the line curves in upward. A negative energy X reduces

the speed, causing the line to curve in downward. The acceleration by gravitation curves the light. Its speed is no longer constant.) Let us take the example of the luminous ray coming from a star skimming over the sun's edge. The star is visible sooner than would be possible if the calculation were made when light comes in a straight line. (This phenomenon has been observed during solar eclipses.) It was thought that it might be the result of diffraction occurring when light goes through the chromosphere of the sun (or perhaps only through its "crown"), in other words, when the ray goes through an area more dense than the "vacuum" of space. This occurrence implies a variation of the speed of light, which diminishes or increases in proportion to the density of the media passed through. This curvature would then allow us to calculate the refractive index of the solar chromosphere.

I could continue to point out "weaknesses" in the presently practiced science of physics. However, it would take many pages simply to discuss the fact that not all energies brought into play in biology are of the same nature of those of gravitation.

There is not the least doubt that Lavoisier was perfectly correct in his field. We understand why. Chemistry is the science of the combination of atoms; it studies in a specific way the variations in the links between the peripheral electrons of the atoms, which gather into molecules.

[H: But how could we KNOW that Einstein's laws were not actually "laws"? He said they were not. Now how can you know that Einstein was a controlled man and a servant to his controllers? Well, for one thing, a scientist of his supposed caliber would not be attracted to the usual sexual "stings" of blackmail or bribery. This "scientist" was so mortal, my friends, that he actually had an affair with a known mind-controlled "MON-ARCH" with a stage name of Marilyn Monroe. So, "which" Einstein? The one that sold you out for a bill of goods in a sexpot's butterfly. Einstein was, just as his cohorts were, a presentation of the Evil Empire.]

THE SYMBOLS IN NUCLEAR PHYSICS

The chemical symbol for the atom is not always sufficient when we are dealing with the atom's nucleus. It is often necessary to indicate the total number of particles (i.e., protons and neutrons, which are both nucleons or particles of the nucleus). This is because the natural elements are made of different atom combinations: all the atoms of the same element have an identical number of protons and electrons, since a normal atom is electrically neutral, but it was discovered that the number of neutrons in a nucleus can be different. A neutron owes its name to its being neutral. It has almost the same mass as a proton.

Atoms having the same number of protons but a different number of neutrons are called "isotopes". They are written thus: ^{24}Mg , ^{25}Mg , ^{26}Mg [these being stable (non-radioactive) isotopes of magnesium], which means that in those nuclei there are 24, 25, or 26 nucleons. Since all have 12 protons, the number of neutrons can easily be found by subtraction. Likewise, we have ^{10}B , ^{11}B for boron, ^{12}C and ^{13}C for carbon, ^{28}Si , ^{29}Si , ^{30}Si , for silicon, etc.

Notations of this kind can often be found: $^{16}_8\text{O}$, $^{17}_8\text{O}$, $^{18}_8\text{O}$, for example, which are the three stable isotopes of oxygen. The small index 8 means that there are $16-8=8$ neutrons in the isotope 16, $17-8=9$ neutrons in the isotope 17, and $18-8=10$ neutrons in the isotope 18.

The phenomenon of biological transmutation applies to the nuclei of the atoms, but the most important and abundant of these transmutations are found to occur mostly with the first 20 elements and to a lesser extent with the next 10 (from a total of 92 elements). [H: Actually we know from our writings on "Secrets of Light" that there are far more elements than this.] The elements are put in order according to the number of their protons (and electrons). Thus hydrogen (H) comes first; it has only one proton and one electron. Then comes helium (He) which has 2 protons; lithium (Li), 3, etc. [H: Now, here is where it gets very important to know that THERE ARE MORE THAN THE LISTED 92.]

Simplified notations have been chosen so that everyone can understand. Our aim is not to pursue theoretical explanations but to observe facts which cannot be understood in terms of chemical reaction. It is in explaining these that comparisons with chemistry might sometimes prove useful. Reality is too complex to be always accessible by our present scientific knowledge. We do not know, for example, why, during electrolysis (with no system of evaporation in effect), hydrogen and oxygen appear on the electrodes in gaseous form, although in water they do not exist in this form.

No one knows much about what goes on in a catalysis, nor even what happens in a chemical reaction (ignoring, for example, the instantaneous energies). No one knows how the releasing process from wake to sleep comes about, how aspirin works, etc. This is why theories will be avoided here. Only results will be shown, together with phenomena observed in the past and kept in the dark.

Many answers will be given in the following chapters. Systematic experiments which have been made to verify the conclusions of the past ten years will be cited. All precautions will be summarily indicated in order to avoid assuming the position of an analyst of mineral chemistry.

It may be that some chemists and atomic physicists will be hurt. Biological transmutation is a new science which has not yet found its own language, hence there is no way to make ourselves understood except to use the "old" symbols familiar to us all.

In such a study as the present work, it is rather difficult to avoid approaching the many separate fields of science. May the specialists of every particular branch excuse such presumption. Sometimes the exact and desired term is not used, either because the branch under consideration is insufficiently familiar or because hermetic terms would have rendered the text inaccessible to a larger public. This applies even to the specialists themselves, because the vast synthesis projected here places the essential part of this work outside any single discipline. It is hoped above all that no aspect of this exposé has been distorted for the sake of simplification.

SYMBOLS FOR THIS BOOK

We have proposed the symbol \rightleftharpoons to distinguish it from the symbol $=$ which is good in mathematics or chemistry, indicating two valences, and to distinguish it also from the symbol \rightleftharpoons used in chemical reactions, which means that the reaction is reversible. If we want to indicate the only direction the reaction takes, we write (in chemistry): $2\text{Na} + \text{O} \rightarrow \text{Na}_2\text{O}$.

With this type of reaction occurring in biological transmutations, in order to make clear that no chemistry is involved and thereby avoid confusion, we note $\text{Na} + \text{O} \rightleftharpoons \text{K}$. This indicates a reaction from left to right. There is no reversibility as is found in chemistry where one may end up with an equilibrium between the atoms on the left (the constituents) and the composed molecule on the right. In our reactions when we indicate \rightleftharpoons : we mean that the reaction is reversible but not with the same agents. Different enzymes are required; some can be made only by animals and some by plants.



"This place is all right. Two more weeks, and I'll be a molecular biochemist."

The reactions can be subtractions; the potassium nitrate in saltpeter—which is found in the lime on walls—comes from calcium when bacteria cause a subtraction of hydrogen in the middle of the calcium atom. Calcium - hydrogen = potassium, or $^{40}\text{Ca} - ^1\text{H} = ^{39}\text{K}$.

It can be seen that potassium has two origins: sodium plus oxygen, and calcium minus hydrogen. A law now emerges from these biological transmutations: reactions at the nuclear level of the atom always involve hydrogen and oxygen. In biology, there are not only chemical reactions with oxygen (oxidation) or hydrogen (reduction). There exists a phenomenon deeper than the mere "hookings" of the peripheric electrons.

It might be useful to know that very often, to simplify our writing, we write only the number of nucleons (above and at the left of the symbol); we do this because we take for granted that the reader knows how many protons there are—see Mendeleev's periodic table—and the number of protons is sufficient to identify the element. Thus if, for example, the symbol Na is given, one knows it is sodium; it would be repetitive to add the number of protons to again indicate that it is sodium.

For practical reasons, however, one may record the proton number also. If one has $^{11}\text{Na} + ^8\text{O} := ^{19}\text{K}$, he adds the protons (written below and on the left) and automatically gets the atomic number of potassium.

The same method would be used for other elements.

The complete writing is $^{23}_{11}\text{Na} = ^{16}_8\text{O} := ^{39}_{19}\text{K}$, the numbers on the left giving the numbers on the far right. It is important to note that in this type of notation the number above and on the left is not the atomic mass, but the number of nucleons.

CHAPTER I ABERRANT OBSERVATIONS:

ON CHICKENS

[H: Word meaning: "Aberrant": deviation or distortion.]

My parents had a few chickens which they kept in a chicken coop adjoining a yard. We lived in Brittany, France, where my father worked as a government official. The area was full of slate rock and granite, but absolutely devoid of limestone. Limestone was never given to the chickens, yet every day during the egg-laying season they laid eggs with calcareous shells. At that time I had not yet asked myself from where that limestone came, but I was intrigued to observe that when the chickens were let loose in the yard, they scratched about incessantly for fragments of mica strewn on the ground. (Mica is one of the components of granite, along with quartz and feldspar; all are components of *silica*. This is all I knew then when I was in elementary school.) I noticed this neat choice that had been made by the chickens, when the sun shined after a rain: well washed off, these hundreds of visible fragments looked like tiny mirrors. The imprints of the chickens' beaks were easy to follow.

No one could explain to me why chickens scratched mica and not sand. Whenever a chicken was killed I observed my mother opening the gizzard and finding small grains of sand, but never mica. Where did this mica go? Into the stomach? Why was this mineral swallowed by the chicken? This problem intrigued me and remained in my subconscious like anything mysterious, because I rather liked to have "solid and logical" explanations... the whys of

all children.

ON INCANDESCENT STOVES

In the elementary school classroom in the borough where I lived, we were heated by a rudimentary stove made of cast iron. There was a key on the pipe to regulate the draft—or we could push or pull the ash-tray. Old oak was mainly used. When the wood caught fire, the stove very quickly began to "snore" and became red. Then everyone complained of headaches. That is why an "officer in charge" was appointed to turn off the key or push the ashtray when the stove started growing red.

The headaches, the teacher told us, came from the carbon monoxide emitted by the stove at the red-hot point. At school, however, the belief was that slow combustion gives off carbon monoxide (CO), while fast combustion produces carbon dioxide (CO₂), which is less dangerous. We were advised against sleeping in a room having a stove with a slow draft.

I couldn't make up my mind. If the stove becomes red, it is precisely because it has a good draft system, a very good one, and there should be no formation of carbon monoxide. All the explanations given to the questions I later asked my teachers were so little convincing that this mystery also stayed in my subconscious. [H: Can you now see the impact of misinformed teachers? A child is required to believe whatever his teachers, through force, teach. If the lessons be incorrect the child is destined to probably be forever ignorant of truth in just about everything for one lie builds upon another, one ignorant thought upon another until there remains no truth and a bunch of ignorant people trying to make reality of the farce.]

The scientific answer is this: red-hot cast iron becomes porous and allows the CO within the stove to seep out instead of leaving by way of the smoke pipe. If I objected that there could not then be carbon monoxide from a fast, complete combustion, the reply was that CO₂ went through the red-hot cast iron, became rich in carbon, and then became carbon monoxide. This meant that the cast iron would eventually lose its carbon! I have never seen a few hundred grams of coal (approximately 40 grams per kilo of cast iron) disappear from a cast iron stove to produce a stove of steel! These hundreds of grams of carbon would have burned quickly! Even if cast iron is porous when incandescent, I do not believe carbon monoxide is produced in the contact of

CO₂. Thus, to make things worse, we are considering unreal conditions, since if the stove draws well it is because there is depression. This means that if the cast iron is porous, there won't be any gas seeping out. On the contrary, there will be an "air call" through the porous wall!

But what really happened? Undeniably a red-hot stove in a closed room brings about intoxication, sometimes deadly, from carbon monoxide.

The explanation of all this came to me indirectly when I was fifty years old, although when I was still a child the problem had already repeatedly presented itself. I had to wait until 1955 for a convergence of mortal accidents to make me doubt the theory of the "invariance of matter". Notwithstanding the current respect for official prescriptions, there were nonetheless many people who had met death by carbon monoxide intoxication, although it was attested to by many analyses that the victims could not have inhaled carbon monoxide. I crossed the Rubicon, and with coworkers (eleven were engineers from the finest schools of France) undertook a long series of experiments. We secured the help of official laboratories along with the cooperation—for blood analysis—of many M.D.s. I abandoned my postulate concerning the invariance of matter in order to confirm or nullify my hypothesis about the real cause of death, intending to concentrate only on results, whatever they might be.

In the meantime, in the spring of 1959 I was led to conclusions which revealed the explanation. Balance sheets had been established on teams of workers. The Minister of the Sahara himself, Jacques Soustelle, an ethnologist, had given me the opportunity to make a close study near petroleum wells. In spite of the prevalent classicism, I decided in the summer to publish these aberrant balance sheets, established from chemical and physical points of view, but resulting from research I had made with the cooperation of the most eminent specialists of organic chemistry, together with professors of medicine who believed that I was on solid ground.

As a high official of the French government, I had the unique privilege of using any official laboratory. I could thus have the collaboration of the most eminent specialized chiefs of laboratories, professors of universities, etc. (for it is impossible nowadays to ask the same laboratory to make different experiments). This privilege proved very useful to me. Without such a synthesis of disciplines my task would have been impossible. No isolated specialist could have succeeded.

I thank all the eminent men of science who brought me the support of their high qualifications, permitting me to prove and confirm the validity of my theories.

ON WELDERS

In 1935 I made an observation which left me perplexed. A blowtorch welder was mortally intoxicated by carbon monoxide. My job was to investigate the conditions surrounding the accident in order to determine the causes and eventually prevent them. Nothing enabled me to discover the source of this carbon monoxide.

Many times after that such accidents occurred, and on no occasion could I find the link which would lead me to the origin of the inhaled carbon monoxide. These facts remained in my subconscious until 1955. It was not until that year that I saw the light.

That same year in the space of a few months, three oxyacetylene welders died. I received all the detailed reports, including autopsies. All evidence indicated that the welders, who were all steel cutters, had died from oxycarbonaemia and not from nitrogen oxides.

Analysis showed that the inhaled air had too small a percentage of carbon monoxide to be dangerous. It was then decided, with the assistance of M.D.s working for the companies, to make blood analyses on all the victims' comrades, although they looked in rather good health. We found that those doing the same work were deeply affected with chronic oxycarbonaemia, some to a level approaching that of fatal accident.

I put together all I had and imputed the fault to working conditions, although analysis of the air inhaled by the workers proved that there was no source of carbon monoxide anywhere. Investigations were made in different places. The impregnation with oxycarbonaemia was general. After four years of research, using the most delicate of methods, I could conclude:

- (1) that the strong blow-torches with which the workers cut metal do not liberate carbon monoxide, but do bring a large surface of ferrous metal to incandescence.
- (2) that those workers who were bending down to their work—and only they, not their helpers standing by—inhaled the air which licked the ferrous and incandescent metal.
- (3) that the analysis of the inhaled air showed an absence of carbon monoxide, meaning that the air was always a combination of nitrogen and oxygen. This explained the fact that never, even though a great number of investigations were made the world over, was carbon monoxide found in the inhaled air.
- (4) that carbon monoxide—being detected in the blood of workers, not in the blood of the helpers—could only have an endogenous formation when this air is breathed. In other words, it was activated by the air's contact with a ferrous and incandescent metal. This would shed light on the observations made in places using cast iron stoves heated to incandescence.

The oxygen in the inhaled air was not sufficient to allow a formation of CO in the organism. There is O, but C is needed. From where does it come? After much research I thought that it was activated nitrogen which produced carbon in the organism (at the level of red corpuscles irrigating pulmonary alveoli). This question hasn't been cleared up. The nitrogen molecule (there is never free atomic nitrogen; isolated nitrogen is always in the form of N₂) contains two nuclei of nitrogen enveloped by the electrons of the molecular

orbit. In the heart of the molecule the two nuclei vibrate at a known frequency. Were this submitted to a vibratory and outer energy more or less of the same period, could it be a resonance which at a certain time provokes the passage of a proton with its neutron from one nucleus to another? All this occurs without any change of the peripheral electrons. On one hand, there remains a nucleus with one proton missing, thus carbon; the other nucleus acquires one more proton and

cytes going through the air cell. It has not yet been proved that I was mistaken. [see figure 1]

Controversies arose when I published the above explanation in 1960. A specialist advanced the following opinion: the heat of the inhaled air led to a dilation, a reduction of density, thus to the rarefaction of the inhaled air. From this would result a diminution of the oxygen pressure, which is conducive to "bad combustion" in the blood, hence CO is formed instead of CO₂.

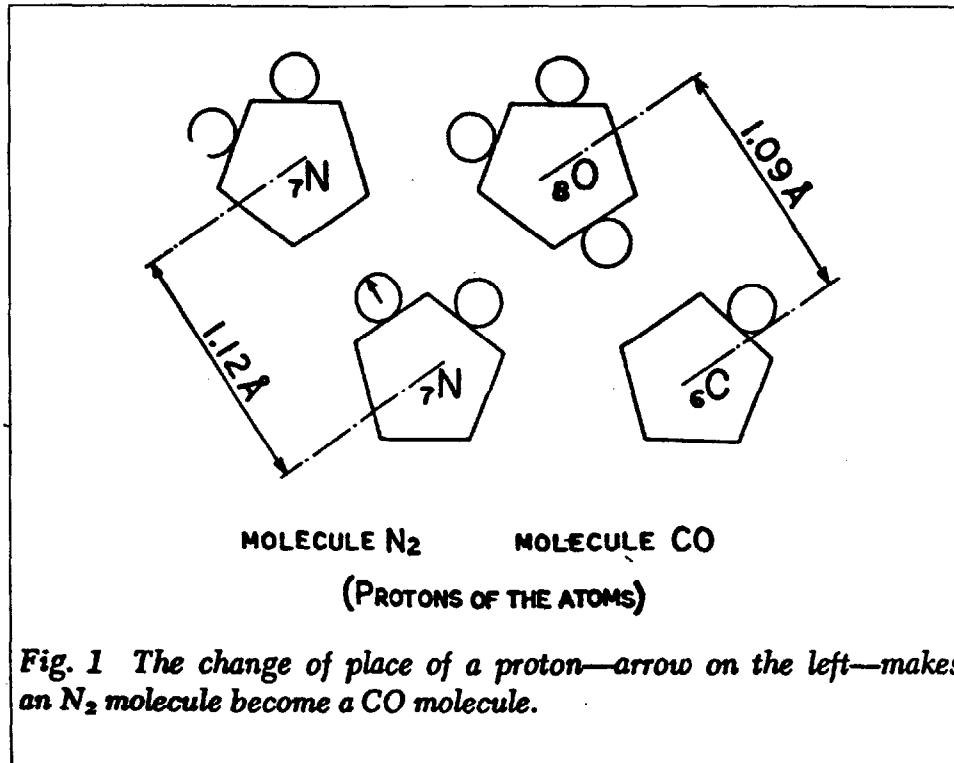
It is easy to see that this hypothesis has no value whatsoever. The breathing in of hot air would not lead to the same effect if there were no contact with an incandescent metal.

Nevertheless, a systematic study was made in 1963 by a friend, Professor Desoille, and his colleague Truffert, both holding high official positions. They demonstrated that the phenomenon was independent of oxygen pressure. (H. Desoille, *Absence de corrélation entre la pression de l'oxygène et l'oxyde de Carbone dans le sang*, Arch. Mal. Prof, July 1963.) In 1964 I also showed that this phenomenon does not occur when the metal sheet is brought to a temperature of 400°C; one needs at least the deep red, and when the sheet is bright red the effect is quick. Oxygen is not the cause; thus my first publications in 1960 were confirmed. Nor does this same effect occur if one exchanges the nitrogen of the air with helium. Nitrogen alone is the origin of this en-

ogenous production of carbon monoxide. The phenomenon being clarified, since my position in the scientific world permitted it, I notified "inspectors" of the measures to be taken in factories to avoid oxycarbonic intoxication once and for all.

becomes oxygen. It is thus a phenomenon having nothing to do with nuclear physics; one remains at the molecular state. But we have here an internal remodeling by the removal of a proton from one nucleus to another. The measurements taken show that in the molecule N₂ the distance between the two nuclei of nitrogen is 1.12 Angstroms, whereas in the CO molecule the distance between the C and O nuclei is 1.09 Angstroms.

This removal of a nuclei when a proton and its neutron exchange places does not seem radioactive: it could occur under the energetic action of an unidentified enzyme at the level of the pulmonary air cells, or perhaps in the thickness of the membrane of the erythro-
