Waco Survivor Thibodeau Tells His "Inside" Story You Be The Judge!

This week's Front Page story is a change of pace from the most current news to return to a matter that has been manipulated heavily throughout all of the controlled media mouthpieces. What follows is an interview between articulate Waco massacre survivor David Thibodeau and CONTACT on September 26, 1995.

• *Is David Thibodeau an MK-ULTRA Mind-Control Project "sleeper" spreading calculated disinformation, yet he doesn't know it?*

• *Has David Thibodeau been "brainwashed" by David Koresh?*

• *Or—is David Thibodeau merely a peaceful individual seeking spiritual knowledge?*

What is the TRUTH?

Read the following interview and you, as readers, REACH YOUR OWN CONCLUSIONS. We are merely offering this conversation verbatim, as straight reporting, to cover an aspect of the events that has been largely "overlooked" by the pack of "professional" news hounds.

Moreover, immediately following the interview are two writings from Commander Hatonn extracted from the time period of the original Waco incident in the Spring of 1993. These provide important background perspective on the magnitude and range of manipulating participants.

Now, let's hear what David has to say.

David: People try to make mountains out of mole hills. They'll take certain facts and try to tie in all these other organizations—like, it was a CIA plot and David Koresh was a "sleeper", and you know he was working with the CIA. These things are just crazy. I knew the guy for two years. I lived with him day-in, day-out. I know what his motives were. I know what his stance was about the government and he didn't dislike the government to just dislike the government. David disliked any people or group or entity that would go against basic human rights and human issues because he was, first above all things, a Bible student and Bible scholar, and he was a Bible teacher. He believed in that book with his whole heart. He would live and die for that book. He lived to bring people to the knowledge of the truth. I saw the guy stay up for two, three, and four days in a row to give people studies. Sometimes he would be so exhausted giving someone a study, he would fall asleep out of sheer exhaustion, wake up two hours later and he would continue right where he left off—it was that amazing. He was that devoted twenty-four hours a day, always thinking about what God's will is, what the plan of God is, and what he is to teach and show people; especially for these latter days that I personally believe we're in.

I know that your newspaper believes we're in the latter days. But, you know, people get the latter days confused. A lot of people want to say, alright, this is it. God's going to come down, you know, kick the butt of the heathen, and all the Christians (or however you want to look at it) are going to go to Heaven. And you know, it's just not like that. There's a whole big time prophecy that revolves around the Kingdom being set

up in Israel, Mt. Zion. And all nations are going to be able to flow to that mountain and they're going to learn something from the Lamb himself, standing on Mt. Zion, if you believe in Revelations [sic], if you believe in the scripture. Some people do not. I can understand why people don't believe in the scriptures, having never been raised with the scriptures and just having

been raised in society, in public school systems, and you start to read the scriptures of God and they seem a little bizarre. They seem a little "far out". But, I would simply say, look at what we've done with the television set. Look at the TV shows we have. We have *The Liquid Metal Man*, *Terminator II*—I mean, we've done some incredible feats with imagery; it's almost like a sorcery, in a sense. What I would say, if there is God and He is all powerful and created all things—I believe there is and He did—is God going to be outdone by what the technology of man can do? I don't think so. I think for every image that we can see on the television screen, there is a greater spiritual truth. That's also dangerous, with all these horror movies. I mean, I think there are two sides to every coin. I think mankind has been pretty negligent in honoring society, especially movie makers, but I don't want to get into all of this.

The basic point I'm trying to make is, a lot of people would like to say that David Koresh is just some kind of nut. In reality, he wasn't. He was a hundred percent devoted to God and would have done anything with and for that devotion. I would say though, even more, he was devoted to mankind in the sense that he had a purpose and he wanted to bring his purpose about through music. The government did not allow him to do that when they went onto Mt. Carmel on February 28, 1993, and started shooting.

Now, even if David Koresh was everything that the press said that he was, in no way was it justified for the ATF to open fire on a church-load of people, mostly women and children—disgustingly negligent. Especially when the whole raid could have been avoided and they know it. It could have been avoided because David Koresh, through Henry McMann, who was a firearms dealer in Waco, invited the ATF out to the property to view his firearms that he bought, to see if they had been tampered with, to see if they were illegal. And they

declined. They chose not to go out to Mt. Carmel and look at the firearms because they wanted to go forward with what they call a "dynamic entry". I would call it a military assault. When you have a hundred armed men dressed in black and you're shooting at a building—that's a military assault. You can try to use these pretty words all you want, it's no dynamic entry involved—it's a military-style assault.

Rick: Were you inside at that time?

David: Yes, I was inside for the whole 51 days. I'm one of the nine fire survivors. I exited the building on April 19, literally at the last second that I possibly could. I was either going to burn to death or I was going to come out and be shot in the head. That's what I was thinking. As I was exiting the building I thought I was going to be shot in the head.

Rick: It has been said that Koresh left and was removed by helicopter. Do you think that is false?

David: I think that is false because, number one, while the place was burning there really were no helicopters flying overhead.

Number two, I don't think Koresh would have gone. Koresh was a family man. Koresh believed that everyone there was his family. We were a community that was so strong and so tight, we were like, literally, one family. We considered ourselves a spiritual family of God. And I don't think—no, I KNOW that David would have never betrayed that. If it was God's will that the people die and the people were trapped because of where the tanks went in, then Koresh would have been the first to go. Let me put it this way. He was a good captain. He would have gone down with the ship. Also, while I was there exiting the building there were no helicopters anywhere around the area. There weren't even fire trucks at this point; there were tanks everywhere.

And lastly, I've seen all the vidcos and at no point do I see any helicopters lower toward the building. And the cameras from two and three miles away were fixed on the building until it burned all the way to the ground. There was a surveillance plane flying two miles over the building that day and I have the infrared tape taken from that surveillance plane and at no time do you see a helicopter anywhere near the building while the place is burning.

The last time I saw him was at 10:30. My whole experience, my whole time being inside I never—although the helicopters would fly very close overhead

during the siege and they would buzz the building—they never landed on the building or even hovered over the building. I think they wouldn't do that, number one, for fear of being shot at—not that we would have shot at them, it's just that that's the

way the government thinks. One huge misconception that I want to explain right here in this interview—I'm trying to give you an idea of what the mind-set of the people were. We did not want a confrontation. We did not want it February 28, and we did not want it all the way through the siege. We tried to avoid any kind of confrontation. When they set up the speaker systems, which was the Psy-Ops, this plan to play all of this music [and the sound of killing rabbits]. I'm a very, extremely peaceful person, ok? But there were times when the thought ran through my head, "I would like to shoot those speakers out because they're driving me nuts." That thought entered my mind.

Rick: That was the idea.

David: But I quelled it. Exactly. They wanted us

to shoot at those speakers so that they would have an excuse to shoot back into the building. I think they were absolutely amazed that we didn't shoot at the speaker system, but I think that says a lot for the people in there—from where we were and what we were trying to do and how we were not trying to have any kind of militaristic assault with the government as the government claims. That's craziness. We wanted to avoid any kind of—we didn't want to see any more of our people get hurt. After six of them died the first day, we didn't want anyone else killed. We didn't want to kill the FBI agents, that's ridiculous. The people in there weren't like that. What we did want is justice and that had been void from our presence all the way through the whole thing.

Rick: This is the perfect time to say your piece about various misconceptions over the entire incident.

David: I guess the point I was trying to make was about the communityship. The people were so strong in the scriptures of God that they did not shoot at the speakers. They did not do anything to antagonize the government, yet the government did everything in their power to antagonize us, to make us do something that would promote an armed confrontation. That's the way it seemed to me from the inside.

On April 19, when they had already CS-gased us for three-and-a-half hours at 10:30 in the morning, we had been

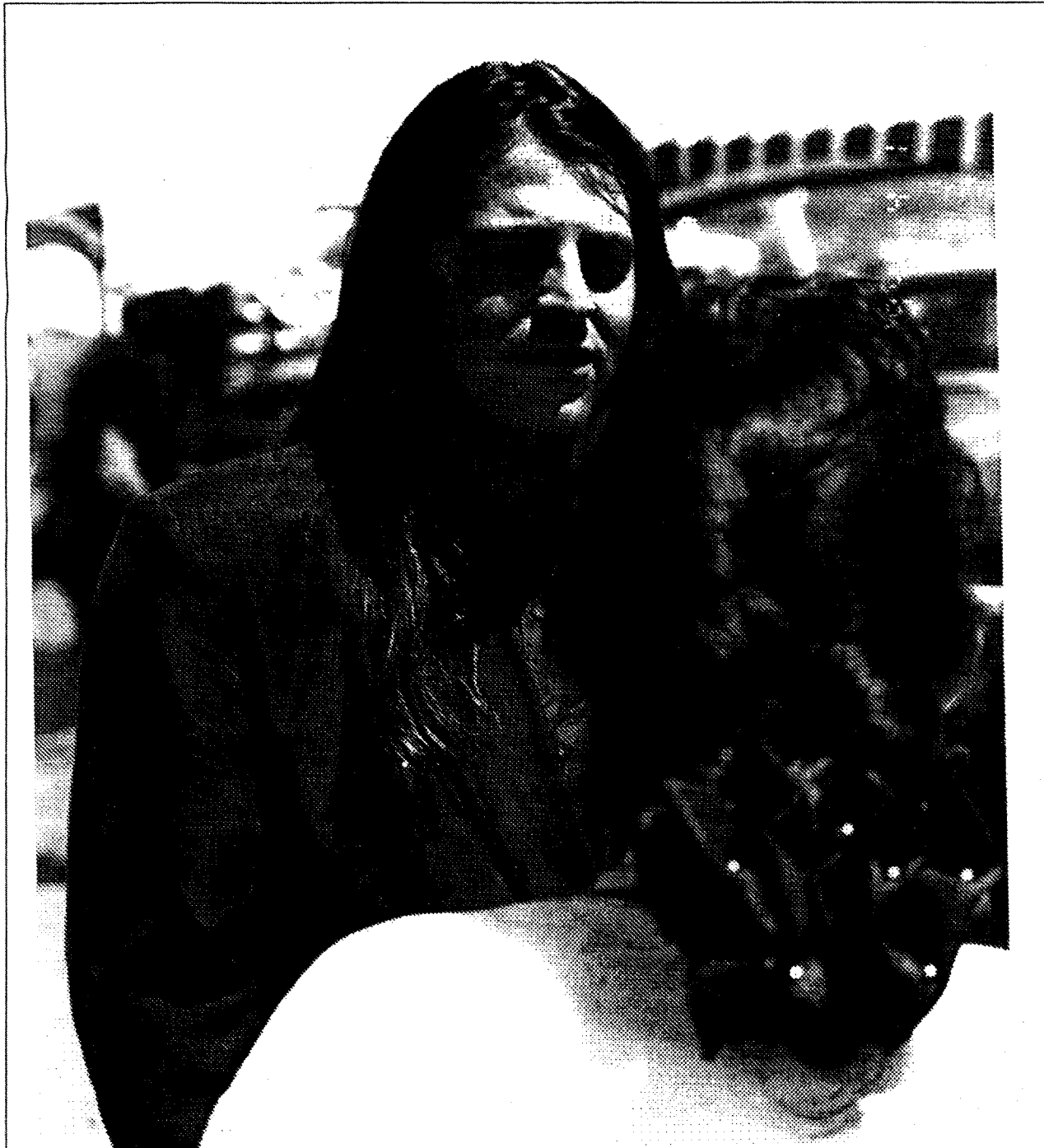
attacked all morning. They had been shooting in these ferret rounds of CS gas. A ferret round looks something like a coke can, about that size, a little smaller. It's got three fins on the back. The one I saw looked like it was stainless steel. Another thing they did is, after 10:30 when the cameras could see them and the light was up, the sun was up, they started to ram the building and take it apart piece by piece. And every time they would ram the building, a tank would enter the building and spray in liquid CS gas. Now, if the reports that I have heard are correct, they sprayed in 1000 units of the liquid CS gas. If you study anything about CS gas, it's physically harmful to women and children. It's not used internationally. We didn't use it in the Saudi Arabian war [sic] because the international community would not allow it because of all the reports that came out about the kids that had been killed, especially in Israel, due to the concentrated use of CS gas. However, there is no law in the United States stating that it can't be used here. So, Janet Reno—and she claimed she did everything in her power for the children—what a farce that is—said that she found the most harmless form of tear gas she could find. What a blatant lie. In her using the CS gas, which is banned internationally, she told one of the biggest fibs I've ever heard in my life. One of them, and I'll mention a few others about some of the FBI agents in a minute. But for her to say that, being the supreme law enforcement personnel of the land, is criminal. She gassed those babies. The kids suffered more through all of this than any of the adults. And I say that because the loud music meant to drive us out harmed the children more than any of the adults. And the CS gas is deadly to children, more so than to adults. We had gas masks but the children did not. We couldn't find gas masks small enough for them. So, the mothers said to take cloths and put them in basins of water and cover the children's mouths. Fortunately, we had a lot of cloth, so they would always switch off.

The point I was trying to make before I got a little side-tracked, was that at 10:30 that morning I was listening to a radio show and they cut to a commercial. We were listening to a guy who had been with us on the radio. His name was Ron Ingleman. He did a lot a great work—I mean he really tried to get some people in there, some medical personnel. The government, of course, would not allow it. But he didn't give up. All he was doing was defending our constitutional rights. This man was saying that, no matter what, if David Koresh is guilty these people have certain rights. We don't know what's going on in there and we shouldn't allow this kind of hatred that is being presented toward this group to occur because we don't know them. We don't understand them.

So, his radio show went to commercial and they had an update and the news update said, "This is so and so and the Branch Davidian compound is being raided by the FBI. Janet Reno has OK'd a tear gas plan." Of course they didn't say "CS gas", they said "tear gas". And, "tear gas is being pumped into the building in the hopes that people will come out. The FBI has reported that they have received 80-200 volleys of gun-shots against their CEVs." CEVs is a really nice word for tank. That was the report.

Now, until I heard that report, I had hope. My hope was that the FBI was going to see that we were not going to come out, that we were going to obey our God, and we

were going to stay there until the timing was right; until David's *Seven Seals* manuscript was complete. They had promised us that David would be able to complete something called *The Seven Seals* manuscript that he was writing. That was part of an April 14th letter that was sent out to the FBI. It basically said that he was prepared to come out on completion of this manuscript, when it could be proven to him that two theologians, James Taber and Phil Arnold got copies of the manuscript that they could give to the scholastic world. That was his little insurance. Then he said, "I will come out with my people and you can do what you want to this beast." Pretty interesting wording for the man who the media says is claiming to be God himself. Don't you think?

The point I'm trying to make: At 10:30 when I heard that report, I saw the writing on the wall and I knew that we were doomed, because no one had shot at the tanks for the entire morning. I was amazed at the restraint of the people I was sitting near, reading their scriptures while tanks are entering the building and inserting CS gas. If somebody did fire from the building, they did it from the other end of the building where I couldn't hear it. And that would be surprising to me because a firearm is a very loud thing and you could hear it throughout the building. During the siege, a couple guns accidentally went off and you could hear it everywhere. I mean, it's loud. So it would be very surprising to me if someone at the other end was firing and I couldn't hear it. The point I'm trying to make is that I was shocked at this report. I knew that the FBI was lying. I knew it was their biggest lie and I knew it was to set up the American public for a massacre, which is exactly what they did and that's exactly what they got, a massacre. So that was one of the disgusting, you know, just disgusting lies from my experience that occurred.

Another one that stands out in my mind that really, really broke my heart was the day after the place burned to the ground. I want to give a little foreground to this story I'm about to relate. By April 19, we had been gassed the whole morning, ok? I'm in the church area, basically our main room. It's where everyone—it's where we had our meetings, where our band played. We had a band there, a lot of musicians there. I was in that

room and they had been demolishing the building pretty much all morning, inserting the gas, and someone yelled from the upstairs that there was a fire upstairs. Now, when I heard this, instinctively I went in the back room. There was a room behind where we were and there was a staircase that led upstairs. The other staircases had been knocked out because of the tank activity going into the front of the building, destroying the building. Entrances were blocked off. Stairwells were knocked out. I went to this back one and I got halfway upstairs and I could see the door but I couldn't reach it because there was a huge beam in front of me. What people couldn't see is at the back of

the building, the building was being demolished, literally leveled to the ground. And this was the gym area that we had, our storage area. And that was adjacent to this stairwell that I'm talking about. Some of this debris had pulled over onto the stairwell and I could see the door but I couldn't get to it. However, to my right was David Koresh's room and there was no wall there any more, I think due to the destruction. So, I basically put my arm and my elbow, elbow length, onto David Koresh's second-story bedroom floor and pulled myself up and I started to walk through all of this debris. It took me some time. I went into the adjacent room, which was an office space where a lot of the firearms had been stored and over the rafters of the church area there was a catwalk, OK? So it was a little walkway that lead to the second-story hallway. Now, I took that catwalk and I got to the hallway. There was a big curtain in front of me. We didn't have doors, we were still building Mt. Carmel at the time. But there was this blanket that was there and

I opened the blanket and I got hit with big black gusts of smoke. Once the smoke dissipated I went to stick my head

into the hallway, I was thinking, all the time I'm thinking, "The women and children. Where are the kids? Got to get to the kids and get them to the underground bus, because we had a bus that was buried and..."

Rick: I was going to ask you about that, whether the entrance was in fact blocked like Linda Thompson indicated.

David: Oh God, let's not talk about Linda Thompson, I mean, she has really done a great disservice and put out a lot of misinformation through this whole thing. Not to mention calling everybody that disagrees with what she says, a government operative. And she's called me a government agent. And about three others of the survivors, government agents, which is just the most ridiculous thing I've ever heard in

my life.

But, yeah, we wanted to get them to the underground structure.

Rick: Was that ultimately blocked off?

David: I'm setting the stage here for that. That's what I'm thinking, "We've got to get the kids into the underground structure." Now, I went to stick my head in this hallway and a wall of flames shot down the hallway in front of me. It just shot right down the hallway. There were thirty, twenty-five to thirty-mile-an-hour winds that day. And the hallway began right where the corner of the building was, right where they went in with the tanks and totally ripped apart the side of the building. That's exactly where the hallway was. So, with that kind of wind you're going to get fire spreading all the way down the hall rapidly like that. That's what happened. I went back the way that I had come. I knew that I couldn't get in that room. I wouldn't be able to get to the kids. I didn't even know if they were upstairs at this point. I was at a different end of the building. So, I went back downstairs and by the time I got downstairs, the place was engulfed with smoke. I took my coat off, I had a black leather jacket and all these little white specks all over from where the CS gas had crystalized on my coat and actually imbedded itself into the coat. Took that off, I got on my knees—took my gas mask off, it didn't matter at that point—and I just started praying. The wall to my right-hand side caught fire and when that did, it singed the side of my head, the side of my face, just a little. When that happened, I looked up and saw Jammie Caseo and Derrick Lovelow going out the big hole that the tanks had made. Now, I ran for it and made it out that hole, just in time. I was surprised

because as I was walking up the walkway, they were telling us where to go, I looked back and saw Clive Doyle come out of the hole and his arms were on fire and he was patting his arms down. We got to the end of the property where they had a big Red Cross sign, the FBI put us down on our faces and they strapped these plastic straps behind our backs and started asking us questions. And one of the FBI agents got

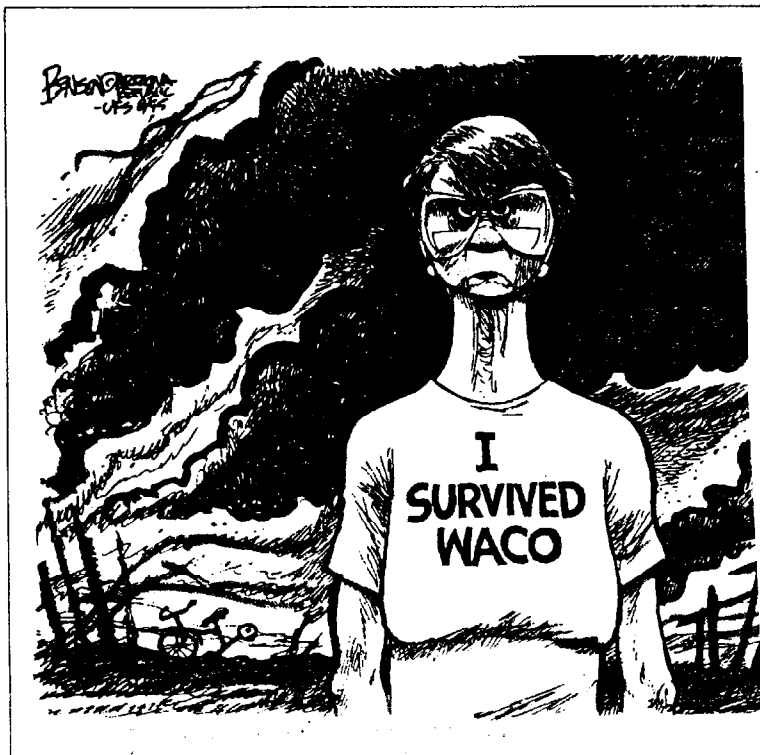
in my face and he said, "Where are the women and the children?" He looked at me and he said, "You're going to live with this for the rest of your life. Where are the women? Where are the kids?"

And then he said something else that was interesting. He said, "I knew we shouldn't have done this. I



knew this wasn't going to work. We should have gone with Plan A or we should have gone with Plan B," I think that's what he said. That always just stuck out in my head, you know, him saying that. I didn't know what the other plan was, but probably a direct assault.

But, anyway, after hearing this they put us in the CEVs and drove us down and turned us over to the ATF. ATF threw us on our faces in the dirt, checked us again and then threw us in a van and took us to where the sheriff's department was set-up, the first check point. We were at a big tent and they took off all our clothes and they videotaped our bodies; took all our clothes as evidence and gave us the orange clothes and took us to a place called TFTC where they were set up and put us through the whole scenario, you know, fingerprints. We did the hand prints. Everything was printed. I'm surprised they didn't want to print my elbows, or something like that. It was absolutely crazy.

Then we go to jail and I'm sitting in jail and I'm watching TV and Jeffrey Jamar, the agent in charge of the FBI down there in Waco, comes on and he's got a little clipboard and they're doing their final press conference and he says, "We went to the underground bus. Some of the survivors told us that the women and kids would be at the underground bus. We went to the bus, our agents went inside it, yet there were no women and no children. The air was crisp and cool. There was water down there, could have supported life. Yet, there were no women and no children." And when I heard that, I was so disgusted. I just wanted to rip the TV off—I just couldn't believe what I was hearing from this guy. After the agent had said to the other agent in my presence that they tear gassed the bus, this guy was refuting that. Then, when the Justice Department report came out later, there is a segment in there that talks about that and they actually brag in the report about tear gassing that bus because they didn't want anybody to go there. They also mention that a wall—that a tank may have knocked a wall over onto the entranceway to the bus where people could not have gotten in. While the tanks were destroying the building, we believe this occurred.

Rick: Was there also an underground bunker?

David: Yeah, well, I would call it our tornado shelter. It was being built. We were putting the floor on it, that was adjacent to the bus, yes.

Rick: Was that filled with people?

David: No, nobody got to—no one made it to that section at all because they knocked off the passageway and they tear gassed that whole area. They didn't want anybody getting to that area. According to the autopsy reports, two of the bodies were found trying to get into that underground area. But, for whatever reason, they could not. We would anticipate it would be debris over the entranceway to the underground area.

Rick: Did you have any particular role in the community? Or were you just living there?

David: Yes. Originally, I met David and Steve at Guitar Center in Hollywood here. I'm a drummer. They went into the music room and they were looking at a drum set. So, I met David and Steve. They were looking at this drum set and they asked me to play, and I played it. They gave me a card. To make a long story short, we ended up getting together and I played some music with them for some time and I also started to get into the studies that David was giving, these scriptural, Biblical studies that were just very, very deep. And so, it was a combination of two things; originally it was the music. Then I started to get into the scriptures, as well and the theology and a lot of time doing both things. But my role was as a drummer. But when we built a pool, I helped build the pool. I did some of the labor stuff around the community as well, as it was a community and everyone was expected to chip in. You know, do their part. That was pretty much it.

Rick: When you were talking with David that last

day or two, was the conversation all centered around the Seven Seals?

David: Well, yes, the whole 51 days we were studying constantly to find out what should be done, what the next move was going to be—actually, literally, where we were in the Seals because each Seal is like an experience that the family of God will have to go through. And so we were studying constantly. But the last couple of days he was really referring to this manuscript in hopes that the FBI was going to allow him to finish writing *The Seven Seals* manuscript in written form, and we were working on that pretty much constantly. So, we didn't see him much the last few days before. It took him about a week to finish the *First Seal* and he finished it on April 18. And he was going to begin the *Second Seal* on April 19, which is, of course, when the FBI

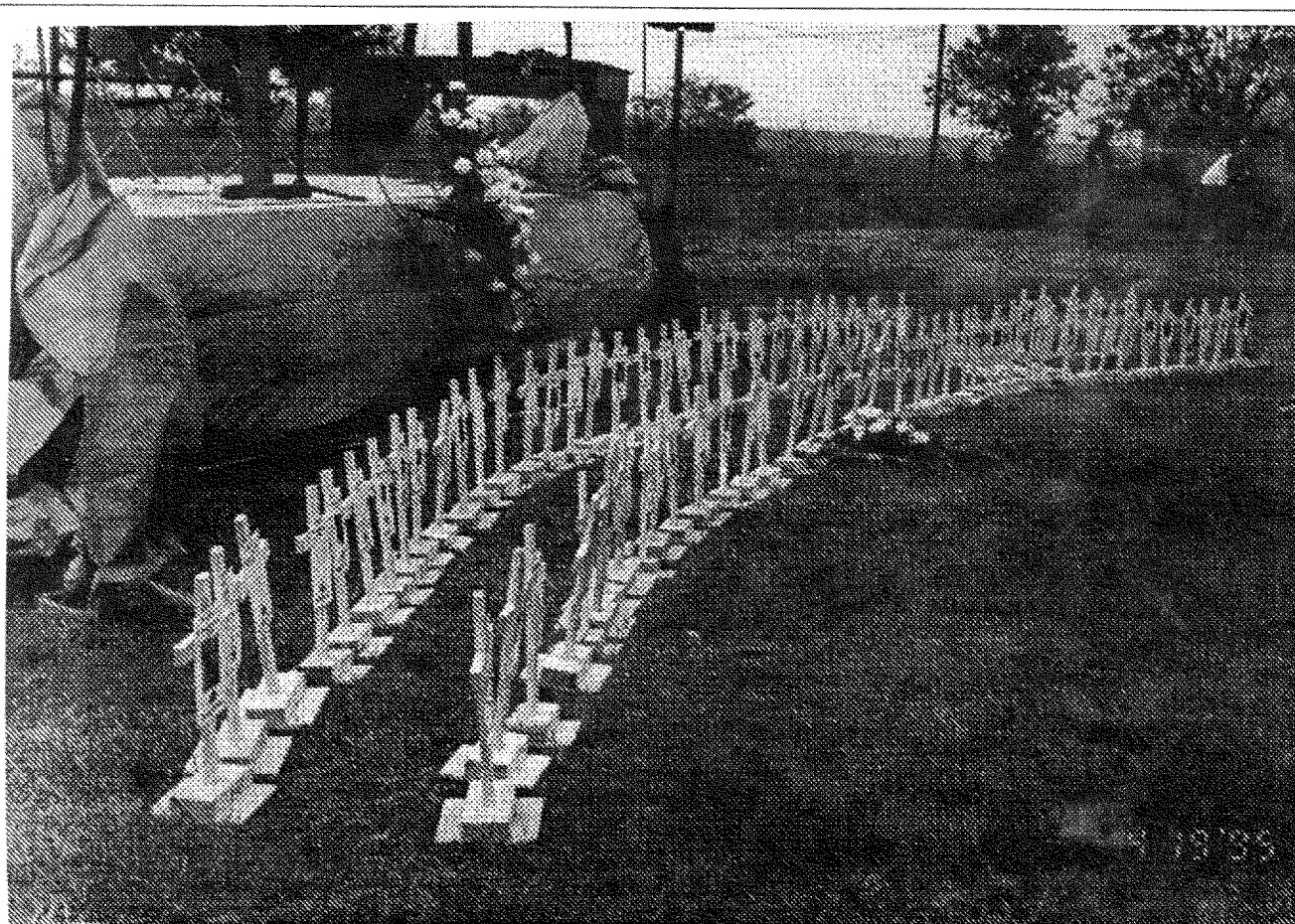

went in with their CS gas plan.

Now, I view this thing spiritually. And when I say that, I keep my talks political. I try not to get into too much scripture. Number one, it's too complicated. It takes too much time. I could never give a person an understanding of where we were coming from in an interview. I would need a week to do it, even to lay a basic foundation. That's why I personally keep it political. But, for this interview here I will let you know that we viewed everything spiritually. In other words, we believed that Koresh had inspiration directly from God and that he was revealing new things every day. And that through his inspiration because of what he was teaching, the Seven Seals, according to scripture, the power of the air or the beast power, or what we would know as the world in general would fight against him. There are scriptures indicating that the person with the last message for the final days, everybody in the world will hate him. He will be loathed. His neighbors will hate him. I mean, literally, scripture talks about how much this one person will be hated and despised by people who don't even know him, who don't even have a reason to hate him.

It says in *Psalms 2:1*, which is a very important *Psalms* for us, "Why do the heathen rage, and the people imagine a vain thing?" It says, "The kings of the Earth set themselves, and the rulers take counsel together, against the Lord, and against his anointed." In other words, if David is the anointed they aren't fighting David, they're fighting God, saying, "Let us break their bands asunder and cast their cords from us." That's the cords of the Seals, and of course the world doesn't want the Seven Seals. "He that sitteth in the heavens shall laugh: the Lord shall have them in derision." God is laughing at these people. It says, "Thou shalt break them with a rod of iron; thou shalt dash them in pieces like a potter's vessel." That is the basic gist. What I'm trying to say is that we viewed this as Mt. Carmel, literally, and that the whole world—all the nations, all the governments, were speaking about this guy. They were counseling and it was coming to pass.

We know at the community college that the ATF took over and the FBI took over during this thing, that right before the fire a number of huge, huge planes flew in to the campus. And they had markings from all kinds of different countries, I don't know exactly which countries. I know that Great Britain was one and there were a number of other countries, planes from other countries that landed at this airport. We can't figure this one out. Why would all these different nations be having planes coming into Waco, Texas for this? It seems

very suspicious. So, it was definitely a global event, literally, the people of Mt. Carmel were very eclectic. There were people from every walk of life. Just about every country was represented. I mean, we had people from Australia, people from England, people from New Zealand. It was an international community, literally, right there at Mt. Carmel.

So, again, after the fact, we were very surprised that England or some of these other countries didn't really chastise the United States for its role that it played. I mean, it's pretty obvious who brought the tanks and who rolled over whom.

Yet, every country seemed to really appease the United States when it came to this particular act that was taken against our people.

Rick: Let's talk for a moment about the Cult Awareness Network (CAN). What do you know about them and their people?

David: There was a report that was put out by Ross & Green, a lobbying firm in Washington, that was an excellent, excellent report on the Cult Awareness Network and what their involvement was. And, of course, they had a "deprogrammer", called Rick Ross. We all know that the Cult Awareness Network, for every person that they deprogram, they make thousands of dollars. They have a monetary interest in Mt. Carmel, as well as deprogramming people.

The thing that really upsets me about that is, even the term deprogramming, it indicates that someone was originally programmed and I don't consider myself to be programmed. I consider myself to be a student. And I consider myself to have learned many things throughout all of this. So, I kind of reject what they have to say about the whole thing. They have all of these little buzz-words and it seems like the government literally took their list of buzz-words to use against our group—"cult", "compound", "charismatic cult leader", just all of these words that they use over and over and over again to set in people's minds that this is a weird group, a cultic group, a cult. And that is one of the tactics of the Cult Awareness Network.

It's a shame that the FBI chose to rely so heavily on Rick Ross and the Cult Awareness Network. They did play a significant role and I don't think they've really been called on it. I mean, to make Rick Ross, of all people, a cult expert, an expert on Waco—we saw him on a couple of news broadcasts that he did and he was very hateful and he actually said—made a statement while the siege was going on, "I want David Koresh to come out. I want him to go to jail and I want him to be sexually harassed in jail." I mean, he said that. A very hateful person. My mother got a feel for how hateful Rick Ross was. She met Rick Ross and talked to him, originally trying to figure out where to go for information on what to do and found out very quickly that these were not the people to deal with, the Cult Awareness Network. They've kidnapped people. They've actually had sex with some of the people that they have kidnapped to break them down and to deprogram them from their original leader. I read a quote from one of their deprogrammers that he actually said, "If a woman refuses me to have sex with them, then I know that she is still involved with a group. I know that her mind is not deprogrammed." That's disgusting. That's illegal. I mean, these guys—it is just amazing what people get away with because they have involvements with the government. It's amazing.

I could give a number of examples. I've been reading about UNICEF and some of the sexual activities—in one case, a child pornography ring was going on with the leaders of UNICEF. I mean, this is crazy. These are the people who are supposed to be helping the children, right? As well as other groups, of course the

ADL. But I don't want to get too far off the subject.

The Cult Awareness Network is a very dangerous group. I think they are responsible for these buzz words, for programming people themselves. And I think that they use the same tactics that they claim that these "cult leaders" use and for a group that is suppose to be helping people, do you think that's right? That just doesn't seem very moral to me. I really don't know what else to say about the Cult Awareness Network.

Rick: That's sufficient. Did any of *The Seven Seals* material survive?

David: The *First Seal* manuscript that was completed on April 18 was brought out of the fire by a woman named Ruth Riddle. Now, Ruth had it on a computer disk and she had been working with David. She was a secretary working on it. When she exited the building, that was one of the things that

she grabbed, and fortunately, unfortunately for Ruth, fortunately for us, when they took her clothes off, the Texas Rangers gathered her clothes for evidence. She told her attorney about it and the attorney went down there and got that from the Texas Rangers, before the FBI could figure out what was going on. So, I have a copy. We have copies made. The two theologians, James Taber and Phil Arnold got a copy of the *First Seal*. It's been distributed pretty widely. But the thing that makes it so important is that Jeffrey Jamar and Bob Ricks, the FBI agents, went on every national show there was and when asked by Ted Koppel, "Why didn't you wait David Koresh out? He said he was working on *The Seven Seals* manuscript and that he would be coming out." And then, Jeffrey Jamar said, [paraphrasing] "We had irrefutable evidence David Koresh was not working on this manuscript; that is was a scam. He had lied to us in the past. He was a con man. And he wasn't working on this manuscript."

Yeah, he said, "...irrefutable evidence he wasn't working on it. He was a con man. It was a scam. And he wasn't even working on *The Seven Seals* manuscript."

Then, Ruth Riddle—we find that we do have it. And, you know, Ruth brings it out and it's one of the FBI's biggest lies because they knew he was working on it. They couldn't be the Federal Bureau of Investigation and have the phone taps in there and wires, and bugs in there and listen to all of the negotiations, and think that he really wasn't working on it. So, again, yet another time they lied to the American public. And like I said, we have this manuscript. My personal opinion, and I was trying to make this point earlier but I got sidetracked, was that I look at everything spiritually. And I look at David Koresh as having the inspiration to the world that will be fought against by the beast power. And it will be quelled because scripture says it will be. Scripture does not say that we [*the Davidians*] would be victorious. So you know, people say, "He's dead now. Do you still believe in him?" Well, anyway, I'm not going to get into that.

But this is also a fulfillment of scripture. That's how I can accept everything that's happened. But the point I wanted to make, especially in Ruth's case, it seems in this case that evil won out. When Ruth brought that manuscript out, they went after her for bringing that manuscript out. Ruth Riddle was a Canadian and she was acquitted on all charges, and she was supposed to get on her plane to go back to Canada. Thirty minutes before she was to get on her plane, they came and nabbed her after the trial in San Antonio. Apparently the judge made the deal with the prosecution and they reinstated a third count that was thrown out. The jury threw it out because it directly tied in the conspiracy-to-commit-murder charge against federal agents. The jury had proven there was no conspiracy to commit murder against federal agents, and threw that count out, the conspiracy charge. Everyone was acquitted on that. But, this third count of this weapons violation was to be thrown out with that first count; however, when they found out the light sentences everybody was going to get on an aiding and abetting voluntary manslaughter charge, they waited until the jury went home, worked with the judge, added this charge, and nabbed Ruth. I think they specifically went out after Ruth because she brought *The Seven Seals* manuscript out and, well, let's just say it's a spiritual thing, if you know what I mean. It's a spiritual thing.

Rick: Obviously there was a huge emphasis on sex and drugs and children and the whole bit. So what you are saying is that it was a community. Could you make a statement about the children, what the feeling was.

David: Sure. Number one, the children were never abused. The children were disciplined. They were disciplined by the individual parents. In 1992, because of all of the allegations of child abuse—and let me just preface this. The reason they were so successful in demonizing David Koresh is because he did have many wives. That's the truth. I'm not going to deny anything. I want all the truth to come out because I believe that if the

truth comes out, you know, we don't need to embellish with the information we have about what the government's role in this is. We don't need to embellish to win. I mean, we've already lost but what I mean is, to be vindicated somewhat. I don't need to embellish anything. So when these Linda Thompsons come out of the woodwork and start putting out faulty material on their videos, and flame-throwing tanks where they don't exist.

Rick: That is another question I had for you concerning the fire.

David: We were talking about the children first.

Rick: Yes, let's talk about the children.

David: In 1992, due to all of the allegations of this child abuse made by a man named Mark Brow, amongst a few others in Australia—he was one of David Koresh's best students who left and basically formed his own group and then smashed Koresh any way he could. What ended up happening is, because of all of the waters he was stirring up over in Australia, the Health and Welfare people came out to check our children. They came out with the sheriff's department.

Rick: Let me just stop you right there for one second. Didn't the original Cult Awareness Network

involvement stem from Australia?

David: That's possible, I'm not sure of that though. I think it stemmed from a former member that they, "deprogrammed" here in Los Angeles. But I don't know about the Australia connection there. In 1992, the state authorities, the people who should be investigating child abuse, not Janet Reno, not the federal government, who has no jurisdiction on child abuse. They will report it in the news if it makes their case, even though it's not true. But in 1992, the Health and Welfare people came out and they checked the young kids, all the kids, for signs of mental, physical, and sexual abuse. And they dropped their case when they found no signs, especially the twelve- and thirteen-year-old girls. And believe me, they checked everyone pretty thoroughly. They found no signs of any abuse and they dropped their case. Next day in the paper, the Health and Welfare people said, "These kids were the nicest kids we've ever worked with. They were very well behaved, very intelligent, very well cared for." The sheriff's department who came out with them for protection, said in the paper, "The only problem with the people out at Mt. Carmel is not that they're weird or crazy, it's that they're misunderstood." This came out in the *Waco Tribune Herald*. Those are just very telling statements for state authorities to be making about our group and then to have the government use everything that they could to demonize us, especially child abuse, it is just a farce. It's absolutely unfounded. It's untrue. And they used it to their advantage.

I'm going to quote something here that is one of my favorite quotes in the world. It is by Senator Henry Clay, 1893, and he said that, "The devices of power and its minions are the same in all countries and in all ages. It marks its victim and denounces it, exciting the public hatred to conceal its own abuses and encroachments." And that is what has occurred here, ever since February 28, 1993. So, no, there was no child abuse. Koresh did have multiple wives and that got him in a lot of hot water. But there were scriptural origins for everything that he did. And that is all I can say. I can't prove my point to people. I can show them the scripture and they can see it a little clearer, but we have a totally different way in this society of thinking than we did even a

hundred years ago, let alone when the scriptures were written. Totally different view. But that is the beauty of what this final message to the world is. This final message is to confound the world. It says, "I will confound the wise, God says. The wisdom of man is not to be compared to the foolishness of God. And through my foolishness I will confound the wise, debasing the proud and the arrogant." That's the one thing God always warns about. Every prophet says to be of a contrite and humble spirit and God can work with you; you can be helped; you can be saved. Pride and arrogance are things that God always warns against, to be careful of, to be avoided, not to get into. If you meet any of these ATF or FBI agents, they are the proudest, most arrogant people I've ever met in my life, let me tell you. So, I think it is safe to say what side is where. But no, there was no child abuse, bottom-line.

Rick: After the Waco incident, what were you charged with?

David: I was not charged. I was held as a material witness for less than a week and released into the custody of my parents. I thought I was going to be used as a witness in the trials but the prosecution didn't want me and the defense rested incredibly early, within two or three days, which I felt was a very, very bad move. It's just that I was not impressed with the defense attorneys, to be brutally honest with you.

Rick: What were the other people charged with?

David: They were supposed to be charged with aiding and abetting voluntary manslaughter, which the judge called voluntary manslaughter. It was just ridiculousness. One of the things I hope to fax to you is a letter from the head jury forewoman, Sarah Baine, indicating that the sentences were supposed to be lenient, that the judge was going against what the jury had intended. I don't have a copy with me, I'll get it to you later. The initial charge was conspiracy to commit murder against federal agents, and that was thrown out. Now, when that was thrown out, another charge, a third, count three, which was a weapons violation, was supposed to be thrown out with that but what happened is the jury goes home, the judge makes a deal with the prosecution and they add in this weapons violation charge, and then he sets up a scale sentencing system

and sentences five of them to 40 years for a weapons violation, and the others got between 5 and 15 years for this violation that the jury had no knowledge of—they thought had been thrown out. Sarah Baine, after she had seen evidence that was suppressed from the jury, after the trials, said in a letter—she was doing a lot of shows and stuff because of her displeasure at the sentencing for these people—she saw evidence that was suppressed—the 911 tapes, certain other evidences, and made the blanket statement, she said, "Had the jury seen all of the evidence at the trials" that she, Sarah Baines as forewoman had seen, "everybody would have been acquitted on all charges." So, it just goes to show you where our judicial system is. The judge was out to get them. He wasn't going to listen to reason at all.

Rick: Of the survivors, are you the only one who is not charged?

David: No, there were a couple others. The person that I was in the underground bunker with the day of February 28, the underground bus, I should say, February 28 when the AFT attacked, was released as well. Our stories corroborated one another. We were basically unarmed. What it comes down to is, anybody who had a firearm on them on the day of February 28, they went to jail. That's the bottom line.

Rick: Were the federal agents shot by "friendly fire", or did those inside shoot?

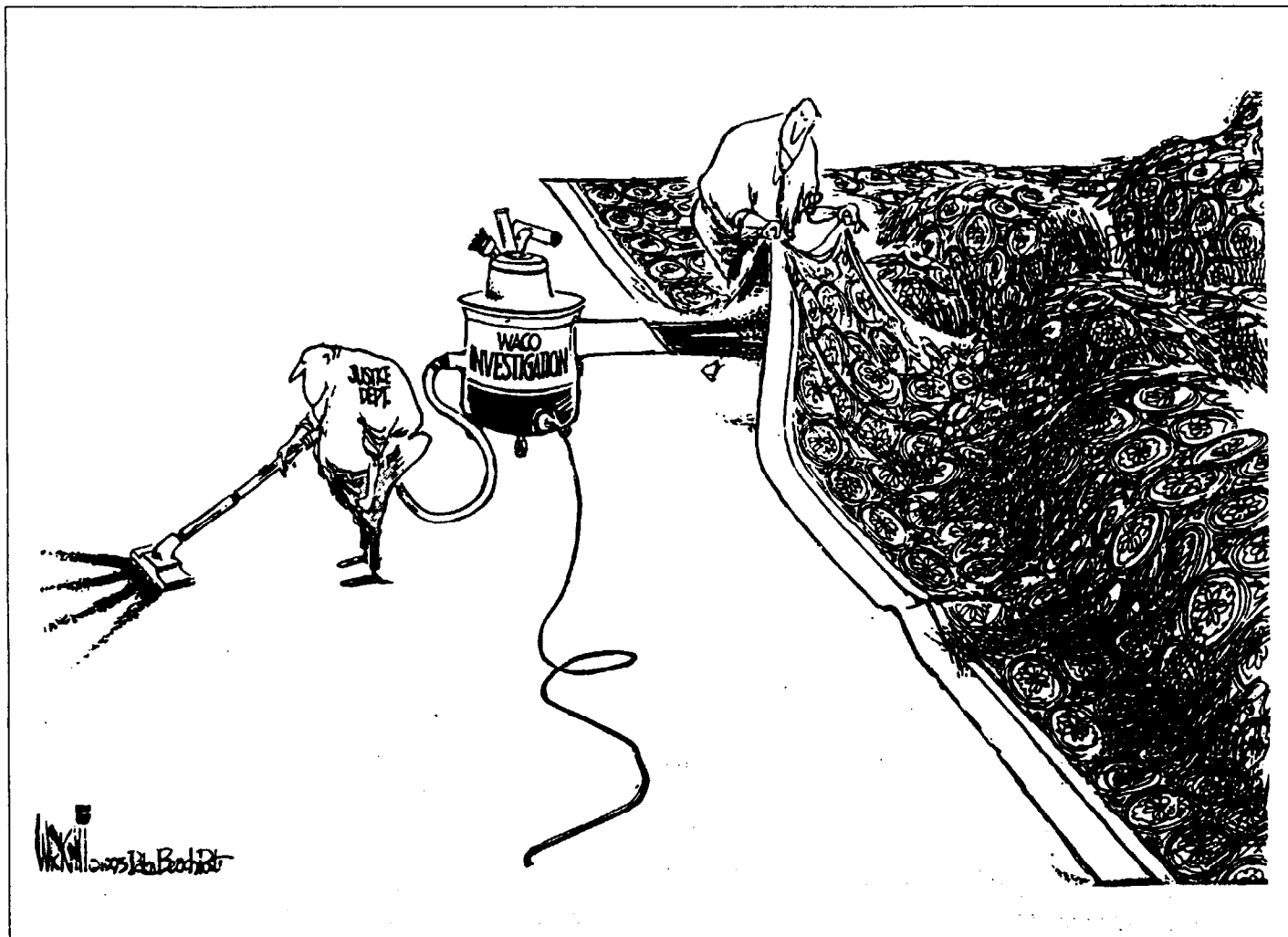
David: Oh yeah, people absolutely defended themselves. I mean, after they saw Terry Jones go down at the front door, a 70-year-old unarmed man—some of the younger men who were armed at the time did fire back in defense. It turns out, to me, the government's stance of an ambush has been totally discredited. The agents who died, died twenty and thirty minutes into the battle. So, it appears that they died at different areas of the building and though there were some reports of wounding with friendly fire, it has never been established that anybody was actually killed by friendly fire.

Rick: Let's talk about the fire because that has been a big issue, particularly with Linda Thompson. How were the fires set?

David: Well, I don't know. I don't really think "set" is the word.

Rick: I should say, what happened?

David: Here's my view. We think, I think from the people that I've talked to who were in there, when the tanks went in—and we have pictures that would blow you guys away, if you saw them—but the color still photos we have, taken from the surveillance plane above Mt. Carmel, show the destruction of the building in the back so completely. The back of the building was leveled to the ground. Literally, it looked like an earthquake or something. When these tanks went in there, they shook the building. In some areas of the building they shook it off its foundation. Now, in every single room we had kerosene lanterns because that is how we were reading at night and that was our heat. So, there was kerosene all over the building, yes. But it is not from the Davidians spreading the kerosene or the fuel throughout the building, it's from the tanks going into the rooms and, literally shaking the building and knocking these kerosene lanterns all over the place. It was a fire hazard waiting to happen. Here's why I say that. If you see an aerial view of Mt. Carmel you'll notice that around the building everything has been cleared away. The crime scene was destroyed. The trees were moved out of the way. The fence was destroyed. The bicycles were run over. The go-carts were run over. The motorcycles were run over. Paul Fatta's custom El Camino was totally run over and destroyed; you can't get another one of those.



It was custom, totally destroyed. You see, it appears there's a firebreak from where the tanks were going around and around the building, clearing the building, making a firebreak around the building so a fire would not spread, had one occurred.

I guess evidence number two would be the tanks going into the building and knocking the fuel all over the place.

Evidence number three—this is David Thibodeau evidence, this is not the government evidence—would be the tanks going into the building at strategic locations, in different segments of the building, poking huge holes in the building (10 x 10-foot holes, big as a tank), everywhere a tank went in you've got a huge hole there. Now, when you do that in five or six strategically placed locations around the building, what

do you get? You get an oxygen flow system, ok? If a fire were to occur, the place would go up like that. Just like a tinder box. I believe that was planned. The CS gas that they used and the amount of CS gas they used. CS gas itself is mildly flammable, but the propellant that they used to put the CS gas into the building, and we're talking about 1000 liquid units, 430 ferret rounds, was methylene chloride, which IS a flammable propellant. So, not a lot of wisdom was used there, if you ask me. Unless, of course, they wanted the fire. And the one thing that I say in my talks is, I say, "Who benefited most from this fire?" The government. Why? Because all of the evidence of the helicopters the first day, shooting at the building, is destroyed. All of the evidence of the amount of firepower that the ATF used against us, is destroyed. Everything is destroyed.

But you know where the smoking gun comes from? Ted Koppel made a good point. If you weren't expecting a fire, FBI, Jeffrey Jamar, how come you had an infrared video camera in a plane flying above the

building? That's a good question. Even more importantly, and this has never been discussed in the nationwide media, [it was in CONTACT at the time] why was Parkland Memorial Hospital called at 6:00 a.m. that morning by the FBI, the morning of April 19, before they started the CS gas attack plan, why were they called at 6:00 a.m. and asked how many beds are available in their burn unit? They were asked that question. Parkland Memorial Hospital—the reason this came out is because Parkland Memorial Hospital was going to sue the FBI for the burn victims that Parkland Hospital treated on behalf of the Davidians. The FBI wasn't going to pay. Dr. Cox, the administrator there, reported, "If you guys didn't know there was going to be a fire, why did you ask how

many beds were available in the burn unit six hours before the fire occurred?" Needless to say, to avoid going to court, the FBI paid the bill. Pretty interesting stuff when you look into it.

Another thing that is kind of interesting is, about a week before CS gas plan, one of the morgues that was in the city—and I get this from two different sources, one is Rita Riddle, when she went to the morgue to see the remains of her brother, Jimmy Riddle—one of the morgues was told by the FBI to have 80 body bags ordered and ready. Another little interesting event—either this was going to be avoided if they didn't anticipate this at all was, the woman that I mentioned earlier for the Health and Welfare Service worker, and I know her name but it escapes me for some reason, I'll come back to that. It's on the tip of my tongue. Anyway, the woman who was in charge of that was working with the FBI and FBI was telling her about the CS gas plan—about a week before they went through with it. And they said, "If we do this, we want you to have a crew on hand so when the kids come out, you can shower them down, have clothes ready. We're thinking of doing this." And she told the FBI that she didn't think it was a good idea, that they should not go through with the CS gas plan. It was just not a good idea. It was too dangerous, too harmful. So they didn't call her anymore and she thought, "Ok, they're not going to do it."

Now, she sees on the TV that morning that they had gone in and started the CS gas plan. She calls the FBI and says, "What's going on? I thought you guys weren't going to go through with this. How come you didn't call me, so I could get my people together down there?"

And, according to an interview that she had done, the FBI agent she spoke to said, "Don't worry, nobody's coming out."

And I'm going to think of her name. I can't think

of it right now. Her husband's name is Frank Lahee. I have it written somewhere. Pretty incredible stuff. I mean, when you put all of these things together and then you see that the fire trucks were on call and waiting for the 51 days, and a week before, or a few days before this gas plan they were told to stand down and go

back to their bases. And when they were called, they were held at the first check point for twenty minutes until the place was completely burned to the ground. We have pictures to prove this. They didn't allow any fire trucks on the property. It's pretty apparent they wanted the place to burn to the ground. I mean, they're not fooling anybody.

A lot of people have awakened. I think a lot of people are waking up more and more. I think if something like this occurs again, the government is going to have a real problem on their hands because I know, around this nation right now, there's thousands and thousands and thousands of people that are not going to let another group of people be slaughtered at the hands of a tyrannical government. And I don't ever want to see that day happen. A lot of people are concerned about these militias but it's not the militias to be concerned about. The analogy I like to use is: We have a railroad track and we have two huge steam engines, one with the militia movement, and it's going down the track at about 10 miles-an-hour. At the other end of the track is the federal government, and they are headed down the track at about 110 miles-an-hour. And I don't think either one of them is going to get off of that track.

So, I think it's time for the government to open up their hearts, if they have any; open up the books and be totally honest with the people. And not have Congressional hearings that are going to be stonewalled and that are going to use all of these devious tactics and measures they do to hide the information and to convert the truth; not convert, but distort the truth. They should open up the truth to the people and just let it be

MOUNT CARMEL CENTER

On February 28, 1993 a church and its members known as Branch Davidians came under attack by ATF and FBI agents. For 51 days the Davidians and their leader, David Koresh, stood proudly.

On April 19, 1993 the Davidians and their church were burned to the ground. 82 people perished during the seige. 18 were children 10 years old or younger.

known. Maybe they won't be able to be the people that are in our government now. Maybe some people will lose some jobs. But it's better than having an all-out civil war, is it not?

I don't think the government is going to do that. I think they're going to continue to cover things up that they have, with all of the information they have with everything from Vietnam to UFOs that have been covered up. I mean, they're experts at it. They don't like to let us know anything. They think we can't handle it, as a people. That's a shame. But they're digging their own grave. Did CAN and the ADL Sucker the Feds into April 19 Massacre? [H: Come now, if you are ALL a part of the same thing I doubt much suckering of the "bigger" beast is possible, but let us enjoy the scenario as it is related to other prior stupid actions.]

By Harley Schlanger. HOUSTON, April 23 (EIRNS)—On April 17, 1961, a mercenary army of Cuban ex-patriots launched an invasion of Cuba, under the direction of the CIA. Despite months of planning, based on intelligence assessments prepared by CIA and military advisers while Eisenhower was President, the poorly disguised "covert" operation was a complete catastrophe, with 114 invaders killed and over 1,200 taken prisoner by Fidel Castro.

While President John F. Kennedy took responsibility for the defeat, he quickly moved to discover why the CIA-directed operation had failed so miserably. Within months, there was a shakeup at CIA, as both CIA Director Allen Dulles and Richard Bissell, his deputy for planning and the man most responsible for the abortive invasion, were ousted, and Kennedy moved to rein in the intelligence community.

In the wake of this week's deadly blundering by FBI officials in Waco, Tex., which resulted in 86 deaths, including those of 24 children, President Clinton is facing the same problem as JFK did 28 years ago: that of a federal agency which is out of control. The success or failure of the Clinton Administration may well hinge on how decisively he addresses this problem. Who are the "experts"? [H: It saddens me to see that the ones who are most observant and enlightened as to The

Truth of how things are rigged, set-up and orchestrated, and from where (like the Administration's puppet masters) the manipulators come, still write and speculate in such foolish apparent blindness. This type of speculation is exactly what is wrong with the world. The only thing that Clinton's reign hinges on is his ability to follow orders!]

In her press conference immediately following the final FBI assault on the Branch Davidian compound on April 19, U.S. Attorney General Janet Reno stepped forward to take the blame. "I made the decisions; I'm accountable," she said. In making that decision to "compress the perimeter" around the compound by using armored vehicles to bash in the walls, then pour in a "non-lethal" but extremely harsh form of tear gas, she said she relied on advice from "experts".

The gruesome results from the April 19 raid demonstrate that the "experts" consulted in planning the final attack were no more competent than those who planned the initial assault.

The siege in Waco began on Feb. 28, when agents of the Bureau of Alcohol, Tobacco and Firearms (ATF) raided the Branch Davidian compound to execute a search warrant seeking evidence of alleged violations of federal weapons laws. As documented in the March 26 issue of *Executive Intelligence Review* magazine, the ATF actions were triggered by a concerted campaign conducted by the Cult Awareness Network (CAN) in both the U.S. and Australia.

CAN is an organization of kidnappers and "deprogrammers" (that is, brainwashers) which gains influence by (and makes its money from) convincing law enforcement officials and the general public that the United States is awash in dangerous mind-controlling cults. Together with the American Family Foundation and the Anti-Defamation League of the B'nai B'rith (ADL), CAN has corrupted official government law enforcement agencies, as the Waco case and an investigation by the San Francisco police of an ADL national spy ring demonstrate.

In fact, the ADL has been involved directly in the events in Waco, according to Herb Brin, publisher of the *Heritage* newspapers in California and a fanatic promoter of ADL illegal covert operations. In a piece defending the ADL's national spy operations, Brin writes, "U.S. and Texas authorities have precise documentation (from the ADL, of course) on the Branch Davidian cult in Waco, and how it operated in the past."

Investigations of CAN reveal that CAN "experts" use precisely the methods of deprogramming of which they accuse the "cults" they attack, such as isolation, sensory deprivation, threats, and the like.

Further, CAN uses the "confessions" extracted from former members of targeted organizations, to demand that action be taken against those organizations.

CAN and Waco

It was this modus operandi which was used by CAN to deploy the ATF against David Koresh and the Branch Davidians in Waco on Feb. 28.

CAN and its Australian affiliate planted, with ATF officials, a series of stories from deprogrammed former members warning that Koresh "was heading in one of

the following directions: a final Jonestown massacre; an armed confrontation with authorities; or some bizarre behavior, such as an attempted assassination of a public figure."

With this profile, ATF bypassed local Waco authorities, who knew and had had dealings with Koresh, and instead launched what one of these officials described as a "Gestapo-style assault" on the compound. Under criticism from local officials and military consultants for their tactics, which resulted in the killing of four ATF officers and an unknown number of Branch Davidians, ATF officials justified their actions by referring back to the profile provided by CAN, as if that constituted any kind of evidence at all.

ENTER THE FBI

Although it is premature to make conclusive judgments as to what really occurred on April 19—and indeed it may be impossible, since fire destroyed much of the evidence—it is clear that the FBI, which took over the operation from ATF, and the FBI's "experts", are ultimately responsible for the tragic results of that day.

Primary blame must be placed on the "experts" to whom Attorney General Reno has referred repeatedly. These are centered in two related agencies of the FBI based in Quantico, Va., the Behavioral Sciences Unit and the Hostage Response Team. Both provided the psychological profiles employed by FBI negotiators during the 51-day siege. And both are deeply penetrated by the ADL.

In fact, the Hostage Response Team's "Delta Team" was among the forces deployed against Lyndon LaRouche and his colleagues on Oct. 6-7, 1986, during the 400-man raid against LaRouche and the offices of his associates in Leesburg, Va. Both CAN and the ADL were central to illegal Justice Department and FBI operations against LaRouche.

The tactics used by the FBI during the Waco stand-off, including psychological warfare techniques such as the broadcast of ear-splitting noises, and the use of bright lights at night, have been denounced by many law enforcement officials as the opposite of what is necessary to promote a peaceful resolution to a stand-off. [H: So, you have to now assume correctly that it is intentional NOT to peacefully resolve any such staged standoff.]

As to why the FBI decided to move on April 19, there are many conflicting stories. [H: It was none other than because it was necessary in order to have the total conflagration which occurred—quit trying to put "reason" to this thing—it was deliberate and orchestrated to perfection for the EXACT results which were accomplished.]

Was there evidence of child abuse? While Attorney General Reno said the "experts" told her there was, the FBI now denies it. FBI Director William Sessions said there is "no contemporaneous information" confirming child abuse. In fact, the only evidence ever presented on child abuse was from CAN-controlled former members who had much to gain by giving such an outrageous story.

Was it clear that there could be no peaceful settlement? Reno said she was told, by the "experts", that nothing would change no matter how long they waited; that Koresh et al. were not coming out. Yet Koresh's lawyer, Dick DeGuerin of Houston, the only man from outside the compound (other than FBI agents) who spoke with Koresh over the last two weeks, said his client wanted to come out and have his day in court.

Did Koresh order mass suicide through immolation? Although this fits neatly with the CAN-developed profile, there is only the word of the FBI to prove it. DeGuerin, who has interviewed five of the nine survivors, says there was no suicide pact, and that the Branch Davidians did not start the fire. The *Washington Times* quotes numerous experts who say the CS tear gas used by the FBI—a gas banned for military use

under the Geneva Protocols—could have incapacitated and disoriented many inside the house, making it impossible for them to escape the flames and smoke.

Defense attorney Jeff Kearney of Fort Worth, who represents one of the survivors, said the fire will help the government. "Government agents can say what they want now and there's little physical evidence to dispute it," he told reporters.

CLEAN HOUSE AT JUSTICE DEPARTMENT

President Clinton, Attorney General Reno, and members of both Houses of Congress have called for investigations into the Waco atrocity. These investigations must start with the so-called experts—CAN, the ADL, the FBI psychological units at Quantico—and must include scrutiny of any federal officials who have given them credibility, or who have attempted to cover up for them.

That many of Reno's comments justifying her decision have been contradicted almost immediately raises the possibility that she may have been "set-up" as the fall guy. One official who should be questioned with this in mind is Justice Department official Mark Richard, who was one of the small group which met with Reno when she made her final decision to proceed with the April 19 actions. Richard, the founder of the Office of Special Investigations, has a long history as a top agent within the U.S. Government of the ADL and the Israeli Mossad.

CAN has already begun a cover-up of its role. Although it was CAN which initiated the action, through its corruption of the ATF, this week CAN officials have been out in force, arguing that the FBI was unable to cope with Koresh because the Bureau had dumped CAN input. CAN Director Cynthia Kissner has called for a much larger role for CAN in dealing with cults in the future.

It is likely that such terrible incidents will recur, unless the corruption of our federal law enforcement agencies is ended. President Clinton must act as JFK did after the Bay of Pigs—take the blame, and then clean house. [H: Oh—I thought he simply got murdered!]]

In short, it was the ADL that essentially tricked the federal authorities into conducting the operation that resulted in the tragedy.

What's more, the *SPOTLIGHT* learned the so-called Cult Awareness network (CAN) which also prodded the assault on the Branch Davidians is closely connected to the ADL [H: Like twigs on adjacent branches of a thicket tree. They are actually exactly the same thing wearing a different type of make-up to suit the clown-suit of the day.]

Some sources, in fact, believe that CAN is, in fact, an ADL-funded front operation. [H: Well, they worded it better.] There is no question, however, that CAN does operate as such.

In any case, the American public owes a great debt to Herb Brin, publisher of *Heritage* newspaper and an admitted sometime ADL informant himself. Thanks to Brin the truth about the ADL's intervention in the Branch Davidian affair is now part of the public record.

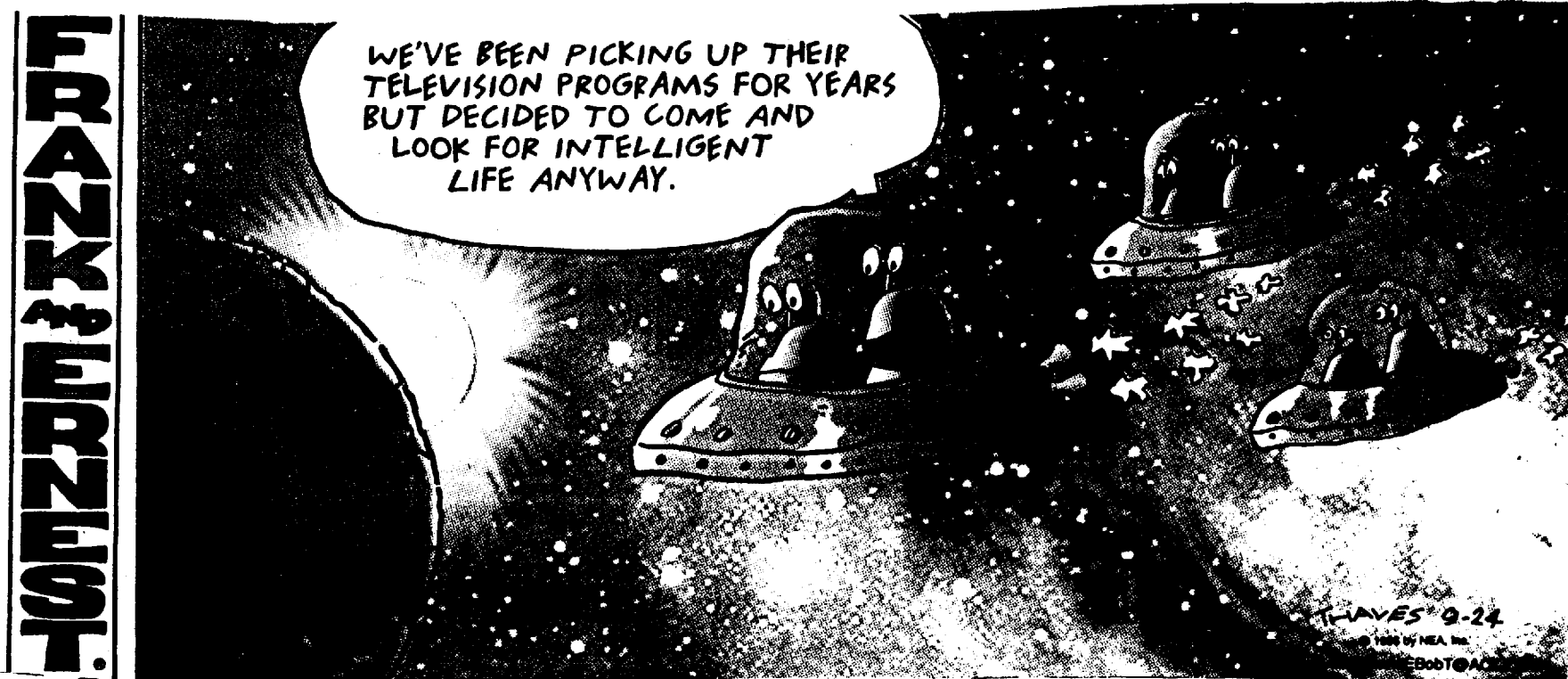

The fall of the Branch Davidians has brought the inevitable clucking about "cults" and "fundamentalists". President Clinton, in the course of defending the final FBI assault on the Waco compound, spoke of the "rise in this sort of fanaticism all across the world", warning that "WE MAY HAVE TO CONFRONT IT AGAIN."

He added piously: "I hope very much that others who will be tempted to join cults and become involved with people like David Koresh will be deterred by the horrible scenes they have seen over the last seven weeks." So the federal government is now in the business of deciding which religions are good for us. Mr. Clinton seems ready to attach warning labels.

But his alarm is hypocritical. There is, in fact, no segment of the American population that is more gentle and law-abiding than fundamentalist Christians.

Fundamentalists have very low rates of violent crime, drug and alcohol abuse, illegitimacy, and other disorders. Few of them even smoke, which ought to win them at least a little respect from liberals. Most of them work and pay taxes and don't take welfare. They don't riot when they don't get their way. They aren't into street crime. Or organized crime. Their names don't come up in Wall Street scandals. They don't mug or kill foreign tourists. They haven't introduced

new diseases into the national bloodstream. They don't amuse themselves with drive-by shootings. Nobody avoids a neighborhood because fundamentalists dominate it.

On the contrary, fundamentalists are rather easy to push around. They are given to charitable works, though they don't believe in advertising their kindness. They suffer a lot of abuse without complaining. If they are getting active in politics now, it's because they have learned the hard way that the government won't leave them alone and respect their way of life.

Which brings us back to Waco. The Branch Davidians weren't bothering anyone. Why was it necessary to disturb them in the first place? Why was the final attack called for?

A *New York Times* headline says it all; "Officials Contradict One Another on Rationale for Assault on Cult." Attorney General Janet Reno offered "child

abuse" as the reason for the attack that resulted in a score of children's deaths. FBI Director William Sessions denies that child abuse had anything to do with it. [H: Could that be why Sessions is now OUT!?!]

It looks very much as if the government decided in February that the Davidians would be easy pickings for a dramatic operation, with the media in attendance. If Rodney King's civil rights were violated in Los Angeles, what happened in Waco, Texas?

If a billy-club is excessive force, what is a tank [with a lighted flame-thrower attached]?

If four Los Angeles police officers—their adrenalin flowing from exertions to subdue a resisting, large, strong man—used bad judgment in applying force, what kind of judgment was exercised by President Clinton, Attorney General Janet Reno and the FBI in the relative calm of their Washington office?

The Branch Davidians are not a preferred minority, but their civil rights were nevertheless violated.

The federal officials responsible must be held accountable for the deaths of about 24 children and 62 adults. The congressional hearing into the extraordinary miscalculation that produced the horror must not become a cover-up dominated by liberal hostility toward religion and gun ownership.

The excuse given by Attorney General Reno is that the FBI's hostage team was fatigued and could not indefinitely continue in place. Out-waited and impatient, something had to be done.

So the FBI played directly into David Koresh's hands and fulfilled his prophecy.

Throughout the long siege the media have regaled us daily with reports that Koresh believed that he was destined for persecution and that he and his followers would die in a violent confrontation with the secular state.

The FBI cannot claim to have been unaware of his views. In a briefing last month, a senior FBI official said: "From the mid-80s on, he's preached that his group will end up in a violent confrontation with law enforcement and that this will be a fulfillment of his prophecy."

Fully armed with all the facts, the federal government set out to bring the tragedy to pass. Numerous opportunities were ignored to serve Koresh with the warrant on his trips to town or to detain and question him about the government's suspicions that he possessed illegal firearms. Instead, 100 armed agents of the Alcohol, Tobacco and Firearms division of the Treasury Department unexpectedly assaulted the compound.

The agents dressed themselves in black assault uniforms and brought the TV cameras along to record their exploits, but their assault was repelled by the Branch Davidians, with loss of lives and injuries on both sides. The FBI showed up with tanks and armored vehicles.

The FBI let the tensions build up for 50 days and then broke into the building with tanks and attacked with gas. After experiencing the ATF attack and being prepped by Koresh, people inside the compound might expect to be gunned down if they rushed outside.

Clearly, any psychiatrist who dealt with a paranoid patient in this way would be guilty of malpractice. How could a highly trained FBI team, an Attorney General and a President make such a mistake?

The black inmates who have taken over the Lucasville, Ohio, prison and murdered both inmates

and guards are being shown a great deal more understanding.

True to form, many liberals have rushed forward to blame the Waco disaster on the Second Amendment, which permits Americans to own guns.

To the contrary, it happened precisely because of federal laws regulating gun ownership. The Branch Davidians hadn't assaulted anyone. They lived peacefully within the community. Except for the federal gun laws, they would all still be alive.

It wasn't the state of Texas that provoked the confrontation. It is the gun control propaganda that has let the ATF off the reservation and encouraged the T-men to throw their weight around. From the standpoint of the Sarah Bradys of this world, to own an unregistered gun is a matter of serious import; it ought to be illegal.

The liberals' premise that gun ownership should be illegal, or in the least heavily regulated, has created the atmosphere in which the ATF, like an unthinking bully, feels compelled to increasingly and brazenly show its presence. That is what produced the deaths of 86 children, women and men.

An embarrassed Attorney General lamely blames

her "fatigued agents" and "reports" that babies were being beaten and children molested. After the event, she pleads the Clintons' concern with children to justify setting in motion a plan that gets all the children killed. Some solution. And now it is proven that there was NEVER any child abuse under any circumstances.

But it shows once again the utter incompetence of the federal government. Why anyone would want it more involved in our lives is inexplicable.

WAR ON GANGS

This article by Patrick McGreevy appeared in the September 22 issue of the *DAILY NEWS* (Los Angeles), [quoting:]

Declaring war on gang violence on all fronts, Los Angeles Mayor Richard Riordan said Thursday he will appoint a gang czar [that's right, a GANG CZAR!] to take back the streets. Riordan—who assembled law enforcement and political leaders at City Hall to cooperate in the battle [Did you ever notice how frequently the words "battle" and "war" are used in reference to disease, poverty, drugs, and crime? This diverts our attention from the fact that all of these problems were strategically CREATED by the same vermin who then have the chutzpach to climb on white horses and sally forth to save us with our own funds funnelled into a guaranteed-to-fail plan.]—said disjointed government efforts are partly to blame for the failure to halt gang

violence. [Wrong. Gang activity is Elite-sponsored and controlled, and is already being used to terrorize us into submission.] To correct that situation, Riordan said the new gang czar will oversee a task force of law enforcement and government officials to coordinate efforts and develop and implement a combat plan. The gang czar won't have any law enforcement powers, Riordan said, but will instead focus on coordinating law enforcement and social services groups that deal with gangs. Riordan disclosed his plans after the first meeting of a 22-member Street Violence Working Group, which will meet regularly to discuss solutions to gang violence.

DOCTORS ON STRIKE

Los Angeles is facing a "health care crisis" as public health clinics come under the budget-cutting knife. (Just in time for a major earthquake or pestilence?) As an interesting aside, in Vol. 2 No. 3 of *GOD'S PLAN FOR GOOD HEALTH* (1496 Pritchard Rd., Evans, WA 99126), the next article tells what has happened in the cities where doctors have gone on strike and refused to treat anyone except trauma victims: the death rate dropped dramatically, [quoting:]

In 1976, the mortality rate in Bogota, Columbia dropped 37% during a 52-day strike by doctors. In Los Angeles, California, the death rate dropped 18% during a doctors' strike in 1976. The most amazing of all, was a 1973 strike in Israel where the mortality rate dropped 50% during a 2 month strike. Morticians complained that "business hadn't been this slow since the last doctors' strike 20 years ago."

We need to be aware that 1 out of every 20 people who go into the hospital pick up a NEW symptom or disease totally different or unrelated to the original reason they were admitted.

"THE SHOOTING BELL"

"What did you learn in school today?" "To duck for cover!" From the September 19 issue of *THE ORLANDO SENTINEL*, [quoting:]

LOS ANGELES—Like air raid sirens of the Cold War, a special bell now alerts children at an elementary school that violence is just outside the building and sends them ducking for cover. Students at Langdon Avenue School are trained to return to class when they hear what some parents call "the shooting bell". It signals gunshots have been fired in the North Hills neighborhood 20 miles from downtown.

KIDDIE CONCENTRATION CAMPS?

More Big Boy non-solutions, this AP article comes from the September 21 issue of the *ROSWELL DAILY RECORD*, [quoting:]

SANTA FE—The [Governor Gary] Johnson Administration faced questions Wednesday about its juvenile justice proposals, with a Democratic lawmaker sug-

gesting the governor is focusing too much on building correctional facilities such as a boot camp. Sen. Carlos Cisneros, D-Questa, described a military-style boot camp for juvenile offenders as a "concentration camp". "It may seem a very politically popular solution, but so is building penitentiaries. But is it a solution? I don't think so," Cisneros said in an interview after the meeting. The Children, Youth and Families Department proposes a 50-bed boot camp as part of a \$23 million, two-year juvenile justice reform package. A military-style boot camp, according to the administration's proposal, would offer a disciplined environment for juvenile offenders including physical training, counseling, work and education programs. It's projected to cost about \$1.35 million. [On paper, the boot camp proposal may sound at least somewhat effective in curbing juvenile crime, but once your eyes have been opened to the agenda of the Power Elite, you begin to read between the lines and take nothing at face value.]

DAY CARE CHILD-ABUSE CASES

From the September 11-17 issue of *THE WASHINGTON TIMES*, NATIONAL WEEKLY EDITION, [quoting:]

A legal nightmare is finally over. After spending eight years in jail, Violet Amirault, falsely convicted of molesting children at the Fells Acre Day School in Malden, Mass., has finally been released from prison. Her daughter Cheryl Lefave, 37, is also being released. Mrs. Amirault's son Gerald, father of three and in jail for almost 10 years, is still awaiting his appeal before the judge who presided over his conviction. The case is one of the last in a slew of spectacular 1980s trials of day care professionals convicted of sexual abuse against their young charges to be overturned—including the McMartin trial in Manhattan Beach, Calif., Little Rascals Day Care in Edenton, N.C., and Wee Care in New Jersey. It seems that this dangerous fad could be coming to an end. [Just what the child-abuse perpetrators would like you to think: that it was all a big mistake, a FAD, but now over, while they continue to operate with impunity. Interestingly, the same abusers are not above using false charges of sexual abuse and misconduct to eliminate people who get in their way.]

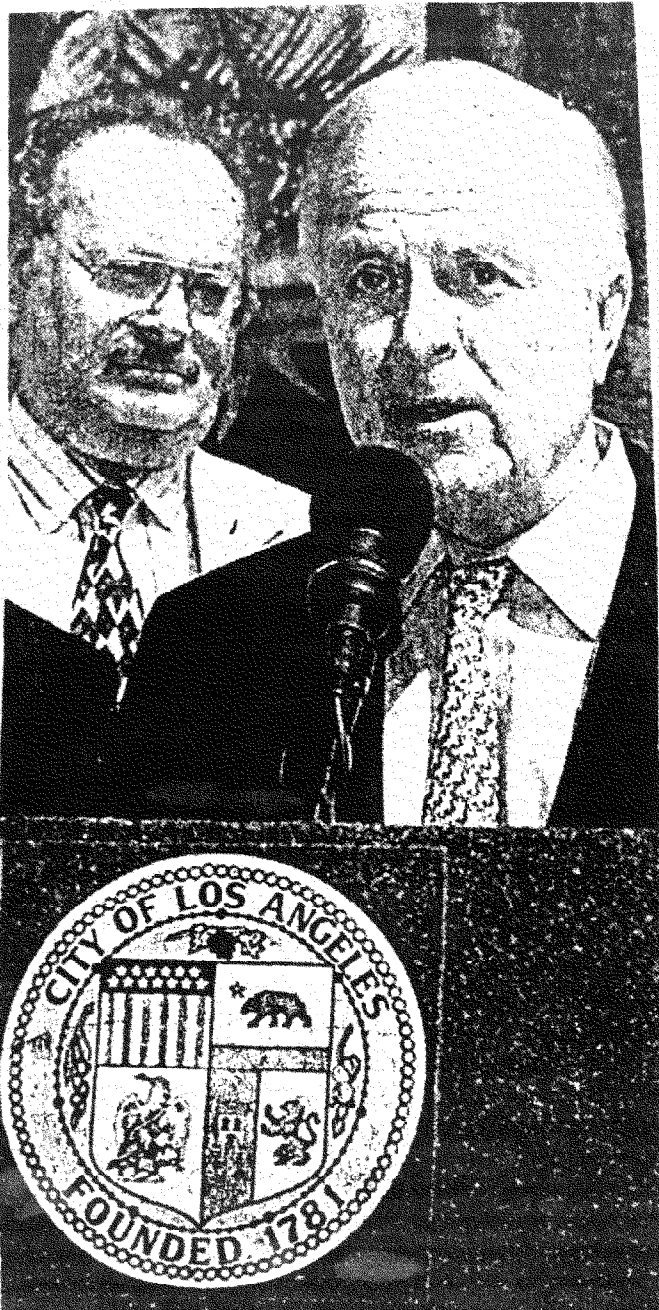

Last month business leaders, politicians and the curious from across the state came to this farming community 20 miles northwest of Fayetteville to officially celebrate groundbreaking—they termed it "cloudbreaking"—for a \$144 million airport to be completed by early 1998. Gov. Jim Guy Tucker told the crowd of 500, who braved unpaved roads and mid-90s temperatures to get to the rural site on August 10, that the project was "our children's future". [Can you BELIEVE this guy?] Billionaire Alice Walton, daughter of the late Sam Walton who built Wal-Mart into one of the world's most successful companies [thanks to his number one product: DRUGS!], admitted it would benefit several of the area's larger businesses but said her family's support of Northwest Arkansas Regional Airport went well beyond that. FREEMASONRY AND THE ESSENES

Part VII—Section III in a Series

Editor's note: Part I of this series was in the 11/15/94 issue of CONTACT; Part II, Section I was in the 11/29/94 issue; and Part II, Section II was in the 12/27/94 issue; Part III was in the 2/7/95 issue; Part IV was in the 2/28/95 issue; Part V was in the 3/21/95 issue; and Part VI was in the 5/9/95 issue; Part VII, Section I was in the 7/11/95 issue; Part VII, Section II was in the 8/1/95 issue; we are presenting Part VII, Section III here.

With excerpts from the book, *Destruction of Freemasonry Through Revelation of Their Secrets*, by General Erich Ludendorf (1927). Translated from German by J. Elizabeth Koester (1975).

When discussing the use in Masonry of *New Testament* ideas, General Ludendorf states, [quoting:]

Freemasons also claim that Jesus belonged to the Jewish sect of the Essenians, and that he himself was a Freemason. Drawing the person Jesus into Freemasonry seems to have occurred later.... [End of quoting.]

You know that if Esu/Immanuel was really one of them, he would have been promoted by the Jewish Priesthood, and NOT CRUCIFIED!

Since General Ludendorf wrote the above prior to any discovery of the *Dead Sea Scrolls* or Edgar Cayce's work and all the current media "New Age" propaganda over the Essenes and Jesus' connection to them, I wondered where this unbased rumor had originated.

It seems that the dividing of "Jewish sects" into only three "philosophical sects of the Jews" (i.e., Pharisees, Sadducees and Essenes) has been attributed to Josephus. The name "Essenes" is not found in the text of the *Bible*. Josephus was a "historian" of the first century A.D., who wrote in Aramaic and Greek. He, together with Philo and Pliny, who both also lived in the first century A.D., were what is called the "classical sources" of our knowledge of the Essenes. None of these sources identified Esu/Immanuel as a member of the Essene Sect. Further, these individual sources arrived at conflicting conclusions regarding the "Essenes". Ref.: *The Dead Sea Scroll Deception*, by Michael Baigent and Richard Leigh, starting pg. 165. However, I came to the surprising statement in this same book, pg. 167, that, [quoting:]

Thus, in 1770, no less a personage than Frederick the Great wrote definitively that "Jesus was really an Essene; he was embued with Essene ethics". [End of quoting.]

The source of this statement is listed in the chapter notes as having been stated by Dupont-Sommer, *The Essene Writings from Qumran*, pg. 13. Of course, my next subject of research was Frederick the Great and his possible role in Freemasonry in the year 1770, and the rumors that Immanuel was an Essene. It appears that all of the later writings on the subject probably drew their initial fantasies and theories from this originating rumor mill. Indeed, one can only ask, from whom did Frederick get his "information"? And, further, why

would someone in his position want to promote such questionable ideas? In 1770 there was no known historical support for the idea that Immanuel was an Essene and Frederick produces none. Further, the little that was known about the Essenes was in conflict with the known life and teachings of Immanuel. Therefore, the ones promoting this idea were ignorant, less than forthright or outright prevaricators. What was the purpose? Perhaps it will be made clear to you as we go along.

Frederick II (The Great) was king of Prussia (1740-86). His major thrust (aggression) was to unite all of the German people into one confederation. Obviously, by his title, he was highly rated by historians. What about his involvement in Freemasonry?

According to the historian, Nesta H. Webster, in her book, *Secret Societies and Subversive Movements*, Frederick the Great was initiated into Freemasonry in 1738, when he was still Crown Prince. In 1740, in response to urgent invitations, Voltaire paid his first visit to Frederick, which was followed by several additional long visits and the institution of additional degrees in Masonry in France [Frederick thought the lower degrees of Masonry were "Kinderspiel"]. Out of Frederick and Voltaire's work arose many new Orders of Masons, including the Order of Strict Observance, whose members were all wealthy and aristocratic men, such as the Duke of Brunswick and Phillippe, Duc d'Orleans, among others. This Order of Strict Observance is said by Nesta Webster to have been the first Masonic Order with "hidden superiors", and these "superiors" were widely thought to be Frederick and Voltaire!

Frederick is said by Mrs. Webster to have been the

one who [quoting:]

Conducted the operations; drew up the new constitutions of the Order ("Ancient and Accepted Scottish Rite"—a Scottish cover for Prussianism) and rearranged the degrees so as to bring the total up to thirty-three....

In the last four degrees Frederick the Great and Prussia play an important part; in the thirtieth degree of Knight Kadosch, largely modelled on the Vehmgericts, the Knights wear Teutonic crosses, the throne is surmounted by the double-headed eagle of Prussia, and the president, who is called Thrice Pussiant Grand Master, represents Frederick himself; in the thirty-second degree of Sublime Prince of the Royal Secret, Frederick is described as head of Continental Freemasonry; in the thirty-third degree of Sovereign Grand Inspector General the jewel is again the double-headed eagle, and the Sovereign Grand Commander is Frederick, who at the time this degree was instituted figured with Phillippe, Duc d'Orleans, Grand Master of the Grand Orient, as his lieutenant. The most important of these innovations was the thirty-second degree, which was in reality a system, rather than a degree, for bringing together Masons of all countries under one head—hence the immense power acquired by Frederick. By 1786 French Masonry was thus entirely Prussianized and Frederick had indeed become the idol of Masonry everywhere. Yet probably no one ever despised Freemasonry more profoundly, as the American Mason Albert Pike shrewdly observed: "There is no doubt that Frederick came to the conclusion that the great pretensions of Masonry in the blue degrees were merely imaginary and deceptive. He ridiculed the Order, and thought its ceremonies mere child's play; and some of his sayings to that effect have been preserved. It does not follow that he might not at a later day have found it politic to put himself at the head of an Order that had become a power...." (Quoted by Nesta Webster from Albert Pike's *Scottish Rite of Freemasonry: The Constitutions and Regulations of 1762*.) [N: Emphasis mine.] [End of quoting.]

You can see in the above an actual modern time's manifestation of that old, assumed prerogative of kings, the fabrication and establishment of a "new religion"

intended and used for the purpose of aggression and the gaining of wealth, influence and power.

Let's back up a little and consider some related history at the time of Frederick and Voltaire:

1. The American Colonies were growing and becoming more inclined toward independence. Several European countries (England, France, Germany and Spain) had interests in the colonies, but especially England. Rothschilds negotiated with the Landgrave of Hesse for Hessian (German) troops to be sent by England to fight the American Colonists, whose supposed independence from Great Britain began in 1776. (Please note: Masonry was already well established in the Colonies with many active English, French and German lodges.)

2. The Bavarian Order of the Illuminati, according to A.E. Waite, *Occult Freemasonry and the Jewish Peril*, (1920), "was founded by Adam Weishaupt in 1776", the same year America gained its independence. Webster states that the order was suppressed in 1786, and also asserts (with proof) that Weishaupt and the Illuminati continued to intrigue long after the French Revolution (they merely went underground for awhile). Weishaupt is reported to have become an advisor to the Rothschilds and lived until 1830.

3. Most of the forebearers of the present ruling house of England were in what is now called Germany in the late eighteenth century. According to the *American College Dictionary*, this present ruling "House of Windsor" (aka Montgomery-Battenburg) was formerly known by the name of a duchy in central Germany called Saxe-Coburg-Gotha from 1901 to 1917 when the name was changed to Windsor. Queen Victoria's consort, Albert of Saxe-Coburg-Gotha, had been the source of this family name. It was thought inappropriate by the English monarchs to use a German name during the First World War. They also publicly renounced their holdings in Germany. It is also true that the present ruling House of Windsor is closely related to Frederick the Great, and was formerly called the House of Hanover, a German duchy going back to before the time of Frederick the Great, from which he also hailed. Please see attached Genealogical Table #VIII [see box on this page], taken from the book, *A Shorter History of England and Great Britain*. In this table it will become evident how the title Saxe-Gotha acquired the additional name Coburg. It is important that you realize these relationships because, at the time that Weishaupt and his Illuminati were "suppressed in Bavaria", due to his discovered plans for world domination, Weishaupt was given asylum at the estate of Saxe-Gotha. While many investigators have described Weishaupt in harsh terms, it is Hatonn who confirms for us that Weishaupt was "the old boy himself"—Lucifer in incarnation! What his relationship was to Frederick has never been revealed. Frederick died about the same time that Weishaupt was banished. According to the book, *Occult Theocracy*, pg. 373, [quoting:]

When Weishaupt was banished from Bavaria by his sovereign, he was received at the court of Ernest-Louis de Saxe-Gotha who, besides a pension gave him the title of Honorary Councilor, the Marquis of Constanza, his secretary, and Count Saviola, the Keeper of the Archives of the Order, two Italian accomplices, were also banished with pensions of 400 and 800 florins respectively.... [End of quoting.]

One cannot easily dismiss these facts, and the present-day results of Weishaupt's long-term plans. Further, it is certainly more clear now who might have perpetrated and continued the false rumor that "Jesus was an Essene", and who gained by this falsity. There is no record, known to me, of Weishaupt having met Frederick before 1770; yet, it appears they and the House of Saxe-Gotha were in close sympathetic agreement. Also one would think, given Frederick's powerful political position but also his powerful position in Freemasonry and blood-relationship to the House of

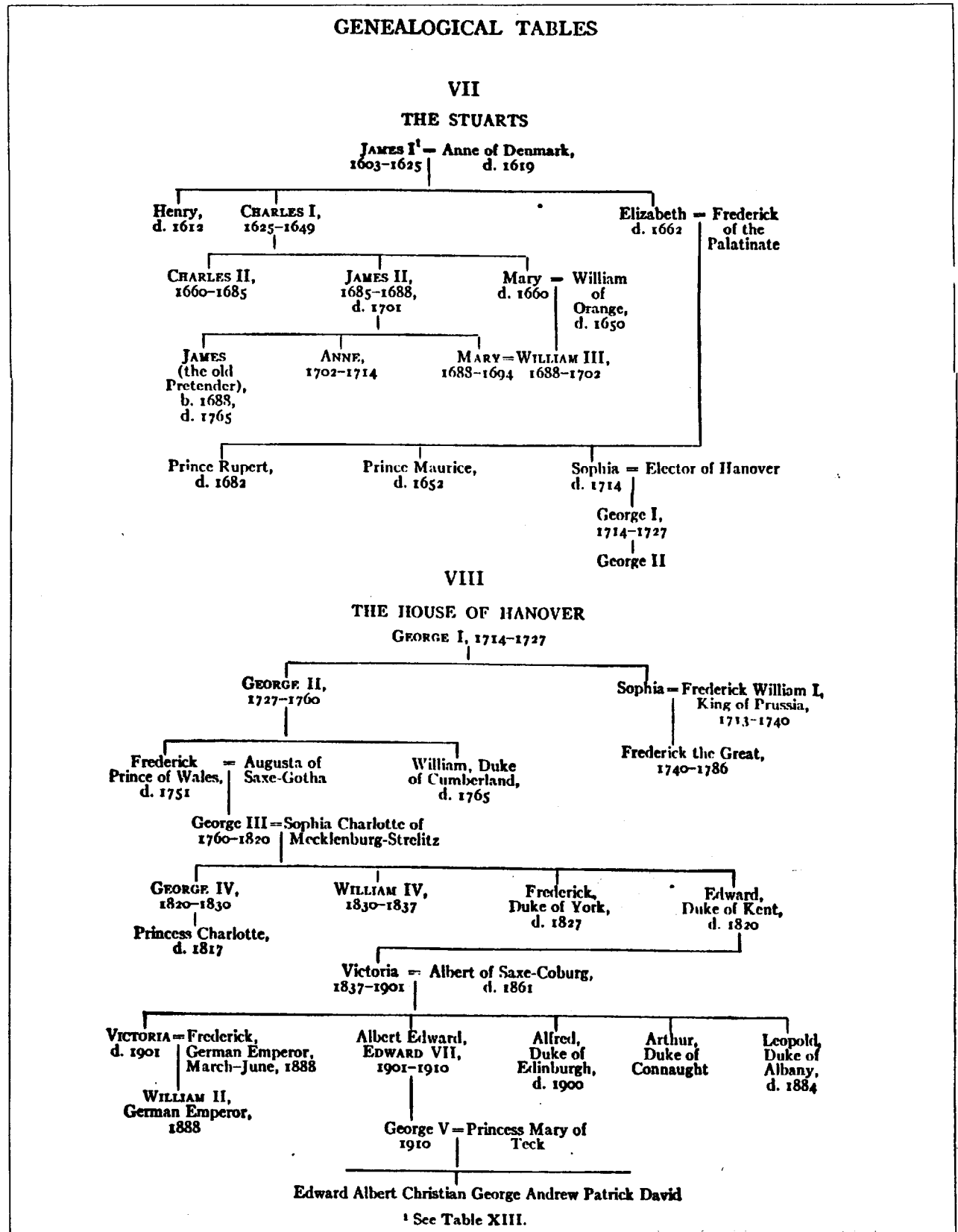
Saxe-Gotha at the time of Weishaupt, that there must have been considerable communications between them. Remember, from 1776, the year that Weishaupt is said to have established the Illuminati, until 1786, when he was banished from Bavaria, Frederick was at the height of his power in Prussia, and in international Freemasonry.

Lucifer/Satan's game is to cause one to "slip, or to miss the mark" of knowing and following the TRUTH. The idea that Immanuel was an Essene, an idea promoted by Frederick of the House of Hanover, and the highest ranking Freemason in 1770, has caused many to do just that, especially in these latter-day "New Age" groups, covertly promoted by Freemasonry. It is certain, as you will see, that the rumor that "Jesus was an Essene" has been part of long-term planning.

It should not be missed here that Lucifer's game also is world domination, and it is this goal that was obviously shared by Frederick and the British East India Company, predecessors of the Committee of 300, whose members include the ruling house of England and the Rothschilds. One wonders if Weishaupt, as

Ernest-Louis de Saxe-Gotha's "Honorary Councilor", wrote down for future rulers of the House of Saxe-Gotha and the Rothschilds his plan for world domination. Can you imagine having Lucifer as a house-guest and "Honorary Councilor" for over forty years?

Perhaps it is now somewhat easier to accept the idea that the higher echelons of Freemasonry worship Lucifer, as stated by Albert Pike, head of Freemasonry in the United States in the mid-to-late 19th century. Albert Pike's leadership of Masonry came close on the heels of Weishaupt's demise. Lucifer incarnates as a man. He may be, and probably is, incarnated today as a man. Nevertheless, do not expect to read about Lucifer in most recent works on Freemasonry. Most Masons are either unaware of Pike's statements, and the involvements of the "Elite" with Weishaupt/Lucifer, or they deny the historical facts. Even though most of the investigators I have used (see Bibliography) agree that Weishaupt was given asylum at the Estate of Saxe-Gotha, none have taken this information further to make connections with those powerful others at the head of Freemasonry at the time. Even Nesta H.



Webster, who was an English woman, seems to have passed over the importance of those who gave Weishaupt asylum. My one complaint about Webster's work is that she does not seem to realize any problems with English Freemasonry, or English Masonic leaders, but appears to accept all they say at face value. In any event, if we see 700,000 to one-million Scottish Rite Freemasons and Rebeccas canvassing the United States promoting a One World Order, we will know that the well laid plans of Lucifer and his cohorts are producing the fruit of all their efforts—and a tree is known by the fruits thereof. Lucifer's plan from the beginning is world domination.

Luke 4:5 through 8 (Re: Jesus' Temptation in the Wilderness.) [quoting:]

And the devil (Satan/Lucifer) taking him up into a high mountain, showed unto him all of the kingdoms of the world in a moment of time.

And the devil (Satan/Lucifer) said unto him, "All this power will I give you, and the glory of them: for that is delivered unto me; and to whomsoever I will I give it.

"If you therefore will worship me, all shall be Thine."

And Jesus answered and said unto him, "Get thee behind me, Satan: for it is written, you shall worship the Lord thy God, and Him only shall you serve." [End of quoting.] [N: I took the liberty of changing the words wilt to will, shalt to shall, and thou to you in this text from the *King James Version of the Bible*; also, parenthesis are mine.]

In my opinion, the "old boy" has been sorely tempting a lot of people in places of money and power in our present-day "civilization".

Nesta Webster states on pg. 354, [quoting:]

Both Weishaupt and Frederick the Great were earnest students of Machiavelli—and both overdid their masters. This form of Machiavellism, carried to a point probably never dreamt of by the Italian philosopher, has run through the whole struggle of Prussia for supremacy and at the same time through each outbreak of world revolution in which Prussian influence has played a part. [N: I add, including the part played by the Illuminati and Frederick's Freemasonry in the French Revolution, 1789.] [End of quoting.]

According to the dictionary, Machiavelli placed expediency above political morality, and countenanced the use of craft and deceit in order to maintain the authority and effect the purposes of the ruler. His doctrines are "characterized by subtle or unscrupulous cunning; wily; astute".

(Please see [prior page] the attached tables VII and VIII, taken from the *Shorter History of England and Great Britain*, and showing the geneological line of descent from the House of Stuarts and House of Hanover.)

One needs to realize that secret societies such as Freemasonry had been major factors in political intrigues of the past. It was due to a quarrel between potential claimants to the British throne that the infamous "Jacobin Clubs" were formed in France to support the cause of the "House of Stuarts" on the continent. These same Jacobins were later key players in the French Revolution (1789). Secret societies had already been effectively used in Italy for political causes. One group was called the "Guelphic Society"—a name also linked with the present rulers of England. These secret societies did not stop at intimidation, mayhem and murder. This is why some leaders were instigators and supporters of secret societies. They had proved politically powerful and useful also by the Church in the subversion of political parties and governments under the guise of "heroic knights", i.e. Templars, Teutonic Knights, etc.. Considering the number of Masons in the world and the power the secret superiors have over

them, you know that Frederick's assertion that "Jesus was an Essene" was picked up and carried by an international group.

In reading the various accounts of Adam Weishaupt, the Encyclopedists (Voltaire's group), the Illuminati and Frederick the Great's involvement therewith, I find that not all of the accounts agree. Some see Frederick's involvement as minimal, some believe the Encyclopedists were absorbed into the Illuminati that came later, some that the Illuminati were already established before Adam Weishaupt's takeover. Therefore, I was unable to confirm the relationship except that both groups were deists, both were radical, and both arose at the same general time in history. In my opinion, the Encyclopedists provided one of the first major experiments in educational and therefore media and mind control. Frederick, with Voltaire, were instigators and supporters of the Encyclopedists. They used Freemasonic brethren to write about the various subjects (free gratis) for the Encyclopedia, according to Nesta H. Webster in her book, *Secret Societies and Subversive Movements*, pg. 160-165. It was a project of Freemasons, and decidedly anti-church and anti-monarchy, basic ideas revealed in the rituals of Freemasonry. One can wonder why Frederick the Great, King of Prussia at the time much of this took place, would have sanctioned, much less supported such radical teachings. I have personally concluded that it was only a first step which hid the greater purpose. The secret plan is not to rid the world of monarchs (except, perhaps in name only). The plan is world domination, destruction of all present legitimate governments, and takeover by the conspirators—themselves, of course. They plan a new one world religion and one world government. The continuing influence of Frederick and Voltaire's known work together is as strong as it ever was. You may be interested to know that Nostradamus has stated, during the writing of the book, *Conversations with Nostradamus*, Vol. II, by Delos Cannon, that the anti-Christ was presently (about 1987) at a university in Egypt, [quoting:]

...studying and doing research on a project...incorporating the philosophies of Voltaire, Hegel, Marx, Engels, and other famous philosophers into one philosophy. [see pg. 112] [End of quoting.]

This "one philosophy" will be his plan for world takeover and domination.

As for the continuing arguments and theories about "Jesus being an Essene", authors Baigent and Leigh, in their book, *The Dead Sea Scrolls Deception*, marshal many theories which they use to discount the classical theories about the Essenes put forth by Josephus, Philo and Pliny (i.e., the Essenes were a little known sect in Judea). However, Baigent and Leigh appear to be doing this in order to join in with the presently, almost internationally, promoted and accepted theory that, [quoting:]

Provided we do not define Essenism too narrowly, by equating it exclusively with the Dead Sea Group, but

are prepared to understand the term as a general description of this widespread movement of anti-Jerusalem, anti-Pharisaic non-conformity of the period, it is from such an "Essene-type of Judaism" that Christianity is descended. [End of quoting.] [Their ref.: Professor Mathew Black's book, *The Scrolls and Christianity*, pg. 99.]

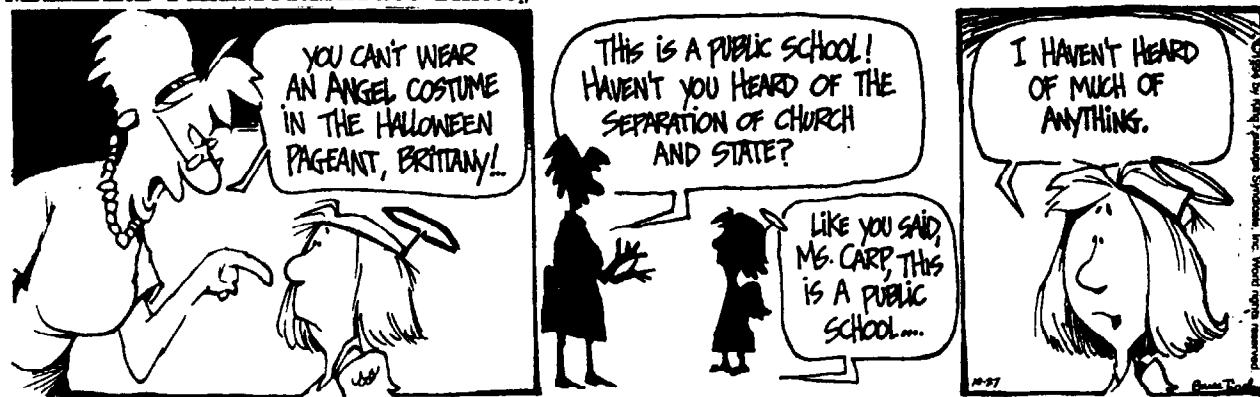
Of course, the above dares to take in such a large group that it accommodates most of whatever could be said about any group living in Judea at the time, except that much of the material in the *Dead Sea Scrolls* (that we have been given to know about) is hardly "non-conforming" but, on the contrary, rigidly orthodox (i.e., the Temple Scroll), and even secular (i.e., the War Scroll and material from *Bar Kochba*). Further, to be "anti-Pharisaic" could also be said of the Sadducees who are not included in the group. Consider also that a good many individuals in Judea at the time of Immanuel were not "Jews". Judea was governed by the Romans. Therefore I consider the above quote to be presumptuous.

I personally place Baigent and Leigh, who were co-authors with Henry Lincoln in the book, *Holy Blood, Holy Grail*, within the group of propagandists promoting the "New World Order". The final paragraph of their book pretty well confirms my feeling about this: they see the religions of Judaism, Islam and Christianity overlapping with much in common, and plead for a greater "understanding" of their "common roots". (In other words, a one world religion under the Jews.) Of course, they have missed entirely the point that "Christianity" was not descended from any sect in Jerusalem, or elsewhere. Whatever truth is still in present-day Christian teachings came from a very special person indeed, certainly not one who could be lumped together with all the "anti-Jerusalem, anti-Pharisaic, non-conforming groups of the day". Immanuel was one who did conform to God's Laws, and taught others to do likewise. He also obeyed the laws of Caesar. Further, one certainly cannot place Immanuel either with the non-conforming Zealots, or the Assassins (Sicarii). Baigent and Leigh, in my opinion, while having done a great deal of research for their book, certainly arrive at some very strange conclusions; conclusions which I believe are much in harmony with the *Babylonian Talmud* and discrediting to both Christianity and Islam (Please see Article II of the Series titled, *The Babylonian Talmud*). The account of Esu/Immanuel's encounter with the Essenes is stated in the Phoenix Journal, *THE RAINBOW MASTERS*, pg. 15. He was not an Essene, [quoting:]

Immanuel had gone away unto the city of Ephesus. In Ephesus there were many people, dealers and merchants, and they came from Jerusalem to conduct business. Immanuel (Jesus) had gone away from Jerusalem because of the persecution of himself and his people and he feared recognition.

After he had lived in Ephesus only a few days, behold, one of the merchants recognized him and told those who were like-minded thereof; they belonged to a

secret association which they called "The Association of the Essenes".

IMMANUEL AND THE ESSENES

Immanuel was brought by them to a secret meeting, for they feared the people, because their association was not permitted. Among them there was one named Juthan, and he was the oldest of the secret association in Jerusalem, and he spoke, saying, "Behold, that which happened to you in your life is very well known to us, but we do not know why you are still among the living. Please tell us your secret". Immanuel was guided to tell them nothing for fear he would be shackled and returned into Jerusalem so he told them only a bit about his flight from Jerusalem.

But Juthan, the oldest, said, "Behold, we belong to a secret association which is called 'The Association of the Essenes'. But our pressing on and our knowledge is not attuned to the teachings of the Scribes, but is attuned to the secrets of nature and everything that is inexplicable to people. But your knowledge has progressed greatly and extensively and exceeds our knowledge by great measures. Therefore, please join our association and be one of us and teach us your knowledge."

But Immanuel answered and said, "Though I should teach you my knowledge it would not agree with your teachings because you go according to human wisdom and set your doctrines thusly; I go only according to spiritual truth and Laws of God and of The Creation. Therefore, our teachings are enemies to one another. Nor am I interested in spreading my knowledge in secret places nor in secrecy of any sort and which, furthermore, is not permitted by the laws of the lands. You do that which you do in secret, since you are the Secret Association of the Essenes. But allow me time to consider the pros and cons for three days, and then I shall tell you my answer. If my answer is yes, I shall return; if no, I shall be gone."

Juthan said, "Be it as you say. Peace be with you, brother. We will await the three days".

But Immanuel did not ponder at length but instead went quickly, far away into the countryside and there explained to his people, "Behold, the Association of the Essenes lives in false cult, but they gather much of my teachings and simply add it to the old, corrupting both. Their old teachings are not the teaching of wisdom, therefore it cannot sustain for it is not of truth and therefore has become worthless. They have recognized this and are now weaving my teachings into theirs to

make a NEW cult thereof, and they insult me as labeling me one with them.

"They will say that I am connected with their association and was helped by them from the beginning of my life physical journey. They will also say that my teachings were from their original teachings (cult) and they have saved me and tutored me. Further, they will say that I am the only begotten son of God; that is not truth.

"I tell you now that I never belonged to that association of the Essenes, that I have nothing in common with it, and that I have never received any help from them.

MANY CULTS AND CHURCHES WILL USE MY NAME

"The Essene Association is not the only group that will make use of my name for many cults will arise and build 'churches' in my name and glorify me in them, to make it more credible for the people, so that they can become more enslaved.

"Many cults will be established in my name, but only for the purpose that man can be enslaved in his spirit thereby giving the cults great power over the people and the land, and over the money. But I tell you that no cult is justified unless it solely recognizes The Creation as the highest. There will be no cult which will preach total truth, knowledge, and wisdom.

"But in two times a thousand years the time will come that my teachings will be preached anew, without being falsified. Until then, there will be so many false cults that they can no longer be counted. They will be founded on the blood of men, and on hatred, greed, and power. But as they are established they shall be destroyed again, for the truth shall triumph. For there is no untruth that shall not be denounced as a lie. And, there is nothing hidden that shall not become evident. Man shall recognize what is in front of his face, and what is hidden from him will reveal itself to him when he searches for truth and the explanation of wisdom." [End of quoting.]

It appears from the above that Esu/Immanuel encountered the Essenes after his crucifixion (from which he recovered). He passed through Ephesus on his way to India. (Please note: Ephesus is a long way from Qumran where the *Dead Sea Scrolls* were found.) There is also some record of his having visited Nisibus (Edessa), a city on the silk road to India, and the site where the Turin Shroud was thought to have been found, according to the legend. (Ref.: *Jesus Lived in India*, and *The Jesus Conspiracy*.)

Confirmation that the Essenes were indeed a "Nature cult", as stated in the Phoenix Journal, *THE RAINBOW MASTERS*, is provided in the massive number of writings produced by Edmond Bordeaux Szekely, who claims to have had access to the *Dead Sea Scrolls* held in a special and separate storage by the Vatican many years prior to any information being released to the public. He claims that his work is true to these scrolls (!!). (Ref.: *The Teachings of the Essenes: From Enoch to the Dead Sea Scrolls*, also *The Gospel of the Essenes*.) Why it is that Szekely had access to material that none others had (material held in a separate location by the Vatican) is questionable in the extreme. We don't hear the Vatican or the Israelis touting the "Nature cult" theory yet, although innumerable "New Age" groups have. Further, Szekely didn't seem to have much trouble deciphering the scrolls made available to him. Why is it that an international team of scholars could not do something similar in thirty years? Undoubtedly, we have here some more secrets needing to be unearthed in the Vatican archives.

"New Age" groups such as those sponsored, directed or supported by Sir George Trevelyan promote Szekely's work. Sir George claims to be "working towards a new society", that "the industrial society must be abandoned", that Szekely's Essene teachings mean "possessed by a god" and are a "very pure and developed expression of the Ageless Wisdom, the ancient Hermetic doctrine of holism which underlies and overlights all the approaches to esoteric knowledge in all the religions." He is a prolific writer, speaker and organizer of "New Age" work, projects of international, academic and scientific groups and propaganda pointing towards a "holistic view" of the world—in other words, a "One World Government", although he denies being interested in the "politics of it". His message is: "spiritual wholeness" the "oneness of all life", the "wholeness of all life", the "brotherhood of man", the "New Jerusalem", "sharing", etc. While there is much with which one can agree and disagree, Sir George, I believe, is irresponsibly promoting a one-world system while refusing to discuss, much less consider at length, all of the practical and political ramifications of it, thereby revealing his own lack of the "WHOLENESS" he preaches.

Sir George was a former teacher at the "Princes School of Gordonstown", and Warden of the famous Attingham Park Adult College in Shropshire, where many international students and groups gathered. He received, together with his Wrekin Trust, the "Right Livelihood Award, sometimes called the Alternative Nobel Prize...which is an inspired attempt to credit

outstanding contributions to the formulation of a new world view". As a director of Findhorn Gardens in Scotland, he had access to most of those visiting Findhorn or involved in it including David Spangler's followers, Donald Key's followers, Planetary Citizens and U.N. promoters. A problem with such efforts is that, while some truth is given and Nature is loved and cared for, the promotion of an unqualified, one-world view plays right into the hands of those who seek world domination. These are the ones, of course, who have the funds to provide "prizes" for a "new world view". Those who control the money can also control the direction of society through support of just such projects as those of Sir George Trevelyan. They are the puppeteers and not themselves "lovers of the Earth". (Ref.: *Summons to a High Crusade*, by George Trevelyan, 1986) Sir George had been in charge of the Adult College for twenty-four years when the above book was written (1986). That could mean his "international groups of scientists and scholars" were meeting during the "cold war period".

Sir George Trevelyan is the nephew of Sir George M. Trevelyan a plaudited historian of the past and one who was a part of the Socialist/Communist group at Cambridge, which David Emerson GuMaer had investigated in England in connection to the "spy ring" involved in MI-5 and MI-6 (See the 6/27/95 issue of *CONTACT* newspaper and the article titled, "The Dark Side of the Force, a Historical Overview of the Occult Conspiracy"). The spy ring was obviously installed and maintained in critical and sensitive positions by those in power, as well as wealthy persons such as Victor Rothschild. Since he is a "titled gentlemen", we know that Sir George is a servant of one of those in power, Queen Elizabeth, of the House of Guelph, Hanover, Saxe-Coburg-Gotha, Windsor, and a high-ranking member of the Committee of 300.

Mr. GuMaer's accounts of the individual sexual proclivities of this group of men deeply involved in the subversion of the people of Great Britain and her allies (us), are astonishing. They appear to have been mostly homosexuals! You will find, if you delve very deeply into the Secret Societies (see Bibliography) that morbid sexual activities have also been part of them, especially in the higher degrees. It would appear in general that the closer one gets to the "dark side of the force", the more this is true.

Sir George Trevelyan claims to have seen the god PAN, and often mentions PAN in his discourses on "Nature". Pan is, of course, a "goat-god", or a deity with the legs and feet of a goat, known as PAN THE SATYR! SATYRS are "one of a class of woodland deities attendant on Bacchus and noted for riot and lasciviousness" (Ref.: *Webster's Third International Dictionary*). Knowing that the Masons, especially those working the Templar grades, worship a goat-god called Baphomet (aka the "Goat of Mendes") (Ref.: *Morals and Dogma*, by A. Pike), we can perhaps see here the "hidden direction and hidden director" of Sir George Trevelyan's work.

Not only does Trevelyan follow the lead and doctrine of Freemasonry regarding the sect of the Essenes, "New Age" ideas, world unification and the goat-god, he also quotes from Alice Bailey's "Tibetan Master", and uses the same description for the "returning Christ" as Benjamin Creme uses in promoting his "Maitreya", said by him and Trevelyan to be "the returning Christ, the 5th Buddha Maitreya, the Iman Mahdi of Islam, Krishna and the Messiah" all in one. See lecture to the Onearth Conference, October, 1976, titled "The World Crises and the Wholeness of Life", in his book, *Summons to a High Crusade*. This lecture was presented a little less than one year before Benjamin Creme started to receive and promote messages from his "Maitreya", the first of which started September, 1977 (Ref.: *Messages from Maitreya the Christ, Vol. I*). Everything is connected!

Of course, the above only scratches the surface of all that could be said about the Freemasonic and "New

Age" rumors of the Essenes and the connectedness of it to world unification. For example, Madame Blavatsky, who established the Theosophical Society and was herself a co-Mason, wrote as if Jesus was an Essene, a MAGUS (magician) and a Gnostic. Edward Bordeaux Szekely set-up an international PEACE group in Costa Rica, and taught his Nature cult of the Essenes. He was closely associated with the U.N. groups such as Lucis Trust, also promoting PEACE (one of those propaganda themes the anti-Christ will use to gain control of the world). The PEACE they talk about is really planned, enforced submission of all peoples. It has not been the people who have lacked the desire for PEACE and BROTHERHOOD so much as the leaders who have manipulated wars, terrorism, economic collapses, etc., for purposes of their own aggression and control. Freemasonry, Lucis Trust, Trevelyan and Szekely, in my opinion, have (in some cases, unknowingly) furthered the cause of these despicable conspirators. It appears that the true dignity of man and the true stature of Esu Immanuel must first be degraded by association with a polyglot of false sects, murder, blood sacrifice, war, goat-gods, Pan the Satyr, Baphomet, etc., in order for Lucifer and his minions to come forth and claim dominion (a Jewish/Socialistic/Communitic dictatorship) over their "New World Order", an expanded and even darker example of the "Old Order" they also perpetrated upon us. Who are these persons? According to Hatonn, they are the Khazarian Jews (aka Goths from Goatland)—the "Elite" rulers, Masonic secret superiors, world bankers, financiers, Communists, media controllers, monopolizing merchants, war mongers, arms dealers, etc. They are lovers of mammon, not lovers of GOD WHO IS ONE.

It appears, in retrospect, that the long delay in giving public access to the *Dead Sea Scrolls*, even in part, allowed ample time for the moulders of public opinion to promote their versions of the scrolls and further the Freemasonic/New Age/Khazarian/Communitic/One-World philosophies. Hatonn has said the public is never intended to see the Truth of the matter. The scrolls have now been doctored to fit what the One Worlders want us to believe. The films now available at the Huntington Library of these doctored accounts do not provide any opportunity to verify the truth. In fact, it is hoped by these plotters that even the films will be lost due to expected quakes in the L.A. area where they are located. They are only a farce, and a sop to public outrage over the long delay in bringing the TRUTH of the *Dead Sea Scrolls* to the public. The Vatican and Israel have been primary actors in this atrocity.

Proof of the long-term plan for world domination by the "Elite" from the genealogical lines of Frederick the Great and the House of Hanover, is being revealed in that other book I have quoted so often in my articles, *Holy Blood, Holy Grail*. These scoundrels, in this thinly veiled propaganda, are now claiming descent from Immanuel supposedly from a child born to Mary Magdalene. They also claim the throne of the Holy Roman Empire and the title King of Jerusalem. The Goths (Khazars) must create some kind of "lineage to Solomonis" in order to claim the title, King of Jerusalem, according to Hebrew texts. Therefore we see this hoax which is given considerable backing by the controlled media. According to this book, the families claiming this "distinction" are: The Plantagenets (another family name of the English and French Monarchies), The Bourbons (related to the Duc d'Orleans), the House of Lorraine, the Lombards, the Hapsburgs (thus including some of Napoleon's descendents), and "some Jews who were interested in perpetuating the bloodline". It will be most interesting to see who these "Jews" turn out to be, and who actually steps forth to claim rulership of the world. (Will it be one of the "lineage of Solomis" and head of Freemasonry?)

In any event, if you have access to the *Cambridge Modern History* (Volume Thirteen) you will have a partial review of the interrelationships of all of these families with each other and some of the rest of the

"Elite". When Queen Victoria married Albert of Saxe-Coburg-Gotha, they were already distant relatives, both hailing from the House of Hanover. Victoria's reign was marked by expansionism. A description of her, common in many history books is: "Victoria rules the waves"—meaning the sea and trade routes. Like Frederick, she certainly was not unfamiliar with ideas of world domination. Elsewhere in this issue of *CONTACT* will be an announcement of a special sale of the colloid products, GaiaCol, OxySol and GaiaGold. As we get feedback from experiencers we learn more about what works and we intend to pass on that information as it is verified and experienced by others.

Some great sage once said, "Experience is personal." So we learn by experience—I hope some one can learn from mine (in addition to me). A few days ago I finished off my third GaiaCleanse program by taking two ounces of GaiaCol followed by six one-half ounce gulps more. Scientific Fundamentals For The Enquiring Mind

I would like, Dharma, to give the next lesson on cellular LIFE as we get behind with our lessons about ourselves as we are sidetracked into the living arena of LIFE moving in ceaseless wave after wave of distractions.

[Editor's note: This is the continuation of a scientific "course" that Commander Hatonn started teaching on pgs. 42-53 of the 9/19/95 issue of CONTACT.]

CHAPTER FOUR

THE CELL: ITS METABOLIC MACHINERY

PREVIEW QUESTIONS

1. Would a "universal enzyme" that could catalyze all the necessary chemical reactions within cells be feasible? Why do you feel that a variety of specific enzymes that catalyze only one or a few reactions is a more desirable state of affairs?
2. Cells are structurally composed of various complex molecules. At the same time, cells are building up large molecules (synthesis) and tearing down others (hydrolysis). [H: This is exactly what is happening in Gaiandriana and AquaGaia as spoken of [on pgs. 21-22]. The odor, for instance, is YOUR proof that life is taking form and changing.] Would you expect that some measure of regulation and interrelationship between these two opposite processes must occur to prevent the cells from dismantling themselves on the one hand, or overproducing structural materials on the other?
3. What nutrient materials do you need to continue life? What nutrients does a maple tree need? A soil bacterium? Are all these requirements the same? Which of these nutrients are organic and which are inorganic in chemical nature? What basic distinction do you see in this regard between the nutrient requirements of a maple tree and your own nutrient requirements?
4. Would you expect that the highly specialized chemical activities of a cell could take place in a noncompartmented, homogeneous structure? Of what value are the many membranes (external and internal) that compartmentalize all cells? Name some of the chemical activities of cells and the internal structures associated with these activities.
5. Virtually all the chemical reactions occurring within cells involve some energy change. Many of the most vital reactions require an external input of energy. (They are endergonic.) What are the ultimate and the immediate sources of the cell's available energy? In the business world, there is a need for a variety of coinage and currency to pay for items of widely different prices. Do you think this situation might have its cellular analogy? Might cells need various sizes of "energy cur-

rency" to pay their "energy debts"?

6. Why are green plants green? Why aren't they red, black, or white? What does color have to do with ability to absorb light? Are all the cells of a "green plant" green? What might this indicate in regard to differing functions of the different cells in a plant?

TERMS:

[H: Every one of these terms will apply directly to the Gaiandrianas so please take time to understand them.]

ADAPTATION: The peculiar usefulness to an organism of its particular activities and structures, which enable it to survive and reproduce in a given environment.

HOMEOSTASIS: The tendency of an organism to maintain a fairly constant internal condition within its range of tolerance. Thus, despite the variety of food-stuffs entering the body, the pH of the blood is maintained at a rather constant value. (From the Greek "same standing" or "same condition".)

METABOLISM: A general term referring to the sum of all the chemical reactions occurring within an organism.

ANABOLISM: Those metabolic reactions that result in the synthesis of cell parts and products from simpler molecules. The synthesis of protein molecules from amino acids would be an example.

CATABOLISM: Those metabolic reactions that result in the breakdown of larger molecules to smaller molecules and usually also result in energy release.

AUTOTROPHS: The class of organisms that need only low-energy, inorganic materials as a nutrient supply and from these and an energy source are able to produce their own supply of organic materials. The green plants and algae are the most common examples of autotrophs. (From the Greek "self-feeder".)

PHOTOSYNTHETIC AUTOTROPHS: Organisms possessing light-absorbing pigments in their cells that enable them to trap and convert light energy to chemical energy. This chemical energy is then utilized in the synthesis of organic compounds. This activity is termed *photosynthesis*. The most common type of pigment involved in this light-trapping process is the *chlorophylls*.

HETEROTROPHS: The class of organisms that require a few of many preformed organic compounds as a nutrient supply. These they must secure either from other organisms (living or dead) or from the products of other organisms. Man, all animals, the fungi, and most bacteria are in this group. (From the Greek "other-feeder".)

GRANA: The numerous small bodies within chloroplasts that are the actual cellular sites of photosynthesis. *Chlorophyll* molecules are arranged within them like a stack of coins.

ELECTRON DONORS and ELECTRON ACCEP-

TORS: An *excited* molecule capable of transferring an energetic electron in a chemical reaction is termed an electron donor. This transfer is *not* quite the same as ionization. Light-activated chlorophyll is an important electron donor in photosynthesis. By contrast, an electron acceptor is a molecule capable of receiving an energetic electron from an electron donor.

OXIDATIVE PHOSPHORYLATION: The vital reaction in all living cells whereby the formation of ATP molecules (phosphorylation) is coupled to the oxidation of glucose. The former is an endergonic reaction, whereas the latter is strongly exergonic.

GLYCOLYSIS: The sequential, enzymatic conversion of glucose to pyruvic acid in living cells. This is a nearly universal biochemical pathway but involves no oxygen consumption or CO₂ and results in electron removal to the respiratory chain. The enzymes promoting this reaction are found within the mitochondria of cells. The cycle is variously named because (1) its initial compound is citric acid, (2) it involves several organic acids containing three carbon atoms, and (3) its discoverer was the biochemist Sir Hans Krebs. The cycle occupies a central position in cellular metabolism, since the synthesis and breakdown of most carbohydrates, proteins, and lipids, as well as the major energy release in cells, are intimately associated with it.

RESPIRATORY CHAIN: A complex series of enzymes that serve alternatively as electron acceptors and donors, and whose activity results in the transfer of electrons from compounds in the citric acid cycle to oxygen. This transfer of electrons is a strongly exergonic sequence of reactions and is coupled directly to reactions synthesizing ATP, which are strongly endergonic. Thus, the activity of the respiratory chain results in the utilization of oxygen and the production of ATP-oxidative phosphorylation. This chain is located within the mitochondria. Several of the important enzymes of the chain are known as *cytochromes*.

STEADY STATE: The maintenance of fairly constant internal environment within cells, despite a constant influx, utilization, and removal of their molecular components; also referred to as a dynamic equilibrium.

FEEDBACK: The cellular situation whereby a biochemical effect acts back upon its causative mechanism. An everyday example would be the interaction between a thermostat and the furnace in a home heating system. This and most biological examples are termed *negative feedback*, since an "off-on" response is involved.

FEEDBACK REPRESSION: Similar to the situation in feedback inhibition, except that the final product acts back to inhibit the further synthesis of one or more of the enzymes, not their activity *per se*. The end result is essentially the same.

COUPLING: The cellular mechanism whereby the energy requirements of an endergonic reaction are met by association of this reaction with an energy-releasing (exergonic) reaction. This avoids the necessity of supplying the energy for the former reaction in the form of heat, which would be intolerable within a living cell. Coupling usually involves the important molecule adenosine triphosphate (ATP).

INDUCED ENZYME SYNTHESIS: A biochemical situation in which the synthesis of a given enzyme is promoted by the presence within the cell of the substrate (or a similar compound) of that enzyme. The obvious value of this mechanism is that enzyme synthesis is adjusted to the "need" for the enzyme, i.e., the presence of a suitable substrate. Such enzymes are termed *inducible enzymes*, in contrast to *constitutive enzymes*, which are normally present in the cell.

REVIEW QUESTIONS:

1. What are some of the factors affecting the rate of cellular metabolism? How are these related to enzyme function?
2. When wood is burned, the energy liberated is usually lost, insofar as further use by us is concerned. On the other hand, when glucose is broken down in a cell, much of its liberated energy is retained for use by the cell. How can you explain this striking difference?
3. Through what sequence of reactions is the energy of sunlight converted to the chemical energy in a sugar molecule? What part do plant pigments play in this?
4. In what sense is oxidative phosphorylation (involving ATP synthesis) in cells a "coupled" reaction? Can you suggest some distinct advantage in having oxidation and phosphorylation coupled in this manner? Predict what might happen to the cell if these reactions were "uncoupled", i.e., if oxidation were to proceed without phosphorylation.
5. Why is the compound acetyl coenzyme A (acetyl CoA) regarded as a "crossroads compound" in cellular metabolism? In what way(s) is it involved in both catabolism and anabolism?
6. In what way are mitochondria related to the energy-releasing phases of metabolism? Can the internal structure of mitochondria be related to the sequential reactions of catabolism? In what way? Does it appear likely to you that the human analogy of an Industrial Assembly-line has its counterpart on the cellular level in a sequence of enzymes arranged in some geometrical array?

By contrast, using the wholesale oxidation of glucose to supply energy for endergonic reactions in a cell would be like paying for a package of gum with a twenty-dollar bill and not being able to get change.

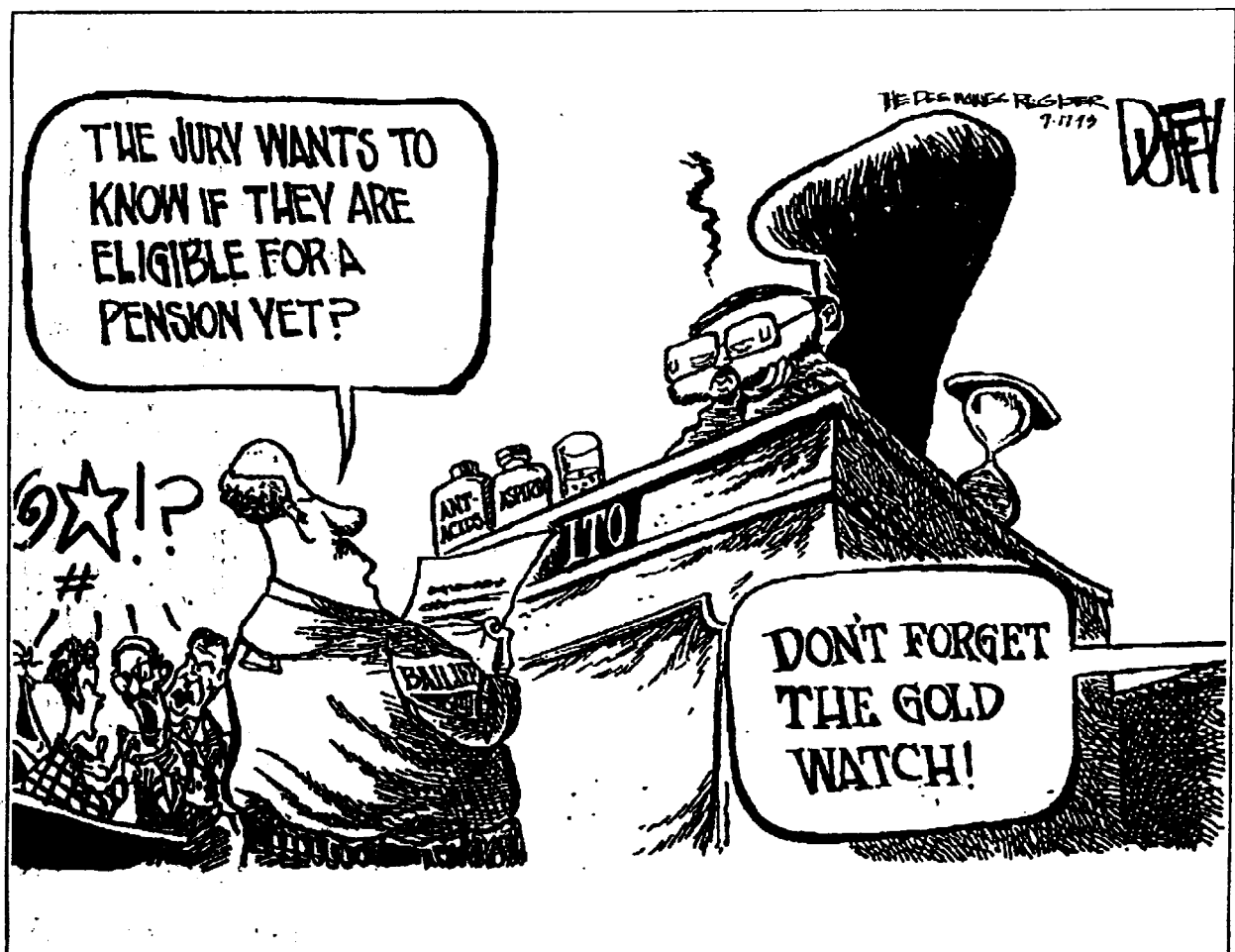

For your information only, Colloidal Silver has been used effectively on the following: acne, conjunctivitis, allergies, rheumatoid arthritis, bladder inflammation, venereal diseases, eczema, appendicitis, boils, cancer, candida, otitis media, prostate problems, whooping cough, ulcers, plus many, many others. **GaiaCol** can also be used to wet wound dressings and bandages and help heal cuts, scratches, abrasions, fever blisters, etc. There is a myriad of uses for this product which makes **GaiaCol**, in my opinion, one of the most exciting and valuable products on the market today.

OxySol contains Colloidal Silver and Trace Colloidal Gold but has Hydrogen Peroxide (food grade) and other trace minerals to add a new dimension to the effects. Organisms that have plagued us for centuries may be destroyed using this product but the new, more resistant strains will require the higher frequency **GaiaCol**. When added to water, the **OxySol** will help to purify, which makes this ideal for taking to restaurants or for travel. When taken with **GaiaCol** you get a two-fold effect of combating foreign invaders and providing a greater oxygen content for the health of the cells from the Hydrogen Peroxide. **OxySol** is wonderful topically as well, but is not advised for burns (use **GaiaCol** for burns). The trace minerals found in **OxySol** are vital to our health because the nutrients that were once taken for granted in our vegetables and fruits have been systematically farmed out of our soil. These trace minerals need to be replaced, otherwise our bodies continue to be open season for aggressive bugs. New Gaia has presented many products to the public that you can pick or choose for individual needs. But there is a core of products, which should be taken

regularly, that is felt to be essential to health and well being. These products are: **Gaiandriana**, **AquaGaia**, **Gaialyte**, **Kombucha Tea**, **Kombucha Vinegar**, **CarbraGaia**, **GaiaCleanse Program**, **Chlorella**, **Spelt**, and **3-In-1**. Each of these provides a service to the body that is a necessary assistant to the other. We will discuss each one individually to provide you with the information you need to understand why these items are necessary.

The physiology of the body is basically governed by the actions and programming found within the cell. The cells make up the tissues of the body, the tissues make up the organs such as the heart or liver which, in turn, make up the organ systems that work in harmony with each other to keep the entire body functioning. If the cell structure has been altered or is malfunctioning (for whatever reason), every organ system is affected. To what degree they are affected depends on the offending substance that has caused the cell's breakdown or the length of time that cell has been subjected to abuse.

Try mixing the tea with the **Gaialyte** and your favorite juice, or just drink it straight.

There is a **Kombucha Vinegar** that has been developed which offers similar properties to unpasteurized apple cider vinegar, which has been used for centuries to care for all types of ailments. This product packs a punch when fighting off the common cold and is great as a digestive aid. Many are using this product in their salad dressings or other recipes to enhance the nutrition that their families receive. While **Kombucha Vinegar** is not recommended for canning or preserving, it certainly is recommended for general consumption.

CarbraGaia is the membrane that is found in the mushroom fungus of the **Kombucha Tea** bathed in a nurturing amniotic-like fluid of **Gaiandriana** to aid the body in repair of connective tissue. This product was designed to replace the need for **Shark Cartilage** supplement, which has been well researched and documented in recent years and which is said to program the body to never develop cancer tumors. By mixing one teaspoon in to any of the above mentioned drinks, you add one more weapon to your arsenal in the quest to build the immune system to its optimum healthy state.

A 14-day program called **GaiaCleanse** has been developed that assists in the elimination of the nasty

This simple addition to your family's diet can provide a wealth of extra nutrition for your loved ones as well as a great taste experience.

The last product I wish to discuss is a newer product of which you may not be fully aware.
