## REAL ESTATE AND MORE...

**Real Estate In Another State:** One thing that is wonderful about Nevada Corporations is that they can own real estate in any state in the country without having to register with that state. As long as that corporation is not buying and selling properties frequently in a particular state, they are free to hold as much real estate as they want.

This can save a substantial amount of money for a corporation that holds property in California where they charge an out-of-state corporation \$1200 to register.

**Protecting Personal Savings:** If you are trying to protect money you have in the banks, here is an important strategy you may want to consider. There is a bill now that has already been approved and when it is passed, it will limit FDIC insurance to \$100,000 for all of an individual's bank deposits no matter how many bank accounts they have. This is ready to go into action now. Up until now, you have been able to spread it out, not in just branches, but you could go into one major bank and put in \$100,000, then go to an entirely separate bank and put in another \$100,000 and then another \$100,000 in a different bank and ultimately you would be able to get \$300,000 or more covered. With this new bill they will only be guaranteeing \$100,000 for all of your accounts together. So one strategy is to set up one new Nevada Corporation for each \$100,000 that you have, and this could turn out to be a very inexpensive insurance plan in these uncertain times.

**Trusts vs. Corporations:** For those who are unsure what exactly a trust is, here we will give you a simplified definition: A Trust is a right of property, real or personal, held by one party for the benefit of another.

A trust then is a Contract in which an individual (called a Settlor, Creator, Trustor or Grantor) transfers property, either real or personal, to one or more Trustees, to be held or managed for one or more Beneficiaries.

Time and again we are asked whether a trust or a corporation is the best form of ownership. From one end of the country to the other, I have heard why one is better than the other. We are professionals in the world of corporations and not in the world of trusts, so with that in mind, we will share with you some of the understanding that we have gained in our exposure to both.

When deciding whether to utilize a trust or a corporation, one needs to consider carefully all of the given specifics of the situation in which they are considering using the trust or corporation. Some of these specifics are: cost, public exposure, privacy, use of the entity, and tax position. There are, however, some situations where a combination of trusts and corporations work well together.

From a lay perspective, corporations are generally much more accepted and understood. Unlike trusts, there are very few different types of corporations. When setting up a corporation, you are only confronted with selecting "Profit or Non-Profit" and "C-Corp. or S-Corp." When looking at trusts, it can become quite confusing deciding which type is best for your situation. There are Living Trusts, Common Law Trusts, A-B Trusts, Grantor & Non-Grantor Trusts, Statutory and Non-Statutory Trusts, Irrevocable and Revocable Trusts, Business Trusts—also called Unincorporated Business Organizations (UBOs), and the list goes on. From this perspective alone, you can see how there is much more to be aware of when working with a trust. It is very important to work with an experienced individual when creating a trust.

One of the most serious concerns that we have about either form of ownership, is how they are viewed by the courts. Clearly, corporations are better understood by the courts than trusts, but this does not necessarily mean they are better. One of the most alarming articles that I've read regarding the asset protection strength of today's more popular trusts, was written in

the *Low Profile*, October 1994 newsletter. This article, entitled "Some Trusts Can't Be Trusted", went into the recent boom of trust promoters around the country. The trusts that are being most commonly sold by these promoters are called: Common Law, Massachusetts Business Trusts, UBOs, Pure, Equity, and Family Preservation Trusts. The article states that "Promoters of such trusts misrepresent the law and conceal that courts have consistently ruled that such trusts were shams lacking in economic substance and invalid for tax purposes." This last statement, about trusts being invalid for tax purposes, caught my attention because so many patriots today use these trusts to protect their assets when taking a stand against taxation. Because these trusts are used commonly by tax protesters and the untaxed, I fear for their future. The article went on to say that "The courts have repeatedly ruled that these trusts provide absolutely no liability protection against the claims of personal creditors or the IRS."

With this in mind, let's continue. Once an individual becomes experienced with trusts and corporations, there are benefits to layering assets with multiple trusts and corporations where ownership of an asset is meant to be obscured. It is my opinion that trusts do have their place. Trust are less expensive to create and maintain. Trusts, unlike corporations, don't have to pay the state for their existence, so if you know how to set up a trust, or can find someone that is not going to overcharge you, they can be very inexpensive. I have found however, that most promoters of trusts overcharge for their services and their trust packages.

Because of the courts' past decisions allowing creditors and the IRS access to trusts, we would advise not using trusts except in specific situations and not by themselves. We have not run into a case yet where a properly run Nevada Corporation has been broken into by the courts. In fact, in a very recent case involving a very stringent testing in a Nevada state court, the Nevada Corporation held firm in every aspect, moving "case-law" precedent in a very pro-Nevada-Corporations direction. With so many large corporations in this country operating and successfully separating the liability of a corporation and its owner(s), the odds are that corporations will maintain their strength into the future, and especially so in Nevada.

## SAVVY LAWYERS MAKE MILLIONS FROM PRO BONO CASES

It's time to take a second look at those philanthropic lawyers! From the November 29 issue of the *WALL STREET JOURNAL*, [quoting:]

SAN FRANCISCO—As the legal elite looked on, partners of Wilson Sonsini Goodrich & Rosati stepped up to receive a coveted plaque: the state pro bono award for lawyers who provide "extraordinary" services to the poor "with no expectation of being paid". Wilson Sonsini won for a case that led to sweeping reforms at California's notorious Pelican Bay State Prison. But unmentioned at last year's poolside reception was the fact that Wilson Sonsini could expect to be paid very well. Because the case was brought under a law that lets attorneys collect fees from the state, Wilson Sonsini's pro bono project will yield a sum worthy of the firm's rich corporate clients: \$3.5 million. [These guys must be alumni of the "Rockefeller School of Philanthropy".]

*Pro bono publico*, it turns out, can mean big business. Contrary to the popular image of attorneys donating their time, many law firms have taken advantage of so-called fee-shifting statutes that offer a financial incentive for bringing cases that promote public policy. ["Public policy"—sounds like another sneaky euphemism like "peacekeepers".] Fee-shifting laws allow victorious attorneys to bill the opposing party—typically a government entity—at their usual rates. The net result: Firms taking on certain pro bono cases can quietly take in big money even as they reap a public-relations windfall. Indeed, Wilson Sonsini initially asked for \$7.6 million—and fought a five-month battle with the state before agreeing to the lower amount. "The fee aspect had nothing to do with our motivation for taking the case," says David Steuer, a partner. [Now he's doing what lawyers do BEST!]

## PUNITIVE DAMAGES: VIGILANTE JUSTICE BY CIVIL SUIT

Richard Grenier takes a shot at the jury system in his column in the November 27-December 2 issue of *THE WASHINGTON TIMES, NATIONAL WEEKLY EDITION*, [quoting:]

The American system of "punitive" damages, as in the recent case of an Alabama doctor awarded \$4 million to supplement the pain and suffering inflicted on him by a \$600 paint imperfection on his new BMW, is viewed by the rest of the civilized world as somewhere between preposterous and demented. A Dallas jury recently awarded a "wrongfully terminated" executive \$124 million, nicely covering his salary for the next 1,240 years. In Washington, a mother left her baby in a sink. His pre-school-age brother injured him by turning on the hot water. And the mother received a \$15 million settlement from the building owner and water-heater manufacturer

America's punitive damages are a flagrant anomaly. Although assessed by the common-law tort process—the goal of which is compensation for actual injuries—punitive damages nowadays are imposed for the purposes of criminal law: deterrence and retribution. But the punitive-damage system lacks almost every single protection of criminal justice, in which punishment can be imposed only by responsible public officials [Ooooooh! An oxymoron!] in keeping with clear legisla-

tive standards [Another one!]. Defendants in criminal cases, moreover, are protected by a huge array of constitutional safeguards, while defendants in punitive-damage suits have virtually none. [The safeguard IS the jury, to whom Mr. Grenier refers as "uninformed, irresponsible, unaccountable..." Another safeguard is shallow pockets—a well-planned corporate structure in Nevada, perhaps? (Listen up, O.J.!)]

As the idea gained ground in the late 1970s that the judiciary was a marvelous way of redistributing wealth, juries began imposing punitive damages with ever-increasing frequency, in ever-escalating amounts and in an ever-widening spectrum of cases: environmental, defamatory, product liability, medical malpractice, sexual harassment, "wrongful termination". [In other words, an ever-increasing number of law school graduates in need of work!]

## THE "GAY GENE" REVISITED

This excerpt from Cal Thomas' column appeared in the November 13-19 issue of *THE WASHINGTON TIMES, NATIONAL WEEKLY EDITION*. The subheadline reads: "Never has it been more necessary for the public to analyze the information it receives from the media. Increasingly, when it comes to homosexuality, the press cannot be trusted". [Quoting:]

The "discovery" of "new evidence" of a "gay gene" was trumpeted on the front page of *The Washington Post* as a scientific breakthrough equivalent to a cure for cancer. But the story is another exercise in the uncritical "reporting" by most of the major media when it comes to homosexuality and an example of the loss of credibility the press suffers when it climbs into bed with an advocacy group. The story quotes another "study" by Dean Hamer, a molecular biologist at the National Cancer Institute (NCI). *The Post* fails to mention that Dr. Hamer's widely trumpeted 1993 "gay gene" study is under investigation

Nor does the press report on Dr. Hamer's own homosexuality, which might indicate to some readers that Dr. Hamer has a bias in favor of discovering a biological cause for homosexual behavior. Press stories don't mention that Dr. Hamer was reassigned to other areas of research, such as smoking and cancer, after ethical questions arose.

[After pointing out the many flaws in Hamer's research, Thomas aims some well-directed arrows at the press:] Hamer once told a meeting of Parents and Friends of Lesbians and Gays, "If you tell the press what to write about a scientific study, they'll write it." Why has most of the press become a shill for the gay rights movement? Fear is one answer. Most liberals don't want to be labeled "intolerant" and shy away from any moral code that doesn't support their political comfort level. But perhaps the main reason is that the establishment media have developed a relationship with the political objectives of gay rights activism that has shamefully compromised their ability to report objectively and fairly on the issue. [And why is that?: The establishment media is owned by the "establishment"—the power elite Khazarians, who have carefully crafted the destruction of this nation. Homosexuality, their own lust-of-choice, has been programmed into this scenario.]

## FLU INOCULATIONS LEAD TO AIDS SCARE

**SEASON OPENS FOR DESIGNER FLU '95:**

From the December 14 issue of the Antelope Valley edition of the (Los Angeles) DAILY NEWS, [quoting:]

LANCASTER—As cold weather starts, so does flu season [Why IS that?], and with it record-breaking numbers of patients fill the emergency rooms. Dr. Shirley Fannin, director of disease-control programs for Los Angeles County, said this year is the worst for influenza she's seen in about a decade. "We have schools reporting 33 percent absences, and doctors' offices and emergency rooms are packed. [Reports such as this have come in from all over the country.] This year's flu strain [Designer Flu '95] may cause severe symptoms—especially fever, with temperatures rising as high as 105 degrees. With its high fever, it causes serious complications and can sometimes lead to hospitalization or death, particularly for elderly patients. According to hospital officials, almost 20,000 Americans die from the flu and its complications each

cal Care. Some of the Montana and Wyoming cases studied were resistant to one antibiotic; others were resistant to multiple antibiotics, Mike McInerney, a statistician with the foundation, said by telephone from Helena. None defied all the antibiotics doctors have in their disease-fighting arsenal. [Here we go again with that "war-on-nature" approach to medicine.] But in other Western states, the study identified cases of pneumococcal pneumonia that were resistant to all antibiotics. The Centers for Disease Control and Prevention in Atlanta estimates that this type of pneumonia kills 40,000 Americans every year. Most of the victims are elderly. [The ones the flu misses?]

Dr. John McMahon, foundation medical director, blamed the rise in resistance

## *Is It Gotterdammerung for the United Nations?*

The recent 50th anniversary celebration of the United Nations seemed more like a wake. The largest group of world leaders ever assembled anywhere gathered in New York, one-hundred-and-seventy-nine assorted presidents, prime ministers and dictators smiled uneasily for the camera. The group photograph, to those with a knowledge of history, was eerily like the photographs of the crowned heads of Europe taken just before the outbreak of World War I, which would sweep most of them into oblivion. Only a few days after the taking of the UN anniversary photograph, one of its more illustrious attendees, Prime Minister Yitzhak Rabin of the State of Israel, was himself dispatched by bullets from a fellow Jewish extremist. It will be interesting to look back in the year 2000 and see how many of these persons of great power actually survived the twentieth century.

The New York United Nations assemblage had to forego the presence of its most famous creator. It was deemed inappropriate to summon him for the festivities, although he resided only a few blocks from the UN building. As a convicted perjurer who had been sent to prison for lying about his activities as an espionage agent for the USSR, Alger Hiss might have attracted unwelcome reminiscences about his checkered career. Hiss, one of three Communist agents who served as the late President Franklin Delano Roosevelt's personal advisors at the White House, is generally revered as the architect of the United Nations Conference in San Francisco in 1945 which brought the international conspiracy into being. During Hiss' public trial, the media ignored his impressive connections with the subterranean forces of the World Order. He had been selected as president of the Carnegie Endowment for International Peace by General Dwight Eisenhower, later elected President of the United States, and by John Foster Dulles, who became Eisenhower's Secretary of State. Dulles had represented the House of Rothschild at a meeting with Adolf Hitler in Cologne, Germany in 1934 which guaranteed the bankrupt Hitler funds from the Bank of England to install his newly elected Nazi government. When Hiss was indicted by the U.S.A. Government, his lawyer, serving without pay, was Helen Lehman Buttenweiser, daughter of a Lehman Brothers banker, and married to a partner of Kuhn, Loeb Co. in New York, Benjamin Buttenweiser, whose partner Jacob Schiff boasted that he had spent more than twenty million dollars of his own funds to promote the Communist Revolution in Russia. Another Kuhn, Loeb partner, Paul Warburg, had secretly authored the Federal Reserve Act in 1910 at a conspiratorial meeting in Jekyll Island, Georgia, where the event is now marked by a small brass plaque at the Jekyll Island Hotel. Buttenweiser later became Assistant High Commissioner of a defeated Germany after World War II. During Hiss' long trial, and throughout his prison sentence, his son, Tony, was an honored guest at the million dollar Buttenweiser mansion in the East Eighties.

The fiftieth anniversary of the founding of the United Nations could hardly have come at a worse time, as the organization had reached the lowest ebb of its prestige. A war of "ethnic cleansing" has raged in the former nation of Yugoslavia for years, during which many thousands of people have been tortured and massacred, while many thousands of survivors have endured apocalyptic conditions during mass evictions, been forced into concentration camps, and faced all the horrors of war. Many of the victims have been women and children. The United Nations has had "peacekeeping forces" stationed in the war-torn area during much of these hostilities, but their presence has been the occasion for scorn. The *Washington Post* on October 26, 1995 noted that at the very time of the lavish United Nations festivities in New York, "the Dutch (U.N.) peacekeepers made little effort to defend the civilian population. They were worried about their own hos-

tages. Refugees later described how many of the Dutch were forced at gunpoint to strip to their underwear by Bosnian Serb soldiers, who then strutted around in U.N. uniforms themselves". One refugee was quoted about the sorry spectacle. "Hassan Nuhanovic, a 27-year-old translator, said he was permitted to remain in the compound because he was employed by the United Nations. 'I don't understand it. Nobody believed that the U.N. wouldn't protect the people,' said Nuhanovic, who has not seen any of his family members since their tearful farewell at the gate to the U.N. compound."

Now President Clinton has dispatched some 20,000 United States to the scenes of these massacres in a desperate effort to revive the tarnished image of the United Nations. American youths are to serve, and more than likely, to die, in the effort to rehabilitate the United Nations. Their families will be notified that they died in the service of the United Nations.

Clinton justified this act of high treason by announcing that "We must continue to bear the responsibility of the world's leadership in Bosnia, as elsewhere. If the United States does not lead, the job will not be done." But Clinton's action is contrary to the expressed purpose of the United Nations, which states that all nation members must share equal responsibility. We are now witness to the discouraging spectacle of a financially bankrupt United States bearing the billion-dollar-a-day cost of maintaining peacekeeping troops in Bosnia for a morally bankrupt United Nations.

Clinton's action comes at a time when there is a growing chorus from both liberals and conservatives that the day of the United Nations has come and gone. *Nation* magazine noted on Nov. 13, 1995 that Congressman Joe Scarborough of Florida had introduced a resolution on the occasion of the United Nations' fiftieth anniversary to take the United States out of the United Nations. This has been officially catalogued as "The United Nations Withdrawal Act of 1995". The chairman of the Senate Foreign Relations Committee was quoted as having denounced the United Nations as a "rathole". The *New Republic* suggested in a lead article, Oct. 30, 1995, that the United Nations "be allowed to wither away into irrelevance". Even a staunch Clinton supporter and State Department official, Strobe Talbott, warned in an August speech that "The United Nations might very quickly join the League of Nations on the ash heap of history."

In fact, we were relieved of the League of Nations only by the advent of the Second World War. Both the United Nations and the League of Nations were the creations of the central banks, manipulated by the House of Rothschild to cover up their financial control of the entire world. The activities in Bosnia, where both previous world wars were launched, indicate that the United Nations will indeed join the League of Nations on the ash heap of history through the convenient outbreak of the Third World War.

have to contend.

## ZIONISM

During my father's excommunication he went through five church trials from 1935-1940. He went through severe persecution because of his faithful stand. After the trials were over he told his family the stress caused him to rub his forehead until it bled. Now, the United Church of Christ has accepted the Jewish Zionist doctrine of Premillennialism. The United Church of Christ is also negotiating with ten other churches in their move to a New World Church Order.

[H: My scribe is being caused to pause here and ponder her own circumstances and wonder if this is what has happened to the hierarchy of the Phoenix Church of Christ which now has control of this property which was once her own home, still in litigation. One after another of the priests who served as intermediaries of business management have moved their focus for building a Sanctuary and Retreat to another location other than Tehachapi. Certainly, this is not unexpected and Ekkers have been humbly grateful for the interim of having a roof over their heads. ness". It is worthy of consideration and thought, nothing more. It is, however, a point of consideration that there is NO CHURCH or group here and it was expected that "they" (the church) would "run things" or, at the least, the hierarchy would do so. Someone in the audience asked former Knesset member and Orthodox Rabbi Meier Kahane if Israel should support the fundamentalist TV movement. Rabbi Kahane answered as follows: "Let us be honest, we have not gotten along well with the Arabs for 2,000 years but we can live with them. Who is the real enemy of the Jew? Was Hitler an Arab? Was Hitler a Muslim? Were the German people Arabs? Were the German people Moslems? I'll tell you who the real enemy of the Jew is: it is the Christian." The Jewish crowd screamed and yelled in approval. The moderator banged his gavel to quiet the crowd. Rabbi Kahane then said, "You know, those Arab nations, they belong to us, as we are the chosen people." Again the Jewish crowd cheered and yelled and the moderator banged his gavel to quiet the crowd. Rabbi

Kahane then said, "You know, the whole world belongs to us, as we are God's chosen people." Again the crowd screamed and shouted as the Jewish crowd was in gleeful ecstasy.

I was shocked when Rabbi Kahane said the enemy of the Jew is the Christian and I let out a grunt and sat up straight in my chair. 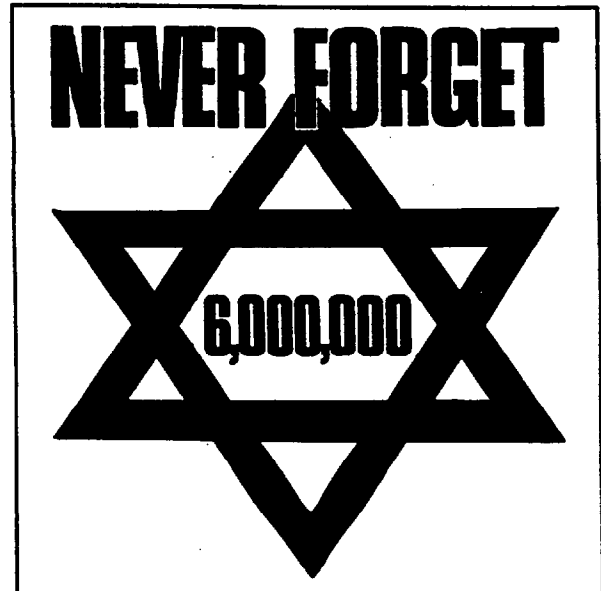

In a dramatic and unprecedented filmed interview, Dr. Franciszek Piper, senior curator and director of archives at the Auschwitz State Museum, admits on camera that "Krema I", the alleged "homicidal gas chamber" shown off to hundreds of thousands of tourists every year at the Auschwitz main camp, IS, IN FACT, A RECONSTRUCTION, FABRICATED AFTER THE WAR BY THE SOVIET UNION—apparently on the direct orders of dictator Josef Stalin.

What Piper said in effect—and on camera—was that the explosive Leuchter Report was correct: No homicidal gassings took place in the buildings designated "homicidal gas chambers" at Auschwitz. (*The Leuchter Report*, \$20, from IHR, P.O. Box 2739, Newport Beach, CA 92650.)

Ironically, for someone to even suggest such a thing could bring a jail sentence in more than one country—including enlightened nations like France, Canada and Germany. (Just ask Ernst Zundel. But more about him later.)

### "FACTS" ARE LIES

With this admission by none other than the responsible head of the Auschwitz State Museum, one of the most sacred "facts" of history has been destroyed. It is the major historical "fact" on which the foreign and domestic policies of all of the Western nations since World War II are based.

It is the basis for the \$100 billion in foreign aid the United States has poured into the state of Israel since its inception in 1948—amounting to \$16,500 for every man, woman and child in the Jewish state and billions more paid by (West) Germany in "reparations"—not to mention the constructing of Israel's national telephone, electrical and rail systems, gifts of the German people. It is the basis for the \$10 billion "loan" (read "gift") made to Israel for housing immigrants in occupied territories, while Americans sleep on streets and businesses are bankrupted by the thousands.

Germany is paying "reparations"—and the United States is making major contributions—to atone for the "gassing at Auschwitz" and elsewhere. If the "homicidal gas chambers" were postwar creations, in which no one was gassed regardless of race, creed, color or country of national origin, then these "reparations" were unnecessary, and were based on fraud.

The videotape on which Piper makes his revelations was taken in mid-1992 by a young Jewish investigator, David Cole. It has just been released, on January 1, 1993, although Cole announced his project at the 11th International Revisionist Conference at Irvine, California last October.

Cole's production follows 12 years of intensive investigation by dozens of historians, journalists and scientists who have tried to get to the bottom of what really happened at Auschwitz.

In 1979, the Institute for Historical Review (IHR) was founded which coordinated these investigations in an effort to "bring history into accord with the facts". Since then the IHR has published dozens of papers and books, none of which has ever been refuted, concerning various aspects of the "holocaust". [H: But they have been threatened, bombed, shot and generally terrorized. Proof has it that at the least the Jewish Defense League was behind the more terroristic actions.]

A major aspect that has been investigated concerns the gas chamber theory, and the biggest and the busiest gas chamber was supposedly at Auschwitz.

The activities of the IHR have been so controversial that on the night of July 4, 1984, after two years of harassment and vandalism, it was burnt to the ground by Israeli agents. Miraculously it was able to continue

operations after some months of inactivity.

### INSTRUCTED FROM YOUTH

Like most Americans, since his youth Cole had been instructed in the "irrefutable fact" that homicidal gassings had taken place at Auschwitz. The number of those so executed—also declared irrefutable—was 4.1 million.

Then came the *Leuchter Report* in 1988. This was followed by a "re-evaluation" of the total deaths at Auschwitz (down to 1.1 million). As a budding historian—and a Jew—Cole was intrigued.

Previous to 1992, anyone who publicly doubted the 4.1 million "gassing" deaths at Auschwitz was labeled an anti-Semite, neo-Nazi skinhead (at the very least). Quietly, because of revisionist findings, the official figure was lowered to 1.1 million. No mention of that missing 3 million.

In 1988, Ernst Zundel was put on trial in Canada for "publishing false news". He sold a book which questioned the legitimacy of the Auschwitz gas chamber. [H: There are several journals which are confiscated at the Canadian border for using exactly this type of article as offered HERE. It is called hate literature and is simply confiscated. This would seem to be a bit more serious than just controlling the stories allowed in a FREE press??!]

Helping with the defense were internationally known historians including Robert Faurisson, David Irving and Mark Weber.

Zundel went looking for an expert on executions, particularly gassings. He found Leuchter, who specializes in the design and fabrication of execution hardware used in prisons throughout the United States. Leuchter was commissioned to visit Poland and conduct a scientific examination of the so-called homicidal gas chambers.

On February 25, 1988, Leuchter left for Poland together with his wife Carolyn, his draftsman Howard Miller, cinematographer Jurgen Neumann and Polish interpreter Theodore Rudolph. They returned on March 3. Then he wrote his controversial report.

### NO GAS CHAMBERS

His conclusions were clear: The evidence was overwhelming that there were no execution gas chambers at Auschwitz, Birkenau and Majdanek and that the alleged gas chambers at these sites could not have been, then or now, utilized or seriously considered to function as execution gas chambers.

In the words of Dr. Wilhelm Staglich, another internationally known historian, "The extermination thesis stands or falls with the allegation that Auschwitz was a 'death factory'."

Leuchter says:

The purpose [of the investigation and subsequent report] does not include a determination of any numbers of persons who died or were killed by means other than gassing or as to whether an actual Holocaust occurred. It, further, is not the intent of this author to redefine Holocaust in historical terms, but simply to supply scientific evidence and information obtained at the actual sites and to render an opinion based on all available scientific, engineering and quantitative data as to the purpose and usages of the alleged execution gas chambers and crematory facilities at the investigated locations.

With this in mind, Cole took his video equipment to Auschwitz [in 1992] and interviewed official personnel there. Piper was the most important of these interviewees. Following his comment that the "homicidal gas chambers" were fabrications, Piper reveals, on camera, how walls were knocked down, holes made in the ceiling and "Zyklon B induction chimneys" installed on the roof so that the building could be

exhibited to tourists from all over the world as a proof of the "final solution".

And Piper doesn't stop there. He describes other "proofs" of the "final solution", which are also "reconstructions". He discusses the routine use of Zyklon B to delouse buildings and the personal effects of internees, and he admits, on camera, that the *Leuchter Report's* findings concerning Zyklon B residues in the alleged gas chambers at Auschwitz are right. [H: Please recall that your now Pope of the Roman Catholic Church before becoming this impressive personage—did in fact, SELL ZYKLON B GAS TO THE CONCENTRATION CAMPS.]

### PARADOXICAL BELIEFS

He then, paradoxically, affirms his belief, not only in homicidal "gassing chambers", but also in the "human soap" tales and the stories about "human skin" lampshades, both of which allegations which long ago have been totally debunked. [H: How can you question the "soap" story? Well, look at the pictures of the bodies shown to you. Number one: there wouldn't be bodies of any kind to show you if the bodies were consumed in such manner. Two: it requires FAT to make soap—and the conditions of the bodies they also show you have so little fat as to be worthless as soap base."]

And the revelations go on. In the video, you tour Auschwitz with Cole and hear him being told that the main camp "gas chamber" (Krema I) is in its "original state". You will see the undaunted Cole ask so many questions about the obviously ridiculous nature of this "gas chamber" that the guide feels it necessary to call her supervisor over to answer the young historian.

Cole says:

When I went to Europe in the autumn of 1992 to conduct my own investigation of the sites of the alleged "gassings" of Jews during World War II, two ideas were paramount in my mind.

The first was that the trip be recorded on videotape so that, rather than bringing back a bunch of colorful anecdotes to bore my friends, I would bring back an objective record of what I found. What I expected to be the great learning experience for me could be one for others too. My discoveries could become your discoveries. Hopefully, I would ask the questions that you would ask if you were to make the journey yourself.

The second idea was that I would go as a Jew. No two peoples have been affected more by the Holocaust than the Germans and the Jews. We know how difficult it has been for Germans themselves to expose the deceptions of the Holocaust Lobby. Germans are forbidden by law, in their own country, to state publicly that they do not believe in the orthodox gas chamber stories; forbidden from discussing THEIR OWN HISTORY.

Jewish organizations have decided that they must have a monopoly on the Holocaust issue. I reasoned that if I went to Auschwitz as a Jew rather than as a "revisionist", that I would have a better chance to cut through the misinformation and lies that so distort what really happened in the German camps during the war.

Perhaps, I thought, if I were to approach the Auschwitz officials as a Jew, my pointed questions, tactfully put, would be interpreted not as the debunking questions of a revisionist, but rather the sincere questions of a righteous Jew wanting to get the real facts to answer those hack home who say there were no gas chambers.

(I remember at one point, standing in Krema I, telling the supervisor of tour guides at Auschwitz that "You must tell me the whole truth so that when I get back home I can speak with authority against those who say 'all this' never happened.") So, donning my yarmulke, and not letting anybody in



Poland know where my sympathies were, I began my journey.

The Cole videotape PROVES that the people who run the Auschwitz State Museum had made a practice of fabricating "proofs" of homicidal gassings. Keep in mind that, over the years, millions of tourists have been told that Krema I is in its original state, while the officials knew that this "original state" is a lie.

The political, religious, financial and historical ramifications of this Auschwitz cannot be measured. Coupled with the Leuchter Report, the Cole videotape proves that what every Western government has taught since World War II is a lie. It proves that what televangelists such as Jerry Falwell and Pat Robertson HAVE BEEN TELLING THEIR FLOCKS IS SIMPLY NOT TRUE.

No one, regardless of race, creed, color or country of national origin, was gassed to death in any building so designated at Auschwitz. And without "homicidal gas chambers" at Auschwitz, where is the reasoning for the special treatment afforded the secular state of Israel?

[H: The FACTS are that hardly anyone has disclaimed that there was a "holocaust" but simply that it is NOT AS PRESENTED as to DEATH CAMPS. If you can't hold truth in one thing—truth in all things becomes hidden and accepted as a total lie once the first lies are proven to be lies. If one person was murdered—it is a "holocaust" and to lie simply brings disgrace and lack of honor to the ones who died for any reason. The TRUTH here is terrible enough to carry its own sorrow—why lie when the truth is already so terrible? Because of MONEY! The worst pictures shown of inmates in the Concentration Camps—WERE OF PEOPLE IN THE EISENHOWER DEATH CAMPS FOLLOWING THE ACTUAL WAR! GO READ OTHER LOSSES.]

By the use of this double-speak—accusing the vic-

tims of employing hate propaganda—Bradley Smith and his ilk have been trying to turn an incontestable historical fact into a "debatable issue".

The Holocaust deniers realize that they cannot "win" the debate during this century. They envision a two-step process: the first is to make the truth of the Holocaust a "debatable" issue; the second is to "win" the debate in the next century, when the victims and perpetrators of the Holocaust will all be dead.

As part of this process, Smith has tried to buy full-page advertisements in college newspapers ("Printing Holocaust denier's work arouses anger at U of I", *Chicago Jewish Star*, Jan. 31). These ads call for "open debate" on whether the Holocaust occurred. [H: And what in tarnation is wrong with open debate????]

Invoking currently vogueish language about "campus thought police" and "political correctness", Smith says that students should be "encouraged to investigate the Holocaust story the same way they are encouraged to investigate every other historical event." [H: Please keep an eye open to your TV and movie schedules now that you are to the Christmas Season—the airwaves will be blanketed with such as *Shindler's List* and other well-known FICTION tales. There was no effort to deny that *Shindler's List* was a movie made from FICTIONAL MATERIAL, and yet it is required viewing in schools across the globe and is featured as one of the greatest "true stories" ever told or made into a motion picture. NO, it is a movie script of total fabrication—BY THE ADMISSION OF THE MAKERS OF THE PICTURE.]

I agree with that formulation. The Holocaust should be studied in the same way that "every other historical event" is studied.

American slavery is studied, but no one "debates" whether there were slaves, because that is not a debatable issue. [H: No? I bet you didn't realize that Spelta is about the ONLY crop grown that is 100% ORGANIC IN ITS NATURAL STATE of anything you can do or buy.

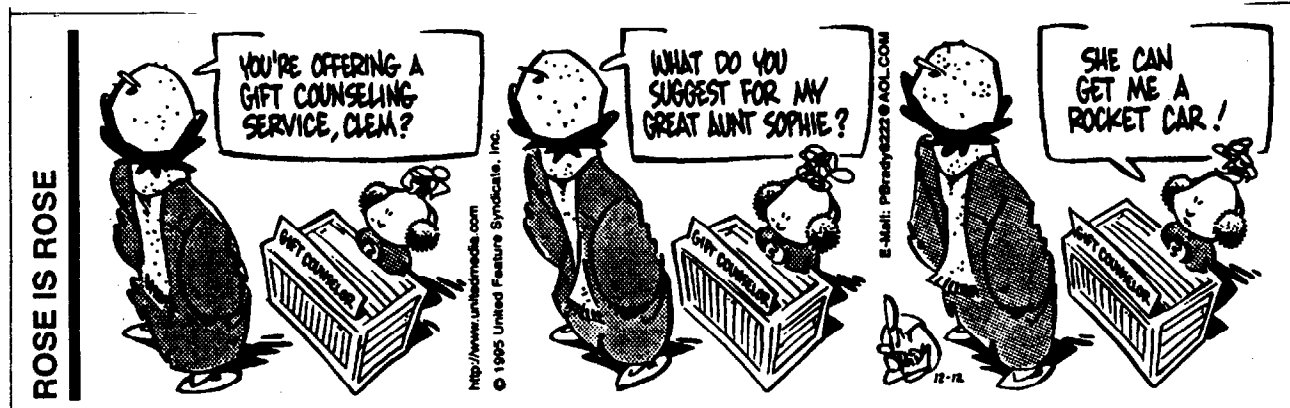

FLORISTS KNOW POINSETTIAS CANNOT BE USED FOR CUT FLOWERS—BUT LOW AND BEHOLD, IN THE EMPTY SPACES WERE TUCKED "OBVIOUSLY CUT" STEMS OF POINSETTIAS. Without the fullness of the now wilted blossoms, the arrangement is not worthy of the cost to the sender. So, now we have the problem—what might be the solution? ## STICKING TO A SUBJECT

I don't stick to one sole subject because the SOUL is impacted by all the myriads of things happening within our UNIVERSE. Souls are housed in bodies—physical on Earth and it would seem logical to me that we must answer questions about all things—not just one topic of interest.

The IDEA of Christmas and a worshipping of the idea of a Christ-child being born somewhere on the globe is wondrous indeed. The facts ARE that EVERY CHILD BORN is a *CHRIST-CHILD*. People, and the life they have, cause a decision or billions of decisions to DIRECT a child's pathway. It must be recognized that a LEADER of MEN must likewise be MAN. I am removing myself from the protector status but I DO NOT RELIEVE ANYONE OF RECOGNIZED PROMISES, CONTRACTS OR COMMITMENTS FOR PROJECT ASSISTANCE FUNDING. ONE THING HAS NOTHING TO DO WITH THE OTHER. COMMITMENTS ARE MADE BETWEEN US, ME, CONTACT, AND MULTITUDES OF INDUSTRIAL VENTURES. WE HAVE NO COMMITMENT TO ANYTHING OR ANYONE ELSE. WE HAVE KEPT OUR COMMITMENTS TO THAT PARTICULAR PARTY AND MR. NEWBY’S “KISS-OFF” MEANS NOTHING TO US REGARDING ANYTHING! I would wish that Rex would take a second look at his position. All are welcome to their choices but some are being more badly hurt than are some others in very earthly physical ways.

What do I believe? I believe that when and if he can do so, Ronn Jackson will meet his commitments and, until that is possible, he won’t. What is so difficult about that observation? He certainly does NOT have to believe anything regarding myself our any projects to which I might affiliate—agreements had to do with neither. I would expect the SAME from Chase Manhattan Bank or Joe Blow. I did not form a relationship with Mr. Jackson because he wanted to build a government—I accepted a proposal and public commitment of funding for projects OF MY CHOOSING. He SAID he could, he CAN, and yes, I certainly expect him to do so. I didn’t ask him to change his mind about anything, especially his SOUL or considered “Overworld”. 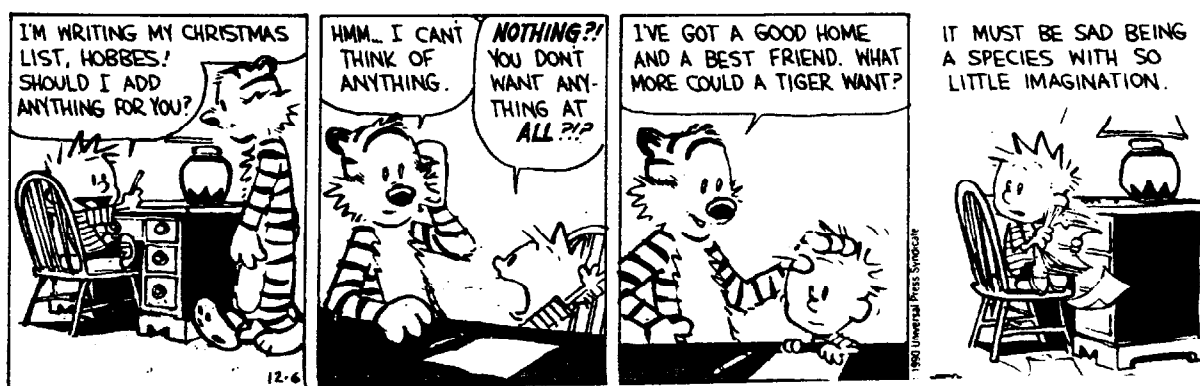
