## LOPEZ DECISION PROMPTS CALL FOR RELEASE OF MOST FEDERAL PRISONERS

This was sent in by Michael Maholy, who could probably use this decision to secure his own release from federal prison. From the January issue of *MEDIA BYPASS MAGAZINE* (1-800-4-BYPASS), this article was written by Pat McMillan, [quoting:]

More than 60 percent of federal prisoners are locked up for IRS violations, political and victimless crimes, etc. They and most other federal prisoners are incarcerated in violation of the *Constitution of the United States*. Every one of them, except those being held for the crimes of treason, piracy on the high seas, counterfeiting gold or silver coin or committing a criminal act in Washington, D.C., or on some military reservations can be freed from the sentences imposed upon them by the federal courts.

Every word you have just read is true. This was proven as recently as April 26, 1995 in the Supreme Court's landmark *Lopez* decision. This writer believes that federal prisoners who do not fall into the categories enumerated above can get out of prison by filing a writ of habeas corpus and an appeal of their own conviction based on challenging federal jurisdiction to bring charges against them for crimes they were convicted of, if they occurred within the borders of a state.

More than a century ago, attorneys seized inordinate power in the court system. Prior to that time, every person who was charged in federal court with a crime that allegedly occurred with the borders of a state, and who challenged federal territorial jurisdiction, gained his freedom by either having his case dismissed or his conviction overturned and being set free. Consider the following passage, quoted in the 1995 *Lopez* decision, where the Great Chief Justice John Marshall made clear in his famous decisions of *New York v. Milne* 36 U.S. (11 Pet.) 102 (1837) and *People v. Godfrey* 17 Johns. 225 (N.Y., 1819) that the federal government is prohibited by the *Constitution* from assuming any police power within a state.

The chief justice made clear that under the *Constitution*, the federal government was specifically restrained from exercising any general police power whatsoever within a State which is not specifically enumerated in the *Constitution*. But this creates a conflict of interest for the attorneys, who in representing the accused in a criminal matter can charge much higher fees than if they simply pointed out to the judge that the *Constitution* granted him no jurisdiction in the case. This conflict of interest extends, of course, to the prosecutor and even to the judge himself. After all, if the defense attorney needs the business to justify his livelihood, so do they. The consequences, with respect to justice for the citizen, are catastrophic.

The problem is compounded by the illegal and unconstitutional Executive actions called "Executive Orders", in which the executive branch arrogates unto itself the authority to legislate, beginning with The War and Emergency Powers Acts. While that is the subject of a whole separate dissertation, suffice it to say that with the emergency order enacted by FDR on March 9, 1933, the *Constitution* was illegally suspended and a state of war was quietly declared on all Americans by the corrupt officials who have taken over control of the executive branch of our government. In 1978, Congress, via reaffirmation of the Emergency and War Powers Act, further acquiesced to the executive branch and allowed treason against "We the People" when they approved the addition of a clause that provided for the seizure of life and property of any person within the United States, without the necessity of stating a cause or purpose.

What happened on April 26, 1995 to change all of that? The Supreme Court upheld the Appeals Court Decision in the

*Lopez* case, that the Commerce Clause of the *Constitution*, upon which every single federal police agency relies for its authority to assume police powers within states, did not grant them the authority they claimed, and that Congress had violated the *10th Amendment* by approving adoption of federal general police power statutes and agencies to enforce them:

"On appeal [for the first time in over a century, a federally charged American], the respondent [Lopez], challenged his conviction based on his claim that 922(q) [the federal crime he was convicted of] exceeded Congress's power to legislate under the Commerce Clause. The Court of Appeals for the Fifth Circuit agreed and reversed respondent's conviction. It held that, in light of what it characterized as insufficient congressional findings and legislative history, section 922(q), in the full reach of its terms, 'is invalid as beyond the power of Congress under the Commerce Clause.' 2F, 3d 1342, 1367-1368 (1993)."

Also, since all attorneys are charged with being competent to represent a defendant, they "knew or should have known" that the jurisdiction defense would have saved those individuals convicted of crimes only cognizable in state courts, and this writer believes they can be sued under Title 42, USC 1983, et. Seq., for conspiracy with government agency officials to violate their civil rights. Big bucks await those who have the dedication to see such a suit through. [You may want to call Media Bypass for a copy of the entire article and sprinkle it around judiciously.]

## INTERNATIONAL THREAT TO HEALTH FREEDOM

Are you familiar with the United Nations/World Health Organization's Codex Alimentarius Commission (Codex)? Perhaps not, since they keep a low profile and hold their meetings in Rome, Italy. It may pose the greatest threat to health freedom in the world today! From No. 10 - February 1996 issue of the *FDA CRIME REPORT* (published by the Life Extension Foundation 1-800-841-5433), [quoting:]

Remember the GATT Treaty to foster international trade? Well, congress mindlessly gave away a large chunk of U.S. sovereignty by signing this 3,000 page treaty, which has given decisions made on an international level considerable influence over our internal affairs. Under GATT, the nations of the world can be penalized heavily by the World Trade Organization if they oppose the decisions of obscure international commissions like Codex (which are influenced heavily by large multinational corporations) [like the international drug cartel?] Under GATT, member nations (such as the U.S.) must "harmonize" their rules governing the manufacture of health and medical products with new international standards so as to be "in line" with them. Each nation can either accept the dictates of the Codex Alimentarius Committee on Nutrition and Foods for Special Dietary Uses regarding labeling and manufacture of dietary supplements, or it can create its own standards—provided they conform to GATT's standards on cost/benefit analysis and on creating and reviewing scientific data for risk assessment.

Any nation which does not accept the Codex standards for dietary supplements can be heavily sanctioned (fined) by the World Trade Organization (WTO). The WTO will have the right to levy enormous fines on any nation that gets "out of line" with the potential ability to cripple entire sectors of that nation's economy! AT their last meeting, the Codex Commission's Committee on Nutrition and Foods for Special Dietary Uses was comprised of 18 delegates, representing either countries or international organizations. The Commission meets every two years. Any delegate can propose a change in Codex standards. If the proposal goes through...it becomes part of the official Codex Alimentarius. The problem is that the German delegation has proposed radical changes in the rules governing dietary supplements which, if passed and implemented, would require a doctor's prescription for the vast majority of dietary supplements now available in this country. Called the "Proposed Draft Guidelines for Dietary Supplements", the German plan calls for the following:

1. No dietary supplement can be sold for prophylactic (preventative) use or therapeutic use;
2. No dietary supplement sold as a food can exceed potency (dosage) levels set by the commission;
- 3) Codex regulations for dietary supplements would become binding, (which means that the escape clause within GATT that allows a nation to set its own standards would be eliminated);
4. All new dietary supplements would automatically be banned unless they go through the Codex approval process. [The international drug cartel has all the bases covered. They control the fertilizer/pesticide industries which have depleted our soil and caused malnutrition in our people. They control the drug industry and the AMA which mis-diagnose the symptoms of malnutrition with hard-to-pronounce, symptom-orientated, disease terminology, and which they go on to "treat" (the "trick" might be safer) with THEIR alternatives: chemotherapy; radiation; surgery; Ritalin and Prozac, and thousands of other synthetic drugs which suppress the immune system and cause side effects that are often preferable to the original symptoms! Is there an alternative? Of course, but if you aren't allowed to hear about it or obtain it, it doesn't exist as far as you are concerned. Truth is being silenced, as we march down the yellow brick road to the New World Order.]

## THE STILL BEFORE THE STORM

By all appearances, things are business as usual in Washington. There is the traditional budget bickering this time of year, the partisan sniping and the backstabbing among Republican presidential hopefuls angling for pole position next year. Meanwhile, President Clinton and his ambitious wife manage to hold a comfortable approval rating in the polls, enjoy favorable press and seemingly have managed to shrug off persistent "Whitewater" allegations that have dogged his presidency.

But don't be lulled by the mainstream media, which has been hard at work pooh-poohing those corruption charges and doubts about the official "suicide" of former White House Deputy Counsel Vincent W. Foster. This is just the eerie still before a storm. A hurricane lurks just over the horizon. Thunderheads are gathering and looming darker. Distant lightning can be seen but not yet heard. Straws are starting to blow in the wind.

**Will the bad guys be able to buy their way out of exposure? One thing is certain: Whoever controls this phantom roster of corrupt politicians and money-men has this government's private parts in a tightening vise.**

This government may be on the threshold of upheaval unprecedented since the Civil War. That is the cryptic message coming from multiple well-connected sources close to the intelligence community, who say big things are quietly afoot that could fundamentally shuffle this country's political deck. And that may be just fine with Speaker of the House Newt Gingrich (R-Ga.), [H: Please be aware of the *FRONTLINE* program LAST EVENING about the incredible politically-motivated Newt! Don't think there isn't a connection with the newt (salamander) eggs aboard the Shuttle as a clear coded message to the teams at work "down" here.] who sources say is quietly maneuvering to use this impending turmoil not just to "re-engineer government" but to purge both political parties and effect what amounts to a bloodless coup d'etat. [H: This is one of the most DANGEROUS men on your globe today!]

Swept away will be not only a raft of big-name Democratic senators and congressmen, but also many prominent, oldline Republicans who have been feeding at the trough of corruption for years. It won't stop with politicians, either. Prominent Wall Streeters, bureaucrats, military officers and a slew of intelligence bigshots are also said to be about to take a fall. Well over 300 names are said to be involved in the scandal.

"Apocalypse soon!" predicts P.P. Willie.

P.P. Willie is actually a dog. But it is also the pen name for a legendary World War II military intelligence veteran, now living in St. Petersburg, Fla., who writes for a semi-weekly newsletter called *Washington Report*. It is a pithy, irreverent Capitol gossip sheet with a penchant for pink paper. But it is read with considerable interest by its 5,000 subscribers—mostly in Washington and overseas—because Willie is known to be well-connected to senior bureaucrats within the intelligence community. In the past he has been uncannily accurate about goings-on in the spook world. And times there now are very troubled.

Willie's latest:

"Remember reading about TEA POT DOME? How about WATERGATE? Then came IRAN-CONTRA. Not bad. All the past WASHINGTON political SCANDALS are ITTY BITTY compared to one that should surface next year, about early spring.

"You don't suppose a few GOOD GUYS in the CIA, FBI, IRS, and NSA (they are not many, but they exist) are fed up with tucking their tails and running in the face of WHITE HOUSE pressure? What if they went public with TRUE DOCUMENTED stories of ESPIONAGE, MURDER, TAX EVASION, DRUG DEALING, MILLIONS OF DOLLARS STASHED IN OFFSHORE BANK ACCOUNTS AND OTHER BIG TIME HANKY PANKY at the very TIP TOP of the WASH-

INGTON manure pile? The MAJOR MEDIA would not want to embarrass the LIBERAL DARLINGS. But WHAT IF A LONDON newspaper and PINK newsletter broke the story? [H: Not to even mention a little paper called *CONTACT*.] TALK radio WOULD THEN SPREAD THE WORD ACROSS THE NATION... The odds are this scandal will break. We hear it's a DONE DEAL."

Whispers of such a spilling of the beans are being heard from multiple, separate intelligence sources. Specifically, as reported in the August and October editions of *Media Bypass*, a small, vigilant team of CIA computer hackers dubbed the Fifth Column has managed to penetrate Swiss and other foreign banks to quietly withdraw what is now an astounding 52.5 billion in illicit money from coded accounts they have identified as belonging to government figures. [H: Well, I certainly HOPE Mr. Jackson is involved!]

Starting in 1991, this five-man Fifth Column team has been using its own Cray supercomputer to break into foreign bank computers, download vast libraries of data and trace this money to a wide range of illegal activities, from kickbacks on drug and arms deals to insider trading profits, software piracy and the sale of state secrets. Oh yes, don't forget tax evasion.

The money has been moved to a U.S. Treasury holding account at several Federal Reserve Banks, escrowed for use by the CIA if and only if the CIA gets rid of its own bad apples. How could the government hide that much money, denying under Freedom of Information Act requests that it even exists? Just ask the National Reconnaissance office, the government's spy satellite agency, which recently fessed up to having \$1.7 BILLION stashed in secret accounts.

More important than the money, however, are the NAMES. Who had these accounts? Are they still in office? Who has the list and the proof? Are they using the information to extort political blackmail? Will the bad guys be able to buy their way out of exposure? One thing is certain:

Whoever controls this phantom roster of corrupt politicians and money men has this government's private parts in a tightening vise. One man who may know is Charles S. Hayes, an irascible Kentucky computer salvage dealer and recently-retired CIA contractor believed to be part of, or closely involved with, this Fifth Column.

Hayes, corroborating P.P. Willie's report, does declare that all the names will come out. Eventually. "When we get good and ready," Hayes says. The Powers That Be can do little to stop him. Any move against the three remaining Fifth Column compatriots (one has died and another is disabled) would be certain to unleash the information in a flood.

At least one big name has already been revealed: Vince Foster. Multiple sources say one of Foster's several Swiss accounts was raided just before his death of \$2.73 million in proceeds from the sale of sensitive codes and other secrets to *ISRAEL'S MOSSAD*. Which may explain why the government is so anxious to portray Foster's death as a simple suicide: In reality, it could be the loose thread that unravels a massive tapestry of corruption.

That suicide cover story is rapidly fraying, despite intense efforts by the White House and Washington establishment to hold it together. For instance, credible independent handwriting analysts concluded in late October that Foster's supposed suicide note is a forgery.

Indeed, there are a number of recent tell-tale events that suggest that something very big is at hand. Among them:

\* CIA briefings. Beginning in late October, high-level CIA officials began sensitive one-on-one briefings with key members of Congress and those with intelligence committee assignments. No staff members are allowed. All parties are sworn to secrecy. Less than a dozen lawmakers are involved. The subject, according to two sources: Espionage activities of Vincent Foster and his alleged partner—First Lady, Hillary Rodham Clinton—on behalf of Israel's Mossad and perhaps other foreign governments.

The purpose of these briefings appears to be to prep key leaders for cataclysmic political events ahead, including the likely indictment and possible flight to a foreign country of the First Lady and what would surely then be the inevitable removal of Bill Clinton from office.

\* Resignations. There has been an unusually large number of veteran congressmen and senators announcing their resignations, retirements or switching parties. Among them, Sen. Sam Nunn (D-Ga.), former chairman and now ranking minority member of the powerful Senate Armed Services Committee. Another is Rep. Norman Mineta (D-Cal.), former chairman of the pork-laden House Transportation Committee. The official explanation: It's no fun now that the Republicans control Congress.

But sources claim the real reason is that some of these departees have been quietly confronted with evidence that they took bribes or payoffs through Swiss or other offshore bank accounts. Rumor has it that about 30 current members of the House and Senate have been identified as having such foreign slush-fund accounts and that Gingrich is trying to weed them out before the names become public.

\* Curious denials. Multiple good sources have confirmed a report by veteran Washington correspondent Sarah McClendon that, over the Labor Day weekend, Gingrich attended a "party" at the home of Vice President Al Gore that included Sen. Bill Bradley, Attorney General Janet Reno and some other prominent Democrats, after which Gore and Clinton had a shouting match.

But everyone said to be involved in the meeting claims it never took place. Is it because Gingrich was there to deliver the bad news: a mountain of hard evidence of high-level corruption? Gingrich declines to be interviewed.

This Fifth Column team apparently began its work in the late 1980s. Their primary assignment was to break into foreign intelligence agency data bases by a variety of physical and electronic means. But the main means of entry was via secret "back doors" programmed into the modified "PROMIS" tracking software which our government, under the direction of CIA spymaster William Casey, managed to market all over the globe, even to our enemies.

This initial phase of the computer spy effort succeeded in downloading data from more than 50 foreign intelligence services, including the KGB, the Mossad and most of Europe's spy agencies, according to various CIA-related sources. Contrary to boastful claims by the FBI, this is apparently how Russian mole Aldrich Ames was identified as a double agent more than two years before his dramatic arrest in February 1994. It is also how the CIA found out Foster was working for the Mossad, after learning that someone in our government was delivering highly sensitive computer codes to the Israelis: Foster had been a long-time handler of sensitive computer spy deals and covert money-laundering for the NSA. Found along with Foster's name in the Mossad data base was that of Hillary Clinton, whose name also cropped up as an operative for at least two other European intelligence services, as yet unidentified.

At the time of his death, *Media Bypass* has previously reported, Foster was under close counter-espionage surveillance involving agents of the CIA, FBI, Secret Service as well as an IRS team. Two good sources say they have heard that Saudi Arabia also had agents surveilling Foster. He knew he was being investigated and was apparently under pressure to cop a plea to prevent the probe from bringing down others in the White House. The FBI apparently also knew that Foster's life was in danger: According to two reliable intelligence sources on the day of his death, FBI agents used a pair of bomb-sniffing dogs to inspect Foster's

Honda in the White House parking lot—and probably planted a transponder on the car so they could track his movements.

White House videotapes of the parking lot, which would have shown that inspection, have allegedly disappeared, according to this intelligence source. But sources say the surveillance teams have still photos and videotapes of Foster's activities on the afternoon he died, July 20, 1993, showing him entering an apartment. It is here that Foster was apparently killed, after a sexual encounter with a brownish-blond-haired woman photographed leaving the apartment afterward. Also photographed, these sources say, was the hit squad, apparently "assets" contracted by the Mossad but not including any agents of the Mossad itself. Foster's body was apparently rolled up in a rug and deposited at Fort Marcy Park—which is still closed to visitors as the FBI supposedly searches for the bullet that killed him.

Doggedly, the White House and official Washington, aided by a blindered mainstream press, continue to claim it was just a suicide, despite the seriously questionable and widely discredited report to that effect by original Whitewater Special Counsel Robert Fiske, and cursory Senate inquiry.

Sources say it is the continuing cover-up, now more than two years after Foster's death, and the brazen nature of Foster's assassination, that has soured CIA professionals and has prompted them to consider going public with what they know. Adding to their frustration was the resignation of reform-minded CIA director James Woolsey last year and his replacement by John Deutch.

Deutch's job appears to be to keep a lid on things and to protect the Clintons and the massive, ongoing illegal drug and arms trade that provides the agency with billions of dollars in revenue completely out of view of Congress and government watchdogs.

Deutch's recent attempt to use the Aldrich Ames case as a club to attack the CIA and its past directors has brought the agency's simmering revolt to a boil. "Deutch had better watch his altitude and attitude," said one veteran CIA man. "He'd better get off his soap box before he gets indicted himself."

Rumors of CIA involvement in drug trafficking go back to before the Vietnam War, with heroin trade from Laos' Golden Triangle [H: *And shades of Col. Bo Gritz.*]. But in the late '70s or early '80s, the agency virtually took over and nationalized the wholesale importation of cocaine into this country through obscure airfields like the one at Mena, Ark., on the grounds that it was the only way to control the drug trade. In other words: "If you can't lick 'em, join 'em." The operation was soon generating vastly more money than ever imagined—which has come back to line the pockets of top government officials from the Reagan, Bush and Clinton administrations. The money-laundering operations have likewise drawn in major banks and brokerage houses. By some accounts, the revenues still run upwards of \$7 BILLION a year.

Details of government involvement in this society-wrecking drug trade are now emerging from various sources. Bits and pieces emerged during the Iran-Contra and Iraqgate hearings of the 1980s, which produced a million pages of documents but only a handful of indictments, and fewer convictions. Perhaps the biggest fish caught was Reagan Defense Secretary Caspar Weinberger, charged with lying to Congress. He was pardoned by President George Bush just as Bush was leaving office in 1992. Curiously, Weinberger's right-hand man through most of that period was would-be presidential contender GEN. COLIN POWELL, who Weinberger had brought up

to be a top military advisor, out of Casey's intelligence empire where he is said to have served with the NSA and to have been intimately familiar with the drug and arms flow. [H: Still wonder why Powell sort of backed out of the race?]

There is also a growing court record of sworn testimony in the wrongful prosecution case of former CIA contract pilot Terry Reed. Reed claims in his book, *Compromised: Clinton, Bush and the CIA*, that Bill Clinton, while governor of Arkansas, was well aware of the drug trafficking there but played along with the game to earn himself the status of "approved" candidate for the presidency. With that would come plenty of financing.

Another source now openly discussing the massive drug business is retired Navy Lt. Commander Alexander Martin. Martin was, in effect, the chief accountant for the Reagan/Bush drug operations run by Marine Lt. Col. Oliver North, through an obscure arm of the White House National Security Council called the National Programs Office. In a radio interview with talk show host Tom Valentine last July, Martin spoke not only of drugs and money, but death. "Out of roughly 5,000 of us who were originally involved in Iran-Contra, approximately 400, since 1986, have committed suicide, died accidentally or died of natural causes. In over half these deaths, official death certificates were never issued. In 187 circumstances, the bodies were cremated before the families were notified." Martin then said he was lying low.

Not low enough. In late October, *Martin was arrested and jailed without bond in Broward County, Fla. for supposed violation of his probation on a 1990 bad-check charge.* Such small-time charges are a common device used to squelch and discredit former players in this government-run drug and arms racket.

Corruption. Most Americans like to think their government is somehow immune to the kinds of bribery and abuse of public power rampant in "Third World" countries. The emerging reality is that the exact opposite is true. The more wealth and power at stake, the greater the incentive to subvert and corrupt. Sources say the dark truths predicted to be unveiled by P.P. Willie will be utterly damning.

Let me quote from the "PROTOCOLS", page 43, as shared by Calvin A. Buehrer. [QUOTING:]

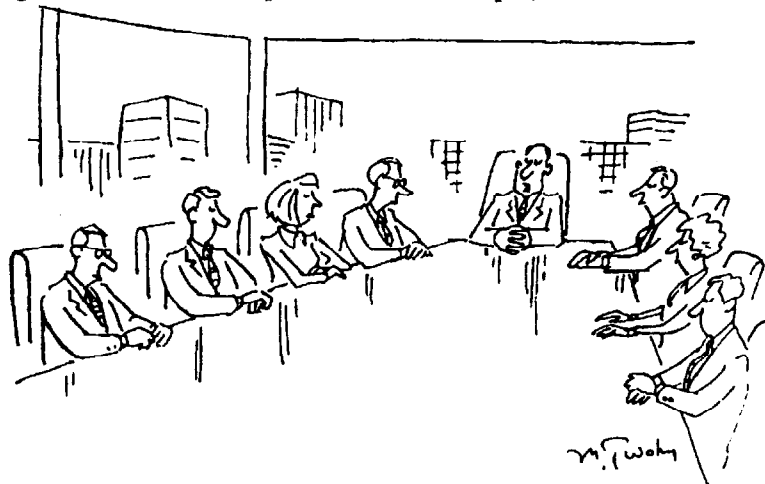

## LEARNING AND HYPNOSIS

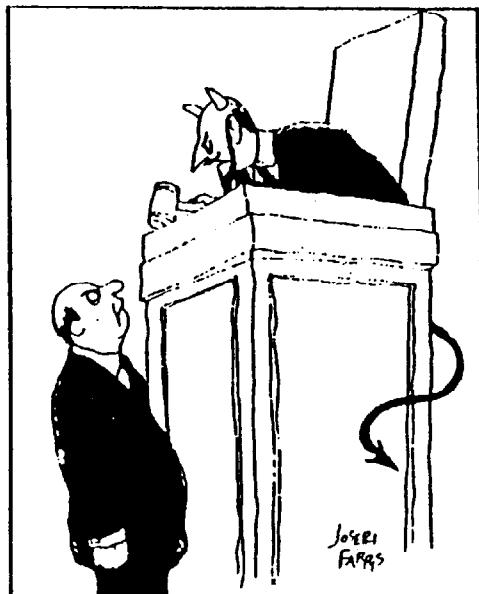

- Water**  
Stored in a portable container. Rotate regularly. Have at least three gallons per person (for a three day supply). Have a water purification method.

Suitable for long term storage. Packaged to prevent water damage. Include cups, utensils, paper plates and a can opener, if needed.
- Extra Clothing**  
A complete outfit of warm clothing for each family member. Include extra socks, and underwear. Include walking shoes.
- Warmth & Shelter**  
Coats, hats, scarves, and gloves for everyone include warm blankets (wool or emergency blankets are best). Rain ponchos, garbage bags, and/or umbrellas to keep off the rain. Warm Packs or other heat source. Pup tent or tarp.
- Light Source**  
Flashlight with extra batteries or a chemical lightstick. Kerosene lanterns are fine, but any flame may pose a hazard, especially near potential gas leaks. Have at least two quick and safe light sources in your kit.
- Tools**  
Pocket knife, lightweight shovel, duct tape, matches, pocket sewing kit, screwdriver.
- Important Papers**  
Important family documents (such as birth certificates, marriage certificates, insurance forms, wills), addresses and phone numbers of relatives, and places to meet if separated.

Keep at least \$20 in your kit. Be sure to include quarters for phone calls, etc.

# Monopoly: The Bar Association's Stranglehold At The Throne Of Justice

## Part I: There's A Camel In The Tent

So, you want to represent yourself in court? You know what lawyers have to say about that. "A man who is his own lawyer has a fool for a client."

Even Gerry Spence, in his book *With Justice For None*, said, "One can no more search for justice through the entangled labyrinths of the law without a lawyer than one can trod through fearsome, uncharted jungles without a guide."

Spoken like a true lawyer.

But what are these nebulous terms: *law, justice*? And how did lawyers come to play such a key and, dare I say it, parasitic role in our lives today? Have you ever tried to represent yourself in court?

Again quoting Spence: "What is justice? Clarence Darrow insisted, 'There is no such thing as justice. In fact, the word cannot be defined.' Darrow was right. Justice, like life, cannot be adequately defined. Justice is the divine mist, and is something inexorably connected to the state of being. But Darrow understood clearly the meaning of *injustice*, and all his life fought against it."

Spence also said, "Justice is not a willow in the wind; justice is the great tree that stands immutable against unjust forces, and the law, the massive trunk of the great tree, must resist the tempests that storm upon it."

"Most of us maintain vague notions of justice, but its precise meaning escapes us until we are deprived of it."

You are about to embark on a historical journey, a search, where we will discover just how the American Bar Association and more recently, state bar associations, have gained their literal monopoly over the judicial process.

### JOHN LOCKE ON THE LAW

In 1609, John Locke wrote the treatise *Of Civil Government*. In it, he writes of Law [quoting:]

And Reason, which is the Law, teaches all Mankind, who will but consult it, that being all equal and independent, no one ought to harm another in his Life, Health, Liberty or Possessions...For Law, in its true notion, is not so much the limitation as the direction of a free and intelligent Agent to his proper interest, and prescribes no farther than is for the general good of those under that Law; Could they be happier without it, The Law, as a useless thing, would itself vanish: and that ill deserves the name of confinement which hedges

us in only from Bogs and Precipices. So that, however it may be mistaken, the end of the Law is not to abolish or restrain, but to preserve and enlarge Freedom. For in all the States of created beings capable of Laws, where there is no Law, there is no Freedom. For liberty is to be free from restraint and violence from others; which cannot be where there is no Law; But Freedom is not, as we are told, A Liberty for every Man to do what he lists: (For who could be free, when every other Man's honor might domineer over Him.) But a liberty to dispose, and order as he lists, his person, actions, possessions and his whole property, within the allowance of those Laws, under which he is, and there is not to be subject to the Arbitrary Will of another, but freely follow his own. [End quoting.]

Now, moving ahead in time three-hundred years to England, let's see what the well respected Barrister William Blackstone has to say about the law. Then we'll take a look at modern time and see if there are any similarities or divergence. I think you'll eventually agree that it is an *eye opening* experience to view this historical perspective against the backdrop of present day concerning the subject of "the law".

### SIR WILLIAM BLACKSTONE ON THE LAW

In his 1915 classic *Commentaries On The Laws Of England*, we read the following insight on the meaning of law. [Quoting:]

Law, in its most general and comprehensive sense, signifies a rule of action; and is applied indiscriminately to all kinds of action, whether animate or inanimate, rational or irrational. Thus we say, the laws of motion, of gravitation, of optics, or mechanics, as well as the laws of nature and of nation. And it is that rule of action, which is prescribed by some superior, and which the inferior is bound to obey.

Thus when the Supreme Being formed the universe, and created matter out of nothing, He impressed certain principles upon that matter, from which it can never depart, and without which it would cease to be. When He put the matter into motion, He established certain laws of motion, to which all movable bodies must conform. And, to descend from the greatest operations to the smallest, when a workman forms a clock, or other piece of mechanism, he establishes at his own pleasure certain arbitrary laws for its direction; as that the hand shall describe a given space in a given time; to which law as long as the work conforms, so long it continues in perfection, and answers the end of its formation.

If we further advance, from mere inactive matter to vegetable and animal life, we shall find them still governed by laws; more numerous indeed, but equally fixed and invariable. The whole progress of plants, from the seed to the root, and from thence to the seed again; the method of animal nutrition, digestion, secretion and all other branches of vital economy—are not left to chance, or the will of the creature itself, but are performed in a wondrous involuntary manner, and guided by unerring rules laid down by the great Creator.

This, then, is the general significance of law, a rule of action dictated by some superior being; and, in those creatures that have neither the power to think, or to will, such laws must be invariably obeyed, so long as the creature itself subsists, for its existence depends on that obedience. But laws, in their more confined sense, and in which it is our present business to consider them, denote the rules, not of action in general, but of *human* action or conduct: that is, the precepts by which man, the noblest of all sublunary beings, a creature endowed with both reason and free will, is commanded to make use of those faculties in the general regulation of his behavior.

Man, considered as a creature, must necessarily be subject to the laws of his Creator, for he is entirely a dependent being. A being, independent of any other, has no rule to pursue, but such as he prescribes to himself; but a state of independence will inevitably oblige the inferior to take the will of him, on whom he depends, as the rule of his conduct: not indeed in every particular, but in all those points wherein his dependence consists. This principle, therefore, has more or less extent and effect, in proportion as the superiority of the one and the dependence of the other is greater or less, absolute or limited. And consequently, as man depends absolutely upon his Maker for everything, it is necessary that he should in all points conform to his Maker's will.

This will of his Maker is called the laws of nature. For as God, when He created matter, and endued it with a principle of mobility, established certain rules for the perpetual direction of that motion; so, when He created man, and endued him with free will to conduct himself in all parts of life, He laid down certain immutable laws of human nature, whereby that free will is in some degree regulated and restrained, and gave him also the faculty of reason to discover the purport of those laws.

Considering the Creator only as a Being of infinite power, He was able unquestionably to have prescribed whatever laws He pleased to His creature, man, however unjust or severe. But as He is also a Being of



infinite *wisdom*. He has laid down only such laws as were founded in those relations of justice, that existed in the nature of things antecedent to any positive precept. These are the eternal, immutable laws of good and evil, to which the Creator Himself in all His dispensations conforms; and which He has enabled human reason to discover, so far as they are necessary for the conduct of human actions. Such, among others, are these principles: that we should live honestly, should hurt nobody, and should render to everyone his due; to which three general precepts Justinian has reduced the whole doctrine of law.

But if the discovery of these first principles of the law of nature depended only upon the due exertion of right reason, and could not otherwise be obtained than by a chain of metaphysical disquisitions, mankind would have wanted some inducement to have quickened their inquiries, and the greater part of the world would have rested content in mental indolence, and ignorance its inseparable companion. As, therefore, the Creator is a Being, not only of infinite *power*, and *wisdom*, but also of infinite *goodness*, He has been pleased so to contrive the constitution and frame of humanity, that we should want no other prompter to inquire after and pursue the rule of right, but only our own self-love, that universal principle of action. For He has so intimately connected, so inseparably interwoven the laws of eternal justice with the happiness of each individual, that the latter cannot be attained but by observing the former; and, if the former be punctually obeyed, it cannot but induce the latter. In consequence of which mutual connection of justice and human felicity, He has not perplexed the law of nature with a multitude of abstracted rules and precepts, referring merely to the fitness or unfitness of things, as some have vainly surmised; but has graciously reduced the rule of obedience to this one paternal precept, "that man should pursue his own true and substantial happiness." This is the foundation of what we call *ethics*, or natural law. For the several articles into which it is branched in our systems, amount to no more than demonstrating, that this or that action tends to man's real happiness, and therefore very justly concluding that the performance of it is a part of the law of nature; or, on the other hand, that this or that action is destructive to man's real happiness, and therefore that the law of nature forbids it.

This law of nature, being coeval with mankind and dictated by God Himself, is of course superior in obligation to any other. It is binding over all the globe in all countries, and at all time: no human laws are of any validity, if contrary to this; and such of them as are valid derive all their force, and all their authority, mediately or immediately, from this original.

But in order to apply this to the particular exigencies of each individual, it is still necessary to have recourse to reason; whose office it is to discover, as was before observed, what the law of nature directs in every circumstance of life; by considering, what method will tend the most effectually to our own substantial happiness. And if our reason were always, as in our first ancestor before his transgression, clear and perfect, untroubled by passions, unclouded by prejudice, unimpaired by disease or intemperance, the task would be pleasant and easy; we should need no other guide but this. But every man now finds the contrary in his own experience; that his reason is corrupt, and his understanding full of ignorance and error. [End quoting.]

In R. Randall Kelso and Charles D. Kelso's book titled *Studying Law: An Introduction*, we read [quoting:]

Some people shy away from general reflections on law, believing that they are best left to others, such as social scientists or philosophers, who are thought to be more capable or competent in developing an over-all synthesis. That is a mistake. Jurisprudence, to give such general reflections their proper name, is everyone's business, and those who claim to be experts at it are typically no better than anyone else. The experts may

be aware of a special vocabulary and the standard arguments. Neither vocabulary nor prior reading necessarily translates into special competence. A sure sign of incompetence in jurisprudence is a bluster about knowing it all.

Some people shy away from questions of jurisprudence, as from politics or religion, because the discussion may appear to become personal. This too is a mistake. The give and take of jurisprudential argument, like the give and take of any argument, does not and should not implicate personalities. So far as jurisprudence is concerned, people are conduits through which arguments get made and the great debates of the past are continually renewed. It is the arguments, i.e., the reasons one can give for positions, that count. If during a discussion one comes to see an argument in a different light, that is good. A faulty argument doesn't indicate a faulty person; it is a useful reminder that there is always something to learn. The important thing is that the dialogue continue between students of all ages, with respect on all sides for everyone conscientiously involved. [End quoting.]

**LAW "PRACTICE"**  
(as defined in various actual cases)

"The legal definition of *practice* is: Repeated or customary action; habitual performance; a succession of acts of similar kind; custom; usage. Application of science to the wants of men. The exercise of any profession.

"The form or mode or proceeding in courts of justice for the enforcement of rights or the redress of wrongs, as distinguished from the substantive law which gives the right or denounces the wrong. The form, manner, or order of instituting and conducting an action or other judicial proceeding, through its successive stages to its end, in accordance with the rules and principles laid down by law or by the regulations and precedents of the courts. The term applies as well to the conduct of criminal as to civil actions, to proceedings in equity as well as at law, and to the defense as well as the prosecution of any proceeding." *Wells Lamont Corp. v. Bowles*, Em. App., 149 F.2d 364, 366.

"The legal definition for *practice of law* is: The 'practice of law' is the rendition of services requiring the knowledge and the application of legal principles and technique to serve the interests of another with his consent." *R.J. Edwards, Inc. v. R.L. Hert*, Okl., 504 P.2 407, 416. "It is not limited to appearing in court, or advising and performing of services in the conduct of the various shapes of litigation, but embraces the preparation of pleadings, and other papers incident to actions and special proceedings, and in larger sense includes legal advice and counsel and preparation of legal instruments by which legal rights and obligations

are established." *Washington State Bar Ass'n v. Great Western Union Federal Sav. and Loan Ass'n*, 91 Wash.2d 48, 586 P.2d 870. "A person engages in the 'practice of law' by maintaining an office where he is held out to be an attorney, using a letterhead describing himself as an attorney, counseling clients in legal matters, negotiating with opposing counsel about pleading litigation, and fixing and collecting fees for services rendered by his associate." *State v. Schumacher*, 214 Kan. 1, 519 P.2d 1116, 1127.

**THE AMERICAN BAR ASSOCIATION**

In a pamphlet from the American Bar Association titled *ABA Profile—August 1995* [prepared by the Division for Media Relations & Public Affairs Communications Group], we read [quoting:]

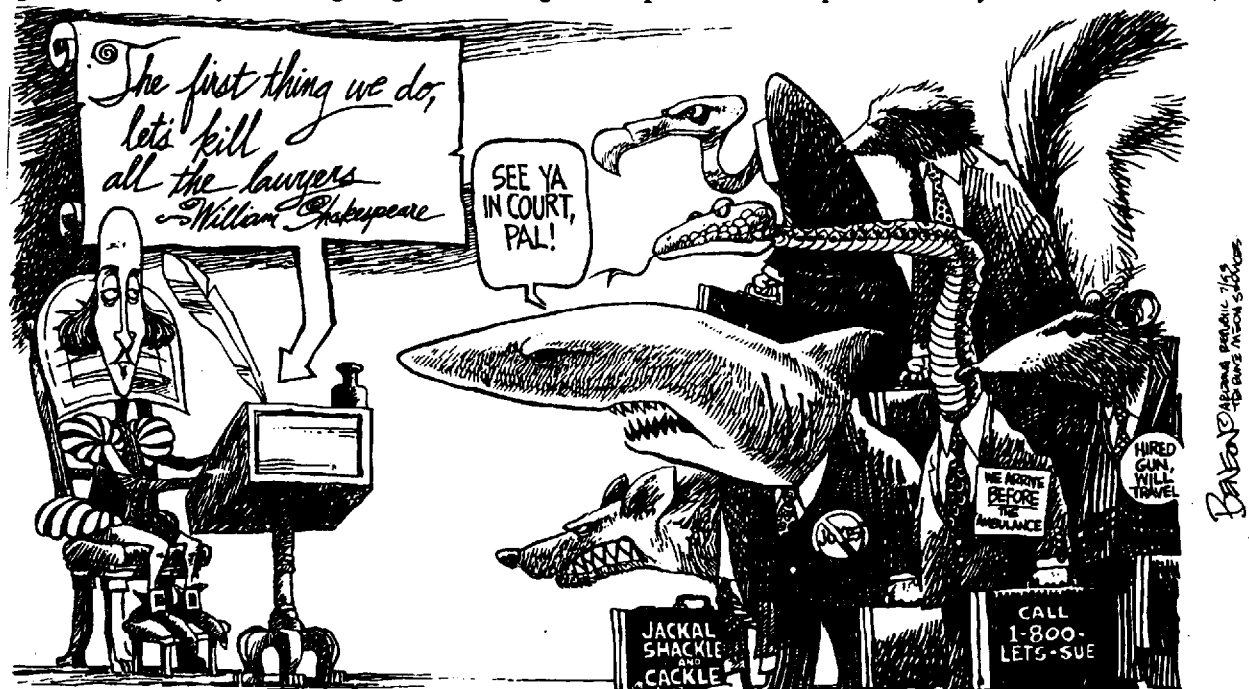
The American Bar Association, with approximately 370,000 members, is the world's largest **VOLUNTARY** professional association. The Association has long served a dual role as advocate for the profession and for the public. With the growing complexity of society and our legal system, the Association's public role has gained both emphasis and breadth. [The current President of the American Bar Association is Robert A. Stein.]

During the past decade, the Association has initiated hundreds of programs addressing a wide range of public concerns: from child abuse to the problems of the elderly; from governmental corruption to the high cost of justice; from juvenile crime to transnational pollution.

The Association's response to these and other problems is made possible by thousands of members who contribute both time and money. It is estimated that the Association's total annual budget of over \$100 million would be a minimum of six times greater if dollar values were assigned to the uncompensated hours contributed by its members.

The Association is the national organization of the legal profession. It is composed principally of practicing lawyers, judges, court administrators, law teachers, public service attorneys and many non-practicing lawyers who are business executives, government officials, and so forth. It represents geographic interests such as those of state and local bar associations. It represents practitioners in specialized areas of the law. It also represents affiliated law-related organizations and groups with specialized interests or needs such as administrative law judges, lawyers in the armed forces, and minority and women's bar associations.

The legal profession can be viewed as a giant confederation at the center of which is the American Bar Association. While the ABA does not have the power to discipline attorneys or enforce rules, the



Association leads by developing model rules and guidelines. The ABA serves as the national voice of the profession. It is a maker of models, a codifier, a searchlight, an experimenter, a moral force working to make the justice system work better for all Americans.

### ABA HISTORY

[Still quoting from *ABA Profile*.]

The ABA was founded on August 21, 1878, in Saratoga Springs, New York, by 100 lawyers from 21 states. The legal profession as we know it today barely existed at that time. Lawyers were generally sole practitioners who trained under a system of apprenticeship. There was no national code of ethics; there was no national organization to serve as a forum for discussion of the increasingly intricate issues involved in legal practice.

The original ABA constitution, which is still substantially the charter of the Association, defined the purpose of the ABA as being for "the advancement of the science of jurisprudence, the promotion of the administration of justice and a uniformity of legislation throughout the country..."

Today, the stated mission of the American Bar Association is "to be the national representative of the legal profession, serving the public and the profession by promoting justice, professional excellence and respect for the law."

The eleven goals of the Association are:

- (1) to promote improvement in the American system of justice;
- (2) to promote meaningful access to legal representation and the American system of justice for all persons regardless of their economic or social condition;
- (3) to provide ongoing leadership in improving the law to serve the changing needs of society;
- (4) to increase public understanding of and respect for the law, the legal process and the role of the legal profession;
- (5) to achieve the highest standards of professionalism, competence, and ethical conduct;
- (6) to serve as the national representative of the legal profession;
- (7) to provide benefits, programs and services which promote professional growth and enhance the quality of life of the members;
- (8) to advance the rule of law in the world;
- (9) to promote full and equal participation in the legal profession by minorities and women;
- (10) to preserve and enhance the ideals of the legal profession as a common calling and its dedication to public service; and
- (11) to preserve the independence of the legal profession and the judiciary as fundamental to a free society.

The ABA's influence today stems from both the number and diversity of its membership. ABA members represent approximately half of all lawyers in the United States. In addition, the Law Student Division has more than 33,000 members.

ABA membership is open to lawyers admitted to practice and in good standing before the bar of any state or territory of the United States. [End quoting.]

An article sent to *CONTACT* by the American Bar Association, titled "The First Century Of The American Bar Association", was written by Whitney North Seymour and appeared in the *American Bar Association Journal*, July 1978. [Quoting excerpts:]

At the time of the founding of the American Bar Association in 1878, most lawyers were sole practitioners, trained in law offices, with no pressure beyond their own consciences to feel that public or professional responsibility required concern with the public interest. Most thought it enough to use the skills they had to advance the interests of their clients and their own fortunes. No uniform code of ethics governed their conduct; few institutions for common effort were available. The spirit of brotherhood was found primarily in

the tavern, the courtroom, and the home. Judges and courts did what they thought right with no organized help from the bar. And the problems of judicial administration created by modern social welfare, regulatory, and environmental legislation were literally unknown.

It would, of course, be wrong to assume that those lawyers were benighted or without standards. Like the rest of their countrymen, they had the benefit of the moral lessons then generally learned in church, home, and school.

The lawyers who largely wrote the *Constitution* and later helped the Supreme Court reach its views about interpreting it were scholarly, inspired men. Some had been educated in the Inns of Court, some in great private law schools at Williamsburg, Virginia, and Litchfield, Connecticut.

Langdell had introduced the case method of teaching law at Harvard in 1870; an important local bar association (the Association of the Bar of the City of New York) had been formed in New York City in 1870, largely to fight the corruption of the courts by the Tweed Ring; a state bar association had been formed in New York in 1876; and some other associations were also in their infancy or had come and gone or become moribund. The need for legal aid, particularly for poor German immigrants, had called forth an organized effort to provide help (later the New York Legal Aid Society). On the whole, however, it could be said that the bar, like the rest of society, was made up of individuals, with few outside guides.

Some lawyers, on the other hand, particularly in larger cities, participated in political and other activities that caused history to blush. There can be no doubt that the creation of the organized bar and particularly the national reach of the American Bar Association elevated the standards of the bar generally.

### HEADQUARTERS IN CHICAGO

[Still quoting excerpts:]

To jump ahead, for those who like to see how a story comes out before they start reading it, the American Bar Association, which started in 1878 as a tiny corporal's guard of lawyers, largely from the East, meeting very tentatively in Saratoga Springs to see the races and to talk about an organization, now has some 235,000 [this was written in 1978] members located in every state, city, town, village, and hamlet in America. After ten years of annual meetings in Saratoga Springs, the meetings were held in other cities, none of which could have felt any particular squeeze from their presence. Now fewer than a dozen cities in the nation can accommodate the Association meetings. It has a headquarters building on the campus of the University of Chicago with a staff of more than 475.

The importance of the development of this staff cannot be overemphasized. For much of its early life the dedicated administrative staff was headed by an executive secretary, Olive G. Ricker, who retired in 1952. The present larger and more specialized staff

began to develop under Whitney R. Harris, who was appointed executive director in 1954, under Joseph D. Stecher, who served as executive director from 1956 to 1964, and under Bert H. Early, who succeeded him.

[Later in the article:] By 1889, however, the Association was prepared to "put [the American Bar Association] on wheels", in the words of one of its members, and the annual meeting that year was held in Chicago. In the remaining decade of the nineteenth century, it alternated annual meetings between Saratoga Springs and other American cities, attracting new membership and creating a national constituency.

Solid accomplishment followed this commitment to a national orientation. These accomplishments of the Association's early years were realized chiefly in the critical areas of law reform and legal education.

The Association's interest in the drafting and enactment of uniform laws was embodied at its founding in Article I of its Constitution. The first efforts, chiefly by the Committee on Jurisprudence and Law Reform, centered on forms of acknowledgement for real estate and testamentary instruments, and on marriage and divorce. These efforts resulted in the scattered adoption of a few uniform statutes.

In 1889 a special Committee on Uniform State Laws was created. The following year, citing New York state legislation authorizing the appointment of "commissioners for the promotion of uniformity of legislation in the United States", the committee recommended that each state pass a similar law. As a result of the action of New York, of the recommendation of the Association, and of the efforts of various interested persons, the first National Conference of Commissioners on Uniform State Laws was held in August, 1892, in Saratoga Springs, in conjunction with the American Bar Association annual meeting. While only nine states were represented at the first meeting, since 1912 lawyers from all the states, territories, the District of Columbia, and Puerto Rico have been present at meetings of the conference.

The object of the national conference as stated in its constitution is "to promote uniformity in state laws on all subjects where uniformity is deemed desirable and practicable." Since 1903, the Association's Standing Committee on Uniform State Laws has worked closely with the conference by coordinating Association consideration of proposed uniform laws submitted by the conference for Association approval. The Association's interest in the uniformity of state laws was further implemented in 1926 by the appointment of two members in each state to constitute special Association legislative committees to press of the enactment of legislation recommended by the National Conference of Commissioners on Uniform State Laws. Today, the national conference has drafted and approved more than two hundred acts, which have received the sponsorship of the American Bar Association.

The Section of Patent Law, created in 1894, addressed an issue of law reform on a national scale. The section's proposed amendments to the nation's patent

laws were approved by the Association and, in 1887, enacted by Congress. In succeeding years the Committee on Patent, Trademark, and Copyright Law addressed the goal of a national trademark law, and considered means of ensuring international protection of patents and trademarks. The section has been a powerful factor in improving these laws and their administration, working in close harmony with the American Patent Law Association.

In 1886 the Committee on Commercial Law set about drafting a national bankruptcy act. The Association approved the proposed law, and in 1898 the Bankruptcy Act was enacted. The committee worked in close co-operation with the chairmen of committees of both houses of Congress and remained active in the advocacy of amendments, many of which were adopted by Congress in 1903.

While the section has become, in this century, the chief organizational unit for implementing the Association's goals, only two sections were created in the nineteenth century—the Section of Patent Law and the Section of Legal Education. The latter, formed in 1893, was the first of the Association sections and reflected one of its earliest interests. The Committee on Legal Education had been the first committee created by the original constitution.

The Section of Legal Education was instrumental in organizing the Association of American Law Schools, which in turn has defined the requisites of legal education in America.

The Association has also been active in formulating standards for admission to the bar and developing better and more nearly uniform methods for examining candidates. Prior to 1890 only four states had boards of bar examiners. One of the main causes of dissatisfaction with the structure of the bar was that it was too easy to set up as a lawyer. In 1898 the Committee on Legal Education and Admissions to the Bar convened a conference of State Boards of Law Examiners in Saratoga Springs. This conference met annually thereafter and, in 1931, a National Conference of Bar Examiners was formed as a permanent agency designed to aid the various state boards in performing their duties.

The Bar Examination Committee of the National Conference of Bar Examiners developed a new multi-state bar examination in 1972. It is administered in more than twenty-five states. The planning, development, and administration of the examination were funded by a grant from the American Bar Endowment. [The President of the American Bar Endowment is Arthur W. Leibold, Jr.] The grading of this examination is conducted by an expert outside group and, despite some recent attacks on today's bar examinations, the criticisms have generally been found to be without substance.

**REFORM AND ACCOMPLISHMENT  
(1906-36)**

[Still quoting:] At the close of the century the American Bar Association was still an infant organization compared to its ultimate role as a national bar. Its membership had grown from 289 in 1878 to 2,049 in 1905, but it still represented only a small fraction of the nation's lawyers, meeting once a year and functioning in the manner of a town meeting. The annual meetings were ill-suited to definitive or conclusive discussions of substantive resolutions; its machinery and influence were still less adapted to the accomplishment of the ends called for in its resolutions. Moreover, the new century saw a growing clamor for reform of the system of justice and of the legal profession itself, which the Association, as then constituted, was without power or influence to achieve.

Those who attended the 1906 annual meeting in the Minnesota State Capitol witnessed the historic articulation of this discontent. On August 29 Roscoe Pound, then dean of the University of Nebraska Law Department, delivered an address the force and clarity of

which would be catalytic in reforming the American system of justice and, indirectly, in changing the Association itself into a vehicle for implementing reform.

Dean Pound began his address, "The Causes of Popular Dissatisfaction with the Administration of Justice", with the mild observation that dissatisfaction "is as old as law". In particular, he condemned the "environment of our judicial administration", and attacked "the sporting theory of justice" prevalent in America.

Dean Pound's speech was condemned by some at the 1906 meeting as destructive of public confidence in legal institutions. Other hearers thought otherwise, and while it cannot be said that the monumental reform of federal civil procedure and the reform of the American Bar Association—efforts that came to fruition in the 1930s—were products of Dean Pound's exhortations, the address certainly galvanized those who thought as he thought, and their labors dominated the reforms and accomplishments of the Association during the first third of the twentieth century.

Calls for reorganization of the Association mark the beginning of this period. In 1908 Jacob M. Dickinson, as president, proposed a representative system of delegates elected from the state bar associations. While this proposal met defeat, the underlying reform retained a constituency. The necessity for reform arose from the increasing numbers and influence of state and local bar associations, which numbered more than fifty by the time the new constitution was adopted in 1936. In his presidential address in 1923, John W. Davis advocated the fundamental reconstruction and expansion of the Association that was ultimately realized in the constitution of 1936.

In 1930 a Committee on Co-ordination of the Bar was created to propose ways to establish closer ties between the Association and lawyers throughout the country. The work of the committee resulted in the constitution of 1936, which is basically the structure of organization we know today. Edson R. Sunderland, the author of the most comprehensive treatise on the American Bar Association and its work, characterized the year 1936 as the turning point in the Association's development.

The present strength of the organized bar in this country, from the America Bar Association through the state and local bar associations and the many groups concerned with particular areas of reform, like the American Judicature Society and the network of mutual exchanges and co-operation, all rest ultimately on the farseeing reforms adopted in 1936.

The Association's wide-ranging activities in the area of judicial administration have been both innovative and prescient. Within a decade of its founding, the Association had adopted a resolution calling for the creation and adoption of a uniform system of federal procedure.

The Association's continuing interest in court reform early embraced both the federal and the state courts. In 1907 the Committee on Judicial Administration recommended the creation of a special committee to formulate a comprehensive scheme of judicial procedure. At that time federal procedure was governed by

the Conformity Act of 1872, which linked federal procedure in each district to the procedure prevailing in the state in which it sat.

The Association adopted a resolution at its 1911 meeting recognizing the failure of that act to bring about the conformity between federal and state procedure and proposing the adoption of federal rules of practice that would be an exemplar for the reform of the disparate judicial procedures in the several states. In 1912 the Committee on Uniform Judicial Procedure was established. The Association declared that "a complete uniform system of law pleading should prevail in the federal and state courts."

The Association was active in the legislative proceedings that concluded with the enactment of the Federal Rules. While the House Committee on the Judiciary heard testimony in support of the Federal Rules from such members as William Howard Taft and Elihu Root in 1914, twenty years elapsed before senatorial opposition to the revolutionary idea of a uniform federal practice was overcome. The Federal Rules of Civil Procedure, enacted in 1934 and adopted by the Supreme Court in 1938, effected a revolution in practice.

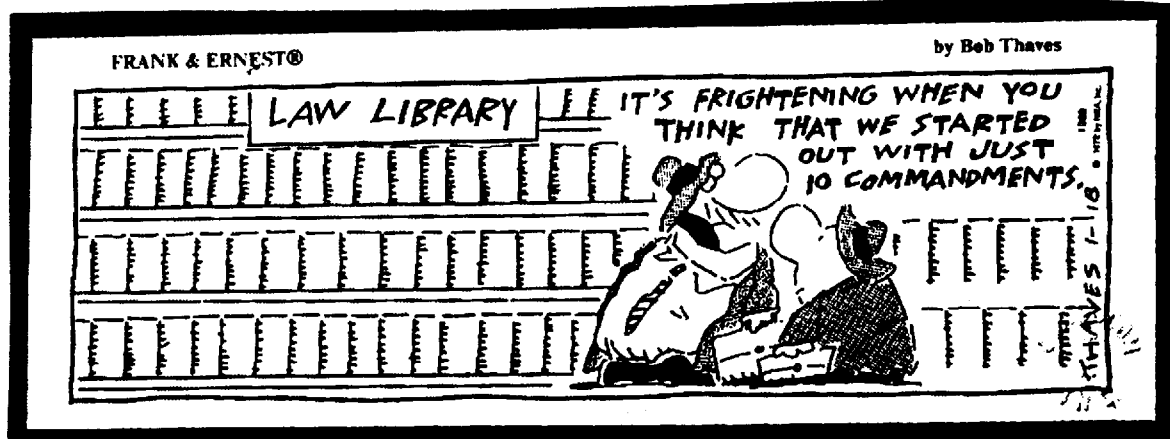

**TRIALS AND CONTROVERSIES  
(1937-54)**

Much of the early history of the Association was concerned with the creation and fostering of institutions. The principles that animated the organization in these endeavors were that the public interest would be safeguarded by the personal character of the individuals who compose its institutions, and that the institutions themselves would be safeguarded by the respect of their constituencies. As the Association moved toward mid-century, it took an active role in the trials and controversies of the nation and of the profession as it sought to strengthen and preserve organizational, national, and international institutions. This was a lively period in the life of the Association as well as the nation. Controversies which sometimes became bitter now seem the growing pains of an institution that recognized its primary obligation to the public interest.

The attempt by President Franklin D. Roosevelt in 1937 to overcome judicial opposition to his legislative program by packing the membership of the Supreme Court deeply troubled the institutional conscience of the America Bar Association. The independence of the pre-eminent legal institution in the country was at issue, and while at the outset the membership was heard on both sides of the extraordinary and spirited national debate, it soon became clear that an independent judiciary was imperiled by the proposal.

The Association determined to oppose the Court-packing plan, and it lobbied against the proposal by providing speakers for local bar associations and other civic organizations, by urging all citizens to communicate their opposition to Congress, and in other ways. Members and representatives of the Association were present and assisted throughout the hearings of the





Senate Committee on the Judiciary, marshalling an impressive array of factual data and reasoned opinion.

The *Journal* was a forum for both sides in the debate. Its pages for April and May of 1937 reflect both the passion and the vision of the Association's participation in that debate. One editorial in the *Journal* warned:

*Before a step is taken which will lead to reduce the Supreme Court to a subordinate state, which will destroy the balance between the branches on which our whole system of Government depends, a step which will set a precedent only too sure to be followed, and probably improved on, in the future, it is well to remember what an independent and impartial Supreme Court has meant to the people. The individual may well ask what guarantee of his individual rights is likely to be found in executive and congressional supremacy which can compare with the guarantee offered and still offered by such a Court.*

In the same vein, Warren Olney, Jr., spoke of the profound importance of independent judicial institutions:

*Assuming that each and all of the measures desired by the president represent changes that should be had in our social system and crediting him with the utmost purity of motive, the advantages of those changes are not to be compared with the value of preserving to the American people the independence of their courts and with that independence the only means they have of protecting their fundamental liberties.*

As the debate progressed, the majority of the Supreme Court upheld some Roosevelt legislation, leading to the quip by the Washington correspondent of the *LONDON TIMES* that "A switch in time saved nine." This episode in American history contributed to the recognition of the Association by the public as the legitimate spokesman of the organized bar.

Following the adoption of the new Association Constitution in 1936, new committees were formed to deal with a broad range of social, political, and economic problems. Among the most important was the Special Committee on the Bill of Rights, created in 1938.

In recognition of the importance of the work and its own inadequacy to deal with the number of complaints which came to its attention the special committee, headed by Grenville Clark of New York and including such younger leaders as later president Ross L. Malone of New Mexico and Frederick A. Ballard of Washington, D.C., recommended the organization of committees by state and local bar associations to function as protectors of rights safeguarded by state or federal constitutions. Forty-eight committees were formed. The *BILL OF RIGHTS REVIEW*, launched in 1940 under the guidance of Grenville Clark, provided a sounding board for civil liberties controversies.

In later years further work in the civil liberties field has been carried on by the relatively new Section of Individual Rights and Responsibilities.

The post-World War II anti-Communist concerns also created problems that evoked Association interest. Congressional investigations into the national security had raised questions about the fairness of some investigations, and the difficulty some unpopular persons had in obtaining counsel raised other question. As a result in 1952 the Association created the Special Committee on Individual Rights as Affected by National Security.

The next year the House of Delegates approved a resolution offered by the committee that emphasized the right of all defendants to counsel, including those accused of the most unpopular offenses, and the concomitant duty of the bar to provide counsel. In 1954, the House of Delegates approved a code of fair procedure for congressional investigations prepared by the committee, which endeavored to strike a balance between the rights of witnesses and the investigatory role of Congress.

The social revolutions and conflicts of the 1930s had made the law and the courts, in the words of Chief

Justice (and former Association president) Arthur T. Vanderbilt, "peculiarly the target of attacks by enemies both within and without the country." With his active participation and support, the Association moved to protect the effectiveness and prestige of the nations courts. The Section of Judicial Administration, created in 1937 under the chairmanship of John J. Parker of North Carolina, chief judge of the Fourth Circuit, sought to focus the Association's energies in judicial administration on a set of practical and well-defined goals for reform.

In 1938 the section presented a set of recommendations in the fields of judicial administration, pretrial, trial and appellate practice, jury selection and jury trial, evidence and administrative agencies. Except for one issue of appellate practice, every recommendation was approved unanimously.

The recommendations, designated the Minimum Standards of Judicial Administration, contemplated practical, specific reforms rather than ideal guidelines. Vanderbilt, one of the leading architects and advocates of these standards, noted:

*The draftsmen...wisely concentrated on the fundamental problems of judicial administration, knowing that if the minimum standards they advocated were achieved, all the other desirable advances in improving the administration of justice would inevitably follow.*

In the field of administrative law the contributions of the Section of Administrative Law deserve mention. That section was largely responsible for the enactment of the Administrative Procedure Act, which first brought order to a rapidly burgeoning field of law that had become a rambunctious competitor of the courts in the judicial process.

The American Bar Association has long labored to improve the manner of selecting judges at both state and federal levels as well as the conditions under which they work. That work was carried on through the Special Committee on Judicial Selection and Tenure, established in 1936; the Special Committee on the Judiciary, established in 1946; and, at present, the Standard Committee on the Federal Judiciary, established in 1949. A high-water mark of these activities occurred in 1952 when arrangements were first made with Ross L. Malone, then deputy attorney general, for the Association to participate in judicial selection by reviewing the qualifications of those under consideration by Attorney General Brownell, has been continued to the present by all subsequent attorneys general. It has greatly minimized political considerations in federal appointments and has contributed significantly to the high caliber of those nominees.

[Later in the article, we read:]

The contemporary period of the Association has seen an appropriate emphasis on international law and international activities of all kinds. In large measure, this broadened outlook has been the work of individuals; the membership at large has benefited and participated, however, most especially through those annual meetings joined in by the bars of other nations. The 1924 trip to London was, of course, a shining beginning. In 1942, when the Association met in Detroit, the council of the Canadian Bar Association met in the sister city of Windsor, Ontario; and a joint meeting with the Canadian bar was held in 1950 in Washington, D.C.

The 1957 annual meeting in London was, in part, a pilgrimage. On July 28 hundreds of members met at Runnymede to commemorate the granting of Magna Charta by King John on that field 742 years before. In a moving ceremony, the Association unveiled a handsome memorial, erected by the contributions of more than eight thousand American Bar members.

The meeting convened in the Guildhall for a ceremonial dinner three days later, and Sir Winston Churchill delivered a toast to the legal profession in what turned out to be his last public speech. Sir Winston spoke of Magna Carta and its place in the

Anglo-American tradition:

*Between Magna Carta and the formulation of the American Constitution, we in Britain can claim the authorship of the whole growth of the English common law. Our pioneers took it with them when they crossed the Atlantic. For many centuries in the Middle Ages, English lawyers would not admit that the law could be changed even by Parliament. It was something sacrosanct, inviolable, above human tampering, like right and wrong. This seems to have been the view of the English Chief Justice Coke. He, as early as the sixteenth century, unfolded his dream of a supreme court, above the legislature, for Great Britain. This dream vanished in our civil war; we have had some of it ourselves. The Supreme Court, however, survived and flourished in the United States. England was too compact and uniform a community to have need of it, but the Supreme Court in America has often been the guardian and upholder of American liberty before the world. Long may it continue to thrive.*

On that last night of the 1957 London meeting, Viscount Kilmuir, the lord chancellor, voiced the hope that the British and American bars would continue "this two-way traffic of legal points of view." Three years later, Viscount Kilmuir led 870 members of the bars of England, Scotland, Australia, and Canada to attend the Association's meeting in Washington, D.C. The theme of most of those who spoke at the ceremonial event before the Washington Monument in 1960 was the spirit of internationalism and the faith that the rule of law would come to govern the conflicts among nations.

In 1971 the American Bar Association again held its annual meeting in England. The optimism so frequently voiced at these meetings was in part founded on the dedication of those members of the Association who have labored, through the International Law Section and the Special Committee on World Peace through Law and otherwise, toward an international order governed by law.

In 1958 recent presidents of the Association joined in seeking to encourage the organization of the world's lawyers toward the end of bringing international controversies and international trade within a framework of law and legal institutions. The fruit of those efforts was the first meeting of the World Conference on World Peace through Law, held in Athens in 1963, at which the World Peace through Law Center was founded. The center is a permanent and independent institution which has drawn together thousands of the world's lawyers. Former Association president Charles S. Rhyne heads the center's executive committee. Mr. Rhyne was also the originator of Law Day, which has been celebrated on May 1 in the United States since 1958—in contrast with the celebrations on the same date in the U.S.S.R., where law and freedom are not the subjects of the celebration.

In September, 1965, the center sponsored an extraordinary meeting in Washington of the world's lawyers and judges for the second World Conference on World Peace through Law. That meeting was attended by 254 justices of the high courts of more than 100 nations, and by 59 heads of the ministries and departments of justice. [End quoting.]

### **CONSIDER THIS**

Eustace Mullins, in his book *The Rape Of Justice—America's Tribunals Exposed*, writes:

"We must be aware of what has happened to our legal guarantees which were written down in our *Constitution*. We must be able to challenge the stealthy takeover of our judicial system by furtive conspirators, hiding behind the international allegiances of the law merchant, the Star Chamber procedures of the equity courts, and the secret fraternal associations which dictate judicial decisions diabolically opposed to the interests of our citizens and our nation."

# Nora's Research Corner

## The Four Horsemen Of The Apocalypse

*Editor's note: The beginning of this series, Article I, Section 1, appeared in the 1/16/96 CONTACT on page 14. Here we continue with Nora's research on a subject most relevant as we enter 1996!*

### MANIPULATOR-CONTROLLERS, MERCHANTS, MONARCHS, BANKERS AND THIEVES

#### Article I—Section 2

I provided a brief history of the early formation of the international web of monopolizing, non-taxpaying merchants; their use of the monarchy to support, protect and give legitimacy to their robberies and enslavement of people; and their subsequent amassing of great wealth and power as a result. Part of this web of merchants came to be called the British East India Company (BEIC), most of whose stockholders were, or became, titled people, servants of the monarch, used especially as agents to foreign lands and in "Crown" lands.

The Committee of 300, the anti-Christ group according to Hatonn, is patterned after the BEIC, including many descendents of the original stockholders among its members. Queen Elizabeth, the Rothschilds, Henry Kissinger, George Bush and many titled and wealthy people from many countries are members of the Committee of 300, or are cohorts of this group (See Bibliography, Dr. John Coleman's book, *Conspirators' Hierarchy: The Story of the Committee of 300*). The history of the Roman Catholic Church also reveals its close ties to the rulers, merchants and bankers, their "holy" wars, etc.

These manipulator-controllers are well aware of the need for and value of propaganda (brain-washing) and control of information. In other words, an "innocent", "necessary" or "good" label is always attached to their nefarious schemes, some of which are not revealed in TRUTH for decades, if at all.

I suggested that activities such as England's Opium War with China in 1840, which they insisted was for the purpose of "free trade" and the Crusades of the Catholic Church, which they proclaimed were necessary to "reclaim the holy-land from the infidels", etc., were early examples of the White Horseman of the Apocalypse [i.e., The innocent, necessary or good (White) empire building at other's expense (Horse) and the idea, propaganda and promoters (man), which rides upon it]. It is primarily the wealthy few in power, with their obsessive greed, lies, treason and long-standing goal of a world rule, who have brought us to our present circumstances, although there have been plenty of people who have contributed to this end. The Committee of 300 is not the only group of players in this field, and the examples given are only a very few of those that could be listed. It was considered necessary by those who seek dominion over others that they first obtain control of a large base of people, property, power and resources from which to launch their take-over. Going out "conquering and to conquer", as described in the *Book of Revelation* (6:2) by the "White Horseman" has been and still is a main part of the scheme of the one-world government and one-religion promoters. It is a plan and purpose which has opposed God's Laws from the beginning.

Indeed, part of our current problems started with the drug trade, which has now become international and epidemic in proportions. It is not only debilitating to the person who indulges [*in drugs*], making them of

little use in any critical situation (such as defending your life and nation), but is also draining on the resources of those who must pay the costs (medical, lost work time, funerals, etc.). The drug business also provides a huge source of ungoverned cash for illegal and illicit activities—so much in fact that those with the money can even "purchase" a nation!

In closing Section One of Part I of this article, I revealed the fact that England's Navy bombarded the southern Coast of China to force "free trade" upon them in 1840. The commodity they were pushing was opium. Surprisingly, David Sassoon had a monopoly on opium at the time! You know from this that the war was not for the benefit of the people or for "free trade". Sassoon's sons, under Queen Victoria, became peers of the realm—barons in England. They were members of parliament, bankers and textile merchants, directors of English companies and had the freedom of the City of London (they are described as Anglo-Indian and the Rothschilds of the East)! In reading some of the "philanthropies" of the family I see they provided several synagogues, schools and hospitals in India as well as statues of the royal family, etc. They entertained the Prince of Wales and the Shah of Iran. The forefather of the family, which has many descendants, was an "Exilarch" (head of the Jews in Exile and who claimed descent from the House of David, also called "Nasi" or Prince.) living in Baghdad (formerly known as Babylon and being the seat of the Hebrew religion for many centuries). There

are others who also claim the distinction of being descended from King David of the Jews. Nevertheless, the Sassoons are related to the Rothschilds via marriage. The Rothschilds (aka Fuggers) are related to the English monarchy through marriage into the House of Hanau, which married into the House of Orange (the rulers of the Netherlands and at one time England) as well as the English Monarchy via the Montgomery family, etc. In other words, the Monarchy, many wealthy Jewish bankers, merchants, etc., are closely aligned and have used secret, treacherous and ungodly means to protect and promote each other at the expense of everyone else. The Roman Catholic Church has also been closely tied to this group, having hired the Fuggers to sell indulgences for them in the 16th Century, dubbed them "knights" of the "holy" Roman Empire, etc.

It may interest you to know that the Fuggers/Rothschilds owned one of the first international newsletters. It was an outgrowth of their trading business. They had world-wide contacts, and access to the news before anyone else through their confidential agents who, (quote:)

...reported back on any important and unusual occurrence in the territories for which they were responsible. Since the Fuggers had interests all over the Renaissance world, from China to Peru, they were the recipients of red-hot information on contemporary conditions which enabled them to invest their money correctly. (End quote.) [Ref.: *News and rumors in Renaissance Europe (The Fugger Newsletters)*]

For confirmation of the Fugger's family relationship to the Rothschilds see: *Baron James, the Rise of the French Rothschilds*, by their relative, Anka Muhlstein. I believe it was through the experiences gained and advantages taken with this early newsletter that the present controlled media had its beginnings.

Remember, the wealth necessary to purchase all of the media has its roots in the unfair and unconstitutional business and banking practices of such as the Committee of 300. America has a constitution which protects a free press and also has laws against monopolies. These laws appeared to be functioning forty years ago. There is not even the appearance of such today. We will see how public opinion has been manipulated by the owners of the news media as this series of articles unfolds.

### World War I and The Balfour Declaration

Now that you have some idea of the historical roots of the Committee of 300, I will move forward in time to World War I and the *Balfour Declaration*.

The *Balfour Declaration* was written 11/2/17 in the form of a letter from Lord Arthur Balfour to Lord Rothschild, confirming His Majesty's Government's sympathy for a national homeland for the Jews in Palestine. (Please see the attached copy of it, which was taken from the *Encyclopedia Judaica*.) I believe this declaration was a pivotal point in the strategy of those promoting the one-world government, and was admitted to be such by Chaim Wizemann, head of the Zionist Organization at the time, in his discussions with Lord Robert Cecil, who was also interested in a one-world or international government.

The circumstances surrounding the *Balfour Declaration* starkly reveal the machinations of the International Zionists and some members of the Committee of 300. (Remember, not all of those who are Jews were, or are, Zionists. In fact, at the time of the *Balfour Declaration* the Zionists

could claim only 12,000 members world-wide.) Therefore, I have chosen to use it as another historical example of the "White Horseman", going out "conquering and to conquer" (Rev 6:2). This time the propaganda for conquest was the supposed "need for a homeland for the Jews in Palestine".

The years preceding and following 1917 were years of major importance. You may recall that England, France, Russia and their allies were at war (beginning in 1914) with Germany, Turkey and their allies, called the "Central Powers". Both sides had had huge losses by 1916, most of them caused by egotistical generals out to make a name for themselves. England and France were hoping to seduce neutral America into joining with them against Germany and Turkey. Americans were opposed to joining the war in Europe and President Woodrow Wilson, in his campaign for a second term of office, had promised he would keep us out of it. Unfortunately, it appears President Wilson had some secrets in the form of some hot love-letters he had sent to a neighbor's wife. It is possible President Wilson succumbed to blackmail and did the opposite of what he had promised the America people. Events tend to show that President Wilson was dancing to the tune of his Zionist advisors. More on this later.

Most of the facts surrounding the events of 1917 and later were not known until the Landman document

was published in 1936 via a book titled *Great Britain, the Jews and Palestine*. Samuel Landman was a "Zionist Jew" who wrote the book under the "auspices of the Zionist organization". The book deals with "Zionism and the entry of the United States into the war". According to Count Leon de Poncins, Landman "proves in detail that it is the Jews, set in motion, as they themselves admit, by their own exclusively Jewish interests and possessions, who launched America into the World War". The document was not widely distributed and not taken-up by the press in the United States. Most Americans remained ignorant of it. (Ref.: *State Secrets*, by Count Leon de Poncins)

I will back up and provide some historical background to events. Aside from German acquisitions, which I will not get into, there had been heavy massacres of Armenian and Bulgarian people by the Turks over a long period of time. A secret society called the "Young Turks" was promoting the idea of "Turkey for the Turks", and causing difficulties for several other

nationalities within the Ottoman Empire, but especially Armenians and Bulgarians. The Christians appeared to have suffered the most. The "Young Turks" were not the only problem. There were several fanatical leaders in Turkey preceding World War I. Armenia had representatives in several nations trying to gain some help and to influence world opinion against the unmerciful slaughter of their people. They were not heard! It was not until Germany began to show an interest in Turkey (they obtained rights to build the Baghdad railway—all part of the banker's plans) that the "Allies" became alarmed over the possibilities of the situation. England refused to deliver two battleships to Turkey which they had ordered and paid for.

Germany sent two of her battleships to Turkey to replace them and the hostilities began with Turkey. Of course, all of the "Allies" had interests in the area and plans for carving it up between them if successful. Russia had interests in the Black Sea area, the Dardanelles and Armenia; France had interests in Algeria and Syria; England with Egypt, the Sudan, the Suez Canal, etc.; and the Zionists wanted Palestine. (It is most interesting that, at the time our Congress was agreeing in the late 1980s that the Jews had experienced a "genocide" in World War II under the Nazi regime, the Armenians asked our Congress to acknowledge that they too had experienced a genocide prior to World War I. Our Congress, under heavy Jewish lobbying, denied their request.)

The First World War was only one focus of events on the world stage in 1914. Russia was having her own problems with the Mensheviks and Bolsheviks. She did not remain in a position to provide strong support to England and France against Germany and Turkey. In fact, it appears that the "Russian Revolution", starting in March 1917, made it seem even more important to England and France that they find some way to bring the United States into the war. I say "seem important" because there were other options, such as a peace negotiation with Germany which the Allies refused to consider.

According to Myron Fagan, a New York playwright, who had frequent contacts with influential Zionists in the motion picture industry, the Rothschild stooges had set up a Congress in Vienna in which they had tried to set up the first League of Nations (this was in the early 1800s). The "idea was torpedoed by the Czar of Russia, and the Rothschilds declared they would destroy that family". I was unable to confirm this information except that a so-called "Congress" did occur in Vienna, at which only a few participants, calling themselves the "Great Powers", had secret talks, to the disgust of every other participant. There is also information that the Russian Czar was very wary at the time of any encroachment on his sovereignty. (See Bibliography for information on Myron Fagan's audio tapes and the Congress of Vienna.) It is certainly true that the Zionists of 1917 had no regard for Czar Nicholas II, as he did not approve their plan to take over Palestine. Czar Nicholas II was very adamant about protecting the rights of the Russian Orthodox Church members already in Palestine, although he did not object to Jews settling there also.

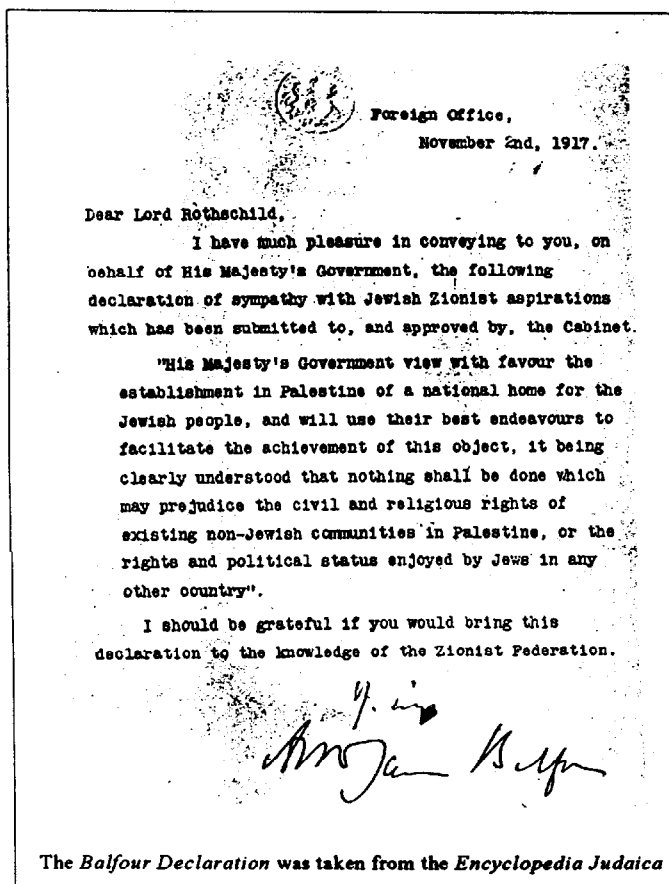
(Remember, the Bolshevik coup of October 1917, and later assassination of Czar Nicholas II and most of his family was a Jewish operation. Remember too that this family, the "Romanovs" had placed considerable wealth under the management of the London Jewish bankers which has never been returned to the Russian people.)

The timing of the Bolshevik coup was, as I said, important to the Allies and their hope for total victory over the Central Powers. Russia was no longer able to support them and apparently the Jewish Bankers had their own agenda. It was also a very opportune time for the Bolsheviks to take over Russia, with England, France, Germany, Turkey and soon the United States having their hands full elsewhere.

Further, Myron Fagan claims that the Rothschilds got Adam Weishaupt to redesign the *Protocols of Zion*. He is said to have completed his task and officially organized the Illuminati 5/1/1776. The plan was to "turn the goyim into opposing armed camps. Incidents were to be provided which would cause them to destroy themselves." The idea was to make war and make it so unbearable that humanity would demand an international league of nations to prevent another war. Of course, the "Illuminati" planned to rule that league of nations. If it is true that Adam Weishaupt redesigned the *Protocols of Zion*, it would be confirmed by Mr. Pierre Plantard, of the Priore de Sion, in the book, *Holy Blood, Holy Grail*, where he stated that the *Protocols* were signed by a Mason of the 33rd degree, for it appears that Weishaupt and the "Illuminati" were the secret superiors of Freemasonry in 1776. (Please see my articles on Freemasonry for further information.) According to Mr. Fagan, some descendants of the original "Illuminati" are the hierarchy in the United States today (i.e., the Council on Foreign Relations, Trilateral Commission, Think Tanks, Foundations, etc.)

There is a superb article written by Robert John titled: "Behind the *Balfour Declaration*: Britain's War Pledge to the Rothschilds" in the Winter 1985-86 issue of *The Journal of Historical Review*. In it Mr. John provides documented evidence of how the *Balfour Declaration* came to be—the pressure, manipulations, secret discussions and treachery involved. (I am indebted to one called "Clarity" for providing me with this and many other journals. Thank you.) I rely upon Mr. John's research in this article and recommend that you obtain and read it. Unfortunately space does not allow reporting the full events.

It is very interesting that the Zionists had been trying for some time to negotiate with Turkey for the land of Palestine—promising all kinds of advantages to Turkey. The Zionists even offered to pay Turkey for the country, but were refused on the grounds that the Arabs, to a man, rejected the idea. The Zionists eventually gave up on Turkey, having also tried to wrangle some plan with Germany for Palestine after the war in

the event Germany was successful, including financial and other support from the Jews. Nevertheless, it became clear to them that their best leverage was with England, and most efforts were eventually focused in that direction. I say "most efforts", because the Zionists and Bankers still used the potential threat of siding with Germany in order to obtain their ends. They were not working with the "Allies" out of any patriotic or loyal spirit. It is astounding how quickly Prime Minister Asquith's government in London was replaced, with the help of King George V, by pro-Zionists Lloyd George and Lord Balfour, when push came to shove over the issue of a "homeland in Palestine for the Jews". (Ref.: Robert John's article; see Bibliography.)

One of the primary arguments for a "homeland" for the Jews had been their reported persecution in other countries, and remember we are talking about the years preceding and during World War I. I tried to locate information on this "persecution". It appears that most of the Judaists preferred assimilation in other countries, and were upset by the Zionist's push for a separate homeland. In fact, the Jews of Turkey may have had some difficulties at the time of the "Young Turks", but the primary sufferers were Christians, Armenians and Bulgarians. Ben-Gurion, who was to become the first president of Israel in 1948, lived in Turkey at Constantinople in 1914 when World War I broke out. He advocated loyalty to Turkey! It is said he left Turkey in 1915 due to anti-semitism in Turkey at that time. However, when you consider that the Zionists had been trying to gain Palestine for themselves from the Turks, any anti-semitism is understandable. Further, there have been many comments about the "pogroms" against the Jews in Russia during the late 19th and early 20th centuries. It is true the Jews were only allowed to live in rural areas, but they had a very large space to live in. The problem was they were not farmers by choice or inclination and could not earn much money as merchants in the rural areas. It is also true there were cases of blood-libel brought against some Jews, causing disturbances, and the Czar's government had outlawed all religions except that of the Russian Orthodox Church for awhile. However, in this case, other Protestant groups and Catholics were as badly persecuted as were the Jews. I could not find out what was happening to the Mohammedans in Russia at the time. I do not pretend to have all of the facts on the treatment of the Jews in Russia. It does appear that they were not the only ones being persecuted, and not the most persecuted in all cases. They did have powerful groups lobbying for them in England, France, Germany and the United States! Given the financial wealth and actual autonomous power of these "Jewish" merchant princes, one can hardly consider that Jews as a group need protection from anyone except this powerful group among them that appears to have control of their lives, and much of our own lives.

It should also be noted here that Jews had lived peacefully in "Palestine" with Arabs and others under Ottoman rule for centuries. Turkey already had a policy which allowed individual Jews to settle in the Ottoman Empire, prior to World War I. The Rothschilds had been heavy supporters of Jewish settlements in Palestine for a number of years. Also, England had offered land in Africa (actually in Kenya, but through a misunderstanding it was reported as Uganda) for Jewish settlement. The head of the Zionist Organization, Theodore Herzl, after some disappointments in his hope for Palestine, was willing to consider this offer as a temporary measure. He received opposition from all sides and "died suddenly of a heart attack" in 1904. Chaim Weizmann took over as head of the Zionist

Organization upon Herzl's death. Weizmann was a highly effective and therefore influential promoter of a "homeland for the Jews in Palestine."

How did the Zionists force the "Allies" to promise them the land of Palestine in the event of a successful conclusion of the war? There are a great many stories to tell in that regard. It appears that they became noticeably more successful in their efforts with the arrival of a newcomer among the diplomats and Zionists who were struggling with the problem. Consider alone the situations that are public knowledge: (1) Sir Sykes and Mr. Picot had already been working on a plan for the distribution of Turkey's land after the war. Many representatives from many countries had already been involved in this work. (2) The Zionists wanted all of Palestine, but other countries, notably France, had interests in it. (3) Russia was adamant about protecting the rights of their people already in Palestine, but was losing status and influence due to the revolution in their country. (4) The Zionists actually did not represent more than 12,000 members, and many powerful

Jews were against the Zionists' plan for Palestine. (5) The "Allies" were running out of funds and needed the support of the United States or the Jewish Bankers if they were to continue to their "acceptable" total victory. Into this diplomatic nightmare steps James Malcolm.

James Malcolm was reported to be a representative of the Armenian people in London. He also had set up a "Russia Society" to promote Russia in England. It seems that he just happened to make a suggestion to these government diplomats and Zionists for a successful outcome of their dilemma which opened all doors to him. What was his suggestion? Both Count Leon de Poncins and Robert John in their articles on the *Balfour Declaration* discuss the Landman Document wherein James Malcolm's role is described. The Landman Document had been published under the auspices of the Zionist Organization in 1936. It seems that Mr. Malcolm suggested that the way to get the United States into the war was to make a bargain with the Zionists and the influential Jews in Washington—bring the U.S. into the war on the side of the "Allies" and you get Palestine after the war! It is documented

through the records of several of the participants to these "diplomatic discussions" that as soon as the Zionists received the oral commitment from the "Allies" for Palestine and the information was passed to influential Zionists in New York, America was covered with the necessary propaganda to change people's minds. Did the Zionists make all the difference? They seem to think so. It is possible, given their close association with President Wilson, control of the media and the fact they were co-religionists with the Bankers. This is not to say that other means of persuasion had not been used as well, such as the sinking of merchant ships and the *Lusitania* by the Germans—but my story is getting too long.

I wondered how a man in James Malcolm's stated position and background would have had the necessary knowledge and status to bring about such an event. It was given out as a "spontaneous act" and that the Zionists complained about "this stranger" among them. It appears from a footnote in Robert John's article that James Malcolm was staying "at the home of his agent in London", Sir Sassoon. Further, Mr. Malcolm had lived in Sir Albert (Abdullah) Sassoon's household beginning in 1881 in order to obtain his education in England. Given our present knowledge of the wealth and power of the Sassoons, it would appear to me that, instead of the Sassoons being the agent of Mr. Malcolm, it was really the other way around. An Exilarch (of the Jewish House of David) is much more likely to be the one to bring the rest of the Jews together on any issue considered important to them than an ineffectual representative of the Armenian people. (You may be able to see from the perspective of the year 1996, that the ownership of Palestine was a critical part of the plan for a one-world government and one-world religion under the Jews.)

On the propaganda issue it is important to know that the undersea cable connecting the United States to Germany had been cut by the British early in World War I, according to Robert John, who also reports on the activities of the British propaganda agent, Sir Albert Parker, in the U.S. Sir Parker, in his "secret *American Press Review* for October 11, 1916, before the Presidential election [wrote]: 'This week supplies satisfactory evidence of the permeation of the American Press by British influence'." (!) Surprisingly we even read about the kinds of propaganda dished-out by the "British" in Robert John's article, including the grossest garbage proclaiming the Germans were using dead bodies to make glycerine and soap! This low level propaganda proved so effective it was used again in World War II.

According to Robert John, President Wilson sent Ambassador Henry Morgenthau, Sr. to Turkey to sound out possibilities of peace. America was not at war with Turkey. Mr. Morgenthau (a Jew and Zionist) never made it to Turkey. According to reports gathered by Robert John from people involved, Morgenthau and three other Jews met at Gibraltar and scratched the project. Why he was not fired immediately is a rather large question. Mr. Morgenthau's son, Henry Morgenthau, Jr. was to become the powerful Secretary of the Treasury under Franklin Roosevelt during World War II, usurping even the role of the Secretary of War and the Secretary of State, and revealing again some very questionable, persistent and powerful influences at work which were by-passing the United States "government by the people".

According to many articles on the Presidency of Woodrow Wilson, the Jewish advisors surrounding him included Colonel E.M. House, Judge Louis Brandeis, Felix Frankfurter (Brandeis' nephew), Henry Morgenthau, and Bernard Baruch—all strong Zionists and many also influential later in President Franklin Roosevelt's administration during World War II. President Wilson certainly appeared to be "their boy" in the White House for more reasons than World War I,



including the passage of the Bank Act of 1913, which brought the U.S. under the Federal Reserve System—a private corporation pushed through Congress with the help of the Jewish Bankers Schiff and Warburg. It is interesting that President Wilson would later be credited with the following statement (quote):

There is a power so organized, so subtle, so complete, so pervasive that they had better not speak above their breath in condemnation of it. (End quote. Reported by A. Ralph Epperson in his book, *The New World Order*.)

The subject of a "homeland for the Jews in Palestine" was tenaciously pursued on all fronts and with all governments by the Zionists. The details of such a project remained undefined and appeared in some instances to be framed according to the beliefs and philosophies of those receiving the arguments, as admitted by Chaim Weizmann and reported by Robert John. The range of meanings to the proposed "homeland" included, but was not limited to: (1) An immigration of dispossessed Jews to Palestine based upon the area's population absorption rate. (2) An autonomous Jewish government of the Jews among the Palestinians. (3) No infringements of the rights and property of those already in Palestine was to occur. (4) A company was to be set up to be used exclusively for the Jews in the development of Palestine. (5) The best plan was for Palestine to be administered by an international group or under an English protectorate. (6) Palestine was to become a regularly constituted government by the Jews, for the Jews, etc. The full intent, or the exact intent was never clarified to the public. However, the *Balfour Declaration* was being considered and various versions of it being drafted for a year before it was signed and sent to Lord Rothschild by Lord Arthur Balfour, 11/02/17. There are records to show that President Wilson's "close associates" were involved in the final drafting and approval of it. It was the result of the secret "gentlemen's agreement of 1916" when the "Allies" had promised Palestine to the Jews in return for their influence in bringing America into the war, and the insistence of the Rothschilds and Zionists that a written statement be made confirming the agreement. In 1916 America had not yet entered the war, the land of Palestine was still the possession of Turkey and the results of World War I were not yet known! The War ended 11/11/18. It would not be until 6/30/22 that the U.S. Congress would adopt a resolution subscribing to the tenets of the *Balfour Declaration*. The English Parliament had not had a chance to discuss it, much less vote upon it as late as 1922.

While few understood the significance of the *Balfour Declaration*, two influential persons in England who tried to understand, and who were opposed to "regarding the Jews as a separate race and distinct nationality" were Edwin Montagu and Lord Curzon. Robert John extracts some statement from Lord Curzon's memorandum titled: "The Future of Palestine", which he circulated to the Cabinet 10/26/17. (Quote:)

I am not concerned to discuss the question in dispute between the Zionist and anti-Zionist Jews...I am only concerned in the more immediately practical questions:

(a) What is the meaning of the phrase "a national home for the Jewish race in Palestine", and what is the nature of the obligation that we shall assume if we accept this as a principle of British policy?

(b) If such a policy be pursued what are the chances of its successful realization?

If I seek guidance from the latest collection of circulated papers (*The Zionist Movement*, G.-164) I find a fundamental disagreement among the authorities quoted there as to the scope and nature of their aim.

A "national home for the Jewish race or people" would seem, if the words are to bear their ordinary meaning, to imply a place where the Jews can be

reassembled as a nation, and where they will enjoy the privileges of an independent national existence. Such is clearly the conception of those who, like Sir Alfred Mond, speak of the creation in Palestine of "an autonomous Jewish state," words which appear to contemplate a State, i.e., a political entity, composed of Jews, governed by Jews, and administered mainly in the interests of Jews...

The same conception appears to underlie several other of the phrases employed in these papers, e.g., when we are told that Palestine is to become "a home for the Jewish nation", "a national home for the Jewish race", "a Jewish Palestine", and when we read of "the resettlement of Palestine as a national centre", and "the restoration of Palestine to the Jewish people," all these phrases are variants of the same idea, viz., the re-creation of Palestine as it was before the days of the dispersion.

On the other hand, Lord Rothschild, when he speaks of Palestine as "a home where the Jews could speak their own language, have their own education, their own civilization, and religious institutions un-

expropriated for Jewish immigrants, or to act merely as hewers of wood and drawers of water to the latter. (End quote.)

In all of this keep in mind that the greater percentage of the Jewish population at the time were not Semites, they were Ashkenazi/Khazarian Jews descended from Noah's son, Japheth, not Shem, and therefore not from Abraham. They did not become associated with Judaism until the 8th century A.D., and therefore had no hereditary or "scriptural" claim to the ancient land of Judea.

As soon as the United States entered the war, England placed a large number of her troops in the battle to secure Palestine for the Jews. The U.S. was not only manipulated into the war in order to allow this maneuver, but President Wilson also sent \$190,000,000.00 to the Red-German Jews/Bolsheviks to aid in their take-over of Russia! (Can you imagine how much usury the Jewish Bankers gained alone by this loan to the U.S. Government for this purpose?) Czarist Russia was still an ally at the time. The propaganda fed to the American public, according to

Robert John, was that the Russians were "becoming free" under the Bolsheviks. (That man on the White Horse again.) The fact is that a revolution had taken place in Russia, March 1917, and the people had gained some changes under Czar Nicholas II. There were still some opposing groups in the country, including many German Jew infiltrators and agitators. According to several authors, the Bolsheviks, with the help of Rothschild's agent in America, banker Jacob Schiff and his money; Trotsky's return to Russia with 300 armed Bolshevik terrorists out of New York; and Lenin's return to Russia from Switzerland via a sealed train crossing Germany, staged a coup in October 1917 (within a month of the signing of the *Balfour Declaration*) which took over the government in Petrograd and put the Red-German Jews/Bolsheviks in power in Russia. The Czar and most of his family were taken and later killed (1918).

Those who should have sounded an alarm and prevented the foregoing subversive activities were: (1) Sir William Wiseman, a Jew, head of British Military Intelligence Service in the United States and a pro-Zionist; and (2) One of the Warburg brothers, a Jew and head of secret intelligence in Germany at the time. The United States did not yet have an "intelligence" service.

Historian Nesta H. Webster, in her book, *World Revolution*, had this to say about it

der the protection of Allied governments," seems to postulate a much less definite form of political existence, one, indeed, which is quite compatible with the existence of an alien (so long as it is not Turkish) government.

Now what is the capacity as regards population of Palestine within any reasonable period of time? Under the Turks there is no such place or country as Palestine, because it is divided up between the *sanjak* of Jerusalem and the *vilayets* of Syria and Beirut. But let us assume that in speaking of Palestine in the present context we mean the old scriptural Palestine, extending from Dan to Beersheba, i.e., from Baniyas to Bir es-Sabi...an area of less than 10,000 square miles. What is to become of the people of this country, assuming the Turk to be expelled, and the inhabitants not to have been exterminated by the war? There are over a half a million of these, Syrian Arabs—a mixed community with Arab, Hebrew, Canaanite, Greek, Egyptian, and possibly Crusaders' blood. They and their forefathers have occupied the country for the best part of 1,500 years. They own the soil, which belongs either to individual landowners or to village communities. They profess the Mohammedan faith. They will not be content either to be

At the outbreak of the March revolution of 1917 the Bolsheviks were, however, completely in the minority amongst the various revolutionary groups—a fact frankly admitted by the Bolsheviks themselves (according to Trotsky, *The History of The Russian Revolution to Brest-Litovsk*, Allen Unwin, page 62). A report on the *White Paper on Bolshevism* asserts that 90 percent of the population were in favour of the monarchy (date of October 14, 1918)—and it was only by a force of systematic deception, and finally by force of arms, that the party which might be described in Bakunin's words, "the German-Jew Company", the "red bureaucracy", succeeded in establishing its domination. Such popularity as it had achieved had been won by the old method of the conspiracy—promising one thing and doing precisely the opposite. Thus according to the word of command of the Secret Societies—"Constitution"—the Bolsheviks had clamored for a Constituent Assembly, and their first act was to dissolve the assembly elected by Universal suffrage; exploiting the war-weariness of the troops they had promised the people

The Bolshevik revolution has in fact followed out the code of Weishaupt in every point—the abolition of monarchy, abolition of patriotism, abolition of private property and of inheritance, abolition of marriage and morality, and abolition of all religion.

### Page 295

Quoted from *The Communist*, a newspaper published in Kharkoff (number for April 12, 1919), "we find Mr. M. Cohan boasting that,....without exaggeration, it may be said that the great Russian social revolution was indeed accomplished by the hands of the Jews....It is true that there are no Jews in the ranks of the Red Army as far as privates are concerned, but in the committees and in Soviet organizations, as Commissars, the Jews are gallantly leading the masses of the Russian proletariat to victory....The symbol of Jewry, which for centuries has struggled against capitalism, had become the symbol of the Russian proletariat, which can be seen even in the fact of the adoption of the red five-pointed star, which in former times, as it is well known, was the symbol of Zionism and Jewry." Bolshevism took on the name of Communism in 1918, and Russia began to be called the "Red Communists", or "Reds". (In fact China was also called "Red China" after their Communist Revolution.) With this event, and the Bolshevik revolution, the "Second Horseman of the Apocalypse" gallops into full world view, although the Communist philosophy had already had some development, promotion and distribution under many labels, through many organizations and leaders over many decades, starting with Adam Weishaupt in 1776. (Rev. 6:3 & 6:4; quote:)

And when he had opened the second seal, I heard the second beast say, come and see. And there went out another horse that was Red; and power was given to him that sat thereon to take peace from the earth, and that they should kill one another: and there was given unto him a great sword. (End quote.) (Ref.: King James Version of the *Holy Bible*.)

Undoubtedly the meaning of the "red horse" and "great sword" must imply a great deal of bloodshed. In fact, Communism made no bones about being an atheistic philosophy. The White and First Horseman did not follow God's Laws. This Second, Red Horseman, does not pretend to even believe in God.

Historian A. Ralph Epperson, in his book, *The New World Order*, repeats some words of Alexander Solzhenitsyn on the subject of the great bloodshed of the Bolshevik Revolution, published in *Summit Journal*, December (1987). Alexander Solzhenitsyn is a Russian born historian and philosopher (quote:)

Over half a century ago, while I was still a child, I recall hearing a number of old people offer the following explanation for the disasters [meaning the disasters of the Communist Revolution that killed up to 42,000,000 Russians] that had befallen Russia.

"Man has forgotten god; that's why all this has happened".

Since then I have spent well-nigh 50 years working on the history of our revolution.

But if I were asked today to formulate as concisely as possible the main cause of the ruinous revolution

that swallowed up some 60 million of our people, I could not put it more accurately than to repeat:

"Men have forgotten God; that's why all this has happened". (Author's parenthesis.) (End quote.) (I am indebted to my friend Brent for the loan of this book. Thank you.)

It appears from the above there is some difference of opinions as to the actual number lost in the Bolshevik revolution. In any event, the numbers are so huge it is certain that a genocide was intended against the Russian people, most of whom were Christian. This greater "holocaust" was perpetrated and led by the Bolshevik Jews.

Keep in mind as we go along that all the while the Zionists were demanding a "homeland for the Jews", from 1917 through the Second World War and up to and beyond the establishment of the present state of Israel in 1948, the Bolshevik/Khazarian/Zionist Jews were in control of Russia, having deprived at least 42,000,000 Russians of their lives and property. This means that the Jewish leaders (or those who claimed to be "Jews") in Russia after October 1917, were some of the greatest persecutors of all times. It also means, among other things, that if Jews were persecuted in Russia after 1917 (as claimed by Zionists) it was at the hands of those Khazarian/Communist/Zionist Jews who claim the same heritage! One might wonder, with all of Russia under their control, why the "great need" for a "homeland for the Jews in Palestine" after 1917—unless the purpose was indeed a part of the plan for a one-world religion and one-world government under the "Jews"! Consider how dearly Americans have paid to transport "persecuted Jews" from "Jewish" controlled Russia to "Jewish" controlled Palestine. This too has only been a small part of the plan, having to do with the dismantling of America. Now you know what a controlled media can accomplish, and how easy it was to rob Americans, Russians and Palestinians in this case.

Further, for those of you who think the one-world religion and government under the Khazarian/Communist/Zionist Jews will really have anything to do with brotherhood or God, forget it!

Article II of this series will cover some of the events following World War I, including the League of Nations and the part played by the Zionists and Freemasons in its preparation.

Thomas Paine is THE man unto which I offer my bended knee for striving without rest to bring America into enlightenment and to offer you a true *REPUBLIC*. Since I haven't space to adequately eulogize and honor this man, then perhaps since we have been writing on "Church Order" we might share his singular recognition as offered in his *AGE OF REASON*.

Let us please just share his own thoughts as put to print for it is LONG PAST time that you see it and think upon the wisdom offered.

## THE AGE OF REASON

by Thomas Paine

It has been my intention, for several years past, to publish my thoughts upon Religion. I am well aware of the difficulties that attend the subject; and from that consideration, had reserved it to a more advanced period of life. I intended it to be the last offering I should make to my fellow-citizens of all nations; and that at a time when the purity of the motive that induced me to it could not admit of a question, even by those who might disapprove the work.

The circumstance that has now taken place in France of the total abolition of the whole national order of priesthood, and of everything pertaining to compulsive systems of religion, and compulsive articles of faith, has not only precipitated my intention, but rendered a work of this kind exceedingly necessary; lest, in the general wreck of superstition, of false systems of government and false theology, we lose sight of morality, of humanity and of the theology that is true.

As several of my colleagues, and others of my fellow-citizens of France, have given me the example of making their voluntary and individual profession of faith, I also will make mine; and I do this with all that sincerity and frankness with which the mind of man communicates with itself.

I believe in one God, and no more; and I hope for happiness beyond this life.

I believe in the equality of man, and I believe that religious duties consist in doing justice, loving mercy, and endeavoring to make our fellow creatures happy.

But, lest it should be supposed that I believe many other things in addition to these, I shall, in the progress of this work, declare the things I do not believe, and my reasons for not believing them.

I do not believe in the creed professed by the Jewish Church, by the Roman Church, by the Greek Church, by the Turkish Church, by the Protestant Church, nor by any church that I know of. My own mind is my own church.

All national institutions of churches—whether Jewish, Christian or Turkish—appear to me no other than human inventions, set up to terrify and enslave mankind, and monopolize power and profit.

I do not mean to condemn those who believe otherwise. They have the same right to their belief as I have to mine. But it is necessary to the happiness of man that he be mentally faithful to himself. Infidelity does not consist in believing, or in disbelieving; it consists in professing to believe what he does not believe.

It is impossible to calculate the moral mischief, if I may so express it, that mental lying has produced in society. When a man has so far corrupted and prostituted the chastity of his mind as to subscribe his professional belief to things he does not believe, he has prepared himself for the commission of every other crime. He takes up the trade of a priest for the sake of gain, and in order to qualify himself for that trade, he begins with a perjury. Can we conceive any thing more destructive to morality than this?

Soon after I had published the pamphlet *Common Sense*, in America, I saw the exceeding probability that a revolution in the system of government would be followed by a revolution in the system of religion. The adulterous connection of church and state—has so effectually prohibited by pains and penalties every discussion upon established creeds, and upon first principles of religion, that until the system of government should be changed, those subjects could not be brought fairly and openly before the world, but that whenever this should be done, a revolution in the system of religion would follow. Human inventions and priestcraft would be detected, and man would return to the pure, unmixed and unadulterated belief of one God, and no more.

Every national church or religion has established itself by pretending some special mission from God, communicated to certain individuals. The Jews have their Moses; the Christians their Jesus Christ, their apostles and saints; and the Turks their Mahomet—as if the way to God was not open to every man alike.

Each of those churches show certain books, which they call revelation, or the word of God. The Jews say that their word of God was given by God to Moses, face to face; the Christians say that their word of God came by divine inspiration; and the Turks say that their Word of God (the *Koran*) was brought by an angel from heaven. Each of those churches accuses the other of unbelief; and for my own part, I disbelieve them all.

As it is necessary to affix right ideas to words, I will, before I proceed further into the subject, offer some observations on the word revelation. Revelation, when applied to religion, means something communicated immediately from God to man.

No one will deny or dispute the power of the Almighty to make such a communication, if He pleases. But admitting, for the sake of a case, that something has been revealed to a certain person, and not revealed to any other person, it is revelation to that person only. When he tells it to a second person, a second to a third, a third to a fourth, and so on, it ceases to be a revelation to all those persons. *It is revelation to the first person only, and hearsay to every other, and consequently they are not obliged to believe it.*

It is a contradiction in terms and ideas, to call anything a revelation that comes to us at second-hand, either verbally or in writing. Revelation is necessarily limited to the first communication—after this it is only an account of something which that person says was a revelation made to him; and though he may find himself obliged to believe it, it cannot be incumbent on me to believe it in the same manner, for it was not a revelation made to me, and I have only his word for it that it was made to him.

When Moses told the children of Israel that he received the two tablets of the commandments from the hand of God, they were not obliged to believe him, because they had no other authority for it than his telling them so; and I have no other authority for it than some historian telling me so. The commandments carry no internal precepts, such as any man qualified to be a lawgiver, or a legislator, could produce himself, without having recourse to supernatural intervention.

When I am told that the *Koran* was written in heaven and brought to Mahomet by an angel, this comes too near the same kind of hearsay evidence and second-hand authority as the former. I did not see the angel myself and, therefore, I have a right not to believe it.

When also I am told that a woman called the Virgin Mary, said, or gave out, that she was with child without any cohabitation with a man, and that her betrothed husband, Joseph, said that an angel told him so, I have a right to believe them or not; such a circumstance required a much stronger evidence than their bare word for it; but we have not even this—for neither Joseph nor Mary wrote any such matter themselves; it is only reported by others that they said so. It is hearsay upon hearsay, and I do not choose to rest my belief upon such evidence.

It is curious to observe how the theory of what is called the Christian Church sprung out of the tail of the heathen mythology. A direct incorporation took place in the first instance, by making the reputed founder to be celestially begotten. The trinity of gods that then followed was no other than a reduction of the former plurality, which was about twenty or thirty thousand—the statue of Mary succeeded the statue of Diana of Ephesus. The deification of heroes changed into the canonization of saints. The mythologists had gods for everything; the Christian mythologists had saints for everything, the Church became as crowded with the one as the Pantheon had been with the other, and Rome was the place of both. The Christian theory is little else than the idolatry of the ancient mythologists, accommodated to the purposes of power and revenue; and it yet remains to reason and philosophy to abolish the amphibious fraud.

Nothing that is here said can apply, even with the most distant disrespect, to the real character of Jesus Christ. He was a virtuous and an amiable man. The morality that he preached and practised was of the most benevolent kind; and though similar systems of morality had been preached by Confucius, and by some of the Greek philosophers, many years before; by the Quakers since; and by many good men in all ages, it has not been exceeded by any.

Jesus Christ wrote no account of himself, of his birth, parentage, or anything else. Not a line of what is called the *New Testament* is of his writing. The history of him is altogether the work of other people; and as to the account given of his resurrection and ascension, it was the necessary counterpart to the story of his birth. His historians, having brought him into the world in a supernatural manner, were obliged to take him out again in the same manner, or the first part of the story must have fallen to the ground.

The resurrection and ascension, supposing them to have taken place, admitted of public and ocular demonstration, like that of the ascension of a balloon, or the sun at noon-day, to all Jerusalem at least. A thing which everybody is required to believe, requires that the proof and evidence of it should be equal to all, and universal; and as the public visibility of this last related act was the only evidence that could give sanction to the former part, the whole of it falls to the ground, because that evidence never was given. Instead of this, a small number of persons, not more than eight or nine, are introduced as proxies for the whole world to say they saw it, and all the rest of the world are called upon to believe it. But it appears that Thomas did not believe the resurrection, and, as they say, would not believe without having ocular and manual demonstration himself. *So neither will I*, and the reason is equally as good for me, and for every other person, as for Thomas.

The best surviving evidence we now have respecting this affair is the Jews. They are regularly descended from the people who lived in the times this resurrection and ascension is said to have happened, and they say, it is not true. It has long appeared to me a strange inconsistency to cite the Jews as a proof of the truth of the story. It is just the same as if a man were to say, I will prove the truth of what I have told you by producing the people who say it is false.

That such a person as Jesus Christ existed, and that he was crucified—which was the mode of execution at that day—are historical relations strictly within the limits of probability. He preached most excellent morality, and the equality of man; but he preached also against the corruptions and avarice of the Jewish priests, and this brought upon him the hatred and vengeance of the whole order of priesthood. The accusation which those priests brought against him was that of sedition and conspiracy against the Roman government, to which the Jews were then subject and tributary; and it is not improbable that the Roman government might have some secret apprehensions of the effects of his doctrine, as well as the Jewish priests. Between the two, this virtuous reformer and revolutionist lost his life.

But if objects for gratitude and admiration are our desire, do they not present themselves every hour to our eyes? Do we not see a fair creation prepared to receive us the instant we are born—a world furnished to our hands, that cost us nothing? Is it we who light up the Sun, and who pour down the rain, and fill the Earth with abundance? Whether we sleep or wake, the vast machinery of the universe still goes on.

I know that this bold investigation will alarm many, but it would be paying too great a compliment to their credulity to forbear it upon that account; the times and the subject demand it to be done. The suspicion that the theory of what is called the Christian Church is fabulous is becoming very extensive in all countries; and it will be a consolation to men staggering under that suspicion, and doubting what to believe and what to disbelieve, to see the object freely investigated.

When the Church mythologists established their system, they collected all the writings they could find and managed them as they pleased. It is a matter altogether of uncertainty to us whether such of the writings as now appear under the name of the *Old and New Testaments* are in the same state in which those collectors say they found them, or whether they added, altered, abridged or dressed them up.

Be this as it may, they decided by vote which of the books out of the collection they have made should be the *Word of God*, and which should not. They rejected several; they voted others to be doubtful such as the books called the Apocrypha; and those books which had a majority of votes were voted to be the *Word of God*. Had they voted otherwise, all the people, since calling themselves Christians, had believed otherwise—for the belief of the one comes from the vote of the other. Who the people were that did all this, we know nothing of; they called themselves by the general name of the Church, and this is all we know of the matter.

When Samson ran off with the gate-posts of Gaza, if he ever did so (and whether he did or not is nothing to us), or when he visited his Delilah, or caught his foxes, or did anything else, what has revelation to do with these things? If they were facts, he could tell them himself, or his secretary, if he kept one, could write them, if they were worth either telling or writing; and if they were fictions, revelation could not make them true; and whether true or not, we are neither the better nor the wiser for knowing them. *When we contemplate the immensity of that Being who directs and governs the incomprehensible WHOLE, of which the utmost ken of human sight can discover but a part, we ought to feel shame at calling such paltry stories the Word of God.*
