# Confirmation About Fake Comet?

## FAMILIES LIMITED IN SEEKING DAMAGES ON MANDATORY VACCINES

From the February 14 issue of the *MODESTO* (California) *BEE*, [quoting:]

WASHINGTON—The seizures started only hours after 6-week-old Laura Meyer, a healthy baby with a beautiful smile, got her first vaccination. Paralyzing her brain and her body, the seizures would continue, unresponsive to drugs or treatment, for the rest of her life. At age 11, she recently died during a seizure believed to be caused by the vaccine, which was supposed to protect her from whooping cough. Laura is one of thousands of healthy children who has died or been injured after receiving a mandatory childhood vaccination. She also was among the first to have her medical care paid for through the National Vaccine Injury Compensation Program, a little-known system set up as an alternative to costly, time-consuming lawsuits against the drug companies which make the vaccines.

Of the more than 20 million children vaccinated every year, an estimated 500 suffer serious reactions and 75 die, the U.S. Centers for Disease Control and Prevention has determined. [Of course, *THEY* have a vested interest in presenting very LOW figures.] Since it began in 1988, the program has awarded \$605 million to 1,858 parents or their lawyers.

The money comes from an excise tax on the vaccines. A type of civil justice reform, the program started partly in response to drug companies' threats to stop making vaccines. [Oh no!—That would really upset the NWO depopulation program!] Though injuries are rare, they were occurring often enough that the companies feared lawsuits would drive them out of business. [I would imagine it's pretty darned hard to drive a drug company out of business. They make millions a day just on aspirin-related products!]

The lawsuits also proved difficult from the parents' perspective. To prevail, they had to prove a child's injury was caused by the vaccine, which was sometimes impossible. In this system, they don't have to prove the drug company did anything wrong—only show that their child was injured. Now before parents can sue drug companies, they must first go through the compensation program and reject its decision or award.

The program has its detractors. "It has been very successful in protecting the drug companies from lawsuits, but at the expense of children," Kristine Severyn, director and founder of Ohio Parents for Vaccine Safety. Through December 1995, 5,004 cases had been filed. Of those, 884 families received funding, and 2,337 were dismissed by a special attorney the court appoints to review the claims. The rest still are pending.

## RADIATION INCREASES LATER CANCER RISK

Mainstream medicine has this to offer, from the March 21 issue of *THE ORLANDO SENTINEL*, [quoting:]

BOSTON—Women who had childhood Hodgkin's disease and were treated with radiation have a much higher risk of developing breast cancer and some other types of solid tumors, according to a study published in today's *New England Journal of Medicine*. The research, which shows a breast cancer rate 75 times

higher than in the general population, suggested that women treated for Hodgkin's should be regularly screened for breast cancer, according to a seven-member team led by Dr. Smita Bhatia of the University of Minnesota in Minneapolis.

Hodgkin's disease, also known as Hodgkin's lymphoma, is a cancer of the lymph nodes and similar tissue. Affecting one in 30,000 people, it usually affects people in their 20s or after age 55. Previous studies showed that adults treated aggressively for the disease were more likely to develop cancer and were particularly at risk of developing leukemia.

In the earlier findings, published in 1989, the researchers calculated that there is a one-in-five chance of developing a new cancer 20 years after being diagnosed with Hodgkin's. The new study, part of an ongoing evaluation of 1,380 children, is an extension of the earlier research in which youngsters treated for Hodgkin's were followed for an average of seven years. Now, after monitoring the patients for four more years, the Bhatia team has calculated that the radiation treatments that cured [*"Cured" hardly seems the appropriate word.*] the Hodgkin's made the breast cancer risk 75 times higher than expected. That translates into a one in three chance of developing a breast tumor by age 40. The women facing the highest risk were between 10 and 16 when they were treated, and they tended to be given the highest doses of radiation. [*Unbelievable!*]

## BIBLE CODES GREETED WITH SCORN

From the March 9 issue of the *MODESTO BEE*, [quoting:]

Skeptics are slamming claims that three Israeli professors have discovered hidden word patterns in the *Book of Genesis* which prove the book was written by God. But Dr. Jeffrey B. Satinover says at least three new papers making the rounds of statistical journals not only corroborate the original findings but present additional new proof. "One of the (new) papers involves a completely independent confirmation of the original findings," Satinover said in a recent interview. The mathematician who wrote the paper used "alternative statistical methods and his own...computer programs," Satinover said, not the program created by the three Israeli professors. The other two papers, which were prepared by the professors, "involve (previously undiscovered) information which is encoded in the text that couldn't possibly have been put there by human hands," Satinover said.

The controversial *Genesis* study was first revealed in the August 1994 issue of *Statistical Science*, whose editor at the time, Robert Kass, offered it as a "challenging puzzle" to statisticians. The findings have been reviewed by several renowned mathematicians, including the chairman of the Harvard University Math Department, David Kazhdan, and so far remain unrefuted.

"To be published in a journal such as *Statistical Science*, (the *Torah* codes findings) had to run, without stumbling, an unusually long gantlet manned by some of the world's most eminent statisticians," Satinover reminded *Bible Review* readers. [*The original findings were first published in Bible Review—and ridiculed by readers.*] The editor of *Statistical Science*, himself a skeptic, has challenged readers to find a flaw. Though many have tried, none have succeeded.

The three professors, Eliyahu Rips of the Hebrew University of Jerusalem and Doron Witztum and Yoav Rosenberg of Jerusalem College of Technology, based

their study on an examination of the *Torah* (the first five books of the *Bible*) begun in 1958 by Rabbi Michael Weissmandel. After first removing all spaces between words, the professors searched forward, backward and diagonally in the text for 300 pre-selected Hebrew word pairs with related meanings—for instance, "hammer" and "anvil"—to see if they could be found in close proximity to one another. They found that the word pairs "occurred much too frequently to be accounted for by chance," Satinover said in his *Bible Review* article. Some combinations appeared so frequently that they began to look "not so much like a random happening, but like something carefully embedded in the text."

The professors checked their findings by scrambling the selected text and searching it for the same 300 related word pairs. The words did not appear, ruling out random chance. They also tested the theory on the *Samaritan Pentateuch*, which differs from the traditional Jewish textus receptus used in their research, and on a Hebrew translation of *War and Peace*. "None of the word patterns appeared. 'The published results show that...the odds of (the phenomenon) occurring merely by chance are less than one in 50 quadrillion,'" Satinover concluded. The researchers also discovered neighboring word pairs which were names of 66 prominent people who lived and events that occurred centuries after the *Torah* was written.

"On the one hand, this is the most astounding research that has ever emerged—if it holds up," Satinover said. "On the other hand...because of its exactness, precision, and its use of rigorous scientific methodology, it is from a certain point of view boring. It's not sexy in a way that appeals to the sound bite mentality of our age. If you give me one-and-a-half, two hours, I can definitely explain it in a way so that people come away understanding exactly what the work is all about." [*Care to check it out? ## THERAPY USED TO CURB DISSENT

From the March 20 issue of the *WALL STREET JOURNAL*, [quoting:]

When security engineer Glenda Kay Miller questioned the reliability of a proposed employee-identification system at the Browns Ferry nuclear plant near Decatur, Ala., she says, the plant's operator sent her to company psychologists. The psychological sessions, which Mrs. Miller recalls as a series of hostile interviews, began in February 1995. She says she was questioned about her church attendance, how much she missed her husband when he traveled and whether she had ever had more than \$100 of unpaid parking tickets. "I've never been talked to that way in my life," says Mrs. Miller, who was fired last August on the ground of being unfit for duty. Mrs. Miller says further: "I'm a pretty normal person. But they were trying to portray me as a terrorist." In January, she filed a complaint with the U.S. Department of Labor alleging that the Tennessee Valley Authority, which operates the Browns Ferry plant, harassed and dismissed her for questioning managers. A spokesman for the TVA says it can't comment on the complaint, citing concerns about Mrs. Miller's privacy.

However it may be resolved, complaints like Mrs. Miller's are increasingly common. In a growing number of instances, nuclear workers say they are being pressured to undergo psychological evaluations after raising safety concerns. "The pattern is, people get normal (performance) reviews until they start raising concerns, and management needs a way to discredit them," says Lynne Bernabei, a Washington attorney who has represented workers in several harassment

cases. The U.S. Nuclear Regulatory Commission is currently investigating claims that Northeast Utilities, majority owner of the Millstone nuclear-plant complex in Waterford, Conn., has routinely harassed workers criticizing safety procedures, including sending them to psychological therapy and counseling. The NRC has threatened to close the plant's three reactors permanently if the utility cannot demonstrate that its operating practices are safe.

In January, U.S. Labor Secretary Robert Reich ordered the rehiring of a Florida Power & Light Co. engineer who had complained to the Labor Department about his dismissal: He was fired, he said, for refusing to undergo an exam with a psychiatrist after raising concerns about the reliability of reactor pressure-monitoring equipment at the company's Turkey Point facility. Both Northeast Utilities, which is based in Berlin, Conn., and FPL Group Inc.'s Florida Power & Light, based in Juno Beach, Fla., deny they have used psychological exams to punish whistle-blowers. Psychological testing of nuclear-plant workers has become routine as a result of new rules instituted by the NRC in 1990 and 1992. These rules, intended to combat drug abuse and other behavioral problems among nuclear-plant workers, required plant operators to monitor employees closely and offer assistance programs to those showing signs of stress.

Why would managers discourage employees from reporting safety concerns? In the Florida case, engineer Richard Robainas said that he was ordered to undergo a psychiatric examination because the safety issues he raised would have cost millions of dollars to correct. In fact, he says, the company later replaced the pressure-monitoring equipment in question. "In certain societies, psychiatry is used to curb dissent," says Mr. Robainas. "I think that's what is occurring here." [This is reminiscent of The Soviet Art of Brain-washing: Communist Psychopolitics and the Slaughter of Western Culture, in which it is stated: "Psychopolitics is the art and science of asserting and maintaining dominion over the thoughts and loyalties of individuals, officers, bureaus, and masses, and the effecting of the conquest of enemy nations through 'mental healing'."] ]

## CARBO CAKES

1 c. finely grated carrots  
3/4 c. apple juice  
2 1/2 tbl. oil

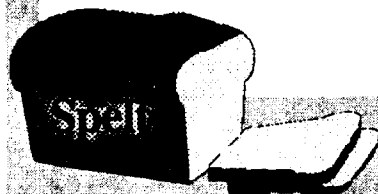
1/2 c. finely diced apples  
1 egg, beaten  
1 1/2 tsp. vanilla

Combine ingredients in a 2-quart bowl. Set aside.

1 3/4 c. spelt flour  
1/4 tsp. sea salt  
1/2 tsp. baking soda  
1 tsp. nonaluminum baking powder  
1/2 tsp. ground cinnamon  
1/3 c. raisins  
1/3 c. chopped walnuts

Combine ingredients in a 3-quart bowl. Add the carrot mixture to the flour mixture, and blend just until the dry ingredients are moistened. Fill the prepared muffin wells 1/2 full with the batter. Bake for 20 minutes, or until a toothpick inserted in the center of a muffin comes out clean. Turn the muffins sideways in the wells, and allow them to cool in the tins for about 5 minutes. Remove the muffins from the tins and transfer to a wire rack. Cool completely before serving.

We feel great sorrow at the erroneous choices and desire to push another into the way that we have found into balance—but in the ending we must simply realize that it is ONLY ONE and we cannot do of what another must do for self to perfect the fragment and reclaim it unto God.

How smug Man becomes as he journeys through the physical for he is blinded by that which is called "ego". God's gift unto human to set him apart is "reason" and "thought with choices of his own conjuring". Ego is that which is of the physical process which "believes" itself to be "all". Just as a serpent must shed of its outgrown skin that it might grow, so must the being shed of its ego restraints in order to grow. Is it so very difficult to see that you come from the heavens? Would it not be wondrous to KNOW that there are higher knowings unto which you can turn from your limitations and ignorance? I came not with great cosmic revelations at that time for the journey of the species lived in a limited mystical level of growth, and understanding was only present to the level of that which was allowed to be given by Man. # Legal Gangsters??

Orange County, California revolving around an organization called J.A.M.S., Inc., which stands for Judicial Arbitration and Mediation Services, Inc. Gene felt strongly that this possible corruption dovetailed directly with the work that Gary Wean has done. It would appear that he was correct in his assessment.

J.A.M.S. is a Private Judging firm and has been active since 1979 when it was formed in Orange County, California [With a population approaching two-and-a-half million, the county includes numerous well-known cities of the Los Angeles Metropolitan Area. It has made recent history as the richest county ever to go bankrupt (stated cause: trading in derivatives!)], by former Orange County Superior Court Judge H. Warren Knight. The evergrowing J.A.M.S. consists mostly of retired Judges who hear disputes in private courts as part of what is now known as the Alternative Dispute Resolution (A.D.R.) industry.

J.A.M.S. is part of the Alternative Court Structure that exists in California as an adjunct and a supplement to the public court system. Because of the increasing caseload in the California public courts there was a need to develop some other way of dealing with this increasing caseload. This situation appears to have been engendered because of the ever increasing legislation, generated by Sacramento [the state capital], which creates more and more laws for We the People to violate (It has been aptly stated that, "No man's rights are secure as long as the legislature is in session."). A public judicial system of limited size and scope is unable to deal with a potentially unlimited caseload.

An article in the July 1993 Edition of the *Southern California Law Review* on Alternative Court Structures indicates that there has been a "litigation explosion". The article states that between 1960 and 1990 in the Appellate and Supreme Courts there has been a 727% increase in filings; in the Superior Courts there has been a 197% increase in filings; and, in the Municipal and Justice Courts there has been a 107% increase in filings. Without a corresponding increase in the size of the public court system, the consequence has been that parties to actions must sometimes wait years to have their cases heard.

The article goes on to state that, "California litigants began using private judging procedures in 1976, when civil practitioners rediscovered a section of the California Code of Civil Procedure that allowed the parties to a lawsuit to mutually consent to refer issues to a private referee. In March 1982, the Board of Governors of the State Bar of California voted to support private judging." (See: Cal. Code Civ. Proc. Sections 638 - 645.1)

In 1989 the Judicial Council Advisory Committee issued a Report on Private Judging in which they outlined the situation as it existed then. The Report laid out the foundation and the parameters within which an Alternative Court System could function, or, more appropriately, was already functioning.

The California Legislature in October of 1993 enacted legislation which added new sections to the Code Civ. Proc., namely Sec. 1775 et seq., which stated exactly how this Alternative Court System shall

function.

In the 1989 Report of the Judicial Council Advisory Committee, the Council explained, among other things, the fact that when Judges reach their maximum retirement (at age 60, or after 20 years of service. Many Judges are in their early to mid-fifties when they complete 20 years of service.), there is no longer any incentive for the Judge to continue to work in the public

courts, because the Judge receives no further retirement benefits, even though the Judge must continue to pay 8% of his or her income into the retirement fund. As the Report states, "Judges view this as an eight percent reduction in income and an obvious disincentive to continue service." Thus, Judges reach retirement and can move directly into the Private Judging system, and receive their full retirement pay as well as their new income. Judges who continue to serve in the public system after reaching full retirement eligibility may receive, after taxes, only about \$45.00 per day in real pay. By contrast, private judges can earn \$175.00 to \$350.00 per hour.

In 1994, J.A.M.S., Inc. merged with Bates Edwards Group, and with Endispute, Inc., to form J.A.M.S./Endispute, which is now, by far, the leading provider of Private Judging, with offices in 14 states and Washington D.C., with Corporate Headquarters located at 500 N. State College Blvd., Suite 600, Orange, California 92668 (714-939-1300), in good old Orange County.

The legislation now in place clearly states that decisions rendered by the Alternative (Private) Courts

**LIMITING IMMUNITY. JUDGES. PROSECUTORS. SOCIAL WORKERS.**

**INITIATIVE CONSTITUTIONAL AMENDMENT.** Eliminates immunity from civil liability

of judges, prosecutors, and social workers for clear constitutional violations, deliberate

violations of law, concealment of evidentiary truth or evidence, judicial acts lacking

jurisdiction or authority, and unreasonable delay in concluding cases. Permits civil suits

against prosecutors and social workers for willful violations of law and for certain

prosecutions motivated by gender, racial and other specified bias. Requires notice amongst

public agencies to prevent public officials from receiving unlimited immunity. Permits

amendments by 2/3 vote of Legislature. Contains severability clause if part is held invalid.

Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state

and local governments: The cost of this measure is unknown, and would depend largely on

the number of lawsuits filed as a result of the new limitations on immunity. State and local

governments usually pay the cost of defending their employees and reimburse government

employees for monetary awards assessed against them. The costs to state and local

government could range from the millions to tens of millions annually.

in many cases carry the same legal weight as public court decisions. Under the Code Civ. Proc. Sec. 639, Judges in the public courts can refer cases to the private courts without the consent of the parties involved in litigation. (3 attorneys, 1 Judge, and 1 Justice who testified for the 1989 Judicial Council Advisory Committee Report, expressed concerns about a "public judge's desire to benefit a private judge", i.e., the Good Old Boy network). In J.A.M.S./Endispute's own literature (1996) they state that, "A.D.R. proceedings and results are generally not part of the public record and can be kept strictly private." It should become quite obvious, even to the most casual observer, that this unique combination creates the potential for possible widespread blatant abuse of the rights of the People of the State of California to have fair and open public trials!!

I accepted my assignment from Gene Dixon to in-

vestigate and research J.A.M.S. and the Alternative Court System in California, specifically in Orange County where the judicial corruption appears to be the most endemic, and specifically with a case involving one very brave woman named Rose Colombo, who has experienced extensive and ongoing (to this day) abuse by J.A.M.S. and the Orange County Judicial System

We all know that Orange County declared bankruptcy in 1994, yet Orange County remains extremely wealthy and powerful. In fact, I believe, it was the *Orange County Register* that reported that political candidates in California receive approximately 75% of their campaign funding within Orange County. Does anyone else smell a rat?

My first meeting and interview with Rose Colombo was on March 25, 1996, and lasted about 13 1/2 hours. The account of her experiences within the public and private judicial system of Orange County clearly shows

a long train of abuses that has been leveled against her personally.

Rose, who is a very warm, friendly, and outgoing person, was warned by one attorney not to go out at night, to be careful where she does go, and to be careful in all of her actions. Subsequent to this warning Rose was confronted by three armed men at night in a shopping center parking lot. Although she was accompanied by two friends, her attackers were clearly after her. Acting instantly on her intuition, Rose screamed and ran, was shot, fell, and rolled under her car, and the ensuing commotion caused her attackers to flee. One of Rose's friends took a bullet in the foot. Shortly thereafter, her former husband acted quite surprised to see Rose when she came to pick up her daughter (Was he expecting to never see her again?). She received numerous threats against her life during 1993 and 1994. She has seen her own child's car burned to a crisp, after receiving a warning about such an occurrence. Of the fifteen attorneys she has had, the only one who did attempt to seriously help her, died suddenly and mysteriously of an apparent heart attack, and was cremated shortly thereafter, and on and on it goes.

What does this brave woman know, what information does she have, which could be so threatening to the public and private judicial system in Orange County, that it would cause these things to happen to her? Well, she has decided to fight, to speak out, and to go public with what she has experienced. Rose is the Founder and President of Women Fight Back For Legal Justice (established in 1989), at 16027 Brookhurst St. #G279, Fountain Valley, California 92708 (714-839-5236). She has a "Women Fight Back" television show which airs Fridays at 3:30 p.m. on Channel 40, the TBN station, out of Orange County. She is the author of and is sponsoring an Initiative to be placed on the November ballot entitled "The Judicial Accountability and Limited Immunity Act of 1996" (contact Women Fight Back if you wish to support this, they need volunteers), which would correct deliberate violations of the law, concealment of evidentiary truth or evidence, and eliminate immunity from civil liability for corrupt judges.

Rose has done, and continues to do, more, but this alone is enough to shake-up the Good Old Boys network in Orange County. You see, Rose began her journey through the Orange County Judicial System seeking resolution of a four-and-one-half-million-dollar divorce settlement, from a husband who drank excessively and became physically abusive. Even though she has four children, Rose ended up owing her former husband \$96,000.00. This is a story about money, power, sex, greed, and corruption.

As you will see, Orange County is, indeed, a hotbed of corruption. But the corruption only begins in Orange County. Eventually, it reaches to the very doorsteps of the Governor of the State of California.

For all those Officials, Judges, and Attorneys in Orange County, or elsewhere, who may be interested: Take Notice: If anything should happen to Rose Colombo, the information flowing from this source will not stop, it will only increase.

This week we will begin to expose what is really going on in Orange County, in Rose Colombo's own words. Here is the interview:

**RB:** This is an interview with Rose Colombo. Her name was Rose Strickland while she was married to John Dennis Strickland, but she has changed her name back to her maiden name. This is an account of fifteen different lawsuits (Rose initiated only three of these) that she has had to deal with, having to hire fifteen different attorneys, and appear in front of at least twenty-five different judges, all within Orange County. Her experiences over approximately the last ten years have apparently shown there is a great deal of corruption within the Judicial System of Orange County.

Let's start at the beginning, Rose, and give us a little bit of background.

*Editor's note: In this Initiative Ballot (to function as a petition) the subscribing voters ask for a new amendment to the California Constitution, to be formally voted upon in the next general election. The proposed amendment would seek to broaden and enhance proper judicial responsibility, as well as to firmly register same with the U.S. Constitution.*

### INITIATIVE MEASURE TO BE SUBMITTED DIRECTLY TO THE VOTERS

The Attorney General of California has prepared the following title and summary of the chief purpose and points of this measure.

#### To The Honorable Secretary of State of California:

We, the undersigned, registered, qualified voters of California, residents of \_\_\_\_\_ County (or City and County) hereby propose an amendment (new section) to Article VI of the Constitution of California, relating to judicial reform, and petition the Secretary of State to submit the same to the voters of California for their adoption or rejection at the next succeeding general election, or otherwise provided by law. The proposed constitutional amendment shall read as follows:

### THE JUDICIAL ACCOUNTABILITY AND LIMITED IMMUNITY ACT OF 1996

#### Section 1. Findings and Declaration.

The People of California find and declare as follows:

That they have suffered and are suffering economic, physical and emotional hardship caused by the pressures of public officials whose misconduct is protected by the cloak of immunity and the lack of judicial accountability.

Thereby, We the people, demand the restoration of judicial accountability and the implementation of limited immunity of all public officials in the State of California.

(a) The term Public Official shall include but not limited to justices, judges, commissioners, judges pro tem, private judges and arbitrators, hereinafter referred to as "Judges," District Attorneys, Social Workers and Child Protective Service Workers. This shall be known as the "Judicial Accountability and Limited Immunity Act of 1996."

(b) Notwithstanding common law or any other provision to the contrary, no immunities shall be extended to any member of the judiciary of the State of California, except as specifically set forth in this Act. For purposes of this Act, members of the judiciary shall include but not limited to judges, commissioners, judges pro tem, private judges and judicial public officials, i.e. District Attorneys, Deputy District Attorneys, Social Workers and Child Protective Service Workers.

(c) That they have a right to the protection of their government from any person or persons employed by the judicial system who willfully and intentionally violates their oath of office and the Constitution of the United States of America.

(d) Therefore, the People of California declare their intention to provide for cooperation between their agencies of state and local government, and to establish a system of required notification by and between such agencies to prevent unlawful acts by public officials in the State of California from receiving unlimited immunity.

(e) Preserving the original intent of immunity to protect public officials from frivolous and harassing complaints, the "limited immunity act" shall be construed to extend to any clear violation of the Constitution of the United States or California Constitution, wherein a willful and intentional and deliberate violation of law, concealment of evidentiary truth or evidence, judicial acts lacking jurisdiction or authority, and unreasonably delaying the conclusion of a case.

(f) Commencing on January 1, 1997, after the enactment of this Act, any citizen may file a suit in the court of jurisdiction against a Judicial Public Official who has intentionally and willfully violated the law and maliciously prosecuted or persecuted a citizen based on gender bias, race, ethnicity, religion, political or economic status.

(h) The provisions and procedures herein are in addition to other redress that may exist and are not exclusive.

(i) The statutory provisions contained in this measure may not be amended by the Legislature except to further the purposes by statute passed in each house by roll call vote entered into the journal, two-thirds of the membership concurring or by a statute that becomes effective only when approved by the voters.

(j) In the event that any portion of this act or the application thereof to any person or circumstance is held invalid, that invalidity shall not affect any other provision or application of the act, which can be given effect without the invalid provision or application, and to that and the provisions of this act are severable.

**RC:** I filed for divorce in 1987, when my husband vowed to put me and the children in the street without a dime.

We were married on March 4, 1978, and Holly was born on February 21, 1979. I worked. We had a prenuptial agreement. I put \$30,000.00 immediately after the marriage into a Joint Trust Account for John and myself, a community account. In exchange, he was to issue stocks to me from the corporations. He did not. Altogether, by the end of one year I had added an additional \$20,000.00 from vacation, savings, credit union, and sick pay from the County before I quit working there. This was also placed into the Joint Account for John and myself. At that point he still did not issue the stocks.

We owned a home at 1724 Catalina, in Seal Beach. When I filed for divorce in 1987, we lived in a home at 279 Owens Drive, in Anaheim Hills. It was purchased on January 23, 1985, a joint tenancy community home. We paid \$220,000.00 for it, and by 1989, it had skyrocketed [*in value*] to \$645,000.00, and when we entered the courts in 1987, the home was paid for in full.

We had approximately four million dollars in community assets. My ex-husband, John Dennis Strickland, a contractor, and owner of Paramount Door & Glass, Paramount Distributors, and John's Glass, employed David K. Jefferies, Attorney, to represent him, and Milan Dostal, Attorney, to represent the corporations.

In 1984, we purchased an electric-generating windmill near Palm Springs, a community asset, and opened up Electro-Pro. It produced electricity and earned \$100,000.00 in tax credits, and an income during the marriage, and it is still earning money because it is still generating electricity.

We also started a new business called Jovoné Cosmetics and Skin Care in 1984, in both our names.

In 1993, John fired his Attorney, David K. Jefferies, and he hired Ronald W. Weiss, who is still his Attorney to date. I did not know at the time that David K. Jefferies had taken out a Lien for \$12,000.00 on our Seal Beach home to start divorce proceedings. That home was also a joint tenancy community property, so that was also an illegal loan to Mr. Jefferies for attorney fees, done without my knowledge.

My first attorney was William Yacobozzi, who was a high-profile attorney in Newport Beach. Mr. Yacobozzi insisted I employ William Mills (C.P.A.) in 1987, a respected forensic expert witness in Orange County. Mr. Yacobozzi said I couldn't hire my own C.P.A. because the judges wouldn't allow them to testify. Mr. Mills was supposed to do an evaluation of the businesses and the properties, and it was supposed to take about two weeks, and he was supposed to give a written evaluation for court.

**RB:** And this was for the divorce proceeding?

**RC:** Right. And the property settlement.

Mr. Yacobozzi had me in court over 24 times from 1987 through 1989. These were continuances. Most of the times he sent substitutes. He took on two multi-million dollar criminal cases during my divorce proceeding, and he also decided to run for Congress in the middle of my divorce. Mr. Yacobozzi would have Mr. Mills sit in the cafeteria, or in the hallway (of the Courthouse), and he would have Mr. Mills bill me for his time, from the time he left his office until the time he got back to his office, even though he never testified during those two years (1987 to 1989), nor was he needed. He could have been on call. So I was paying not only Mr. Yacobozzi an hourly wage, I was also paying William Mills each time the case was continued.

**RB:** This was through the 24 continuances?

**RC:** Correct. We would go to court, and then the case would be continued, or he would send a substitute attorney in who didn't know anything about my case, and it would get continued. And Mr. Yacobozzi also made sure that William Mills was in court and he would bill me, as I said, from the time he left his office until the time he returned, and he never testified at any of

those proceedings.

All in all, I ended up paying William Mills \$7,000.00 by 1989, prior to going into J.A.M.S., Judicial Arbitration and Mediation Services, in Orange County.

Later, Mr. Yacobozzi told me that he needed money because he was running for Congress and it was costing him more than he had anticipated. He had leased Newport Beach office suites. He had purchased Tammy Baker's \$50,000.00 Rolls Royce. He had an estate in Newport Beach, He had numerous classic cars, and he said he was strapped for funds. He kept sending me letters and asking me for contributions to his campaign, wanting up to \$1,000.00.

In 1989, Mr. Yacobozzi tried to sexually harass me in his office several times. He would have me come to his office either on a Saturday, when there was nobody there, or late in the evening. So I started bringing a friend with me, because I rejected his couch.

I tried to get a new attorney during this time but they wouldn't take the case because they said Mr. Yacobozzi was above reproach, and that I should stick with Mr. Yacobozzi because he was a very good attorney. I could not get another attorney.

I had paid Mr. Yacobozzi \$20,000.00 by 1989, and had not gotten to trial.

In April of 1989, Mr. Yacobozzi told me we were going to trial. I inadvertently discovered we were in a Mandatory Settlement Conference. He handed me a fraudulent settlement offer. Because it appeared to be too good to be true, I questioned him. He shoved it at me (across the table), it was 8 o'clock in the morning, in the cafeteria of the Orange County Superior Court, and he said, "Look, you refused to have sex with me so this is the best I can do."

After I questioned him, it turned out that I was getting zero assets of support, but the offer was cleverly put down on paper.

**RB:** Let me interrupt you for a minute. This is a case that involves a total amount of assets, as you say, of about four-and-one-half-million dollars?

**RC:** Right.

**RB:** And this attorney (Mr. Yacobozzi), out of this divorce settlement, is not able to get you anything at all of the four-and-one-half-million dollars?

**RC:** Well, on the yellow pad that he shoved at me, it looked good on paper. He said it was a good offer and I should take it, and I should sign it. It appeared that my ex-husband was giving me more than I asked for, and up to that point he wanted the shirt off my back, so I couldn't understand why he would want to give me more than I had even asked for.

So, when I questioned Mr. Yacobozzi it turned out that I was getting nothing. He was making my ex-husband the landlord. I would be paying him rent, and he was going to dole out the child support himself. So, Mr. Yacobozzi was taking the child support away from

me. I was only going to be given a minimum amount of spousal support, and it was going to be diminished over a period of three years, totally. So, what appeared on paper was not the actuality of what the settlement was going to be. It was going to be that I was going to end up with nothing in reality. I also learned that Mr. Yacobozzi had never filed a Brief in my behalf, in my defense. But John's attorney had filed a Brief in his defense.

Mr. Yacobozzi got mad at me because I refused to sign the Settlement offer that he proposed, and he dragged me (not literally) into Judge Monarch's chambers, and Judge Robert Monarch tried to intimidate me. This is the same Judge Robert Monarch who was taken off a case for making ethnic slurs against a female litigant, Nancy Rosen. That hit the newspapers.

Anyway, I was dragged into Judge Monarch's chambers. There was no court reporter. John and John's attorney were not present. Judge Monarch said, "Do you think, if I gave you the opportunity to defend yourself, you could do as good a job as a sophisticated attorney like Mr. Yacobozzi?"

I said, "Technically, no, because I haven't gone to law school, but common sense wise, absolutely."

Judge Monarch got angry at this point. He insisted that I sign the fraudulent, not that he considered it fraudulent, but he insisted that I sign the Settlement offer that Mr. Yacobozzi had insisted I sign, and take the advice of my attorney.

I said to the Judge (Monarch), "Look, I'm not going to sign it, and I don't understand why everyone's making such a big deal about this case. We have four million dollars of community assets. I only want a house and child support, and I want to clear my name of any possible tax evasion in the future."

Judge (Robert) Monarch looked at me and said, "Mrs. Strickland, you don't think that a judge in Orange County is going to hold your husband accountable for a little perjury, or a little tax evasion, do you? I strongly suggest you take the advice of your attorney and sign the Settlement offer."

After leaving the Judge's chambers, I went into the restroom of the Courthouse, and it was there that I broke down in tears, realizing that Mr. Yacobozzi had sold me down the river. And my illusion of Justice and fairness in the courts of America was shattered, I vowed to fight back against these injustices, because I realized this must be happening to far too many citizens, and there was nowhere to go.

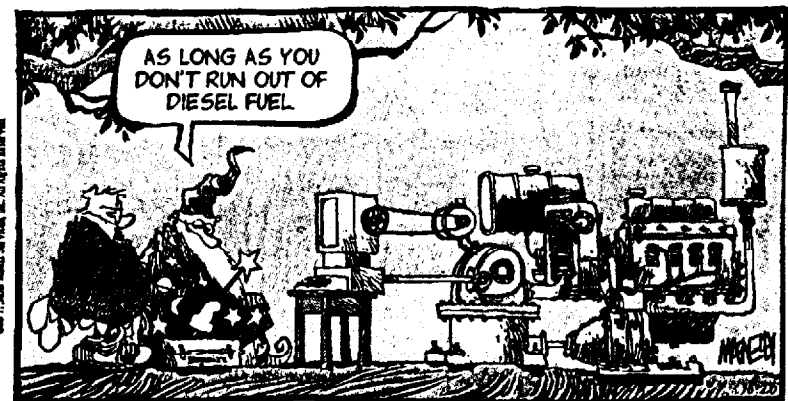
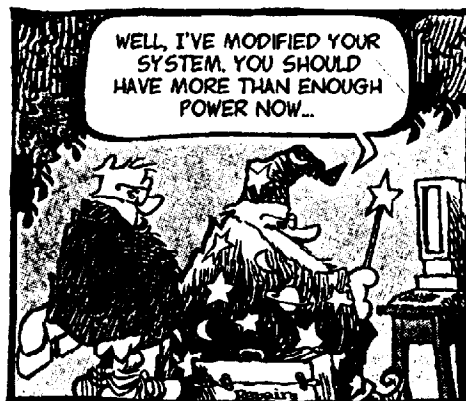
So, I decided to start a nonprofit organization, write a book, and expose these injustices through the media.

# Montana Freeman Update

*Editor's note: CONTACT has learned from friends and family members of the Freeman that Gerry Spence has been unanimously accepted by the Freeman as their negotiator. Word of this was given to the FBI several days ago and they have been remarkably quiet ever since. It appears from comments by Montana's Attorney General on CNN Wednesday evening that the suggestion of Gerry Spence entering the picture is not viewed very positively from either the state or federal side of things.*

CONTACT has been informed by sources very close to the Freeman that all they are really asking for is a Constitutional Grand Jury public forum hearing over this entire matter. The feds seem to want to issue a federal grand jury, and the state of Montana seems to want to issue a state grand jury. Well, which will it be? The Freeman will not budge from their position in wanting, specifically, a Constitutional Grand Jury. If they do surrender, it will likely be as "prisoners of war" under the War Powers Act.

CONTACT has also been informed that LeRoy Schweitzer, who was moved to a Springfield, Missouri federal prison over a week ago, was visited yesterday by his son and daughter, Craig and Brandy, who reported via Schweitzer's wife that he is being "force-fed" by a tube. Prison authorities keep increasing the size of the tube and LeRoy tells his children that he is in a great deal of pain. This, on the heels of reports of severe beating prior to being transferred from Montana. The feds are playing this one very low key, as far as the public is concerned. Will Spence be allowed to enter the picture as chief negotiator? We shall see...

In the meantime, other negotiators have been meeting with the Freeman over the last several days. They are making their request for a Constitutional Grand Jury known.

Readers, please keep in mind that this is a fluid and ever-changing situation and obviously by the time you get this there will be a change in the status of the Freeman.

RE: Freeman status report

It has come to our attention that many concerned patriots are considering coming to the state of Montana for the purpose of "sending the FBI home" and "freeing the Freeman."

This message is for the purpose of making you aware of what to expect when you enter our great state.

1. All vehicles of a suspicious nature bearing out of state license plates will be stopped and searched.
2. All telephone conversations are being routed through Billings, MT.
3. You will not find a "militarized-police action" in operation against the Freeman. (Remember, this was the number one purpose for the formation of militia organizations across America.)
4. Area ranchers were and still are prepared to handle the matter themselves if the FBI would not or can not take care of it.
5. As stated in number 3, there is no militarized-police action. However, we are fairly certain, military forces (amount unsure) are on standby if the FBI becomes surrounded by Freeman supporters.

1) That you have all of your people pressure the justice department into returning Leroy Schweitzer to Montana from Missouri. Until this happens, we do not believe any Freeman will surrender from the Clark ranch. Would you? 2) That your energies be placed upon the judicial system to ensure that these men are given fair trials. The Randy Weaver siege and the Gordon Sellner stand-off are just two of many cases where they would not have occurred if the judicial system could be trusted.

## The Four Horsemen Of The Apocalypse

### LUCIFER'S PLAN TO OBTAIN RULE OF THE WORLD, AS REVEALED THROUGH ALBERT PIKE AND FREEMASONRY—THREE WORLD WARS

#### Article III, Section 1

In order to understand the difference between Lucifer's plan and God's plan for mankind, it might be a good idea to consider parts of God's plan and Lucifer's plan together. When a question of "God's will for Man" recently came up, Hatonn said that "God's will is Man's freewill"! It is my understanding that Man is given the great opportunity to develop himself, learn his lessons and advance from this Earth School to greater opportunities and responsibilities. In order to do that he must not only recognize his own and each other man's uniqueness, but also learn to love and respect that uniqueness while efforting to perfect himself. (This does not imply that Man should be a wimp, that he should allow others to run over him, or that he should not stand for truth and goodness—God's Laws.) Obviously, this requires time, space and circumstances favorable to completing the task.

How does the above compare with Lucifer and Freemasonry? One of the primary doctrines of Freemasonry is that the entering mason is a "rough ashlar" (quarried stone) which is to be "hewn into a perfect ashlar"—a "stone made ready by the hands of the workmen, to be adjusted by the working tools of the Fellow-Craft". (Ref.: Albert Pike, *Morals and Dogma*) When you consider that Esu/Immanuel advised his followers: "Be ye perfect, as your Father in Heaven is perfect", Masonry sounds very similar in intent. Also, Masons make a freewill choice about entering the lodge—so far so good. However, a Mason is not expected to perfect himself, but is "made ready by the hands of the workmen"—Masonry, his "brothers" and the tools of the "Craft". Additional and frequent assaults on his "freewill choice" come with the mandatory and unconscionable oaths of secrecy which the Mason encounters immediately—a secrecy even about matters yet to come, of which he still knows nothing. Further, he is sworn to come to the aid of all "brother Masons" in preference to all others, a far cry from loving others as yourself. The Mason is no longer a man with freewill.

If the above were the only problem we could mark it down to one individual's choice and let the matter rest. However, Albert Pike, in the first few pages of his book, *Morals and Dogma*, reveals that the hierarchy of Freemasonry sees the mass of humankind as a "rough ashlar", which they plan to hew into shape for their controlled one-world government and religion! This is the hidden meaning and intent to their motto: "Order out of Chaos"—take the "chaotic" world of mankind and create "order". Nevertheless, this motto is deceiving. The hierarchy of the Masons have never planned to create "order" through beneficial works, as most

lower degree Masons are led to believe and work towards. The hierarchy (who must be of the "lineage of Solomonis" according to General Erich Ludendorf and the Basic Constitution of Freemasonry) plan to create that chaos so they can then force their own rule ("order") upon mankind! The above is one of the major reasons for all of the enforced secrecy in Freemasonry. The hierarchy must be sure of the international leanings and loyalty of their man to themselves before he is brought into the higher councils of Freemasonry, because, in effect, the hierarchy of Freemasonry plans to take over all governments—a criminal, treasonous activity, and a very far cry from the propaganda used to promote Freemasonry!

I have recently discovered references from two presenters which outline that plan. One presenter is Myron C. Fagan, who prepared an audio tape (and also a typed manuscript) from the work of educationist Anthony J. Hilder, titled the "Illuminati". The other is author Des Griffin, who included the reference in his book, *Descent Into Slavery*. The reference is in a letter written by Albert Pike (head of Freemasonry in the U.S. of A.) to Giuseppe Mazzini (head of Freemasonry in Europe) on 8/15/71, outlining the plan of chaos determined by the hierarchy of Freemasonry. Mr. Fagan states that the letter is catalogued in the British Museum, London, England. (Keep in mind that Adam Weishaupt, a Jew and former Jesuit, who set up the

Illuminati, and who became the head of Freemasonry in Europe in 1776 was, according to Hatonn, the "old boy himself"—Lucifer in incarnation. Remember also that Weishaupt/Lucifer was given asylum at the estate of Saxe-Gotha when he was banished from Bavaria due to the discovery of his plan for world domination. Weishaupt was made "Honorary Counselor" by Ernest Duke of Saxe-Gotha, who was also a relative of the Prussian and English Monarchs and many other "Elite" of Europe. Weishaupt also became counselor to the Rothschilds, and continued his intrigues and agitations until he died in 1830. Pike and Mazzini followed closely on his heels as heads of Freemasonry. The various male heads of the ruling houses in Europe, and perhaps elsewhere by now, hold the Masonic title of "Vicarious Solomonis", and are under a secret head of Freemasonry, known only to them, who must be of the "lineage of Solomonis". Further, according to the Freemasonry Archives on the Internet, updated July, 1995, all of the "legal" Masonic lodges in the United States must derive their charters from an English mother lodge!)

I quote from Des Griffin's book, *Descent into Slavery*, page 38, (quote):

#### PLAN TO CONQUER THE WORLD

Having consolidated their financial grip on most of the European nations by the middle of the last century, the International Bankers worked feverishly to extend their sphere of influence to the ends of the Earth in preparation for their final assault on the United States—a nation which, through its unique *Constitution*, remained free.

In the decades that followed it became apparent that, in order to achieve their goal of world domination, they would have to instigate a series of world wars which would result in the leveling of the old world order in preparation for the construction of the New

World Order. This plan was outlined in graphic detail by Albert Pike, the Sovereign Grand Commander of the Ancient and Accepted Scottish Rite of Freemasonry and the top Illuminati in America, in a letter to Giuseppe Mazzini dated August 15, 1871. Pike stated that the first world war was to be fomented in order to destroy Czarist Russia—and to place that vast land under the direct control of Illuminati agents. Russia was then to be used as a 'bogey man' to further the aims of the Illuminati worldwide.

World War II was to be fomented through manipulation of differences that existed between the German Nationalists and the Political Zionists. This was to result in an expansion of Russian influence and the establishment of a state of Israel in Palestine.

The Third World War was planned to result from the differences stirred up by Illuminati agents between the Zionists and the Arabs. The conflict was planned to spread worldwide. The Illuminati, said the letter, planned to "unleash the Nihilists and Atheists" and "provoke a formidable social cataclysm which in all its horror will show clearly to the nations the effect of absolute atheism, origin of savagery and of the most bloody turmoil. Then everywhere, the citizens, obliged to defend themselves against the world minority of revolutionaries, will exterminate those destroyers of civilization, and the multitude, disillusioned with Christianity, whose deistic spirits will from that moment be without compass [direction], anxious for an ideal, but without knowing where to render its adoration, will receive the true light through the universal manifestation of the pure doctrine of Lucifer, brought finally out in the public view, a manifestation which will result from the general reactionary movement which will follow the destruction of Christianity and atheism, both conquered and exterminated at the same time." (End of quoting.)

In other words, the mass of humankind (the rough ashlar) is to be "beaten into shape" and readied for the worship of Lucifer through three terrible world wars.

It is incredible that Albert Pike, supposed citizen of the U.S. in good standing, would have the knowledge, arrogance, and betrayal to write such a letter in 1871. It can only mean there was a hierarchy (Lucifer and his chief agents) of Freemasonry and the international bankers with a well-formulated plan, which was to determine their actions and could foretell the results to a great extent. Certainly my most recent articles in this series briefly confirm the part played by W.W.I in this plan (forty-five years after Pike), as well as the beginning of the plan for W.W.II foretold by Albert Pike.

Certainly too, the "plan" includes all the greedy, lying, tyrannical and bloody aspects revealed in the biblical symbolism of the first two horsemen of the Apocalypse in the book of *Revelation*, another view of the plan (script) written by the adversary.

I would like to backtrack a little on some history of the times of Albert Pike and the years preceding W.W.I. This will not be the kind of history found in the much edited and rewritten books today, but will offer clues as to what was really going on. Preceding Pike and America's Civil War of 1865 were the wars of Napoleon Bonaparte, the first anti-Christ, according to Nostrodamus. As a result of Napoleon's drive for power, a huge number of lives were lost and the Rothschilds, who financed both sides of the conflict, "cleaned-up" financially. It was at the end of Napoleon's Battle of Waterloo (6/18/1815) that the Rothschilds, through trickery and their advanced knowledge of the results of the battle, gained control of England's banking system. Still, there were other aspects to Napoleon's time, and later, of which most people in the world today are unaware; namely, the knowledge gained from Middle Eastern Archeological digs and Napoleon's expedition to Egypt. These revealed: (1) that the history of the Hebrews was not in accord with the *Old Testament*; and (2) there were civilizations preceding our own which were far more advanced than our own. (Of course, this information was not generally publicized.) According to Hatonn, there are flying disks, as well as other advanced technologies, stored beneath the pyramid! (Please see my book, *The Garden of Aton*, for background information.)

Keeping the above in mind, it should not sound strange to you that Hatonn has said the adversary had developed time-travel by the turn of this century! Which means, among many things, that the average citizen has been grossly deceived by his "leaders" for a very long time. Nevertheless, the use of advanced technologies has to have been well underway to provide a reason and a means for world control. Not surprisingly, there is a confirming hint of some unusual knowledge in the possession of Albert Pike in 1871, (quote):

"There is in nature one most potent force, by means whereof a single man, who could possess himself of it, and should know how to direct it, could revolutionize and change the face of the world.

"This force was known to the ancients. It is a universal agent, whose supreme law is equilibrium; and whereby, if science can but learn how to control it, it will be possible to change the order of the seasons, to produce in night the phenomena of day, to send a

thought in an instant round the world, to heal or slay at a distance, to give our words universal success, and make them reverberate everywhere." (End quote.)

The above is taken from page 734, *Morals and Dogma* (a gift from my good friend, M.B.). How do you suppose Albert Pike obtained the knowledge of the above possibilities in his day?

By the time of W.W.I (1914-1918) the international bankers had also gained control of the banking system in the United States. Many of these bankers are members of the Committee of 300, the actual hierarchy of Freemasonry, Communism and Zionism, among other nefarious schemes.

In my article preceding this one I showed how W.W.II was being "fomented through manipulating the differences that existed between the German Nationalists and the Political Zionists" via infiltration and agitations by the Red German Zionists/Communists as soon as W.W.I had ended (there was never a true intent by the Freemasonic and Rothschild controllers at the Peace Conference after W.W.I to maintain the PEACE).

Des Griffin provides a general summary of the world situation at the time of Albert Pike which essentially dictated military and subversive political actions necessary for the adversary to gain world control, (quote):

At the time Pike wrote this remarkable letter [to Mazzini, 8/15/1871] there were five different ideologies extant on the world scene and involved in a "struggle for space and power." These were:

1. The secret ideology of the International Bankers or the Illuminati as laid out in *Fourth Reich of the Rich*. Their aim was the creation of a One World Government to be ruled over by the "illuminated ones" at the top.

2. The Russian "Pan-Slavic" ideology which was originally conceived by William the Great and expounded in his will. According to A. H. Granger, the author of *England World Empire*, 1916, p.173, this ideology called for the elimination of Austria and Germany, then the conquest of India and Persia and ends with the words: "...which will ensure the subjugation of Europe."

3. The ideology of "Asia for the Asiatics" as expounded by the Japanese. This called for a confederation of Asian nations dominated by Japan.

4. The ideology of Pan-Germanism which called for German political control over the European continent, freedom from the Crown's restrictions on the high seas and the adoption of an "open door" policy in trade and commerce with the rest of the world.

5. Pan-Americanism or the ideology of "America for the Americans". This called for "trade and friendship with all, alliances with none." Secretary of State Root stated in 1906 that, under this ideology which was given expression in the *Monroe Doctrine* of 1823, we are "debarred from sharing in the political aims, interests, or responsibilities of Europe, just as by the equally potential doctrine, now nearly a century old, the European powers are excluded from sharing or interfering in the political concerns of the sovereign states of the Western Hemisphere."

If the plans of the International Banker/Illuminati Cabal were to be brought to fruition Russia, Germany, Japan and the United States would have to be brought to their knees in unconditional surrender, poverty and ignominy.

The Illuminati plan for world conquest, referred to by Albert Pike, was a diabolical masterpiece of Luciferian ingenuity that would take the lives of hundreds of millions of human beings and cost hundreds of billions of dollars in its accomplishment. (End quote.) (Ref.: *Descent into Slavery* by Des Griffin, page 39.)

Obviously, Russia was "brought to her knees" during the Bolshevik Revolution at the time of W.W.I. Germany and Japan were both to suffer defeat in W.W.II. The United States has taken much longer, but its former adherence to the *Monroe Doctrine* was a policy totally disregarded in W.W.I and from that time forward. The United States, its resources and technologies has always been an integral and important part of the Illuminati's plans and activities through their puppets in critical positions in our government and country.

Before I proceed with more history on W.W.II and its PEACE CONFERENCE, I want to provide another clue to the identity of the hierarchy of the adversary, Lucifer and his crew.

You may recall, from my earlier writings on Freemasonry, that the Masons believe the colors of "God" are blue and gold on a white background. These colors are used on the Mason's white apron for certain degrees and match the colors that Aaron (the High Priest of *Old Testament* accounts, which are now highly suspect) wore when he entered the temple and "holy of holies", once a year, etc. The blue and white colors are also used by the new state of Israel in their flag; by the United Nations; by Benjamin Creme's Maitreya; and by Lucis Trust (aka Lucifer Trust), the only "religious" organization given early residence at the United Nations complex in New York (they moved to a different address in the 1980s). (I have recently learned from Fritz Springmeier's book, *The Top 13 Illuminati Bloodlines*, that the Rockefeller tax-free foundations have control of the Lucis Trust and are their primary funding source. The Rockefellers are one of the top thirteen Illuminati bloodlines according to Fritz Springmeier. Since the Rockefellers, through their foundations, donated the land on which the United Nations buildings sit, we may have an explanation here of the reason for Lucis Trust's seemingly unrepresentative, and therefore unwarranted, privileged and unprecedented early position within the U.N. complex, unless it were to be recognized by the majority of Nations that Lucifer and his Illuminati are representative of their religions.)

I believe the use of the same colors (and also symbols as discussed elsewhere) within the above listed groups suggests a purposeful plan developed for the eventual public merging of these groups under the one-world government and "religion" of the Zionists/Communists/Freemasons/Illuminati and Lucifer. Now that we know that not all of the *Old Testament* "history" of the Jews matches with archeological finds, one can see important reasons why the controllers would have a need to "change religions"—reasons beyond their obvious intent to bring them all under one head. One can also see the probabilities that the same bunch of "Luciferians" (aka "Snake People") had a great deal to do with the promulgation of the *Old Testament*, as we know it, and its related works. There were ample

reasons why Esu/Jmmanuel castigated the work of the scribes and priests of the temple in Jerusalem in his day. (Please keep in mind that not all persons who follow the "Bible" are aware of all its actual origins, that not all Jews are Zionists and that the Masons of the lower degrees are primarily unaware of the hierarchy's activities, although they now have the opportunity to become aware of them.)

According to Hatonn and other investigators, the "Elite"/Adversary/Committee of 300 made contact with a group of beings originating from off our planet, and were given knowledge of advanced technologies. This, together with the scientific breakthroughs of Nikola Tesla speeded them along with their plans. Hitler was also involved with similar beings. I do not know if they were/are the same group. Hatonn said the Pleiadians contacted both sides of the conflict of W.W.II. Their offered assistance was rejected by England/France. They had some early success with Hitler. However, Hitler was unwilling to accept their condition that the Jews were not to be harmed but could be moved to another place. The Pleiadians departed, and a new group of beings began collaboration with Hitler. We know the Germans were quickly developing some very advanced technologies by the end of W.W.II. The results of the war could easily have gone in their favor if they had had a little more time. After the war, our own government, in cooperation with Britain, France, Russia, etc., transferred many German and Japanese scientists and medical persons to the U.S. to help further these technologies. It is astounding how our "deadly enemies" became our "friends" overnight with the combined and massive propaganda programs of the controlled media. From that point on, the United States was gradually taken over by the secret activities of the international military, international science, international secret services, international planning, etc. The questions and guesses regarding the identity of these beings and their advanced technologies, unknown to the public at large, have been the subject of many individual investigators and the absolute stonewalling of information by our government. Please remember that Freemasonry, and all the other connected groups (i.e. Communism, Zionism, Luciferianism, Creme's Maitreya, the Committee of 300, the United Nations, etc.) promote internationalism and a one-world government under the "Jews" and/or a new "Messiah", etc. Remember also that most of the heads of government and their close advisors are connected to at least one of these groups.

The reason for the above review is that I found a very interesting, well documented and substantiated report on a "UFO" incident in Argentina which could shed more light on the identity of the "alien" beings possibly connected to this group of international, secret collaborators due to their use of the same color schemes! The report is to be found on page 163 of William Gordon Allen's book, *Overlords and Olympians*, (quote):

#### "THE OCCURRENCE"

"On December 30, 1972, at approximately 10:20 p.m., Sr. V.M. (\*1) was sitting, drinking the national beverage maté about six metres from the little wooden shack in which he lives. He was sitting by a small fire, and had just finished his evening meal. At his side were his dog, a medium sized animal some four or five years old and a cat with her three kittens. He was listening to his transistor radio, when suddenly the radio began to fail. He thumped it a few times, thinking that perhaps the batteries were loose, but as it continued to fail, he switched it off.

"At that moment, he heard a loud humming noise, which he described as 'like the noise of angry bees, only ever so much louder.' It was growing steadily louder and, when he realized that it was coming from overhead, he looked up and saw a powerful light, rapidly increasing in intensity and flooding the whole area

around. Within the area of the light he could clearly distinguish an enormous object.

"As a result of the calculations which we have made when discussing the case with him at the spot and reconstructing the episode, we estimate that the object must have been approximately 20-25 metres in diameter. It was almost exactly right above his head, hanging stationary above the nearby grove of eucalyptus trees, which are some 10-12 metres high. From tubes in the lower central portion of the object (tubes protruding some 20 or 30 cms. from it) it was emitting sparks, while around it an enormous wheel was constantly spinning.

"The witness describes the colour of the object as having been 'red-orange turning to purple.' In the upper central part of it, the whole of which was intensely illuminated, he could see a spherical cabin with two small windows. At one of these windows was a person, visible only from the waist upwards. This individual was wearing dark grey clothing 'made of rolls or cylinders joined together'. The 'rolls' gave the appearance of being inflatable, similar to the garb worn by astronauts. On the individual's head was a helmet. From the upper part of the helmet a tube passed down into a box on his back.

"Simultaneously with his sighting of this occupant, a shower of sparks shot from the under-part of the object right in front of where V.M. was sitting, and the object tilted slightly downwards and towards him, so that he now had a full view of the lighted cabin on the stationary craft, and could see that there was also a second occupant with identical features and clothing, who was looking over the shoulder of the first one. He described the eyes of both of them as slanted. He said the eyes looked fixedly, and gave an impression of depth. The mouth was but a thin line, and he remembered no details of nose or ears.

"The object being now in this tilted position, V.M. was able to see moreover that, in addition to the two small windows on this side, through which the occupants were viewing him, there were also two more windows on the further side, and between these other two windows he could see what seemed to be, as he described it, a small flag or banner or emblem, the upper part of which was light blue. On the left was the representation of a dragon or sea-horse bearing a crown, and to the right of the dragon/sea-horse a number of signs or symbols. The lower part of the banner was golden.

"Inside the cabin he could also see a long panel with, as he put it, 'a whole lot of instruments and clocks'.

"Almost simultaneously with downward tilting movement of the object, a powerful flash of light came from the under-part, blinding the witness temporarily and forcing him to avert his eyes downwards. This flash of light completely enveloped the cabin and then vanished at once. Meanwhile the humming noise was growing much louder, and the colour of the object was turning to bluish-green. It began to move forward, away from the eucalyptus trees, and descended still lower until it was no more than 4 to 6 metres above the ground. At this point V.M. was able to see that in the upper part of the cabin there was a wheel or ring which was spinning very fast.

"After that, the object moved off towards the northeast where the main road is, and where there are high power cables. A strong smell like the smell of sulphur or arnica remained in the air for a few seconds. Then the object disappeared behind the tree-covered mound. It was still flying very low, its colour changing slightly to reddish and then greenish-blue.

"The whole observation had lasted for approximately 20 seconds."

(\*1) Important Note: A German publication, *UFO Nachrichten*, has revealed the names of the persons involved. Sr. Ventura Maceiras, and the local government official is Sr. Agnel Petrazinni of the Municipality of Tres Arroyos. (End quote.) (I am indebted to a

generous friend, R.E.B., for this book, thank you.)

Mr. Allen gives a thorough review of all aspects of the occurrence as reported to investigators (i.e., the behavior of the animals, the physical symptoms of the witness and victim, traces left by the object, and investigative conclusions). Sr. V.M. was interrogated more than sixty times by different professional people. None doubted his veracity.

The matter of most interest to our subject is the banner (a flag), revealed inside the flying disk, of light blue color at the top, golden color on the lower portion, and with the symbol of a dragon/sea-horse bearing a crown on the left side! The colors match those of the "god" of the Freemasons and the Hebrew Priesthood! The symbol of the "dragon/sea-horse" is also particularly interesting when one considers that the adversarial hierarchy call themselves the "snake people", and Lucifer/Satan is often referred to as "that old dragon". The fact the "UFO" was in the area of Argentina suggests a possible home base at the South Pole, although this cannot be ascertained from the information available to us. Hitler is believed to have escaped with some of his top aides to the South Pole at the ending of W.W.II. We know from the filmed second expedition of Admiral Byrd to the South Pole that there is open ground (not snow covered) in a large area of Antarctica. Also, there are reports of an opening to the center of the Earth at both the South and North Poles. (Ref.: Video Tape: "The Hollow earth, or the city of New Berlin", and books: *Skeletons in the Closet* (Phoenix Journal #13) and *The Hollow Earth*.) It is possible that the sighting of this particular "UFO" in Argentine air space tells us more about those "alien" helpers of Hitler, and perhaps others, than they intended to reveal. Hatonn has stated that the Nazis, the Communists, the Zionists, and the Masons are all the same! They are all part of the plot to gain control of our world, even though they may not always agree among themselves. The idea (plot), remember, is to create wars in order to beat the people down and take over, according to Albert Pike, Freemason leader of 1871! There must be at least two opposing groups for a war, even though the controllers of both sides may be under the same hierarchy.

I would like you to consider now some information in a book called *Initiation, Human and Solar*, by Alice Bailey, published by Lucifer Trust (now called Lucis Trust) in 1922, as reported in Edith Starr Miller's book, *Occult Theocracy*. There is a description therein of the invocation of their "god". A group of "adepts" encircle an equilateral triangle invoking the "god", which reveals itself as a "blue and white colored flame, which burneth not". Is it possible, in view of our present knowledge of the adversary's use of advanced technologies by the turn of this century, that some of those technologies were deceitfully used to awe and convince the "initiation" participants of the presence of a "god"? Hatonn has often taught that there is "no mysticism", only Truth or knowledge of which we are not yet aware! You can be sure that the one-world government bunch will exploit all of the advanced knowledge and technologies possible in order to fool and rule the rest of us. Please remember, when thinking about any combination of colors that God is Light, the Source of all colors.

I believe we must seriously consider the very real possibility that, that old dragon, Lucifer/Satan/Weishaupt, has been preparing for his take over of the Earth for sometime, and that the presence of God's Hosts are indicative of the imminence of events foretold in the biblical book of *Revelation*.

Perhaps this is a good place to remind you that Gyeorgos Ceres Hatonn in ancient times was known as George, the Dragon Slayer. Some artifacts revealing and confirming this knowledge were also found in the archeological digs in the Middle East just prior to the twentieth century. In other words, some of the old "myths" are remnants of true stories, long forgotten or

suppressed by those who came later. (Please see my book, *The Garden of Aton*, for background and research information.)

Perhaps too, in order to refresh your memories and remind you of some of the connections of the Nazis to the other groups of adversaries, it should be restated that, according to Hatonn, our enemies are the Khazarian Jews, also known as Ashkenazi Jews. Whether or not all Ashkenazi Jews are Zionists, and/or part of the adversarial plot would have to be determined by their individual activities. Ashkenaz was a decedent of Gomer, a descendant of the biblical son of Noah named Japheth. The Gomerites came from the area of the Black Sea and settled in central Europe. The Khazars came from the Caucasus Mountains and also the Black Sea area known as Gothland (or Goatland), and were subsequently known as Goths. They are a mixture of Nordic, Mongolian, Russian, Turkish races. Most of the ruling houses of Europe, the Baltics, and even two of the Emperors of the old Roman Empire were Khazars (Goths). The Khazars chose the religion of Judaism in the eighth century, A.D. However, only the King of the Khazars and his immediate family and entourage were required to be "Jews", the rest of them could be whatever they liked, although all Khazars remained under the rule of the King of the Khazars. It is a fact that the Jewish language, called "Yiddish", is composed of many old Gothic words. At present this language is called Judeo-German! Further, Hatonn stated that the name "Nazi" came from the word Ashkenazi, which, according to the Jews (Ref.: *Encyclopedia Judaica*) means Germany! The connection of this word to the actual leaders and/or instigators of the Nazis will become more clear to you when you carefully consider the use of the word "Nazi" as a label, supposedly an acronym referring to the National Socialists, under Adolph Hitler. If such was intended why is a "z" used instead of an "s" to stand for "Socialist"? Even a word such as "Naso" would have more relevance to the National Socialists than does the word "Nazi". Or, if the word Nazi was intended to convey the meaning of "Germany" or "Germans", why use a Jewish word, especially under Hitler's regime?

You may be surprised to learn that "Nazi" is the correct Gothic spelling and pronunciation of the English, "Nasi", and that "Nasi" means "Prince of the Captivity" to the Ashkenazi Jews. This title, strangely used to identify Hitler's political party, is now a complimentary title given to the head of the new state of Israel! In other words, it appears that World War II was fomented, carried out in all its horror, and ended by one group only, using the various pseudonyms of supposedly multiple "isms"! According to Fritz Springmeier, in his book, *The Top 13 Illuminati Bloodlines*, there are circumstances which make it possible that Hitler was actually a member of the Rothschild Bloodline!

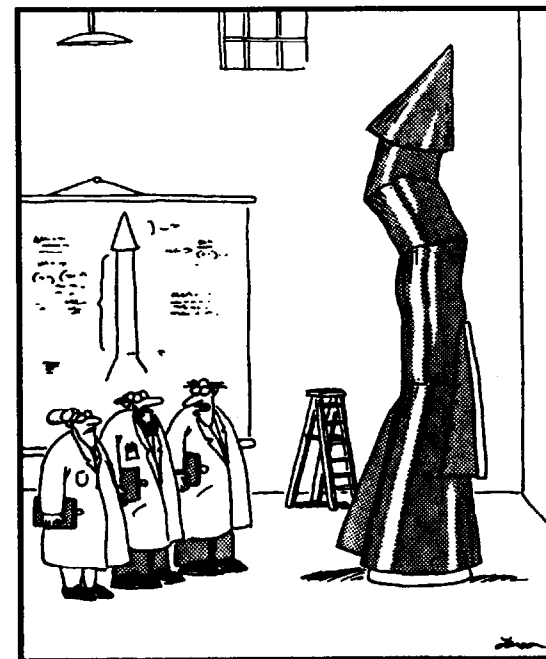

Please, readers, allow us just a moment to balance the scales so that we can focus on the entropy and confusion without distraction. Oxymoronic statement or petition? No, for it is the myriads of chaotic fragments of demanded attention which destroy the orderly thought sequences. Is he not rather obligated to get what is public information from public resources? Oh well...! If tit for tat, I would imagine that this lawyer could be caused to bring forth everything regarding everything these companies have written, for instance, all sales, to check patterns, witnesses, etc. (They say they destroyed the information in a "timely" manner.) Is not the very destruction of such relevant material unlawful in an ongoing case? Is that not deliberate denial and destruction of obviously pertinent evidence? All legal notations regarding even the opposing attorney's notes and phone notes should be demanded because he MAY have a pattern of destroying information from files and misrepresenting the case facts—even at depositions and before and to the Bench. Why might (d)harma not be obliged to produce demanded "stuff"? Because journalistic privilege and privacy of resources and sources is certainly as SACRED and private as any attorney-client privilege. Is this destruction by the opposition not pretty unlawful IN AN ONGOING CASE CONCERNING THOSE PROCEDURES? LAWYERS: **THINK!!!** All lawyers are taught carefully to think—especially

about fees! If you have a case worth some \$215,000 and over a million \$\$ have been poured into fees, wouldn't that seem to be because SOMETHING was wrong with that sale on sale day? If the opposing corporations and people are willing to spend \$600,000 in arguing the case, doesn't this likely MEAN THAT YOU WILL FIND ALL SORTS OF SIMILAR CIRCUMSTANCES IN THOSE FILES—THAT THEY SAY ARE "GONE" (OOPS!). SOUNDS LIKE THE ROSE LAW FIRM IN ARKANSAS, DOESN'T IT? It is really more interesting, however, that the focus is on everything ELSE rather than the "No Sale", so doesn't that also tell us a lot more than meets the eye?

Perhaps a few definitions might help sort the problem areas. We do not even pretend to know much about the law as is practiced these days but I would suggest that some definitions are not too likely to change from one *Black's Law Dictionary* to the next. With this possibility in mind, let us consider "journal":

**"JOURNAL:** A daily book; a book in which entries are made or events recorded from day to day. The place where transactions are recorded as they occur or as in a diary, the entry of ongoing and regular entries on various subject matters.

"In maritime law, the journal (otherwise called "log" or "log-book") is a book kept on every vessel, which contains a brief record of the events and occurrences of each day of a voyage, with the nautical observations, course of the ship, account of the weather, etc. In the system of double-entry bookkeeping, the journal is an account-book into which are transcribed, daily or at other intervals, the items entered upon the day-book, for more convenient posting into the ledger. In the usage of legislative bodies, the journal is a daily record of the proceedings of either house. It is kept by the clerk, and in it are entered the appointments and actions of committees, introduction of bills, motions, votes, resolutions, etc., in the order of their occurrence.

**"JOURNAL ENTRY.** A recording in an accounting journal of equal debits and credits, with, when necessary, an explanation of the transaction. Also a compilation of regular entries of information on various subjects or ongoing notations, comments or directives.

**"JOURNAL ENTRY RULE.** Regularity of enactment of statute may be inquired into by examining legislative journals.

**"JOURNALISTS' PRIVILEGE:** In the law of defamation and, or, privacy privileges, a publisher is protected in actions of defamation *if the publication constitutes fair comment on the subject of public officers and employees in matters of public concern.*"

If the journalist believes his own comments to be true he is protected in his 1st Amendment rights to speak, write, publish or print as in Freedom of Speech. If information from other resources is utilized then the reference is presumed to be the opinion of the original speaker, writer, publisher or printer.

Now let us turn in the same dictionary to "Privilege" as applies in this matter:

**"Discovery:** When interrogatories, depositions or other forms of discovery seek information which is otherwise privileged, the party from whom it is sought may claim his privilege. Fed. R. Civil P. 26; Fed. R. Crim. P. 16. See "Protective order"; *Work product rule*. [H: The latter "Work Product Rule" deals with notations, etc., of parties in preparation of their case, presentation, articles and other materials relevant to a given profession or occupation."

OK, let us consider a protective order and what that might mean:

**"Protective Order:** Any order or decree of a court whose purpose is to protect a person from further harassment or abusive service of process or discovery; see e.g. Fed. R. Civil P. 26(c); Fed. R. Crim. P. 16(d)(1). See also Gag order; Protection order."

Let us now look at the first portion of definition of "Harassment" and see if that, too, fits this particular case in point of Mr. and Mrs. Ekker at the hands of opposing attorney:

**"Harassment:** As defined in federal statute providing for a civil action to restrain harassment of a victim or witness, is "a course of conduct directed at a specific person that causes substantial emotional distress in such person and serves no legitimate purpose." 18 U.S.C.A. sub. 1514(c)(1). Term is used in a variety of legal contexts to describe words, gestures and actions which tend to annoy, alarm and abuse (verbally) another person; e.g., the use of "obscene or profane language or language the natural consequence of which is to abuse the hearer or reader...."

Now let us move on to a definition that DOES also fit this case in point where all documents, writings, articles, backup material, sources and resources are demanded.

**"Newsman's privilege (*Black's Law Dictionary*):** *The alleged constitutional right (freedom of speech and press) of a newsman to refuse to disclose the sources of his information. (See Shield Laws).*

**"SHIELD LAW. Statutes affording a privilege to journalists not to disclose in legal proceedings confidential information or sources of information obtained by them in their professional capacities. Cf. N.Y. McKinney's Civil Rights Law sub. 79-h.**

**"RELEVANCY:** ...Relevant evidence is such evidence as relates to, or bears directly upon, the point or fact in issue, and proves or has a tendency to prove the proposition alleged; evidence which conduces to prove a pertinent theory in a case. It does not mean evidence addressed with positive directness to the point but that which according to the common course of events, either taken by itself or in connection with other facts, proves or renders probable the past, present or future existence or nonexistence of the other.

**"Relevancy of evidence refers to its probative value in relation to the purpose for which it is offered. Term describes the logical relationship between a proffered item of evidence and a proposition that is material or provable in a given case."**

So, in plain questioning: What could Mr. Horn's asking Mrs. Ekker if she is "anti-Semitic" have to do with an advertised public auction sale of the property on which Ekkers held a land contract eight years ago? THERE WAS NO SALE! THAT IS THE ONLY ISSUE AT POINT!

If the opposition in this case actually believes there was no funding with the Ekkers on that "sale day" would not that have been established AT THE SALE? And, further, is it plausible that if there was or was not a sale it could have been settled immediately by holding the said-sale which would require valid currency exchange, OR, by honoring the request of the Ekkers and their attorney for and by "request for another sale" being granted wherein the Ekkers even offered to PAY FOR THE SALE. After all, a sale only costs at most, a couple of hundred dollars! THERE WAS NO SALE!

And remember: The auctioneer in point gets somewhere around \$21 to \$25 to call a sale. In this case,

however, there is some \$800 TO \$1,000 UNACCOUNTED. Don't you find it interesting how many times Mr. Horn repeated the supposed sale amount, which is some \$800 more than the advertised amount?

Now to further consider what information could be in any journals and news items relevant to this case requires stretching of the imagination since Mrs. Ekker was NOT writing journals or newspaper articles at the time in question. The NO SALE in point was dated May 24th, 1988. She began her work, if you check the journal publications, over a year afterwards! This is not a double or triple murder trial, readers, this is a civil confrontation over one point: Ekkers went to purchase their home with viable and liquid funds in hand. THERE WAS NO SALE AS ADVERTISED OR NOTIFIED VIA CERTIFIED MAIL AND POSTING OF PROPERTY. Would you not think Santa Barbara Savings would be at least as concerned about THAT auctioneer as Ekkers? Wouldn't you think that there would be NO COVER-UP instead of joining in a conspiracy of giving him 3 non-existent witnesses and a real estate agent as observers? Something is WRONG WITH THIS PICTURE! So, what does Mrs. Ekker's attitudes about Semites have to do with that day eight years ago? Or with ANYTHING? Is this not a good example of intimidation and harassment of a published journalist? Is Mr. Horn *Anti-Christ*? Does this disallow him from continuing to be a lawyer? Now, how, for goodness sakes, can being pro-Semite AND pro-Christ end up corrupting her to the point of Mr. Horn's disdain and insulting demeanor? Mr. Horn is a lawyer asking the questions and Mr. Green is the one who publishes selected nasty notations FROM THESE DEPOSITIONS all over the globe, so one feels one has the right to speak in journalistic/diary fashion on these parties and subjects. The JUDICIAL system is a point of great interest to the public as well. And, Mrs. Ekker can read a dictionary as well as anyone around, I would presume.

Mr. and Mrs. Ekker are the epitome of a journalistic TEAM which identifies both as JOURNALISTS. Moreover, all published material has a basis under published materials whereby ALL is available to anyone and everyone unselectively, including Mr. Horn. Does this not reek of control of press, speech and FREEDOM OF RIGHTS UNDER THE CONSTITUTION AND BILL OF CITIZEN'S RIGHTS?

Even Mr. and Mrs. Clinton seem to have RIGHTS of non-disclosure, or whatever they CHOOSE to invoke. Does it mean that Ekkers have no right to forget a thing after eight years, or is it a ban on their rights if they keep notes? And, if a victim is bound to truth—WHY IS NOT THE ATTORNEY? Mr. Horn gave the Discovery Masters totally erroneous information in his case summary without seeming negative recourse for the lies and semi-lies. He didn't even get the amount of the check in point correct. If a printed number cannot be repeated accurately, then how can you trust ANYTHING ELSE IN THE DOCUMENT? Well, the document was not presented in time to correct anything nor even have Ekkers' attorney read it, so what have you? Is THIS TRUTH written in this journal entry somehow against the law because it focuses on an attorney who misinformed through his own writings? Lawyers obviously have privileges that citizens do NOT have; but, do they have more rights than media or press journalists and newspaper writers who speak the truth or, at the most, their OPINIONS? I would think that, as an OFFICER OF THE COURT, it would be less than correct, even politically, to introduce invalid and irrelevant documents or statements—or to remove ANY documents which are part of a court FILE from that file and dispose of them elsewhere. I believe, further, that it is unlawful to dispose of documents of pertinent relevance to a particular case ongoing as claimed now by Mr. Horn of his client's disposal of old manuals and procedures which are THE DIRECT INSTRUCTIONS TO AUCTIONEERS AND EMPLOYEES, AUCTION RULES AND REGULATIONS AND THUS AND SO.

This case is a CIVIL matter and when information

of total lies from a recognized criminal in Montana is utilized and scattered around, by the opponent, is not TRUTH suitable for the defense? Mr. Horn is now basing all of his CASE on George Green's offerings; is this not really INTERESTING? George Green did not even enter the lives of Ekkers until the Fall of 1989. This seemingly "small" cluster of stars, well known even if only visible best through peripheral-vision sight, is actually very big and VERY BRIGHT. Is it too far away or too close—which is it? Neither, it is exactly PERFECT in placement. You are simply constrained by your visual limitations in that the Pleiades has the type of Light that is seen best through the rods of the eye and not through the cones of the physical eye. There is a good REASON for that phenomenon but that is for another day and another lesson on "vision".

This "little" cluster of "somethings" is recognized throughout history and right into the current myths of all original tribes. They have been known as the "Seven Sisters", the "Daughters of Zeus", "The seven nymphs of Poseidon" as associated with "Dorian" woman. As the "daughters of Zeus" they are called Maia, Electra,

Celaeno, Taygeta, Asterope, Merope, and Alcyone. Mothers of Greek gods, they are believed to have been turned into stars by Zeus so that they might be safe from Orion, who had chased them for several years. There are no stars so widely acclaimed as these; their beauty and grace are spoken of in literature from all cultures, past and present.

*The Pleiades were among the FIRST stars mentioned in astronomical literature, appearing in Chinese annals of 2357 B.C.*

## BEGINNINGS

Sappho, Euripides and Homer referred to the Pleiades in their writings. Later, in *The Rubaiyat* written by the poet-astronomer Omar Khayyam in 1123, they were referred to as "the Begetters", as "beginning all things"; while half a world away, ancient Peruvian legend identified the Pleiades uniquely as "the arbiters of human destiny". In China, they were worshipped by young women as "the Seven Sisters of Industry", and in ancient times were known as "Mol", the constellation "Or Gang". Milton called them "the Seven Atlantic Sisters". Manly P. Hall, in *The Secret Teachings of All Ages*, stated that, "The sacred Pleiades were famous to freemasonry as the Seven Stars of the upper end of The Sacred Ladder." As "the Seven Sisters" they are familiar to most, and as "the Seven Stars" they are one of the few star clusters mentioned throughout the Bible. And boy, does that one make the Khazarians mad as Hell and they refuse to take it any longer!

The German astronomer Bessel stated that the Pleiades are literally a cluster of suns drifting together in one direction, led by the brightest of the seven, Alcyone, which the early Arabs referred to as Al Jauzah or Al Wasat. Now, for a personal reference if I might: I, Hatonn (Aton) am also known to some AS *Alcyone*, but more often in the circles of the Ancient lands I am often referred to as El Wasat. I think you can coyly remember that by another term phonetically spelled Al What-is-that (Whatzat?). Al became recognized better as El because it indicates "elder".

Now, I don't suggest you rush out to your local mountain top and make a fool of yourselves. Number one, the star system is not made up of suns, although they could be claimed to be honored as SONS of the ONE LIGHT, ATON. Now you may be able to relate to the label "Hatonn" a bit more easily. Again, if Duggah told you differently, remember something: I have a much longer history than does a Duggah from the constellation Orion and in-between mislabeled spot-check-points. I even go back further than the old buddies, Ramtha or Bashar (meaning "Commander" or "messenger") from Assassenia. Now, good friends and readers, it must be noted that Alcyone shines to its sister stars with eighty-three times the brilliance of Sirius and that its brilliancy is one thousand times greater than that of your Sun.

Located in the constellation TAURUS, the Bull, the Pleiades (Plee' ya deez) look like a small reproduction of the Big Dipper and are often mislabeled the Little Dipper or the Wee Dipper. They are approxi-

mately 500 light-years from Earth as calculated by mortals who have no idea of what they speak. The stars of the Pleiades are clustered closer together than in ordinary space, averaging no more than one light-year between stars.
