## FLUSH WITH ANGER; WE SHOULDN'T STAND FOR TOILET LAW

If you call yourself an American, you need to know about a crucial issue that is now confronting the U.S. Congress (motto: "Remaining Firmly in Office Since 1798"). This is an issue that affects every American, regardless of race or gender or religion or briefs or boxers; this is an issue that is fundamental to the whole entire Cherished American Way of Life.

This issue is toilets.

I'm talking about the toilets now being manufactured for home use. They stink. Literally. You have to flush them two or three times to get the job done. It has become very embarrassing to be a guest at a party in a newer home, because if you need to use the toilet, you then have to lurk in the bathroom for what seems (to you) like several presidential administrations, flushing, checking, waiting, flushing, checking, while the other guests are whispering: "What is (your name) DOING in there? The laundry?"

I know this because I live in a home with three new toilets, and I estimate that I spend 23 percent of my waking hours flushing them. This is going on all over America, and it's causing a serious loss in national productivity that could really hurt us as we try to compete in the global economy against nations such as Japan, where top commode scientists are developing super-efficient, totally automated household models so high-tech that they make the Space Shuttle look like a doorstop.

The weird thing is, the old American toilets flushed just fine. So why did we change? What force would cause an entire nation to do something so stupid? Here's a hint: It's the same force that from time to time gets a bee in its gigantic federal bonnet and decides to spend millions of dollars on some scheme to convert us all to the metric system, or give us all Swine Flu shots, or outlaw tricycles, or whatever. You guessed it! Our government!

What happened was, in 1992, Congress passed the Energy Policy and Conservation Act, which declared that, to save water, all U.S. consumer toilets would henceforth use 1.6 gallons of water per flush. That is WAY less water than was used by the older 3.5-gallon models—the toilets that made this nation great; the toilets that our Founding

Fathers fought and died for—which are now prohibited for new installations. The public was not consulted about the toilet change, of course; the public has to go to work, so it never gets consulted about anything going on in Washington.

But it's the public that has been stuck with these new toilets, which are saving water by requiring everybody to flush them enough times to drain Lake Erie on an hourly basis. The new toilets are so bad that there is now—I am not making this up—a black market in 3.5-gallon toilets. People are sneaking them into new homes, despite the fact that the Energy Policy and Conservation Act provides for—I am not making this up, either—a \$2,500 fine for procuring and installing an illegal toilet.

I checked this out with my local plumber, who told me that people are always

asking him for 3.5-gallon toilets, but he refuses to provide them, because of the law. The irony is that I live in Miami; you can buy drugs here simply by opening your front door and yelling: "Hey! I need some crack!"

Here's another irony: The federal toilet law is administered by the U.S. Department of Energy. According to a *Washington Post* article sent in by many alert readers, the DOE recently had to close several men's rooms in the Forrestall Building because—I am STILL not making this up—overpressurized air in the plumbing lines was CAUSING URINALS TO EXPLODE. That's correct: These people are operating the Urinals of Death, and they're threatening to fine us if we procure working toilets.

The public—and this is why I love this nation—is not taking this sitting down. There has been a grassroots campaign, led by commode activists, to change the toilet law, and a bill that would do that (H.R. 859—the Plumbing Standards Act) has been introduced in Congress by Rep. Joe Knollenberg of Michigan. I talked to Rep. Knollenberg's press secretary, Frank Maisano, who told me that the public response has been very positive. But the bill has two strikes against it:

1. It makes sense.
2. People want it.

These are huge liabilities in Washington. The toilet bill will probably face lengthy hearings and organized opposition from paid lobbyists; for all we know it will get linked to Whitewater and wind up being investigated by up to four special prosecutors. So it may not be passed in your lifetime. But I urge you to do what you can. Write to your congresshumans [*humans?? isn't the writer being extra-kind??*], and tell them you support Rep. Knollenberg's bill. While you're at it, tell them you'd like to see a constitutional amendment stating that if any federal agency has so much spare time that it's regulating toilets, that agency will immediately be eliminated, and its building will be used for some activity that has some measurable public benefit, such as laser tag.

So come on, America! This is your chance to make a difference! Stand up to these morons! Join the movement!

Speaking of which, I have to go flush. [End quoting]

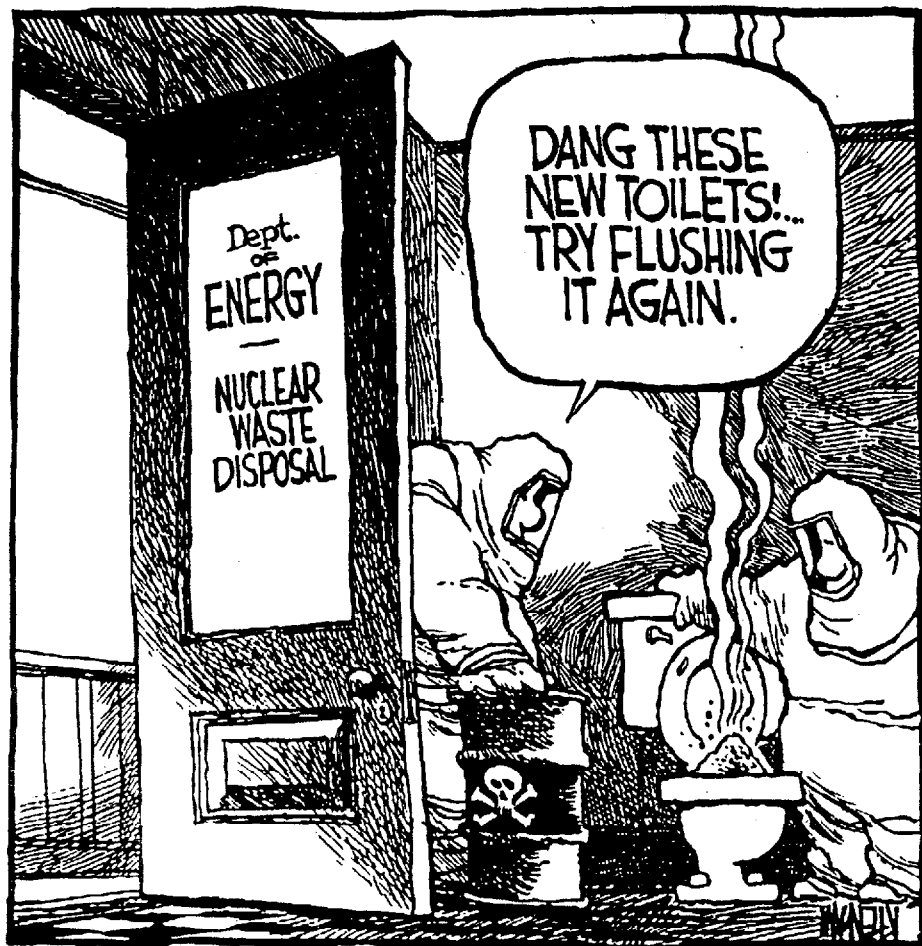
This should be pushed as an ecology and environmental issue—think of all the water and time we would be saving.

## TAX BILL TARRED

Congress should restrain its cheering over the new tax-cut bill. As often is the case when lawmakers tinker with tax laws, some shenanigans occurred.

Unbeknownst to the public and apparently most members of Congress, a last-minute change was made in the bill to give the tobacco industry a big tax break—and undercut the settlement reached in June between the industry, state attorneys general

and lawyers representing smokers and their families.

The settlement required the tobacco industry to pay about \$18 billion a year for 25 years into a fund for victims.

But the change approved Thursday could reduce the payout by as much as \$2.5 billion a year—the amount of money that is expected to be raised by the newly approved 15-cent-a-pack increase in the federal cigarette tax.

This in effect shifts more of the burden of the effort to fight smoking from the companies that profit from their dangerous products to the people who are hooked on them.

The sneaky provision also provides more evidence of the clout of the tobacco industry in Congress. Current House members reportedly received \$1.3 million from industry political action committees for their last campaigns, with nearly \$1 million going to Republicans.

Rep. John Spratt, D-S.C., one of the budget negotiators, said: "I'm surprised to see this in the final agreement, because the meetings I was at, the administration dismissed it out of hand. But stuff happens."

Sen. Richard Durbin, D-ILL., tried to reopen the tax bill for debate in order to challenge the last-minute favor to the tobacco industry. His move, however, was rejected on a 78-22 procedural vote.

The tobacco deal was handled so secretly that most of the opponents didn't get wind of it until they saw a copy of the bill on an Internet home page controlled by House Speaker Newt Gingrich. That was the only copy of the measure available to outsiders, because Congress' bill-printing process couldn't keep up with the legislative railroad.

Fortunately, what transpired last week isn't necessarily a done deal. The settlement of the tobacco litigation will require separate congressional approval, giving lawmakers an opportunity to right this wrong.

Further, the windfall for the tobacco industry—it was among about 80 special provisions in the tax bill—would seem to be an ideal candidate for a line-item veto under the new powers granted the president by Congress.

The tax cuts on the whole should be good for the people and the economy. But members of Congress should be careful about slapping themselves on the back. Their hands are stained with tobacco tar.

Better they should come clean and admit the error of their ways. [End quoting]

### FRESH WORRY: DEVASTATING TOMATO VIRUS

It has shown up  
for the first time in the country  
in South Florida.  
It stops plants from producing  
marketable tomatoes.

A virus that devastates tomato production has been found in South Florida—the first such discovery of the disease anywhere in the United States.

Tomatoes are Florida's leading commercial vegetable crop, and the timing of the find is particularly bad because the state is already battling citrus canker and Mediterranean fruit flies.

"We have a potential epidemic on our hands," said Jane Polston, a plant pathologist with the University of Florida's Gulf Coast Research and Education Center in Bradenton.

Polston discovered the tomato yellow leaf curl virus a week ago on small tomato plants being sold to consumers at nursery stores in Charlotte, Collier, Dade and Sarasota counties.

The virus does not affect humans or animals but prevents tomato plants from producing large, marketable tomatoes.

Polston, who met Tuesday with other scientists and growers in Bradenton, said the disease wiped out 90 percent of the tomato crop in the Dominican Republic in 1992.

Florida tomato growers said it's too early to determine the extent of the threat to their \$400-million-a-year industry. There are no tomato fields in production at this time of year in Florida, but fall planting will begin soon.

"We don't have the facts yet," said Wayne Hawkins, executive director of the Florida Tomato Committee in Orlando. Hawkins said growers fear that consumers may misunderstand the nature of the threat and stop buying tomatoes.

"A big red flag has been raised, but so far that's all," Hawkins said.

Any tomatoes in stores have not been affected by the virus, and the disease does not harm humans in any way.

A number of different viruses and fungi organisms attack tomatoes, and resistant plants are produced regularly by scientists for sale to farmers as well as home gardeners. But Polston said a tomato variety resistant to the leaf curl virus is at least three or four years away.

Ernest Hiebert, a professor of plant pathology with the University of Florida in Gainesville, said the infestation appears to be in the early stages and could be contained during the next two months—before the fall tomato growing season begins.

Hiebert said home gardeners can help by destroying any potentially affected plants they may have bought at garden centers. Another way they could help, Hiebert said, is in controlling whiteflies more vigorously with pesticides.

Whiteflies pick up the disease while feeding on

infected tomato vines and spread it to other plants, including many kinds of weeds and other foliage. [End quoting]

This is probably another one of the Elite's "planted bugs"—and it may well do more than "just" damage a tomato industry.

### CAN YOU READ THIS?

From *MEDIA BYPASS MAGAZINE*, July 1997, [quoting:]

A new program funded by a charitable foundation will award university honorees on the basis of their commitment to teaching the *interdependence* [*emphasis mine*] of political freedom [*If you are forced to be dependent how can you be free?*], the market economy and the moral principles that sustain a free society.

The John Templeton Foundation on May 21 kicked off the "Templeton Honor Rolls for Education in a Free Society" at a ceremony in the Russell Senate office building. \* Arguing against knowledge of grammar and logic, Professor Jay Robinson of the University of Michigan says that "the myth of basic skills" helps sustain rigid and evil class structures; what college kids really need is reaffirmation as members of "racial, social and linguistic minorities".

\* The National Association of Scholars' devastating report on the dumbing-down of college curricula, which includes courses for credit like "queer theory" and the works of Pee Wee Herman. [End quoting]

### BONDING FOR STRENGTH

From *POPULAR SCIENCE* magazine, August 1997, [quoting:]

Talk about getting together! The United States and Russia are collaborating to commercialize a process that could produce stronger bonds for cars, planes, and orthopedic components by squeezing together microscopic nanopowders.

The new technique, invented in Russia, is called severe plastic deformation. It subjects ceramics, metals, and alloys to stresses—using loads as heavy as 400 tons per square inch—that break down the materials' grains into microparticles less than four-millionths of an inch in diameter. The result: materials of exceptional strength and resistance to wear. Otherwise brittle ceramics can become malleable, and parts derived from nanopowders of copper, iron, aluminum, and titanium are as much as 10 times as strong as their conventional counterparts.

The technique is the first practical way to fashion high-strength biomechanical and industrial components from ultrafine powders, says Emil Strumban, general manager of Synmatix Corp. in Southfield, Michigan. Synmatix is working with researchers from Los Alamos National Laboratory and three Russian scientific facilities to refine and market the process, which is already being used to manufacture titanium bone implants in Russia. [End quoting]

Slowly, the Elite are letting we-the-people in on some high-tech knowledge—but notice how they still benefit financially by allowing it.

### IMPORTED FOOD IS MAKING US SICK

And a newly identified germ—a hardy parasite called cyclospora—is stumping health officials.

From *THE ORLANDO SENTINEL*, 7/28/97, [quoting:]

It's Montezuma's revenge—right in your own kitchen.

More Americans are getting sick from fresh fruits and salads imported from developing countries, and at least one of the newly identified germs is stumping health officials.

So far this year, about 1,400 cases of cyclospora infection have been reported nationwide, although health officials think the numbers are much higher. Symptoms include diarrhea, fatigue, dramatic weight loss and despair, which can go on for weeks if unchecked.

"We think only the tip of the iceberg is reported on cyclospora sickness," said Dr. Barbara Herwaldt of the Centers for Disease Control and Prevention. Many people do not report their illness, and the problem is so new doctors have not been primed to look for it, she said.

Scientists are unsure how the parasite is transmitted and whether it infects animals other than humans. They do know it is hardy and highly resistant to chlorine, so washing produce in the kitchen sink may provide no prevention.

Herwaldt and dozens of other doctors, scientists and food-safety experts gathered in Washington last week to pool information on the parasite. The meeting was called by the Food and Drug Administration, responsible for safeguarding much of the U.S. food supply.

Most of the outbreaks of cyclospora sickness this year and last have been linked to fresh raspberries from Guatemala. In May, the FDA suspended raspberry imports from that country and now is weighing whether to lift the ban this fall, when seasonally the risk of the cyclospora disappears.

But in the past few months Americans also have caught the parasite after eating imported mesclun—a mix of various types of baby lettuce leaves—or fresh basil. [End quoting]

Every week it seems we are bombarded by a new "bug scare". Is this one step at a time toward incapacitation of we "useless eaters"?

### BANK OF ENGLAND IS OFF THE HOOK ON BCCI CLAIMS

LONDON—The bank of England was widely accused of lax supervision of rogue bank BCCI, but a judge ruled Wednesday that the central bank doesn't have to worry about paying any money to BCCI's creditors. The judge threw out a lawsuit in which BCCI liquidators sought about \$900 million from the Bank of England, saying there were no grounds for a court battle because banking regulators did not "dishonestly" mismanage the BCCI affair. International banking regulators closed the Bank of Credit and Commerce International in July 1991 in what has been described as history's biggest banking fraud. [End quoting]

## MAVERICK FINANCIER GOLDSMITH DIES

His political party  
helped Britain's Liberals win  
landslide victory

Sir James Goldsmith, the cosmopolitan billionaire who formed his own political party to crusade against European unification, has died after a long battle with cancer. He was 64.

Mr. Goldsmith's loved ones — his wife, ex-wife, mistress and eight children — are "united in grief," said his British spokesman, Patrick Robertson.



Sir James Goldsmith: Was opposed to European unification

The son of a British Jewish father and French Roman Catholic mother, Mr. Goldsmith was a citizen of both countries and lived a life without borders. But he abhorred the European Union as a German-dominated threat to British sovereignty.

Mr. Goldsmith's fortune—including millions made during the 1980s when he was a corporate raider in the United States—is estimated at between \$1.7 billion and \$2.4 billion.

He turned to politics after retiring from the business world in 1990, having built a fortune in food processing, retailing and stock dealing.

Mr. Goldsmith's cause was opposition to the Maastricht Treaty, which calls for creation of a single currency as well as common foreign and security policies among the 15-member European Union.

As a financier, Mr. Goldsmith was renowned for his sense of market timing. His investment motto: "If you see a bandwagon, it's too late." [End quoting]

All the other freedoms will naturally follow after that, once we have learned to take responsibility for ourselves, not only on third density, but on other levels as well. [End quoting]

Though interesting to consider, always read these types of writings with much discernment.

## PRINCE PHILIP DEPLOYS 'ANTI-CORRUPTION' WEAPON

[H: I will give you more reference material regarding this author as we move along into better security for same. Suffice it to say he has access to his information and is willing to share it so please let us not push his safety defenses.]

It has been five years now, since the Jacobean assault was launched against the Italian state. By throwing to millions of citizens terrorized by the economic depression, the bone of an "anti-corruption" crusade, the magistrates of the so-called "Clean Hands" team succeeded in politically decapitating the country. [H: Continue to watch for sequels at your local "anywhere" country theater.] A large part of the political and industrial elite still linked, to some extent, to the idea of economic development and national sovereignty, has been swept away by well-targeted scandals.

Suddenly, almost the entire Italian media became fanatic groupies of the "Clean Hands" Grand Inquisitors, such as Saverio Borrelli, Piercamillo Davigo, Gherardo Colombo, and international superstar Antonio Di Pietro. Di Pietro, who left the magistracy following accusations of corruption, has profiled himself as the "New Duce" who will root out corruption forever.

The victims of this vicious system are innumerable. Often the victim is selected as a warning to someone else, or to force him to submit to some political demands. No matter whether the accusations are true or false, the accused is immediately lynched by the media, which receive all the details of an investigation which is legally supposed to be secret; the victim's career is over, and sometimes he pays with his life. The most recent case of "murder by indictment" was that of Alessandro Sodano, brother of the Vatican secretary of state, who became seriously ill after having been arrested in February 1994, in Asti, and accused of corruption, together with several city officials. At the trial, everybody was acquitted, but Sodano died at the beginning of July 1997. [H: Hummnnn!]

Now, a defenseless Italy is ready for the butcher,

in the form of a final assault against its industrial patrimony, the living standards of its citizens, its republican institutions, and national integrity. But how could such a coup d'etat come about? What forces could mastermind it?

The answer appeared in one of the main Italian dailies, *Il Giornale*, on April 18, in a front-page article by Gianluigi Nuzzi. Nuzzi placed Operation Clean Hands in the broader international context. He described the modus operandi of the gigantic organization called TRANSPARENCY INTERNATIONAL (TI), dedicated to "fighting corruption nationally and internationally". [H: Keep paying close attention, readers.] He described how Transparency had opened an Italian branch on Jan. 20, its connections with the "Clean Hands" magistrates, and its symbiotic relation with the World Bank. Finally, he dug into Transparency's "theological foundations" and found the man hiding behind the murky transparency; he published the forbidden name: Prince Philip, Duke of Edinburgh!

### A TRANSPARENT FRAUD: PRINCE PHILIP'S ETHICS

Transparency International was launched in May 1993, following a meeting at the Villa Borsig in Berlin. Among the participants was the late former president of the World Bank, and a top population controller, ROBERT McNAMARA, who had been fully converted to the idea of eradicating "corruption" from the world.

But behind the rhetoric, as Nuzzi pointed out, "close to Transparency, we find some very prominent characters of the British world. The moral-theological foundations of the organization received precious contributions from a series of meetings promoted, starting in 1984, by Prince Philip, Duke of Edinburgh and husband of Queen Elizabeth of England." Nuzzi was quoting directly from TI's own documents, in particular from its *Source Book*, a sort of guide on how to fight corruption, published in many languages and distributed all over the world with generous support from the World Bank [H: Sounds identical to World's War on Drugs to me. In other words: "how to never end corruption".] and the Ford Foundation. The book features "An Interfaith Declaration: A Code of Ethics on International Business for Christians, Muslims and Jews, 1993." It describes the meetings started by Prince Philip, under the auspices of the St. George House, Windsor. Sir Evelyn Rothschild became a "patron of this endeavour", apparently purporting to represent Judaism.

"A group of distinguished members of the three

religions convened periodically... Theologians, academics, and prominent figures active in business and government were all involved," stressed this document, carefully avoiding mentioning any names. As to the "Origin and Purpose of the Declaration", the document explains that "the globalisation of business is well under way and growing... the volume of world trade is accelerating again... Cross border investment is expanding even faster than trade... Stock and shares of any of the world's largest enterprises are quoted on a variety of stock exchanges..." Thus, "its purpose is to set out an ethical basis for international business. It includes some principles and guidelines for practice to help business people, traders and investors... It also gives guidance in resolving genuine dilemmas which arise in the course of day-to-day business... There is evidence that morality and ethics standards are declining in their [the participants'] respective societies, as exemplified by the wide reporting of dishonest and corrupt practices. Part of the problem is an ambivalence concerning what is considered right and wrong... [thus] a reiteration of shared ethical precepts in the form of a Declaration would help to sustain... the standards of interna-

tional business behaviour."

The declaration itself makes clear that there must be a sort of alliance between the "providers of finance" and "customers" and "employees" against corruption, and corruption is identified with sovereign governments and industrialists. Money lent must, of course, be repaid "at all due dates". "A business cannot operate without finance. There is, therefore, a partnership between the provider and the user. The company borrowing money shall give to the lender:

\* "What has been agreed to be repaid and on the due dates.

\* "Adequate safeguards in using the resources entrusted.

"Regular information on the operations of the business and opportunities to raise with directors matters concerning their performance..." And, among the anti-corruption duties of local and national governments, there is that of "protecting the local environment from harmful emissions from manufacturing plants... and any practice likely to endanger humans, animals or plant life." [H: Shades of Prince Albert, Team?]

Prince Philip established the "ethics rules", and suddenly in the same year, 1993, the enforcer emerges, in the form of Transparency. TI's propaganda repeatedly emphasizes the need to establish an "Anti-Corruption Authority" that is independent of governments, and to fight the corruption of the "politicians". [H: Wow, doesn't that dark glass obscuring viewing become transparent as we consider international dealings and demands?]

TI is basically a rib of other British-controlled agencies, such as the World Bank. The above-quoted article in *Il Giornale* explains: "From ideology, we are already at the bill of laws. By the end of summer, TI will conclude certain close agreements with some South American and eastern countries, to assist them in the development of national

strategies to put an end to corruption." Then the action will move to Europe; Italy is at the end of the line. The road is easy: The World Bank gives loans to developing countries and, 'TI is charged with the creation of a system of control and budget,' says the chairman of TI in Italy, Maria Teresa Brassaiolo. Brassaiolo is a city councilman in Milan for Umberto Bossi's Northern League, which is operating both legally and illegally to split the country. TI Italy was officially launched on Jan. 20 at the Milan Chamber of Commerce, at a meeting that included TI Chairman Peter Eigen and the two main bosses of "Clean Hands," Piercamillo Davigo and Gherardo Colombo. [H: Really quite a *small world* isn't it? Note that we just keep running into the same names and people everywhere we go.]

The chairman of the board of TI, former World Bank official Peter Eigen, proclaims on the Internet: "Transparency International is a not-for-profit, non-governmental organization, to counter corruption both in international business transactions and, through our National Chapters, at the national level. Our mission is:

\* "Curb corruption through international and national coalitions encouraging government to establish and implement effective laws, policies, and anti-corruption programs.

\* "Strengthen public support and understanding for anti-corruption programs.

\* "Encourage all parties to international business transactions to operate at the highest levels of integrity, guided in particular by TI's Standard of Conduct. [Barfable.]

"Our strategy is to do this by:

\* "Establishing coalitions of like-minded organizations and individuals to work with government (wherever possible) to assist in developing and implementing national anti-corruption programs.

\* "Initiating an information centre and conducting *practically-oriented* research into aspects of containing corruption... [and] broaden public awareness...

\* "Building National Chapters that foster anti-corruption programs."

Before creating TI, Eigen had worked for 25 years as World Bank manager for programs in Africa and Ibero-

America. Under Ford Foundation sponsorship, he "assisted" the governments of Botswana and Namibia. From 1988 to 1991, he was director of the regional Mission for Eastern Africa of the World Bank. [H: Boy, they certainly ended corruption over there, didn't they?]

Currently TI has chapters in more than 60 countries, and around 70,000 members. Among the

members of the Advisory Council we find a few jewels:

Peter Berry, the managing director of the British Crown Agents (CA). While TI is among the elected members of the Crown Agents Foundation, the latter is rapidly becoming the key instrument for direct operations of the British Special Air Services and other commando forces into the countries of the

British Empire. This is nothing new. Since 1833, CA has provided logistical and technical services to the British Crown colonies, especially procurement of weapons; its primary client is the British Overseas Development Administration, i.e., the administration of the "former" colonies.

**John Brademas**, chairman of the National Endowment for Democracy.

**Luis Moreno Ocampo**, a former Argentinean prosecutor, who helped try the military junta in 1985; co-founder of the Poder Ciudadano (Citizen's Power) NGO, and known as the "Argentinean Di Pietro". He is key for the destabilization of Ibero-America that Transparency is planning, and is especially dedicated to destroying any resistance to the subversion of national sovereignty. His preferred target is the military.

**Nestor-Humberto Martinez Neira**, Colombia's justice minister.

Among the funders of these anti-corruption crusaders, we find, again, Crown Agents; and the directly British corporations such as Coopers & Lybrand, Rio Tinto Zinc Ltd, Tate & Lyle, Nufield Foundation, and Rowntree Trust. Top financial contributors are the British Overseas Development Administration; the Inter-American Development Bank; BHP Minerals of Australia; Banque Bruxelles Lambert, Belgium; Bristol-Myers Squib; IBM, Germany; Arthur Anderson, U.S.A.; and the Ford Foundation. The UN is prominent in the list, especially through the UN Development Program.

### PRINCE PHILIP'S PANDORA'S BOX

TI is just the most recent tentacle of the British oligarchy, of the royal family, in its war against the republican nation-state. It is used, in particular, against the developing countries, in a process of irregular re-colonization, but Europe and the United States are also targeted. TI is deployed in parallel with the environmentalist movement, and is coordinated by the World Bank and the International Monetary Fund (IMF).

The creation of TI coincided with the "greening" of the World Bank, and the appointment of James Wolfensohn as the bank president on June 1, 1995. TI's self-proclaimed holy war against "corruption" signalled a phase change in the British underground war. The World Bank-IMF apparatus no longer limits itself to imposing deadly conditionalities and destroying its victim country through usury; now, this apparatus wants to take over gov-

ernments and states directly.

The "reforms" launched by Wolfensohn emphasize direct control of the credits granted by the World Bank *even after* they have been delivered to a particular government, on the pretext of preventing corruption. These "reforms", as we shall see, are perfectly coherent with the deployment of the TI anti-corruption stormtroopers.

### THE 'ECOLOGICAL' TENTACLE

Prince Philip, who views man as a dangerous accident who upsets the balance of nature, and thus must be limited or suppressed, made a key move in 1986, when, as international president of the World Wildlife Fund, he organized a conference on "Religion and Conservation", in Assisi, Italy. There he brought together representatives of Christianity, Judaism, Islam, Hinduism, and Buddhism to push a *pagan* agenda, a pseudo-ecumenism based on the return to Mother Nature, away from the idea of man in the image of God. "I believe that... a new and powerful alliance has been forged between the forces of religion and the forces of conservation," he said.

From April 29 to May 3, 1995, Prince Philip launched a second eco-fascist assault against religion. He gathered 60 prominent environmentalists and religious leaders at Windsor Castle for the "World Summit for Religion and Conservation".

The main threat facing the planet, he said, is population growth; thus "vital actions" are needed by both religious and non-religious bodies, to "interfere" in human activities and protect the environment from the "dramatic increase in the world's human population". "The key issue for the Conservation of our natural environment is to find ways of protecting it from the consequences of human population explosion... If you are in a process of blowing up a balloon, there is nothing to warn you that it is about to burst. We are stretching the Earth's systems like a small child blowing up a balloon."

The final press release of the event pointed to the prominent role played by two of the main British tentacles: (1) the United Nations bureaucracy, in particular the UN Environment Program. The UNEP would ask religions to be "environment monitoring agencies at the local level", while "the faiths" would be offered an increasing role in UN decision-making; and (2) the World Bank. "The World Bank has extended an invitation to faith leaders to establish a dialogue with the World Bank Directors on the Ethics of Contemporary economics."

### RELIGION AS 'INSTRUMENTUM REGNI'

It is painfully obvious that Prince Philip's aim is to coopt religions and religious leaders within a cultist Pantheon controlled by the British oligarchy. As Mark Burdman pointed out in *EIR* on May 19, 1995, "If that sounds like an attempt to use religious leaders as, in effect, operatives in a new environmental gestapo, that is in full conformity with the royal consort's prescription to the Windsor gathering."

In fact, the historical parallel that comes to mind is the beginning of the Christian era, when the Roman oligarchy, having reached the depths of depravity, corruption, and auto-cannibalistic usury, launched a utopian project to stop the influence of emerging Christianity. They tried to gather every cult in the empire, in a sort of unholy ecumenism. This was the meaning of the pantheon, a place in which each "religion" had a precise pigeon-hole, and they acted, all together, to promote the purposes and the ideology of the empire.

Finally the Romans created a super-cult, using the forms of the secret cult of Mithra, under which they tried to collect all existing religions. It was supposed to be the perfect *instrumentum regni*; it would have stopped the spread of Christianity and assured the creation of a global, eternal empire. Indeed, the Roman oligarchy was able to take over and use many of the cults; but then, the whole structure collapsed. The super-cult was the "loser".

Today, Prince Philip and his legions are fully involved in making religions their instruments. The Catholic Church has been one of their main targets. One of their most recent meetings took place on June 9-10 in Rome, titled "Economic Modernization, Democratization, Social Justice". Among the participants were the chairman of the Latin American Bishops Conference (CELAM), Archbishop Oscar Andres Rodriguez Maradiaga; Msgr. Giampaolo Crepaldi, undersecretary of the Pontifical Council Justice and Peace (which hosted the meeting); World Bank President James Wolfensohn; IMF Managing Director Michel Camdessus; and INTER-AMERICAN DEVELOPMENT BANK (ALSO KNOWN AS INTER-AMERICAN INVESTMENT CORPORATION) PRESIDENT ENRIQUE IGLESIAS. According to Crepaldi, the real object of the discussion was the Ibero-American debt to the international financial institutions.

Camdessus maintained that the issue of the Ibero-American debt has been greatly exaggerated. The problem is not real! Apparently, the participants in the meeting agreed. In the dialogue with the usurers, Archbishop Rodriguez Maradiaga not only endorsed the approach of Wolfensohn and Camdessus, but used the "anti-corruption" rhetoric that closely echoes Transparency International: The problem is not the debt, the problem is the corruption of the political leaders of Ibero-America.

In an interview with the Catholic daily *Avenire*, Rodriguez Maradiaga stated: "It is not a mystery that economic aid did not reach the intended recipients. A large part of the aid ended up in the hands of corrupt people." Then, the interview took the tone of a "deal"; "Thus, a determined fight against corruption is the compensation that our countries must offer to the international financial organizations, in order to obtain a reduction of the debt; actually this is a *precondition* for the implementation of such an approach", Monsignor Crepaldi commented that the meeting established a "fertile dialogue" between the Church and the world of finance, and added that this was just "an opening phase for further dialogue... What pleased both sides was that there were more points of agreement than disagreement...."

### "PARTNERS IN DIALOGUE"

At the beginning of the process, the World Bank and the IMF were the "counterparts" of the religious institutions, not the "dialogue partners", on the issue of debt cancellation or moratorium. In 1994, in his apostolic letter *As the Third Millennium Draws Near*, Pope John Paul II had stressed: "In the spirit of the *Book of Leviticus*, Christians will have to raise their voice on behalf of all the poor of the world, proposing the Jubilee [the year 2000] as an appropriate time to give thought, among other things, to reducing substantially, *if not cancelling outright*, the international debt which seriously threatens the future of many nations."

When Wolfensohn was initially asked about this, his answer was, "The idea isn't practicable." He said that something can be done for countries that could offer guarantees, i.e., that had more to be





looted. For the others, nothing was possible. "A sort of death sentence decreed by a financial institution," commented the Rome press agency ASCA.

In September 1995, the Pope took up the issue again, "I make a pressing appeal to the International Monetary Fund and the World Bank and all foreign creditors to alleviate the crushing debts of the African nations. I earnestly ask the episcopal conferences of the industrialized countries to present this issue consistently to their governments and to the organization concerned."

The pressure on the financial tentacles of the British Empire was growing. The front against the Nazi economics of Wolfensohn and Co. was broadening. There was now also the appalling case of Bosnia, a country destroyed by a genocidal war, which the World Bank deprived of any aid until it had agreed to pay the foreign debts of former Yugoslavia. And there were many other cases of "genocide through financial means".

So the World Bank and IMF started a "dialogue" on the problem of the debt, and agreed to do something. They were no longer the enemy, but a "partner". On Feb. 12, 1996, Cardinal Basil Hume, Roman Catholic primate of England, held a seminar in London on the "debt crisis". Archbishop Rodriguez Maradiaga participated in the meeting, as did as Secretary of Justice and Peace Msgr. Diamuid Martin. Among the participants were Camdessus, IMF Executive Director Hugh Evans, World Bank Executive Director Ruth Jacoby, Bank of England Executive Director Brian Quinn, and many other officials of the two institutions. With them sat one of the individuals most responsible for the genocide and the destabilization in Africa, Baroness Lynda Chalker of Wallasey, the British minister of state for foreign and Commonwealth affairs and minister for overseas development—one of the pillars of the empire.

In October 1996, the World Bank and the IMF "acknowledged the debt problem" and pledged to do something about it. On April 7, the Catholic bishops of England and Wales, who apparently are dealing with the issue, met in London and issued a "Statement on International Debt". They wrote: "We are heartened by the new Initiative announced last October by the World Bank and the IMF to tackle the unpayable debts of the world's poorest countries. But its scope and effectiveness are still unclear, as is the extent of support among major Governments... We urge the British Government, which has played a leading role hitherto, to continue to press for long-term solutions which would allow these countries to achieve debt sustainability".

The World Bank kept offering its deadly dialogue with religions. In its spring 1997 issue, *News from ARC: Bulletin of the Alliance of Religions and Conservation* asked, "Is the World Bank getting serious about religion?" The head of ARC is Martin Palmer, the "religious affairs" adviser of Prince Philip. The article reads: "For the first time in its history, the World Bank is to ask world religious leaders for advice. They have asked ARC to organize a series of meetings, bringing together World Bank directors with senior religious leaders of nine world faiths... The purpose will be to examine and question the ethics of the World Bank, and to help it understand the values and concerns of local communities..."

That meeting did indeed take place at the World Bank headquarters in Washington at the end of May. It was sponsored by the office of James Wolfensohn and organized by Martin Palmer.

Next October in Rome, Wolfensohn, Camdessus, Archbishop Rodriguez Maradiaga, Crepaldi, and

the others who participated in the "historical dialogue" in June in Rome, on the alleged non-importance of the debt problem, will meet again, immediately before the synod of the bishops of North and South America.

[END QUOTING]

And so it goes on and on and the same power-brokers and leadership simply take other colors and names, and set up powerful governments, within governments, and come out with everything in the end—they suppose.

And where do YOU go for protection? Ah, so, it doesn't look too promising, does it?

Moreover, when you have local "little cheats" such as George Green and the attorneys of the world all doing their lie-cheat-and-thieve operations on you, it really doesn't look too good, does it?

What do I suggest? As we sit in the middle of a heat wave that seems to hang on, with its fire danger prevailing over the setting locally, we are reminded of ten years ago.

These bills are as follows:

HR 1385—The Employment, Training and Lit-

eracy Act of 1997 has ALREADY PASSED the House. It mandates further details and funding for all the "parents as teachers" psychological training, and intrusive "visits" to "monitor" how children are being raised. It also mandates that businesses in every community will dictate to the schools which types of jobs children will be trained for. interest that Americans pay to the British knighted Jews HSBC Group would be vaporized as easily as they conjured it up.

Since I first investigated Los Angeles gangster Mickey Cohen, Abraham Davidian and Harry Pregerson's Cocaine-Heroin Connection with Benny Wong in L.A.'s Old China Town in 1946, the FBI and the Jew Anti-Defamation League have built a secret file against me.

U.S. Government Agents, honest, godfearing, loyal Americans, have seen my secret files and have given me precise information as to their contents and even the exact number of pages and where other information is contained. Among the hundreds of items the files contain all the information of my 1963 meeting in Ruidoso, New Mexico with my partner Frank; Audie Murphy; Bill Decker, Sheriff of Dallas County, Texas; and U.S. Senator John Tower, at which time Tower gave us information and documented proof of who killed President John F. Kennedy. And in 1987 John Tower gave me his word that he would appear and give his sworn testimony and documented evidence of who killed JFK if Senator Joseph Biden, Chairman of the Senate Judiciary Committee, would set up official, open hearings by the Committee. Senators Arlen Specter and Joseph Biden sabotaged the evidence that was given to them and involved the entire Senate in a cover-up. 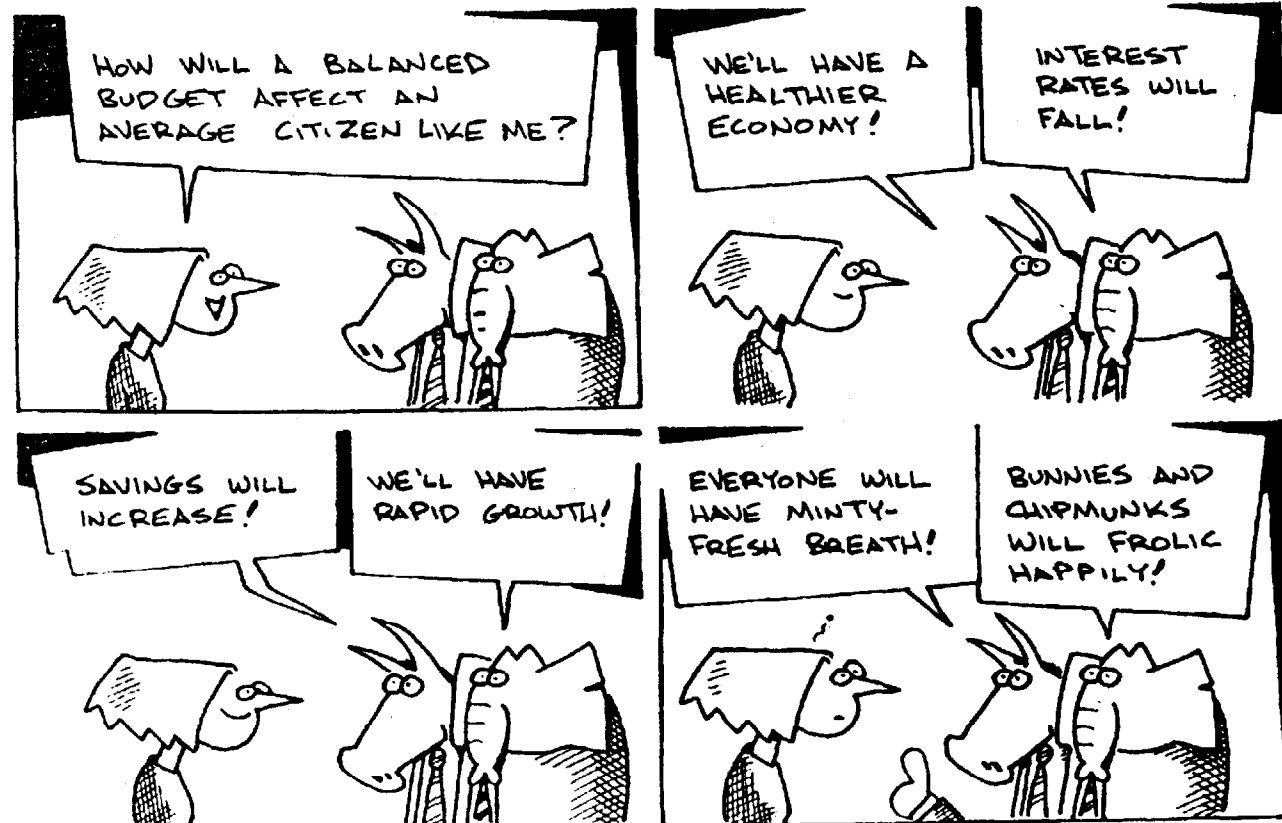

## 8/10/97 MASTER HILARION

Good morning and be at peace, my scribe, for all IS well! Master Hilarion present to continue where we left off at the end of last week's lesson. I come within the Light of Creator's magnificent and infinite spectral expression. I represent the Emerald Ray, as you would perceive same in the visible frequency range. You know me well.

We last spoke of the basics of preparation and following one's internal guidance system. We monitor the response from those of you who are taking in the information as given. We see the need to offer more upon the subject of connecting to your Higher Self.

You each are connected at all times to the higher energy of Source. However, when you are in a lower-frequency state, say due to emotional "stress", your ability to consciously connect is greatly diminished.

When you are feeling boredom, frustration, anger, or any of those states that debilitate, then you can know that your frequency has lowered and that the otherwise-free-flowing connection has been diminished or choked off. These feelings are, for most of you, associated with the heart energy center.

Many of you have experiences in your life where you were extremely excited and happy, and had a feeling that there was nothing in the world that could stop you. This is when the heart is soaring and you are vibrating at a frequency that more closely matches who you REALLY are!

When the heart energy center (your Guidance center) is radiating the higher-frequency emotions of joy, excitement, and enthusiasm, you will cause the solar plexus energy center (just below the heart center) to respond in like manner. It begins to "rev-up" and thus you begin to radiate with

greater and greater intensity. All of your energy centers are connected in a coordinated and complimentary manner. The heart center and the solar plexus are closely linked, and many will say that they have a "gut" feeling regarding a particular experience when, in fact, more of that "gut" feeling may be emanating from the heart.

There is a great amount of lower-frequency energy being radiated at this time on your planet. However, due to the nature of the energy associated with this lower-frequency state, it is such that **ONE who is radiating in a joyous state puts out more energy than a million who are radiating in the lower-energy state!** Therefore, a balance can be achieved and the process of turning around the "mess" on your planet is truly not as difficult as it may at first appear.

**As has been stated many times prior: IT ONLY TAKES ONE TO RECOGNIZE THEIR TRUE POTENTIAL AND THE GAME IS OVER!**

This means that, from the point of view of energy dynamics, if there is just ONE who functions in the physical from a position of being truly connected to Higher Source, then that ONE can so greatly tip the scales back into balanced Radiance that the dark Elite controllers of your planet would shrivel to a point of insignificance.

This is the reason for the mind control of the masses—especially as you ones spoon-feed yourselves by way of your news media and television programming. Please do not take the above statement in the wrong way. Understand that laughter is a most wonderful frequency vibration and is beneficial to your well-being. This corruption is centered around the power of suggestion.

Therefore, it is the subtle nature of suggestion that will get you, for instance, to a point that you will find humor in something that is truly twisted

and not humorous at all. Moreover, when you find yourself all wrapped up in some of the modern "bad guy" movies, then you may want to ask yourself: "Is there truly joy in this sort of violence, or am I that desensitized to actual violence that I have become numb to it?"

Recognize that the "numbness" of mind keeps you off balance and in a mode of seeking something of even greater "shock" value in order to register the slightest charge of emotional stimulation. This desensitizing situation has been built-up to such a level in recent years that the movie producers are finding it more and more difficult to pack enough violence and/or sex into a film so that the public will even want to see it! Meanwhile the desensitization causes you to lose touch with your Spiritual Center, your Guidance, your Source of Being.

We monitor many who say with the mouth that they want to feel more connected to the spiritual nourishment of Higher Self. Yet all the while these same ones sit in front of their television screens, day after day, in ritualistic fashion, filling their heads with programming that will eventually lower their frequency to such a level that they will surely be among the first to "jump through the hoops" whenever the Elite controllers say to jump through those hoops.

Large companies like Pepsi Cola, Anhauser-Busch, Colgate-Palmolive or General Motors do not pay millions of dollars for 15-second spots of advertising (brainwashing) during events like the Super Bowl because they are ineffectual. Many of you would be far wiser to spend more of your time focusing on strengthening your Inner Connection and Guidance System. It will be quite different—and instructive in its revelations!

**Raising your frequency, and thus connecting more fully with your Higher Self, is as simple as visualizing a time when you were feeling really good and resonating again with that situation as if you were there. Now hold that feeling and begin to feel it radiating from**

within you, out to the whole universe.

This is what it FEELS like to be connected at a higher frequency. You can do this anytime you desire.

Now, while maintaining this high-frequency vibration, focus your thoughts upon your desires, with that feeling of joy in your heart, and you will be a million times more powerful in manifesting your desires in the physical!

If you find it difficult to hold these higher emotional frequencies, then take a moment to look at what it is you are resisting and simply let go of it. Then, again, focus on those thoughts from times that bring forth joy you have known. Soon you will find that what you are radiating is the higher-frequency energies, and you are connecting with who you REALLY are—a Being of Light who has been endowed by God with INFINITE capabilities of creating!

Now, when you have done this, and you KNOW that you can feel this joy anytime you like, and that there is no situation wherein you cannot pull yourself out of the lower frequencies and into the higher frequencies, then it is time to focus your thoughts upon that which causes these creative energies to intensify. That is, FOCUS on the way you would like your life to be; FEEL what it will be like; RADIATE your heart's desire with the power of joy and enthusiasm—and you will be amazed at how fast change will manifest and the joy will flow into your experience like never before. A CAUTION: As I gave for background in last week's lesson, seek first a condition of balance—else you will find that you are actually more focused upon what you do NOT want, and you will miss a very fundamental dynamic of creation. If you do NOT want poverty, then don't dwell upon a perceived condition of poverty, but upon abundance!

The fundamental point here is that YOUR Higher Self connection is YOUR guidance system. And when you are properly focusing your desires, your Higher Self will offer HIGH-FREQUENCY emotional support, and well-being WILL manifest.

Always try to follow and sustain the high-frequency signals. When you encounter lower-frequency situations, look at what it is you are doing (or thinking) which has caused this encounter. Find a better way to meet the challenge. Often this means letting go of that which you are resisting (that is, change your focus). Be thankful for the experience, for you now know better where to focus your thoughts and energy.

Your Higher Self will naturally guide you through your challenges, and the resulting growth will enable you to more fully recognize your true potential. In this way you will be doing your part to turn around the low-vibration condition on your planet. If not YOU, then who?

Stop waiting for another to do it for you and you will eventually come to understand that the reason you were so disconnected in the first place

JOY and ENTHUSIASM are the signals from Higher Self that tell you that what you are focused on is in alignment with who you really are. If you are feeling otherwise, then you can know that your focus could be better.

There is no limit to the joy you can create; it is truly infinite. When you are connected and aligned in joy, your physical condition (whatever it is) will naturally return to complete balance and perfection, given enough time and persistence. Resist the alignment with Higher Self for any continued length of time, and your physical condition is likely to suffer. Why do you think that "stress" has been observed to cause so many physical illnesses?

Yesterday I received an alarming 8-page fax. It was a copy of a set of papers being distributed by a group called "Coalition For Democracy".

This group consists of 23 organizations including the Anti-Defamation League, State Pride Agenda, People for the American Way, Planned Parenthood, United Teachers, AFL-CIO, and Humanist Society [*emphasis mine*].

They are sending a "survey" to all public schools to determine "the nature and extent of activity intended to break down the constitutional separation between church and state". It refers to "concern over the growth of the Radical Right"...and "political and religious extremists' attempts to impose their religious, social and moral values on all of us". The letter emphasizes a desire to have "all future incidents documented and reported to them on an ongoing basis", and assures all parties concerned that their answers will be confidential [*If you believe this—I've got a bridge to sell you.*]. The stated purpose of the survey is to gather information on "hate crimes" [*Their definition of any of your actions that they dislike.*].

The underlying danger is that many of the "hate groups" they have listed are organizations such as the Christian Coalition, Family Friendly Libraries, Promise Keepers, American Family Association, Eagle Forum, Focus on the Family, National Association of Christian Educators, The Rutherford Institute, Traditional Values Coalition and others—which are not hate groups!

Even if the schools don't respond, the damage is already done. The hidden purpose of their survey is to link hate groups and hate crimes with known pro-family groups. This survey is a clever piece of blatant propaganda designed

to convince people that groups who are concerned with children or parents and who object to sex education and the promotion of homosexuality are associated with hate groups like Neo-Nazis!

The most insidious section was that which asked for information regarding "letters saying that...a parent does not want his/her child taught or exposed to such things as evolution, values clarification, non-academic personality tests, curricula pertaining to drugs and alcohol, discussion of the occult, education in human sexuality, globalism and anti-nationalistic curriculum..."

This group is actually requesting copies of letters written by parents who object to sex-education, curriculum, etc...and adding these parents' names to a list of those who supposedly commit hate crimes. As soon as parents object, they get painted with a "religious, right-wing fanatical nut" brush. It is urgent that we fight for the immediate removal of state laws which require parents to object to sex-education, etc., on religious grounds rather than strictly on the rights of parents to raise their own children properly.

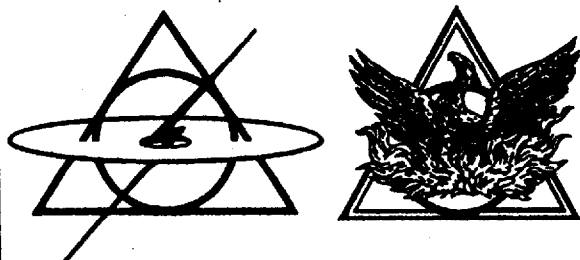
