## TREATED RATS REGAIN FUNCTION AFTER BRAIN DAMAGE

From *THE DAILY NEWS*, Los Angeles, 5/19/98: [quoting]

Brain-damaged rats that were given injections of an experimental treatment grew new nerve fibers that once again let them climb ropes, grasp food pellets and remove sticky tape from their front paws, scientists reported Monday.

Experts said the research could help lead to new approaches to spinal cord and brain injuries in humans. These injuries are particularly devastating because damaged nerve fibers in adults do not regenerate on their own.

The growth of new nerve fibers in the rats enabled them to recover their ability to function to “an amazing degree”, said Martin Schwab of the Institute for Brain Research at the University of Zurich in Switzerland. “If you test these animals for hand function, precision movements, you find a recovery of the behavior which is almost 100 percent.”

The study by Schwab and his colleagues at the University of Zurich appears in the June issue of the journal *Nature Neuroscience*.

The researchers first cut through nerve fibers in a small area of the rats’ brainstem, where the upper part of the spinal cord joins the front of the brain. That knocked out fine motor control of the animals’ front limbs. In humans, that area controls such movements as typing on a keyboard.

Regeneration of brain and spinal cord nerves is naturally inhibited by proteins in the protective sheaths of the nerve fibers. So Schwab and his colleagues devised an approach to neutralize the proteins with a specially engineered antibody, called IN-1.

Rats injected with the antibody sprouted healthy, new nerve fibers in undamaged regions of their brains and spinal cords that took over for the damaged ones. The nerves sprouted and built new connections “which automatically seem to be the right connections”, Schwab said. The damaged fibers also showed some regeneration.

The ability of the antibody to promote new compensatory growth, rather than just repair damaged nerve fibers, could be useful in treating stroke, the researchers said. Strokes tend to damage one side of the brain only.

The human central nervous system contains growth inhibitors similar to those found in the rat. Schwab already is collaborating with a large biotechnology company to neutralize them with antibodies.

“It’s an important and interesting study,” said Michael Beattie, a neuroscience professor at Ohio State University who specializes in spinal cord injury and regeneration. He called

Schwab’s results “very encouraging”.

“This study re-emphasizes the role of the noninjured nervous system in compensating for the loss of function after damage,” he said. “The work they’ve done suggests that they’re on the right track to understanding how to produce therapies that can enhance repair and recovery of function.” Story Landis, scientific director of the National Institute of Neurological Disorders and Stroke, part of the National Institutes of Health called the study “very promising”, she said.

“What makes it promising is they’ve shown a remarkable regrowth of axions (nerve fibers), sprouting of axions and functional recovery. This should definitely be tested in primates,” she said. [End quoting]

If only more medical technology were made available to the public, rather than being kept hidden for private financial reasons.

## DRUG CARTELS STUNG

### Millions Seized In ‘Dirty’ Money

Federal prosecutors announced the end Monday of the largest drug-profits laundering investigation ever, an undercover probe that started in Los Angeles, and spanned six nations, leading to more than 100 arrests.

Operation Casablanca became public when indictments of 97 people were unsealed U.S. District Court in Los Angeles. The banks were accused of laundering money for Colombian and Mexican drug cartels. “Today we have hurt the drug cartels where it hurts the most—in their pocketbooks,” said U.S. Treasury Secretary Robert Rubin in a written statement. The investigation started in 1995 and revolved around a warehouse in Santa Fe Springs, where undercover agents said they received drug money for deposit in bank accounts they had opened. Investigators said more than \$65 million, which they believe was drug money from the Mexico-based Juarez and Colombia-based Cali cartels, was processed by the banks.

“Some of that money made it back to the drug deals,” said U.S. Attorney spokesman Thom Mrozek.

Federal officials were not sure how much of that money was seized directly, but said \$35 million in cash, more than two tons of cocaine and four tons of marijuana were confiscated in spin-off investigations related to the money-laundering probe. [End quoting]

No doubt, Rubin and his gangster cohorts are overjoyed since they are probably the biggest profiteers of this confiscation. Does anyone really think that this cache of narcotics will be destroyed?? **LAWYERS:  
RUSH TO CASH  
IS DAMAGING STANDARDS**

Executives at Sporicidin Co. figured they needed a few good lawyers back in 1991. Instead, they wound up with a few dozen.

Altogether, 53 lawyers and paralegals from the Washington law offices of Baker & Hostetler logged time trying to convince federal regulators that the Rockville, Md., company's sterilizing solution should be allowed on the market. After spending about \$830,000 in legal fees in less than a year and a half, Sporicidin's executives hired an auditor.

Among the auditor's findings: \$24,053 for injunction papers that were never filed, \$5,891 for seven people to research one statute and \$177,251 for time spent by the army of staffers to update one another on progress in the case.

"They were just throwing lawyers at the problem and billed heavily from the word go," said John Toothman, an attorney for Sporicidin.

Lawyers representing Baker & Hostetler dispute some of these particulars, and say the overall fee reflected the complexity of the case, which required negotiations with three government agencies. Further, they say, executives at Sporicidin greatly complicated the work by issuing contradictory instructions to the firm's lawyers.

Whatever the outcome of this case—now part of a pending malpractice suit—it comes at a moment when many corporate attorneys say their profession is being overwhelmed by pressure to snare clients and bring money into their firms. Those pressures, according to academics and lawyers, are profoundly

changing the culture of corporate law by giving rise to a bill-or-die ethos that many lawyers find dispiriting, yet impossible to ignore.

Professors who study the business of law say associates and partners are billing hours that suggest superhuman concentration, outright fibbing or an eagerness to log time even if the expense isn't a worthwhile one for clients. And firms are less vigilant about making sure they don't represent anyone whose interests could collide with those of clients they already represent, according to the former head of the American Bar Association's Associates Ethics and Responsibility Committee.

Occasionally, clients get miffed and sue, but the public rarely hears much about lawyer misconduct because, unlike doctors, corporate attorneys nearly always resolve their problems in confidential, out-of-court settlements. [End quoting]

This is merely the icing on the cake of a profession that has generated more sad-but-true joke books than any other.

### ORGANICS PROPOSAL DRAWS FIRE

Pro-organic groups are urging the Agriculture Department to scrap its proposed rules on organic foods, which drew more than 150,000 overwhelmingly negative comments from across the nation.

Major reasons opposition arose were that the department left open the possibilities that organic food could be sold even if genetically engineered, irradiated to kill bacteria or fertilized with sewage sludge.

"This is by far the worst beating that any federal agency has taken on a proposed rule,"

said Roger Blobaum, a Washington agricultural consultant.

According to an analysis by the group Organic Watch, more than 83,000 people wrote, faxed or e-mailed comments opposed to allowing genetic engineering in organic foods and only 18 were in favor. Better than 78,000 people opposed irradiation.

Forty-eight members of Congress signed a letter to USDA Secretary Dan Glickman opposing the rules. They say they run counter to "historical practices of the industry" and don't protect consumers.

Organic farm groups have identified 66 objections to the rules. Among them are that state and private certifiers could not have tougher standards than the federal.

Brad Marman of the USDA's marketing service said the agency would analyze the tens of thousands of comments and "perhaps rewrite parts of it to reflect public comment." [End quoting]

#### **Biomed industry booming with renewed interest in DNA therapy**

Tinkering with plants in her USC lab, Lisa Welter dreams of one day vaccinating people against a potentially deadly disease by feeding them genetically altered vegetables.

In Duarte, John Rossi is testing a way to implant a kind of a molecular version of scissors in human cells to shred the virus that causes AIDS.

Throughout Southern California, scientists searching for new ways to fight disease have begun looking past drugs to deoxyribonucleic acid—DNA, the chemical blueprint that shapes everything living.

And the Los Angeles region has become a hotbed for a field—and an industry—that promises to change the way doctors understand, prevent and treat illnesses. Instead of attacking symptoms, scientists are studying how a person's genes, which determine everything from hair color to height, cause or contribute to disease.

Tinkering with faulty genes to combat disease is called gene therapy.

"We used to look at the patient, and then we got sophisticated and looked at the proteins involved, and now we're looking right at the gene," said David Rimoin, the Stephen Spielberg chairman of pediatrics at Cedars-Sinai Medical Center.

This revolution has been under way for years in Los Angeles universities and biotech companies, and it has already made great strides.

Scientists have pinpointed genes that play a part in ailments ranging from gum disease to various kinds of cancer, and the list continues to grow.

"Virtually every human disease has a genetic component," said Laurence Kedes, who heads the Institute of Genetic Medicine at the University of Southern California.

For all the strides that have been made in gene therapy, however, scientists caution that progress often takes years. Many experiments replacing defective genes or adding new ones have met with little success. And even the basic work of tracking down individual genes and understanding their functions can be maddeningly complex.

"It's a slow, slogging process," Kedes said. "You can have hundreds of people working on a single gene, and it will take them a decade to understand it." [End quoting]

Sounds good, but I hope you don't trust these people. Look how easy we could be inoculated with anything. Prepare for the worst.

### INDONESIA

#### **Foreign Naval Presence Builds Around Indonesia**

From the INTERNET, 5/20/98: [quoting]

Australia has carried on with scheduled joint naval and air exercises with the Indonesian military this week, despite that country's apparent impending collapse. Three frigates and a destroyer, approximately a third of Australia's navy, along with three Australian F-111 bombers and a P-3 Orion reconnaissance aircraft, will be joined by a similar number of Indonesian forces in the exercises. The exercises, titled "New Horizons", will take place off the Indonesian port of Surabaya. The Australian government acknowledged the sensitive timing of the maneuvers, but stated that the long-planned exercises, which take place within the two countries' bilateral defense accord, were not subject to internal Indonesian events. Nevertheless, Australia, like other countries, is arranging for the potential evacuation of its citizens from Indonesia on chartered civilian Boeing 747 jets.

Taiwan and Japan have also sent naval forces to Indonesian waters, though not as part of joint exercises. Taiwan has a three-ship fleet cruising near Indonesia, for possible use in evacuating Taiwanese nationals from Indonesia. Japan has also dispatched two patrol boats to Singapore for possible use in evacuating Japanese nationals. The two countries have each sent military C-130 transport aircraft and chartered civilian airliners to Indonesia for use in evacuating their citizens.

Malaysia has placed its coastal troops on full alert and has stepped up sea and air patrols to defend against a "possible sneak landing by Indonesians" fleeing the country's unrest, according to the Malaysian Defense

Minister, cited in the daily *Nanyang Siang Pau* newspaper. Malaysia has deployed 10 vessels to patrol its waters against any possible mass refugee exodus. Malaysia is also preparing for the possible evacuation of its nationals from Indonesia by ferry or civilian airlines.

Indonesia's near and distant neighbors are concerned about more than just the immediate security of their citizens in the country. Indonesia has a history of externalizing its internal problems, using the nationalism card to trump economic failure. This was especially the case under Sukarno, whose domestic radical populism was accompanied by aggressive, confrontational external politics, targeted in particular at New Guinea and Malaysia. The potential for Indonesia to once again revert to aggressive, nationalistic foreign politics has its neighbors concerned over, among other things, the security of Indonesian waters.

Australia's naval exercises with Indonesia serve two purposes. Australia first and foremost wants stability in Indonesia, and if that can be accomplished through the careful return to and maintenance of the status quo ante, then just as well. However, if Indonesia begins to collapse, Australia is committed to making sure Indonesian instability does not spill over into Australia's sphere of influence, which extends roughly from New Guinea to the Cocos Islands.

Two other potential external impacts of an Indonesian collapse are of critical concern to other countries. The first is the security of foreign firms operating in Indonesia, particularly those in oil and other extractive industries which would be ripe for nationalization. The second is the security of the flow of oil from and through Indonesia. Countries such as Taiwan and Japan, which are highly dependent on Indonesian oil and on Middle East oil passing through the Strait of Malacca, are extremely worried about the potential effect an Indonesian collapse could have on their fuel supply. We note in particular the deployment of Japanese vessels to Singapore, on the Strait. Should that oil flow become threatened, they will be forced to turn, at least in the short term, to Australia to keep the sea lanes open. The nearest significant US Navy presence is the two Carrier Battle Groups committed in the Persian Gulf, while the Seventh Fleet has a frigate and a destroyer deployed in the Philippine Sea. The potential for a constriction in the oil supply, either through the temporary disruption of Indonesian production or through threats to traffic through the Strait of Malacca, while an unexpected boon to Indonesia's cash-strapped OPEC allies, is a nightmare for already economically unsettled Japan and other Asian nations. [End quoting]

Notice that the elite are taking our attention from the Middle East—so what do they have in their evil minds for that area for the immediate future?? You can bet it isn't good for us. The Sun that beat down on my Volkswagen had parched the farmers' fields dry. It was another hot, dusty day in the Florida panhandle. The temperatures were recordbreaking; we hadn't seen rain in weeks.

Every other Saturday I had been following these dirt roads through the most remote areas of my north Florida town to deliver mail. The ad for a part-time mail carrier had caught my eye seven months earlier. My husband and I were having financial problems—among others—so I had inquired about the job.

"It's the most difficult of all our rural routes," the postmaster told me. "Six hundred eighty-four homes along eighty-six miles. It's too much for a woman."

"What does it pay?" I asked, unfazed.

"About a hundred dollars a day," he said. "But you drive your own car and use your own gas."

I figured I could work two days a month. The extra two hundred dollars would make all the difference.

Several weeks after I took the civil service exam the postmaster called to say I had made the highest score. When I met with him he warned me that my work as a legal secretary hadn't prepared me for the rigors of being a mail carrier, lifting heavy bags and packages. He emphasized how isolated the route was. I took the position anyway.

My first day was the Saturday before Christmas, and the regular mail had more than doubled because of the holiday. Unfamiliar with the names and addresses on my route, I spent more than five hours sorting, stacking and bundling the letters and packages in gigantic bags.

My small yellow Volkswagen groaned under their weight as I headed out. The only directions I had were 14 pages of handwritten notes. After hours of following advice like "Take the right fork at the big pine tree and go 3.2 miles to mobile home" and "Turn left at the little white house with the big black

dog," I managed to get my car stuck in a sandpit. By the time I dragged myself back to the post office that evening the postmaster had called the sheriffs department to report me missing in action.

"Lord," I prayed that night, "I believe you gave me this job. I need you to be on the route with me. I can't do it alone."

Over the next few months I learned the addresses. I got to know the people behind the names too—a friendly wave or a cookie were reminders that God was helping me. But just when I got the hang of my job, my marriage fell apart. In April my husband left town, leaving me and our two children. Money, which had been a problem, became a crisis. The kids were seven and twelve, both of them eating so much and growing so fast I could hardly keep up. There were times that spring when I was rolling pennies to buy groceries. I used the Saturdays in my VW bug to talk things over with God.

The warm days of spring turned into the scorching days of summer. When I delivered mail I packed a cooler with ice and Cokes, and kept a hand towel on my lap to wipe the dust off my face. Sometimes I drove on the wrong side of the road just to stay in the shade.

Finally there came that hot, dry afternoon in July when I didn't think I could take it anymore. I was feeling light-headed and my cooler was empty, the ice a warm puddle sloshing around the bottom. No one on my route was home to pour me a glass of water. Halfway through my shift I began to feel sorry for myself. In the thick, stagnant heat, I stopped the car, put my head on the steering wheel and cried.


"Oh, Lord, I've gone as far as I can go today," I sobbed. "I don't have the strength to deal with my problems. I need this job. But today, Lord, I feel too sick and hot to go on."

I sat there choking on tears that tasted like salt and dust, too worn out to move. Just then I felt a slight breeze coming through the windows. Lifting my head, I noticed a small gray cloud moving toward my car. As it came closer and closer, I stepped outside. The cloud seemed to linger directly overhead.

Standing on that dirt road with my face turned to the heavens, I felt drops of rain. First a fine mist, then a sweet, gentle shower.

It rinsed the dust from my arms and the tears from my cheeks. I basked in its spray. And when I had had enough, it stopped. *Thank you, God*, I thought, feeling cool and refreshed. Then I noticed: The fields and road surrounding my car were still dry! That little gray cloud had rained just for me. "God, you are amazing," I said.

A few days later our thirsty little town got the downpour we'd been waiting for. By then my spirit and my strength had been renewed. A shower from a small gray cloud had soothed my soul. —Debra Hill, McDonough, Georgia—[End quoting]

# Re-Establish The Constitutional Republic Or Start Anew?

Mohandas K. (a.k.a. Mahatma or “great soul”) Gandhi (1869-1948) is credited with making the astute observation that “The world has enough for everyman’s need, but not enough for everyman’s greed”. Seen another way, it should be obvious that societies and economies cannot have unlimited growth when the Earth has only limited resources. Hence, any concept of a realizable and achievable just government must be inextricably linked with the concept of our Earth as having finite resources. Bigger is not necessarily better. We must be realistic about what we plan to do today, but our planning must go beyond tomorrow. A balanced approach is the only perpetually sustainable approach.

In a perfect world it would seem that there would be no need for government at all, for all would honor and respect all others. As Thomas Jefferson said in 1782, “It is error alone which needs the support of government. Truth can stand by itself.” So, since we are where we are in time and space, perhaps we should try to build a just world government.

Gandhi also advanced the idea of “an exploitation-free society”. In other words, we must be concerned with the needs of people, rather than the needs of the system. The system must be tailored to the needs of human beings. The idea of a government of, by and for the people is a nice idea on paper, but in a world such as ours it will take some work to make it a reality.

“That government is best which governs least.” This must be our cornerstone and our goal, as it entails the concept of more localized governance with everyone being responsible for making things work in their own communities.

Our active participation in the governing process has, until now, been cleverly engineered out of the system, thereby making us dependant on others whom we have elected to do our thinking for us. And those who have done our thinking for us have been corruptible and, thus, have become greedy and have not had our best interests at heart. Unfortunately, our government has not simply ignored our problems, it has perpetuated them. It is time for a change.

Now that the Earth is as populated as it is,

balance and harmony must be a significant part of the foundation of any proposal for a just world government. And, although we are physical beings, we must cease our over-emphasis on our physical bodies, our physical world and physical environment, and instead express the fact that we simultaneously exist as spiritual beings. But more than that, we must understand that we are spiritual beings first, last and foremost.

We were spiritual beings before we made the conscious decision to come down here to experience in this human physical dimension, and we will still be spiritual beings after we leave this three-dimensional plane, with the added benefit of what we have learned in our journey here to help us in our own spiritual evolution. And what we will ultimately realize, if we think enough about it, is that how much we benefit from this experience is dependant upon how much we are able to help our Creator with HIS Bigger Plans for this planet, of which our own individual plans are but a part.

And what are those Bigger Plans? They appear to be to see how we will do (with all of the multi-faceted distractions that a world such as ours holds), and what we will do, when left on our own, to create a just and better world for all human beings.

You see, when we really think about it, it seems quite plausible that, in this vast universe of ours, there must be many, many inhabited worlds and that our world may well be rather unevolved and even barbaric compared to some others. It is completely conceivable that there are worlds where all life is held sacred, where there is no violence, or terrorism, or mass exploitation by people who feel the overwhelming need to have total power and control over others; worlds where the Creator is recognized by all as the Source of all life, love, joy and abundance; worlds where all things coexist in harmony and balance.

Obviously, our world has not yet reached that point. Ours is a planet where we can all learn our lessons about what is good and what is evil by experiencing every situation in life as an opportunity to learn some lesson.

What we have today in our world is starvation in the Third World, overpopulation,

poverty, injustice, inequality, frustration, despair, crime, aggression, dehumanizing technological development, the befouling of our Earth, air and waters by industrial, agricultural, and individual pollution, overtaxed social amenities, etc., etc.

Since what each of us does ultimately affects each and every other human being on Earth in some way, the solution to our world's problems will not be achieved if only one nation chooses to do something about them. The peoples of the world all appear to have the same basic needs, but the world's many governments do not appear to be run by those who wish to see those needs met. Thus, the need for the peoples of the world to unite to now set up a Just World Governance System.

Some would argue that we already have the basis of this in the United Nations. But anyone who understands how and why the U.N. was set up, by whom it was organized and established, and who actually runs it from behind the scenes, will know that it is an evil front for powerful international bankers and industrialists who are bent on keeping us perpetually at war with each other, and in exploiting the world's people and resources to make us all slaves to them and their corrupt world system. controlling people, because it is a commodity that can be controlled, and when everyone uses it, everyone can be controlled by it.

When our Creator's abundance is available freely to all human beings, there is no need which is not immediately met. In such a situation there is no need for money.

We need to learn when enough is enough. What point is there in one man having millions or billions of dollars while millions of other human beings must starve? Can he take it with him when he leaves this world? Can it buy him true happiness? Does it help ease his conscience or help him to sleep better at night?

We, the Human Beings and inhabitants of planet Earth, in order to insure that we will not be exploited by greedy forces in opposition to our best interests, and to secure a good future for all Human Beings on Earth, do hereby set forth our basic program for the secure operation of a just, harmonious and balanced Planetary Governance System, based on true and just values and principles, whereby all Human Beings on Earth may live together with peace, equality, understanding and consideration for all living things.


### ARTICLE I.

#### EQUAL RIGHTS FOR ALL

#### SECTION 1

1. Each and every Human Being on Earth has an inherent and inalienable right to the basic necessities of life, which include the right to be

properly fed, clothed and housed, and the right to adequate health care, when and where it is needed, and the right to a decent education.

2. Each and every Human Being on Earth is, by Nature, free and independent, and has certain inalienable rights, among which are those of enjoying and defending life and liberty, of acquiring, possessing and protecting property, and of pursuing and obtaining safety and happiness.

3. The right of liberty includes the right of locomotion, of being able to freely move from one place to another on Earth, by any means or conveyance whatever, without any restrictions whatsoever by any government or anyone else.

4. The right of acquiring and possessing property includes the right of each and every Human Being on Earth to have and enjoy the benefits of all of the fruits of his or her labor without any restrictions or any taxing of such labor by any government or anyone else.

5. All power is inherent in each and every Human Being on Earth, and they are Absolute Sovereigns in any and all arrangements with all government. All government is instituted for the protection, security and benefit of each and every Human Being on Earth, and all Human Beings have the right to alter, reform or abolish their government, whenever the public good, determined by all Human Beings, may require it.

6. Each and every Human Being on Earth has the right to exercise his or her religious beliefs in any manner they so choose, so long as doing so does not interfere with or deny any other Human Being's right to do so, and so long as doing so does not jeopardize or compromise any other form of life on the planet. All life has the right to live freely.

7. Each and every Human Being on Earth has the right to speak freely, and the right to publish anything they so choose, so long as doing so does not bring undue hardship, burden or death to others.

8. Each and every Human Being has the right to peaceably assemble together in an orderly and civilized manner consistent with all other provisions set forth in this Constitution, and the right to submit grievances to the Planetary Legislative Council.

9. Each and every Human Being on Earth has the right to be secure in their persons, houses, papers and effects, against unreasonable searches and seizures. Warrants to search or seize any property of any Human Being shall only be issued where there is serious probable cause, supported by oath or affirmation, and particularly describing the place to be searched and the person or things to be seized.

10. Each and every Human Being on Earth has the right to be free from answering for a capital, or otherwise infamous crime, unless on a clear and specific presentment or indictment of a grand jury. Each and every Human Being charged or accused by such a presentment or indictment must be presumed innocent until proven guilty beyond a doubt, and also has the right not to ever be charged (or accused) and tried twice for the same offense.

11. Each and every Human Being on Earth has the right to be free from being compelled to be a witness against himself or herself in any criminal case.

12. In all criminal or civil prosecutions, each and every accused Human Being on Earth has a right to a trial by jury, without sale, denial or

delay, and such right remains inviolate forever. Each and every Human Being on Earth has the right, in any criminal or civil prosecution, to be fully and completely informed of the nature and cause of the accusation against him or her, and the right to be confronted with any and all witnesses against him or her, and the right to obtain any and all witnesses in his or her favor.

13. In any and all criminal or civil prosecutions, each and every Human Being on Earth has the right to counsel with any Human Being or Human Beings he or she may choose to counsel with, to have such Human Being or Human Beings assist him or her in all phases of any and all criminal or civil prosecutions, and to have such Human Being or Human Beings speak in his or her behalf in any or all phases of any and all criminal or civil prosecutions, as he or she may deem fit or proper at the time.

14. Each and every Human Being on Earth has the right to be a witness in any matter whatsoever, and no Human Being shall be rendered or determined incompetent to be a witness on account of his or her opinion or opinions on any matters whatsoever.

15. The privilege of Habeas Corpus shall be enjoyed by each and every Human Being on Earth and shall not be suspended or denied to anyone for any reason whatsoever, and no Human Being shall be held a prisoner because of his or her political or religious beliefs.

16. Each and every Human Being on Earth has the right to be free from being required to pay excessive bail, and free from having excessive fines imposed, and free from having cruel or unusual punishments inflicted or imposed, and no witness shall ever be unreasonably detained.

17. Each and every Human Being on Earth shall be bailable, by sufficient sureties, except for capital offenses or other crimes which threaten the life or property of any Human Being, when the proof is evident or the presumption great that harm would come to any Human Being.

18. The enumeration in this Constitution of certain rights shall not be construed to deny or disparage other rights retained by each and every Human Being on Earth.

## SECTION 2

Each and every Human Being on Earth has a duty and responsibility to do whatever they can, within the law, to make certain every other Human Being has every opportunity to exercise and enjoy their inherent and inalienable rights, and all other rights set forth herein.

## SECTION 3

1. No Human Being on Earth has any right to deny or deprive any other Human Being of his or her inherent and inalienable rights, and the opportunity to exercise and enjoy same, or to deny or deprive any other rights set forth herein.

2. No Human Being and no government on Earth can ever deny or deprive any Human Being on Earth of any right to life, liberty or property without due process of the Common Law, and only where all other remedies have been completely exhausted.

3. No Human Being and no government on Earth can ever take any private property from any Human Being on Earth for any public use

without just compensation, to be determined by a full hearing on the matter before a grand jury, and only where all other remedies have been completely exhausted.

4. The liberty of conscience, hereby secured to each and every Human Being on Earth, shall not be so construed as to excuse acts of licentiousness, or justify acts or practices inconsistent with the peace or safety of each and every Human Being on Earth.

5. No bill of attainder, ex post facto law, or law impairing the obligation of contracts, shall ever be passed by any government, or by any legislative body thereof.

6. No slavery, or involuntary servitude, shall ever be tolerated by or against any Human Being on Earth.

7. Treason against the Human Beings of Earth shall consist in levying war against them, or adhering to their enemies, including the international bankers, or giving their enemies aid or comfort, as in allowing any international bank to be established in any nation. No Human Being shall be convicted of treason, unless on the evidence of two or more witnesses to the same overt act, or upon confession in open court.

## ARTICLE II.

### PLANETARY LEGISLATIVE COUNCIL

#### SECTION 1

1. All legislative powers and duties herein granted shall be vested in a Planetary Legislative Council which shall be composed of three Human Beings, called Representatives, from each nation a signatory to this Constitution.

2. The three Representatives from each nation shall be chosen from their respective nations by paper ballot elections in their respective nations, and no electronic voting shall be allowed anywhere. Whoever wins a majority of the popular votes shall become a Representative of his or her nation.

3. Representatives to the Planetary Legislative Council shall hold their position during time of good behavior, as long as the Human Beings of his or her nation choose to keep them in their position.

4. Each nation a signatory to this Constitution shall maintain a local branch of the Planetary Legislative Council, consisting of not more than ten local Representatives within each nation, to implement the provisions of this Constitution in each nation. These local Representatives shall be elected in each nation the same as Representatives to the Planetary Legislative Council.

#### SECTION 2

1. The Planetary Legislative Council shall meet whenever a majority of the Representatives thereof call for such a meeting, or whenever the Human Beings of Earth so order such meeting.

2. Meetings of the Planetary Legislative Council shall take place at a location chosen by a majority of the Representatives thereof by a voice vote. The voice vote shall be taken at the end of each meeting and will determine the location of the next meeting, with the first meeting to take place in Cairo, Egypt.

## SECTION 3

1. Representatives to the Planetary Legislative Council shall be paid a compensation for their service, to be determined by the Human Beings of their respective nations.

2. Representatives to the Planetary Legislative Council shall not hold any other office during the time which they are serving as Representatives of their respective nations.

## SECTION 4

The Planetary Legislative Council shall keep an accurate and detailed journal of their proceedings, and shall immediately publish the same in every nation a signatory to this Constitution.

## SECTION 5

The Planetary Legislative Council shall elect from its member Representatives, those who shall serve on the Planetary Executive Committee.

## SECTION 6

The Planetary Legislative Council shall submit to the Planetary Executive Committee, for the Committee's approval, every resolution the Council votes to approve.

## SECTION 7

The Planetary Legislative Council shall have the power:

1. To determine and expose violations of rights of Human Beings in member nations.

2. To tax businesses and corporations 3% in order to provide revenues for implementing the provisions of this Constitution in member nations.

3. To promote the progress of science, the useful arts and education for all Human Beings on Earth.

4. To propose ideas, concepts and programs which will serve to uplift and make better the living conditions of all Human Beings on Earth.

5. To encourage understanding between member nations of all races, creeds, colors and religions of all Human Beings on Earth.

6. To support legislation which helps corporations and businesses better serve the real needs and interests of all Human Beings on Earth.

7. To constitute tribunals inferior to the Planetary Supreme Court.

8. To select and support an Interplanetary Greeting Committee to act as host and intermediary for visitors to Earth from other planets.

9. To propose all laws which may be necessary and proper for carrying into execution the foregoing powers, and all other powers vested by this Constitution in the Planetary Executive Committee.

## ARTICLE III.

## PLANETARY EXECUTIVE COMMITTEE

## SECTION 1

1. The executive power shall be vested in a Planetary Executive Committee, which shall consist of seven Human Beings who shall be elected from the members of the Planetary Legislative Council to serve as members of the Committee. When a member of the Council is elected to serve on the Committee, the nation of which he or she was a Representative shall elect a new Representative to replace him or her on the Planetary Legislative Council.

2. The members of the Planetary Executive Committee shall hold their office during time of good behavior as long as the Planetary Legislative Council shall determine they should serve on the Committee.

3. The members of the Planetary Executive Committee shall receive as a compensation for their service, the same compensation they were receiving as members of the Planetary Legislative Council.

4. Before they enter into the Execution of their office, the members of the Planetary Executive Committee shall take the following oath or affirmation: "I do solemnly swear (or affirm) that I will faithfully execute the office of the Planetary Executive Committee, and that I will to the best of my ability, preserve, protect and defend the Constitution of the Human Planetary Governance System."

## SECTION 2

1. The Planetary Executive Committee shall have the power to grant reprieves and pardons for offenses against the Constitution of the Human Planetary Governance System, in cases where it is clearly shown that no serious damage resulted and where every effort has been made to correct the offending action or practice.

2. The Planetary Executive Committee shall have the power, with the advice and consent of the Planetary Legislative Council, to make treaties and alliances with other planets which further the needs, interests and rights of each and every Human Being on Earth, and to promote the peaceful exchange of ideas and visitors between planets.

3. The Planetary Executive Committee shall nominate, and with the advice and consent of the Planetary Legislative Council, shall appoint ambassadors to other planets, other public consuls, judges of the Planetary Supreme Court, and all other officers of the Human Planetary Governance System whose

appointments are not herein otherwise provided for, but which shall be provided by law.

4. The Planetary Executive Committee shall do all within its power to promote peace, commerce, and honest friendship with and between all nations, whether they be signatories to this Constitution or not.

## SECTION 3

1. The Planetary Executive Committee shall, at the beginning of each year, present to the Planetary Legislative Council and to the Human Beings of Earth, information about the state of planet Earth, and recommend to the same for their consideration such measures and suggestions as they shall judge necessary and expedient to promote the blessings of peace, joy and abundance for each and every Human Being on Earth.

2. The Planetary Executive Committee may, on extraordinary occasions, convene the Planetary Legislative Council; the Committee shall receive ambassadors from other planets; the Committee shall take care that the laws of planet Earth be faithfully executed.

## ARTICLE IV.

## PLANETARY JUDICIAL CONFERENCE

## SECTION 1

1. The judicial power of the Human Planetary Governance System shall be vested in one Planetary Supreme Court, and in such inferior courts as the Planetary Legislative Council may from time to time ordain and establish.

2. The judges, both of the Supreme and inferior courts, shall hold their office during good behavior and shall receive for their services a compensation to be determined by the Planetary Legislative Council.

3. The Planetary Supreme Court shall be composed of eleven justices to be selected by the Planetary Executive Committee.

4. Any Human Being who holds any title of nobility shall not be allowed to serve as a justice of the Planetary Supreme Court, or as a judge or officer of any inferior court.

## SECTION 2

1. The judicial power shall extend to all cases at the Common Law arising under this Constitution, and treaties made, or which shall be made, with other planets; to controversies between two or more member nations; to all cases affecting ambassadors and consuls; to all cases between a member nation and a Human Being of another member nation; and to all cases between Human Beings of different member nations.

2. In all cases affecting ambassadors and consuls, and those cases in which a nation shall be a party, the Planetary Supreme Court shall have original jurisdiction. In all other cases mentioned in Clause #1, above, the Planetary Supreme Court shall have appellate jurisdiction, both as to law and to fact, with such exceptions, and under such regulations as the Planetary Legislative Council shall make.

3. The trial of all crimes against this Constitution shall be by jury and shall be held in the nation where the said crimes shall have been

committed.

4. In all cases whatsoever, all juries shall be composed of twelve Human Beings, except that a grand jury shall be composed of twenty-three Human Beings, and all juries shall have the power to determine both the law and the facts of any and all cases brought before them.

### SECTION 3

The Planetary Legislative Council shall have the power to determine the punishment for treason against the Human Beings of Earth.

### ARTICLE V.

#### RESPECTING NATIONAL SOVEREIGNTY

### SECTION 1

Each member nation shall respect the national sovereignty and local national laws of all other member nations. National laws of member nations shall not be in conflict, but shall be in

conformity, with the provisions of this Constitution.

### SECTION 2

Any Human Being charged in any nation with treason, felony, or other crime, who shall flee from justice to another member nation, shall be taken back to the nation having jurisdiction of the crime.

### SECTION 3

New nations may be admitted as members of this Human Planetary Governance System at any time by approval of the Planetary Legislative Council.

### ARTICLE VI.

#### AMENDMENTS

The Planetary Legislative Council, whenever two-thirds of its members shall deem it necessary and appropriate to promote the rights and interests of each and every Human Being on

Earth, shall propose amendments to this Constitution. All such proposed amendments shall become part of this Constitution when ratified by three-fourths of the members of the Planetary Legislative Council.

### ARTICLE VII.

#### SUPREMACY OF CONSTITUTION

### SECTION 1

This Constitution, and all laws which shall be made in pursuance thereof, shall be the supreme law of the land in each nation a member and signatory of this Human Planetary Governance System, and the justices, and judges in every court in every member nation, shall be bound thereby.

### SECTION 2

All members of any department, agency or branch of the Human Planetary Governance System, and all bureaucrats, ambassadors, and consuls, and all members of Councils, Committees and Conferences thereof, including all justices and judges, are all public servants, and at all times answerable to each and every Human Being on Earth, who are the Masters and Absolute Sovereigns over their public servants.

### ARTICLE VIII.

#### RATIFICATION

This Constitution shall be sufficient in and of itself to establish it as the law of any and all nations which shall choose to become members of the Human Planetary Governance System, and shall not be deemed to be in conflict with the laws of any nation which does not wish to become a member nation.

**DONE IN CONVENTION** by the unanimous consent of the Representatives of the nations present at the first meeting of the Planetary Legislative Council held in Cairo, Egypt, on the fourth day of July, in the year one thousand nine hundred and ninety eight. In witness whereof, the nations below hereunto subscribe as member nations.

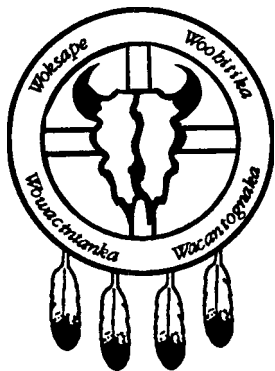

We have had severe haze for over a couple weeks here in Texas, creating health problems for many. The media says it is from fires caused by drought conditions in Central America and Southern Mexico, especially in Chiapas and the areas of the Zapatistas and Indians.

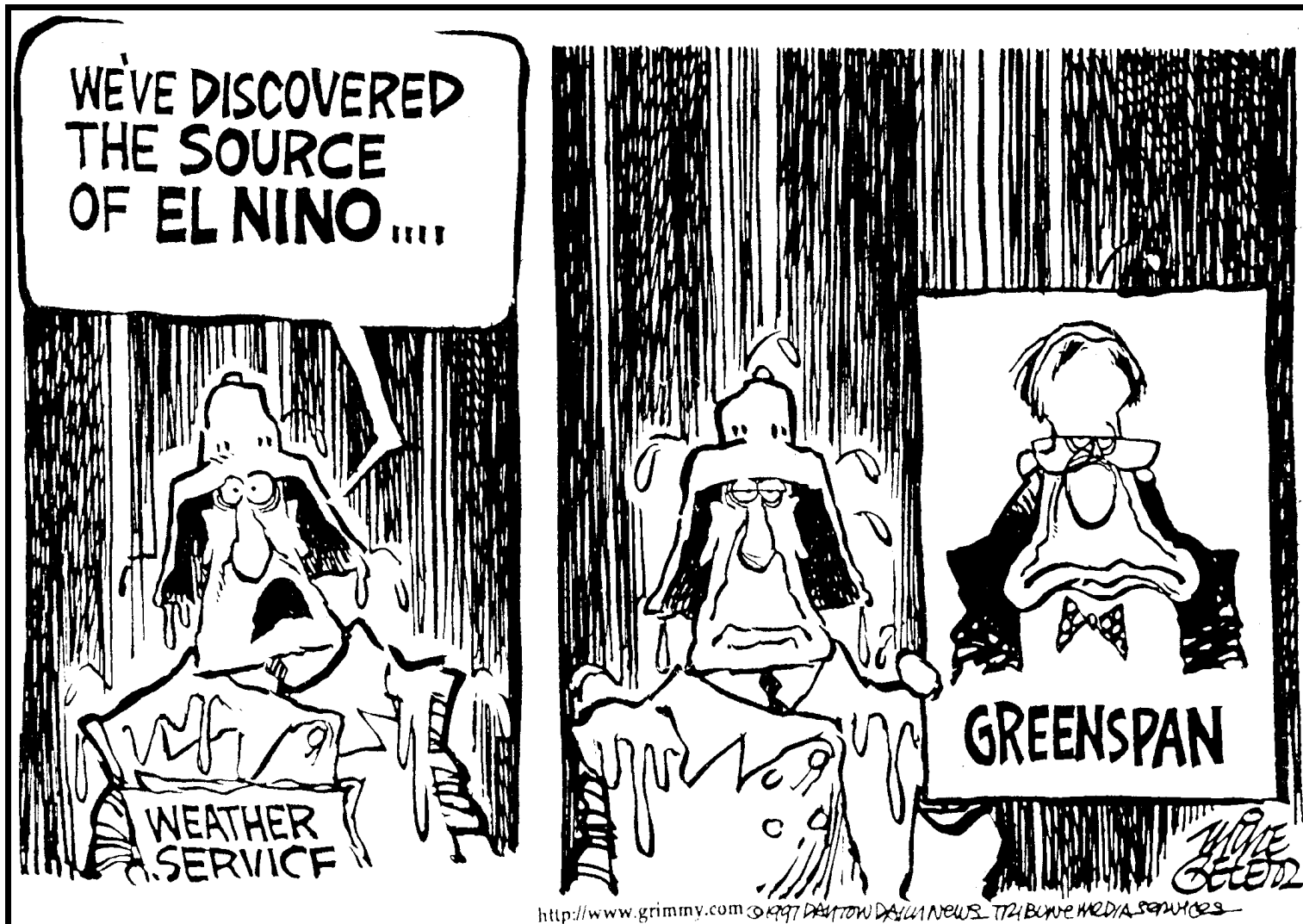
Droughts happen, but this severe haze has never happened before, so I suspected that there was something unusual that was not being told and decided to take a closer look.

I find that on Jan. 13, 1995, Chase Manhattan Bank's Emerging Markets Group wrote in a memo: "While Chiapas, in our opinion, does not

pose a fundamental threat to Mexican political stability, it is perceived to be so by many in the investment community. **The government will need to eliminate the Zapatistas to demonstrate their effective control of the national territory and of security policy.**" [emphasis mine]

The Mexican government is heavily mortgaged to Chase Manhattan. After the newly elected Zedillo government came to power, in February 1995 it launched an offensive against the Zapatistas and the EZLN (Zapatista Army of National Liberation) communities to "eliminate the Zapatistas" as ordered by the banks. They brought-in over 70,000 troops and security forces into Chiapas, and began financing and organizing terrorist organizations to burn the homes and loot the crops of the Indigenous locals.

Chiapas is one of the poorest Mexican states, but it is the richest in undeveloped resources. It contains 81 percent of Mexico's crude oil reserves. The International Monetary Fund is very interested in this, as 78 percent of the oil Mexico



produces goes to repay loans to the banks.

Since 1966 over 200 foreigners have been expelled from Mexico for "meddling" in the region. According to the *La Jornada* newspaper, the government terrorist groups have killed over 800 people. On Dec. 22, for instance, 45 unarmed Tzotzil Indians were massacred. Over 22,000 Indigenous people have been run off their land into mountain hideaway refugee camps.

On May 19th, Don and Marcia Steelman posted a message on the Internet which is called "Chiapas Is Burning". They stated: "The fires that now burn in an almost ruler-straight line from the Oaxaca border to Chiopancingo, on the border with Guatemala tell the story." Watchers have noticed that the fires spread by marching in a straight line, and they do so against prevailing wind. The fires concentrated on the homes, fields, and hideouts of the Indians, and then later spread into massive holocausts.

Others have tried to get access to find out more of the story, but are refused. On May 11, 40 Italians who had tried to look into the situation were expelled by the Mexican government.

Texas and others in the United States offered to help stop the fires, but were refused permission until it became too late. The homes, fields, and forests are already burned.

What must the poor peasants think?

*Editor's note: The following is the more detailed, background report from which Calvin wrote the above report. We share it for those of you who are curious about what all is going on down there.*

### EYEWITNESS REPORT FROM CHIAPAS, MEXICO

[Hackwell is a photo-journalist who participated in an emergency Pastors for Peace caravan from the United States to Chiapas, Mexico, in early May. The delegation delivered 32 tons of humanitarian aid to eight Indigenous communities and the San Carlos Hospital in Altamirano.]

It has been over two years since the Mexican government and the Zapatista Army of National Liberation (EZLN) signed the San Andreas accords. These accords officially recognized the right of Indigenous communities to choose their own leaders and control the natural resources in their territories.

Members of the Pastors for Peace caravan that visited Chiapas in May could see immediately that the Mexican government is not respecting this agreement. Instead of moving towards peace, Chiapas is a war zone. It reminds me of how Vietnam looked when I photographed the war there 30 years ago.

Just to get to the Chiapas border, the emergency caravan had to go through 15 military checkpoints inside Mexico. Once in Chiapas, we saw many Mexican Army convoys and military bases using U.S.-supplied hardware, ranging from Humvees and assault helicopters to army uniforms and everything in between.

Mexico and Colombia are the main recipients of U.S. military aid in Latin America. Over one-third of all officers being trained at Fort Benning School of the Americas are now from the

Mexican Army.

The "low-intensity, counter-insurgency" war being carried out against the Indigenous population here is made in the U.S.

U.S. military sales to Mexico rose from \$4.8 million in 1996 to \$28 million in 1997. Since President Ernesto Zedillo took office in December 1994, spending on the military has doubled. The cost rests on the backs of the Mexican workers.

### AUTONOMOUS COMMUNITIES

Despite this growing military presence, autonomous communities that have broken away from control by the ruling Institutional Revolutionary Party (PRI) continue to survive. Of 110 municipalities in Chiapas, 38 have declared themselves autonomous communities. This is defined by setting up a ruling council unconnected to the PRI and refusing help from the government.

The caravan visited eight autonomous communities. Near each one there was a big Mexican Army presence. This included checkpoints, army encampments complete with assault vehicles, and active patrols in full combat gear.

Indigenous community leaders told us that they are on red alert because of increased activity by the Army and other state and federal security forces. The heightened tension throughout Chiapas has halted all development projects and disrupted agricultural activity. Basic food crops like corn and beans were not planted this spring in many communities because of fear that the crops would be burned or people attacked in the fields.

In the EZLN highland center of Oventic,

Comandante Moises inventoried antibiotics and other medicines brought by the caravan. He stood in front of a community medical clinic adorned with murals of Mexican revolutionary hero Emiliano Zapata, Che Guevara and masked Indigenous women.

At a public amphitheater nearby, large poles with pointed ends stick out of the ground. Moises explained they are to prevent military helicopters from landing.

"There are Army night patrols that come into the center," he said, "and we are constantly harassed by the helicopters that fly very low. The army will not do this while you are here, or as long as the international observers stay."

### IMPORTANCE OF INTERNATIONAL OBSERVERS

The solidarity of international observers has become essential in the defense of the autonomous communities. Acteal is the village where 45 unarmed men, women and children were brutally massacred in December. A sign there reads: "Welcome to national and international companeros. We do not accept people from the government."

While the EZLN and its supporters encourage the observers, the Zedillo government is on the attack against [the observers]. The Mexican government is waging a war of genocide and does not want eyewitnesses to tell the world about it.

Since 1996, some 200 foreigners have been expelled from Mexico for "meddling in the country's internal affairs". The number of international observers today may be as few as 45.

Mexican immigration officials told the newspaper *Reforma* that agents were searching for 40 foreigners in Chiapas who are acting as human rights observers "without the correct visas".

The "correct" way is to register with the government and get an FM3 visa, which specifies where you can go and what you can do. But observers applying for an FM3 are usually turned down. Most people come to Mexico on a tourist visa. That has now become a pretext for expulsion.

At most military checkpoints we encountered immigration agents as well as Judicial Police. In April the newspaper *Novedades* actually published a list, complete with visa numbers, of 47 foreigners acting as human-rights observers.

### THE REAL MEDDLING

While Zedillo attacks foreigners sympathetic to the Indigenous people of Chiapas, the real interventionists in Mexico are the International Monetary Fund and U.S. corporations.

Since the North American Free Trade Agreement took effect in January 1994, the Mexican government's debt has reached \$170 billion. That has set off a fire sale of national industries once protected by the Mexican Constitution.

U.S. companies are poised to buy all 57 airports in Mexico, as well as essential railroad and telecommunication lines. The national oil company, Pemex, remains nationalized, but 78 percent of the oil it produces goes to the U.S. to pay loan interest.

While Chiapas is the poorest state in Mexico, it is the richest in untapped resources. It contains

81 percent of Mexico's crude oil reserves. U.S. corporations see the Zapatista movement as an obstacle to the exploitation of this area.

On Jan. 13, 1995, Chase Manhattan Bank's Emerging Markets Group wrote in a memo: **"While Chiapas, in our opinion, does not pose a fundamental threat to Mexican political stability, it is perceived to be so by many in the investment community. The government will need to eliminate the Zapatistas to demonstrate their effective control of the national territory and of security policy [emphasis mine]."**

### LOW-INTENSITY WARFARE AND PARAMILITARY GROUPS

Right after the release of this Chase Manhattan memo, the newly elected Zedillo government took its cue from the U.S. financial institutions to which it is mortgaged. In February 1995 it launched a two-part offensive against the Zapatistas and the EZLN communities.

Today over 70,000 armed troops and security forces are stationed in Chiapas. Most are camped in the eastern part near the Lacandon forest, where the Zapatista army is strongest. The intent is to cut off and isolate the EZLN from the autonomous communities in the center of the state.

The other significant part of the government offensive is the growth of paramilitary groups armed and financed by the PRI. These groups are terrorist organizations similar to the Ku Klux Klan in the United States.

According to *La Jornada* newspaper, since 1996 these groups have killed over 800 people. They have conducted a campaign of burning homes and looting Indigenous crops.

The Dec. 22 Acteal massacre of 45 unarmed Tzotzil Indians was carried out by one of these groups, armed with Army-issued assault rifles. An elite Army unit had been seen with the paramilitaries the day before the massacre.

According to Enlace Civil, the civilian link to the EZLN in San Cristobal de las Casas, over 22,000 Indigenous people have been displaced and are living in the mountains or in refugee camps as a direct result of paramilitary terror sanctioned by the Mexican government.

### WOMEN ON THE FRONT LINES

As our caravan neared the autonomous village of Polho, we saw rows of women, their faces covered, guarding the entrance. U.S. military-issued Humvees patrolled the main road.

Yet the women were not intimidated. They have been conducting a heroic front-line defense of many of these communities. Here, and in the neighboring village of Xoyep [spell??], women with babies on their backs have repeatedly repulsed Army patrols trying to enter.

Their determined faces reflect a struggle that predates the Zapatista uprising by 500 years.

The flashpoint of the struggle recently shifted to a small, isolated community in the eastern canyons of Chiapas, Taniperlas.

The town had declared itself autonomous on April 10. Immediately, Mexican Army troops along with Judicial and Public Security Police invaded the newly independent community. Twelve international observers were arrested and deported. Six Mexican nationalists were

imprisoned. Hundreds of military troops continue to occupy the community.

Some 140 male EZLN supporters fled to the surrounding mountains while women and children remain under house arrest.

The emergency caravan decided on April 24 to attempt to deliver food and messages of peace to the people of Taniperlas. After driving 75 miles from Ocosingo on a small dirt road, we delivered seven tons of rice, beans, corn, sugar and salt to the displaced men in the highlands.

It was carried on the backs of mules, EZLN supporters and the caravanistas. As the sun began to go down, the aid was safely carried away from the heavily patrolled road to Taniperlas. When asked how they would get the food into the occupied town, the men smiled and said, "We have our ways."

### PARAMILITARIES HARASS CARAVAN

The next morning the caravan proceeded to the town. The Rev. Lucius Walker informed public security agents and PRI sympathizers that the caravan was there on a pastoral visit. It was at this point that paramilitary members allied with the PRI appeared. Many had clubs.

Unfazed, members of the caravan joined in a prayer for peace and then proceeded to leave. Frustrated at the success of the caravan's mission, the PRI sympathizers tried to block the road and threw a rock, breaking one of the vehicle's windows.

This incident got international media attention—not the occupation by the military. The reports made it sound as though the people were hostile to the caravan.

The solidarity movement worldwide needs to continue to expose the U.S. government's role in the Mexican ruling class' war of extermination against the Indigenous population. The war in Chiapas has slipped from the headlines, but this should not be taken as a sign that the struggle is over.

In many respects the situation is more grave. More confrontations are sure to come. The popular movement in Mexico not only welcomes international observers, but says they are urgently needed to expose the insidious warfare being conducted against them.

Editor's note: On May 11, the Mexican government deported 40 Italians who had come to Chiapas as human-rights supporters.

Dear Building Community Family,

It appears we should have heeded instinct and written last week based on today's 7.3 quake in Taiwan. We've been seeing a massive heating in these areas on the OTIS [ocean temperature] thermal anomaly maps that we monitor daily. Two weeks ago, Stan targeted this exact area on his Shaker map as well as announcing it on the *Art Bell Show* being ripe for quake activity. That Shaker map is still available on our website. Stan sat across the desk shaking his head at the heat build up, so we were not surprised at the resulting seismic activity.

This afternoon, we received a phone call from Charlie McFarland in Klamath Falls, Oregon, whom we have quoted previously on quake warnings. As a refresher, Charlie is a stringer (independent video news reporter) for Channel 10 outside Seattle, WA. Today, Channel 10 notified Charlie to "take your video equipment everywhere you go" as they are expecting serious EQ activity. Due to the volcanic region in which he lives, Klamath Falls is a known precursor area for the Juan de Fuca plate and the fault lines leading north into Washington,

A couple other things are transpiring that we'd like to touch on.

For those who missed last week's announcement, this fall's Leonid showers occurring between November 12 and 15th are expected to be the worst in 33 years. Air Force Space Command anticipates losing 20% of our GPS [*Global Positioning Satellites*] as a result of these showers. This possible loss could have both airline navigation and military implications.

The CMEs (Coronal Mass Ejections) seen in the last 3 days have been mighty! CMEs are a few steps beyond the severity of Sun spots and solar flares. CMEs are actual solar material thrown off the Sun. The one that Stan and I looked at last night showed the ejecta reaching a distance 7 times greater than the diameter of the Sun itself in the

initial burst. Shortly thereafter, it broke loose in all directions moving at 1200 km/second or 2.7 million miles per hour. This is huge and fast! Accelerated protons from these ejections reach Earth within 3 or 4 hours in some cases. This type activity at its worst can zap chips in any electronic equipment.

The magnetic solar wind storms from these last two massive CMEs on May 1-2 can be expected to reach us during May 4-6. If there is an ultraviolet burst, DO NOT look at it directly. It has the potential to blind. If you must be outside, wear sunglasses and keep your skin covered as much as possible.

You are wondering if this activity is unusual? For Art Bell listeners, you'll recall months ago, Stan reported the Sun's increasingly unstable behavior. So far in the first 4 months of 1998, we have seen greater solar instability and activity than for all of 1997 and expect this pattern to continue.

As a result, we foresee **El Nino continuing to build rather than slack off as NOAA [*National Oceanic & Atmospheric Administration*] models are predicting [emphasis mine]**. We feel global warming is a direct result of the Sun's misbehavior even more than the greenhouse effect. Weather will remain unpredictable and increasingly violent.

A newsletter from FEMA [*Federal Emergency Management Agency*] on April 27th further underscores our on-going problems. Let me restate a comment relating to their El Nino warning of October 14, 1997 in which FEMA warned people publicly that we must take emergency preparedness into our own hands and quit relying on government to bail us out. Last week's newsletter from FEMA can be read in its entirety under Special News on our website tomorrow and I did already post it on the ARK list. If FEMA says we have disasters on the way, you can bet those same booties, they anticipate mighty happenings. To quote James L. Witt, FEMA director, this last week, "Communities across this country need to be prepared for disasters that we know are coming". They are so certain of this that 7 states are being targeted for disaster planning against flooding.

"The designation is part of Project Impact: Building a Disaster-Resistant Community, a national effort that aims to change the way America deals with disasters by encouraging communities to come together to assess their vulnerabilities to natural hazards and implement strategies to limit damage before disasters occur."

There are 7 communities under Project Impact: Alleghany County, Maryland; Deerfield Beach, Fla.; Oakland, Calif.; Pascagoula, Miss.; Seattle, Wash.; Tucker and Randolph counties, W. Va.; and Wilmington/New Hanover County, N.C. If these places don't ring a geographical bell with you, dig out your atlases. Five of the seven target impact areas are coastal. Just chance? Possibly, but doubtful.

Along with today's 7.3 earthquake, a 7' tsunami alert is in place for the West Coast. Even though the above-mentioned 7 Project Impact scenario is for floodplains, don't you find it a little curious that 70% of these target areas are coastal?

Stan and I have been advising everyone to be at least 200 miles inland from all coastal areas.

FEMA can only say so much openly and it is up to us “unofficial” sources to spill the worms. Consider them spilt. The government, once again, just like they warned everyone openly last fall about the severity of El Nino, are warning people now, especially those on the bordering bodies of water to CYA.

### ROW ERUPTS OVER RISKS IN VESUVIUS

Experts fear a massive eruption of Mt. Vesuvius is due.

Robert Matthews reports on the dilemma

between preparation and risk.

Visitors to Naples are told how Mt. Vesuvius erupted in 79 AD, killing thousands in Herculaneum and Pompeii and that it has slept quietly since 1944.

What the guides omit to say is that the spectacular volcano rising to 1230m to the city's south has been quietly filling with molten rock for 50 years and experts believe it is close to a colossal

eruption capable of killing tens of thousands of people in minutes.

Volcanologists probing the area with electric currents have found a huge rock plug jammed in the 30m conduit of the volcano, like a stopper in a champagne bottle.

Many believe that when this “cork” goes pop it will release a soaring cloud of superheated ash and poisonous gas known as a pyroclastic flow, like that described by Pliny the Younger in his account of the killer flow from Vesuvius 1900 years ago as: a dark and horrible cloud . . . coming up behind us as we were fleeing, spreading over the earth like a flood.” But it took the explosion of Mt. St. Helens in Washington State of the United States in 1980 to show the accuracy of Pliny's report.

Computer simulations of Mt. Vesuvius present a more terrifying picture. Once the rock plug gives way, a cloud of molten rock, ash and gas will be blasted about 1.5km into the sky.

Once the heat from the initial blast subsides, the cloud will swoop down and flow along the ground at speeds upwards of 160kmh and reach the 100,000 population of Torre del Greco in less than four minutes, and the outskirts of Naples, with its three million people, five minutes later. ### ARIZONA SKIES FILL WITH SMOKE FROM FIRES ENGULFING MEXICO

From *THE DAILY NEWS*, Los Angeles, 5/20/98: [quoting]

Smoke from deadly, raging forest fires in Mexico are traveling more than 1,000 miles into Arizona, causing teary eyes and reduced visibility in Tucson, the National Weather Service said Tuesday.

“We can see that. Some of that is coming from Mexico up through the Gulf of California and then coming up into southeastern Arizona,” said Bob Berkovitz, meteorologist for the weather service in Phoenix, after scanning satellite images.

The most devastating wildfires in seven decades are raging across Mexico and Central America, gobbling millions of acres of forests and grasslands, closing international airports and pushing blankets of smoke into Texas and gritty haze as far away as Oklahoma, Wisconsin and Georgia.

Smoke from the fires has forced government officials in Mexico and Texas to declare health emergencies, and it was blamed for an airplane crash in Guatemala this weekend that killed three people.

At least 50 people have died in Mexico as a result of the fires, most of them while battling the flames.

The fires, which are burning across the region from Nicaragua north through El Salvador, Honduras, Guatemala and throughout Mexico, are threatening centuries-old Mayan ruins and have incinerated animals and rare plants in some of Mexico's most fragile areas. [End quoting]

And from the reports that Art Bell is putting on his radio program it's **much worse** than this indicates. There are also underground fires and several volcanos blowing off.

It's horrible—and deadly—when all this poison air is surrounding thousands of miles and no place you can go to get a “breath of fresh air”. # Vanishing Bees

## Threaten Food Supply

### MINT SAVES BEES

I first used this article in THE NEWS DESK, Nov. 5, 1996. But the bees are still dying off, so I thought someone might put this to use to help save them. I also added a new bee article at the end of this one.

Beekeeper Robert Noel of Cumberland, Maryland couldn't bear to just stand by as witness to the demise of his 46 bee colonies, so last year he started experimenting with remedies to eradicate the culprit mites. "I just wanted to try something," he told *ECR*.

Rapid spread over the last few years of two types of parasitic mites coupled with the recent harsh winter have crippled the bee population, threatening crops, especially in the North and Northeast, and caused farmers to pay dearly to rent hives for pollinating. (See News story, *ECR*, 8/96)

Thinking about some of the natural ingredients that bees encounter in nectar and what might be acceptable to a bee but distasteful to a blood-sucking mite, Noel was inspired to try applying cinnamon in one of his hives. He was elated to find that it succeeded in knocking the mites off his bees, but dismayed several days later to discover that, "they jumped right back on".

Noel consulted his sister, a nursing school college professor, who opened her kitchen cupboard and grabbed a bottle of wintergreen oil. She recalled one of her college professors who had extolled the powers of wintergreen. Since his bees were dying anyway, Noel went home to concoct a mixture of the wintergreen oil into a solid patty of shortening and sugar.

Much to his amazement, when he checked the tested hive several days later not only were the

mites off his bees, but they were dead, by the hundreds, on the bottom of the hive. Thrilled with his discovery, Noel contacted the U.S. Government and at least 15 Universities about his natural remedy. The only respondent was West Virginia University entomologist James Amrine who was, indeed, skeptical at first but could not argue with Noel's resulting healthy, honey-producing bee colonies.

Since then, Noel and Amrine have worked together testing other effective oils such as tea tree, pennyroyal, spearmint, peppermint and patchouly and devising the best delivery system for the remedy. It appears that most mint oils will work.

Successful methods of delivering the remedies so far have included mixing the mint oils in a patty placed in the hive, on a sticky tracking strip that the bees come in contact with or in a sugar water mix that the bees drink when flowers are not making nectar. The oil eradicates varroa mites, the most deadly, by weakening them and leaving them unable to reproduce. The pesky tracheal mite gets stuck in the oil and dies because it is unable to migrate to the bee's breathing tubes.

Noel's most recent experiment is aimed at treating the top of the hive as effectively as the bottom which has the drink dispensers and sticky strips. "A friend of mine calls me the mad scientist," he said, "because I'm always trying new things."

Another friend told him he should hire a lawyer and seek a patent. This doesn't interest Noel. "Loss of bees for pollination could mean world famine," Noel warned. To be truly successful he feels it is more important to get the word out to beekeepers than to cash in on his solution.

"To that end, Noel, a high school computer teacher by day, has over 200 beekeepers listed on his data base. He offers suggestions tailored to each individual beekeeper's needs and keeps records on their applications. Noel's research and formulas are posted on the Internet at <<http://www.wvu.edu/~agexten.varroa.htm>>. An article



outlining Amrine and Noel's research and formulas appeared in the Sept. issue of *American Bee Journal*. Information on his remedies and results can also be obtained by contacting Noel at 108 Blackiston Ave., Cumberland, Maryland 21502.

While scientists continue working on the development of mite-resistant bees, they admit that the oils, which seem preferable and more effective than the traditional chemical pesticides, are a very plausible solution.

"I think there is hope," Noel reflected, "the key is to get the word out to beekeepers because we need to save our bees and the Earth." Acknowledging that he could gain to profit from his experimentation, Noel excuses that angle, stating that the problems with our Earth have come about because of people going after the "almighty dollar". He prefers to try and "help my fellow man and help out our Earth. We need to work on that," he finished, "there's nothing more important than our environment." [End quoting]

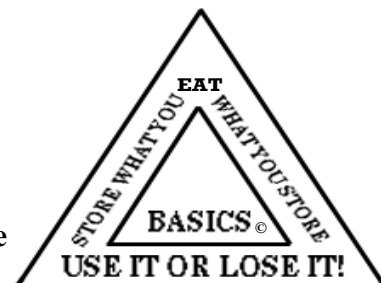

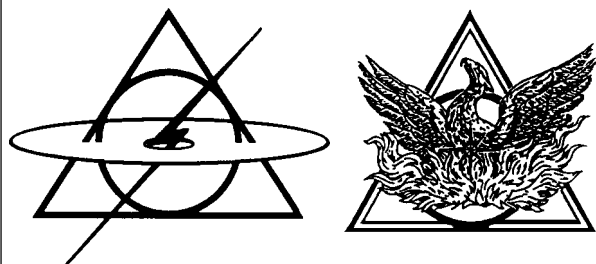
