## FIREFIGHTS IN GULF AND FIREWORKS IN CONGRESS

It was a day of fast-breaking, wide-ranging developments as the White House juggled the deepening crises in Iraq and at home:

\*Cruise missiles slammed into Iraq after President Clinton launched "Operation Desert Fox" with a surprise attack on Saddam Hussein for refusing to cooperate with United Nations weapon inspectors.

\*House leaders delayed an impeachment vote against Clinton—deciding instead to vote today [12/17/98] on a resolution supporting American troops in the Persian Gulf.

\*In a 15-minute address to the nation after the bombs started falling on Baghdad, the president denied the raids were a plot to divert attention from Sexgate.

\*Top congressional GOP leaders, including Senate Majority Leader Trent Lott, were quick to criticize the timing of the attack. "Why now?" asked Rep. Gerald Solomon (R-N.Y.), who accused the president of trying to delay the impeachment vote. Democrats and some Republicans defended Clinton's decision.

\*Defense Secretary William Cohen ordered a sharp increase in American air and ground forces in the Gulf, and officials said the bombing raids could last four days.

\*Grim-faced Prime Minister Tony Blair announced Britain had joined in the attack against Iraq. "We have exhausted all other avenues," he said.

\*U.N. weapons inspection teams were hurriedly evacuated from Baghdad in a convoy hours before the attack. The crisis reached a boiling point after a blistering report to the U.N. by chief arms inspector Richard Butler, who said the Iraqis had once again refused to cooperate by blocking access to sites and hindering inspections.

**\*Former chief U.N. weapons inspector Scott Ritter accused Clinton of being on a "Wag the Dog" schedule, saying U.S. officials created a crisis that would justify a bombing by pushing inspection teams to return to Iraq last month [emphasis mine].**

\*Officials confirmed they timed the airstrikes so they would not interfere with the projected start of Ramadan, the Muslim holy month of

dawn-to-dusk fasting, prayer and reflection.

\*Hours before the strikes, Saddam told his country Iraq would not "kneel" before the United States. Iraqi radio reported he and his top aides were preparing for strikes by dividing the country into four regional commands.

\*Early reaction to the strikes from U.S. allies was mixed—with Canada backing the military action while France tried to distance itself from the bombing, noting the "grave human consequences".

\*Israeli defense chiefs met late into the night to prepare for possible retaliatory Scud attacks by Saddam Hussein in a replay of Desert Storm.

\*The double whammy of Iraq and impeachment triggered a stock-market drop, with the Dow falling 32.70 to 8,790.60, although historically low oil prices and oil stocks were boosted by the latest Gulf crisis.

\* Arab-Americans in New York expressed skepticism about the raids, as 80 protesters in Times Square blasted the United States, shouting "Let Iraq live."

\*In Los Angeles, Hollywood stars including Ted Danson, Barbra Streisand and Jack Nicholson backed Clinton during an anti-impeachment rally.

\*Officials said reputed terror boss Osama bin Laden has ordered new "unusually specific" attacks on American targets in the Persian Gulf. Meanwhile, five more fugitives were charged with the August attack on a U.S. Embassy in Tanzania, which bin Laden is accused of orchestrating. [End quoting]

BANKING CRISIS  
HITS PERU, ECUADOR.  
FUJIMORI FORCED  
TO BUY BANKS'  
NON-PERFORMING DEBT

The crisis in Peru's banking sector which has been brewing for months, has now hit full force.

In neighboring Ecuador, rumor has it that the central bank is about to intervene in the country's largest bank, Filanbanco, which has half a million depositors. Last week, the central bank tried to bail it out with \$150 million, but now appears ready to declare it insolvent. Two months earlier the Banco de Prestamos closed its doors. Paraguay is the other country whose banking system is also in crisis. Reviewing the regional situation, Peru's *Sintesis* warns that "the outbreak of a probable crisis approaches." *Gestion* includes a cartoon showing banks as falling dominos.

In Peru, the banks' estimated short-term foreign debt (in dollars) of \$3.5 billion—total bank foreign debt is at least \$5 billion—a drying-up of foreign credit lines and a run on mutual funds and deposits have combined to make for an explosive situation. On Nov. 23, the Banking Superintendent announced the intervention of the Banco Republica, whose investors are Chilean, while the Banco Latino was reportedly "informally" bailed out by the central bank. In a panic, President Alberto Fujimori announced in early December that all deposits would now be insured for up to 62,000 sols (\$20,000—previously the ceiling was 14,000 sols). Then, last weekend, in a highly unusual move, the government announced it was buying up the banks' bad debt for \$150 million, which would provide them with some liquidity, while offering another \$140 million through the third reduction in the last several weeks of the reserve ratio (from 40.5 a 20%) [sic]. In any case, banking sources say that the \$150 million is totally insufficient—banks had expected \$500 million.

Now, a rash of mergers and acquisitions are expected, to pare down the size of the banking sector. Large banks have stopped lending to smaller ones. Some banks are also demanding that the government use some percentage of its reserves, which are deposited in Swiss banks, to provide liquidity, and also as collateral for new loans. However, most banks admit that were this to occur, they will use the funds to pay their foreign debt. [End quoting]

The IMF has the pressure on every country they possibly can to force their worldwide control, but **thank God** some are taking daring steps to stop this global raping.

IMF TRADE SURPLUS DEMAND  
FROM BRAZIL FOR 1999,  
SUGGESTS  
DEVALUATION PLANNED

According to *O Estado*, the Dec. 2 IMF

communique announcing the approval of the first loan for Brazil contained a surprise: the statement that Brazil would reach a \$2.8 billion trade SURPLUS in 1999. Given that Brazil has been running record trade deficits each month in 1998, and is projected to run a \$5.5 billion trade DEFICIT for the year, the only ways Brazil could achieve this conditionality would be to radically cut imports, either through a severe fall in domestic production, a maxi-devaluation (which would produce the same effect), or a combination of both. Thus, *O Estado* wrote, the IMF trade conditionality was read by "investors" as an indication that Brazil would have to maxi-devalue its currency.

The IMF communique specifies that imports will drop in 1999 by U.S.\$4 billion over 1998 levels, and exports will increase by U.S.\$3.8 billion. The latter assumption is ludicrous. 1998 exports are projected to come in at 1-2% below 1997 exports.

According to *O Estado*, the comment of the Minister of Trade, Commerce and Industry, Jose Botafogo Goncalves, on this part of the IMF communique was simply, "From what I know, this [\$2.8 billion] estimate is an IMF exercise, and not our commitment." [End quoting]

Here is yet another example of the collapse of a country's economy, despite all the hot air in recent years over the benefits of NAFTA. The only winners are the "elite" crooks—as always.

RIO TINTO SET TO  
GOBBLE CHEAP ASSETS  
IN GLOBAL RECESSION

The **Queen's** mining company [*emphasis mine*], Rio Tinto, is preparing to seize growth opportunities created by what it publicly expects to be a "profound and prolonged" global economic recession in 1999. Rio Tinto's London-based chairman, Robert Wilson, said that if the U.S. economy contracted suddenly in 1999, "we are facing a very gloomy future." "The downside risk is very serious," he said.

"Looking into 1999, we are going to see an unusually low rate of global growth, only around 1.5%. I see 1999 as being quite unusual in terms of its outlook. It would not look like a great year in any circumstances, but it holds nasty possibilities on the downside."

Wilson went on to state that there were "three easily identifiable trigger points which could lead the global economy into a very profound recession, profound and prolonged," which he identified as: a collapse of the U.S. stock market, a slide of the Japanese economy from recession into depression, and a disintegration of the Brazilian economy, which could trigger a U.S. stock market crash.

Particularly referencing the collapse of the global steel market, Wilson attacked some countries' anti-dumping rules, which he described as "protectionism by another means", and said they concentrated the burden of recession. He also admitted that the steel collapse had impacted on the production of its Hamersley Iron Ore mine in Western Australia. Despite the gloomy outlook, Wilson stated that "the prospect of a global crunch had prompted the world's biggest miner to keep its takeover tinder dry in expectation a global downturn would throw up growth opportunities." [End quoting]

WHEN TRUTH DEPARTS

### GORE IGNORED INTELLIGENCE REPORTS

### **SPOTLIGHT READERS ALREADY KNOW THE VEEP IS LINKED TO RUSSIAN CORRUPTION; NOW THE REST OF THE WORLD KNOWS.**

Vice President Al Gore is deeply involved in a conspiracy with a syndicate of Zionist racketeers who plundered the Russian economy to the tune of hundreds of billions of dollars. The *New York Times* confirmed on Nov. 23.

The story of the vice president’s criminal alliance with a paper-thin upper crust of Moscow financiers who are stealing Russia blind, linked by their ethnic and emotional ties to Israel—by their Israeli passports—was broken by this populist newspaper in a series of exclusive investigative reports more than a month before the *Times* discovered the scandal.

“Among financial and political insiders in Moscow, Gore is known as ‘the Knuckle’, which is nineteenth century thief’s slang for the strong-arm attendant who used to accompany crooked Russian gamblers, serving tea with rum to card players oblivious of being ‘cheated’ and then protecting the sharpsters’ getaway in case of trouble.” *The SPOTLIGHT* revealed Sept. 28.

What Gore did was to “strike up a back-room alliance with some of the most rapacious and cunning self-promoters in Moscow, among them Victor Chernomyrdin, a longtime Soviet bureaucrat who had managed to turn Russia’s huge gas reserves into a corrupt personal fiefdom after the Communist regime’s collapse”, this populist newspaper reported in its groundbreaking exposé.

Backed by Gore’s unconditional endorsement, Chernomyrdin became prime minister of the Russian Federation and co-chairman **with the U.S. vice president of a top Moscow “leadership**

**commission” in charge of Russia’s democratization and economic reform** [emphasis mine], *The SPOTLIGHT* disclosed.

With Gore providing political support, international legitimacy and economic credibility, “Chernomyrdin and his retinue—a clique of Zionist financiers backed by gangs of killer thugs—stole whatever they could, and what they did not steal, they corrupted,” this newspaper summed up, quoting a Russian sociologist.

Following the trail blazed by this populist newspaper, the *Times* revealed on Nov. 23 that over the years, Gore received voluminous hard intelligence summaries from the CIA documenting the “pervasive corruption and criminality of the regime he sponsored in Moscow”.

But the “conclusive evidence gathered by the CIA on the personal corruption of Prime Minister Victor Chernomyrdin was rejected by Vice President Al Gore, who sent it back to the CIA with a barnyard epithet scrawled across its cover,” the *Times* said.

“At CIA headquarters in Langley, Va., the message seemed clear: The vice president did not want to hear that Mr. Chernomyrdin was corrupt, and was not interested in further intelligence reports on the matter,” the imperious East Coast daily newspaper charged.

As a result, CIA analysts “now censor themselves” the *Times* said.

“When, for instance, the agency [CIA] found that it cost a German business executive a \$1 million bribe just to get a meeting with Mr. Chernomyrdin, it decided not to circulate the report,” the *Times* imparted.

Belatedly, the New York newspaper acknowledged that another top Russian official, Anatoly B. Chubais, a front man for both Chernomyrdin and Wall Street currency speculator George Soros, was also identified as a crook in “many other CIA reports”.

What the *Times* did not mention was that until now, it was itself among the admirers of Chubais—one of the key Moscow power brokers said to hold a second passport from Israel—whom it hailed as “the architect of property privatization in Russia”.

That post-Communist “reform process”—now exposed as a vast organized-crime racket from which a handful of Zionist billionaires gouged hundreds of billions of dollars—netted Chernomyrdin himself a hidden personal fortune of at least \$5 billion, the *Times* estimated this month. [End quoting]

With the *Times* reporting this it looks like Gore may have a hard time keeping the Presidency “if” he ever gets it. There are other indications certain powerful people want him in, but others definitely don’t. A battle royale is coming up!

### CLINTON CRISIS: PHONE CALLS, E-MAIL, WIRES INUNDATE HOUSE OFFICES

An avalanche of telephone calls, e-mail and even old-fashioned telegrams poured into congressional offices Tuesday as people coast to coast sought to influence the House vote on impeaching President Clinton.

“Every time we hang up a line, it rings again,” said Leslie Belcher, spokeswoman for uncommitted Republican Rep. Wes Watkins of

Oklahoma. “The one thing that is consistent is people feel very strongly about it.”

The House e-mail server, which normally processes about 80,000 electronic messages a day, handled more than 1 million Tuesday, almost double the 520,000 on Monday. Telephone calls to the main Capitol switchboard were double the normal volume at more than 14,000 Tuesday.

“It’s been very, very large, but we’re used to it,” said Jason Poblete, spokesman for the House Oversight Committee.

Some contacts were part of an orchestrated campaign by the liberal group People for the American Way, which opposes impeaching Clinton for his conduct in the Monica Lewinsky affair. The House will begin debating four articles of impeachment Thursday.

Using broadcast ads and phone banks in four major cities, the group claimed credit for generating more than 174,000 anti-impeachment calls over six days by providing a toll-free number that automatically routes callers to the Capitol switchboard.

“We’re telling them to use Westrem Union because you can’t get through to the Capitol anymore,” said Carol Shields, president of People for the American Way. “The e-mails they’re getting in Congress they’re not even reading anymore.”

Indeed, calls Tuesday to House and Senate offices in Washington were frequently met with the frustrating “all circuits are busy” recorded response.

Most lawmakers report a deep split among callers and people sending e-mail on whether to impeach or censure Clinton. It’s unclear how much impact they might be having. [End quoting]

It is clear from watching the hearings on television that those Representatives who are not completely bought-out through Zionist blackmail or bribery are well aware there is an overwhelming public opinion to back-off from a full impeachment. This year there would be no tree or almond cookies, but she would set up the crèche—in memory of a child.



I have spent several days lecturing at the WORLD ENVIRONMENTAL CONFERENCE on "ASPARTAME, marketed as 'NutraSweet', 'Equal', and 'Spoonful'". In the keynote address by the EPA, they announced that there was an epidemic of multiple sclerosis and systemic lupus, and they did not understand what toxin was causing this to be rampant across the United States. I explained that I was there to lecture on exactly that subject.

When the temperature of Aspartame exceeds 86 degrees F, the wood alcohol in ASPARTAME converts to formaldehyde and then to formic acid, which in turn causes metabolic acidosis. (Formic acid is the poison found in the sting of fire ants.) The methanol toxicity mimics multiple sclerosis; thus people were being diagnosed with having multiple sclerosis in error. The multiple sclerosis is not a death sentence, where methanol toxicity is.

In the case of systemic lupus, we are finding it has become almost as rampant as multiple sclerosis, especially [among] Diet Coke and Diet Pepsi drinkers. Also, with methanol toxicity, the victims usually drink three to four 12 oz. cans of them per day, some even more. In the cases of systemic lupus, which is triggered by ASPARTAME, the victim usually does not know that the Aspartame is the culprit. The victim continues its use, aggravating the lupus to such a degree that sometimes it becomes life threatening. When we get people off the Aspartame, those with systemic lupus usually become asymptomatic. Unfortunately, we can not reverse this disease.

On the other hand, in the case of those diagnosed with multiple sclerosis (when in reality, the disease is methanol toxicity), most of the symptoms disappear. We have seen cases where their vision has returned and even their hearing has returned. This also applies to cases of tinnitus.

During a lecture, I said, "If you are using ASPARTAME (NutraSweet, Equal, Spoonful, etc.) and you suffer from fibromyalgia symptoms, spasms, shooting pains, numbness in your legs, cramps, vertigo, dizziness, headaches, tinnitus, joint pain, depression, anxiety attacks, slurred speech, blurred vision, or memory loss—you probably have ASPARTAME DISEASE!" People were jumping up during the lecture saying, "I've got this; is it reversible?"

It is rampant. Some of the speakers at my lecture even were suffering from these symptoms. In one lecture attended by the Ambassador of Uganda, he told us that their sugar industry is adding Aspartame! He continued by saying that one of the industry leader's son could no longer walk--due in part from product usage!

We have a very serious problem. Even a stranger came up to Dr. Espisto (one of my speakers) and myself and said, "Could you tell me why so many people seem to be coming down with MS?" During a visit to a hospice, a nurse said that six of her friends, who were heavy Diet Coke addicts, had all been diagnosed with MS. This is beyond coincidence. Here is the problem. There were Congressional Hearings when Aspartame was included in 100 different products. Since this initial hearing, there have been two subsequent hearings, but to no avail. Nothing has been done. The drug and chemical lobbies have very deep pockets. Now there are over 5,000 products containing this chemical, and the PATENT HAS EXPIRED!!!!

At the time of this first hearing, people were going blind. The methanol in the Aspartame converts to formaldehyde in the retina of the eye. Formaldehyde is grouped in the same class of drugs as cyanide and arsenic—DEADLY POISONS!!! Unfortunately, it just takes longer to quietly kill, but it is killing people and causing all kinds of neurological problems.

Aspartame changes the brain's chemistry. It is the reason for severe seizures. This drug changes the dopamine level in the brain. Imagine what this drug does to patients suffering from Parkinson's Disease. This drug also causes Birth Defects.

There is absolutely no reason to take this product. It is NOT A DIET PRODUCT!!! The Congressional record said, "It makes you crave carbohydrates and will make you FAT." Dr. Roberts stated that when he got patients off Aspartame, their average weight loss was 19 pounds per person. The formaldehyde stores in the fat cells, particularly in the hips and thighs.

Aspartame is especially deadly for diabetics. All physicians know what wood alcohol will do to a diabetic. We find that physicians believe that they have patients with retinopathy, when in fact, it is caused by the Aspartame. The Aspartame keeps the blood sugar level out of control, causing many patients to go into a coma. Unfortunately, many have died.

Memory loss is due to the fact that aspartic acid and phenylalanine are neurotoxic without the other amino acids found in protein. Thus it goes past the blood brain barrier and deteriorates the neurons of the brain. Dr. Russell Blaylock, neurosurgeon, said, "The ingredients stimulate the neurons of the brain to death, causing brain damage of varying degrees."

Dr. Blaylock has written a book entitled *EXCITOTOXINS: THE TASTE THAT KILLS* (Health Press 1-800-643-2665). Dr. H.J. Roberts, diabetic specialist and world expert on Aspartame poisoning, has also written a book entitled *DEFENSE AGAINST ALZHEIMER'S DISEASE* (1-800-814-9800). Dr. Roberts tells how Aspartame poisoning is escalating Alzheimer's Disease, and indeed it is. As the hospice nurse told me, women are being admitted at 30 years of age with Alzheimer's Disease. Dr. Blaylock and Dr. Roberts will be

writing a position paper with some case histories and will post it on the Internet. According to the Conference of the American College of Physicians, "We are talking about a plague of neurological diseases caused by this deadly poison."

Dr. Roberts realized what was happening when Aspartame was first marketed. He said "his diabetic patients presented memory loss, confusion, and severe vision loss". At the Conference of the American College of Physicians, doctors admitted that they did not know. They had wondered why seizures were rampant (the phenylalanine in Aspartame breaks down the seizure threshold and depletes serotonin, which causes manic depression, panic attacks, rage and violence).

Just before the Conference, I received a FAX from Norway, asking for a possible antidote for this poison because they are experiencing so many problems in their country. This "poison" is now available in 90-PLUS countries worldwide. Fortunately, we had speakers and ambassadors at the Conference from different nations who have pledged their help. We ask that you help too. Print this article out and warn everyone you know. Take anything that contains Aspartame back to the store. Take the "NO ASPARTAME TEST" and send us your case history.

I assure you that MONSANTO, the creator of Aspartame, knows how deadly it is. They fund the American Diabetes Association, American Dietetic Association, Congress, and the Conference of the American College of Physicians. The *New York Times*, on November 15, 1996, ran an article on how the American Dietetic Association takes money from the food industry to endorse their products. Therefore, they can not criticize any additives or tell about their link to MONSANTO. How bad is this? We told a mother who had a child on NutraSweet to get off the product. The child was having grand mal seizures every day. The mother called her physician, who called the ADA, who told the doctor not to take the child off the NutraSweet. Several thousand pallets of diet drinks were shipped to the Desert Storm troops. (Remember heat can liberate the methanol from the Aspartame at 86 degrees F.) Diet drinks sat in the 120 degree F. ## What Is Happening In The Middle East?

I am not an expert on Middle East policies of the various governments or of our own government. However, there have been a number of recent events to raise questions as to evolving relationships and actual intent of our own government, the United Nations, England, Israel, Iran, Turkey, Afghanistan, Palestine, and others in this unsettled region.

First there were our government's unprecedented missile strikes against bases in Afghanistan and a pharmaceutical manufacturing house in Sudan. (Why destroy a pharmaceutical plant?) Next there was the media hype about the U.S. and Iran's first step towards an understanding. The reason for this change of direction, according to several leaks on the subject, was that England and the U.S. hoped to obtain permission to run an oil pipeline across Iran. You can imagine the money involved in such a plan. I believe the pipeline is intended to hook-up with the newly developing oil field in Baku, Azerbaijan, north of Iran on the land-locked Caspian Sea. (What will Russia do about it?)

Somewhere in this time line we were told that Turkey had again entered Northern Iraq and was fighting the Kurds! This invasion did not

bring down the sanctions of the U.N. or NATO, or the U.S. Why?

With the entry of the Taliban of Afghanistan into the news following the U.S. strikes against training bases south of Kabul in hopes of eliminating Osama bin Laden, we soon learned that Afghanistan and Iran were having difficulties and that Iran had placed military forces along its borders with Afghanistan. The reason for the disturbance was not explained. We were told that the Taliban had killed four Iranians, but what had caused the dispute was left to our imagination. Later we also learned that the U.S. did not appear at a court hearing investigating Osama bin Laden's involvement in terrorist acts or present any evidence to support their actions!

More recently Mr. Netanyahu of Israel, Yasser Arafat of Palestine, and Bill Clinton met in the U.S. to work on the Middle East peace process (again). The reported results were that Israel would release more land for peace (13% of the Gaza Strip) and Palestine (Arafat) would crack down on Palestinian terrorists, confiscating guns among the Palestinians. Included in that agreement was Mr. Arafat's decision to withdraw certain words from Palestinian documents regarding Israel's rights and legitimacy. All of this set both Israelis and Palestinians against their

leaders. Now we see that the "peace process" is still as much on hold as it ever was. Netanyahu allowed Israelis settlement on more disputed land in Jerusalem, causing an uprising of Palestinians and stopping the land-for-peace agreements in the midst of more violence.

All of the above may appear to be no greater or less than other events which have occurred in the Middle East during the last few decades. However, an article on the Middle East by guest columnist Ali Baghdadi, in the 10/16/98 issue of *The Final Call* newspaper, puts a perspective on the events which provides a look at a possible plan behind some of these activities. Admittedly, Mr. Baghdadi is pro-Arab and pro-Muslim in his views. He sees Israel and the United States as co-authors of the scenario now unfolding, although publicly both urge the various parties to "calm down and address their grievances". Still, an Arab and Muslim view of the situation is critical to what will happen in the Middle East and our understanding of it.

Following is a summary of essential points in Mr. Baghdadi's article:

We are told:

1. Turkey has entered into a military alliance with Israel for "humanitarian objectives" and will strike Syria, which refuses to yield to Israeli dictates. The American government has stated it "understands the Turkish position, a diplomatic term which is interpreted as an invitation for Turkey to attack". (Why would Turkey go to war for Israel? For "humanitarian objectives"?)

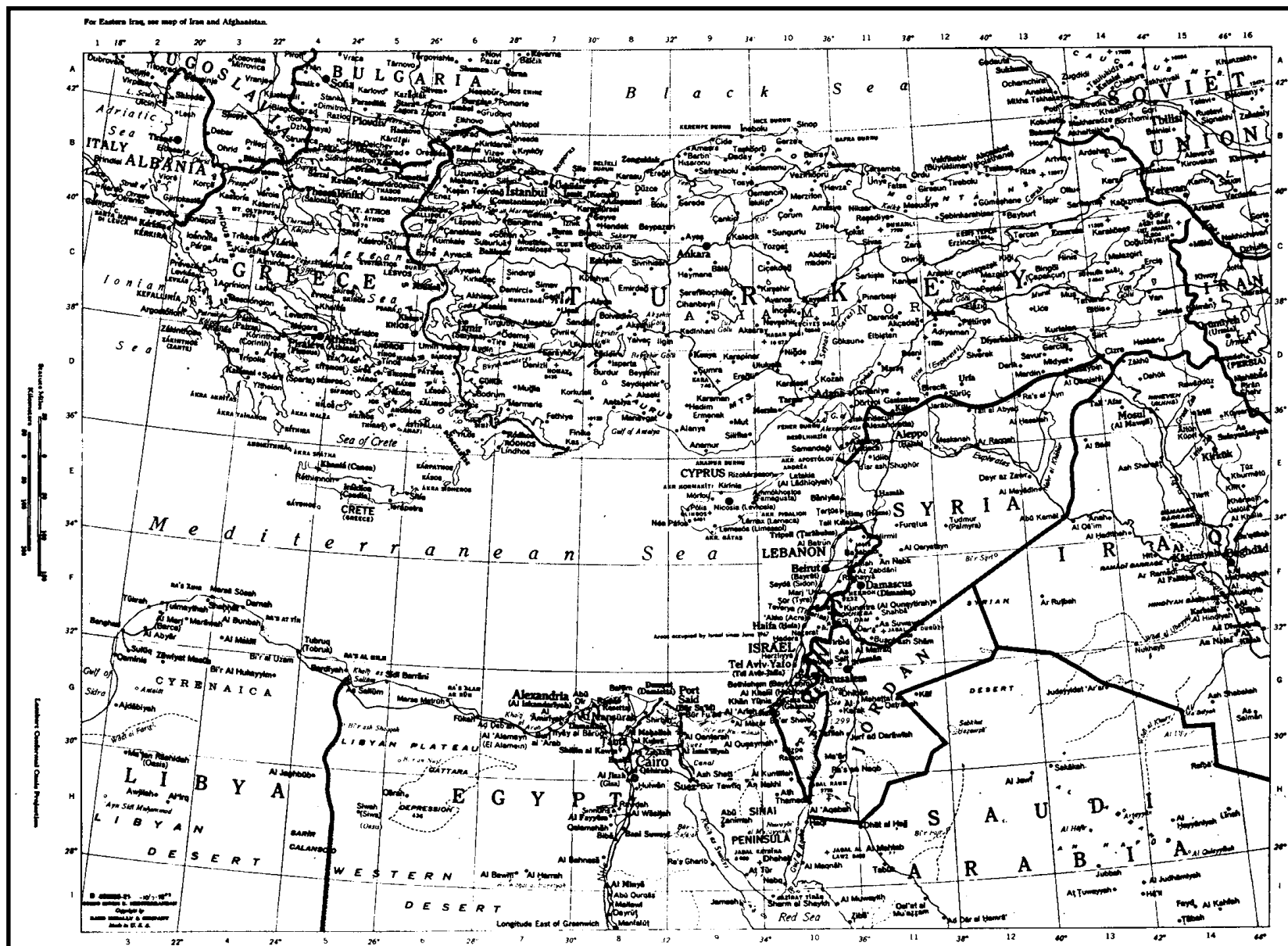
2. The Taliban (remember, according to an earlier report in *The Final Call*, the Taliban are a creation of the U.S.) in Afghanistan are working hard to provoke Iran and force her into a war on her eastern border to distract her from aiding Syria. Pakistan is instructed to come to the aid of the Taliban if necessary. (Who is giving the orders to Pakistan?)

3. It is difficult to imagine that Iraq, which has already been invaded by Turkish forces, will stand idly by. (Even with American guns still at their heads?)

4. Jordan, which joined Israel, Turkey and the U.S. in a defacto military pact that was never publicly announced, will be ordered to move its forces north and east towards Syria and Iraq. (Again, who will give the orders?)

5. In the confusion, Israel will strike missile bases and vital military and industrial sites in Iran and Syria.

6. The American forces in the Mediterranean, Red Sea and Persian Gulf will provide support to its "friends".



7. Mr. Arafat, who provided Israel with the "legitimacy it sought for 50 years", is expected not to be around for very long; health reasons.

8. Israel is alarmed at the population growth of the Palestinians. Mr. Baghdadi predicts that Israel may reoccupy Gaza and West Bank and force another wave of Palestinians to neighboring Arab states. "Jordan may become the new Palestine", despite its past and current cooperation with Israel. Three cities are being built in southern Jordan to receive the next inflow of Palestinians.

9. In order to relieve the pressure, the Zionists plan to transfer approximately three million Palestinians to northern Iraq (this is the area now being cleared of Kurds by Turkey with their "humanitarian objectives").

Mr. Baghdadi understandably does not provide the sources of his information. He has been a Middle East reporter for *The Final Call* newspaper for sometime, and has close ties in the Arab world. He sees the present unfolding scenario in the Middle East as the most difficult yet faced by the Moslem nations with predictably disastrous results unless they wake up to their dangerous situation and work together.

It is impossible in all of this to see how the actions of our own government have been truly of peace-seeking intent. According to Mr. Baghdadi, in effect Israel and her cohorts in the U.S. government plan to set all the Arabs against each other, remaining in the background unscathed, themselves!

Iran and Syria, by their size, are in critical positions in my opinion regarding the affairs of the Arab world. If they do not pull together, both of them and the Arab World will be severely weakened and could fall prey to their adversaries.

One wonders about Iran's sudden involvement in dialogues with the U.S. The oil pipeline appears to be the only reason. How did it all start? Who is the Iranian leader considering and pursuing the change? Who are the oil-barons behind it all? It appears from Mr. Baghdadi's report that Iran is being set up for a fall.

From my earlier articles regarding Nostradamus' predictions about the "anti-Christ" in the Middle East area, you may recall that he predicted Iran would be one of the first major nations to be taken over in the eastern Mediterranean, followed by Russia and China! According to Nostradamus this anti-Christ wears a "blue turban". According to Hatonn, the "blue turban" represents the blue headgear of the United Nations.

I wrote the following predictions of Nostradamus in the 11/10/92 issue of the *PHOENIX LIBERATOR* (precursor to CONTACT), and it was printed in my book *The Garden of Aton, Vol. I* [quote]:

In general the anti-Christ will take advantage of the Earth changes and the general chaos to further his rule. There will be a year without a rainbow (great drought) and famine, which he further uses to his advantage. The first area of his activity will be in the eastern Mediterranean. His first power takeover will be Persia (Iran), and then will spread to Russia and China. His European takeover will start in southern Europe, Italy, Rome. The religious fanatics will be gaining political power and there will be another rise of Nazism. [End quote.]

Considering also the present difficulties in southern Europe (parts of the former Yugoslavia, Serbia and Kosov), the major floods in China,

and financial difficulties of Russia and Asia, it is a time to be more than usually alert to happenings in our world. However, predictions and prophecies do not have to happen. Man must wake up, become responsible for his circumstances and change them.

I have taken a copy of a map of the eastern Mediterranean from Rand McNally's *World Atlas*, printed in 1984, to give you a better picture of the area of Mr. Baghdadi's concern [see previous page]. Obviously, with Jordan tied to Israel, Iraq pinned down by U.S. forces, Iran interested in an understanding with the U.S. and England and involved in military activity on its eastern border, Syria could become isolated from those normally considered friends (or at least Moslem brothers) and therefore prey to its enemies in a concerted military effort by both Turkey and Israel. War in the Middle East could start quickly, given the above scenarios.

It is difficult to understand the politics of Turkey's and Jordan's positions, as outlined by Mr. Baghdadi. There is much that has been kept secret. Nevertheless, keep in mind that Turkey

is part of the former Ottoman Empire which always gave top preference to the merchants and exclusively used Jews who claimed descent from the House of King David as chief bankers until recent times. In addition, the United States has poured in vast dollar sums and military aid to Turkey since the end of World War II. As for Jordan, this monarchy owes its establishment to the "peace accords" following World War II, at which time the Jews were allowed to return to Palestine. From many sources, which I have already touched upon in previous articles, it is clear that the Zionists were in control of that "peace process".

# Testing Lessons Along The Schoolroom Path

### THE GREATEST GIFT WE CAN GIVE TO OTHERS IS A GOOD EXAMPLE

A good example does not include allowing others to take what is rightfully property of another if you can stop such actions.

When we work in service to God and fellow man, we first keep our promises, with or without written contract. We do not keep rewriting prior agreements in a unilateral manner to feed our own greed, for that is dishonor.

Does one participant have a right to “simply write off” that which is agreed to, and lose greatly for many people, to appease the power and greed of another participant in any business or honorable family circumstance? I tell you right here and now that this is NOT acceptable. The point has been to bring the Institute to perfect stability, including the input of one Hugh Hale who seemed to find our work and

product, along with projects, more than acceptable until came this psychic guru. Now he no longer wishes to honor anything, and the lesson you must receive, readers, is that of total lack of honor while he continues to steal and lie.

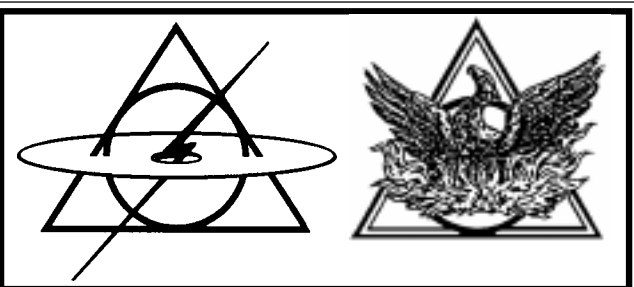
