QUOTE:

(Editor's Note: This is an "English" book; no attempt has been made to conform the spellings, punctuation and grammar to "American".)

Hitler's view of the Jews and the Jewish problem is sharply expressed in *Mein Kampf*. He goes to great lengths to demonstrate that his Jew-hatred was quite reasonable, that it flowed from experience and the logical inferences to be drawn from clear evidence. He always insisted that his first thoughts towards the Jews were all benign. His father, "the old gentleman", looked upon anti-Semitism as a left-over religious prejudice and so, we are told, did the enlightened young Adolf. It was only after his mother died, and he moved from provincial Linz to Vienna, that Hitler found occasion to question the glib assumptions of his youth. For there he wandered through the old inner city and encountered a Galician Hasid, "an apparition in a black caftan and black hair locks. Is this a Jew? was my first thought." But the more he thought about what he had seen the more his question assumed a new form: "Is this a German?" It is in the context of his earliest ruminations on what was, for him, the central question of existence that introduced Zionism into his opus.

And whatever doubts I may still have nourished were finally dispelled by the attitude of a portion of the Jews themselves. Among them there was a great movement, quite extensive in Vienna, which came out sharply in confirmation of the national character of the Jews: this was the Zionists.

It looked, to be sure, as though only a part of the Jews approved this viewpoint, while the majority condemned and inwardly rejected such a formulation. But...the so-called liberal Jews did not reject the Zionists as non-Jews, but only as Jews with an impractical, perhaps even dangerous, way of publicly avowing their Jewishness.

There is no better proof of Zionism's classic role as an outrider

to anti-Semitism than Hitler's own statement. What more, the reader was to ask, could any reasonable person need? However, before 1914 Hitler had no need to concern himself further with Zionism, as the prospects of a revived Jewish state seemed very remote. It was the Balfour Declaration, Germany's defeat and the Weimar revolution that made him think again about Zionism. Naturally he rolled all three events together. The treacherous Jews showed their true colours in the way in which they welcomed the Balfour Declaration, and it was the Social Democrats, those servants of the Jews, who brought down the Kaiser; but for them Germany would have won. In 1919 Hitler joined the tiny National Socialists and became their inspired beer-hall rabble-rouser, but the dominant ideologist on the finer points of the Jewish question was the Baltic German refugee Alfred Rosenberg, who had developed his theories while still in his native Estonia. By 1919 Rosenberg had already explained Zionism in his book, *Die Spur des Juden im Wandel der Zeiten* (The Trace of the Jews in the Wanderings of Time). It was just another Jewish hustle; the Zionists only wanted to create a hide-out for the international Jewish conspiracy. Jews were, by their racial nature, organically incapable of building a state of their own, but he felt that Zionist ideology served wonderfully as a justification for depriving Germany's Jews of their rights and that, perhaps, there was the possibility of future use of the movement for the promotion of Jewish emigration. Hitler soon began to touch on these themes in his talks, and on 6 July 1920 he proclaimed that Palestine was the proper place for the Jews and that only there could they hope to get their rights. Articles supporting emigration to Palestine began appearing in the party organ, the *Volkischer Beobachter*, after 1920, and periodically party propagandists would return to the point, as did Julius Streicher in a speech given on 20 April 1926 before the Bavarian Landtag. But for Hitler the validity of Zionism only lay in its confirmation that the Jews could never be Germans. In *Mein Kampf*, he

wrote:

For while the Zionists try to make the rest of the world believe that the national consciousness of the Jew finds its satisfaction in the creation of a Palestinian state, the Jews again slyly dupe the dumb goyim. It doesn't even enter their heads to build up a Jewish state for the purpose of living there; all they want is a central organisation for their international world swindle, endowed with its own sovereign rights and removed from the intervention of other states: a haven for convicted scoundrels and a university for budding crooks.

Jews lacked the essential racial character to build a state of their own. They were essentially leeches, lacking in natural idealism, and they hated work. He explained:

For a state formation to have a definite spatial setting always pre-supposes an idealistic attitude on the part of the state-race, and especially a correct interpretation of the concept of work. In the exact measure in which this attitude is lacking, any attempt at forming, even of preserving, a spatially delimited state fails.

In spite of any early musings about Zionism's efficacy in eventually promoting emigration, the Nazis made no effort to establish any relationship with the local Zionists. On the contrary, when the Zionist Congress met in Vienna in 1925, the Nazis were among those who rioted against their presence.

NAZI PATRONAGE OF ZIONISM

Did Hitler always plan to murder the Jews? He set down some early thoughts in *Mein Kampf*: If in 1914 the German working class in their innermost convictions had still consisted of Marxists, the War would have been over in three weeks. Germany would have collapsed even before the first soldier set foot across the border. No, the

fact that the German people was then still fighting proved that the Marxist delusion had not yet been able to gnaw its way into the bottommost depths. But in exact proportion as, in the course of the War, the German worker and the German soldier fell back into the hands of the Marxist leaders, in exactly that proportion he was lost to the fatherland. If at the beginning of the war and during the War twelve or fifteen thousand of these Hebrew corrupters of the people had been held under poison gas, as happened to hundred of thousands of our very best German workers in the field, the sacrifices of millions at the front would not have been in vain.

However, these thoughts were never the basis of the Nazis' popular agitation prior to the 1933 take-over. Instead, the Nazis primarily focused on denouncing the Jews, rather than explaining what they would do about them after they won. However, for decades "Kikes to Palestine!" had been the slogan of European anti-Semitism, and the Nazi propagandists used it in their own agitation. In June 1932 the centerpiece for one of their largest anti-Jewish rallies, in Silesian Breslaw, was a huge banner telling the Jews to "get ready for Palestine!" During the anti-Jewish boycott on 1 April 1933, pickets at the department stores handed out an imitation "one-way ticket to Palestine" to Jewish-looking passers-by. The official Nazi manifesto proclaiming the anti-Jewish boycott declared that anti-Nazi feeling abroad was due to international Jewry's "trying to act on the program announced in 1897 by the Zionist Leader, Herzl" to stir up foreign states against any country that opposed the Jews. However, none of this was very serious; it was just another expression of rabid anti-Semitism. Until he achieved power, Hitler hadn't given any serious thought to what he would do with the Jews. Beyond his statement in *Mein Kampf*, there is no evidence to prove that he told even his closest subordinates what he ultimately planned. After all, as he always privately complained, the average SS man was, at bottom, soft--and a blabbermouth. If you

talked about killing Jews, he was sure to make excuses for his own "good Jew" and then where were you? Besides, the capitalists had their Jewish business connections abroad, and there were the churches and their scruples about murder. Hitler solved his problem by just ignoring it, leaving every department in the party and government to feel its way to a suitable policy. There were inevitably conflicting schools. Straight terror always had its devotees, but these were more than countered by others who saw the Jews as deeply rooted in the domestic economy as well as having many contacts abroad. Immediate imposition of a ghetto had its partisans, but this was met with the same objections. Emigration was the obvious solution, but where to? Not only would wholesale Jewish emigration make Berlin unpopular among other capitals, but what would happen after the arrival of large numbers of Jews in any of the major cities of the world? They would incite others, and not just Jews, against the Reich and the effect they could have on Germany's trade might well be devastating. It was within this context that the Zionists, Sam Cohen of Ha Note'a and the ZVfD in Germany, first appeared with their proposals.

Ha'avara had several obvious advantages to the Nazis. If Jews went to Palestine, they would only be able to complain to other Jews. In fact, they would even be a moderating influence there, since the fear of worse consequences for their relatives in Germany, if anything were done to make the Nazis cancel the Transfer, would make them reluctant to agitate on a large scale. But the most important use of the Ha'avara agreement was for propaganda. The Nazis now had something to show the foreign detractors who said they were incapable of any policy toward the Jews other than physical brutality. In a speech on 24 October 1933, Hitler crowed that it was he, not his critics, who really was the Jew's benefactor:

In England people assert that their arms are open to welcome all the oppressed, especially the Jews who have left Germany... but it would be still finer if England did not make her great gesture dependent on the possession of 1,000 Pounds--England

should say: "Anyone may enter"--as we unfortunately have done for 30 years. If we too had declared that no one could enter Germany save under the condition of bringing with him 1,000 Pounds or paying more, then today we should have no Jewish question at all. So we wild folk have once more proved ourselves better humans--less perhaps in external protestations, but at least in our actions! And now we are still as generous and give to the Jewish people a far higher percentage as their share in possibility for living than we ourselves possess.

Nazi Germany regarded the will of the Fuhrer as having the force of law, and once Hitler had pronounced, an avowedly pro-Zionist policy developed. Also in October Hans Frank, then the Bavarian Minister of Justice, later the Governor-General of Poland, told the Nuremberg *parteitag* that the best solution to the Jewish question, for Jews and Gentiles alike, was the Palestinian National Home. Still in October, the Hamburg-South American Shipping Company started a direct service to Haifa providing "strictly Kosher food on its ships, under the supervision of the Hamburg rabbinate". Jews could still leave for any country that would have them, but now Palestine became the propagandists' preferred solution to the Jewish question. However, Zionists were still just Jews, as Gustav Genthner of the German Education School very carefully spelt out:

Just as we now have friendly relations with Soviet Russia, though Russia, as a communist country, represents a danger to our National Socialist State, we shall take the same attitude toward the Jews, if they establish themselves as an independent nation, although we know they will always remain our enemies.

If this was not enough, a children's game, *Juden Raus!* (Jews Out), left no illusions as to how the Nazis saw Zionism. The pieces were little pawns wearing pointed medieval Jewish hats; the players moved them by rolling dice; the child winning was the one whose Jew first scurried out, "off to Palestine!" through the gates of a walled city. Zionism was despised

in Nazi Germany, but the Zionists desperately needed Nazi patronage if they were to get the capital they required in Palestine and they allowed themselves to believe that the Ha'avara and all the Palestinian talk that followed it would lead to a statesmanlike pact.

"OUR OFFICIAL GOOD WILL GO WITH THEM"

By 1934 the SS had become the most pro-Zionist element in the Nazi Party. Other Nazis were even calling them "soft" on the Jews. Baron von Mildenstein had returned from his six-month visit to Palestine as an ardent Zionist sympathizer. Now as the head of the Jewish Department of the SS's Security Service, he started studying Hebrew and collecting Hebrew records; when his former companion and guide, Kurt Tuchler, visited his office in 1934, he was greeted by the strains of familiar Jewish folk tunes. There were maps on the walls showing the rapidly increasing strength of Zionism inside Germany. Von Mildenstein was as good as his word: he not only wrote favorably about what he saw in the Zionist colonies in Palestine, he also persuaded Goebbels to run the report as a massive twelve-part series in his own *Der Angriff* (The Assault), the leading Nazi propaganda organ (26 September to 9 October 1934). His stay among the Zionists had shown the SS man "the way to curing a centuries-long wound on the body of the world: the Jewish question". It was really amazing how some good Jewish *bo-den* under his feet could enliven the Jew: "The soil has reformed him and his kind in a decade. This new Jew will be a new people." To commemorate the Baron's expedition, Goebbels had a medal struck: on one side the swastika, on the other the Zionist star.

In May 1935 Reinhardt Heydrich, who was then the chief of the SS Security Service, later the infamous "Protector" of the Czech lands incorporated into the Reich, wrote an article, "The Visible Enemy", for *Das Schwarze Korps*, the official organ of the SS. In it Heydrich assessed the various tendencies among the Jews, comparing the assimilationists quite invidiously

with the Zionists. His partiality towards Zionism could not have been expressed in more unmistakable terms:

After the Nazi seizure of power our racial laws did in fact curtail considerably the immediate influence of Jews. But...the question as he sees it is still: How can we win back our old position... We must separate Jewry into two categories...the Zionists and those who favor being assimilated. The Zionists adhere to a strict racial position and by emigrating to Palestine they are helping to build their own Jewish state.

Heydrich wished them a fond farewell: "The time cannot be far distant when Palestine will again be able to accept its sons who have been lost to it for over a thousand years. Our good wishes together with our official good will go with them."

IT WAS A PAINFUL DISTINCTION FOR ZIONISM TO BE SINGLED OUT FOR FAVORS

The Nuremberg Laws of September 1935, the finishing touches of Germany's pre-Second World War anti-Jewish legislation, were defended by the Nazis as an expression of their pro-Zionism. They had at least the tacit approval of the wiser heads amongst the Jews themselves. As it happened--and naturally it was more than mere coincidence--every nationwide Jewish organ in Germany was under temporary ban when the laws were promulgated--except the *Rundschau*. It published the codified restrictions with a commentary by Alfred Berndt, the editor-in-chief of the German News Bureau. Berndt recalled that, only two weeks before, all the speakers at the World Zionist Congress in Lucerne had reiterated that the Jews of the world were to be correctly seen as a separate people unto themselves regardless of where they lived. Well then, he explained, all Hitler had done was to meet "the demands of the International Zionist Congress by making the Jews who live in Germany a national minority".

One aspect of the laws, now long forgotten but which attracted

considerable attention at the time, was the fact that from then on only two flags were to be permitted in the Third Reich, the swastika and the blue-and-white Zionist banner. This, of course, greatly excited the ZVfD, who hoped that this was a sign that Hitler was moving closer to an accommodation with them. But for many foreign Zionists this was a searing humiliation, well-expressed in the anguish of Stephen Wise's own organ, the *Congress Bulletin*:

Hitlerism is Satan's nationalism. The determination to rid the German national body of the Jewish element, however, led Hitlerism to discover its "kinship" with Zionism, the Jewish nationalism of liberation. Therefore Zionism became the only other party legalized in the Reich, the Zionist flag the only other flag permitted to fly in Nazi-land. It was a painful distinction for Zionism to be singled out for favors and privileges by its Satanic counterpart.

The Nazis were as thorough in their philo-Zionism as in other matters. Now that the Jews were established as a separate people with a separate soil, should they not also have a separate language? In 1936 they added a new "*nach Palastina*" ingredient to their repressive measures. *Jewish Frontier* had to inform its readers distressfully that:

The attempts to seclude the Jews in the cultural ghetto have reached a new height by the prohibition to rabbis to use the German language in their Chanukah (6 December) sermons. This is in line with the effort made by the Nazis to force the German Jews to use the Hebrew language as their cultural medium. Thus another "proof" of Nazi-Zionist cooperation is seized eagerly by the Communist opponents of Zionism.

NAZI LENIENCY TOWARDS ZIONISM

[H: Is anyone sick yet? I have chosen to not intervene with my comments because this is such a perfectly wondrous historical outlay of factual sequence. Is there backup information? Indeed--well over 50 confirmed references! Anybody in desire of

doing so can check them all! The truth has always been there available if you looked--it is that so few awakened enough to care to look.]

In spring 1934, Heinrich Himmler, Reichsfuhrer of the SS, was presented with a "Situation Report--Jewish Question" by his staff: the vast majority of Jews still considered themselves Germans and were determined to stay on. Since force could not be used, for fear of potential international repercussions, the way to break down their resistance was to instil a distinctive Jewish identity amongst them by systematically promoting Jewish schools, athletic teams, Hebrew, Jewish art and music, etc. Combined with Zionist occupational retraining centers, this would finally induce the recalcitrant Jews to abandon their homeland. However, this subtle formula was not enough, for whenever pressure against them began to subside the stubborn Jews would start to dig in again. The Nazi policy was therefore to increase support for the Zionists, so that the Jews would plainly see that the way to ward off worse troubles was to join the movement. All Jews, including Zionists, were still to be persecuted as Jews, but within that framework it was always possible to ease the pressure. Accordingly, on 28 January 1935, the Bavarian Gestapo circularized the regular police that henceforward: "members of the Zionist organizations are, in view of their activities directed toward emigration to Palestine, not to be treated with the same strictness which is necessary towards the members of the German-Jewish organizations (assimilationists)."

The Nazis created complications for themselves with their pro-Zionist line. The WZO (World Zionist Organization, sister to the Anti-Defamation League) needed German-Jewish capital far more than it ever wanted German Jews. It also operated under the immigration quotas set by the British. Its largest following was in Poland, and if it gave out too many certificates to Germans, there would not be enough for its support base in Poland and elsewhere. Therefore the Zionists gave only 22 per cent of the certificates to Germans throughout the 1930s. Furthermore the WZO were not interested in the

vast majority of Germany's Jews, since these were not Zionists, did not speak Hebrew, were too old and, of course, did not have the "right" trades. Either Jewish emigration had to be organized to other countries as well, or Germany would be stuck with the Jews neither it nor the Zionists wanted. Nazi discrimination against anti-Zionists led to problems for those world-based bodies like the American Jewish Joint Distribution Committee, which tried to provide havens for Jews in countries other than Palestine. Yehuda Bauer, one of Israel's most widely known Holocaust scholars, has written of a discussion of the ensuing difficulties between two leading officials of the Joint Distribution Committee:

(Joseph) Hyman thought that a statement should be made by the German Jews that Palestine was not the sole outlet which of course, frankly speaking, it wasn't. (Bernard) Kahn agreed, but explained that the Nazis supported Zionism because it promised the largest emigration of Jews from Germany; hence German Jewish leadership could not make any public statements about other outlets. Still less could they mention the decision to maintain Jewish institutions in Germany. The Nazis had dissolved one meeting in Germany simply because the speaker had said "we have to provide for the people who go away and for the Jews who must stay in Germany."

In practice, the Nazis' concern about where the Jews should go disappeared with the Austrian *anschluss*, which brought so many Jews with it that further attention to their destination would have crippled the expulsion programme. In October 1938 the Nazis discovered that the Poles were about to revoke the citizenship of thousands of their Jewish citizens resident in Germany. They therefore decided to deport the Jews to Poland immediately so that they would not be stuck with thousands of stateless Jews. It was this cold pogrom that led to the massive violence of Kristallnacht in November 1938.

The story was told, many years later, on 25 April 1961, at the trial of Adolf Eichmann. The wit-

ness, Zindel Grynszpan, then an old man, was the father of Herzl Grynszpan who, in despair at the deportation of his father back to Poland, had assassinated a German diplomat in Paris and provoked the Nazis with the pretext for their terrible night of broken glass. Old Zindel told them of his deportation from his home in Hanover on the night of 27 October 1938: "Then they took

us in police trucks, in prisoners' lorries, about 20 men in each truck, and they took us to the railway station. The streets were full of people shouting: 'Juden raus! Auf nach Palastina!'"

The significance of Zindel's testimony was utterly lost in the welter of detail in the Eichmann trial. But those Jews where not being sent to Palestine, as the Nazi mob cried; the prosecutor in the courtroom in Jerusalem never thought to ask the elderly Grynszpan a question that we would think to ask: "What did you think, what did the other Jews think, when they heard that strange cry coming up from the savage mob?" Zindel Grynszpan is long dead, as are most if not all the others who suffered there that hellish night; we have no answer to our query. But what really matters was what was shouted, rather than what was thought about it in that police van. However, we can reasonably suggest that if the ZVfD had resisted Nazism's rise, if the WZO had mobilized Jewry against the New Order, if Palestine had been a bastion of Jewish resistance to Nazism, the Nazis would never have told the Jews, and that mob, that the place for a Jew was in Palestine. Perhaps, then, that Friday night in Hanover the cry would have been "Jews to Poland", even a straight "kill the Jews." The sombre fact is that the mob screamed

what had been screamed at them by Hitler's minions: "Jews to Palestine!"

THE NAZIS ASKED FOR A "MORE ZIONIST BEHAVIOR"

That the Nazis preferred the Zionists to all other Jews is a settled point. Even though Joachim Prinz may have winced when he wrote his 1937 article, he was only being honest when he sorrowfully had to admit that:

It was very difficult for the Zionists to operate. It was morally disturbing to seem to be considered as the favoured children of the Nazi Government, particularly when it dissolved the anti-Zionist youth groups, and seemed in other ways to prefer the Zionists. The Nazis asked for a "more Zionist behavior".

The Zionist movement was always under severe restriction in the 1930s in Germany. The *Rundschau* was banned on at least three occasions between 1933 and November 1938, when the regime finally closed down the ZVfD's headquarters after Kristallnacht. After 1935 the Labour Zionist emissaries were barred from the country, but even then Palestinian Zionist leaders were allowed to enter for specific meetings; for instance Arthur Ruppin was granted permission to enter Germany on 20 March 1938 in order to address a mass indoor rally in Berlin on the effects of the 1936 Arab revolt in Palestine. Certainly, the Zionists had far less trouble than their bourgeois assimilationist rivals at the CV, and it was nothing compared with what the Communists had to face in Dachau at the same time the *Rundschau* was being hawked in the streets of Berlin.

However, the fact that the Zionists became Adolf Hitler's

"favoured children" hardly qualified him as a Jewish nationalist. Even von Mildenstein, for all his Hebrew records, accepted the party line when it turned to outright murder. Throughout the period, the Nazis toyed with the Zionists as a cat would play with a mouse. Hitler never thought he was letting anyone get away from him because he was encouraging Jews to go to Palestine. If the Jews went to far-away America, he might never be able to get at them and they would always remain the foes of the German Empire in Europe. But if they went to Palestine instead? "There," as a Gestapo agent told a Jewish leader, "we will catch up with you."

The Zionists could not even claim that they were duped by Hitler; they conned themselves. Hitler's theories on Zionism, including the Jews' alleged inability to create a state, had all been there, in plain German, since 1926. The Zionists ignored the fact that Hitler hated all Jews, and that he specifically condemned their own ideology. The Zionists were simply reactionaries, who naively chose to emphasize the points of similarity between themselves and Hitler. They convinced themselves that because they, too, were racists, against mixed marriage, and believed that the Jews were aliens in Germany; because they, too, were opposed to the left, that these similarities would be enough to make Adolf Hitler see them as the only "honest partners" for a diplomatic *detente*.

Who is Gog today?

Thank you, J.B. (Fla). You ask me to print this material so that all might see and so I shall. The following will not be in grammatical structure but rather a collection of notes. I want to move swiftly so I shall not greatly elaborate--I do, however, expect you ones to go study those great prophets and their projections and the locations of these various places of prophecy.

By the way, for you who do not attend instructions for security, I suggest you think on Pillars of Salt instead of fleeing humans. Your Biblical scholars had best forget the nonsense--the "Pillars of salt" were "stone" images of ASH from an incredible nuclear detonation and the instructions "do not look back" was what you face this day--blinding light--light so bright that it blinds totally.

Many questions flow back unto us as you face Gog and Magog and realize they are THE clues to WHO is the anti-Christ and who is the Evil-doer. Who are the ones to be "saved" and who will perish. I leave the perishment to you ones but the facts of geography and groups of participants are openly obvious--but, we shall share herein some excellent clues for your own discernment. I asked for input and I got it--here is a portion which I suggest you study most carefully.

WHO IS GOG TODAY?

QUOTE FROM LETTER OF 12/16/91

Being in America most Christians have been beguiled by our Establishment Churches and its agent. The Truth is, in the latter days there should be two different people in Israel when the anti-Christ takes over, before the Messiah comes--one is the Edomites, today called Sephardic Jews--non-"Jews" [as labeled by the Zionists], described in Malachi:4 Edom sayeth: "We shall return and rebuild the desolate places, these people (Edom) for whom the Lord has indignation forever."

The other people who would be in today's Israel in the latter days is GOG who come from Russia--now get that: "who come from Russia", but their descendents from

Japheth, NOT Sem (Shem), the father of the Semites. The People we call Russians today originally were Swedes and Danes of Europe, from Sem (Shem), the father of the "white race". They became known as Ros, Rus, and Rosh which in Hebrew means "blonds".

To find who GOG is today after a number of name changes, since Ezekiel wrote about them in his book about 580 BC. In Ezek. 38:2 it says, "Set thy face against Gog from the LAND OF MAA-GOG," the Chief Prince of Meshech and Tubal, and prophesy against him. See the enclosed map [Poor quality, not enclosed] to locate where Meshech and Tubal is. Now, most of our Establishment Churches' agents say Meshech and Tubal are Moscow and another city. This is another lie exposed, that we have been programmed with: Tubal is the area under the Black Sea in "Turkey", and "Meshech" the area between the Black Sea and the Caspian Sea, these two (2) areas were hundreds of miles south of Moscow. When Ezekiel wrote his book, it's possible no people lived in the area called Moscow today. [H: Be careful in interpretation for skin color no longer has meaning as the cycles close--it is only a clue for the upstart.] In older Bibles his name is spelled SEM, but to confuse us the reformation in the King James Version changed it to SHEM so that it wouldn't rhyme with Semite--the reformation made a number of modifications in the King James version. Why? For Who? The offspring of Jacob were all white Semites, even Esav Edom, today called Sephardic Jews, were "white", being that they were both fathered by Isaac.

But, back to who Gog is today--the answer comes by deductive reasoning. Just who is this elusive "Gog" who is going to be buried in today's Israel at Homon-GOG--who is not Semite but from Japheth, Noah's other son?

Being as how I believe Hatonn is right when he says "You, America, are israel. Why do you

believe they are trying to take your guns away"? And who are "they"? [Back to quoting] And after this "purification of Israel", Europe next, then So. Africa, New Zealand and then Australia. [H: Again and again I must caution you--these are written words to throw you off from your intent in Godness. MAN HAS NO PERMISSION TO "CLEANSE ANY MAN" FROM ANYTHING OR ANYWHERE! THEREFORE, THE SLAUGHTER WILL NOT BE FROM GOD'S DIRECTION NOR WITHIN GOD'S COMMAND. WHERE INTERPRETATION BREAKS DOWN IS IN THE ACCEPTING OF WHAT MAN "WRITES" AND DISTRACTION INTO FALSE INTENT. GOD DOES NOT "NEED" TO CLEANSE ANYTHING--NATURE WILL CLEANSE ULTIMATELY AND GOD HAS SENT THE HOSTS TO "LIFT UP HIS PEOPLE" AND THE REMAINING OF PHYSICAL EXPERIENCE SHALL CREATE HELL AS THEY SEEK TO DEVOUR AND DESTROY AND "THEY

SHALL DO IT BRAZENLY USING THE NAME OF GOD!" Please realize that I am using this for discussion purposes as to GEOGRAPHY and PLAYERS. You must realize that force and war, killing and damaging another is NOT OF GOD AND IT SHALL NOT BE EVER ACCEPTABLE. MAN MAY DEFEND SELF AND FAMILY--HE MAY NOT BURY NOR KILL AND REMAIN WITHIN THE INTENT OF GOD! EVIL SHALL DESTROY OF SELF!]

[H: Let us take up again where the writing is in point]:

...who's various name changes keep eluding us--the conclusion comes by deductive "reasoning". After extensive research, the answer is very revealing. Gog's operating area was the land of Magog which was between the Black Sea and the Caspian Sea which at that time was called the SEA OF KHAZARIA.

Now as it says in Ezekiel: those who dominate the area called Magog are called "Gog", the leading tribe. In Ezekiel's time the rulers of Magog were called "Gog" and they "shook-down" the people they dominated by getting tributes from them, but this ended in 1016 when the Russians and the Byzantine Greeks slaughtered them in battle and stopped their greedy operations. "The first two installments of immigrants are already here, so \$4 billion is already OWED to us. I can't understand the fuss. It only calls for a little generosity and humanity. IT'S NOT A BUSINESS CONSIDERATION."—Yitzhak Moda'i, Israeli Minister of Finance.

Well, there is one thing you can say for the Israelis. They've got *chutzpah*. And they are tenacious, and amazingly clever. But most of all, they've got *chutzpah*. They won't take "no" for an answer. Not when it comes to demanding U.S. foreign aid--which they seem to think is their God-given right--even when the American taxpayer is going broke trying to keep the U.S. afloat.

One of the several reasons Prime Minister Yitzhak Shamir was miffed during his recent visit to Washington was that he couldn't get President Bush or Secretary of State James Baker to talk about the \$10 billion in loan guarantees Israel is demanding to help with the resettlement of Soviet Jews. All that Bush and Baker wanted to discuss was the Middle East peace process--another sore point with the diminutive Israeli leader.

To make matters worse, Shamir was told by the Jewish pro-Israeli stalwarts that support for U.S. aid to the Zionist state was fast eroding on Capitol Hill. The friends of Israel on the conservative right were making themselves scarce, mumbling about the message Sen. Harris Wofford (D-Pa.)

and David Duke in Louisiana had delivered to the American people. Meanwhile, that dreadnought of traditional American conservatism, Pat Buchanan, has appeared on the horizon, threatening to make a run for the White House next year.

Even more disconcerting, the bevy of pro-Israeli co-conspirators on the liberal left are making like they're about to fly off. Their constituents are troubled and growing angry over the state of the economy (recession or depression, take your pick) and are in no mood to hear that their elected representatives are throwing big bucks Israel's way.

In the Senate, a sneaky amendment to the 1992 foreign aid bill approving the \$10 billion in guarantees for Israel "ran into a presidential ambush", says *Forward*, the Jewish national weekly. Even though some 70 senators, enough to override a threatened veto by President Bush, claimed to support the measure, it died a natural death. Many of the lawmakers agreed to be included on the list only with the understanding that the amendment would not be put to a real vote.

In the House, where the 1992 Foreign Aid Bill failed to pass, there is more trouble looming. The bill will come up again early next year, and shortly thereafter the 1993 foreign aid package will start in motion. On top of this, the pro-Israelites will begin agitating to pass the \$10 billion in loan guarantees measure. But with the elections, spring primaries and the big one in November, bearing down on them, "They are not likely to buck the new anti-foreign aid atmosphere," says *Forward*.

Meanwhile, the Israelis have come up with a new gimmick to squeeze more money out of the American taxpayer. Finance Minister Yitzhak Moda'i proposed last week that the U.S. adopt a three-year timetable for eliminating economic assistance to Israel by the end of the decade. You remember Moda'i. He's the fellow who presented us with a \$13-billion dollar bill--in the middle of the Persian Gulf War--to compensate the Jewish state for its costs and losses relating to the conflict.

Well, the Zionist lunatic is at it again. He has a new plan for President Bush. It goes like this:

"Give me the guarantees, and we will draw on them only as we need them to finance the immigration. If you give us the guarantees over five years, after those five years we will accept that you reduce economic aid by one-third each year for three years". (The U.S. gives Israel over \$3 billion in economic aid [cash] annually--but only \$1.2 billion is considered by the Israelis to be "aid".)

"After three years (and he actually meant and wrote, eight years), Israel will have economic independence--aside from defense aid", Moda'i promises. (We give the Jewish state more than \$1.8 billion a year in military aid.)

Moda'i says Israel needs \$50 billion to absorb the million Soviet Jews it predicts will immigrate to Zion by 1995. Where are they going to get the rest of the money? And how are they ever going to pay it back? Oh, says Moda'i, we are going to have a roaring, high-tech economy in a few years.

I can't stand to go further with the writing because it continues with stupid outlay of needs and

We acknowledge and appreciate your efforts and dedication, in the very face of ADVERSITY, to bring TRUTH and a knowledge of the "real" God and Christ to people before it's entirely too late. I admire and respect all of you. I saw lots of courage in the jungles, rice paddies, and "Iron Triangle" of Viet Nam but admit that the courage and dedication all of you exhibit may exceed that.

When I first started (barely) reading the Phoenix material, having just seen the Green's video tape, I wrote a short letter expressing my reaction to some "traumatic" new ideas (Truths) and the profound effect it was having on me. That must have been some 3 or 4 months ago.

Since then, I have read a great deal more. I was so "captured" by my new experience that I have bought every JOURNAL and all "back-issues" (so-to-speak) of *Expresses*, etc. available, and a few other books you carry (like Mullins' CURSE OF CANAAN) as well. It is obvious that you, as James Gritz, have no fear for self and that allows "daring" adventure--but you must be cautious in that you always "serve" where the gain can be compounded beyond that which can be thrown against you!] and a Viet Nam Vet without guns is unusual. I am in POOR HEALTH (AGENT ORANGE effects, etc.) and have no idea how to defend us without Arms against either marauding gangs turned loose on us by the Gov't or the Communist Armies in Mexico and in the U.S. or the Mossad-trained ruthless, sadistic Security Forces. My wife says I "obsess" (one of the major problems of "Delayed Stress" is obsessive-compulsive behavior) over these "threats". But it worries me. If I buy guns, they'll just be confiscated. If I bury them, metal detectors will find them. It seems like a "No-Win" scenario if we lose our fight for the Second Amendment. So I worry. (I am a big worrier) [H: Here's another deletion to your vocabulary, son--"worry", let us guide that "worry" into constructive "thinking" with the goal intent to "solution through alternative to violence" measures. What will hurt your enemies the most? Revelation of their actions and truth of their actions--you cannot kill them all and moreover, YOU do not know WHO TO KILL TO RID THIS PLACE OF THE EVIL-DOERS FOR THE ONES YOU SEE ARE BUT PUPPETS!] My wife says "obsessing", "worrying" will attract those threats if they become real and I should quit worrying and trust to GOD to protect us. But so far I have read nothing in the literature that says the Space Brothers--Hatonn--Sananda--will do that should the worst happen. Besides, a Viet Nam Vet likes to "trust" to his Weapon! [H: Ah so now we finally get there--good man! YOU just put

your trust in the WRONG WEAPON, son, although I honor you for respecting your wife in her efforts to bring balance. You must realize that the intent, training, medications, and control instilled in ones in "Your" war was directly to keep you focused on violence so that you would be NO PROBLEM as the curtain would descend and the shackles be applied. You would be acting out in ways which would allow their control of you through force and thus, leaving the masses defenseless. As you read you will find those deliberate actions against you, identified. You ones who served in that war were LITERALLY injected with computer pulse-responsive programming CHIPS so that you can be triggered at will to function in most heinous manners--with those guns that most of your brothers still have at their shoulders. You are controlled into doing that which is happening to YOU. YOU CAN REGAIN YOUR POWER WHEN YOU FIND THE TRUTH AND IN THAT POWER YOU CAN HENCEFORTH ACT IN REASON AND RESPONSE--NOT REACTION IN IMPULSE. YOU BECOME "THEIR" ENEMY AND NO LONGER THEIR "TOOL". DO YOU SEE? Will the "Higher Command" protect you? If need be but I suggest that you will be given into knowing how to protect selves by that time of need. God most surely has full intent of bringing His ones into security for you are the keys to that "Kingdom" through the service of your present placement. All you are doing, son, is awakening unto your mission.]

....my wife sees "faces" so to speak when I get ANGRY--I picked some up in Viet Nam and they seem to be discarnate beings. This makes it difficult for me to foresee victory (eg. 2nd Amendment vs. Gun Control; TOTAL

POVERTY, LOSS OF EVERYTHING or GANGS or MILITARY DICTATORSHIP or NUKES; DEATH or ENSLAVEMENT, etc.) against such daunting odds. It looks HOPELESS with only a few thousand people "AWAKENED" out of 245 MILLION. This depresses me. I'd prefer to take up Arms with others, fight a Revolution, probably get killed, etc. That I UNDERSTAND! But Hatonn says NO! to that. I wonder if I no longer have the courage, fortitude, stamina, determination, etc., I had in Viet Nam 23 years ago!? Right now I WANT to do something really ACTIVE to help you or Bo Gritz, etc., but either lack the PHYSICAL ENERGY or the MORAL RESOLVE. It is painful to analyze these things. I have the "guts" to fight these EVIL B-----S on the Battlefield but am IRRESOLUTE AND CONFUSED fighting them your (Hatonn's) way. Perhaps I need to get into BALANCE, to read more and more and more, to meditate SANANDA's real teachings, to practice calm, objective, unemotional analysis of my enemy's plans (as I must have done countless times in armies fighting them in the past) and calm, unemotional counter-actions. I ADMIRE all of YOU WHO DO THIS!!!

[H: I have to stop here and address the above. I shall also tell you a story (out of school) regarding your "leader", Bo Gritz. He said to me, Hatonn: "Can we just go in there and 'take-out' the responsible bastards?" I simply asked him: "Who would you take out?" You see, that is never the answer in God's terms--it is always the answer in the human aspect. It may work if you have the most men and the biggest gun--neither of which you have, even if the plan were valid in moral rightness. The facts remain that you can not reach the REAL culprits and therefore canonically render yourself "dead" in the fray and lessen all chance of change in the overall. You ones think in human "earth" solutions and "force" will not "cut the mustard" this time. It is only through knowledge and KNOWING in the proper service to Command of God that will prevail in "winning" this particular war. A Sniper Rifle will only set the "army" back

and get the "sniper" killed and misery piled upon misery for the loved ones remaining--that is NOT protection of the innocent--it is the selling of the innocent into "hell". The only TRUTHS I feel I can trust now are AMERICA WEST's publications. Please tell people never to buy anything from INNER LIGHT PUBLICATIONS (Beckley--Cooper "NEW AGE CONFERENCE" etc). I was cheated out of \$260 by them just before real exposure to your (Hatonn's) Truths.

Once I establish a "Balance" and finish the rest of the material I hope to be able to do something to help. Anything. Right now, I'm just able to help myself (barely). But that New Truth keeps coming in and staying in!

Despite things I've mentioned, I feel I'm a BETTER PERSON now for reading your material. When I think of the Elite stopping your dissemination of Truth (and explanation of current events--very, very important to me!) I get a little "scared" (worried). Right now I'm "new", so I'm pretty "dependent" on your newsletters and worry when they are late. But, whatever happens, I have ALL of your In-print published works and will bury them if I have to, to keep them from being confiscated by Security Forces "searches".

I have tried to provide your TRUTHS to my son who is in the military. He "believes" ("most of it", he says) but I worry what would result if found with Phoenix

material in his barracks. It also seems to have affected him emotionally as he now hates the Military (to whom he is indebted for 3 more years of indentured servitude) and is "in trouble" as a result and possibly headed for disciplinary action. He feels that the "truth" (conspiracies, collapse of economy, invasion, nuclear war, enslavement, etc.) makes his situation POINTLESS & INTOLERABLE. Already, he has been denied Christmas leave as a punishment. At his age, perhaps these REALITIES (DANGERS) are harder to deal with than at mine? Did I do him a DISSERVICE? He, too, thinks I am "obsessed" over the JOURNALS etc., although he says "Yes, they are right". I felt I owed it to him to give him the OPERATOR/OWNERS MANUAL, all current Newsletters and PLEIADES CONNECTIONS to try to "save his Soul" if the worst case scenario happens soon--was I right? I nor his mother can "Save him (soul)", only he can do it! His mother worried that it would DESTABILIZE him EMOTIONALLY, and it has, but agreed he had a right to KNOW THE TRUTH!

[H: This is a hard one for parents and loved ones to balance in wisdom. Just always look at why you do a thing or "feel" a thing and evaluate it carefully. If you share equally in all instances--the intent is correct. If you "use" any action as escape, ego massaging, self-pity, insecurity, etc., WATCH OUT! Man is not expected to be perfection for that is of God alone and that for which we all seek in service and intent. You are birthed of flesh and trained by flesh and you cannot totally separate from the flesh lest you cease to be "man" and can no longer serve in your manifested placement. Look upon these things with wisdom and discernment. Now, however, I shall give you the punchline: you know

that the things of flesh pass in swiftness and the senses only are hyped to expect more and more and more and actually the fulfillment cannot be found in the physical experiences for the enemy always keeps the goal out of reach. AS YOU MOVE INTO FULL COMMITMENT AND DIRECTION OF PURPOSE YOU WILL FIND YOU HAVE NO "TIME" TO WASTE IN SUCH TRIVIAL EXPERIENCES AND THE "PROBLEM" PERCEIVED WILL TAKE CARE OF ITSELF. IF YOU FOCUS UPON IT IT WILL DISALLOW YOU ANY OTHER ACTION. YOU MUST GROW INTO AND WITHIN THOSE WONDROUSLY BALANCED LAWS AND RESPONSIBILITY AND ABOVE ALL--FORGIVE SELF, IT IS NOT THE EMOTIONS WHICH ARE CULPRITS IN EVIL OR SELFISHNESS--IT IS THE LACK OF WISDOM AND DISCIPLINE AND IT IS THE LATTER ACTION FOR WHICH A MAN IS MEASURED--ALWAYS!]

My soul intent is--I hope--GOOD and I yearn to cast off physical habits, activities, desires, and obsessive practices and pray that I can be "accepted" as a "probationary candidate" (of "Good Intent") [H: Son, and so you have it!] if not deserving of nor ready for immediate "promotion"! I can't think of any other reason to continue in physical form if all the Elite Plans are successful. [H: I suggest that it is ONLY through ones such as yourself remaining in the physical state of being which shall insure that the Elite Plan DOES NOT WORK.] I feel that I have lived as many lifetimes as almost anyone else here--mostly killing and being slain on Battlefields throughout History. [H: Ah so--killing and being killed. "Willing to die" is not at point, then, is it? Therefore, consider "willing to live" for an ideal and willing to serve to leave a legacy of Truth and freedom to the children--that is a worthy plea, indeed.]

I pray that Hatonn feels I have a "fair" chance to pass "Sananda's" Judgement (even if only Probationary as a "student") on one of his beautiful craft off this evil planet! [H: Fine, I thought for a while that you might not ask to use your room!]

In conclusion I want to thank all of you, like Dharma's unselfish and exhausting labor, and most of all Hatonn & Sananda for allowing me to live long enough to LEARN REAL TRUTH about everything, including Christ's (Immanuel's) real experience here; "real" History; the Laws; the workings of the Universe, etc. Of course, I'm not so sure that I'm enjoying it! [H: Ah, but you ARE--you are finally really enjoying the experience for now it has purpose. So be it.]

I am filled with AWE at all of you. To repeat--I think your courage exceeds what I saw around me in battle in Viet Nam. All I can think of to say is "THANK YOU FOR LOVING US ENOUGH TO KEEP TRYING, IN SPITE OF...." [H: I shall humbly accept that appreciation on behalf of my crew who serve long and diligently so that their own growth can mature. It is infrequent that ones recognize them in their journey to your place for the understanding of such travel and service is "forgotten" in your bound society. Yes indeed, it is time to remember that you can "fly" and the journey to God requires that first step in the direction of God—all else will follow if the path be maintained.]

WHAT ABOUT JOHN?

QUOTE:

When World War II broke out in Europe, Ivan (Russian for John) Demjanjuk was a poor farmer in the Ukraine. He enlisted in the Red Army and became an infantryman assigned to halting the onslaught of the Nazi tank divisions which had invaded Mother Russia. Soon taken prisoner by the advancing German troops, Demjanjuk was transported to Poland and detained at Chelm, a prisoner of war camp where captured Soviet soldiers were used as slave labor. Many were worked and starved to death. Some cooperated with the Nazis, and were recruited to guard the concentration camps housing Jewish civilians.

After the war, he languished in refugee camps in Eastern Europe. In 1948, along with hundreds of thousands of other refugees, he was processed through Stuttgart, Germany for emigration to the U.S. At the time, it was believed that he was a Polish civilian who had spent the war sidelined in a displaced persons' camp. In 1952, he was allowed to emigrate and settled in Cleveland. Demjanjuk found a job

as an autoworker, started a family, and began his pursuit of the American dream.

The Department of Justice became interested in Demjanjuk when staff members came across an article in a Ukrainian newspaper that alleged the existence of an identification card from Trawniki, showing that the former POW had been trained there to serve as a guard in Nazi concentration camps. The newspaper article has since been proven to have been planted by the KGB as part of a clandestine intelligence operation against anti-Soviet emigre organizations in the U.S. For years prior to the "discovery" of Demjanjuk's ID card, American-Ukrainian and Jewish groups concerned with the plight of Soviet Jewry had been working with the CIA to undermine the communists in the Soviet Union. The KGB saw Demjanjuk as a wedge which could be used to divide these groups. It proved to be an effective one, largely because the Zionist zealots in the Justice Department blundered into the trap.

Demjanjuk's dream came to a crashing conclusion in 1976, when the witch-hunters of the OSI began their persecution of the former POW. The OSI is the Nazi-hunting wing of the Department of Justice. What its staff lacks in intelligence and integrity, it overcompensates for in vengeful enthusiasm, which in turn has led to a great deal of malicious mischief and a long string of disgraceful indiscretions. The track record of the OSI successfully stripping actual Nazis of their citizenship and deporting them to the appropriate countries for trial is dismal. One of OSI's crowning achievements was the persecution of Frank Walus, a Pole who was accused of being personally responsible for the murder of hundreds of thousands of Jews in a Nazi death camp. After years of spitefully molesting Walus, the Justice Department finally admitted that OSI's 12 key witnesses against him had lied, and the case was dropped. Although Walus escaped the Zionist witch-hunters, his struggle for justice left him penniless.

Other victims of the OSI have not fared so lucky. Cherim

Sobzokov, an anti-communist refugee who emigrated from the Soviet Union in 1955, was charged with being an SS officer who personally committed sadistic mass-murder in Nazi death camps. Initially charged in 1977, it would take seven years and everything he owned to prove his innocence. Finally cleared of the heinous charges and free of the vindictive OSI, Sobzokov was murdered when a car bomb took his life on September 7, 1985. That same day, Elmars Sprogis, an elderly immigrant who had also been investigated and cleared by the OSI, was the intended victim of a bombing. Sprogis was uninjured, but his neighbor was crippled and maimed in the attack. The militant Jewish Defense League terrorist organization immediately took responsibility for both bombings.

The OSI was born to satisfy the cravings for vengeance of Jews frustrated in their efforts to punish the Nazi war criminals who caused them misery. Originally, the Immigration and Naturalization Service (INS) of the Justice Department was entrusted with this responsibility, but their success was not adequate to satisfy the bloodlust of influential American Zionists. Following the highly publicized trial of accused Nazi collaborator Feodor Fedorenko in 1978, in which he was acquitted, the Jewish lobby became enraged and mounted a campaign for the establishment in the government of an agency dedicated exclusively to Nazi-hunting. (Years later, the OSI would again bring Fedorenko to court. This time, he was denaturalized and extradited to the USSR, where he was executed by the Soviets in 1988.)

One month after Fedorenko was acquitted, Congressman Joshua Eilberg (D-Pa.), chairman of the Immigration, Citizenship, and International Law subcommittee, was able to establish the Special Litigation Unit (SLU), the precursor of the OSI. The SLU was intended to be concerned solely with the prosecution of alleged Nazi war criminals. In addition, however, the new component was founded in no small part to hound Demjanjuk. Eilberg

and the lobby believe the continued funding for the Nazi-hunters was contingent on the successful prosecution of the Demjanjuk case.

In a letter sent to then Attorney General Griffin Bell, Eilberg argued, "I would strongly urge you to place the direction of the proceedings of the DEMJANJUK case in the hands of the Special Litigation Unit. We cannot afford to lose another decision." The reference to the loss of another decision was to the first Fedorenko case, but it also signaled the intention of the witch-hunters to go all out in their effort to discover and convict alleged Nazi war criminals. Guilt or innocence would be of little consideration; convictions would be the ultimate goal.

Eilberg was more than a paid toady of the Jewish lobby; he was a common criminal who was subsequently convicted of peddling his influence to the highest bidder. Within one month of the establishment of the SLU, Eilberg pleaded guilty and was convicted of conflict of interest in U.S. district court. He was kicked out of the House of Representatives for taking \$35,000 in fees from Hanemann Medical College, which received a \$14.5 million expansion grant. Eilberg also received hundreds of thousands of dollars from contributors in the Jewish lobby.

The case against Demjanjuk was handled by Martin Mendelsohn of the INS, who would later move to the SLU and still later become director of litigation for the OSI. Hunting Nazis, real or imagined, is in Mendelsohn's blood. He is currently serving as legal counsel for the Simon Wiesenthal Center of Los Angeles.

The INS discovered that Demjanjuk was not a Pole who sat out the war in a DP camp, as was erroneously stated by American immigration officials when he emigrated to the U.S. in 1952. He was forthright with his explanation that he was actually a Ukrainian who had served in the Red Army and had spent the war in Chelm as a POW. But this was not good enough for Mendelsohn's purposes. He needed a Nazi war criminal, even if he had to manufacture one out of thin air to justify the existence of newly created SLU. Be-

cause Demjanjuk's name was Ivan (John), and there was no evidence to prove he had not been at Trawniki, Mendelsohn and the INS conspired to present Demjanjuk as being "Ivan the Terrible", the brutal Ukrainian guard accused of the torture and deaths of thousands of Jews at the Treblinka prison camp. Catching Ivan the Terrible would be quite a trophy for Mendelsohn and the SLU.

When it became obvious that the Fedorenko case was in jeopardy, Mendelsohn requested assistance from the Soviet Union. In a surprise move, the Soviets delivered some 100 pages of testimony taken by the KGB between 1944 and 1961 from 21 Treblinka guards who, as fate would have it, had also worked with and knew Ivan the Terrible. Included in the KGB interrogation file was a photograph of the infamous Ivan the Terrible. Unfortunately for Mendelsohn, the evidence proved beyond all reasonable doubt that Ivan the Terrible was a man named Ivan Marczenko, not Ivan Demjanjuk.

The KGB's interrogations of individuals who served as prison guards at Treblinka described Ivan the Terrible as being tall, with dark hair and a dark complexion, and having a prominent scar on his right cheek and neck. They also knew him by name--Ivan Marczenko. Ivan Demjanjuk was of average stature, with blond hair and blue eyes, and has no scar on his cheek or neck. Photographic evidence had proven that Demjanjuk was not Marczenko and, therefore, not Ivan the Terrible.

The Demjanjuk case could have ended there, but Mendelsohn and his fellow Zionist fanatics needed a convicted witch to justify their jobs. Thus, the exculpatory Soviet evidence would be buried by the Department of Justice for 12 years. It was uncovered only earlier this year when Demjanjuk's defense attorney went to the Soviet Union to follow up on a tip provided by Demjanjuk's family, which was working closely with Rep. Traficant's office.

The SLU, which became the OSI in 1979, proceeded with the Demjanjuk denaturalization case. In 1981, relying on manufactured

evidence, the perjured testimony of a Nazi guard at Treblinka, and the sheer zealotry of the prosecutor, Demjanjuk was stripped of this citizenship. Mendelsohn had hand-picked Norman Moscowitz, OSI's prosecutor in the case. The ambitious Moscowitz pursued the case with fanatical zeal, assembling some 40 eyewitnesses who testified that Demjanjuk was Ivan the Terrible of Treblinka. All but four of the witnesses were discredited in court, and the testimony of three was deemed questionable and inconsequential.

The prosecution relied solely on the testimony of Otto Horn, a Nazi guard. According to the court proceedings, Moscowitz and two OSI criminal investigators took a videotape deposition of Horn, in which he identified Demjanjuk as Ivan the Terrible. However, internal OSI reports by the two investigators, Garand and Dougherty, to Moscowitz and OSI director Arthur Sinai reveal that Horn had been lying. Remarkably, these reports absolutely contradict Horn's damning testimony. The suppressed reports were discovered in the Justice Department's trash dumpster years later.

The internal OSI reports disclosed that Horn was shown eight photographs of men in their twenties, one of which was Demjanjuk. Horn could not identify any of them. The photos were then set to the side, with Demjanjuk's photo on the top of the pile facing Horn. A second set of photos, this time eight men in their forties, was spread before Horn. He could not identify any of them as being Ivan the Terrible. But with coaching from Moscowitz, Horn agreed that Demjanjuk could possibly be Ivan the Terrible. With a little more help from Moscowitz, Horn finally identified Demjanjuk as being the guilty party.

The transcripts of Demjanjuk's denaturalization trial, however, depict a far different scenario. In the videotape deposition, Horn says he identified Demjanjuk immediately from the first set of prints. When the second set was placed before him, the first set of photos was removed from view and placed in an envelope. He then states that he identified the photo from the second set as well. Horn the perjurer has since been a key witness for the

prosecution in Israel. (It seems to run with the "family" name doesn't it, Dharma?)

Other evidence cited by OSI in Demjanjuk's trial was that his mother's maiden name was listed as Marczenko on his emigration documents. This was twisted around by the prosecutor to imply that Demjanjuk had used the name of Marczenko when he was alleged to have been a guard at Treblinka. Years later, as a result of Rep. Traficant's investigation, it would come to light that Marczenko was not really Demjanjuk's mother's name. It was Tabachuk. Demjanjuk had forgotten his mother's maiden name and used Marczenko--a name as common in Ukraine as Smith is in America.

Secure in his innocence, the gravity of what the OSI witch-hunters were doing escaped Demjanjuk. He was taken by surprise at the verdict stripping him of his citizenship. In 1986, he was deported to Israel to stand trial. His family was aghast. Forced to drop everything and devote their lives to seeing that justice prevails, the Demjanjuk family has faced tremendous hardships and endured a vindictive government agency out of control. The family turned to their elected officials. No one was willing to lift a finger to help an alleged Nazi war criminal. None except Congressman Traficant.

Demjanjuk's trial in Israel began in February 1987. He was charged with crimes against humanity, crimes against the Jewish people, war crimes and crimes against persecuted persons--all punishable by death under Israel's Nazi and Nazi Collaborators Punishment Law of 1950. The only other person ever to be tried under that law was Adolf Eichmann. In addition to the shoddy circumstantial evidence used by OSI in Demjanjuk's denaturalization trial, the Israeli prosecutors had five eyewitnesses, one of whom was Otto Horn. Another was Penchas Epstein, who years earlier swore to have been one of a band of camp inmates who, in the confusion just before the liberation of Treblinka by the Red Army, set upon Ivan the Terrible and beat him to death with shovels. Epstein later changed his mind, deciding that it must have

been someone else they bludgeoned to death. He also decided that Demjanjuk was Ivan. **[PROTOCOLS: "IF ONE OF OUR PEOPLE SHOULD UNHAPPILY FALL INTO THE HANDS OF JUSTICE AMONGST THE CHRISTIANS, WE MUST RUSH TO HELP HIM; FIND AS MANY WITNESSES AS HE NEEDS TO SAVE HIM (OR CONVICT THE PERSON IF AGAINST OUR CAUSE) TO SAVE HIM FROM HIS JUDGES, UNTIL WE BECOME JUDGES OURSELVES."]**

On April 18, 1988, John Demjanjuk was found guilty of all four counts and sentenced to death. His conviction was based on the testimony given by the dubious eyewitnesses, the ID card from Trawniki, and the "the false alibi and other lies of the accused and his incriminating behavior and statements." There was no evidence presented linking Demjanjuk to Treblinka. When questioned by the judges as to why he had not addressed the issue of Treblinka, the Israeli prosecutor arrogantly announced: "I will deal with Treblinka later." The judges were drowned out in the reading of the death sentence by curses being put on the defense lawyer, Yoram Sheftel, the singing of Hebrew songs, dancing, and applause.

Defense attorney Sheftel filed an appeal, citing the reasons of "press incitement" and the "lynch atmosphere" in which influential Israeli politicians openly spoke out against Demjanjuk, and most importantly, that most witnesses could not identify Demjanjuk. Months later, just before the appeal was to be heard, one of the defense lawyers died; Dov Eitan allegedly jumped to his death from a building in Jerusalem. There was, however, no suicide note. Two days later, at Eitan's funeral, Demjanjuk's head lawyer was attacked by a holocaust survivor, who threw acid in Sheftel's face, injuring his left eye. The Israeli court has been stalling on Demjanjuk's appeal ever since--now almost five years. Later this month the high court is to hand down its decision, but informed sources believe the court will delay again. "They got the wrong man, and they know

it. But they don't know what to do about it," says one source.

[H: The Israelis are the stooge in this mockery of justice. Their guilt in this matter has been foisted upon them by the OSI--THE TRUE CRIMINALS. But they could not have accomplished this fiasco alone. And their accomplices are just as guilty for their role in subverting justice after the fact. All the milquetoast congressmen and senators who feared reprisal from the Jewish lobby and turned their backs on John Demjanjuk are guilty! All the members of the media who condemned Demjanjuk are also venal. Particularly sinister is the role of the Jewish press. Anyone who questioned the kangaroo-court antics of the OSI and the subsequent Israeli trial was smeared with the old canard of anti-semitism--always used by the lobby to stifle dialogue. Especially singled out for crucifixion have been Rep. Traficant and conservative presidential hopeful Pat Buchanan. Buchanan was lambasted for his support of the Ukrainian groups that have tried to assist the Demjanjuk family, and for his portrayal of Demjanjuk as "the American Dreyfus"--a reference to the French officer wrongly accused before World War I of being a spy because he was a Jew. Demjanjuk was butchered weekly in Jewish publications, but now when serious questions have arisen as to the accuracy of the verdict, there has been virtually no mention of Demjanjuk the Terrible.]

There is wide speculation that the Israelis, the willing dupes of OSI's deceit, are engaged in stalling tactics with regard to Demjanjuk's appeal, and will continue to stall until Demjanjuk "dies" in prison, thus effectively sweeping the situation under the rug of history.

[H: Yes indeed, I believe this is a case for the "Court of Last Resort"--NOW! YOU ARE GOING TO BEGIN TO BRING THIS ISRAELI ZIONIST/SOVIET SOCIALIST FASCISM UNDER CONTROL NOW OR YOU ARE DESTINED FOR DESTRUCTION AS A PLANET! WHAT YOU DO IS UP TO YOU, BUT THIS IS WHERE YOU START--IN A BIG, BIG

WHAT ABOUT JUSTICE IN THIS MATTER?

[H: Let us look at this man, Jim Traficant. Let us also see WHO refused to "get involved" and deliberately shunned truth to stop this gross injustice against a fellow citizen and human being.]

When it became apparent to the Demjanjuk family that justice would in no way prevail without special help, they turned to Congress. As Demjanjuk was from Cleveland, one of three duly elected gentlemen should have taken the responsibility to help their constituent--**ISN'T THAT WHY YOU SEND MEN TO CONGRESS???** But Sen. John Glenn (D-Ohio--Keating Five), war hero and astronaut, **REFUSED TO HELP.** Sen. Howard Metzenbaum (D-Ohio), the liberal who speaks frequently about the virtues of civil liberties, **TURNUED HIS BACK ON THE DEMJANJUK KIN.** The most pathetic display of cowardice, however, was displayed by the slick and slippery Rep. Edward Feighan (D-Ohio), **WHO HAD THE DEMJANJUK FAMILY PHYSICALLY THROWN OUT OF HIS OFFICE AFTER REFUSING TO SEE THEM.** **Feighan receives the bulk of his campaign funds FROM JEWISH PRO-ISRAELI PAC's.**

In desperation, the family sent out no fewer than six mass mailings to every single senator and congressman on Capitol Hill. Eighty percent were ignored. The other 20 percent were non-responsive replies, most of which referred the problem to Glenn, Metzenbaum and Feighan. There was, however, a lone positive response that expressed concern over the fact that Demjanjuk has received no criminal trial. That letter--from Rep. James Traficant (D-Ohio)--was the only encouragement given the family. But Traficant was not overly enthusiastic about helping the

Demjanjuk family. His letter said that he wouldn't help if Demjanjuk had been a guard for the Nazis, let alone Ivan the Terrible. However, Traficant's personal animosity toward the Nazis was overridden by the former sheriff's concern that Demjanjuk, an American citizen, had not received a fair trial.

Ed Nishnik, Demjanjuk's son-in-law, remembers the congressman's reaction. "Traficant said he wouldn't help if Demjanjuk was a Nazi, he hates Nazis. But he expressed concern that Demjanjuk had received no criminal trial," said Nishnik.

Traficant told *New American View*, "When Nishnik and Demjanjuk's son contacted me, they said no one would even talk to them. I explained that I couldn't help them and referred them to their area representative for help as there were no laws broken in the proceedings. But after noticing some legal irregularities, I told them I'd take a look at it."

Next came the mysterious "trash reports"--documents regarding OSI's case against Demjanjuk which had been recovered from a dumpster outside the Justice Department. The anonymously provided documents proved what Nishnik and Demjanjuk Jr. had suspected all along: The Cleveland autoworker had been **framed by the OSI.**

According to Nishnik, the mysterious internal OSI reports started arriving shortly after Demjanjuk was extradited to Israel. Because of the anonymous nature of the documents, it was initially believed that they were being provided by someone within the OSI. It turned out, however, that a civil rights watchdog group was monitoring the Justice Department's trash bins, and had come across the reports.

Several documents proved that the key testimony at Demjanjuk's denaturalization hearing were lies--and the witness's perjury was known by the OSI. The OSI had covered up the false testimony, as well as other exculpatory information which proved Demjanjuk was not Ivan the Terrible. The reports were gold in the garbage "amid french fries and coffee grounds", said Nishnik. **[H: NEVER UN-**

DERESTIMATE THE WORKINGS OF GOD HIS MIRACLES TO ACHIEVE! *The enemy has since taken up with better watching over the paper shredder!* "The reports were stained, torn, and taped together--but they are explosive."

The trash reports convinced Traficant of Demjanjuk's innocence, and of the disgraceful and illegal OSI conduct. Since he has taken an interest in the case some three years ago, Traficant has worked ceaselessly to get to the bottom of the sordid affair. The road has been as long as the angry vituperation of the Jewish lobby has been vicious.

Armed with leads from the trash reports, Traficant started his quest to get to the bottom of the case. Leaving no stone unturned, the congressman made innumerable Freedom of Information (FOIA) requests to all government agencies which could conceivably have information germane to the investigation. The Justice Department covered up what it could, but other agencies supplied documents in spite of the DOJ's roadblocks. The new information proved that a conspiracy has long existed among OSI officials to frame the innocent American and send him to his death--to satisfy an uncontrollable blood lust. The documents also expose the current chief of OSI Neal Sher's decision to consult with Israeli officials on how best to foil Traficant's investigation.

The OSI has not only refused to cooperate with Traficant's investigation, it has attempted to frustrate his efforts at every turn. Traficant describes his investigation as "piecemeal" with information coming from the most unlikely of sources. The State Department, for example, was the source of the fax to Martin Mendelsohn from the USSR which refers to the 100-page KGB interrogation file proving that the OSI knew of Demjanjuk's innocence SINCE 1978.

In May 1990, Traficant sent an investigator, West Richards, to Poland to search for evidence on Demjanjuk's past. After digging through mountains of information, Richards began to sense that the Poles were withholding information. He only recently learned that

the KGB had intervened with the Poles to keep data from him which would prove Demjanjuk's innocence. Nevertheless, Richards' visit did yield some interesting results, the most beneficial being that contacts were established with a Ukrainian Parliament member, Alexander Yemetz, who would turn out to be instrumental in locating the 100-page KGB interrogation file of the Treblinka guards. Thought to have been destroyed by Mendelsohn some 10 years earlier, the file turned up in the Ukrainian capitol of Kiev, where it was found by Nishnik in December 1990. When Nishnik returned to review the file, however, it had disappeared. The KGB had received a request from the Israeli prosecution to review the file, and the Soviet secret police had surreptitiously transferred it to Moscow. The Israeli prosecutor received the file in April 1991, but it would take four months of haggling and a threatened hunger strike by Demjanjuk before it was finally turned over to the defense team.

During the course of Traficant's investigation, Richards has had frequent contact with a Soviet Embassy staff member who assisted with administrative tasks, such as forwarding information requests to the appropriate Soviet agency, issuing visas, and the like. Citing concern for national security, the FBI has hounded Traficant and his staff, demanding accounts of each contact with the Soviets. This raises serious questions. In light of the Justice Department's inaction on the case so far, one must ponder the real motivation for the FBI's interest. The Department of Justice under **ATTORNEY GENERAL RICHARD THORNBURGH HAS BEEN INVOLVED IN DIRTY DEALS AND UNLAWFUL COVER-UPS--the Inslaw case, the role of the Drug Enforcement Agency and CIA in the Pam Am 103 bombing, the dormancy of the Foreign Agents Registration Unit, the BCCI scandal, and a number of other governmental embarrassments (right along with Gates, your new CIA director!)**

Is the FBI monitoring Traficant's progress in order to cover OSI's and the Justice Department's tails? Is this some kind of veiled intimidation calculated to get the Ohio congressman to back off? **[Yes indeed!]**

In his latest effort to get at the truth in the Demjanjuk affair, Traficant has again appealed to Rep. Jack Brooks (D-Texas), Chairman of the House Judiciary Committee. He wants Brooks to force the Justice Department to comply with his investigative requests and to help his investigation. Traficant's letter to Brooks concludes: "It would seem most unusual if the Israelis would vacate this conviction of a former American citizen on the strength of evidence that the U.S. Justice Department had in their possession since August 12, 1978 and suppressed it."

The depth and scope of Traficant's investigation has not been lost on Ed Nishnik. "We are so glad for Jim. Not one, not even one congressman would help us. As you know, he's an ex-sheriff, so he's got a real nose for investigations. He knows from experience all the do's, don'ts and should-have-dones to the letter of the law. He didn't even want to see us in the first place, because of the stigma of standing up for someone who's been branded a Nazi. If he had detected any holes in the Demjanjuk story, I have no doubt he would have thrown us out."

Despite his father-in-law's death sentence at the hands of the

Israeli high court, Nishnik harbors no antipathy towards Israel. Rather, he feels it, too, is the victim of a rogue government agency. "This is a national disgrace forced on Israel from the OSI." **[H: No it is NOT. Israel is 100% behind the dastardly deed, instigator and perpetrator! America's economy failing rapidly

Because the hoped-for war that would save the Bush Administration's sick economy has failed to materialise, there is no relief in sight, no recovery, slow or otherwise, at the end of 1991. Hopes are fading for economic results that will save face for the President and his advisors.

Retail sales are at depression levels, close to those of the post-Wall Street Crash era. In a telephone call to all major banks and finance institutions, President Bush urged them to urgently redouble their efforts to make far more consumer spending loans available. He also asked the Federal Reserve Board to make yet another cut in the prime rate. The prospect of a further drop in interest rates sent disinvestment in "safe haven dollars" soaring.

Government unemployment figures show an increase of 6.8% in joblessness for October, but here again, the figure is understated. According to my economic intelligence sources, "The actual number of unemployed people, not taking into account part-time jobs the government counts as full employment, rose by 11.7%, or nearly double that admitted by the Labor Department."

Unemployment is the single most visible sign that the United States is in the midst of a deep depression, WORSE THAN THE POST WALL STREET DEPRESSION. Loss of jobs in industry, the service industry, medical technology, doctors, dentists and even lawyers is shaking the White House. Although October reports on housing starts looked better, the continuing loss of jobs in the construction industry does not square with alleged new housing starts.

Government statistics admit to 8.6 million unemployed in October, up from 8.4 million in September. Here again the figures are grossly understated, bearing in mind that the Labor Department no longer counts as unemployed those who have simply given up looking for work. As previously stated in my report, the actual number of unemployed Americans is now in excess

of 30 MILLION.

Labor force participation rates declined a full 2% in October, although government is admitting to 0.3%. The Labor Department has it that the startling drop is due to teenagers and women who are no longer looking for jobs, and ignores construction workers, aircraft industry workers and white collar workers who have given up in despair of ever finding a job.

Instead of the expected easing of credit, there is a credit crunch on the go, and as a result, American Express' survey of small business expectations for the Christmas period has been sharply lowered. American Express in its quarterly Small Business Performance Outlook says that Christmas sales will be sharply down. The 14% ceiling on credit card interest rates has resulted in credit card companies sharply curtailing credit limits and in many instances of cards held by "shaky" customers being called in. My source says the numbers run into hundreds of thousands of recalls.

President Bush in the meantime insists that the nation's economy is basically sound, a view which has hardly any takers. A review of the week November 15th shows that, but for manipulation of the stock market by the Federal Reserve Board, there would have undoubtedly been a repeat of October 27th, 1987 Black Monday. Only shock intervention saved a major collapse of the stock market.

On Friday November 15th, economic events came down to the wire. Based on capital flight from the "dollar safe haven" coupled with disastrous news from the auto and housing industries, and "no show" consumer Christmas spending, leading traders had bolted the market by the close of business. This was pretty much a replay of October 27th, 1987. Wall Street took the largest loss, a drop of 120.3 points, since the 508 point plunge in 1987. It was also the largest single day loss since October 1987.

When news of the disastrous economic data hit, computer-driven institutional selling sent traders

rushing to the floor to sell, sell, sell. This set another record, the fifth largest single day drop in the history of the New York Stock Exchange. A very alarming signal was that selling was all across the board.

The sharp drop took even experienced traders by surprise, coming as it did on the heels of a surprisingly strong bull run. The Dow Jones closed at 2943.20, far below the magical 30-stock posted index of 3500 the Bush Administration has been trying for months to reach. Declining issues outweighed advances 1481 to 302.

Over the counter stocks posted their 4th largest loss ever as biotechnology losses rattled windows up and down Wall Street. Increasing pessimism frightened investors into a stampede as the indicators showed no recovery whatsoever and brokers were forced to admit that the U.S. is nowhere near an economic recovery but is, in fact, headed the opposite way. Several key technical support levels were broken on Friday as investors scrambled to get out in anticipation of another "Black Monday". As usual, it is the small investor who got hurt the most.

Although none of the economic experts talked about the threat of the One World Government's new European Currency Union (the ECU), those big investors in the "safe haven dollar pool" know that with the coming of the Exchange Rate Mechanism (ERM), the dollar will be hard hit. The European Economic Community (EEC) has already made it a firm matter of policy that there will be no junk bond trading or speculative trading in dollars allowed in EEC countries in 1992 and a large number of those who hold floating dollars have also been warned that their activities will be curbed. Unless the U.S. can capture a share of the EEC market, we shall have no ECU's with which to pay our debts.

At stake is a huge market of 350 million people representing a gross domestic product of \$5 trillion. Ever since the Treaty of Rome was signed in 1957, Europe has been

wending its way toward economic integration. As such, it could pose a serious threat to U.S. interests in Europe. The Exchange Rate Mechanism (ERM) obliges EEC member nations to keep their currencies within defined limits of currency fluctuations.

The rush to get out of dollars began shortly after a speech on the subject of ECU was made by Representative Henry Gonzalez. Although there was virtually no one in the House at the time, the warning issued by Gonzalez was heard loud and clear on Wall Street. The EEC has already indicated that the United States will have to pay off its trade imbalance, not in dollars, but in the new One World Government currency. This vital issue was totally ignored by the establishment media.

The sharp drop in home building was totally unexpected. Led by the West, the nation reported a drop in home sales far in excess of the 2.8% predicted by government analysts. The vast Southwest market was the hardest hit with California registering losses of 25.4% (Government figure 16.7%). The White House was expecting home sales to lead the country out of the recession, based upon the July-September quarter. Home sales are a bench-mark of the economy, because it indicates that consumers are, or are not willing to make long-term commitments.

Overall, economic indicators fell even further, the first drop reported by the government in 8 months, thus confirming that the U.S. remains in the grip of a depression. The various changes left the index at 145.4% of its 1982 base of 100. The index has risen only on one occasion during the last six months. In spite of the facts, the President and his cabinet persist in telling us that we are out of the recession and well on the way to recovery. The U.S. trade deficit yawned even wider, with the Commerce Department admitting that November figures will be higher by at least another \$7 billion. It looks like another bad case of "read my lips".

Several subscribers have asked me what causes our trade deficit. The answer is quite simple; we import more than we export, and one of the principal causes of imbalance is imported oil WHICH THE UNITED STATES DOES NOT NEED AS WE HAVE SUFFICIENT DOMESTIC OIL TO MEET ALL OF OUR NEEDS. Other causes of imbalance are IMF looting of natural resources from developing countries, thus making it impossible to continue importing manufactured goods from the U.S. So, in a nutshell, the TOTAL collapse of the world's food and raw materials economy, brought on by the brutal austerity programs the IMF imposes upon Third World and Latin American countries, contributes heavily to our trade deficit.

For example, about one-third of the U.S. trade deficit is attributable to this artificially induced collapse in prices and demand. The economic death of Latin America, which can be laid at the door of Kissinger Associates came about through depressed raw materials prices. Latin America used to be our best export countries. To meet these losses, the Bush Administration is faced with a demand for a sharp recession, which is what we are in right now--although I would rather classify it as a DEPRESSION as a means of addressing our trade imbalance. No one dares to say CUT OIL IMPORTS COMPLETELY BEFORE DOING ANYTHING ELSE.

Medical care costs showed another increase in price for October. As retail sales failed to materialise, clothing and jewelry prices fell almost 0.5%. Auto sales were another disaster. Reflecting the state of the market, auto imports fell by \$300 million in September. In order to make retail sales look a little better, the Department of Commerce excluded autos sales from this category.

Retail sales are a key to economic recovery or recession because they represent 50% of consumer spending which in turn makes up two-thirds of the total economic activity of the nation. Empty shops spell trouble for the Bush Administration and shops in suburban malls are emptier than long-time small business owners can

remember. This would not matter if we were geared to savings and capital fund formation, but we are not.

The new House banking bill has allocated an additional \$70 billion to reimburse the near flat broke FDIC. The \$70 billion will be used to close down failing banks and pay off their depositors, but my economic intelligence source told me that the amount needed is "not \$70 billion, but twice that amount, that is if banks do not continue to fold at the present rate."

In a not-unexpected turn of events, a New York court threw out claims amounting to \$4.5 billion dollars against Michael Miliken. Outstanding law suits against Miliken amounting to another \$1.21 billion are also expected to go out of the window. It appears that Miliken knows too much, and cannot be silenced in the usual way, so he has to be bought off. In another startling development, Miliken has sued his former employer, Drexel Burnham, for back pay amounting to what some insiders say is \$245 million. The betting on Wall Street is that his old bosses will pay up and try to look happy. WHO SAYS CRIME DOES NOT PAY?

Salomon Brothers are not going to be so lucky. A Chicago partnership is suing the prestigious firm for millions of dollars, charging racketeering, and violation of securities and anti-trust laws. The betting is 10-1 that Salomon Brothers will pay up before the case comes to court.

This depression must be seen for what it is, and it will not end with the election of a new President. The 1991 depression is endemic, it simply will not go away. The underlying causes are too deep. The United States is an INDUSTRIAL NATION, not a service based economy. This means we need SAVINGS and CAPITAL FORMATION, not spending. With the success of the NATO-Club of Rome's efforts to destroy our industrial base now beginning to bite, we are a nation on a stormy economic sea without a rudder.

This country was never meant to be anything but a vast industrialised nation. Now we find ourselves having to contract and we simply cannot do it without wholesale destruction of our economy. This is reflected in the large numbers of unemployed. Our situation is like

that of a man trying to squeeze into size 8 shoes when he knows he should be wearing size 10. The way our economy has been forcibly restructured means that, given our large population, there is NEVER going to be enough jobs for everybody who wants to work. Social chaos of an incredible magnitude looms just over horizon.

No matter what the candidates for the White House promise, it will all be just so much empty rhetoric. Given our present sick and ailing industrial base, there is no man alive who can make the slightest difference unless he is willing to buck our secret government and restore America to its former industrial strength, and no man is going to be permitted to do that. Had we followed the American economic system, our birthright, we would not be in this terrible situation.

Witness Japan, a country that rose Phoenix-like from the ashes of Hiroshima and Nagasaki. Today we hurl brickbats at Japan for being so successful, when America could have been ahead of Japan had it not allowed itself to be taken over by the upper-level parallel secret government. In this lie the seeds of the next world war which, as I have stated so many times, will align Japan with Russia and Germany against the United States, China and Britain.

Inflation is supposed to level off in 1992-1993 as government borrowing that decimated the capital market slackens off. But will it? Given the demographics and looking at the vast increases in social programs that have to be funded, it appears that inflation will rise rather than fall to a lower level. All that we are going to achieve is GREATER SPENDING which will come from greater borrowing in a vicious never-ending cycle.

Some economists are pointing to the defense industry as our saviour. We can forget that, as anticipated deep defense spending cuts between now and 1995 begin to materialise. Over the next five years the DoD plans to shed \$50 billion from its budget. This is the FIRST ESTIMATE. My economic intelligence source told me that in reality, the cuts will amount to close to \$130 BILLION! Negotiations are going ahead under tight security.

Whatever the money numbers,

there is the other aspect that thousands of men will be forced onto an almost non-existent job market. The impact this will make has yet to be measured. By 1995 it is estimated that thousands of civilian employees of the military will also have been laid off as budget cuts, said to be in the region of \$10 billion in 1993 are felt.

As our economy falters along, living standards are going to be lowered. Washington does not have the ability to think in terms of new programs, nor does it have the money to finance them, because all we do is spend without any attention to saving. Of course our economic situation would look a whole lot brighter if foreign aid was abandoned and the national debt abolished, two important steps Congress could easily take but is unlikely it will do so.

In 1979 when Ronald Reagan was running for the top job, he regularly assailed the giant federal budget deficit and promised to reduce it. He did not. It was all idle campaign rhetoric. Isn't it true that "empty vessels make the most noise"? Yet the federal budget deficit that George Bush is struggling with is 8 TIMES BIGGER THAN IT WAS WHEN REAGAN WAS ELECTED IN 1980. Cutting taxes or increasing them is not going to solve anything. One thing the Federal Reserve Board has learnt from the 1991 depression is that cutting interest rates isn't going to work, either, when there are no jobs for 30 million people and we have no capital savings formation.

As economic stagnation sets in to a greater degree in the mid 1990's, we are more than likely going to see a battle royal to overturn the Federal Reserve Board. Whether or not such a move will be successful remains very doubtful. We do not have statesmen of the caliber of the late Louis T. MacFadden, and without leadership like MacFadden provided, any revolt against the Federal Reserve Board is likely to die on the vine.

Trying to balance inflation against growth rate and lack of employment is a major stumbling block the Bush Administration is having to contend with. As long as Greenspan and his "lower inflation" advisors insist that inflation must be

cut to 2%, just so long will we have an economy in a deep recession.

What then--cut social programs, which some say are the root cause of inflation? Hardly likely as long as we have politicians and not statesmen at the head of affairs in Washington. The reason so many Congressmen were returned to office in the last mid-term election is because welfare voters perceived them as better the one we know than the one we don't know. At least the welfare population was assured there would be little if any cuts in their welfare programs.

If by some fluke Cuomo makes it to the White House, watch out for fireworks as he pits himself against the Federal Reserve. Cuomo has already told aides that he is willing to accept a 5%-6% rate of inflation in return for full employment. "People can see unemployment; they can't see inflation that clearly," is how one of his advisors put it. Will Cuomo be able to resist the pressures of the secret upper-level parallel government, or succumb to its demands as Bush has, for a no-growth low inflation rate? Watch out for a statement clarifying his position, once Cuomo publicly announces what is already well known.

In any event, higher inflation does not hurt everybody, indeed it helps a lot of people, especially those who have gambled on it. There are going to be howls of rage if the Federal Reserve continues with its low inflation no-growth rate position. The Bush Administration is finding out what a lot of former administrations found out; the Federal Reserve Board rules the roost, not the President. The Bush Administration has endured the lowest growth rate of any post-WWII administration. Bush is doing even worse than Jimmy Carter, if we can imagine that.

Instead of 6% expansion which Bush advisors say is possible in 1992, the Federal Reserve plans to keep the screws tightened and it is highly unlikely that we shall even reach a 2% growth rate. If this turns out to be accurate, and I believe there will be a growth rate of 2.3% maximum for 1992, this will be the worst growth rate since WWII.

While the top economists are

not admitting to a recession, some of the more prestigious staffers at various foundations are saying that we have never emerged from the recession which began in 1984. This is a debt-based economy, the 1980's boom only made matters worse and this is clearly reflected in the federal budget deficit figures. In 1992, the debt is expected to hit \$6 trillion, the first time in our national history that it will be that high.

Never has it been clearer that the best our antiquated economy can offer is a series of boom-bust cycles, based on spend and borrow and as long as we refuse to uproot the underlying causes of this truly ridiculous system, there is no hope for a prosperous America anywhere in the foreseeable future. The only solution the so-called "experts" can offer is **HIGHER TAXES**. Politicians will promise to reduce taxes, but by now even the most naive person knows this is a physical impossibility.

This fits very neatly into what the Malthusians see as good for the United States. First, smaller is better. Industrialisation supports bigger populations, so industry must be closed down and excess surplus populations drastically reduced. This is easier than it sounds when the country has no savings and capital investment formation plans for its citizens. That is the direction in which the United States is heading. We thought such programs could only be imposed upon Third World countries, but we are just now starting to realise that the United States has not escaped the British monarchy's Malthusian ideas.

At present a bankrupt Britain is imposing monarchical policies on about 90 different countries. Of recent date, the Queen of England has become more outspoken in her demands that the excess population be culled faster than AIDS is doing the job. In a speech delivered to the new Communist government of Namibia, the Queen listed excess populations as one of the ills of Africa. She then delivered a gratuitous insult to the sovereign nation of South Africa, before descending upon Harare (Salisbury), the capital city of Rhodesia (now Zimbabwe). The Queen has control of Zimbabwe's deposits of pure chrome ore, the finest in the world.

On the way into Harare from

the airport, the Queen passed vacant land that had been occupied by hundreds of thousands of homeless blacks. Their pitiful shacks were bulldozed a few hours before the Queen's cavalcade passed by on orders of dictator Robert Mugabe who feared the sight of so many of his distressed countrymen might offend her majesty. The Queen dutifully proclaimed herself in favour of "sustained development", which in plain language means that if the economy cannot sustain itself while the IMF is looting its natural resources, then nationalism must give way to the New World Order.

Now this may not seem like it, but it relates directly to economic conditions in the U.S. British banks and particularly the Bank of England dictate Federal Reserve Board policies, that is why this re-

cession is unlike any other post war economic downturn, the British having tightened the screws since January 1987. The lowest level of savings and the devaluation of purchasing power has just about broken the back of Middle Class America, and that is as it should be, according to the Bank of England.

As we enter 1992, America faces economic problems that have never been seen here before. We constantly stress consumer spending as a way out of the recession, and now we find that it isn't going to work any more. What we should have followed is the German and Japanese way of high savings and capital formation for the ordinary everyday men and women. The collapse of our savings which are

Are you a 14th Amendment federal citizen, or are you a Citizen of the several States, as described in the Constitution as it was originally intended by the Founding Fathers? Are you aware that there exists in this Nation two separate and distinct classes of citizenship?

To begin with I must define what the definition that the Original Constitution used when it referred to the "Citizens."

The phrase "Citizen of the United States" had a specific meaning in the Original Constitution for the United States of America (1787), the definition and intent of the Constitution was that it described a

"free born Citizen of the several States." The 14th Amendment added a second (2nd) distinct meaning to this phrase. So now, the phrase "Citizen of the United States" has two separate and distinct meanings which are not compatible with each other and indeed in a later issue will be shown to be at odds with one another. They are:

1. A free born White State Citizen in the several States, is an individual whose inalienable rights are recognized, secured, and protected by the various State Constitutions against State actions and against federal intrusion by the Constitution for the United States of America (1787).

2. The 14th Amendment federal citizen, who is a second class citizen, a juristic person, a citizen of foreign or interstate commerce, one

who has congressionally granted privileges that are almost equal to the White Citizen. I say almost because these privileges are secured against a debt of submission to the morality legislated by Congress (including Income Tax). These individuals are subjects of Congress (alieni juris), under their protection as a "resident" of a State, a person enfranchised to the Federal Government (the incorporated United States defined in Article I, section 8, clause 17.) The individual States may not deny to these persons any federal privileges or immunities that Congress has granted to them. This specific class of citizens is a federal citizen under admiralty (International Law). As such they do not have unalienable common rights recognized, secured and protected in the Constitutions of the States, or of the United States of America (1787), such as allodial rights to property, the right to inheritance, the unalienable rights to work and

contract, the right to travel, life, liberty and happiness among many others.

Thus the federal citizen is a taxable entity such as any other corporation, and is subject to pay an excise tax for the privileges that Congress has granted them.

The White De Jure Citizen is a State Citizen by birth and race (the Common Law) first, then as a consequence of his State Citizenship, he is a "Citizen of the United States of America" second. He owes his allegiance to his State of Domicile first, and then to the Union of the several States.

The 14th Amendment citizen is a de facto citizen, a "citizen of the United States" (corporate citizen of the District of Columbia, its territo-

now at the lowest ebb in our history comes as a direct result of government spending resulting in huge federal budget deficits. Our nation was weaned away from saving and investing in capital projects to borrowing and spending on a variety of non-capital projects of little long-term benefit.

What I am suggesting is that because we do not teach TRUE ECONOMICS in this country, much less practice it, those forces that are depressing the economy are now out of the control of the U.S. They are in the hands of the international banksters. The enemy of a sound economy has always been, and will always be budget deficits, trade deficits, lack of savings, lack of investment in capital projects, over-consumption and collapsing asset price inflation.

Capital growth for the manufacturing sector has dropped an amazing 28% in recent years, mostly because we have allowed British policies of zero-growth in a post industrial society to take hold of our economy. Reagan's voodoo economics of the 1980's has destroyed our standard of living and brought on a blindness never before experienced among our economists. At the end of 1989, the National Association of Business Economists reported that 62% of its members

did not foresee a recession. This will give you some idea of what I mean.

The reason why these economists were so complacent is quite easy to explain. Almost to a man they believed that it is impossible to have a recession when business inventories are low, inflation is in the 2%-3% range and the Federal Reserve cuts the interest rate; in short, conditions which exist in our economy today. In the past this was bolstered by a massive inflow of "safe haven dollars" which enabled the country to overspend with imported goods keeping inflation down. Well, they were all wrong, as we now see. Although not perceived by many economists, as we leave 1991, the U.S. is about to enter its longest unbroken recession/depression since the post-Wall Street Crash. In my opinion it is going to last until at least 1995 or even 1997.

ries, and federal enclaves per Article I, section 8, clause 17) first, as a consequence of this citizenship, he is allowed to be a resident within the several States. For this and other privileges he owes his allegiance to the United States (corporation per Article I, section 8, clause 17) first, then to the State of his residence.

Note that "Domicile" and "residence" are not synonymous. See Black's Law Dictionary, 5th Ed.

The Internal Revenue Code's definition of the term "citizen" is identical to the wording of the 14th Amendment, and can only apply to the subjects of Congress. The Social Security Number (SSN), a badge of slavery, is the main registration number of the de facto 14th Amendment citizen, so Congress can tax their subjects (slaves) wherever they are resident.

NOW, which citizen are YOU? a White State Citizen or a de facto resident? You must decide - this is a personal decision - and notify the appropriate government officials of

your status with respect to them. Be prepared though--the United States (District of Columbia) does not want their slaves to escape. If they did, the profit of the Federal Reserve would dry up and you might lead the Exodus out of Egypt.
