On trumped-up charges, the King used to order the arrest of legislators who opposed his policies. - \* 1789: concerning the ratio of members in the House of Representatives.
- 1789: concerning compensation to members of Congress.
- \* 1810: concerning the abrogation of citizenship for accepting gifts or titles of nobility from a foreign power without the consent of Congress. It missed adoption by only one state.
- \* 1861: concerning non-Congressional interference in slavery. Offered to head off the Civil War, it was adopted by only two states. It was the first proposed amendment signed by a President (Buchanan) before distribution to the states. (Just before he was murdered, President Lincoln signed the proposed
- \* 1924: concerning the labor of persons religious groups.
- 1972: concerning equality of rights regardless of gender. E.R.A. fell three states short of adoption.
- \* 1978: concerning representation of the District of Columbia in the House and Senate. D.C. has a population larger than do four of the states. This one will continue to come up.
