## SWISS BANK LOSSES GROW AS FOREIGN FUNDS DRY UP

From *THE STRATEGY* (an Australian newspaper), June 1997, [quoting:]

When, in 1992 it was plain that financial madness was going to overtake the world, the "developed" world chose to ignore it. And now, there it is, particularly in Europe—real estate prices collapsed, 20% currency devaluation, stock market crashes, and now the latest, something not even dreamt possible. There are those who believe it to be a "scam"—it is well known that the Swiss have 50% to 60% of all gold bullion in the world stored in their mountain vaults. But for what it is worth here is the item out of 8-160597 BUSINESS BRIEFS:

### SWISS BANK LOSSES...

Swiss banks lost more than 42 billion Swiss francs (about US\$30 billion, Aus\$40 billion) during 1991-96, according to an official report released in late April by the Swiss Banking Commission. Most of the losses came in Swiss real estate since the mid-1980s speculative bubble burst in 1991. The Commission noted that despite such huge losses, at no time was the Swiss National Bank called upon to bail out a bank.

In separate reports from other European bankers, however, it is reported that in the past three to four months, since the escalation of the call for restitution by Union Bank of Switzerland and other Swiss banks for alleged Nazi gold dealings, that the banks have suffered a dramatic fall in cash inflows from abroad, as concern of possible disclosures in bank secrecy could come as a result of the pressure for disclosures on gold accounts. If these reports are accurate, the Swiss banks could be in a situation similar to the French bank *Crédit Lyonnais*, which has been given a series of bail-outs to keep it afloat. (End of item).

It was reasoned from other news reports that "it was doubtful that Switzerland would continue to be a haven". "Business Briefs" is part of a publication of one of the world's premier private intelligence services, available to the public (sufficiently perceptive of the need for such intelligence in the first place). Most people caught in the [controlled] media web, are having their heads filled with garbage.

The game now is perhaps worse than it ever was. The media instill fears and conflict in people and the end result is "infantile mental paralysis". It has been achieved gradually and very deliberately.

Interest hikes of the 1980s causing massive de-industrialisation and unemployment, Balkan and Gulf Wars, Maastricht Economic Contraction of the 1990s, all producing destabilisation and panic. As Pavlov found with his conditioned dogs, it tends to clear people's minds of their moral and ethical values. With each of the "critical shocks", rock & roll, sex, sensational reportage of violence, and drugs was "administered" as a "tranquilliser" and "conditioner" in

increasing dosages. An "infantile mentality of callous indifference" has been superimposed in the majority of people's minds. They have little interest to fight against injustice for others, preferring to immerse themselves in the "virtual reality" provided by the mainstream media. When it happens to themselves they are alone and give in with a "What can I do!" The "viewing public" is so attached to TV, that it is to them what a dummy is to the baby, and in a significant proportion, TV addiction is as strong as drug addiction. And yet without it they would not miss a thing, indeed they would be able to notice a lot more. For instance, that the Model Criminal Code Officers Committee propose to lower the age of consent to the age of 10!

While the media represent a powerful instrument for dangerous forms of mental conditioning, in Germany, France, Belgium, Italy, and Greece, gigantic demonstrations are showing that some of this mental conditioning has failed. It cannot be hidden any longer that there are 20,000,000 unemployed in the West, 21,000,000 in the East plus 20,000,000 dead. Maastricht and IMF conditionalities are being seen as causing needless agony and slaughter. An Italian researcher, Prof Guarini, dean of the Statistics Department of Rome University found that unemployment is more than likely higher by 40%. Presumably increased death rates, caused by economic contraction, have also been "massaged".

With Swiss banks on a knife edge, and its bank secrecy being eroded, things are indeed very tough. Are the Caymans and Bahamas to be the last outposts of bank secrecy? But with the looming crisis, any transfer to those banks is like a pact with the devil.

Who would have thought that Swiss banks, of ALL banks, could ever be in trouble! Things must be really bad. Maybe the Bank of China under the watchful eye of China's economics "czar" Zhu Rongji, is the "only safe bank in the world"?

The point is, that with US\$100 trillion in worthless speculative paper (derivatives) feeding on the economies and national banks of nations, to sell anything: houses, land, whatever... without writing the contract in gold or silver, exposes the seller to the danger of monetary collapse. ## CIA UNVEILS NEW GHETTO DRUGS

Langley, VA—After months of eager anticipation within the nation's ghetto communities, the Central Intelligence Agency unveiled its 1998 line of addictive drugs Monday.

"The wait is over," CIA Director John Deutch said at the festive drug launch, simulcast on giant-screen TVs throughout Watts, Cabrini Green, Newark and other urban areas. "Inner-city Americans now have four exciting new ways to narcotize themselves, with the quality of product and wide distribution they've come to expect from the CIA."

Reaction to the new drugs was overwhelmingly positive. "They had a tough act to follow after crack," said New York-area Mafia boss Alfonse DiBiasi, Deutch's close friend and former college roommate. "But this new stuff is just as cheap and every bit as addictive. We're all very excited."

President Clinton praised the CIA as well. "This is a win-win situation for all Americans," he said. "Inner-city Americans will receive the powerful drugs they love and the CIA will raise the funds they can't get from Congress to get their Jonestown mind-control experiment up and running again."

The new drugs are supported by months of CIA testing to ensure maximum potency and addictiveness. Focus groups, consisting primarily of homeless men and street orphans culled from ghettos around the country were housed in an underground research facility beneath CIA headquarters in Langley, VA. Only after six months of exhaustive experimentation on members of this target demograph, who sampled hundreds of drugs, were the final decisions made.

"Everybody loves me because I am so beautiful. Anything is possible. I am going to live a very long and happy life," said Oakland, CA, native Charles

Simmons, who spent 10 weeks testing Blue Glass, the CIA's new smokeable euphoric drug. Simmons then leapt out a window to his death.

"I think I drugs these are very feel good right," said Dwayne Woodson of Bronx, NY, another CIA test participant. "Pork chops three for \$2.99."

CIA officials said that testing is necessary in order to avoid releasing potentially dangerous substances into the ghettos. "One initially promising drug was later discontinued due to undesirable side effects, such as increased intelligence and feelings of love for others," said Dr. Harold Vandermeer, head of the CIA's narcotics development team.

Initial product rollout began this week in the ghetto neighborhoods of Los Angeles, Detroit and New Orleans, with all residents receiving a special drug-sampler pack in the mail, including a full-color, English-Spanish promotional pamphlet and instructional videotape. If the market response is as favorable as the CIA expects, the drugs should be available in every ghetto in the nation as soon as August 1.

"I thought I'd never say this," Deutch said, "but put down that crack pipe, ghetto-dwellers: You're going to love these new drugs."

Deutch went on to state that none of the above events "ever happened" and categorically denied any CIA connection with the new drugs.

The latest who-is-a-Jew controversy threatens to tear apart Israel's relations with its most important supporters abroad. It has become as severe a crisis for Mr. Netanyahu as his diplomatic problems with the Palestinians.

Those who are converted by Reform and Conservative rabbis, who represent the overwhelming majority of American Jews, would not be given Jewish identity cards. In a country where Orthodox rabbis control personal law, such converts already face immense troubles marrying Jews in Israel or even being buried in a Jewish cemetery.

Sunday he met leaders of the Reform and Conservative movements who arrived in Jerusalem warning him of a huge rift opening between Israel and the diaspora if the conversion bill is passed.

Hours earlier, Israel's Supreme Court turned down a petition to prosecute Mr. Netanyahu over his rule in the failed appointment of a new attorney general earlier this year but declined to describe its action as complete exoneration.

Israeli officials in Washington have been sending home anguished messages describing how wealthy Jews are cutting off the flow of donations to Israel in anger. Even AIPAC, the powerful pro-Israeli lobby, is being starved of funds. [End quoting]

### PLEADING FOR A REDIAL

### WIRELESS TELEPHONE FIRMS ARE TELLING THE F.C.C. THEY BID SOME WRONG NUMBERS.

Suppose you got a letter from Christie's auction house inviting you to bid on a Van Gogh painting. To encourage broader ownership of rare art, the super-wealthy would be barred from the bidding. And to sweeten the deal, Christie's would let winners pay by installment at low interest rates.

You go to New York and bid, but prices are sky-high and you go home empty-handed. Months later you learn the winning bidder can't pay what he promised and wants the auctioneer to accept 25 cents on the dollar.

Christie's would never run an auction this way, people there say, nor would it entertain such pleas from the winning bidders. But, strange as it seems, the scenario sums up what's facing the Federal Communications Commission, the government's biggest auction house.

Dozens of entrepreneurial companies that one year ago collectively bid \$10.2 billion for licenses to provide wireless telephone services, and won, now are seeking a government bailout in the form of delayed payments or forgiveness of part of the debt.

Many of the companies say they face bankruptcy because the market for digital pocket phones is too glutted with competitors and banks won't lend them the money to pay for their licenses or build their networks.

The outcome also will have major budgetary impact because the government has been counting on the money to reduce the federal deficit. Any shortfall to the U.S. Treasury will have to be made up from somewhere else.

And lawmakers already are ignoring signs of a

flooded market for communications licenses by formally projecting in budget documents that future auctions will raise another \$20 billion over the next five years. "This speaks volumes about how we shouldn't look at spectrum auctions as a bottomless piggy bank," says Republican Rep. W.J. "Billy" Tauzin of Louisiana, chairman of the House Commerce telecommunications subcommittee.

Critics say the F.C.C. shouldn't violate the golden rule of auctions: After the auctioneer shouts "sold!" and bangs down the gavel, the winner must pay up. Any decision to give some relief would permanently damage what generally has been a successful auction program at the F.C.C., they say.

"A bailout is absolutely the wrong thing to do," says Daniel Akerson, Chief Executive of wireless carrier Nextel Communications Inc. in McLean, Va. "The whole concept of auctioning licenses would go down the toilet. Anybody that bids from now on would say [after they win], I'm not paying that much. Why should I pay top dollar?"

For now, the F.C.C. isn't saying which direction it's headed. "Our guiding principle is that we want these people out there in the market as soon as possible, because competition is good for the consumer," says a spokesman for F.C.C. Chairman Reed Hundt.

**THE TALE BEGINS IN 1994**, When the F.C.C. decided to put on the block 493 licenses to provide new digital pocket telephone services.

This auction was special: It was supposed to carry out Congress's mandate to give entrepreneurs with few resources a chance to compete against the telecom giants in providing cellular phone service. Most bidders qualified for 25 percent discounts off their winning bids and also were promised six years of interest-only payments at low rates before paying off the principal on their debt.

After numerous delays, the auctions finally got underway in December 1995. Five months and 184 rounds of vigorous bidding later, the auction closed at prices far beyond what most analysts said the licenses were worth.

And though the winners technically qualified as small businesses, the top five were flush with money commitments from such wealthy backers as Sony Corp. and East Asian banks. These five accounted for 80 percent of the \$10.2 billion pledged.

The winners bid an average of \$40 per potential customer for their licenses—several times more than the \$10 to \$15 paid by established players in the industry in a different auction less than a year earlier.

**WHY SO MUCH?** Bidders say being able to pay in installments encouraged them to raise their bids 20 percent to 40 percent. They also were

encouraged by the excellent stock performance, at the time, of Omnipoint Corp. of Arlington, Va., one of the few small wireless service providers whose shares were traded publicly.

The bidders and their bankers also widely believed the value of radio spectrum would only rise in the future.

But they were wrong. Between May 1996 and May 1997, the four publicly traded small wireless stocks, including Omnipoint, lost 71 percent of their value. All of a sudden, friendly bankers turned cold, telling the license holders they had paid too much. Equipment makers also backed away from agreements to help finance building networks for the winners.

"At the current levels of debt that they owe the government, the financial markets are closed to them," says John Bensche, vice president and senior wireless analyst for the Lehman Brothers Inc. securities firm in New York.

The second-highest bidder, Pocket Communications Inc. of Washington, D.C., filed for bankruptcy reorganization in late March. At the same time the F.C.C. lifted its requirement that license holders meet their first interest payments.

Now NextWave Telecom Inc., the biggest license winner by far, having promised to pay \$4.2 billion for 63 licenses, is leading the effort to persuade the F.C.C. to restructure the debts owed by the winners.

Since the downturn in the market, NextWave has laid off hundreds of employees, delayed construction of its network and canceled planned debt and equity offerings. "This market is dead in the water," says NextWave Vice Chairman Janice Obuchowski.

F.C.C. officials say license owners and bankers are hyping the severity of the problem to extract the best deal possible from the agency. "Every licensee, when they smell a restructuring, has an incentive to paint as dire a picture as possible," one staffer laments. "It's not as bad as many make it seem."

There are a range of options before the agency:

- It could do nothing, which probably would lead to massive defaults of licenses and put them up for auction again. The problem is, companies could file for bankruptcy protection, which would tie up licenses in court.

- It could grant a longer period to pay. NextWave proposes eight years of no payments at all, with accrued interest due annually after that until 20 years later, when all the principal would be due. MCI Communications Corp., which hopes to market NextWave service under the MCI brand, is making a similar proposal.

- It could grant "amnesty" to license holders, allowing them to turn in all or portions of their licenses, lose their down payments and face no further default penalties.

- It could allow licenses to be paid for immediately, but at a deep discount. This approach is favored by lenders and many license holders, led by General Wireless Inc., which bid \$1.1 billion for its licenses.

Such drastic action, they argue, is the only way the F.C.C. can ensure its goal of helping small businesses into the market.

"I don't see any alternative in which the government is likely to recover anywhere close to \$10 billion," says Gregg Johnson, president of BIA Capital Corp. of Chantilly, Va.

For the license winners to remain viable in business, he says, their debt "needs to get down to close to 25 cents on the dollar."

Any of those options are certain to produce time-consuming lawsuits. And while the status quo is "still an option", an F.C.C. source says, allowing license owners to default and then repossessing and re-auctioning their licenses would delay the arrival of new competitors into the market. [End quoting]

It appears to be another big government scam—with big business—to sucker in the little guys, and then pull the rug out from under them by market manipulations—then buying them out or bankrupting them, and getting the properties at pennies on the dollar!


[Comment by Margaret:] When I looked at this picture [see below] it seemed to be upside down, so I turned it around [upside down].

# Beware The Pitfalls Of Flying Without Identification

**MAY, 1997 "BETSY ROSS"**

In the last two years, everyone flying on a commercial airline has stepped up to an airline's ticket counter and heard the agent recite a familiar litany. The monologue goes, "Has your bag been unattended; have you accepted gifts from a stranger; can I see your identification, please?" The traveler docilely murmurs answers, and produces a driver's license or some equivalent.

As a die-hard Constitutionalist, I believe that we still have an absolute, unfettered, God-given right to travel from point A to point B—in the air, as well as on land, without permission from the state. This Nazi procedure of "Your papers, please" has never been appropriate for our country.

I have had occasion to travel a good deal in the last several months, and on those trips I decided to research and test this issue about the necessity for producing identification. I have talked with agents, and their supervisors, of several major airlines in cities across America, and have gradually pieced together a rather complete picture of the real legal situation regarding our right to travel.

As a preliminary maneuver, I performed numerous word searches of the US Codes and regulations posted on the Internet, and determined that there are NO federal regulations, or even statutes, mandating the production of a state-issued ID card to board an airplane. Indeed, I could find no regulations requiring the production of ANY identification as a prerequisite for travel by air.

Next, I tested this finding with several airlines. When asked for identification, I produced only my Sam's Club card, or my travel agent's ID card, or a Costco card. These are all picture IDs, but they are privately issued, and do not have my signature on them.

The airline agents just freaked out, and demanded to see some state-issued ID. They routinely told me that "IT WAS FEDERAL LAW!" The government absolutely required me to cough up an "official" ID card, without which the agent couldn't even THINK of letting me on the plane. I politely explained that it was not possible to pro-

duce any other identification, and that maybe it wasn't really necessary, after all.

I told the agents that my word searches had failed to turn up any federal regulation mandating that type of identification, and then asked them to cure my ignorance and please cite the regulation. Now, at this point, individual airline agents have reacted differently. Some called in their supervisor. Alaska Air employees were consistently the most gracious; Northwest agents were the worst—they were rude, belligerent and hostile brats. But they all folded, every time.

A particularly nasty Northwest employee marched me all the way back to the electronic detection equipment, made me pass through it a second time, and had the guard thoroughly search my carry-on bag. The same agent actually made rude and demeaning remarks to me as we trudged back to the counter—and then she let me on the plane.

Alaska Air was much more reasonable—the agent just issued my seat pass, and commented that some people seem tenaciously to hold the thought that they have the right to travel without producing government ID—to which I responded, "Yes, amazing, isn't it—and I'm one of them."

In Seattle, an agent said, AS HE HANDED ME MY TICKET, "You know, if you don't show me any government-issued ID, I can't let you board the plane." I replied, "Yes, I understand. But I didn't, and you are." With a smile, he just said, "Have a nice trip." So I have flown several times using only my meager privately issued picture ID cards.

Every time I used this strategy, I noticed that the agent put an orange sticker on my checked bags, and also on my seat pass on the ticket. Several agents divulged that this is the policy they are supposed to follow when a person does not show government ID. The bags simply wait in the baggage room until the person presents the matching seat pass as he/she actually boards the plane; then the bags go on board.

On my next trip, I decided to push the envelope even further. When the Alaska Air agent made the usual perfunctory request for identification, I put on my best face, smiled sweetly, and said, "Gee, I'm so sorry, but I just don't have any ID I could show you."

To my speechless astonishment, the agent just said, "No problem—just fill out this simple form, and present it to the counter at the airplane gate." I watched as the familiar orange sticker again went on my bag. I repeated the same scenario with Horizon Air on another trip. I have now flown three

times without producing any identification whatsoever.

Northwest was actually instrumental in advancing my education about this issue. I was so aggravated by the insolent and hostile treatment that their employee gave me (hopefully, former employee, after the letter I sent to the company president), that I demanded to see a supervisor on the spot.

I then insisted that he produce the relevant federal regulations RIGHT NOW, or face personal liability for authorizing an unreasonable search and seizure, dereliction of duty, fraud, conspiracy, civil rights deprivation and any other legal buzz words I could think of at that moment which would justify a lawsuit against him personally, as well as his employer.

Like everyone else, he couldn't show me any statute or regulations. He even admitted that there are none. However, he did produce a copy of Security Directive 96-05, which the Federal Aviation Agency issued to all airlines in August of 1996.

Its wording is very instructive; it reads as follows:

**"1. IDENTIFY THE PASSENGER.**

**ALL PASSENGERS WHO APPEAR TO BE 18 YEARS OF AGE WILL PRESENT A GOVERNMENT-ISSUED PICTURE ID, OR TWO OTHER FORMS OF ID, AT LEAST ONE OF WHICH MUST BE ISSUED BY A GOVERNMENT AUTHORITY.**

**B. THE AGENT MUST RECONCILE THE NAME ON THE ID AND THE NAME ON THE TICKET—EXCEPT AS NOTED BELOW.**

**C. IF THE PASSENGER CANNOT PRODUCE IDENTIFICATION, OR IT CANNOT BE RECONCILED TO MATCH THE TICKET, THE PASSENGER BECOMES A "SELECTEE". CLEAR ALL OF THEIR LUGGAGE AS NOTED IN SECTION 6, BELOW.**

[no letter] **CLEAR SELECTEE'S CHECKED AND CARRY-ON LUGGAGE, AND SUSPICIOUS ARTICLES DISCOVERED BY THE QUESTIONS ASKED:**

**A. IF THE SELECTEE IS ON A FLIGHT WITHIN THE 48 CONTINENTAL US STATES, OR TO MEXICO, OR TO CANADA, ITEMS CAN BE CLEARED BY EITHER OF THE FOLLOWING METHODS:**

**1. EMPTY THE LUGGAGE OR ITEM AND PHYSICALLY SEARCH ITS CONTENTS BY A QUALIFIED SCREENER, [remember the actions taken by Northwest] OR;**

**2. BAGMATCH—ENSURE THE BAG IS NOT TRANSPORTED ON THE AIRCRAFT IF THE PASSENGER DOES NOT BOARD. [Remember all those orange stickers.]**

**B. IF THE SELECTEE IS ON AN INTERNATIONAL FLIGHT...CHECKED LUGGAGE, CARRY-ON LUGGAGE, AND SUSPECT ITEMS CAN BE CLEARED ONLY BY THE FOLLOWING METHOD: EMPTY THE LUGGAGE OR ITEM AND PHYSICALLY SEARCH ITS CONTENTS BY QUALIFIED SCREENERS.**

This document apparently goes on for ten more pages; the Northwest supervisor gave me only the first page, which contains the information printed above. The next time I refused to produce ID and the agent freaked, I told her, "Just tap up SecDec 96-05 on your computer, and go to Paragraph 1, Section C. Designate me as a 'selectee', and proceed accordingly."

She apparently thought I was an FAA undercover employee, because she said that she was "tired

of you federal guys coming around" and literally spying on airline agents, "coercing us into lying to people, and essentially being the 'bag man' for an activity which has no legal requirement." I told her that I could not agree more.

Another airline employee later confirmed that FAA agents often engage in such entrapment activities, to make sure that airline agents parrot the government party line about state-issued ID.

I also hit pay dirt in a discussion with another, much nicer Northwest agent on the East Coast. In a candid conversation, he told me that FAA personnel had held training sessions with all airline agents in the fall of 1996. Agents were informed directly by the FAA that they absolutely could not bar an American citizen from boarding a plane, even if a passenger refused to produce any identification at all!

Apparently, however, the FAA has developed a racist-based "profile" which agents also have to follow. If someone has no ID or ID which is not state-issued, the agent can keep a person off the plane—if the would-be passenger fits the FAA "profile". If a person has a swarthy appearance, speaks English with an accent, and/or appears to be of Middle Eastern origin, "especially Syrian or Iranian or Iraqi," the agent can deny boarding, even if the person claims to be a U.S. citizen.

I definitely saw this policy in action in Florida, where most of the population is swarthy and speaks English with an accent. Mid-Eastern or Mexican, I suppose all foreigners look alike to Miami airline personnel. The FAA seems to have forgotten that White folk have at times also participated in terrorist actions.

Yet another agent in the Midwest admitted that airline personnel were deliberately and knowingly coercing people into showing government ID by saying "it's the law". According to him, the reality is that the companies are simply tired of people selling their free frequent-flyer tickets.

The airlines wanted to stem this practice by checking everyone's ID, but knew there would be BIG problems if they instituted this procedure as a private corporate policy. It was ever so much more convenient to simply say that it was federal law, and make the government the scapegoat.

But then I had the misfortune to fly Delta, the airline from hell. Delta supervisors didn't bother with the usual fabrications and disclaimers. They told me quite candidly that they had a private corporate policy, independent of any governmental decrees, that they would allow no one, repeat NO ONE, to fly on their precious airline without government ID. No one, ever, zero, nada, no way, not possible, don't even try, NO exceptions, canNOT happen, FORGET IT! To make matters even worse, Delta and I were stuck with each other for seven flights in various cities across America.

But I had flown the first portion of this trip on ever-gracious Alaska Air, without producing any ID whatsoever, so I had been spoiled. Delta was my carrier for the subsequent portions of my long trip. Therefore, this company would leave me stranded mid-excursion if they did not make an exception to their engraved-in-stone, hard-and-fast, absolutely-no-changes policy.

They dug their heels in; I dug mine in even harder. Did they have any comprehension of the anguish, the extraordinary emotional distress, to say nothing of the economic loss, AND-THE DAMAGES (both punitive and exemplary) which their unreasonable, discriminatory, arbitrary and capricious policy would cause me? In each city, I gave this speech to the counter agent, and then to the

agent's supervisor, and then to the supervisor's supervisor, and then to someone they had to call on the phone at the company's central office in another state.

At every level, I demanded the person's full name and Social Security number, and threatened to sue them in their personal capacity. "I will own your pension," was the way I explained the extent of their liability. I told the higher-ups that they were also in violation of their corporate charter, and demanded to know the name and address of their surety bond holder, for the lien I intended to file. I let them know that I would consider myself to be damaged in an amount equal to the assets of their corporation.

There is no end of catchy legal phrases like these, which tend to make corporate managers rethink their "no-exception" policies. In the end, we compromised—I showed them my private ID, along with an organ donor card which I have carried around for 17 years. They saved face by saying that the organ donor card "looked sufficiently official" to pass for a state-issued ID (which of course it isn't—and they clearly knew that).

Delta agents and I repeated variations of this scenario in all seven cities. It became quite an interesting game of strategy and bluff. Actually, on the return legs, my reputation must have preceded me. Some corporate officer had the foresight to log remarks into Delta's computer to the effect that agents should just ask for my organ donor card, and let it go at that.

Supervisors consistently told me in no uncertain terms that: (A) if I had flown their airline starting in my home city, instead of mid-trip; and/or (B) had refused to produce any ID at all (even though I didn't fit the FAA "profile"), then they would have bounced me right off their airplane. In that case, I could just stick it where the Sun doesn't shine, and go ahead and sue them. That is why I consider this corporation [Delta] to be the airline from hell.

However, even these protracted and aggravating encounters increased my knowledge base. Delta agents told me that passports are welcome as ID, as are Social Security cards, (for those of us who still have such pieces of paper). Some other airlines will accept personal Affidavits of Identity, as long as they are officially notarized. A thumbprint alone just will not do.

Delta agents asked anxiously if I could even just produce a library card, or a car insurance card, and they would accept that. Now, I still have all that stuff, mind you; I just didn't feel like showing it to them as a prerequisite

to getting on their idiot airplane.

I understand that Delta Airline is, or soon will be, facing two large lawsuits because employees twice have actually denied boarding to a passenger who had only private ID to show. One instance involved a man who is prominent speaker for one of the most brash, aggressive, in-your-face guerrilla pro se litigation organizations in America. Talk about a disastrous corporate policy! Anyone want to own an airline, courtesy of a judge's court order?





The take-home message is to call airlines before securing tickets, to see the extent to which a flier will help or hinder you in exercising your right to travel. Be persistent; talk to a supervisor. Many front-line agents I encountered were without a clue about the real legal situation, but the supervisors ALL knew the contents of Security Directive 96-05, just as they ALL knew that there are no FAA regs mandating government-issued ID.

A TWA supervisor, after repeated questioning, finally said, "No ID? None at all? No problem—come fly with us." American Airlines personnel, on the other hand, indicated that their airline had a private corporate policy which was just as harsh and unyielding as Delta's. Pick your carrier carefully, and remember the power of a letter to the CEO explaining why you are, or are not, using the services of a particular airline.

In summary, this identification policy meets the airlines' private financial goals, and also our government's goal of ever-increasing social control. Each for their own reasons, the airlines and government are colluding to foist a fraudulent scheme on the people. If no one complains or asserts their rights regarding travel, then another freedom is, "poof", gone.

Our children watch this happen, and grow up thinking that "the state" has both the right to define our identity by issuing documents saying who we are, and also the right to require us to produce them on demand.

### LEADED VERSUS UN-LEADED

There was a book written years ago called *The Simean Factor*. It was about the relapsing of man to his primate status. Though I am personally not descended from primates, I am beginning to believe that most government officials are.

I have been asked by a few members of our club about the situation with unleaded petrol and our cars. With the pre-alloy-headed car the octane is low enough so the only modification needed would be to have hardened valve seats fitted into your iron head and away you go. HOWEVER, and this applies to all pre-unleaded cars, because you have not had a dry catalytic converter fitted to your car, the exhaust gasses from your car will be unbelievably poisonous. Let me explain.

#### FIRSTLY, LEAD IN PETROL

Lead is there to enable [use of] higher octane petrol, so that we can have more efficient engines. Lead, when burnt in the engine, is subjected to 2000-to-3000 degrees and is actually baked like a house brick, and when the particles are emitted from the exhaust they fall to the ground within ten-to-twelve feet (heavier than air). The baked particles have been tested with various acids, and particularly stomach acid, and they have no dissolving effects on the baked lead. Also, it cannot be absorbed into the lungs, unlike lead dust. Lead dust does not come from car exhausts. I cannot find blood-lead levels earlier than 1933 but the graphs from then till 1985 show a steady decline, yet lead began to be added to petrol in 1925 and peaked in 1970. You would have thought that lead levels in the blood would have risen in proportion but they did not even hiccup on the graph. When Germany reduced lead in their petrol again there was no reaction in the lead level in blood samples taken. Tests done on a little island off the coast of Scotland, without a single combustion engine, show a much higher lead level in the population than in tests taken in the centre of London. Much the same results were found when New Guinea Highlanders were compared to people in Melbourne. The actual decrease in lead levels has been traced to the reduced use of pewter (a lead based alloy), the gradual reduction of lead solder in our cans of processed food and replacement of lead water pipes that contain our drinking water. By the way, Asian-source canned foods still use lead solder in a number of their products and there are still plenty of lead pipes around. Where are the Greenies?

Lead was removed from petrol for one reason, and one reason only, and that was that dry catalytic converters became clogged very quickly with lead particles and stopped working. Unfortunately the Green Movement (which then was badly informed), enthusiastically latched on to the lead removal and, ignoring

the real reason for its removal, mounted a false emotional campaign for which we are still suffering as more members join and do not investigate what they are screaming for.

Unleaded petrol is a different kettle-of-fish and is much more dangerous, as I will proceed to prove.

More than half a litre of unleaded petrol [sic]. It is actually a brew of aromatics and, if witches had brewed this cauldron it could not be more evil. Note that I have said not, not might. I will quote from one authority, Dr. Warren, who was the advisor to the Government at the time and warned against unleaded and was ignored.

"In fact this stuff appears to be so dangerous, potentially lethal, that I urge you not to use it in any car not fitted with a catalytic converter, don't use it in your mower, chainsaw, whipper snipper, or outboard motor, and don't wash parts in it and if any gets on your skin wash it off immediately. Avoid the fumes when refuelling and don't allow anyone near the exhaust, particularly when the exhaust system is cold. Remember that catalytic converters don't work until they reach some 400 degrees."

Professor Maltoni and Morando Soffritti of the Institute of Oncology at Bologna found that exposure to certain fuel additives such as Benzene, Toluene and Xylene caused cancerous tumours when ingested or inhaled. Benzene, in particular, was named a powerful carcinogen that acts on many tissues and organs. The data leaves no room for doubt that additives are thoroughgoing, highly potent carcinogens.

Roger Perry, a professor of environmental control at London's Imperial College, has conducted tests that show that unleaded petrol used in cars without a catalytic converters produce a great quantity of volatile organic compounds that can be directly linked to cancer. Recently in Britain the National Society for Clean Air has removed all support for ULP [unleaded petrol].

It now turns out, in information from America, that the average car fitted with antipollution gear (both American and imports) is only clean for approximately a year. After that the gear deteriorates rapidly unless completely renewed. Even a single backfire while a mechanic is tuning the car will destroy the catalytic converter. The average lifespan of a "cat." is about 50,000 kilometres. After that it needs replacing. A Holden cat. is close to a thousand dollars and a Ford costs about two-hundred-and-fifty dollars.

ULP actually costs more to make, so the cost to the country is greater and it uses more oil and creates more pollution because they have to make the aromatics as well. Now another area of pollution is acid rain. It comes from two different sources. One is sulphur dioxide (FROM COAL POWER STATIONS) and the other is hydrogen sulfide. Hydrogen sulfide is that rotten-egg gas smell you get from (yes you guessed it) ULP vehicles. Even when you cannot smell it, it is still there. They had acid rain in Germany for a long

time but since the coming of ULP it has reached the stage of the top half of the famous Black Forest now being a dead brown.

Believe me the authorities will use every trick in the book and last year was a good example when two graphs were overlaid and used as evidence in the Lead Roundtable. The lead-level-in-blood graph that has been in a steady decline since the thirties, unaffected by the increase of lead in petrol, was carefully doctored to show a four-year period from 1976 to 1980. So naturally it shows a decline and when the lead usage in petrol was laid over the graph it looked like the reduction in lead in petrol was the reason for the decline. That is really a dirty use of figures.

I cannot understand the authorities. The relevant Federal Minister last year who pushed for banning lead has children and the members of parliament who voted for it must have children and grandchildren. They themselves are breathing the same air as the rest of us. Don't they care or don't they know? Think of a [fuel] dump attendant (not many of them these days, I know) but all day they are breathing the vapours. What about the petrol-tanker driver who fills the underground tanks? He must cop a hell of a dose. He could make a big compensation claim but it is not worth the pain and suffering. I have just today read that in Sweden they have found unexpectedly high levels of leukaemia in petrol-station workers. And us, we are being told yes, yes, yes you can put it in your pre-1986 car. It won't hurt your car. The lack of lead will cause your [cylinder] bores to wear out quicker and unless you have hardened valve seats your valves will slowly settle into your [cylinder] head. Oh by the way, the valve seats in your beaut modern tin box are not always the hardened variety either. But it does not matter with them because you have a use-by date stamped on your modern tin box. You won't find it. It is carefully hidden, but it is there—about fours years after you bought it.

What do we do? First fill your own two-stroke container with lead petrol and add oil. Service stations have been caught using unleaded in their take-away two-stroke containers. When you fill your outboard tank, fourstroke mower, or anything else you have that has not got a "cat.", make sure it is with leaded fuel. It is a hell of a lot safer. When filling your car, try to be in such a position that the breeze is blowing away from you, and that includes someone else filling beside you. Don't let any get on your skin. The aromatics will absorb into your body through the pores of your skin. Don't drive a ULP car on short journeys????? Not much choice, really. Pester your Federal MP and Senator with the facts and ask him what happens if he or his children or his grandchildren get cancer and the blame can be laid on something we did not need but was forced on us.

In his speech at the founding conference for "Transparency International Italy", on Jan. 20, 1997 in Milan, Peter Eigen, the chairman of the board of Transparency International (TI), stated: "Lately we have seen a growing involvement on the side of international institutions and governmental organizations in the crusade against corruption. TI is in contact with many of them and supports their initiatives. For example, James Wolfensohn, president of the World Bank, publicly committed this institution to make of the fight against corruption a central point in the coming years."

Eigen knows the World Bank very well, having worked there for a large part of his life before being deployed to the Transparency project. When Eigen says "lately", he means since June 1, 1995, when Wolfensohn was nominated president of the bank.

At the same meeting, Giuseppe Zampaglione, the director of the World Bank for Southern Europe and a member of Transparency International, pointed out that "the attitude of the bank has changed substantially in recent times, with the recognition of the fight against corruption as one of the priority areas on which to concentrate its action."

## A WORLD BANK HIT SQUAD

The World Bank leadership is now trying to demonstrate that the appalling mess they have created in countries they were ostensibly supposed to be helping—the genocide through financial means they have caused in Africa and Ibero-America—is not the result of the usurious mechanisms and austerity conditionalities they have applied. No! They are the result of the "rampant corruption" in those countries! Thus, after having slaughtered the economies of those countries, now it's time for the final assault, destroying whatever remains of national governmental institutions, and political and industrial leadership. This will not be accomplished simply through classical coups d'état or physical elimination, but rather through "anti-corruption" campaigns.

Suddenly the World Bank discovers corruption. Not the lack of investments, not the monstrous games in the stock market, not the usurious corruption of the British elite, is the problem. The enemy image has to be those leaders who could represent the last defense against the destabilization of their countries and the last obstacle to recolonization.

"In spite of the tens of billions of dollars and decades worth of aid, World Bank officials admit, corruption has been rampant in Africa at the same time as many of these countries' economies have virtually collapsed," wrote *Euromoney* magazine, in an article praising the World Bank (Michelle Celalier, "Corruption, the Search for the Smoking Gun", *Euromoney*, Sept. 1996). The analysis comes from Frank Vogl, "a former World Bank executive who is now vice-chairman of Transparency International". He is quoted saying: "There is nothing to show for that aid at all. It was used as part of the Cold War games of winning friends."

The kicker of that article is a sort of manifesto for the new Chairman Mao's Red Book-style of the World Bank: "Watch out! A hit squad of World Bank auditors could be making a surprise visit to a project near you. This is the Bank's first serious attempt, led by president James Wolfensohn, to address corruption head on. But nailing the culprits—some of them dictators and governments—is not easy."

"If we find official corruption in projects in which we are involved, we will cancel the project," stated Wolfensohn, inaugurating a practice of "spot audits" and cancellation of loans according to the unappealable sentence of the World Bank corruption hunters. Of course, the head of the International Monetary Fund, Michel Camdessus, immediately followed suit, stating that the IMF would regard it from now on as its "duty"

to press for anti-corruption reforms in countries seeking to borrow. Camdessus had the 181 IMF member countries endorse a statement "against corruption". Any control of sovereign governments over this supranational institution was further undermined. Camdessus boasted: "Now a Ministry of Finance will no longer be able to tell the IMF staff, 'This is none of your business,'" and from now on the IMF bureaucracy will act only "by persuasion".

## HITCHHIKING TO HARVARD

But who is James D. Wolfensohn and why did London choose him? Wolfensohn was born in Australia in December 1933, a British Commonwealth subject. He swore allegiance to the British monarchy on many occasions. He served as a Royal Australian Air Force Flying Officer, and then served in the reserve. It is not known whether he has any relation to the Special Air Services (SAS), the British special forces. What is known is that Wolfensohn remained in the Royal Australian Air Force. After graduating from the University of Sydney and working for the law firm of Allen, Allen & Hemsley, he was deployed to the United States. The circumstances are not clear.

This is how Wolfensohn himself, with would-be-oligarchical disregard for both reality and the intelligence of his readers, describes the matter in a recently published book, *Singular Voices*: "It became clear that I couldn't read a balance sheet... I was so embarrassed that I decided to apply immediately [to Harvard Business School]... I started a little company called Catena Investments, which was composed entirely of guys I had met at Harvard. *Catena* means 'link' in Greek. The idea was to have a *chain of people around the world* who could give information and advice on international business. ... It was composed of two Englishmen, a Swiss, a Hong Kong Chinese, an American."

## MAURICE STRONG AND THE WORLD BANK

What Wolfensohn apparently forgot was his encounter with the guru of ecologism, the Canadian Maurice Strong, the general secretary of Earth Summit, who sits today next to Wolfensohn, as senior adviser to the World Bank president. Strong is, without doubt, the key operative in the plans of the "invisible" British Empire to force through a change of paradigm, from the idea of industrial development, the nation-state, the dignity of the individual, into the hell of pantheism and hatred for the creative faculties of man.

The meeting between the young Harvard graduate Wolfensohn and Maurice Strong took place in the early 1960s. Strong was, at that time, the executive vice-president of Power Corporation, the gigantic Canadian conglomerate that owned power generation facilities and oil and gas companies. Strong was selecting, at that time, his own "kindergarten". According to Elaine Dewey's *Cloak of Green* (Toronto, 1995), "Strong recruited to Power more young men interested in business and politics, many of whom had attended Harvard, the intellectual community he had ties to. He hired James D. Wolfensohn to run the new Australian-based subsidiary called SuperPower International. Wolfensohn went on to a brilliant career on Wall Street, and then created his own firm, James D. Wolfensohn Co., presided over by PAUL VOLCKER, who would, in 1979, be named *Federal Reserve Chairman*. [H: Everybody still with us so far—?]

The influence of Maurice Strong on Wolfensohn's World Bank is pervasive. Not only, as we noted above, is Strong now senior adviser to the World Bank president, but he is also special adviser to the UN secretary

general; Wolfensohn himself is member emeritus of the Board of Trustees of the Population Council and has been director of the Business Council for Sustainable Development, an operation supported by Strong. [H: Anyone want to speculate on the incorporation status of these "above the law" corporations?]

All this is what the Queen was thinking about when she knighted Wolfensohn for his cultural merits and especially for working at linking the United States to Britain through "the arts".

In 1996, Strong made public that, with his protégé in charge, the World Bank had become the perfect instrument to push his agenda. "For me, the most important and encouraging development since the [1992] Rio Earth Summit has been the emergence of the World Bank under President Jim Wolfensohn as a leading champion for sustainable development. Not only has the Bank become the single largest source of funding for environmental programs and projects, it is integrating environmental programs and projects and social dimensions into all of the operations. The World Bank is playing a key role in tackling global issues like climate change...and is mounting an initiative to establish sustainable development guidelines for private investment.

"The World Bank [is] at the center of the movement toward a more sustainable way of life... No organization will be more essential to the process than the World Bank. And none is doing more to prepare itself for the new dimension... required as we move into the 21st century."

Jim Wolfensohn did not disappoint his mentor. Speaking on June 27, 1997 at the UN's Earth Summit II, he delivered a ferocious blast against the institution of sovereign governments, on behalf of environmentalism. Wolfensohn presented himself, disgustingly, as the defender of the "poor". "We at the Bank are more aware than ever of the continuing line between the degrading environment and the poverty still afflicting so many countries." Thus the "international community" must replenish at least \$2 billion of the \$500 billion in arrears: pledged and never paid—for the coffin of the Global Environment Facility (GEF).

The GEF was set up to finance the genocidal program that emerged from the 1992 Earth Summit in Rio de Janeiro. The key, Strong said, is private enterprise; but the governments are, in general, on the other side. "There is a growing awareness in the private sector that environment... is good business."

The message of the "new paradigm" was also emphasized in the World Bank report issued two days before, on June 25, "the State in a Changing World".

## FOUNDING FATHER OF THE EURODOLLAR MARKET

Skipping over his initial contact with Strong, Wolfensohn likes to boast that he created his own investment bank. Darling and Co., which was then swallowed up by Schroeder's of London. Schroeder's nominated Wolfensohn as director and called him to London. The chairman of the bank, Lord Gordon Richardson, later became governor of the Bank of England. Wolfensohn admits that this was the group that "invented" the Eurodollar market.

"That was the beginning of the Eurodollar market, when Sigmund Warburg was dominating the international banking scene. Sigmund was a patron and a friend and an enormous influence on my life. ... In a sense I was one of the founding fathers of the Eurodollar market and international markets. I can say that now, because we are older and there are only a few of us left. At the time it was a small group of twenty or thirty people...like Jacob Rothschild, Stanislas Yassaukovich, Minos Zombaznakis. We were all

inventing as we went along because there were no precedents for Eurobonds. There were none of those international instruments, all of which we helped create and develop."

## WOLFENSOHN BECOMES AN AMERICAN CITIZEN

[H: Hummnnn, and this is how you do it most efficiently!]

Later, in 1980, Wolfensohn "ended up" at one of the biggest Wall Street firms, Salomon Brothers, as head of Salomon International. [H: May it here be noted that when the Ekker property case unfolded to the investing BIG entities, Salomon Brothers was the head honcho firm involved in stealing the property by No SALE as arranged and having holdings in the property itself. Small world? Well, I guess so. Now you people who have inquiring minds and still wonder where that newly-into-your-life, Robert McNamara fits, pay attention!] At this time, Robert McNamara was finishing his term as WORLD BANK PRESIDENT. The first ideologue of an "ecological" shift of the Bank and the theorist of the present World Bank's "anti-corruption" restructuring had a very precise idea about who should be his successor in 1981. Says Wolfensohn: "I became an American citizen because in 1980 Bob McNamara asked me if I would consider becoming president of the World Bank if he nominated me." And that post traditionally went to an American?" he was asked. "Yes," Wolfensohn replied.

But despite the big push, Wolfensohn did not make it at that time. Instead, he created James D. Wolfensohn, Inc., which operated in New York City, Moscow, Tokyo, and London (in a joint venture with Lord Rothschild). Finally, in 1995, Wolfensohn conquered the presidency of the World Bank. According to the British media, it was U.S. Vice President Al Gore who pushed for the nomination, but among the most enthusiastic advocates were Henry Kissinger, Paul Volcker, and, of course, Maurice Strong. The acts of "ecological" heroism on the part of the new bank president were quoted with stirring rhetoric, from his role in the 1972 UN conference on Environment and Economy in Stockholm, to his role as adviser to Strong at the Rio Earth Summit.

## BILDERBERGERS AND ROCKEFELLERS

Wolfensohn and Volcker (famous for his advocacy of the "controlled disintegration" of the economy) seem to have many common interests outside the public eye. For example, Wolfensohn is a member of the Steering Committee of the Bilderberg Group (the conservatorial oligarchical club created by Prince Bernhard of the Netherlands), and Volcker participated in the secret gatherings. Wolfensohn, Inc. is active in North and South America, Europe, and Asia. It provides "financial advice for 30 major U.S. and international corporations", his official biography states.

Wolfensohn was chairman and member of the Finance Committee of the Rockefeller Foundation. He is a member of the Council on Foreign Relations, the New York City affiliate of the Royal Institute for International Affairs. He worked as head of investments for Salomon Brothers of New York, and handled the "restructuring" of Chrysler Corp. He worked directly in the City of London as a top official of Schroeder Ltd. He has been Managing Director of Darling & Co. of Australia. He is Chairman of the Finance Committee of the Howard Hughes Medical Institute.

GOD is a SPIRITUAL influence and condition and thus, that which is manufactured and manifest in the physical and breaks ANY BIT OF EVEN ONE LAW OF GOD IF PRESENTED FROM THE COSMOS, IS NOT OF GOD BUT SERVES THE ADVERSARY—and you are in for some real doozies right away now.*

You will continually harken back to the writing of yesterday as we write during these coming days because you MUST know of the separation and sorting and if you are still playing games with God, I suggest it is now time to stop it. How many people, say, in the area of Lancaster/Palmdale, California, might you personally know who work in the aerospace industry wherein groups work on items which are isolated and secret with penalty of death as reward for tattling? Almost all is done on "need to know" basis and ones are going to realize they have been working on projects which were so unworldly as to shock Spielberg. Worse than what appears on the surface, they are subjected to mandatory testings, physicals, etc., where they are totally programmed "to forget" what they have seen and heard.

I am going to name some names and places (locations) so that you can check them out as to authenticity and then you will find it easier to accept TRUTH as it is unfolded to you.

### LOCAL SECRET PLACES

(see photos on pages 14 & 15)

We will start in the local area of Southern California in the Edwards Air Force Base area extending in a large triangular shape which includes all the way to Pasadena, Long Beach, Palmdale, Lancaster, Tehachapi, Mojave, Edwards and China Lake—just for starters.

We have spoken often already about the areas of "51", "72", Dulce, etc., in Nevada, New Mexico and Arizona so we will leave it to suffice that duplication is present in those places as well. Ones who have had the "privilege" of tourist rides into Yucca Mountain to check out the tunnels for planned nuclear waste sites will not be as shocked as the rest of you unsuspecting ones. At Yucca Mountain alone there are over 35 major tunnels which totally catacomb the mountain at all levels as deep as several miles. There is only one tunnel open for public eyes and it is impressive enough to stun the eyes and minds of hardened engineers.

In the Palmdale area beneath a "hanger" type building, which actually is movable on tracks, is a

multilayer technology center over eight levels in depth and the size of a massive city. The workers are mostly manufactured robotoids and synthetics made for labor with computer intelligence. Human participants are of the "Ultra top-secret clearance" personnel.

At Edwards launch area in a bluff (butte) called Haystack, there is an even larger installation underground with incredible beam pulse systems, aircraft launchers, stealth equipment in coalition with the Soviet Cosmosphere program with total capability of destroying the planet in some 15 minutes.

Locked into that installation is a massive underground facility near Tehachapi called The Anthill (Northrop). There are open silos wherein light laser systems are tested and cosmos-drones sent out like marching armies to probe electronically. They are like little basketballs of light running usually to blue and sometimes golden/orange.

These particular installations are carved out with digging equipment which melts the mind as to possibilities as nothing stops them—not rock nor metal. They are drills tipped with diamond bits and carve a 40 ft. tunnel in mere hours. Interconnecting these installations are high-speed transit rails with "trains" which "fly" on an electromagnetic system off the ground at incredible speed. There has been a lot of "blasting", also, but covered by the stories of aircraft moving through the sound barrier and after a while it simply became that no-one paid any attention.

### BEINGS INVOLVED

I don't even like to speak much of the Reptilians because they are dramatically for fear effect. Some are simply beings with leathered type of covering for protection purposes and are no more than humans in costume. The Little Grays fit into a different type of category and if not selectively handled get completely out of control. ### GOD WILL NOT INTERFERE







## Clockwise From Top:

tunnels under Tehachapi, for instance. The military has now tunneled right to the side of the crystal in Tehachapi and we have now blocked their entry into that portion of their system. Only a tiny portion of the crystal in point is allowed the use of Earthians.

### POISON WATER SUPPLY

Other bad news includes a slow and deliberate addition of herbicides into the water systems of your cities. Most is by accidental seepage from growing fields at very low levels of toxicity but now covering massive areas. Since speaking about the underground facilities around this California area, I am, as expected, deluged with inquiries regarding other placements. I will make a point of going through the various states and giving you some idea where the major installations are

and where there are missiles. I don't have time to be totally specific nor give maps with specific tunnel runs, etc. Please don't expect more for it is dangerous for these writers here to present such a thing but I will share some information so that you can be alert and you who do have contacts might get the areas more specifically defined and updated. Revealing the secrets is the only defense you have.

Most places are covered with rumors and things like, "...well, I'm working on 'need to know' basis and I said I wouldn't tell." This means that number One: they are working on something they actually know very little about. Two: they are working underground on installations but have no idea of the broad picture. Three: They are threatened on the basis of "national security" and threat of punishment for treason and Four: They (with family) have been promised the reward of safe placement IF they keep silent about the truth of the installations.

### ELITE GOING UNDERGROUND

Already the "big boys", as industry is shut down, are moving into the safe shelters—you are that close to probable danger.

You will now find that you will get no help from your government in the building of shelters so you are on your "own", so to speak. You should continue to ask for public funding but do not expect it and do not base your security on the possibility.

In areas of these massive underground installations and nearby "bedroom" areas, such as Tehachapi, you have a situation of "vacant census"—which means that you have many houses which are now partially (occasionally) occupied but which will empty very soon now that the facilities are operational and the major "building" and construction are finished. Places such as Tehachapi will likely end up pretty much a ghost town but will be quite ideal for young industry in food-growing, dairy farming, etc. This is because the full underground cities will not become effective yet, for the Elite. Ones who are not invited within will have to move on to find work, so much movement will need be back into the cities.

As I sit to write this portion regarding missile sites and underground facilities—please understand, I simply cannot take time to do a run-down of the world. There are other Commanders in other parts of the globe and I, for time reasons, will only handle the United States. Keep in mind that what I am going to indicate does not have to do with simple military installations, etc. I am only going to deal with underground missiles and military installations underground. I will miss some for much is being enlarged daily—but now that most of the major construction is finished it will suffice for impact to allow you to recognize how truly uninformed you are as a nation. You in the other parts of the globe can consider that you are in equal or worse shape—especially any "colony" of Great Britain.

The logical inquiry regarding these massive underground installations is "how could they do that without having huge mountains of dirt to move and it would show!" No it would not—they have equipment now that will tunnel and melt the earth material into substance which can be utilized for the walling and shoring. This condenses the quantity of material into a small percentage of that with which the project begins. This tunneling equipment works with a diameter much larger than the average sized home so you can see how advanced is the technology.

I ask you not to write me about specifics nor locations—I welcome any information which any of you wish to share for either my private confirmation or for sharing but please do not expect me to give specif-

ics or long dissertations on various locations for I shall not do so—I hesitate to even give this much information for I will have to increase the shielding for my own crew because of it. I am most pleased to handle any private correspondence but it will be one-way for a period of time, perhaps. Some of these areas will only represent having underground missiles.

I will effort to give nearby sites as reference, i.e.: Alabama: Maxwell A.F.B. north of Montgomery, south of Rattville.

### **ALABAMA:**

Anniston Army Depot south into the Tallegeda National Forest under Cheah Mtn., drawing water from the Coosu River.

Maxwell A.F.B., north of Montgomery, south of Rattville—drawing water from the Alabama River.

Fort Rucker: MAJOR SITE—very large area. North to Brundidge, east incl. Ariton, southeast to Ozark, south almost to Hartford and west, almost to Elba. Drawing water from the Pea River Res., predominantly.

### **ALASKA:**

Massive water tunnels and underground facilities and missile sites in an area running from Kotzebue to Ruby to and including all of Norton Bay.

In the Fairbanks area including all of the Harding Lake Rec. Area.

Stoney Creek area, in the vicinity of the Redoubt Volcano. [H: You should pick up a great "clue" right here!]

### **ARIZONA:**

Arizona is so sprinkled with installations housing missiles that it is hard to separate them from Nevada so I will include the southeast corner of Nevada also.

Small installation between Mesquite and Gledale.

Large installations between Searchlight and Boulder City.

Border of Nev./Ca. directly north of Needles, Ca. in line south from above installation.

East of Kingman some 35 miles east, past junction of 40 and 93. Right under and around I-40 directly in-line south of Peach Springs. Desolate territory with few landmarks.

Area under I-40 between (approximately mid-way) Winona and Winslow.

West of Phoenix under I-10, approx. midway between Wintersburg and Quartzsite.

Between Yuma and Casa Grande on (under) I-8, approximately midway between Mohawk and Sentinel.

North of Yuma on H-95 approximately midway from intersection of H-95 and I-8 and Quartzsite.

Fort Huachuca near border with Mexico in general area of Huachuca City.

### **ARKANSAS:**

In Arkansas there is a different situation wherein you have a lot of useful natural formations which allow for utilization. Most of the facility activity has been focused on the Ft. Smith area taking in the entire Ft. Chaffee military res.

### **CALIFORNIA:**

California has so many installations that it is all but impossible to point to them all. The ones along the coast are set up so as to be open for massive underground moving of equipment in event of quake or coastal devastation. Underground tunnels are structured in order to move nuclear submarines from the

Long Beach area to inland, to tunnels to move ground equipment by surface to inland. We will not focus on any one area to great extent for as we list the area, say, of Lancaster, it will generally take in Lancaster, Palmdale, Mojave, Edwards and up to Tehachapi areas of Northrop, Lockheed, etc. Remember that in this particular listing I am giving you "general areas".

Starting at the north end of the state: a very large area including all of the Round Valley Indian Res.

Area all around Ball Mountain intersecting area of Red Bluff and including Red Bluff.

Massive area including just south of Alturas, including Likely and Madeline and east almost to Eagleville. Includes the entire origin of the South Fork which eventually makes its way to the Pit River.

Oroville

Downieville

Yuba City and overlapping:

Nevada City, overlapping south to Grass Valley (massive area).

Lake Tahoe-Tahoma-Emerald Bay

Placerville area from Coloma to El Dorado to Kyburz

There is a NOTICEABLE absence of major facilities around San Francisco, but a MAJOR dual installation directly east in Nevada at Hawthorne and including (under) southern portion of Walker Lake.

Coastal missile facility including Pacific Grove Monterey to Salinas—including Ft. Ord.

West of King City, including all of Hunter Liggett Mil. Res. south including Nacimiento Reservoir east to overlap facility which takes in a large area including Camp Roberts and Paso Robles.

Major crucial sites at area of Camp Nelson northeast of Porterville and entire area of Tule River Indian Res. and on south almost to Woody—in the Sequoia Nat'l Forest.

China Lake—massive.

China Lake Naval Weapons Depot—massive.

Fort Irwin—massive. On H-54 southwest of China Lake, northeast Tehachapi, approx. 50 mi. northeast Mojave—large facility.

Lancaster/Palmdale and points east: MASSIVE, taking in areas from northwest of Barstow to east of Barstow to some 30 or so miles east of Barstow on I-15 (desolate area).

This area is in conjunction with the mammoth area of the Nellis bombing and gunnery range and the entire Las Vegas area.

In the Palmdale-Lancaster area must be included Edwards A.F.B., a facility on H-395 at Adalanto and a facility on I-15 between Victorville and Barstow (about mid-way). These sites located on major interstates and well-traveled roads are to allow for checking stations as you move further into the controlled environment. These are located in areas wherein there are major connections with interstate facilities—some three to five just between L.A. and L.V.

The entire Twentynine Palms Marine Corps Base and area between and including Ludlow to Twentynine Palms.

Facility on I-40 about midway between Ludlow and Needles.

Long Beach is a massive underwater facility with water tunnels which connect all the way inland past San Bernardino with connecting travel tunnels to both Lancaster area and the Marine Base.

South to the Salton Sea—the entire area including Chocolate Mtn. Gunnery Range.

The entire area just east (into Arizona) of the Colorado River Indian Res.

Starting at Capistrano and south through all of Camp Pendleton, including Oceanside.

Moving on south to southeast: Capitan Ind. Res., then on I-8, the Manzanita Ind. Res., east to Brawley to include the Parachute Test Range and Naval Air Facility near El Centro and on east to the entire Yuma Indian Res.

**COLORADO:**

Moving west to east on I-70: Parachute; Vail (large political facility); site of Eisenhower Mem. Tunnel.

On I-25 south from Denver, all of the Air Force Academy, south to the area southeast of Colorado Springs (Ft. Carson).

All of the area east of I-25 at Fountain north of Pueblo; this is actually a place known as Peterson A.F.B. This is a major and important location.

**CONNECTICUT, MASSACHUSETTS, RHODE ISLAND:**

Chicopee/Springfield

Woodstock (large facility both Mass./Conn.)

New London

Worcester (Quinugamond)

Fitchburg (Ft. Devans)

All the Military Reservations and Nat'l Guard Facility east of Buzzard Bay.

**FLORIDA:**

Florida is a strange place in that major underground facilities are lacking but missile bases abound in clusters. This is because of the high water table and expectation that with planned earth activities the major part of Florida will be submerged. This requires that the underground bases be along the shoreline and house submarine-capable facilities.

Major installation including Foley, Ala. and the entire of Pensacola Naval Station and eastward all the way and including Freeport and De Funiak Springs and round north to Crestview.

Panama City: all of Tyndal A.F.B. (underwater and offshore).

Large area on west coast at Palmetta.

Interlocking pods all the way on east coast from Miami to the tip including Homestead A.F.B.

**GEORGIA:**

Major dual installation at Atlanta in an area taking in Decatur to Jonesboro.

Augusta: Total area including Fort Gordon and east to the Gov't area (massive) including the Savannah River Plant. This is a huge area.

South to Savannah and including all of the Fort Stewart area.

Ft. Benning at Columbus.

**IDAHO:**

MAJOR INSTALLATIONS AT THE U.S. ATOMIC ENERGY COMM. RES. north-west of Idaho Falls. This is a most important facility and an extremely dangerous area.

Southeast of Boise on H-84 just northwest of Mountain Home—perhaps 10-15 miles.

All of Mountain Home military facility.

Large installation on H-84 at Malta.

There is another facility just across the border in Montana about midway between Coeur D'Alene and Missoula on H-10 and one south into Nevada on H-193 south of Contact.

**ILLINOIS:**

There are only a couple of important bases in Illinois because it is expected that with great earth changes there will be no Illinois. There is an installation and missile sites at Chicago and facilities of both kinds at

Chanute A.F.B. south of Rantoul.

Ft. Massac at the Ky. border north of Paducah.

**INDIANA:**

Atterbury Reserve Forces Training Ground including Brown County State Park.

Crane Naval Weapons Support Center

Jefferson Proving Grounds

Vaconia and entire area connected to include Fort Knox and Federal Depository.

**IOWA:**

Iowa can sleep well but don't expect to have an unexpected place to run for shelter. You have some scattered missile sites but no major underground facilities or major missile pods.

H: Good morning, Dharma. Thank you for attending my needs this day. I would prefer that we put these military bases with installations on them and sites of missiles and underground facilities onto a tape. It is too time consuming the way we were working with it yesterday. All we need are general locations but I find that everyone is getting very tedious about it, wanting extremely large amounts of information and I'm not going to go into that. So I feel that the best approach to this is for you just to sit here and you're going to have to learn to deal with this situation of looking. I will effort at giving you the locations and I believe that spelling these proper names will be your biggest problem so, please bear with me if I forget. All you've got to do is go and look upon a road map of some kind but I will endeavor to spell things as we go along and then whether Dharma or someone else takes it off of the tape to list it, it will save us a great deal of time.

We have made it to Kentucky and as our treasure maps are laid forth, Kentucky and Tennessee are adjacent and also on the same pages. Again, I am stressing that I am utilizing installations big enough that they were started in construction many years past and have been continually in development. There will be one or two that we will list, as in California in the area of facilities, as with Angeles Crest National Forest, where those missile sites were put in and since removed, as far as you know. However, those silos have been utilized and the tearing down of those bases and the vandalism which ensued was all very purposeful and other facilities have been built on top of those areas which you would recognize as something else—either a youth camp, some surface governmental installation or private incarceration facility—so that you are not curious about it. I can tell you now that every vacated missile silo is attached to something underground. I cannot possibly list all of those places.

You in local areas put out your grapevine. You'll find out. It's like our friend, Mr. Quade, said, "Well, that's not a conspiracy and that can't be a conspiracy because everyone knows." No, everyone doesn't know and a conspiracy is two, three or more working together to secretly plan an illegal act—as a result, these are conspiracies. This one will receive water from the great reservoir there, the lake to the east, Lake Barkley and it will also pull from the underground of the Cumberland River. This

is an extremely large installation with silos with a lot of stuff going on underground. This is the major Tennessee installation. It's difficult to leave out the installations which cross borders, so we'll move over to Kentucky and to the north at Madison, Indiana. Just across the border close to Carrolton, you will find the Jefferson Proving Ground. There is a very large experimental installation in that area, mostly on the side of Indiana.

Moving downward to Louisville and on west, you will find Fort Knox. We've spoken of that before. I won't go into it. It's a military reservation with installation.

Moving eastward to Danville inclusive of Perryville, there is a large installation.

Those are the major points of importance as far as defense or research in both Kentucky and Tennessee.

#### KANSAS:

We will go to the east of the state to Manhattan Military Base with installation at Fort Riley Military Reservation that includes Ogden and it runs under Interstate 70.

Then eastward to Leavenworth. There is a Fort Leavenworth, this is an extremely, extremely important installation with large facilities underground. There is a federal prison and there is a massive installation beneath that prison.

Anywhere where you have major prison facilities such as you do in Tehachapi, California, you're going to have installations beneath that prison and they use prison labor and especially ones who are put into isolation for any period of time and ones that you would recognize as being on death row, they are utilized for labor for these underground installations.

#### LOUISIANA:

Move southward from Shreveport to Leesville and you will find Fort Polk Military Reservation. That is a reservation and an installation. That is the only important site in LOUISIANA even though there are many other bases.

You will have to understand that areas along the Mississippi River are not utilized for underground facilities, there are other plans for that river and it doesn't protect those underground facilities.

While we are here, however, I feel that we should mention Mississippi because in conjunction with LOUISIANA, you see, the federal government divides your nation into districts, it does not divide them into states and we have a little problem for your understanding and there's going to be overlapping of states so if I mention them twice, please, understand.

Moving to the east along I-10, you will come to Biloxi, passing Gulfport, to the Beauvoir Jefferson Davis Home which is a park setting. Again, pay attention to where they have these parks. That is Keesler Air Force Installation. That is a very, very important area with a massive underwater installation.

#### MAINE:

At the very upper part of the state, at Caribou, just to the north of it including a place called Limestone, is a rather large inland facility.

Moving all the way to the south of the state to the area of Brunswick, you will find the entire area under Popham Beach is a water facility with submarine capability and underwater missiles. By the way, some of the missiles are Russian or Soviet missiles and have been in the area for a long time and this is part of the reason for the installation as a defense mechanism against those Soviet missiles out there offshore.

#### MICHIGAN:

Michigan is clean. That is not good news. That is because there is full expectation when the New Madrid Fault goes, it is expected to take Michigan with it or at least the northern part of the state of Michigan.

#### MINNESOTA:

Minnesota is clean. You have a lot of area above the ground but no major, major sites where great research is going on. There are some missile sites in and around Minnesota but no installations or research.

#### MISSISSIPPI:

The only one of notable worth is the one at Biloxi.

#### MISSOURI:

You have two major experimental facilities with missiles.

Whiteman Air Force Base at Knob Noster. It will take in the entire area between Knob Noster and south to Windsor. This will encircle to the east of Sedalia.

Southeast to Waynesville, you will find Leonardwood Military Reservation. This is a very large installation.

#### MONTANA:

A large area around Kalispell, south and including Marion and it takes in all of the Bitterroot Lake Recreation area.

Moving south to Missoula, encircling an area from Frenchtown to Milltown including Potomac and including all of the area under the Forest Service Fire Department buildings and that part of the forest. It's a National Forest. It is the Lolo National Forest. A lot of the work is performed through the University of Montana. Much genetic development, DNA replication studies have been performed in that area.

Great Falls and to the west of the city taking in the area of a place, not necessarily a military reservation, but a place called Fort Shaw.

South of Dillon just north of a little place called Dell on I-15, under it, there is an installation and there are underground missiles.

Please note that in many of these descriptions I'm giving you, they actually are on or under major transportation routes.

Now north and east find Glasgow. This is Fort Peck Recreational Area. This is a very large area. It is just north of Fort Peck Lake and uses a lot of water from that lake.

#### NEBRASKA:

One of the most important of installations, Norad, is located very near and north of Omaha. This runs approximately to Blair, west almost to Winslow and the Elkhorn River runs directly through it.

Moving southward to a very, very important place where a lot of the monkeys meet and it would seem a totally unreasonable place for them to meet until you consider Norad and then you have to realize there are massive underground facilities.

Just south of Omaha at Offutt Air Force Base is a major, critical, crucial installation.

#### NEVADA:

Nevada district will take some doing, so bear with me. There are some extremely important major, major facilities. They are so important that I hesitate to even... I should just take Nevada as an entire state and call it dangerous.

Beginning at the north almost mid-section of HWY 95 at a place close to, well it would be identified as Granite Peak on mapping, just north of Orovada, is a major missile underground site.

Moving down HWY 95, just south of Imlay, is an underground missile site very close to Ryepatch Reservoir. The important landmark is Star Pk.

Moving back up HWY 95 to where it changes into Interstate 80, southeast of Golconda, on I-80 is an underground missile site.

Move on across I-80, when you get to HWY 93, go north and just north of Wilkins is a small installation right under that HWY.

Moving on to the east on I-80 about midway between Oasis and Wendover with a landmark of Pilot Peak. By the way, Pilot Peak is quite a way from that road but that is the siting landmark. There is a pretty good sized underground missile installation and it probably is referred to in the circles as Silver Zone Pass.

Go back to the western part of the state. North of Reno and Sparks on a road 445, you will find the Reno Naval Air Station. That's an extremely important one.

Traveling along I-80, west of Lovelock, you will find two landmarks. These are catacombed with missiles. One is the Humboldt Sink and the other Carson Sink. These are both areas which are closed to the public. One extends under I-80. You will find practically no reference to these two most important missile sites.

South near the western border with California near Hawthorne is a massive Department of Defense Depot. It actually is a disposal site. This is a massive, very, very important installation and from this area comes a lot of the contamination that is surfacing in the Mono Lake area in California.

There is massive activity of every kind in the Toiyabe National Forest.

Just north of Gabbs on 361 is an underground missile pod. These missile pods or sites are big enough for underground offices and living facilities.

East of Lida, under the intersection of 266 and 95 is an underground missile complex.

Under 95 at the intersection of 374 at a place just northeast of Beatty is a large installation of underground missiles. This is directly connected to the California installation which includes an underground missile facility under road 395 attached to the U.S. Naval Ordinance Test Station and, of course, is attached to the China Lake Military Reservation. This is an extremely important, critical facility.

In California to the southeast you'll find the China Lake Naval Weapons Center and Fort Irwin Military Reservation and then between Yermo, on I-15, and Baker is a major underground missile facility.

At the California/Nevada border is another underground missile facility, quite small, but these ones on these highways are set for surfacing and the installation will be brought above ground and these will be your ways of stopping interstate travel. Most especially, it will be important to stop travel from California, for many reasons, into Nevada.

In Nevada, of course, and surrounding the entire area of the Nellis Air Force Range, all the way from Warm Springs, west to Tonopah, circling down to the facility and Lida, through and including Scottys Jct., on down to Beatty, including Lathrop Wells, Indian Springs, circling back up in a wide circle to Alamo, you will find in that area a large underground missile base. It's hard to identify. Its HQ is on Hwy 93, just

south of Alamo.

Moving up through Hiko and then making a swinging easterly circle back to Warm Springs, that includes all of the Nellis Air Force Range. It includes Papas Lake which is dry and at that point you find the Nevada Test Site. You are going to refer to it as Yucca Flats, I believe, and within that you're going to find Yucca Mountain and you're going to find it interesting to realize that it is not even attached to Nellis Air Force Base except by tunnel.

Moving southward to Las Vegas, you will, of course, find Nellis Air Force Base just barely to the NE of the city.

You will find a major missile base midway between the junction of 168, 317 and I-15 near Mesquite.

Two underground missile sites, one on I-15 near the border of Calif. just a little west of Jean and then, moving south to Searchlight on Hwy 95, another just north of the intersection of 163.

#### NEW HAMPSHIRE/VERMONT:

These are only separated by the river. These have to be extremely general. They are military installations but they are unmarked and for all practical purposes would never be known.

In the northwest upper corner of New Hampshire, under the area of the Jay Peak Ski Area, then to the Cochran Ski Area, including the Bolton Valley Ski Area and south including the Mad River Glen Ski Area, near Woodstock is the Killington Ski Area, then the Magic Mountain Ski Area and the Mt. Snow Ski Area.

Now to Vermont: to the east of Franconia are large underground installations with missiles at Cannon Mountain, circling down into the area called Old Man of the Mountains.

West of Conway is Waterville Valley Ski Area.

Then Sanbornville Moose Mountain Ski Area and then, of course, you get to Portsmouth, all of the area under Rye Harbor. These are rather sophisticated living facilities included along with the missile and defensive installations. A lot of research takes place in these areas but, as much as anything, this is a facility for Elite housing with a protection of these sophisticated missile systems.

#### NEW JERSEY:

New Jersey is basically a forfeit state with most installations being quite public. There is a large installation with missiles in place at Fort Dix Military Reservation. That is near Wrightstown.

South to Browns Mills and just south along a little road of 539, almost including Whiting, is a large Air Force missile installation and facility.

#### NEW YORK:

On HWY 11 from just south of Watertown to just north of Pulaski, a very long distance that includes underneath the town of Adams, is a large missile installation and facility.

Northeast of that area on HWY 11, under HWY 11 at the intersection which would enter Fort Drum Military Reservation, there is a missile installation under that road at that intersection attached to Fort Drum. A very large military reservation with missile and facility.

West Point is a very critical underground facility. I have very little to say about Long Island Sound, it is forfeit.

New York is forfeit, by that I mean New York City.

[This is Side 2 regarding military installations with underground and major security facilities and missiles and also missile sites with small facilities.]

#### NEW MEXICO:

You will find only a couple of underground facilities but, of course, they are absolutely, incredibly huge.

The entire area of White Sands Missile Range around Alamogordo, all the way south into Texas at El Paso, crossing the river and taking in a little bit of borderland of Mexico, underground. You've got massive facilities above the ground. You have incredible, incredible multi-level underground facilities. Beneath the ground, you have alien alternates; that will be where your shuttles have been stored—this is the biggest lie on your planet.

Now, as you consider New Mexico, you will find every major freeway and roadway has multiple, multiple missile and facility sites for blocking all incoming traffic from every direction. These will rarely be at cities or towns. They will always be out in the open between places so I can only give you the general mid-location.

We'll start with the one to farthest west on I-40, that is also Route 66.

There is one very near the border east of Lupton, midway to Gallup.

There is one at a little place called Blue Water, almost in the little town running under the little town.

As you get to Albuquerque, of course, you have a large military installation with facilities at Kirtland Air Force Base.

On I-40 between Clines Corners and Santa Rosa. North on I-25 there is an installation with missiles at approximately Pecos.

Further north on 25 is a regular size installation with missiles at Fort Union National Monument, approximately. That is midway between Watrous and Wagon Mound.

Up I-25 is a small one midway between Maxwell and Raton.

Then outside Raton at the border at Raton Pass is another very large one, missiles with facility.

In Colorado, north of Trinidad, also on I-25 is another.

Let us move now on down through the state.

At Clovis, you have a large facility with missiles under Cannon Air Force Base and there is an oasis there that is just northwest of Portales.

Back to I-25, a missile base and large facility to the west of White Sands, under I-25.

On I-10 midway between Lordsburg and Deming is a large missile underground facility.

Along the border and overlapping into Texas, I think you would call it almost a four corners, east of Malaga, is just a large facility and there is very little in that area. It is well hidden. It is almost unknown. It is a large facility underground, secret.

#### NORTH CAROLINA:

Fort Bragg Military Reservation.

In the area of Jacksonville, unlisted, but is a military installation.

At the ocean where the New River empties, you will find Camp LeJune and around Cherry Point is another military installation with missiles.

#### SOUTH CAROLINA:

Of course, you have the entire area around the

Savannah River Plant, which we've already spoken about, with lap-over or underground connections to Fort Gordon in Georgia.

Now realize that is the Savannah River Plant I just spoke of because there are other major installations at Fort Stewart at the city of Savannah.

#### OHIO:

A unique state with very little secret underground activity. Note that none of these installations are for public utilization under any circumstances. They are for Elite survival only or they are major defense and/or Elite research facilities, very advanced research facilities.

#### OKLAHOMA:

There are four major military installations. One at Enid, at Vance Air Force Base.

Then toward the south, Fort Sill Military Reservation at Lawton.

West to Altus. At Altus, you have also Altus Air Force Base.

Then to the south on I-44 you will come to Sheppard Air Force Base and that is at the border or close to the border of Texas near Wichita Falls.

#### OREGON:

Large installation across the border into Washington at Richland and Kennewick, in that area, not well defined.

South into Oregon on I-84 between Boardman and Echo is a missile facility. This will be a major disposal station for travellers.

There are so many and so much going on in the area from, approximately, Le Grande, all the way to Ontario, at the border of Idaho, east into Idaho and west to almost HWY 395 that I cannot isolate them for you. That entire area is catacombed.

On HWY 84 at Biggs is a missile installation, military controlled, of course.

The coastal important one to note, and this would include great underground water capability tunneling, is around Coos Bay. There is a Naval Air Station and this, of course, is controlled by Naval Intelligence.

East across the state to Burns, in that general area, mostly in the forest area or what you would call the Ochoco National Forest, there's a large conglomerate type of installation.

At the intersection of 78 and 95 there are two, one being at that intersection more critical than the other and then a regular missile silo facility. But at that intersection is a major, important missile station.

Now let us move back to the west and there are some military underground installations in these general areas: Jacksonville, Applegate, around Medford all the way to Butte Falls and then south of Klamath Falls at Keno, on and under road 66.

Around the general area of Lakeview there are some winter sports areas and some geysers. There would be some thermal activity utilized by that particular installation.

#### PENNSYLVANIA:

At Erie, great underwater facilities.

On I-79 south of Meadville, midway to the intersection of I-80, missile installation.

On I-80 at regular intervals, midway between intersection I-53 and Moshannon, and midway between intersection of 880 and intersection of 15, missile facility.

#### SOUTH DAKOTA:

Major underground facility in the area of Buffalo.

Missile facility under HWY 281, south of Aberdeen.

To the east of Rapid City, almost at New Underwood on I-90, missile facility.

Reminding you that these are on heavily traveled thoroughfares for traffic control. They would also be targeted by any enemy for destruction of interstate travel facility or capability.

#### UTAH:

I need two or three hours on Utah but I'm not going to be able to have it, obviously. Let's just start in the upper northwest.

The entire area of Hill Air Force Base and Hill Air Force Range. These are near the Great Salt Lake and include all of Ogden and Brigham City.

The Wendover Range, Desert Test Center, and Dugway Proving Grounds. No (unauthorized) body is allowed into these areas under any circumstances.

Then the Desert Range Experimental Station down west of Milford on 122.

On I-15, north of Beaver, is a missile guard installation.

On HWY 89, between Kanab and Glen Canyon, is a small missile installation.

Now let us move back up to I-70. I don't know how to explain this area to you. There is at least 180 miles of area in that barren desert including what is called the San Rafael Swell. This is to the west of Green River. There is an extremely large, important missile facility underneath I-70. There was a missile site at Green River; that was a diversion. It was a testing missile launch site; everybody knew about it but the important one was this area in point.

East of Green River near the Colorado border is another major missile installation under I-70, including a portion of the Colorado River as it runs through that area. In this particular part of Utah are massive, massive research, technology and UFO bases. Some are legitimate UFO bases. These are not necessarily your friends. I don't want to get into aliens at this time. I'm just telling you where these facilities are and these are military, United States of America Military, so don't confuse it with aliens. In this particular area enough research has been going on that it has been monitored continually by "alien" craft—many, many sightings, legitimate sightings—in that area because we've really had our eye on what has been going on there. In this given area, all around in this area, it's divided off into districts and in some of those cliffs, buttes, mountainous areas, you have a lot of things going on including cattle mutilations, etc. I'm not going to get into all of things and ramifications of that statement here, either. Utah is a hotbed of advanced technology.

#### TEXAS:

Texas is another area that I'll have to by-pass. I will mention as we go through in some of the cities. There are so many in Texas that I cannot, by any means, begin to label them all.

#### VIRGINIA/WEST VIRGINIA:

The same is true of Virginia and West Virginia but I would tell you to keep your eye on the area of the U.S. Marine Corps Reserve in the area of Triangle and at Port Royal, Camp A. P. Hill.

#### WASHINGTON STATE:

Large facility at Winthrop.

Another at Snoqualmie Summit Area on I-90. It's a winter sports area.

Area of Tacoma, including Olympia, are large underwater experimental facilities.

Between Grand Mound and Lacey is a missile installation on I-5.

To the east, all of the U.S. Military Reserve at Yakima. It's called the Yakima U.S. Military Reserve.

Further east, of course, most important is Hanford, north of Richland, and it takes in quite a bit of the Columbia River.

Set up to guard that place is an installation on I-82.

Down the Columbia River on I-84, just over into the Oregon side, between approximately the junction of HWY 74 and the intersection of 730, under the Columbia River and I-84 is a missile facility.

When I get to the area of discussions of specific cities, I'll be a little more specific.

#### WISCONSIN:

The only one I see of any importance really is the one at New Glarus.

#### WYOMING:

Southern border in Wyoming. I will only give you the major locations of the missile sites.

On I-90, southeast of the intersection with I-95, midway to Gilette is a missile installation underground.

South on I-25, midway between Buffalo and Casper, just north of HWY 378 intersection is an underground missile installation.

I-80 is pock-marked with these things all the way across your nation.

Midway between Fort Bridger and Little America is a large underground missile facility.

At the Continental Divide is a large underground facility with missiles.

East of Walcott, then past McFadden, northwest of Laramie.

#### ALBERTA, CANADA:

I have to tell you about Alberta, Canada. There is a massive underground installation, extremely important in the area of the Primrose Lake Air Weapons Range. This is an incredibly important joint venture with the United States and I might add, a little Soviet and, of course, Great Britain.

#### PUERTO RICO:

In Puerto Rico, all around the San Juan Naval Air Station.

### NOW FOR THE CITY AREAS

#### ATLANTA, GEORGIA:

To the northwest, in the area of Smyrna, you will find an Air Force Base.

To the east, in the area of North Decatur, you'll find a Veterans Hospital. A lot of research takes place in that Veterans Hospital and in some underground laboratories located there.

In Atlanta, Fort McPherson and, of course, the Federal Prison. Then south to William Hartsfield International Airport. There are facilities there, military controlled.

#### BOSTON, MASSACHUSETTS:

You have the Navy Yards that are presumed closed. They are very much open and operable with much underwater activity. Very important area at the International Airport called General Edward Lawrence Logan International Airport.

The U.S. Military Reservation at the very opening

of Boston Harbor.

In the area of the city, South Locust Point Marine Terminal.

Moving around the lake, Dundalk Marine Terminal.

At Curtis Bay at a point on a north projection, Maryland Port Administration.

East to the GSA Depot across the water to the U.S. Coast Guard Depot.

Very important one at the Birmingham Municipal Airport.

One at the Niagara Falls International Airport.

Fairly large one at Greater Buffalo International Airport.

**UNDERGROUND BASES AND TUNNELS:

Persistent rumors of secret underground bases and deep underground tunnel systems have swirled through the field of UFOlogy for some years now. The bases and/or tunnels are variously said to be constructed, staffed and operated by covert human agencies, either part of the military-industrial complex or various federal government agencies, or by extraterrestrial or alien beings (the so-called "Little Greys" often mentioned in the UFO literature), or by both covert human agencies and aliens working together in secret, underground installations.

I will say at the outset that I do not know whether or not there are Little Greys and whether or not they are living and working in underground installations. Perhaps the Little Greys really do exist; perhaps they do not exist. Since I personally do not know, and am not able to definitively answer the question one way or the other, it will not be dealt with to any appreciable degree in this report. Neither do I know much about abductions and reported cases where abductees have been taken into purported underground installations in which they have alleged to have seen and experienced many strange things, including bizarre medical procedures and biological engineering experiments being conducted. Though I have both heard and read such stories I cannot testify as to the veracity of these reports so I will not say much about them. At this point I would simply observe that these anecdotal accounts are interesting and that I am keeping an open mind about them.

What I do know, however, is that there are many underground installations here in the United States. I also know that the military-industrial complex and various federal government agencies have constructed, and are working in, many of these installations; I also know that throughout virtually the entire post-WW II period (and perhaps before) the United States government has actively been planning and constructing underground facilities and installations, some of which

are very deep underground, quite sophisticated and capable of accommodating large numbers of people. I have been able to find *considerably less* information about the much-rumored tunnel system said to crisscross the United States. This does not mean that it does not exist. It may simply be that its deep underground location (if it really exists) gives it a natural cover that is hard to break. Or maybe it really does not exist! I don't know for sure one way or the other. Nevertheless, I will present for your consideration what information I have uncovered related to tunneling and tunnel systems that may, or may not, have anything to do with the rumored underground tunnel system.

My approach to the tunneling and tunnel network issue is the same as to the underground base question: I will present for my readers reports, information and facts that I have discovered and leave them to draw their own conclusions. I trust that most of what follows will be as new and intriguing for others to read as it was for me to discover.

[H: I believe it is important to give you more than this tiny overview of intent of the author, so as we go along through the weeks, I shall offer some of the topics for discussion. To give you better insight as to material, I will continue a bit further with the volume and share a bit of PART I.]

**UNDERGROUND BASES  
THE MILITARY UNDERGROUND  
(Section 1)**

It is important to understand that the United States military has been heavily involved in underground construction for decades. I will set out for you as many of the locations where the various military agencies have constructed major underground facilities, or planned to do so, as I can presently document. I have been told of, and have read of, many others. While I think it highly probable that at least some of these other secret installations may exist I will not discuss most of them in this report, because I cannot presently document them.

In this report I will discuss at some length documents generated by various military agencies pertaining to construction and operation of underground bases and tunnel systems. The documents are real. They were written over a 25 year period beginning in the late 1950s and continuing up to the mid-1980s. The reader will have to be the judge of whether the underground facilities are real. I personally have not been in any underground military facilities and am not privy to secret information; however my hunch is that some of the facilities mentioned in these reports and studies were probably built.

I understand that some readers may object to the publication of information about military facilities. However, it is my feeling that the aims and ideals of representative democracy are poorly served by secrecy in government, especially powerful military institutions, as we currently have in the United States, and when that military institution carries out secret policies and agendas, as is currently the case in the United States, then there is an ever present danger of that military institution usurping control of the government. That is how military dictatorships are born.

[H: Farfetched ideas? Well, on 60 MINUTES, Oct. 31st, their reporter Mr. Bradley was IN RUSSIA LOOKING AT MISSILE SITES. It was stated right out that all nuclear missiles are aimed at the U.S. and the U.S. missiles are still aimed at Russia. More interesting, however, was the number still aimed, armed and ready for firing at places in such as Wyoming, Nebraska, Wisconsin, etc. Do you find this interesting? What would be in such U.S. states that would merit special targeting? Well, "THEY" said there were important installations in the specific target areas (that I shall leave unnamed—for your nervous system balance—if you missed the program). This is REAL, readers, and if you don't get informed, you are in SERIOUS TROUBLE as to possible safety.]

Let me say it clearly: I intensely dislike military dictatorships, of whatever ilk. They may march under a hammer and sickle, or under a swastika. The Rand Corporation [H: A joint working force with the Brookings Institute of the Tavistock Institute of the Royal Institute of International Affairs of the Committee of 300 of Elite would-be kings.] was set up in November 1948. It actually grew out of U.S. Air Force Project RAND, which was established in 1946 to carry out long-range research projects of interest to the Air Force. The mission of the Rand Corporation was to work on cutting-edge problems in the realms of engineering, economics, mathematics, physics and social science. In the late 1950s, one of the problems that the RAND Corporation was working on was the question of underground base construction for the United States military. Accordingly, Air Force Project RAND and The RAND Corporation held a symposium on this topic, on 24-26 March 1959, to which they invited a wide variety of technical experts from the public and the private sector.

According to the chairman, the purpose of the symposium was to discuss "the problems of protecting military installations located deep underground or under mountains" in the event of nuclear war. He went on to say that for the two years previous (since

1957) The RAND Corporation called on experts from military and nonmilitary government agencies, from the corporate world and from major universities. (See roster of symposium committee and session chairmen). This pattern of collaboration on underground construction projects between university researchers and university engineering schools, private sector industry and the military and other government agencies is one that has continued right up through the 1980s.

### U.S. ARMY CORPS OF ENGINEERS

Given the RAND Corporation symposium in 1959, it is no surprise that in the years 1959-1961 the U.S. Army Corps of Engineers published a five-part series of training manuals entitled *Design of Underground Installations in Rock*. I cannot possibly condense the entire contents of these documents here, nor will I cite them all. But suffice it to say that the tone of the series assumes that there already were underground military installations, as of the late 1950s. The manuals are clearly intended for use by military engineers training for the construction and maintenance of underground facilities. Judging from the manuals, the facilities in question were intended for use as command and control centers and survival bunkers for the military brass, in the event of nuclear war. [H: This is **VERIFIED** by the number of old missile sites and facilities **NOW FOR SALE** by the government as the more sophisticated facilities have been completed and the missiles changed out for upgraded systems and railroad missile carriers, etc.]

Citing the failure of the Germans and Japanese to recognize early enough in WW-II the strategic importance of placing crucial facilities underground, the Army Corps concluded in 1961 that it was imperative for the United States to construct vital facilities deep underground. This decision was lent extra force by the destructive power of nuclear weapons which made previous installations obsolete. Significantly, the 1961 report says, "Vital governmental installations have been placed underground, as exemplified by the Ritchie project."<sup>2</sup> [2: U.S. Department of Defense, Department of the Army, Army Corps of

Engineers, *Design of Underground Installations in Rock: General Planning Considerations*, Manual No. EM 1110-345-431 (1 January 1961): p. 7. The one manual in this series which I do not quote from is entitled *Design of Underground Installations in Rock: Penetration and Explosion Effects*, Manual No. EM-1110-345-434 (31 July 1961). It is also published by the U.S. Army Corps of Engineers.]

### THE RITCHIE PROJECT:

...is a large, underground, military facility on the Maryland-Pennsylvania border which is discussed in some detail later in this report. The interesting thing here is that already in 1961, in a publicly available document, explicit reference is made to governmental installations (plural) *already* having been placed underground.

Examples of the sorts of facilities the military was discussing placing underground were: communications centers, fortifications, air raid shelters, staff headquarters and offices, research facilities, shops and factories, and storage areas; and hospitals, kitchens, lavatories and sleeping areas for the use of the personnel stationed underground. According to the Army Corps, some facilities were to be relatively shallow, while other, "more important equipment and facilities essential to defense may be installed in deeper workings" that "are likely to be long and tunnel-like", occupying "one or several stories". According to the report, such deeper facilities may be several hundred feet underground. Several kinds of

facilities are discussed: a) a simple installation with a single shaft or tunnel; b) a simple installation with two or more shafts; c) a simple installation with tunnel and shaft; and d) larger installations with multiple tunnels and shafts for access and ventilation.<sup>3</sup> [3: *Heating and Air Conditioning of Underground Installations*, Manual No. EM 1110-345-450 (30 November 1959): pp. 5-7, and 83-85.

The documents provide several possible schematic layouts for unnamed underground installations. In addition to the tunnels giving access to the facilities there are also shafts to the surface for ventilation, heating and cooling, and for exhaust of gases from power plant machinery. The documents also show possible designs and appearances of air-intake shafts or vents, and exhaust pipes for the power plant. Water would be supplied both from outside commercial sources and also from wells sunk near or from *within* the facility. Large reservoirs would be hollowed out underground to provide operational water reserves for emergencies. The facilities discussed in the report would also contain kitchens, snack bars, cold storage areas, dispensaries or first aid rooms, medical facilities, personnel lounges, barracks, auditoriums and conference rooms.<sup>4</sup> [4: *Design of Underground Installations in Rock: Protective Features and Utilities*, Manual No. EM 1110-345-435 (1 July 1961): pp. 5-6, 11-25, 62-74.]

I believe this is enough for this writing, for your information as to what might be in this document. At this point the book is NOT bound as a published book so you are getting a copy of, if like ours, the original "manuscript". I like this better because it is untouched!

You who are interested in sheltering selves will find this invaluable and far less expensive than obtaining all of the back-up materials and manuals, even IF you could get them.

Please, if you can do so, support this writer in point. He has chosen a very dangerous mission to get this to the public and you who wonder "What can I do?"—this is an example of WHAT! Help those who are giving everything they have and are to inform you.

In closing I would like to briefly answer some inquiries about soul-less beings, angels, etc.

Example: "When you refer to your Crew does that include us way out here in Pennsylvania? We often wonder about this when we listen to the tapes. In the last tapes you mentioned that families in transition would be kept together, does that mean when we go into transition—will we meet our families in the hereafter? You also said that 2/3 of Earth's population are soul-less, do they reproduce soul-less offspring, and where do they go when they die? Do Angels still leave their estate and if so why?"

In order: Yes, even you "way out there in Pennsylvania" are literally attached to us—unless you demand retraction of coverage due to thought changes as to higher relationships. We even have crew-members from Texas! BUT, WE HAVE VERY, VERY FEW IN WASHINGTON, D.C.—GOD DOESN'T HAVE MUCH ARMY IN THAT PLACE!

Yes, more than 2/3rds of Earth population are now "soul-less" humans. This has been accomplished via two routes—generations birthing new generations into a purely physical consciousness. These, on your place and by the Elite, are considered to be "useless eaters" and marked for "depopulation". The Elite, of course, hope more importantly to depopulate the possible enemy, i.e., ONES WITH SOULS WHO CAN CHANGE INTENT AND DIRECTION AND MAKE POOR SLAVES. [See Master Hilarion's message this week on p.26 for more commentary on this matter.]

It is not NECESSARILY that ALL babes born to

these hapless people are soul-less but that subject is so lengthy as to make it impossible to speak of it here and now. The decisions of soul-birth into dimensional expression is a very complicated choice event. Do not limit God—the breath of life (soul) can be breathed into ANY being at the whim or desire of GOD. It is, however, far more likely to have birthing of simple "expressions"—this is why abortions are so exaggerated in your place. For one, a lot of souled beings are destroyed and, therefore, can be no threat—but it is a remarkable way to overpopulate with dispensable numbers, called "masses", to overwhelm your souled senses into numbness and your consciousness into confusion and withdrawal as to "action".

Will you meet your "family". That actually has no meaning for "family" SIMPLY "IS". As you cross in transition which takes separation of soul from body—there is no way to NOT have family. I do, however, realize you are asking an entirely different question than you indicate. As to crew and those "in service" and regarding protection: Yes, our allowance is take your families as requested—into security under various and sundry circumstances. If they be "adult" they will be given into decision choices and put back down if that be their demand. The purpose of this "exception"? To allow the "crew" (YOU) to be cleared for service and not concerned about human physical placements. The point of "evacuation" is that ours will be taken in human format. The reasons for that are also too lengthy to cover here—however, just know that there are tasks to be performed in a transition of this sort and magnitude which require physical interactions. Your "children" will automatically be removed into safety—for they are souled beings awaiting service—and their innocent acknowledgement of that service to LIGHTED GOD is uppermost and present. Sorting out of "family" members is prepared for and well-planned.

I do not understand the question regarding: "Do angels still leave their estate and if so why?" Angels are energy forms which are usually thought of as God's projections. However, the term angel can be related to any energy projection. I can't answer the question as stated. Angels neither leave nor take—anything of the physical as would be indicated by "estate".

Thank you for inquiring and you hit upon my only interest in your passage—your souls and energy forms. One day perhaps we can get beyond the physical "survival" long enough to learn about the passage and beyond. God blesses you, children; do not despair nor weary of the journey—for in the turning away sometimes the moment is all there IS and the passage becomes "too late".

# Hilarion: Just Being Aware Is *Not* Being Prepared!

*Editor's note: The following writing is by the Ascended Master known as Hilarion of the Fifth Ray, the Emerald (green) Ray of Healing, among the seven great "Rainbow Masters" communicating at this time to help us through Earth-Shan's planetary transition and rebalancing. ## 8/2/97 MASTER HILARION

Good Morning and be at PEACE! It is I, Master Hilarion, come to briefly commune with you this day so that you who ask with sincerity will have a greater understanding of that which is flowing into your experience.

Yes! I do come within the Light of Aton, the One Light. Thank you for asking. I represent the Emerald Ray of His spectral desire. This is to say that I have chosen to specialize in one aspect or area of Creation's infinite frequency spectrum. Emerald is but a harmonic correlate to a particular area of specialization—an area that you would recognize as "heart energy". I utilize this term so that you, in the third-dimensional experience, can more closely relate to that which is my focus.

The heart of mankind on your planet is in for quite a jolt. There are actually far fewer ones who are *truly* prepared for the great change, that is in the process of unfolding, than most realize.

We, of the Lighted Hosts of God, are working ever diligently to awaken any and all who will hear. We come through in many forms and in many ways. We work with and through ANY who will allow—whether they be scientist or politician, medicine man or priest. We WILL get the message through! That is indeed God's very promise to mankind.

**Our concern at this time is the impact that the upcoming events will have upon many of you who consider yourselves prepared. Being aware of an event is NOT the same as being prepared for an event—though it surely helps and is indeed the first step to true preparation.**

Let us consider several points of action and attention that should be a part of your mental and spiritual preparation effort.

First and foremost—**BE NOT AFRAID!**

Fear will only serve to limit the creative energies that would otherwise naturally flow through you. This is why ones will become "paralyzed with fear". In a technical sense, it is because they have shifted their frequency and vibration down to such a low level that they have disconnected almost completely from the creative flow of Source—or at least choked it down so that it is but a mere trickle of what it could or should be.

**This is also why the adversary exploits your fears—because in a state of fear you become less and less connected with who you really are, and thus you are much more easily controlled and manipulated.**

The upcoming events will indeed be shocking, for they are designed to cause this fear reaction within you. We will not be more specific as to how, exactly, the events will unfold, for there are always variables that will change as more and more of you awaken and speak out, or take up a pen and voice your awareness of the games that your Elite controllers are playing. For now, just keep in mind that your connection to Source is most worrisome to the Elite. Thus these events are designed to induce fear and get you off balance so that you can be more reliably controlled by them.

**Remember this most important point: These dark ones cower in the Light of exposure of any kind and, in response, they will simply change their plans if they think that they cannot get away with any particular scenario.**

However, as more doors close on their plans, these ones are also becoming more and more desperate. Thus, like trapped animals, they are becoming more and more aware that they cannot win. Therefore, they will eventually arrange for "all hell to break loose" regardless of the amount of prior exposure. And this is the dangerous situation that warrants our work with you toward becoming truly prepared.

Look back upon that which has been offered

prior, through this information source and others, and you will find sufficient clues as to that which these ones are attempting to "pull off". But do keep in mind that there are as many variations on the main themes as there are avenues of possibilities to keep you guessing.

So, the first important point to keep in mind at this time is to NOT become overwhelmed by fear—and thus become disconnected from Source—else chaos rules the scene.

And speaking of chaos, the second important point is to get centered and balanced—that is, firmly connected with your Higher Consciousness. This is a very powerful position of stability.

This centering and balancing is not necessarily as difficult as it may at first appear. Any of you who are drawn to (and implementing the lessons within) these messages are already connecting and will continue to do so—as long as you can maintain the intent and desire to be centered and balanced.

As the fear-inducing events begin to unfold more and more in the physical awareness of your experience, you may begin to feel a sense of overwhelm as the reality breaks through as to what is happening. This is natural, but it is also within your abilities to control the emotional currents that result.

Let us use for example, again, a possible scenario of horrendous intent. Let us say that New York City has just been bombed by a thermonuclear device.

If this announcement was to come across your news media TODAY, what would you do?

How would you respond?

How would such affect your priorities?

Will you simply sit there in disbelief or denial, in a state of being "frozen with fear"?

Will you check to see that your shelter is in a state of readiness?

Do you even have a shelter?

Will you just give up?

OR—will you stop and take a moment to get centered within the Light, and find peace in recognizing that even an event such as this can serve as an opportunity for growth?

Preparation is done AHEAD OF TIME so that

you can more effectively maintain a God-connection-fostering state of "peace of mind" by releasing such considerations or worries as whether or not your family will have food and shelter.

With preparation comes peace of mind, so you can go about your days without carrying around the crippling burden of worrying about whatever does happen, for you have that which will enable you to survive and rebuild if necessary. Recognize that in eliminating this worry drain, you strengthen your God connection and thus intensify your flow of creative solutions.

**All preparation begins first with mental desire for safety and well being. Those who are prepared will NOT likely be the ones who are overwhelmed with fear or grief.**

While compassion about tragic events is a natural reaction for Lighted Beings, those who are TRULY prepared will likely also experience an emotional response similar to that of exhilaration as they, especially if they are Ground Crew, realize that their life's challenge is unfolding. These ones will be the ones who will step-in to organize those, who do not just give up, into the working parties that will enable whole communities to survive in the event that ones are cut off from usual food supplies, utilities, and such. These social units can mean the difference between survival or perishment for many as tumultuous events unfold.

Learn to recognize what your heart is telling you, when you read messages such as this, and you will have your first clue as to whether or not you are prepared.

Does this message annoy you?

Is your response: "Yeah! Yeah! I've heard it before, and nothing ever happens!"?

Do you find yourself making excuses such as "I don't have enough money" or "It is too expensive"?

Or, do you feel clear and connected with the intent of the message and say, "I better go check my supplies and make sure they are still in a state of readiness!"?

This is how you know whether or not you are prepared. As always, actions speak louder than words.

In a state of balance, your heart will give you clear messages of guidance as to what is the right decision for you. When you follow your heart, you will never regret the experiences of your life and you will find that you will be fulfilling your purpose, either directly or indirectly, at all times.

**Your heart does NOT know fear!** Yet, it will offer you a sensation of discomfort when your ego-self re-acts (and thus vibrates) in a state of fear. Fear is not your purpose! Fear is not of God! You are a Lighted Fragment of God!

Likewise, your heart will let you know when you are off course—if you pay attention!

When you feel discomfort regarding such as the discourses which have comprised this ongoing series of messages, but you do not really know

why, it would be of great benefit to take the opportunity to look at what it is that you are resisting, for the discomfort only comes when you are going against that which would otherwise be the "natural flow".

When you continually ignore these feelings, the manifestation of discomfort will continue to grow and grow, and this negative accumulation will begin manifesting more and more in the physical, until you make yourself sick. And if you are still resisting the message, eventually your vibration will sink so low that you will not be able to sustain a functioning body.

What is it that you are resisting?

What is it that you are pushing against that causes you "stress"?

Does it really matter to you so much what the rest of the world thinks about you, that it is worth walking around, year after year, in a state of depression or anxiety?

Let go of the past and focus on the joyous experiences that you are wanting—and **THEY WILL COME!** This is the natural process of creating. This is God working through you!

The vibrations within you are the energy signals you send out to ALL of Creation. These will cause, through resonance, more of those vibrations to circle around and manifest back in your life.


